The ornamental design for a pipette, as shown and described.

DESCRIPTION

This application claims priority to U.S. patent application Ser. No. 09/873,522 entitled “Handheld Pipette,” filed Jun. 4, 2001, which is incorporated by reference as if fully set forth herein.

FIG. 1 is a side perspective view of the pipette of the subject invention;

FIG. 2 is a top elevational view;

FIG. 4 is a front elevational view;

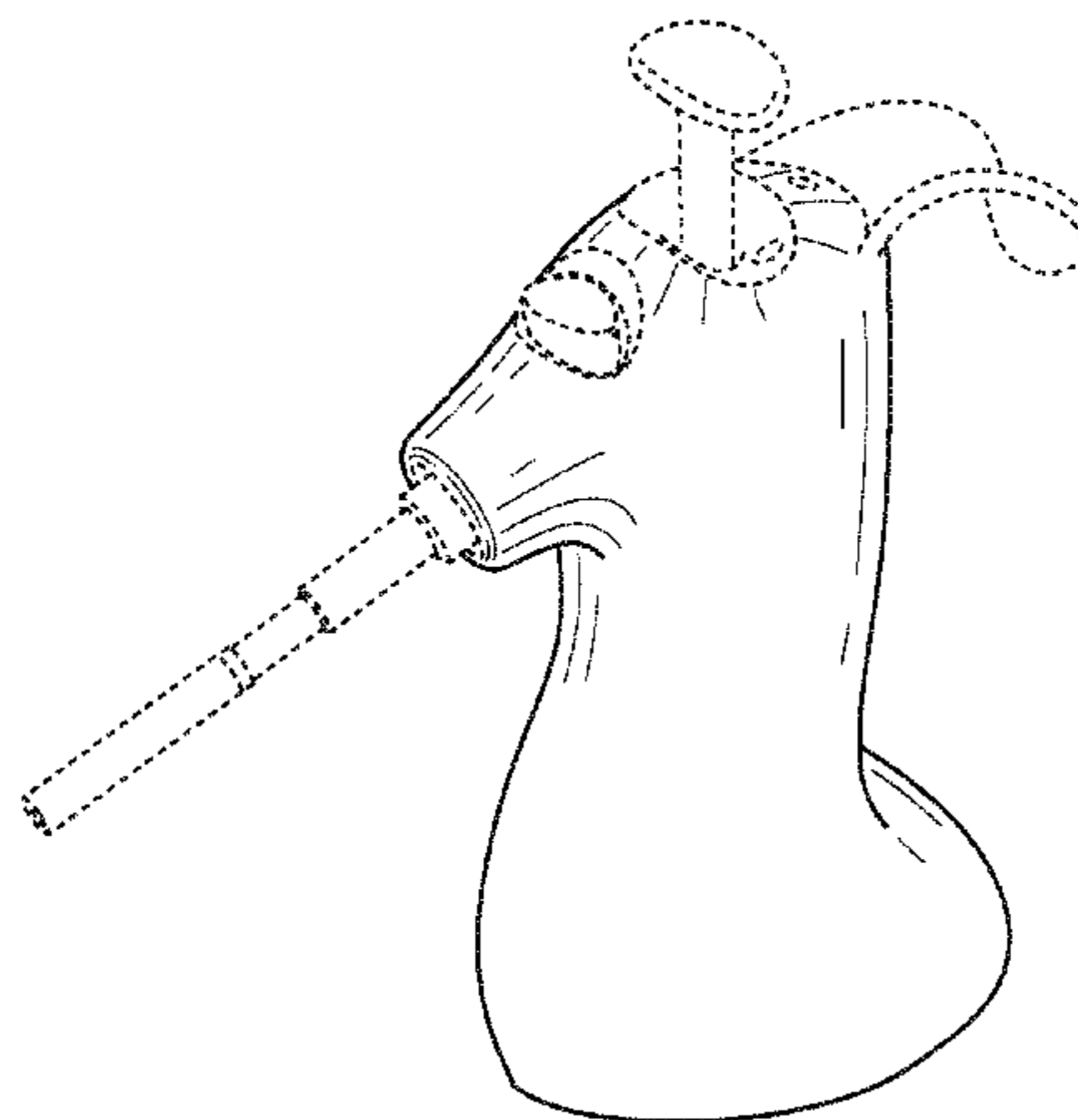
FIG. 5 is a side elevational view;

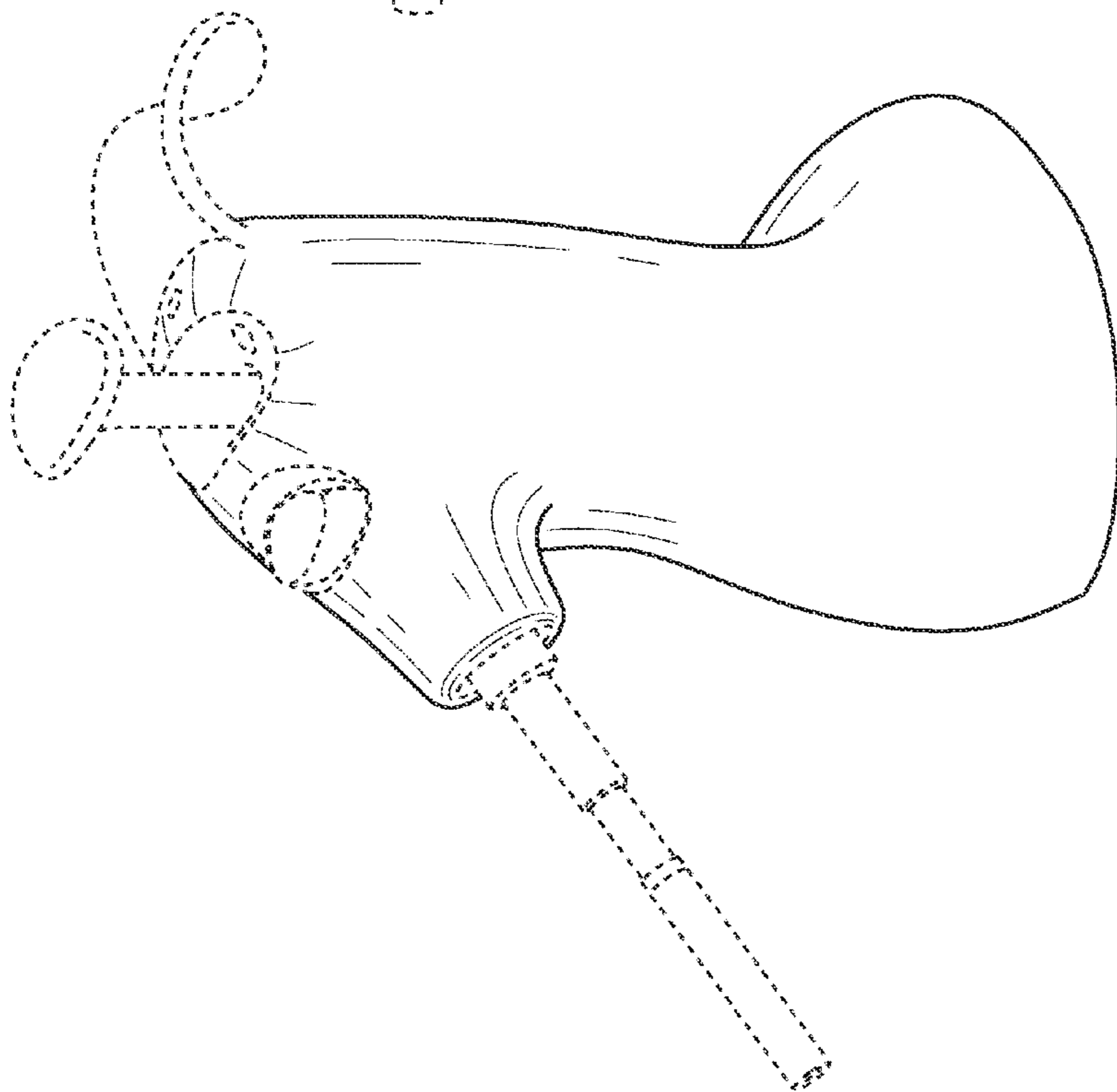

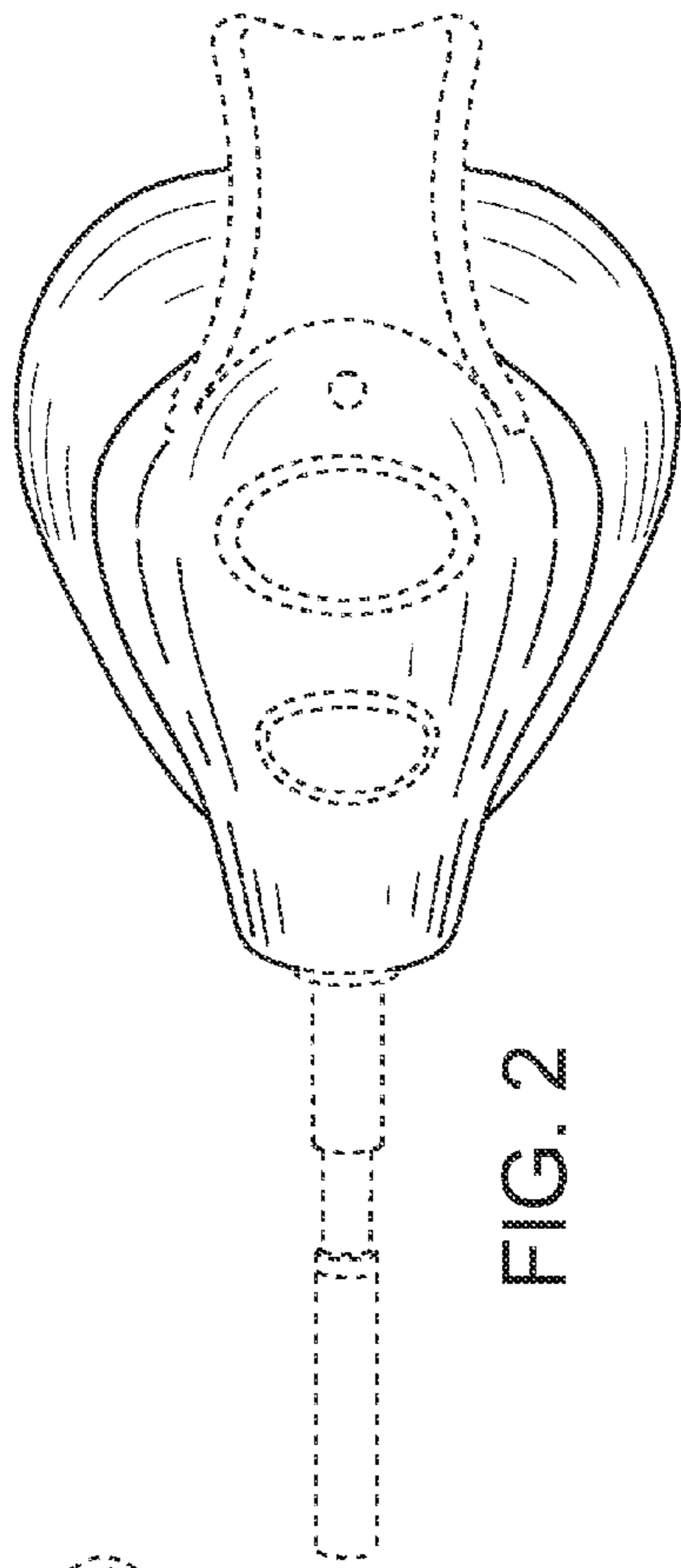

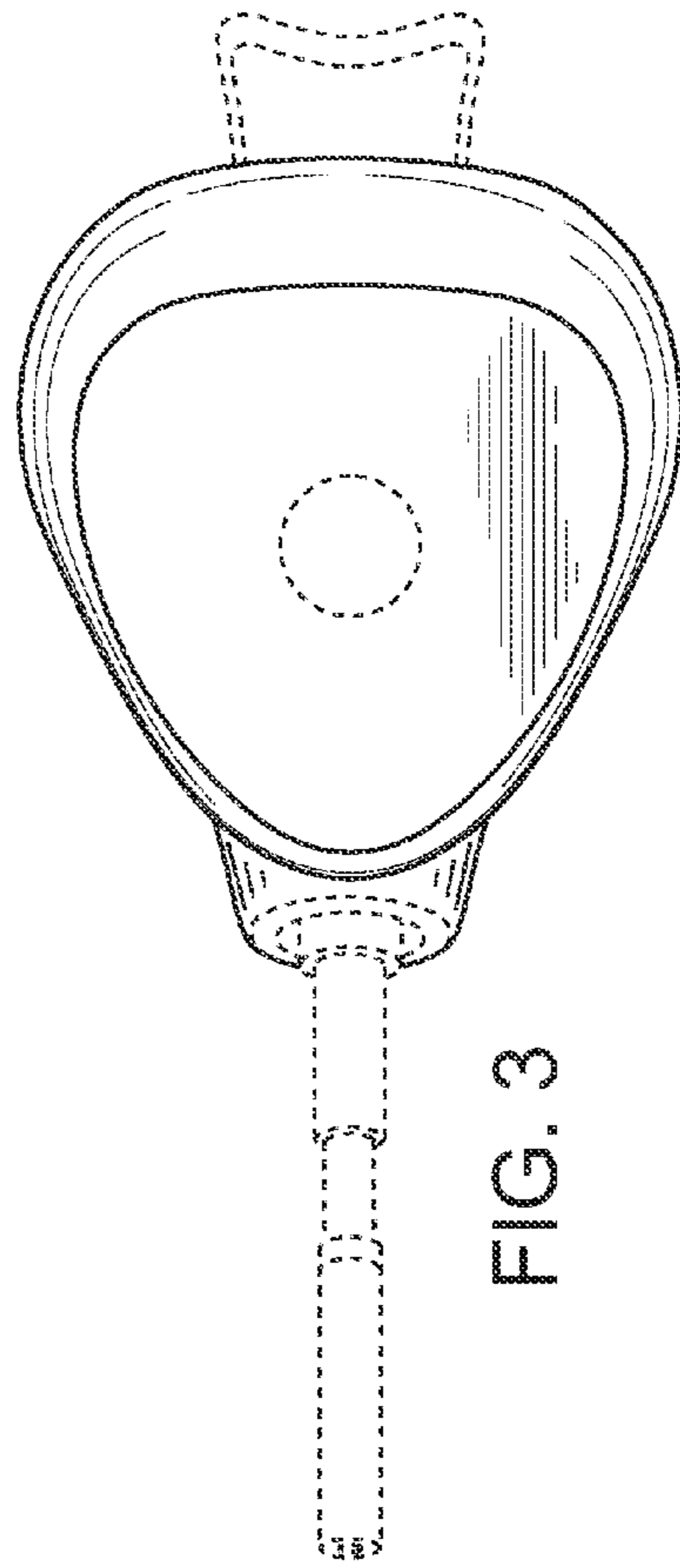

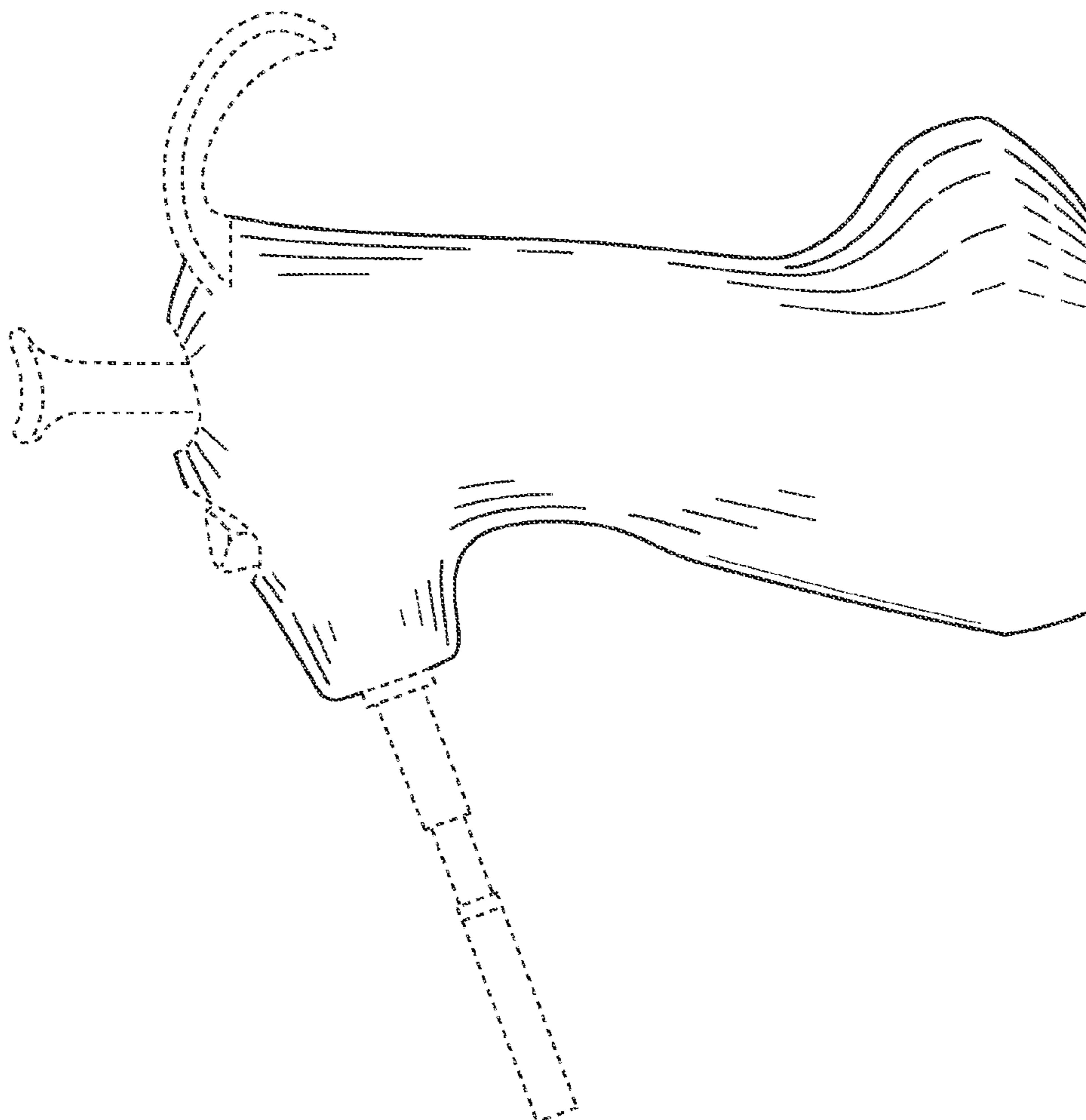

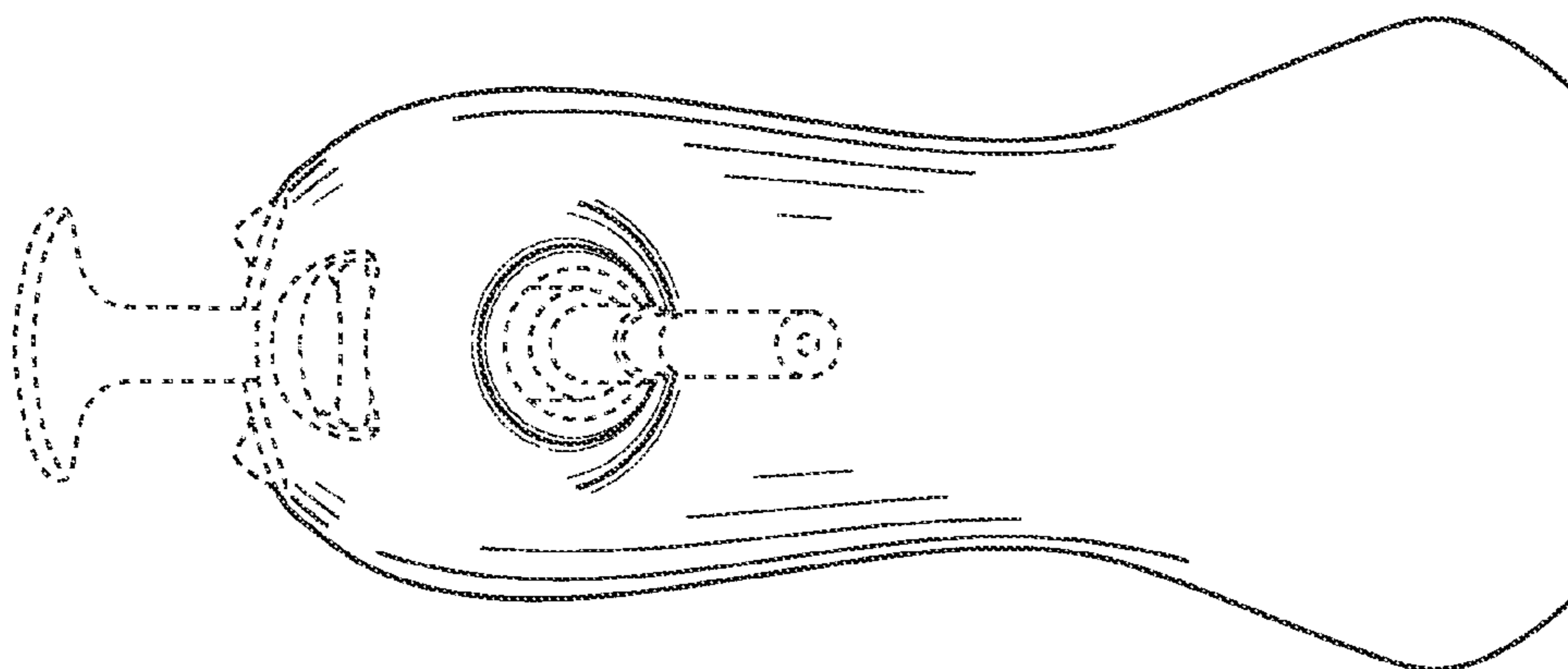

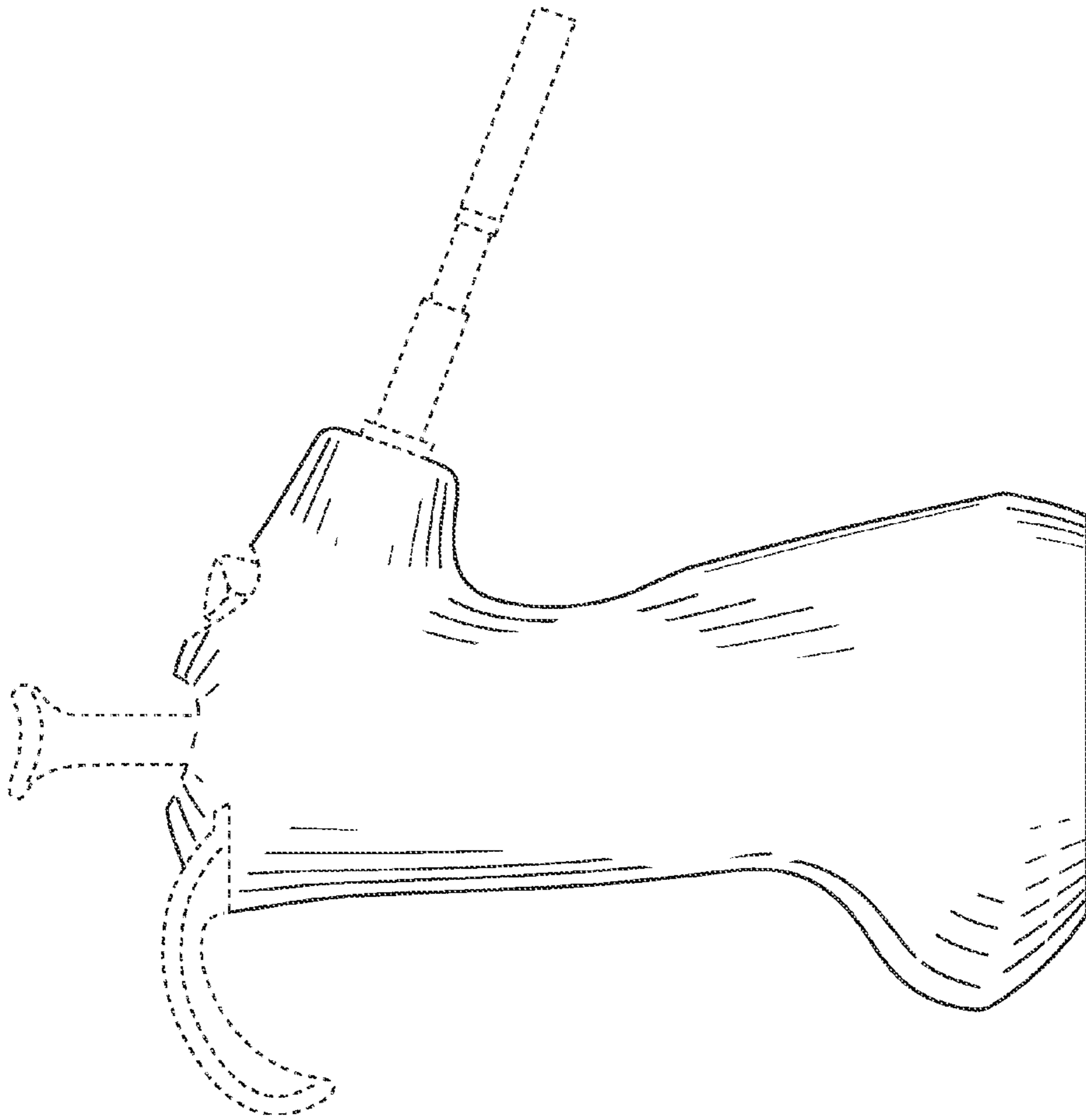

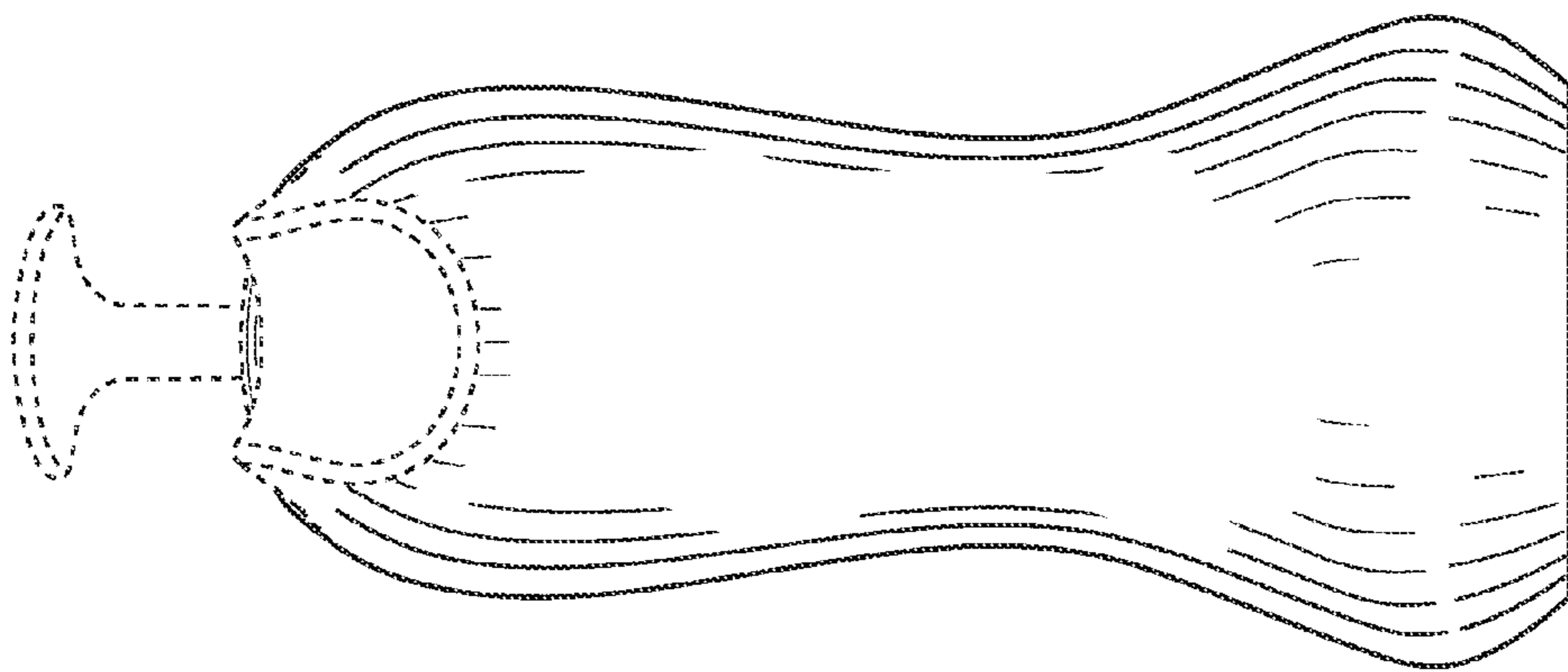
