(57) **CLAIM**

The ornamental design for a wall block, as shown and described.

**DESCRIPTION**

FIG. 14 is a back plan view of the wall block of FIG. 9.

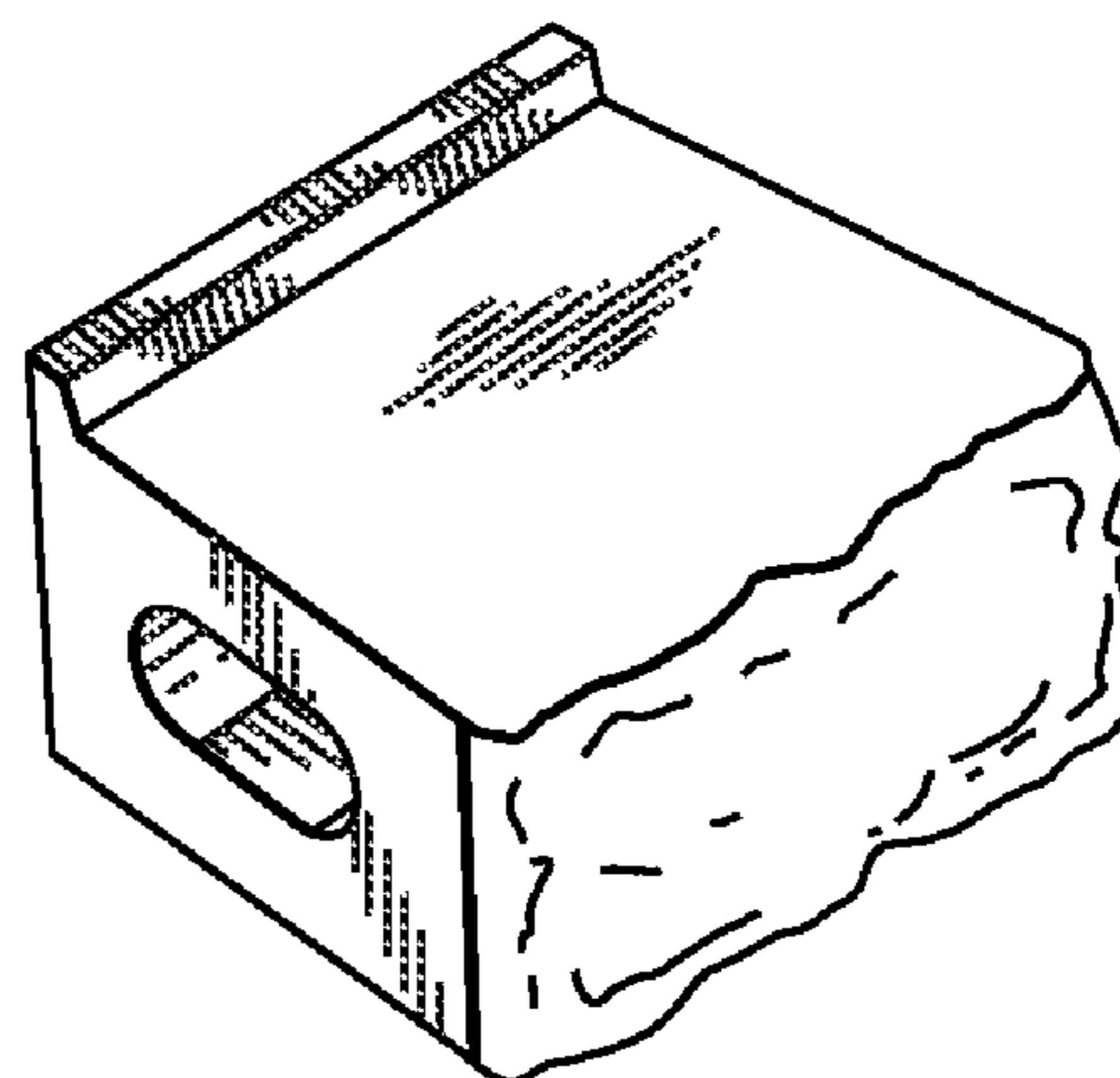
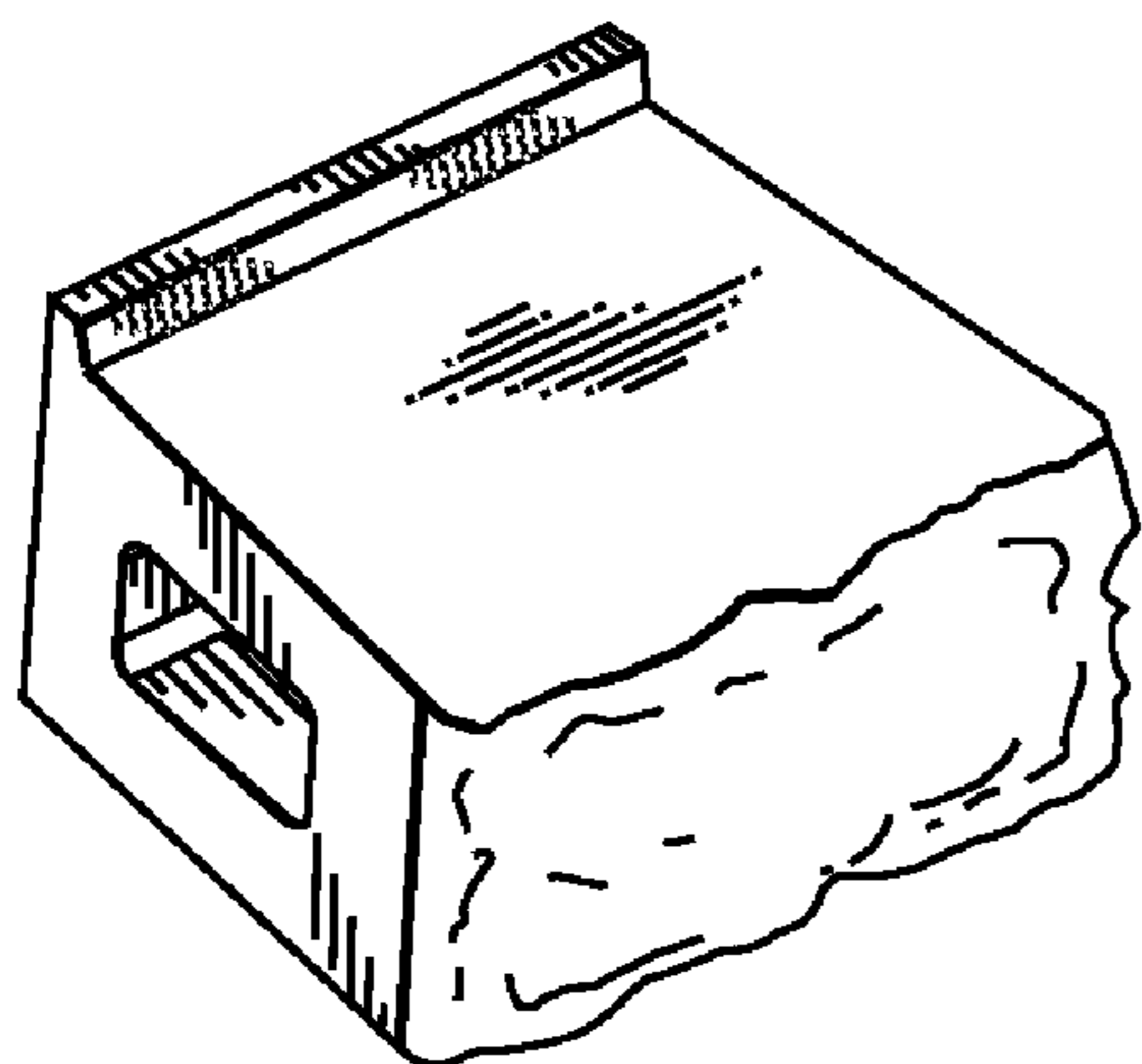
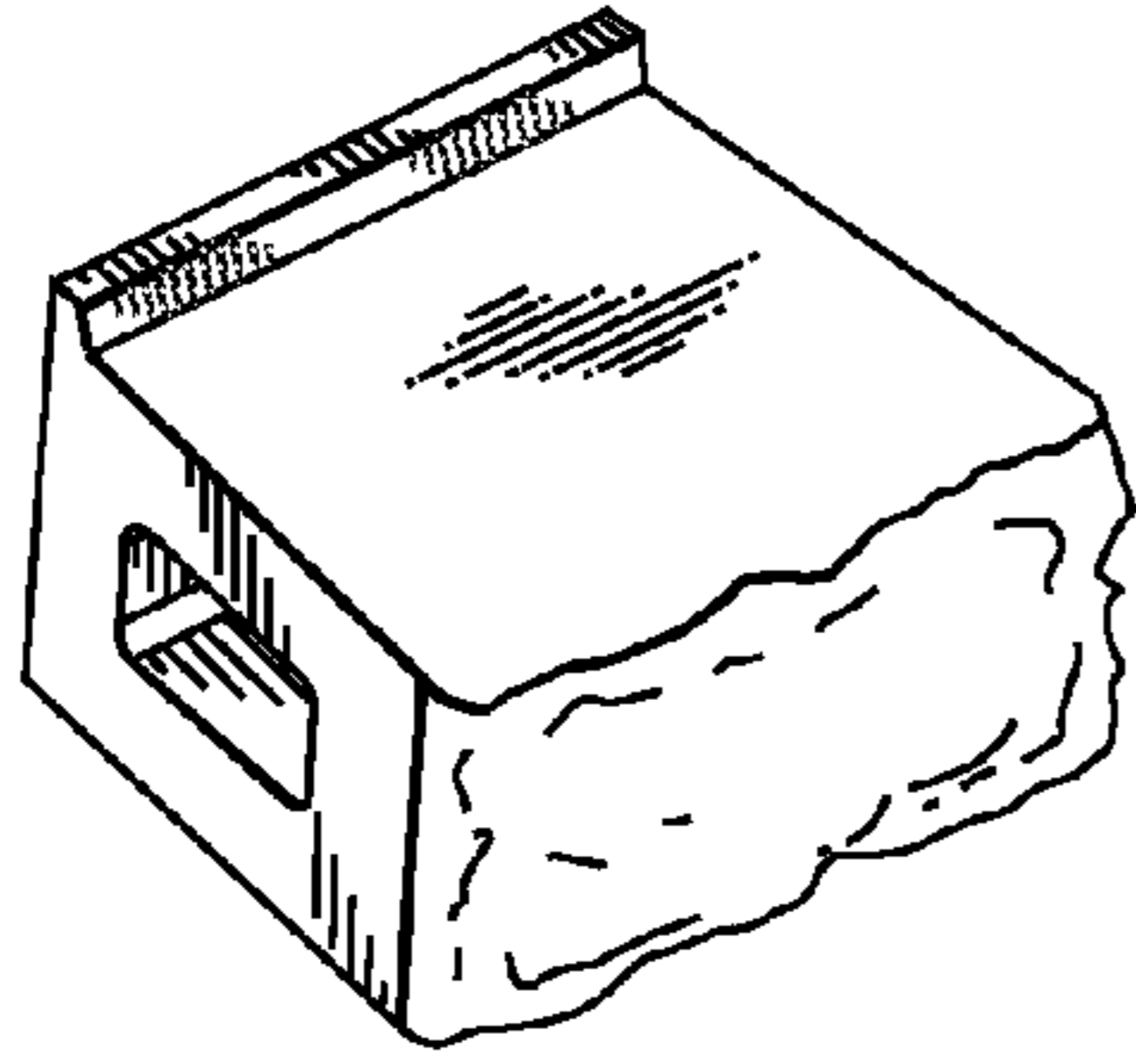


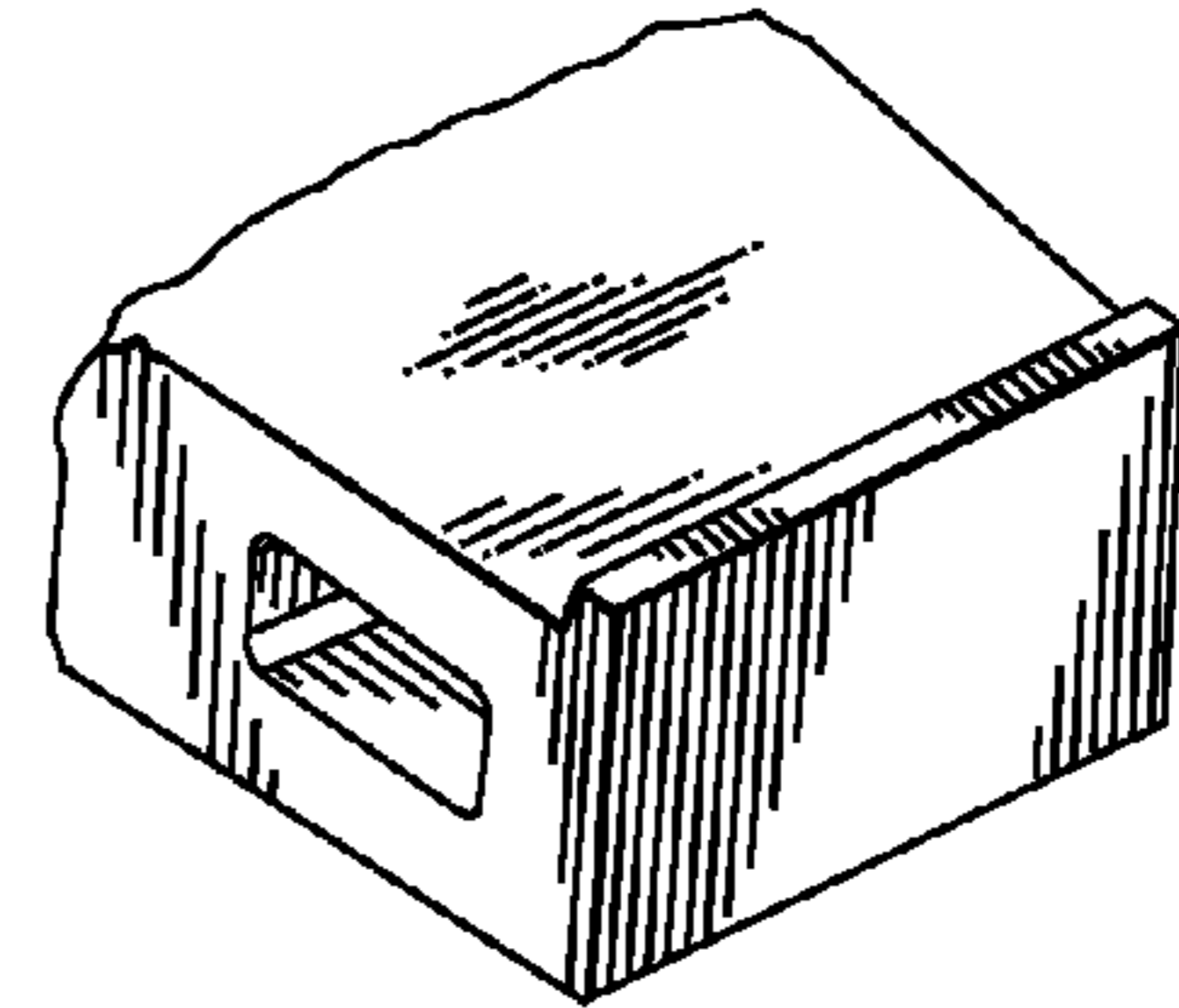

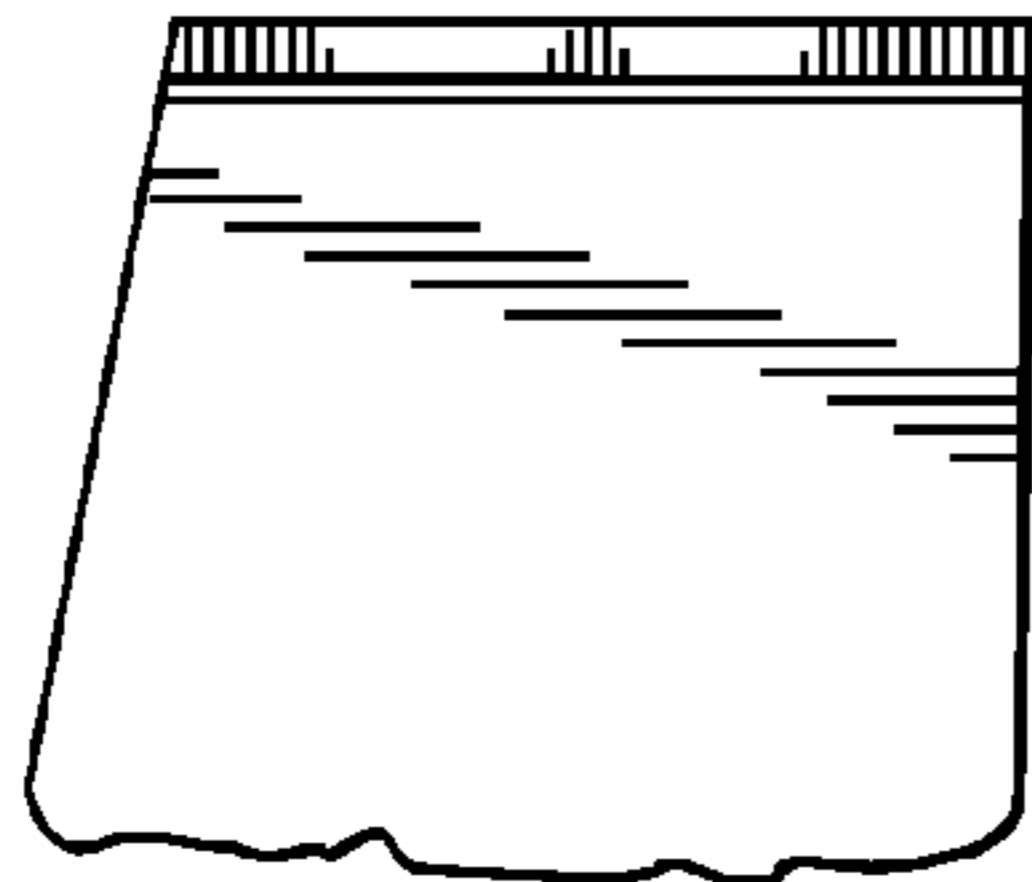

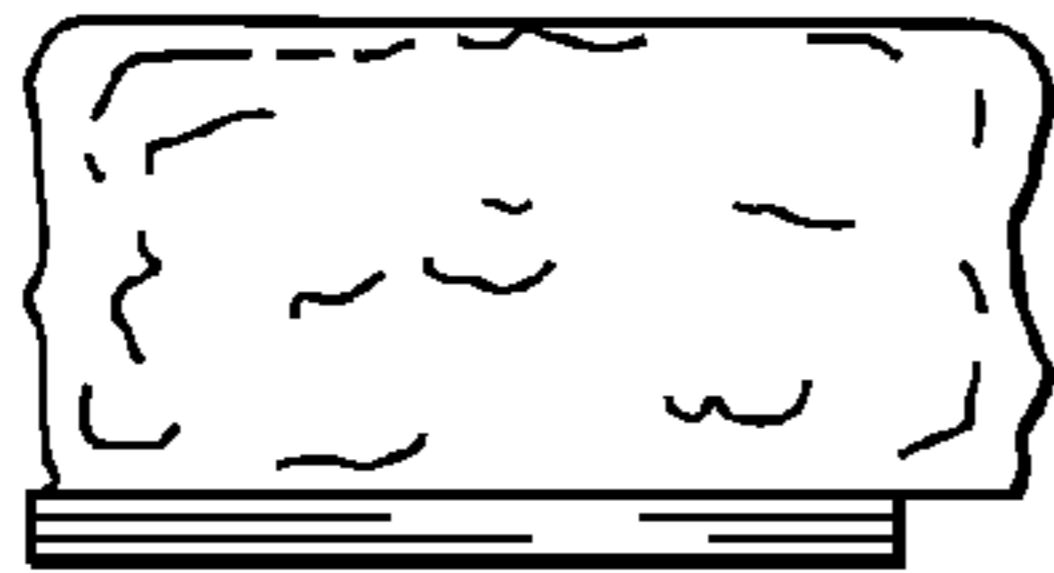

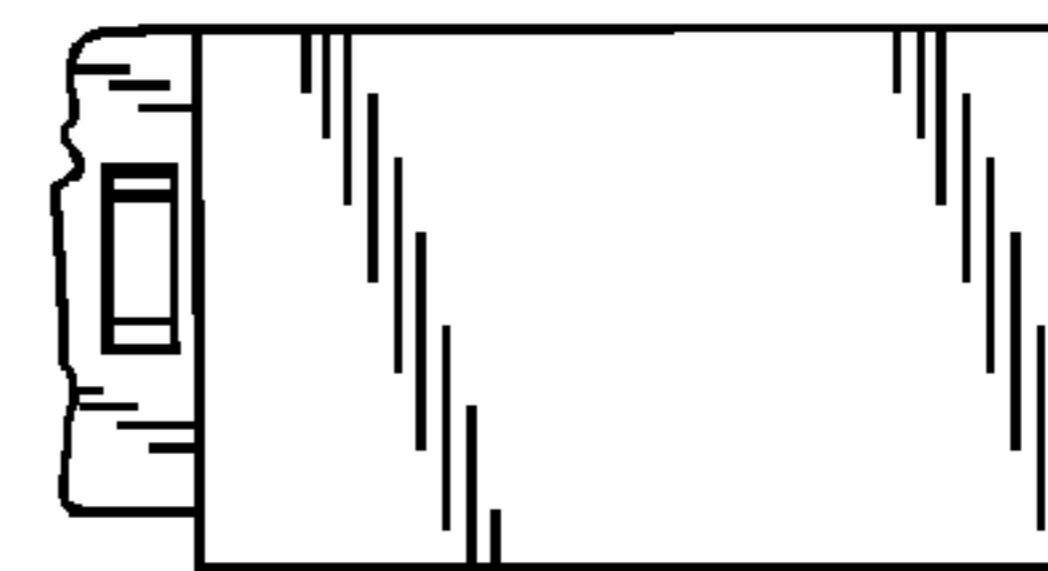

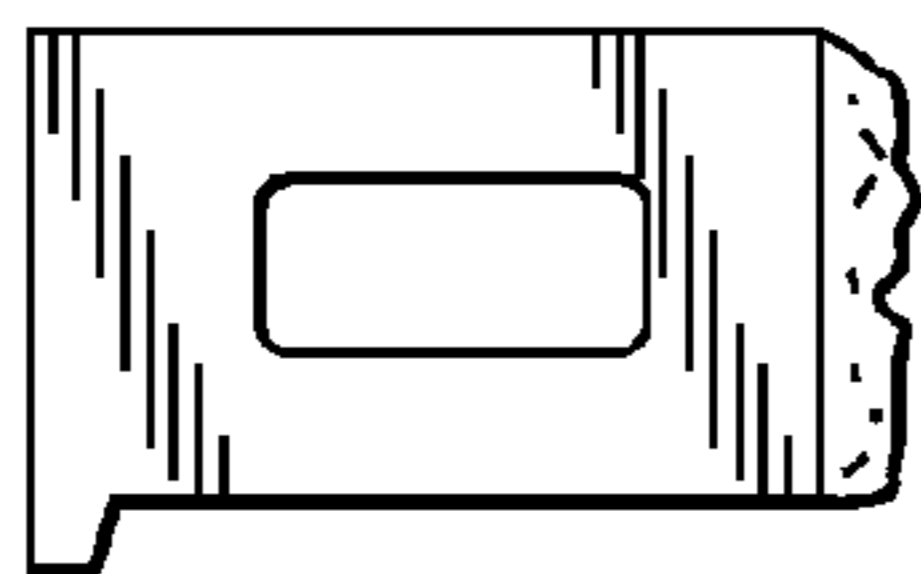

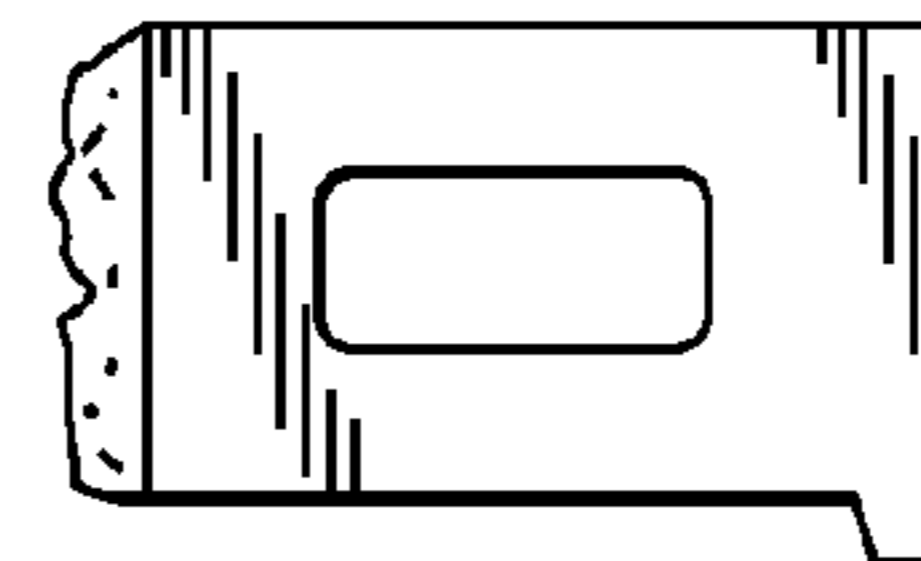
