The ornamental design for a flagstone, as shown and described.

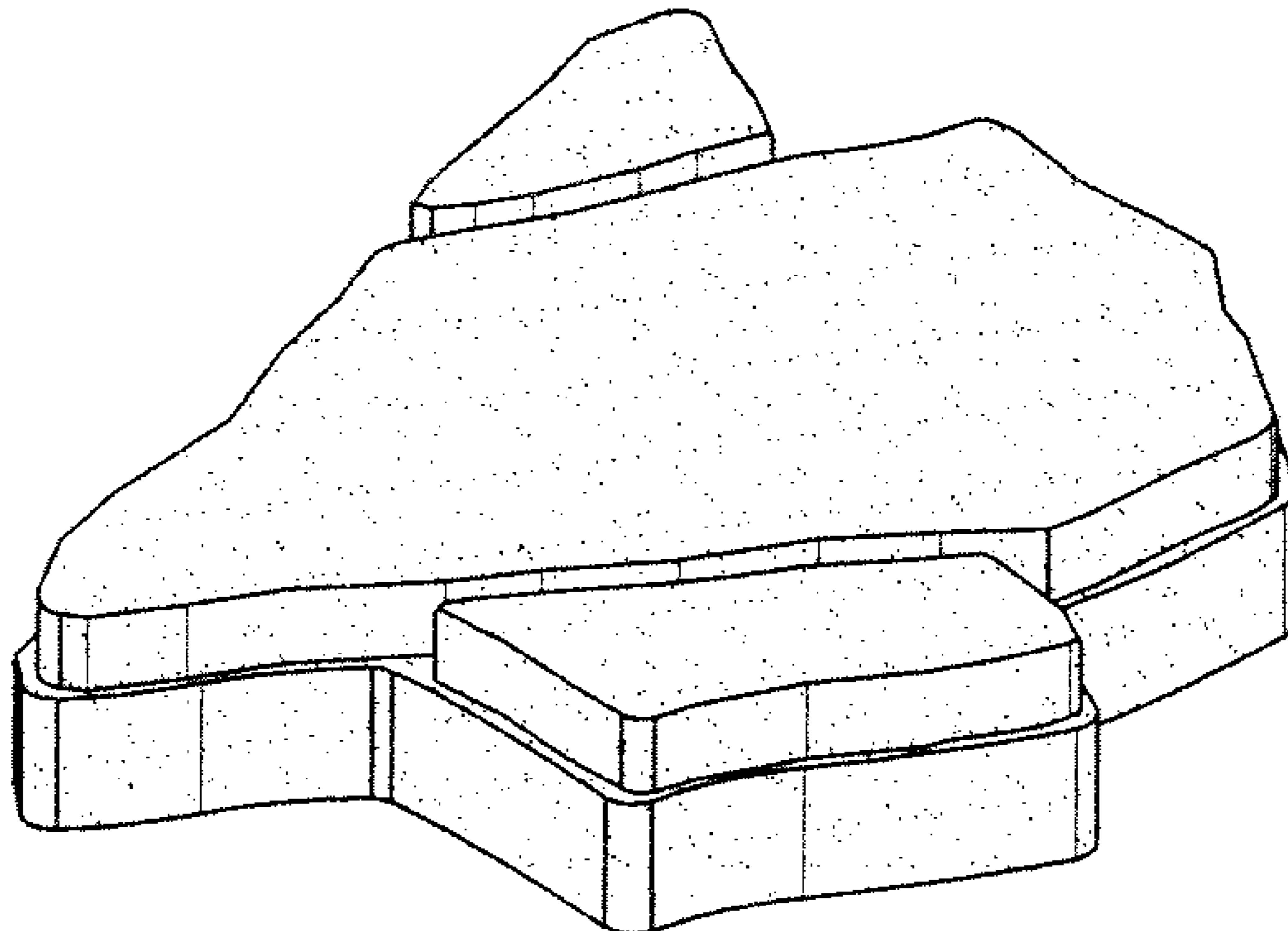
DESCRIPTION

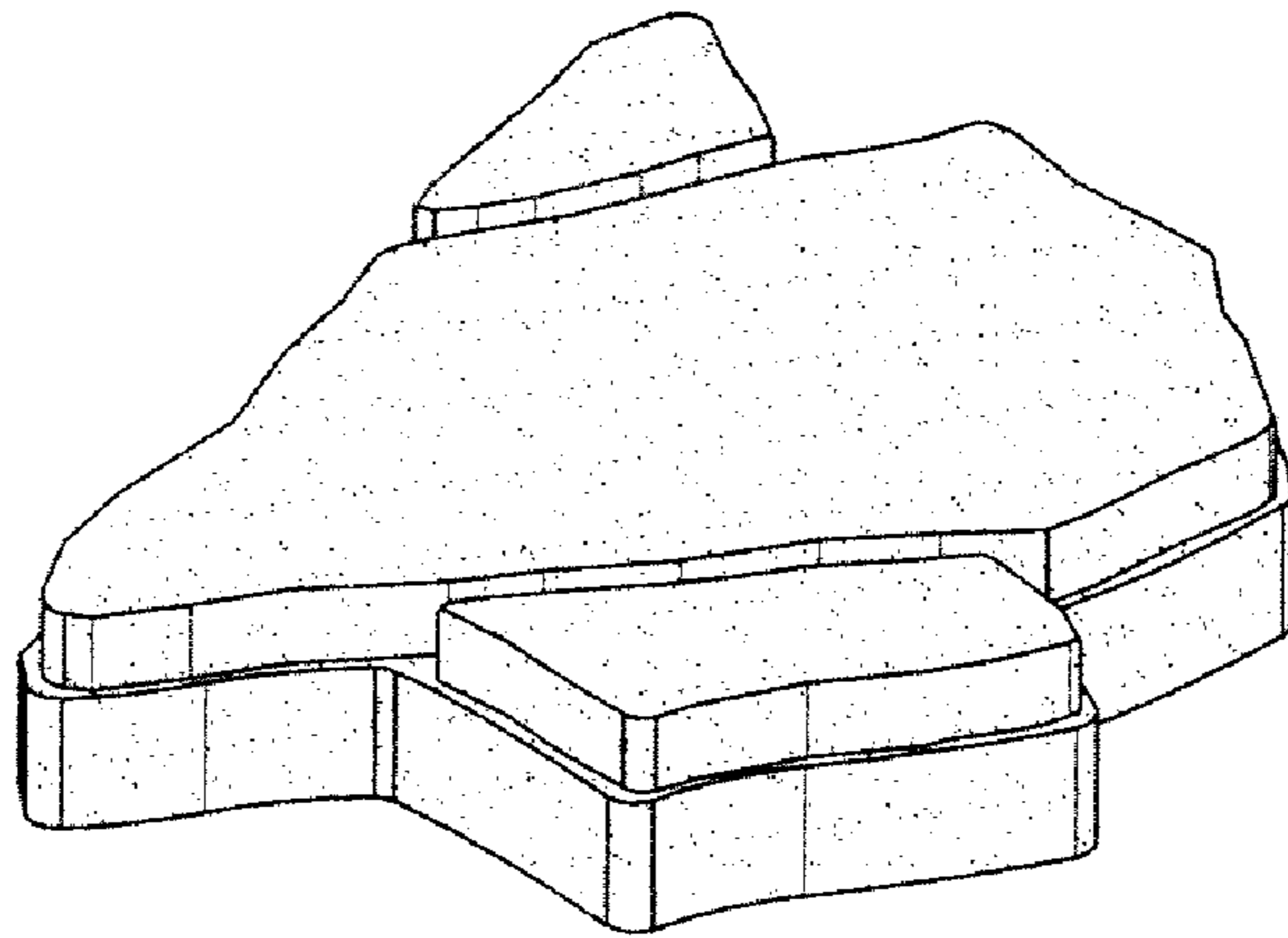

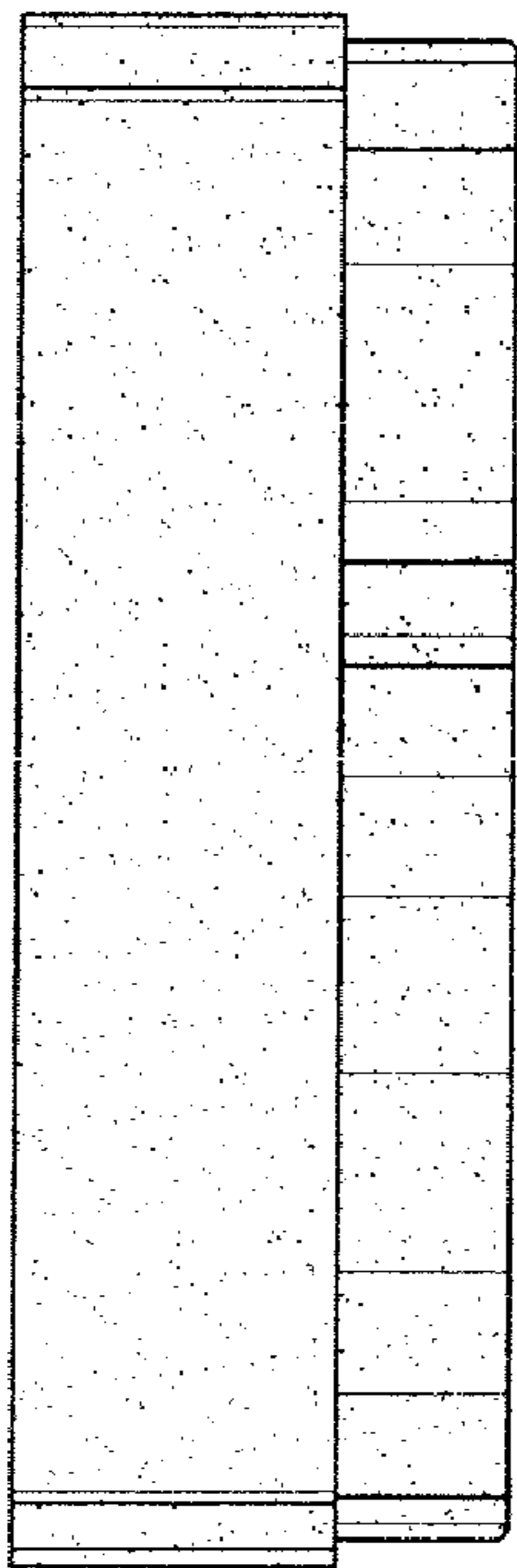

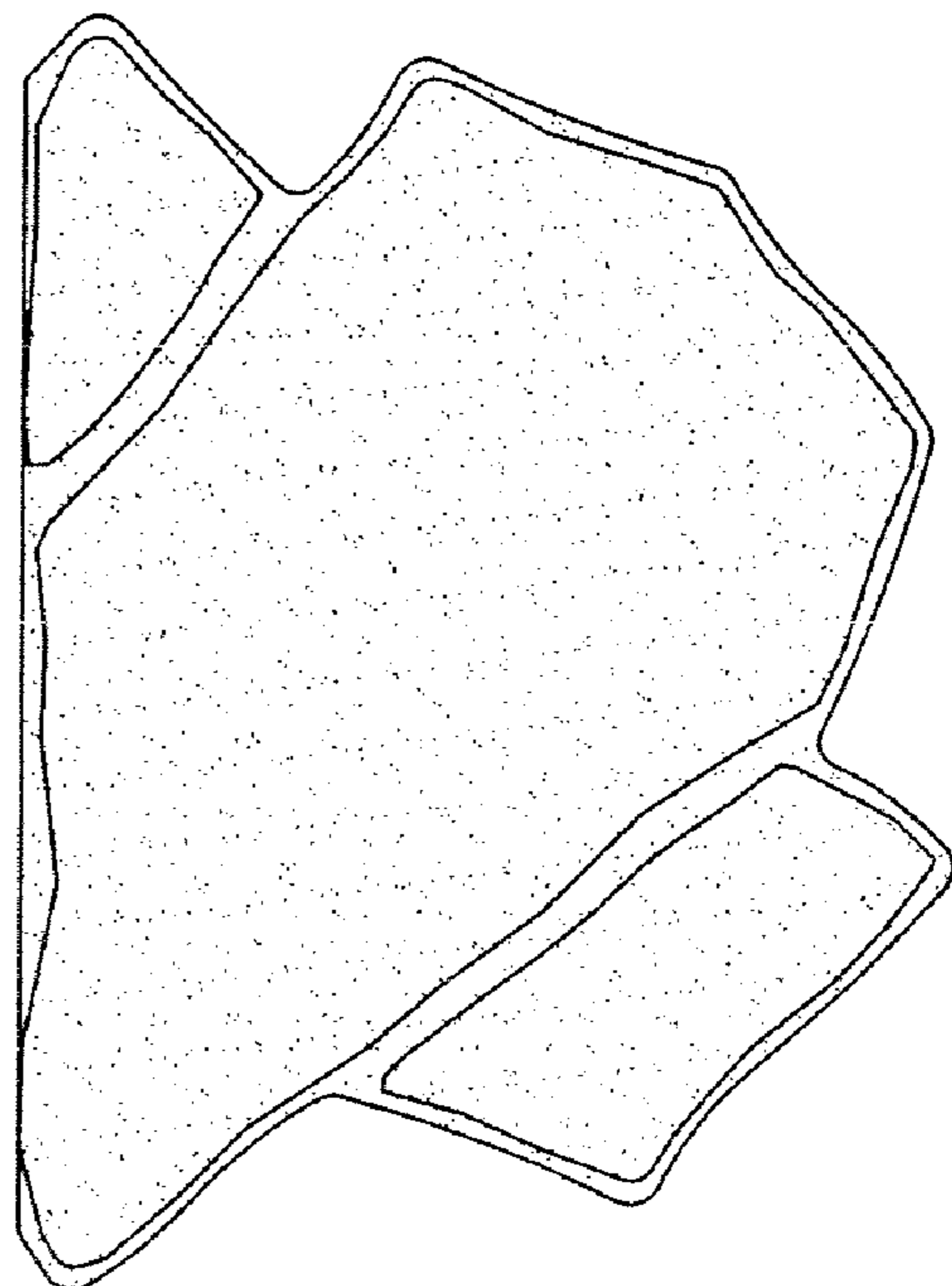
