(57) **CLAIM**

The ornamental design for a resin panel with reinforced translucent wood veneer design, as shown and described in the Figures.

**DESCRIPTION**

FIG. 1 is a facing, perspective view of a resin panel portion incorporating the reinforced translucent wood veneer design as used in a partition structure;

FIG. 2 is a close-up perspective view thereof;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a cross-sectional view of FIG. 3, taken along line 4—4 in FIG. 3;

FIG. 5 is a cross-sectional view of FIG. 3, taken along line 5—5 in FIG. 3;

FIG. 6 is a cross-sectional view of FIG. 3, taken along line 6—6 in FIG. 3;

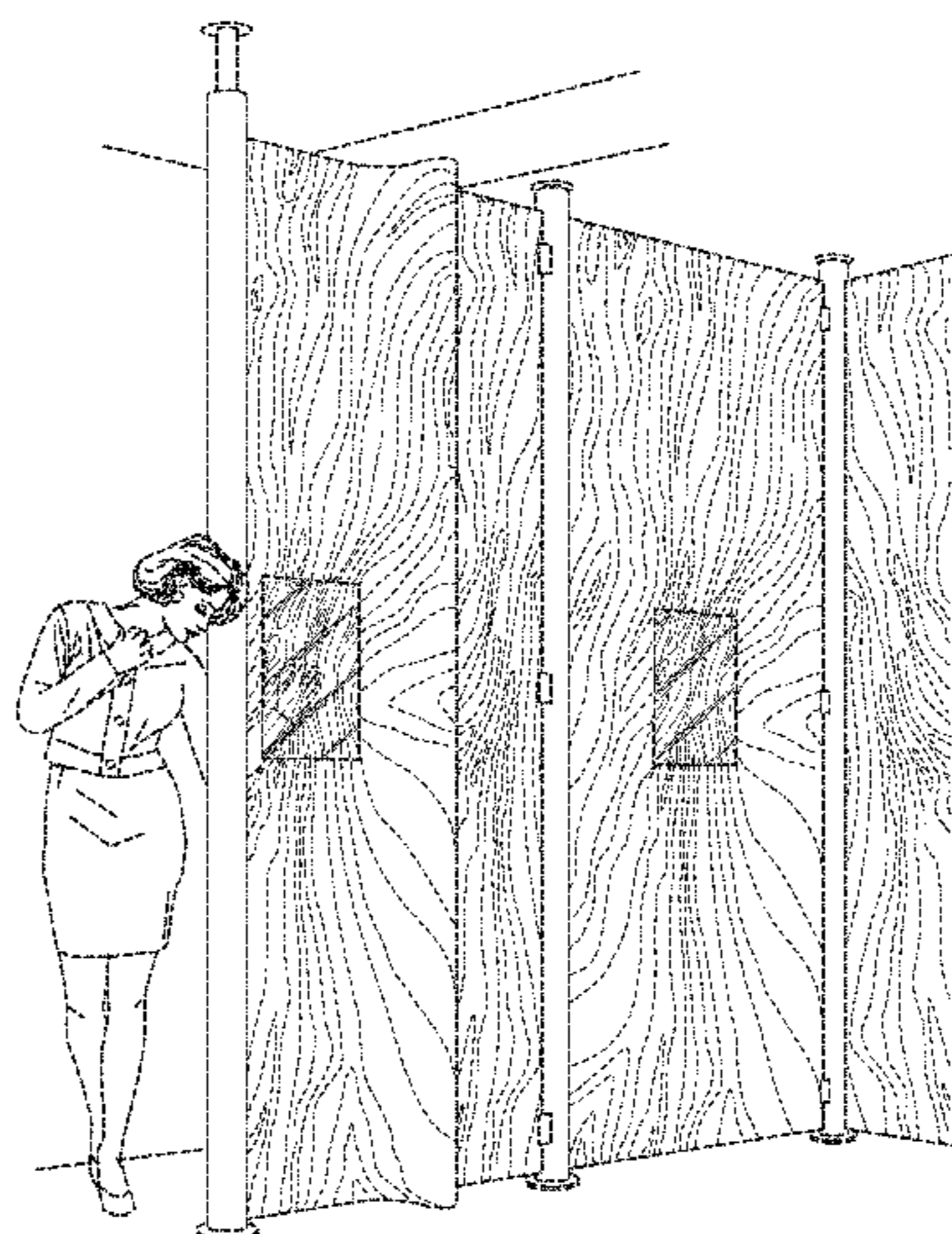
FIG. 7 is a cross-sectional view of FIG. 3, taken along line 7—7 in FIG. 3; and,

FIG. 8 is an enlarged cross-sectional view shown along line 8—8 in FIG. 7.

The rear of the resin panel with reinforced translucent wood veneer design is unornamented.

The broken lines showing environment in the drawings are included for illustrative purposes only and form no part of the claimed design. The outer broken line boundaries in Figures depicting the boundaries of the claimed design indicate that a specific length, width, and shape form no part of the claimed design and are for illustrative purposes only.

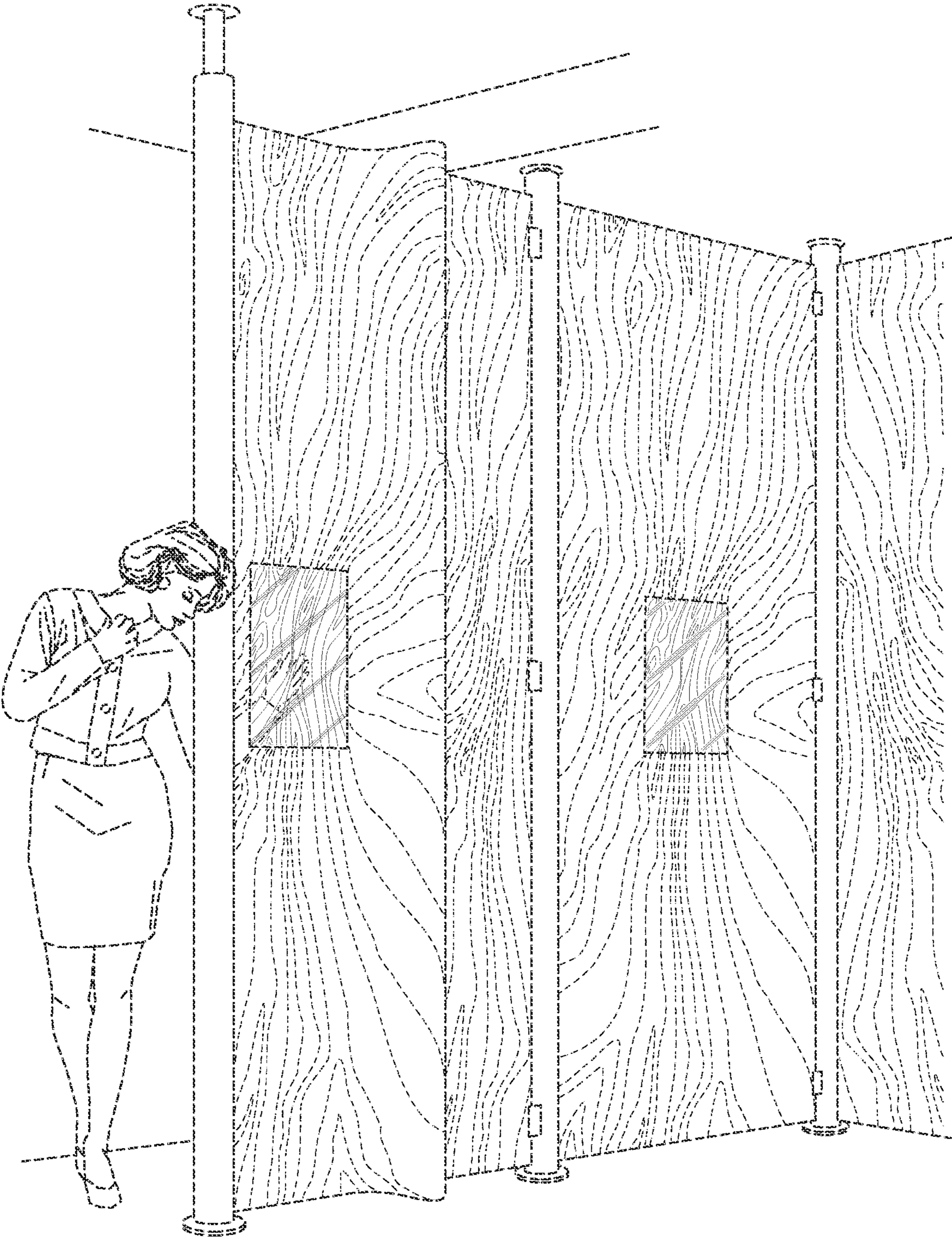
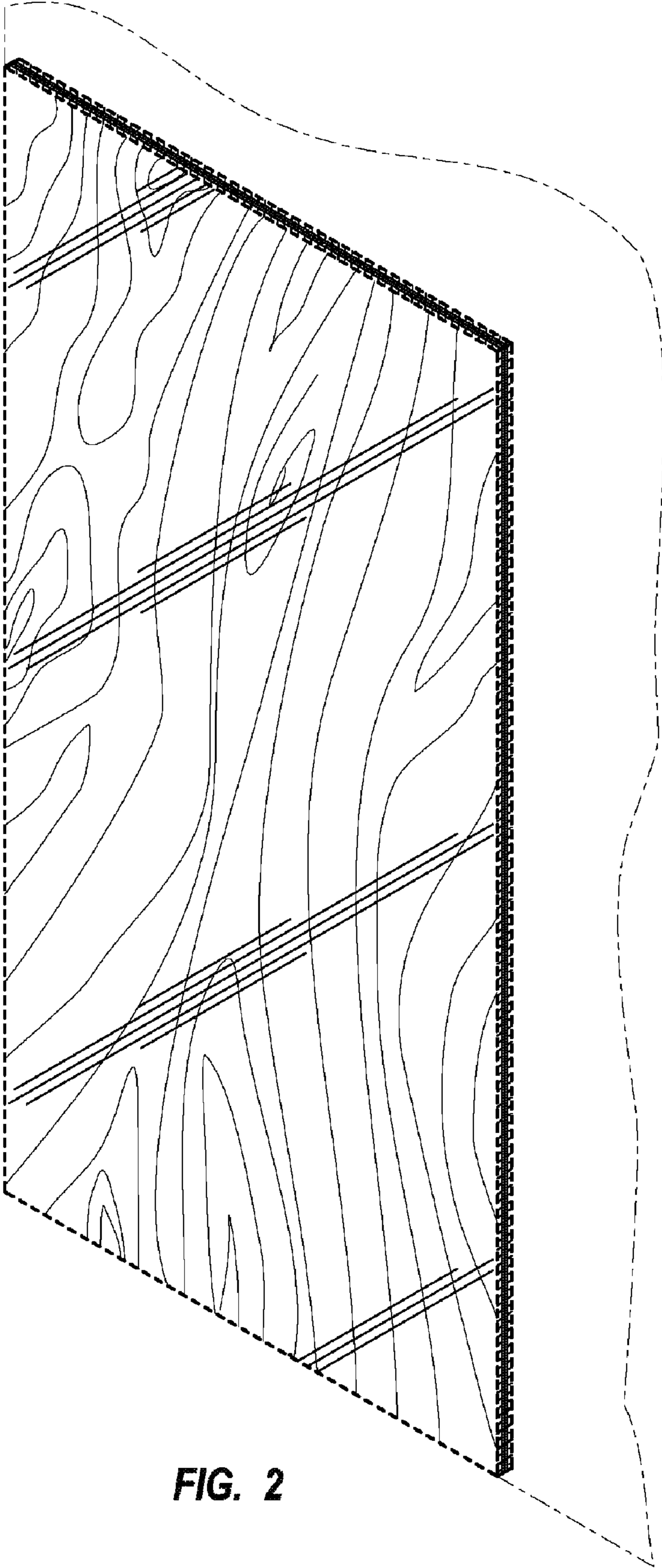
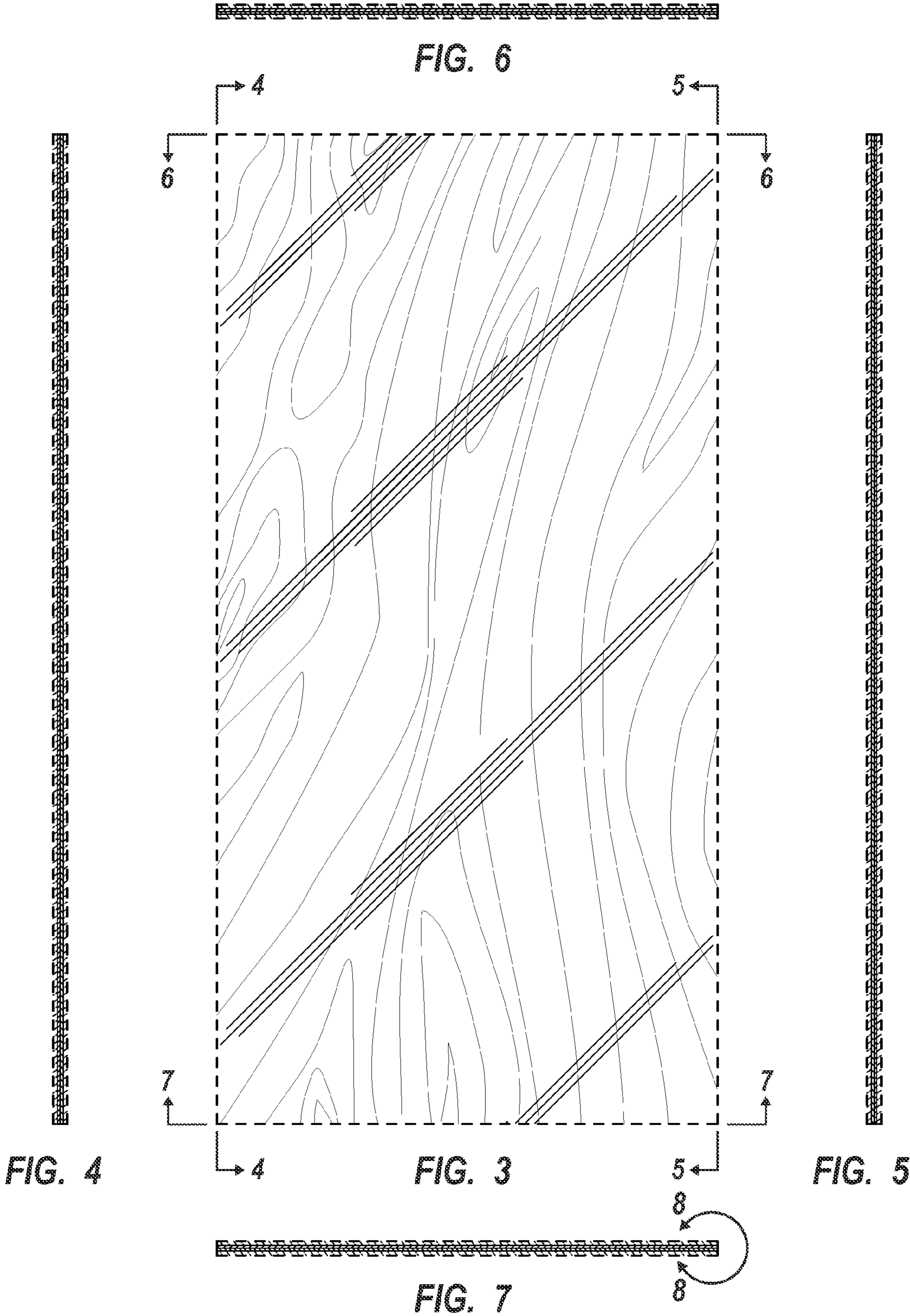

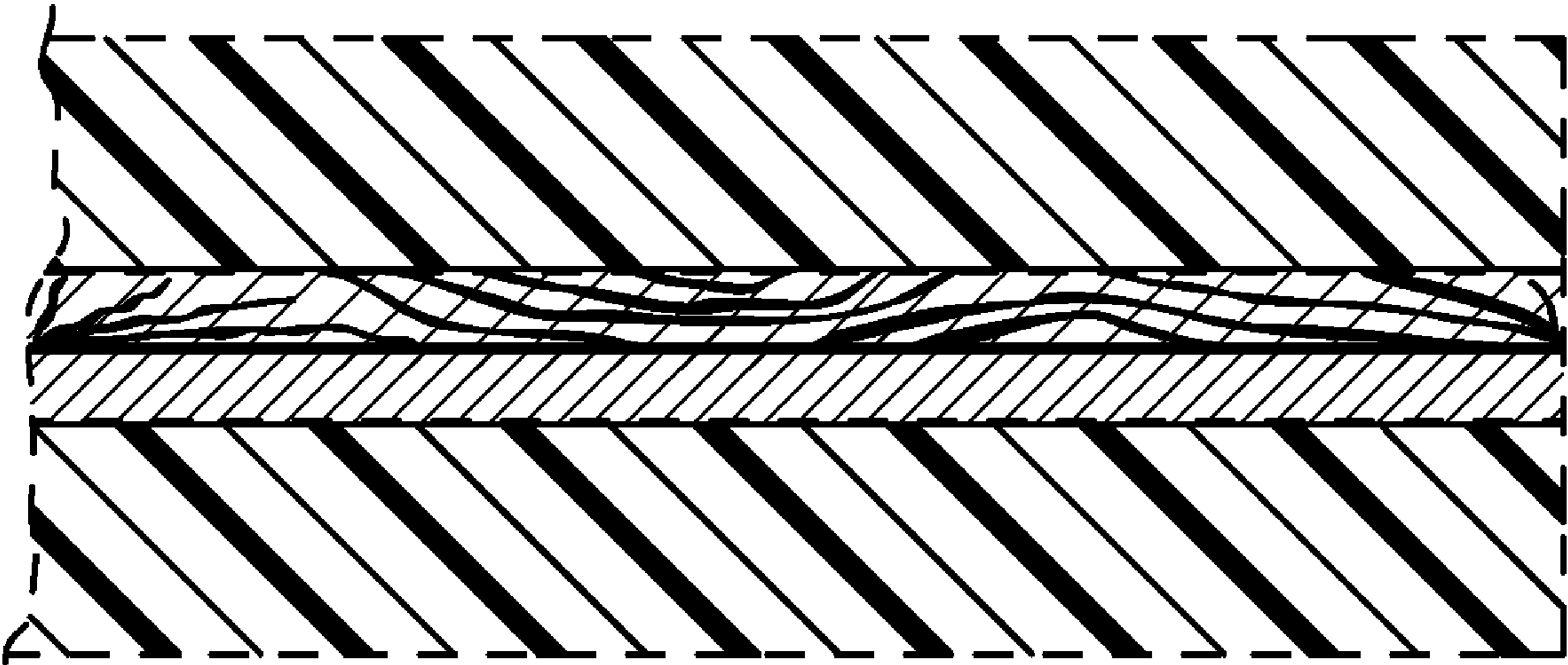
