(57) **CLAIM**

The ornamental design for a hair band, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a hair band from top-right;
FIG. 2. is a perspective view thereof from bottom-right;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5. is a top view thereof;
FIG. 6 is a bottom view thereof;
FIG. 7 is a right-hand side view thereof;
FIG. 8 is a sectional view taken along the line 8—8 of FIG. 3;
FIG. 9 is a perspective view showing how the hair band is used; and,
FIG. 10 is a front view showing how the hair band is used.

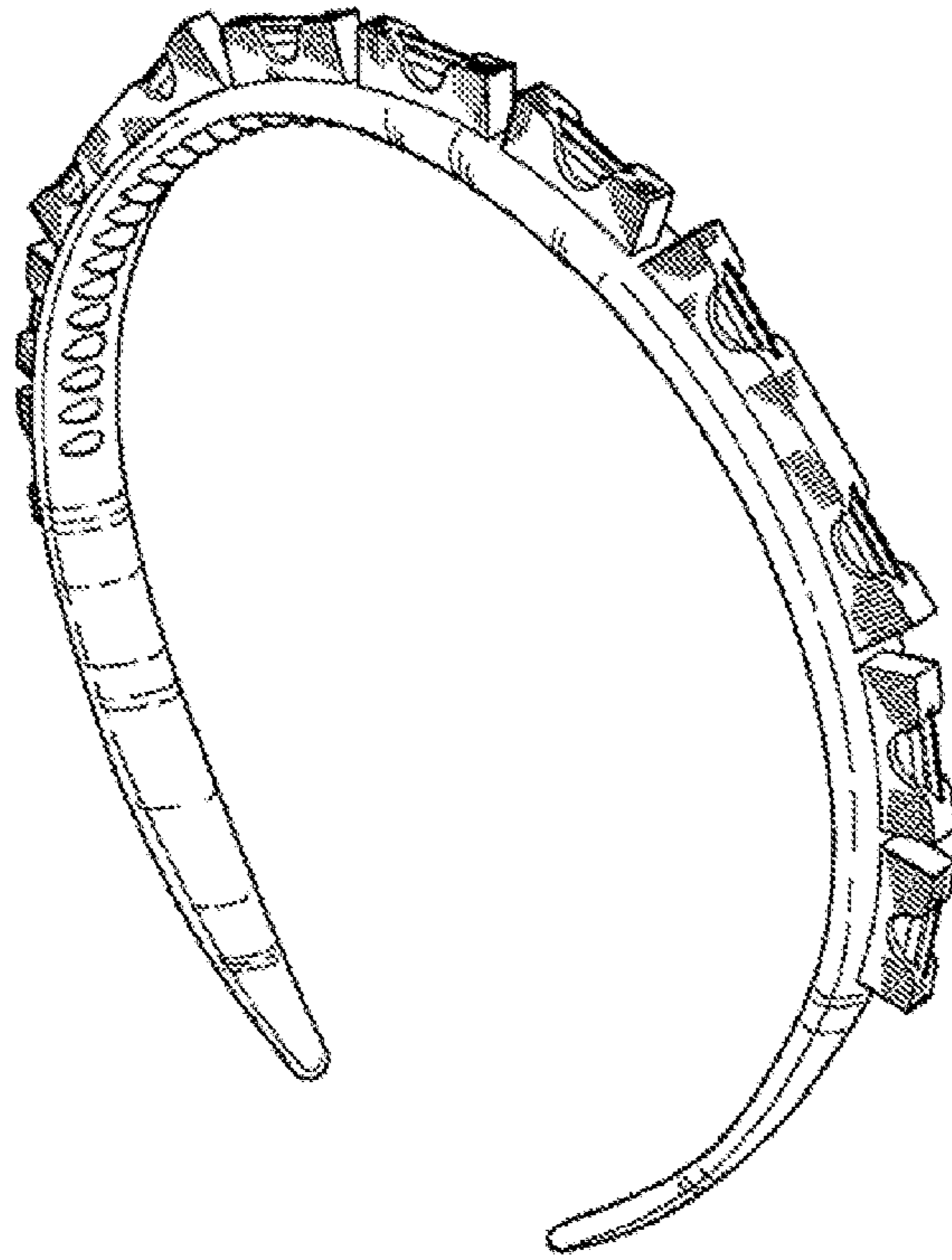

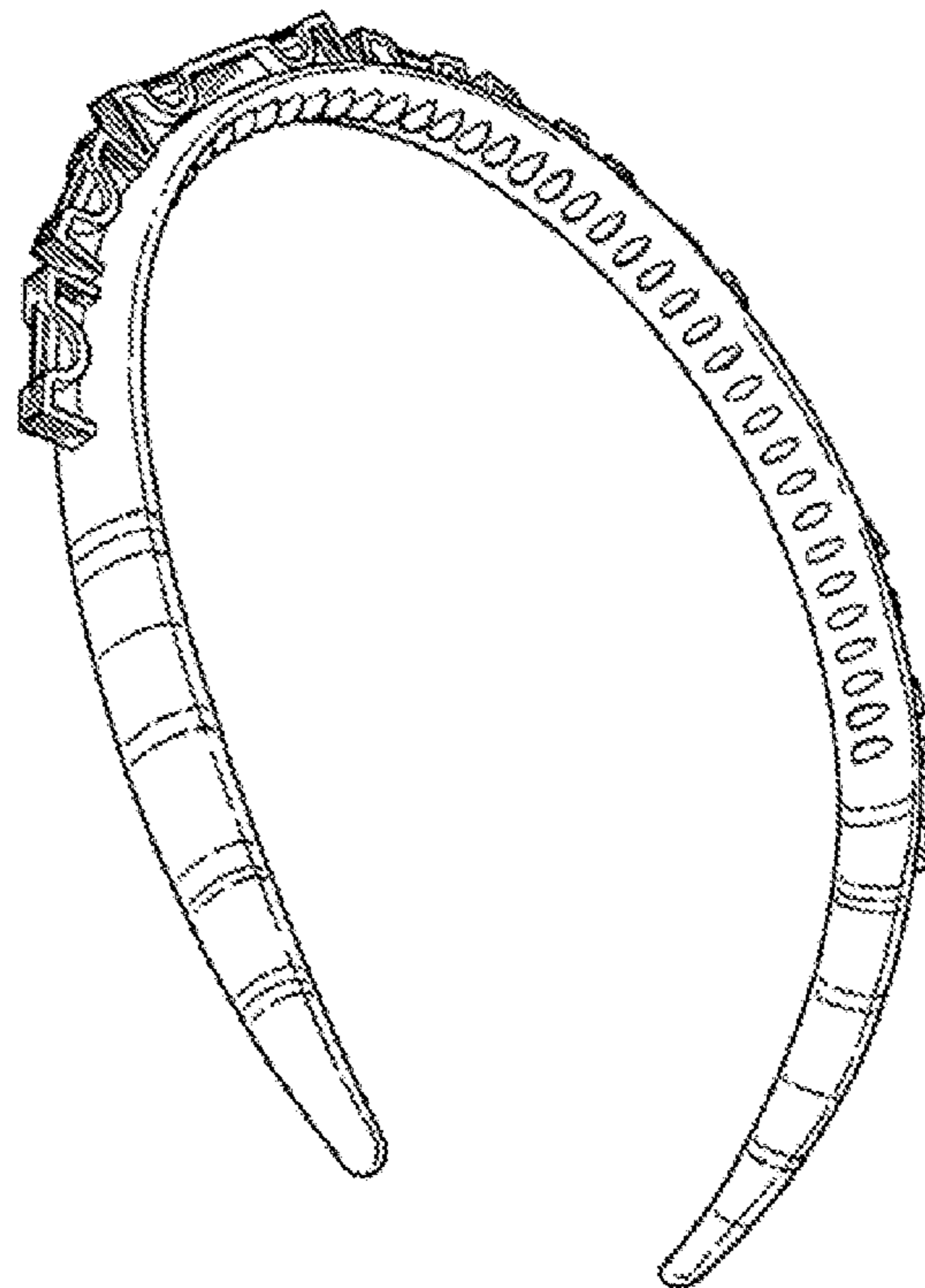

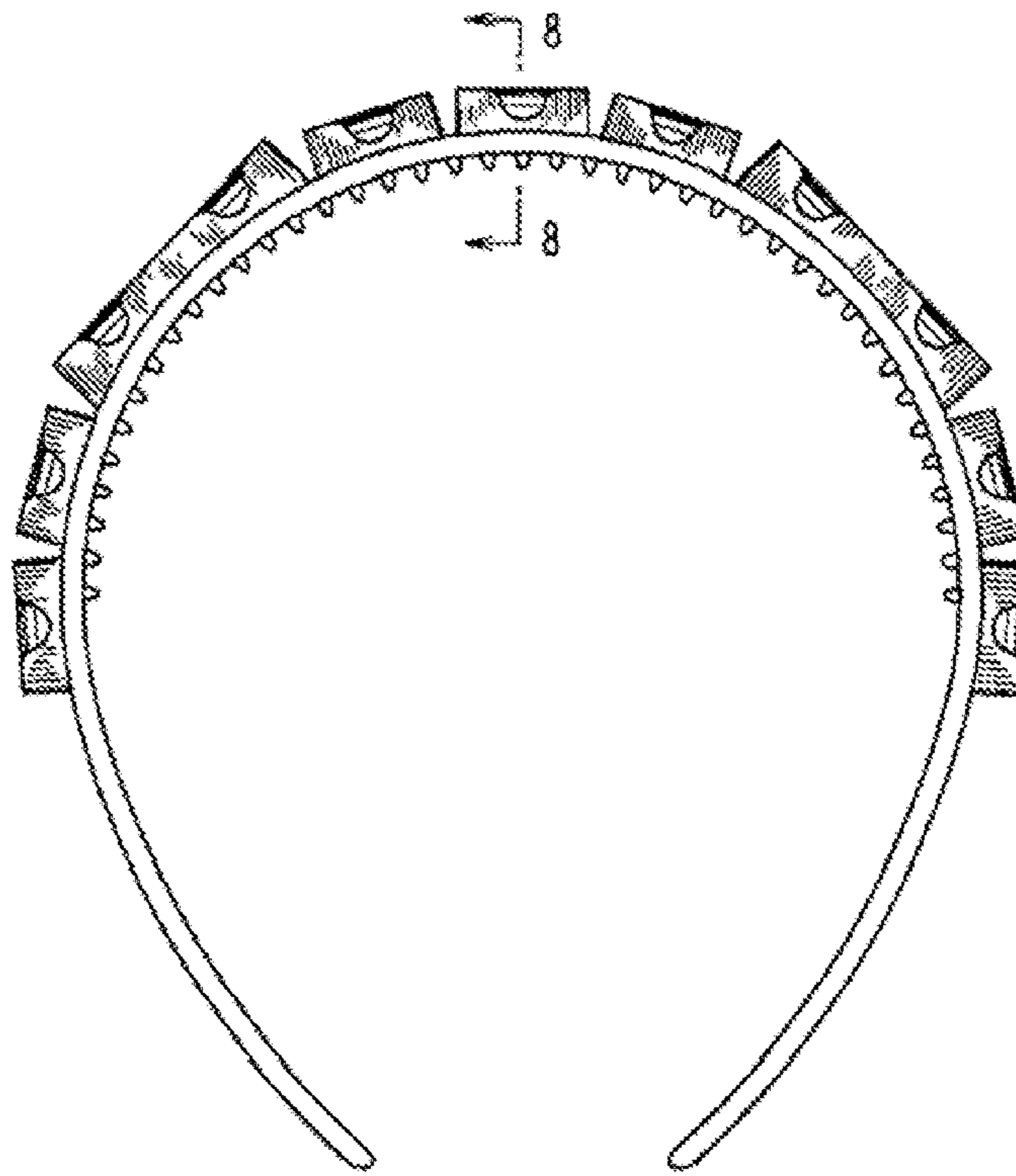

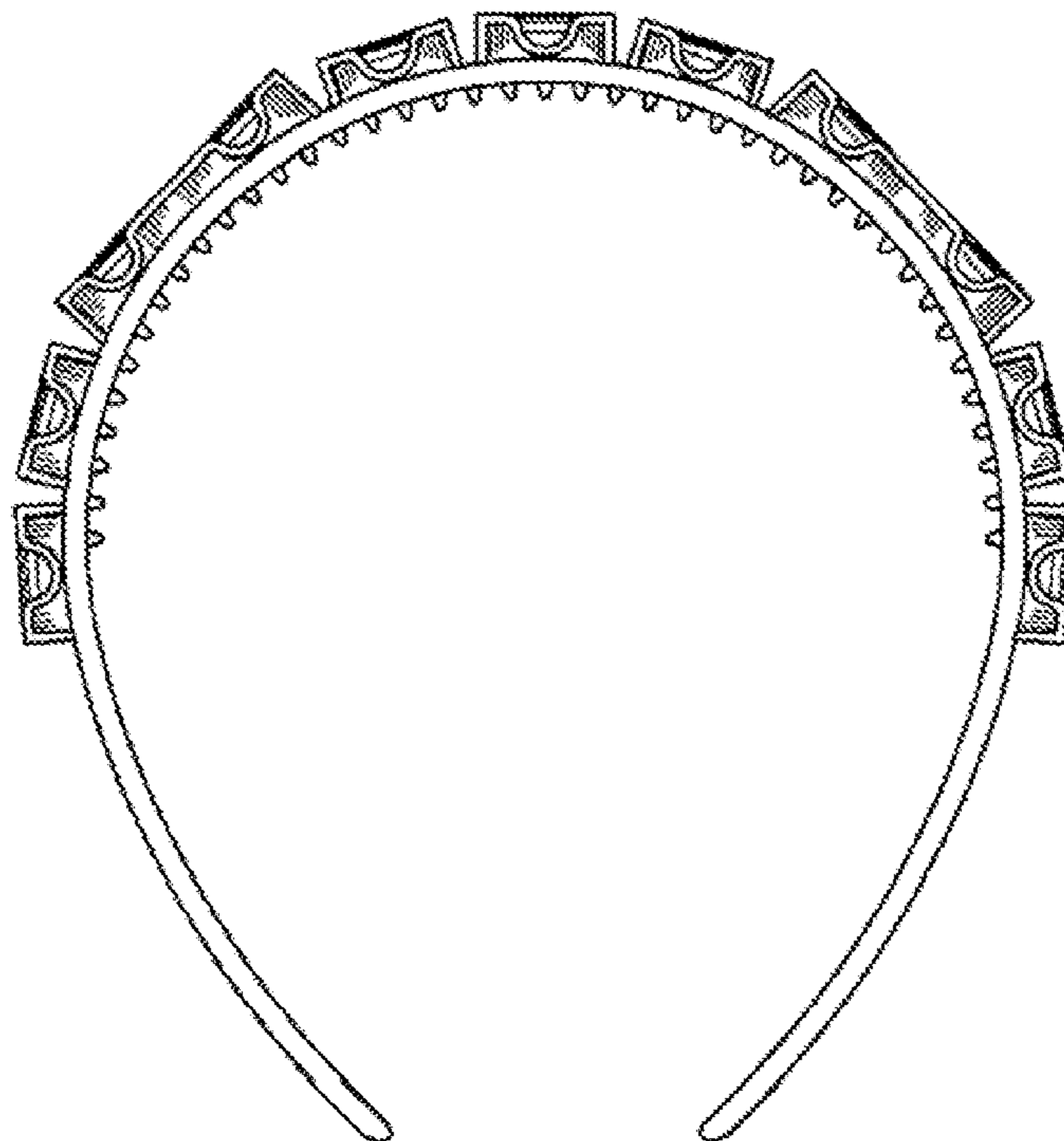

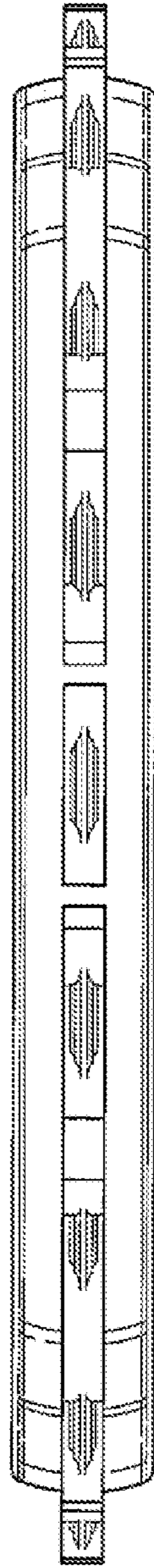

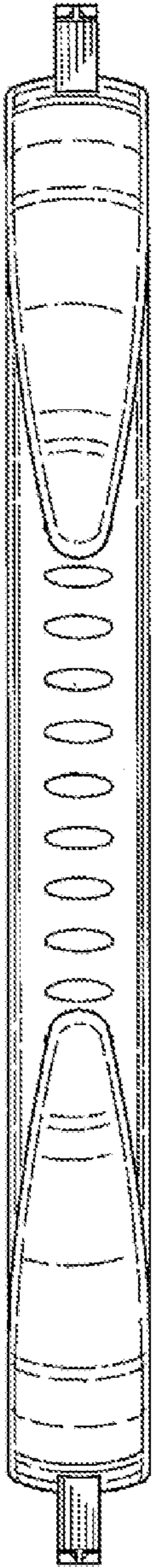

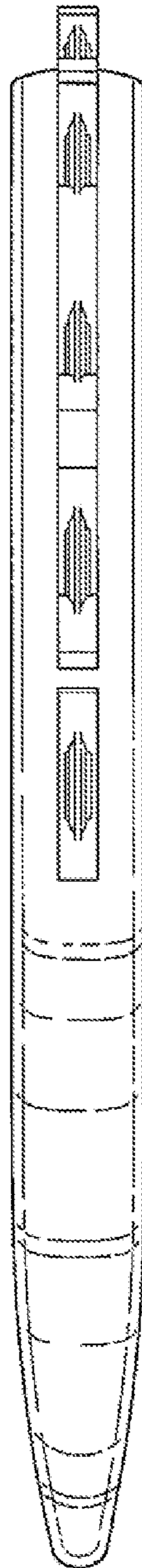

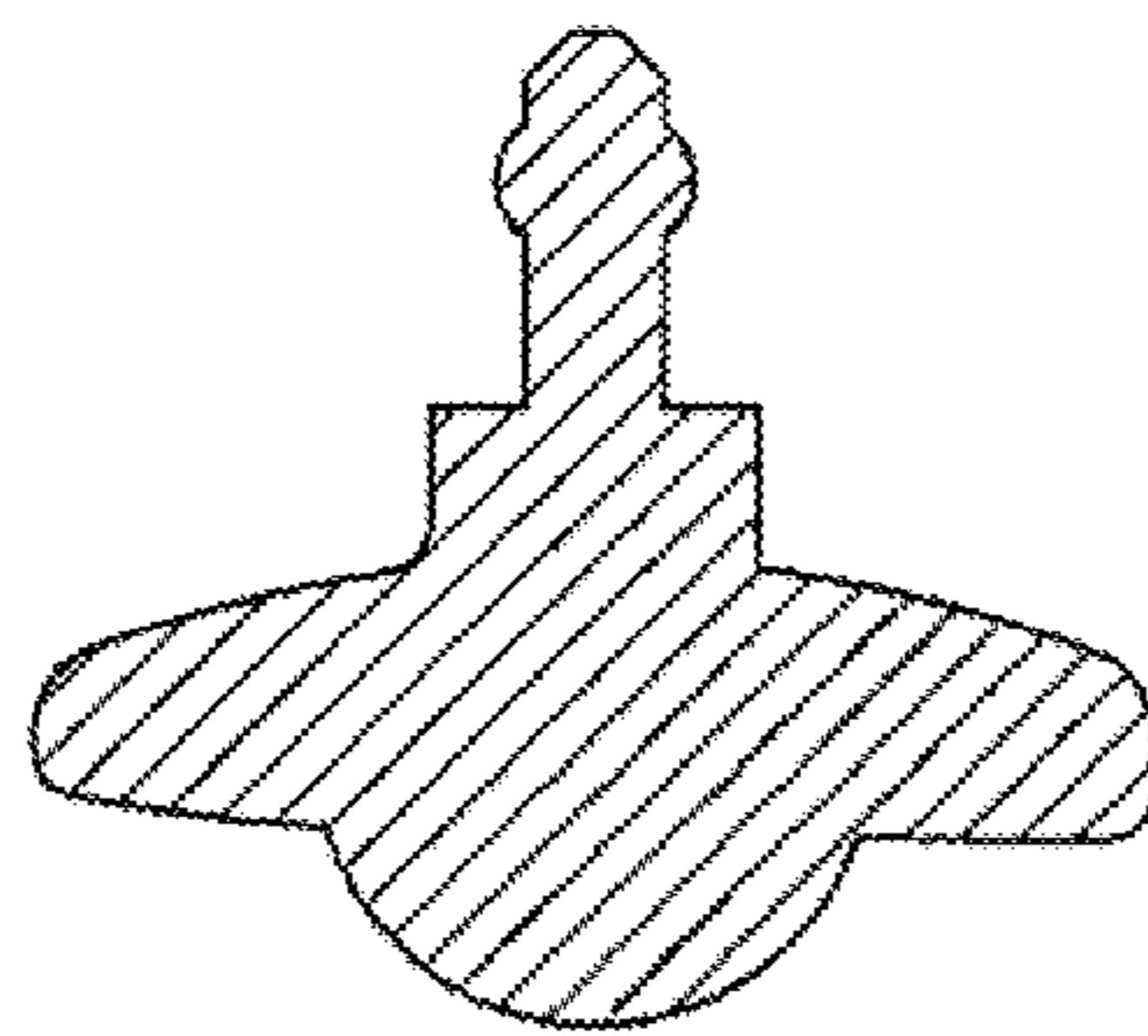

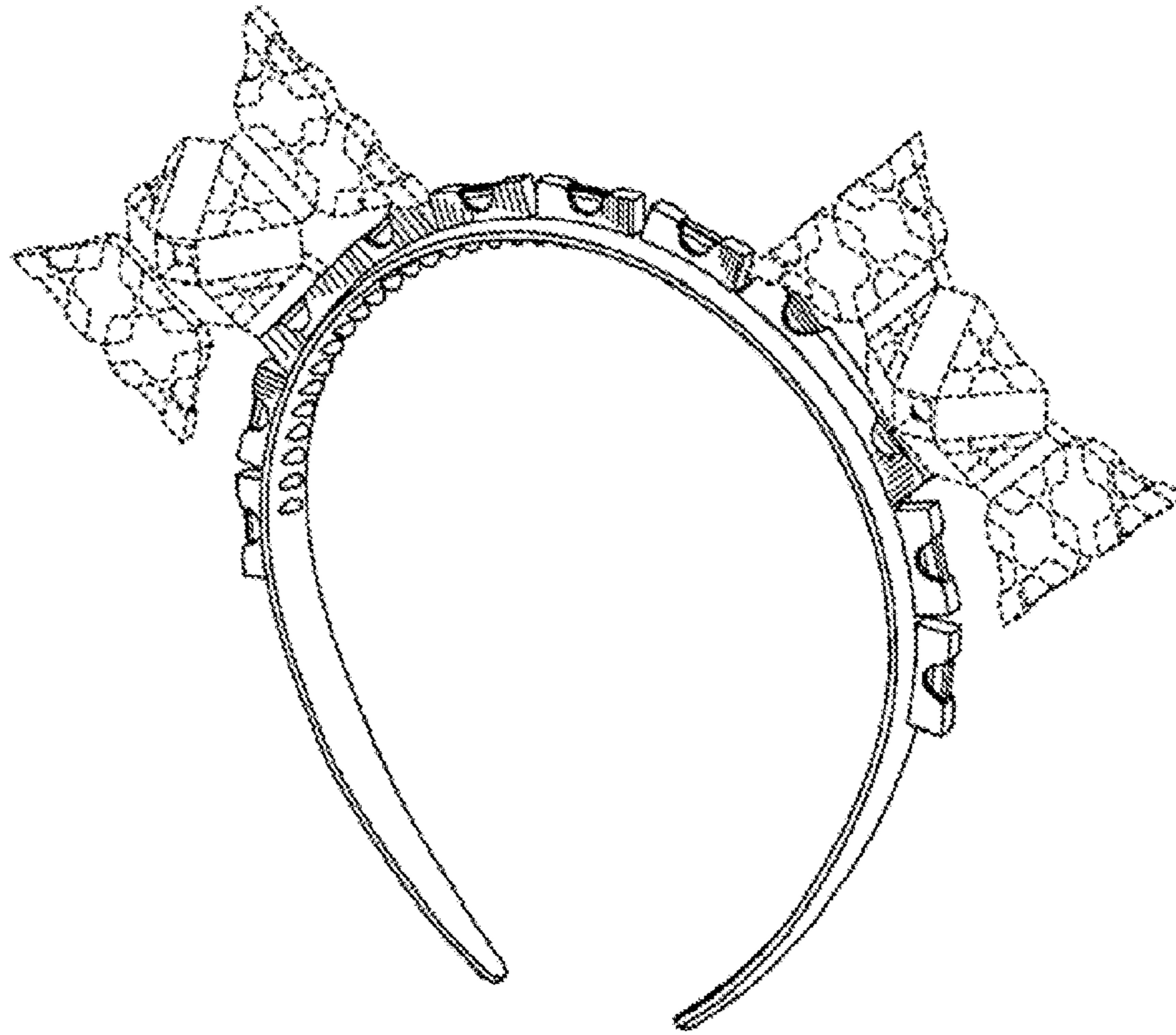
