(57) **CLAIM**

We claim the ornamental design for a sea dolphin-shaped food product, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a dolphin-shaped food product showing our new design;

FIG. 2 is a front elevation view of the dolphin-shaped food product of FIG. 1, the back elevation view being the mirror image thereof;

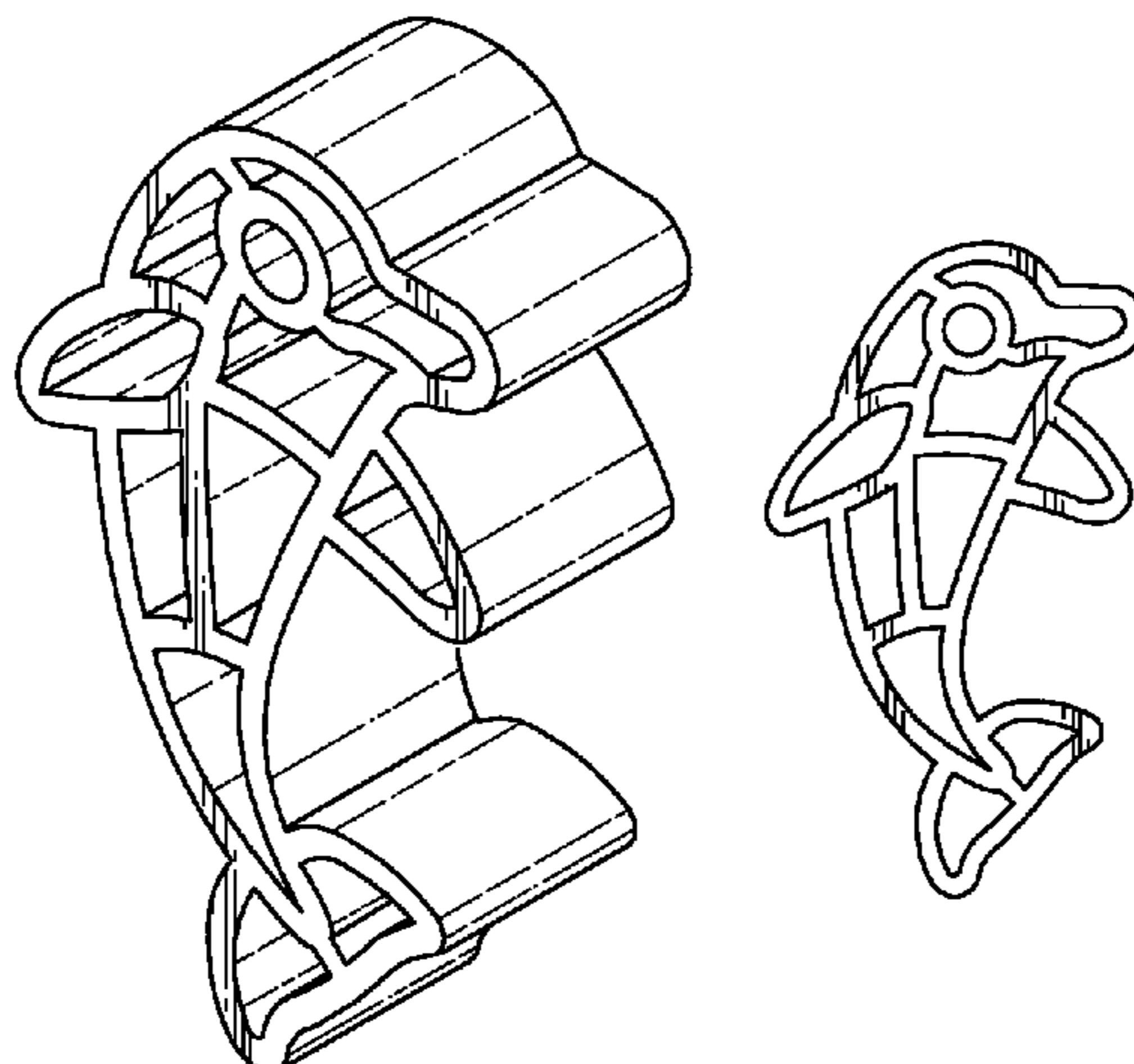
FIG. 3 is a left side elevation view of the dolphin-shaped food product of FIG. 1;

FIG. 4 is a right side elevation view of the dolphin-shaped food product of FIG. 1;

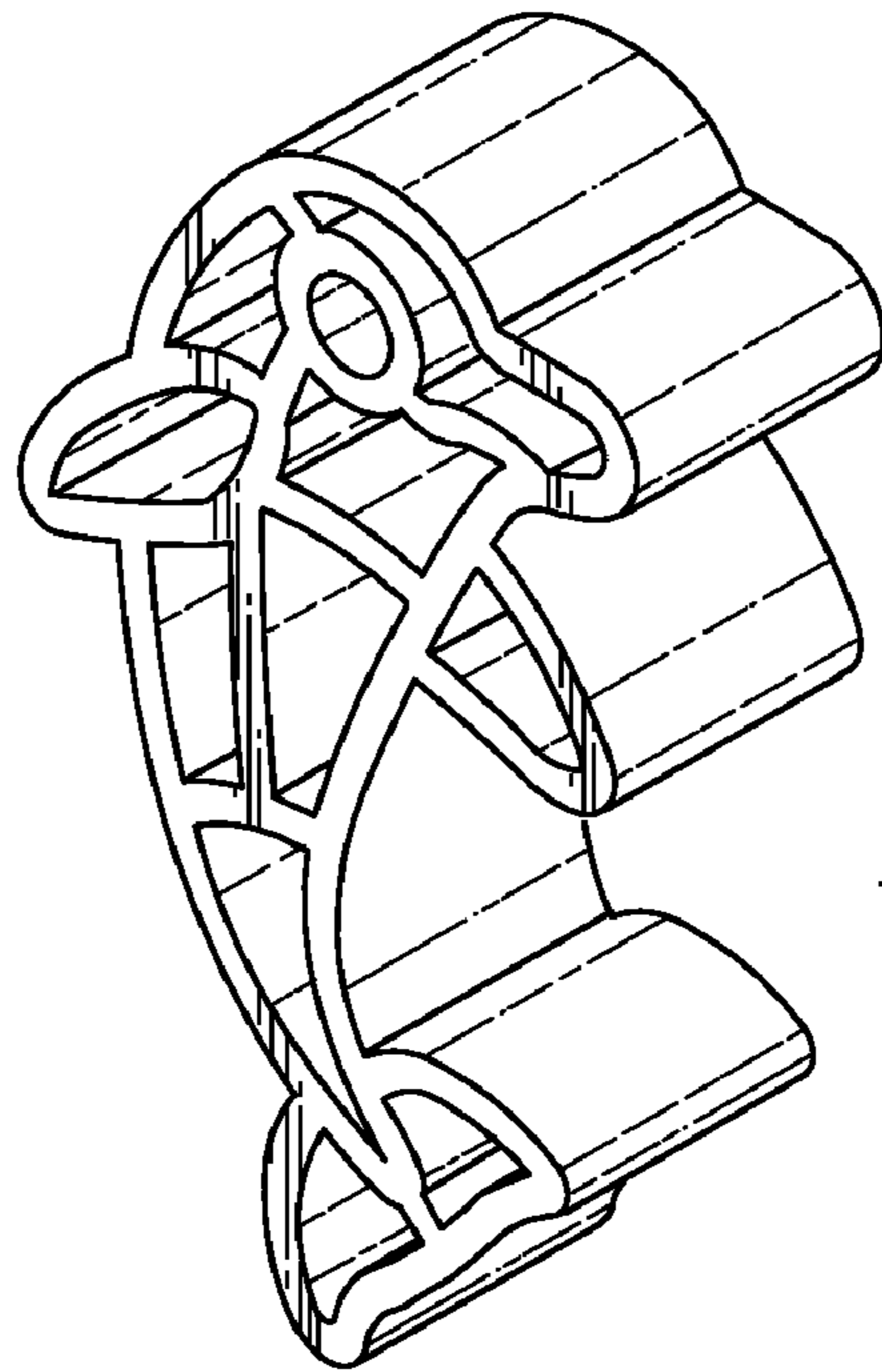

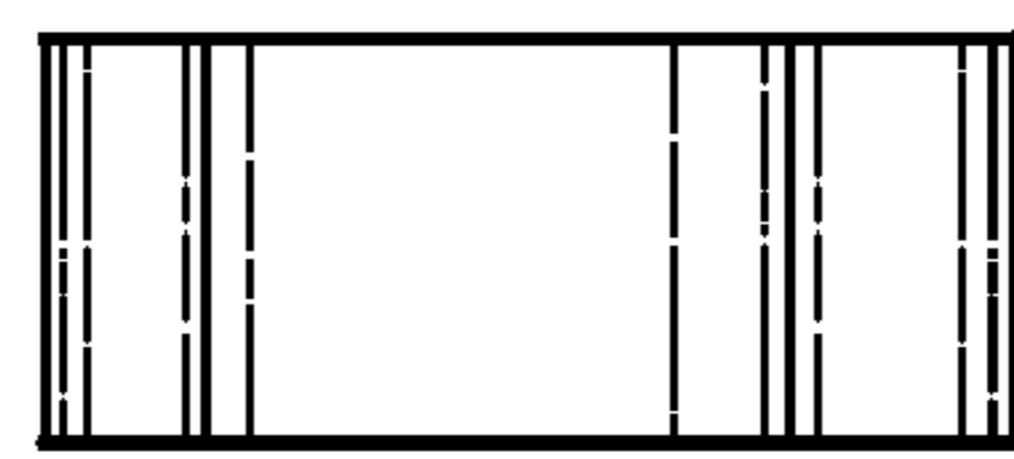

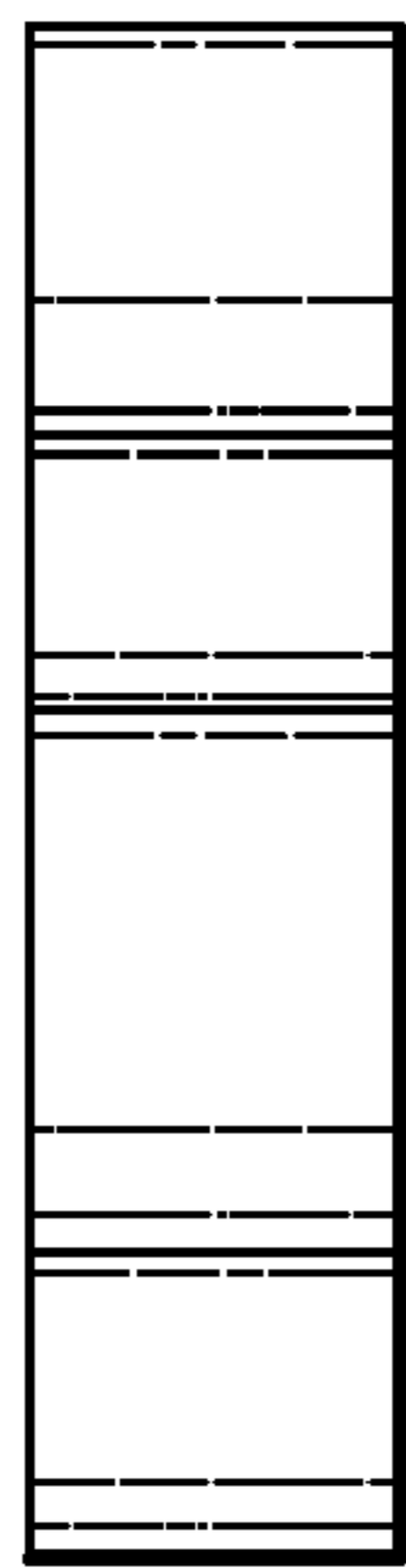

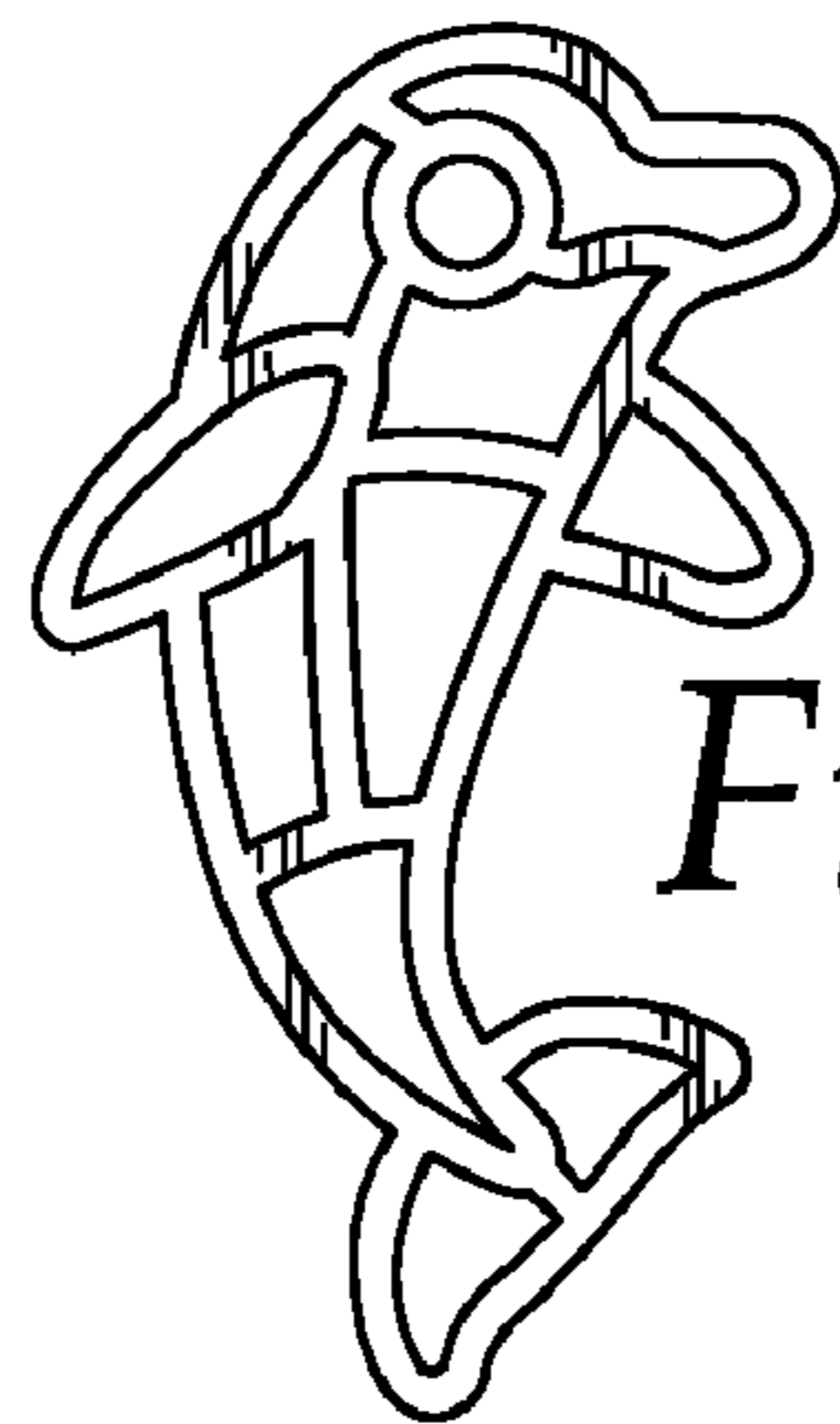

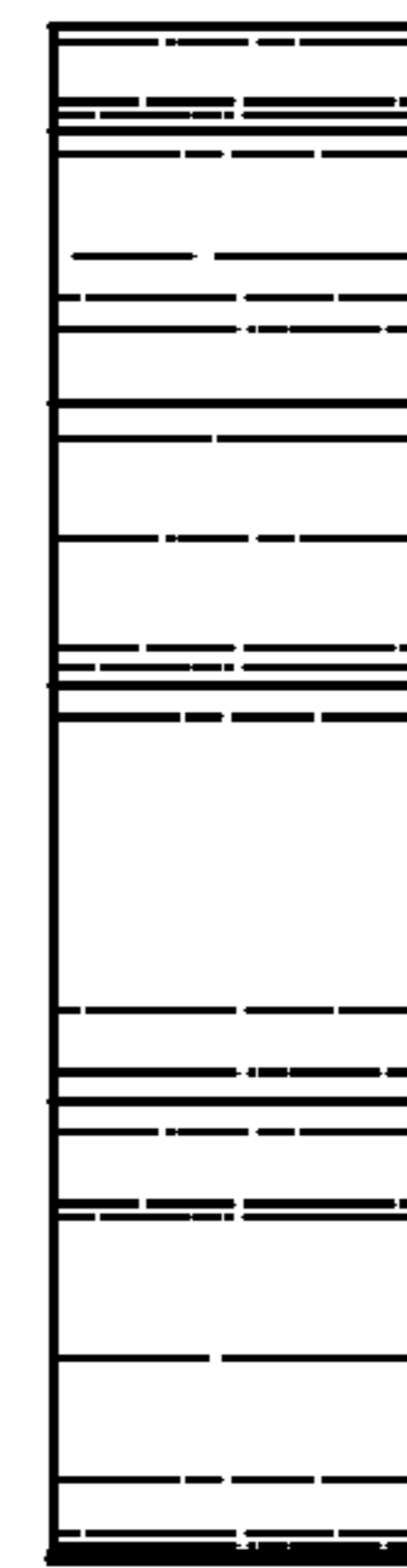

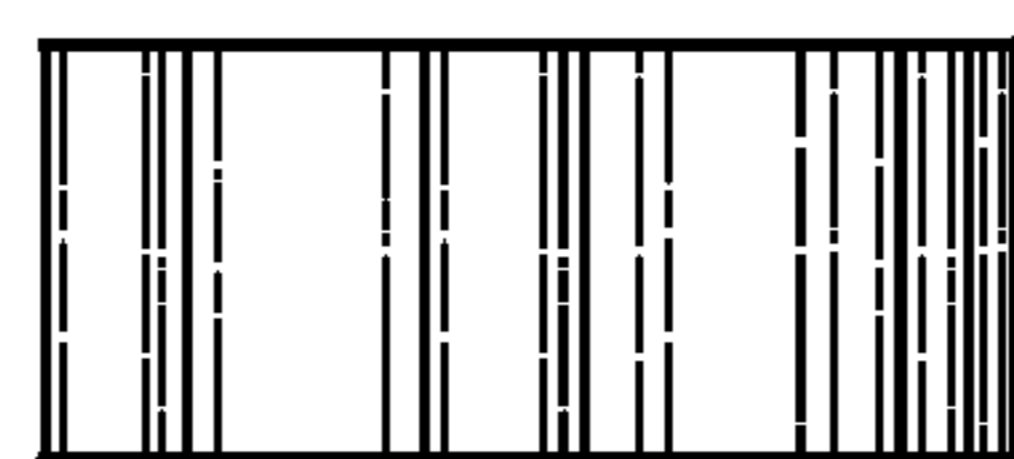
