(57) **CLAIM**

The ornamental design for pants with double stitching, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a first embodiment of my new design for pants with double stitching design;

FIG. 2 is a rear view of the first embodiment of my new design for pants with double stitching design;

FIG. 3 is a front view of a second embodiment of my new design for pants with double stitching design; and,

FIG. 4 is a rear view of the second embodiment of my new design for pants with double stitching design.

The dashed lines on the surface of the pants represent stitching. The remaining dot-dot-dashed lines represent the portions of the design, which form no part of the claim.

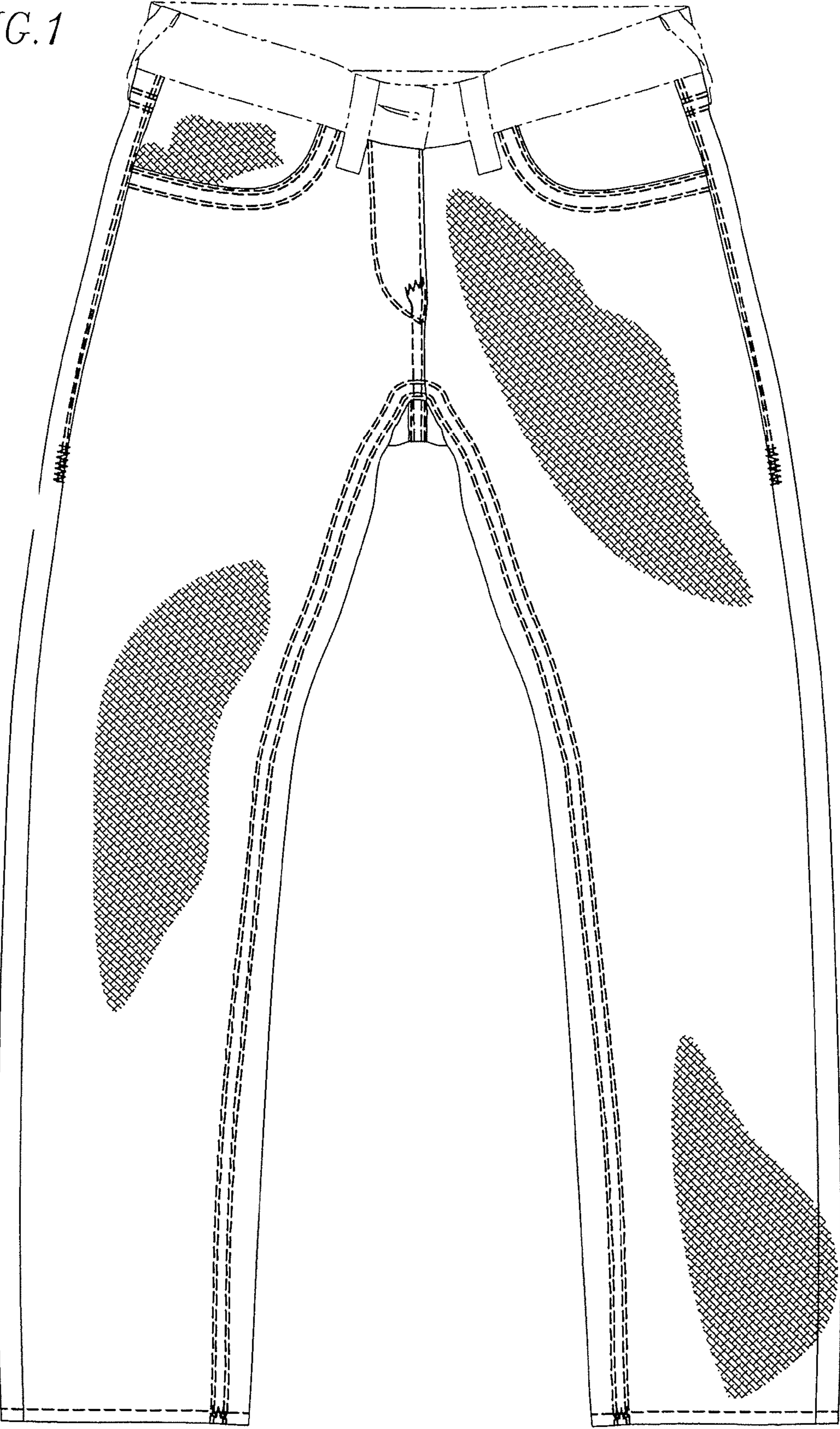

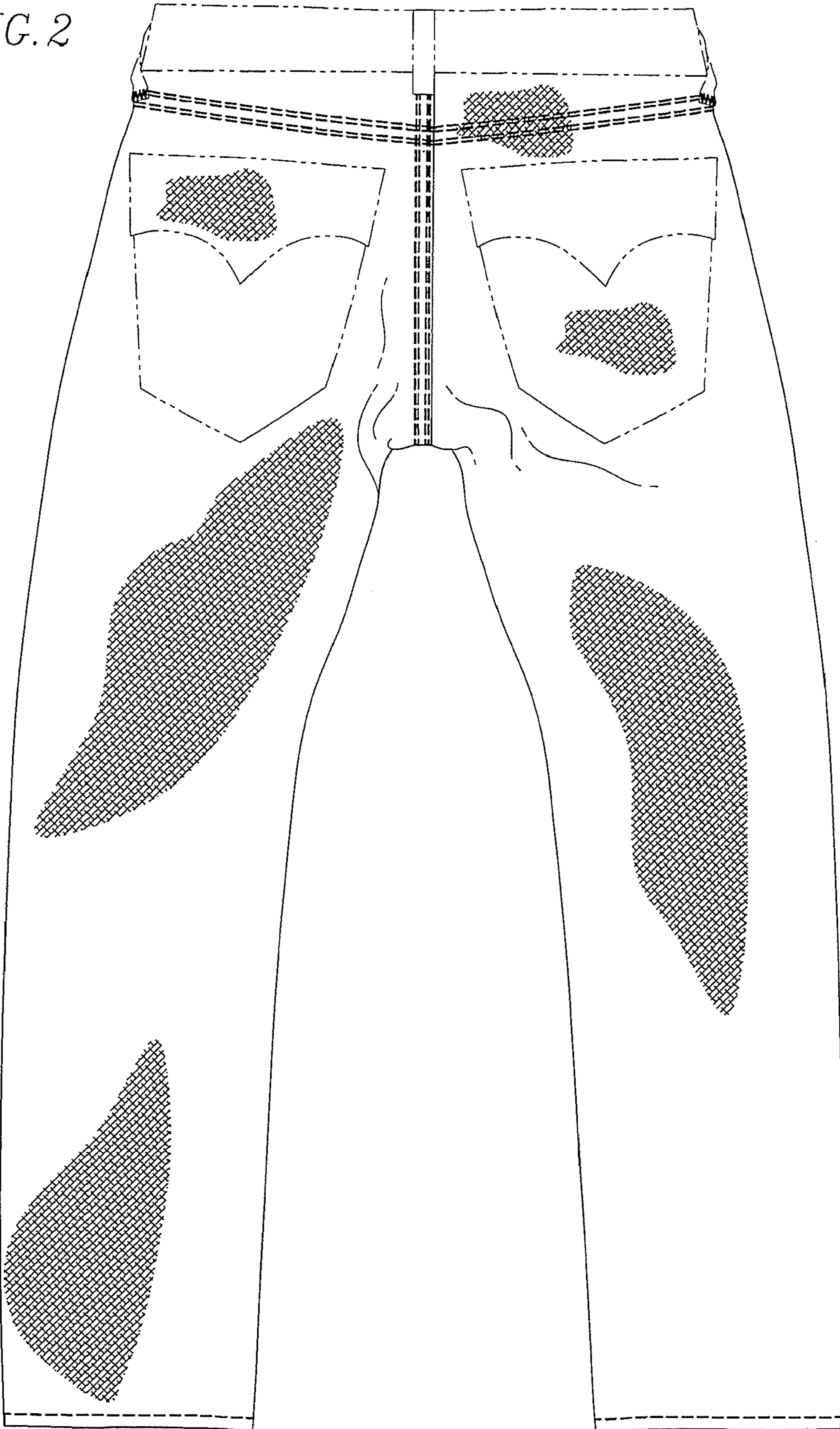

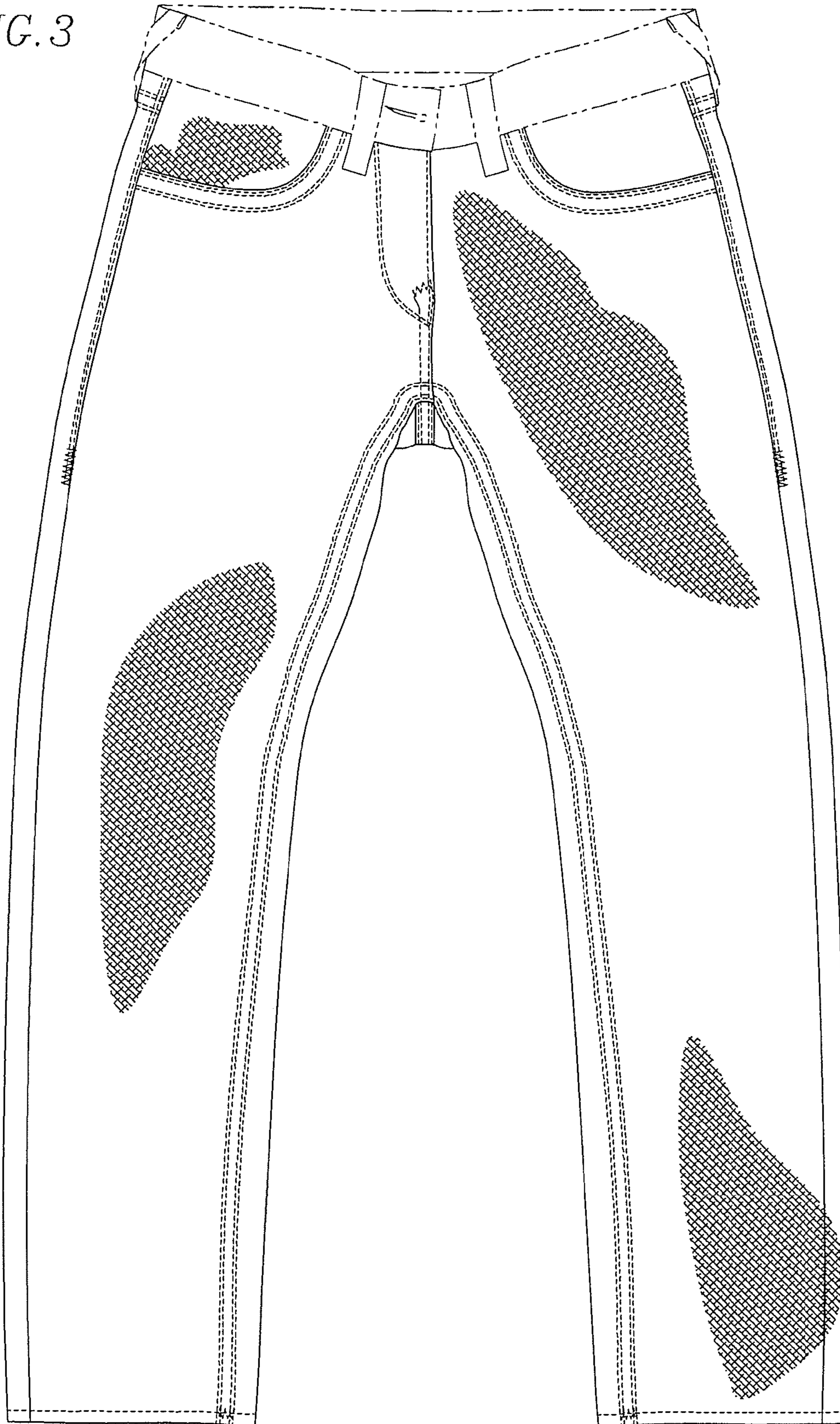
