DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my footwear design;

FIG. 4 is a front view of the footwear shown in FIG. 1;

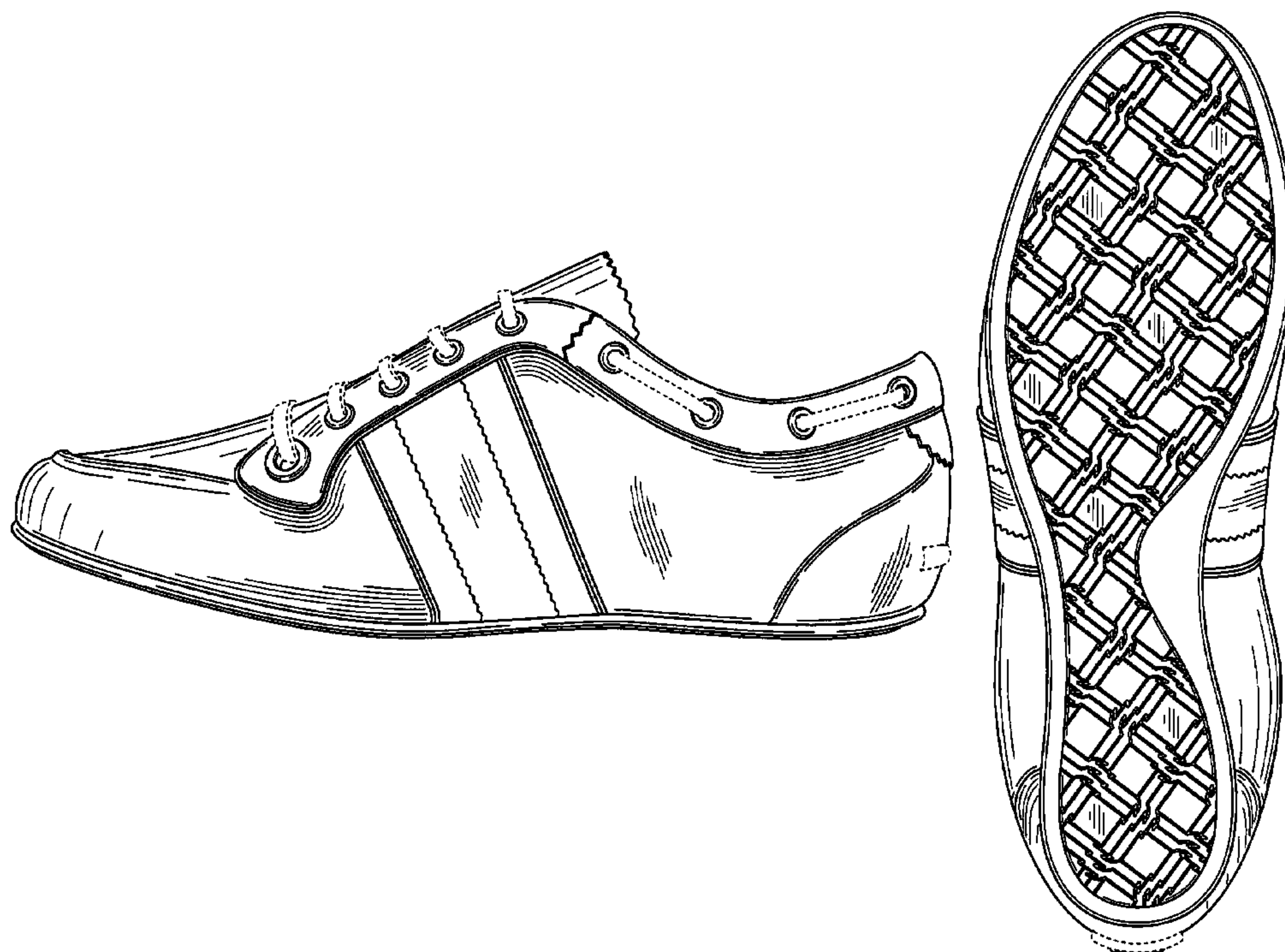
FIG. 5 is a rear view of the footwear shown in FIG. 1;

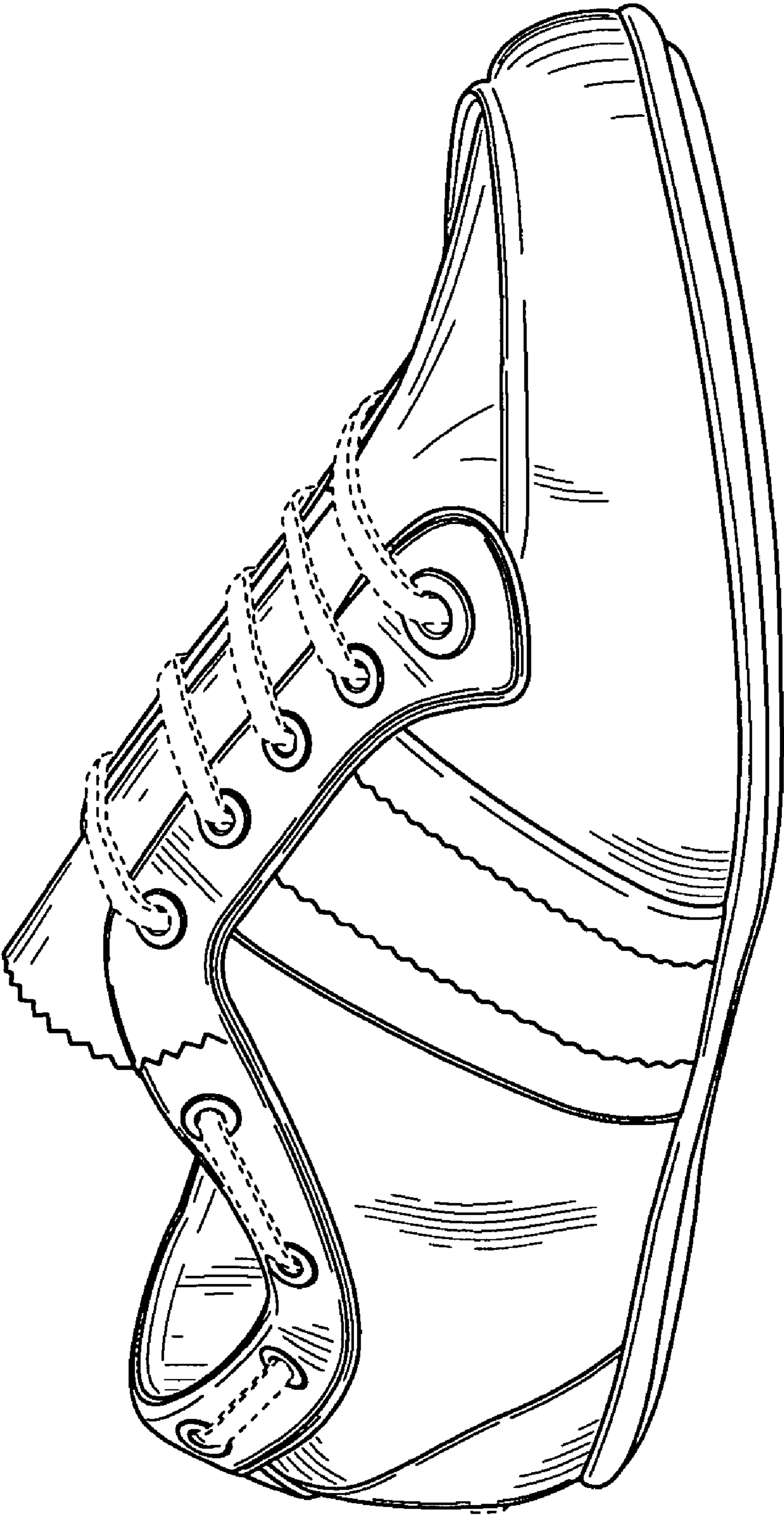

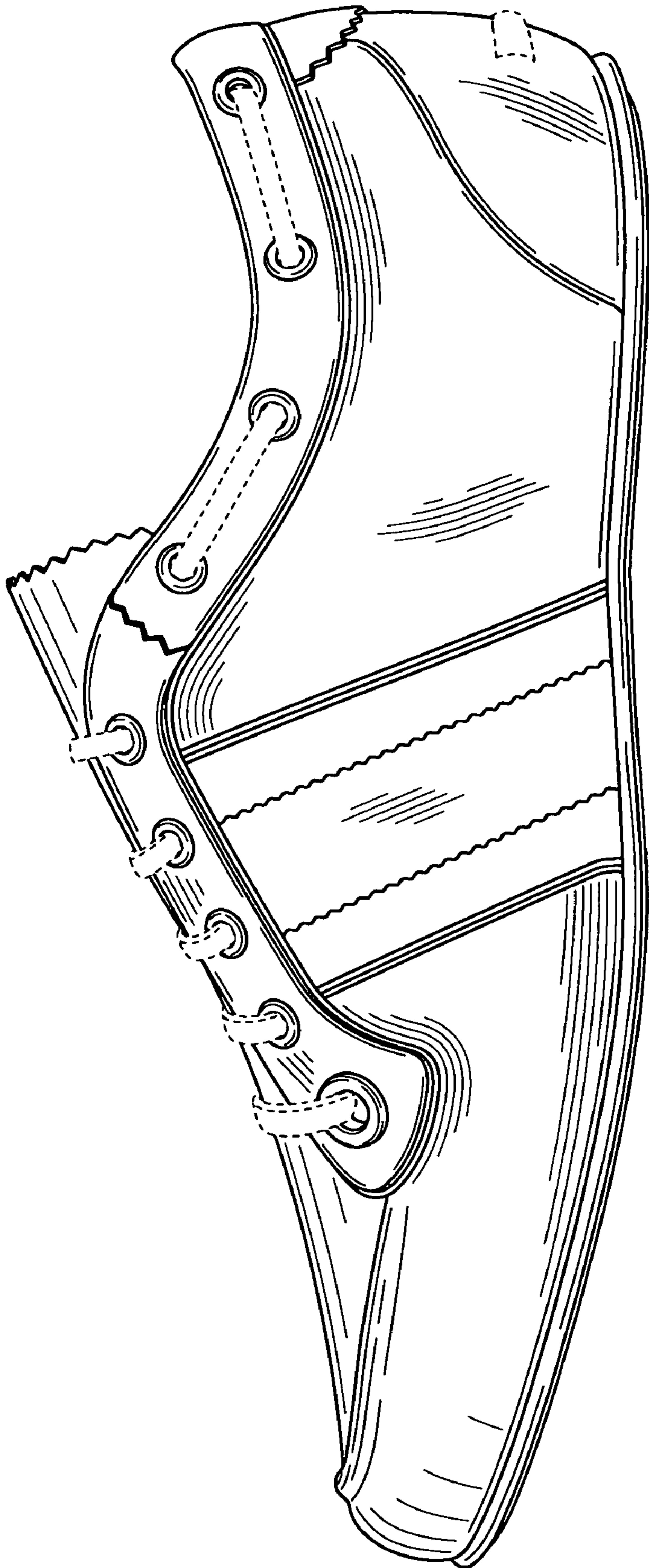

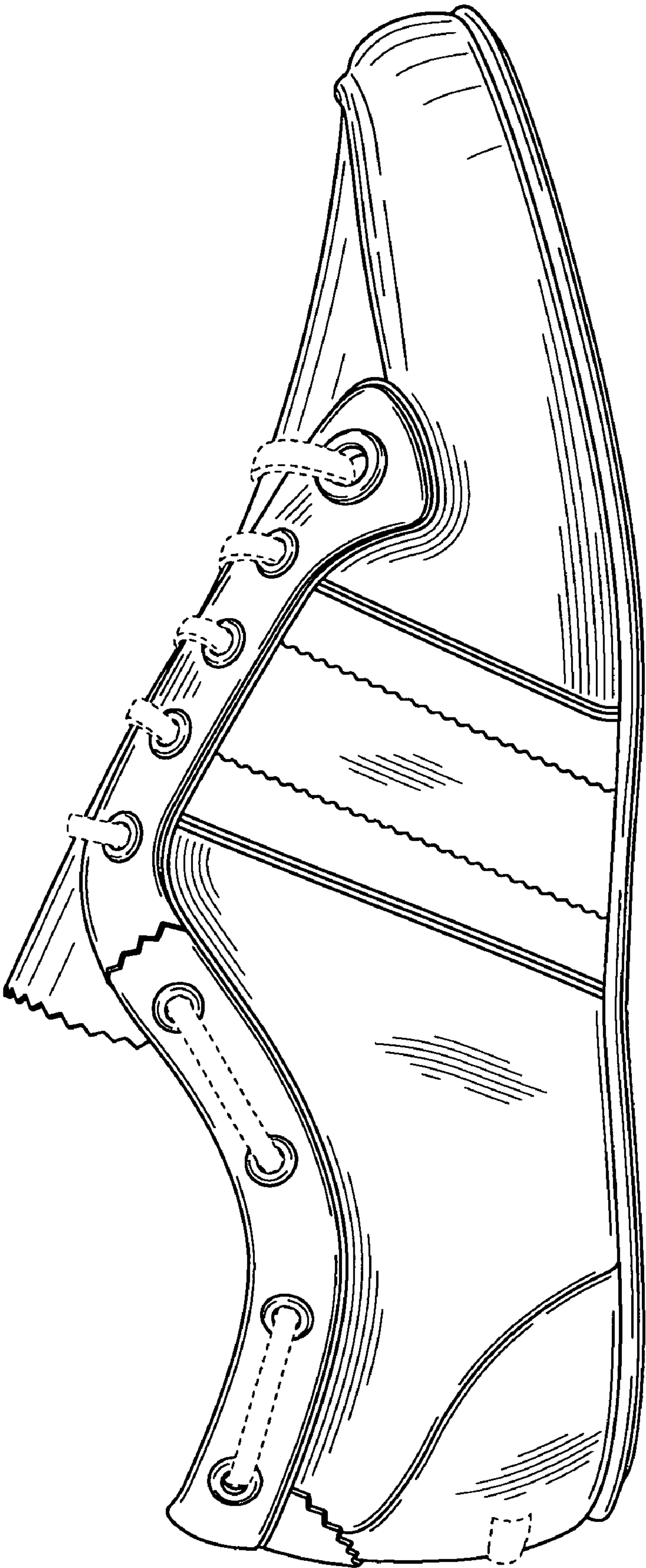

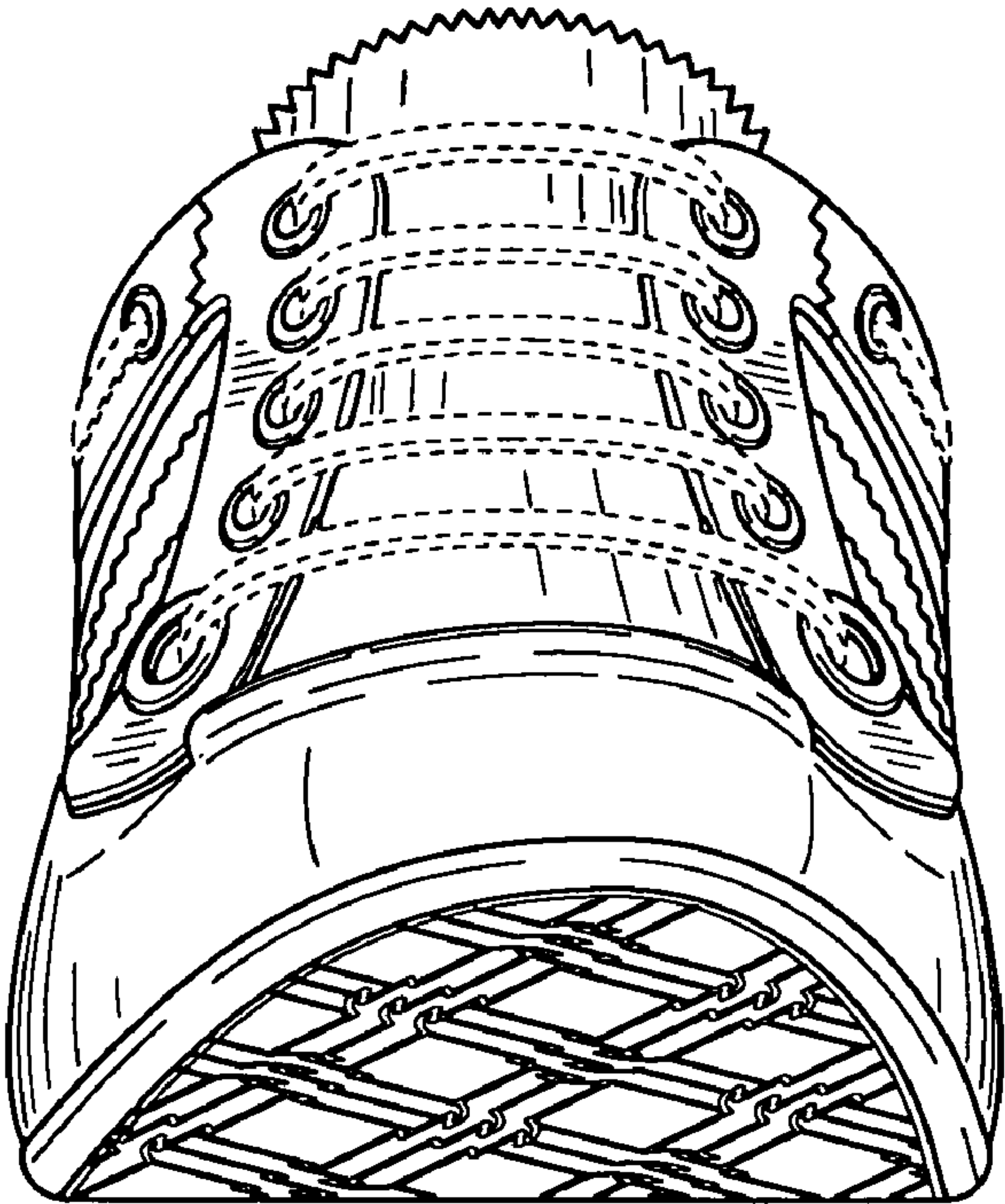

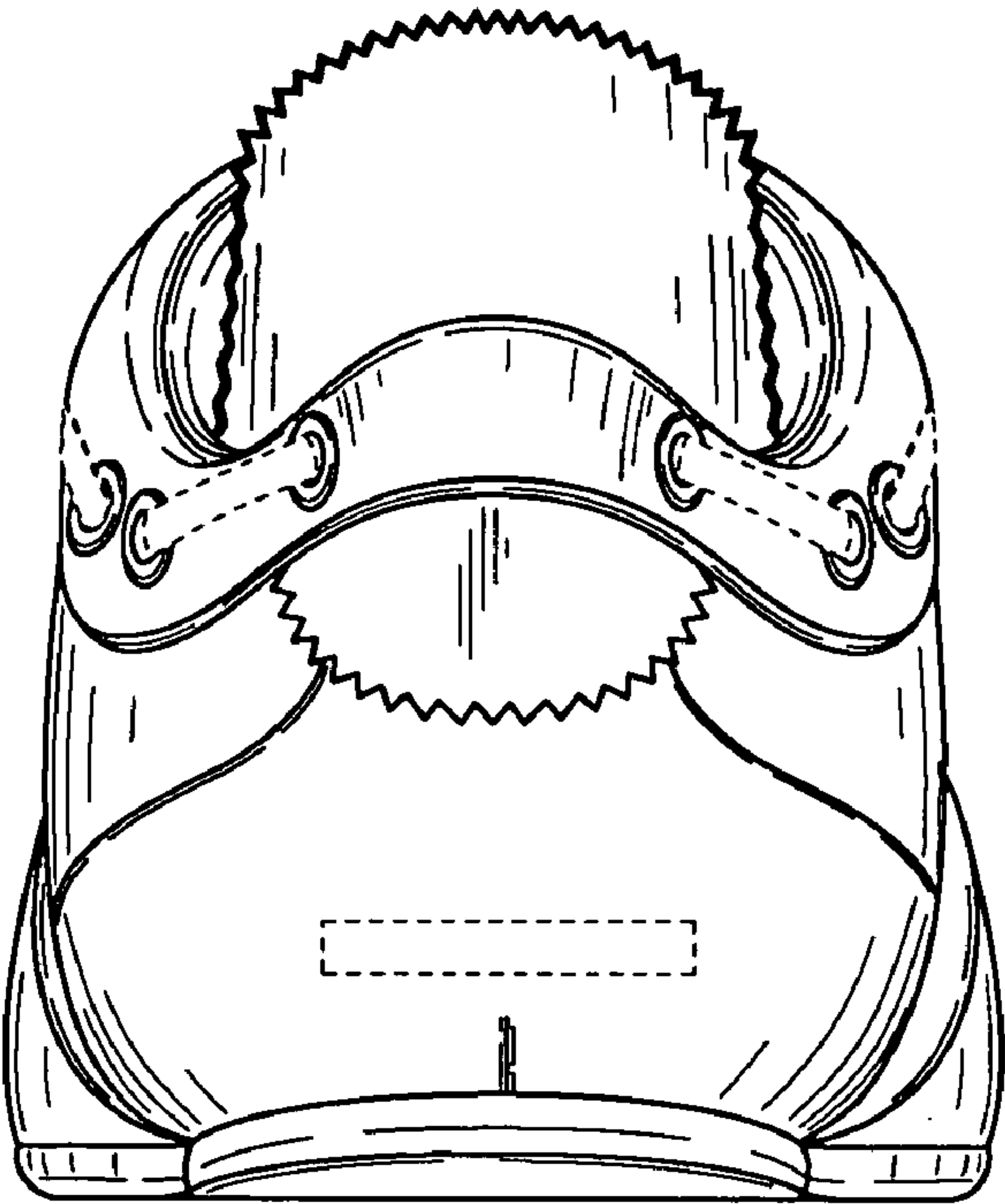

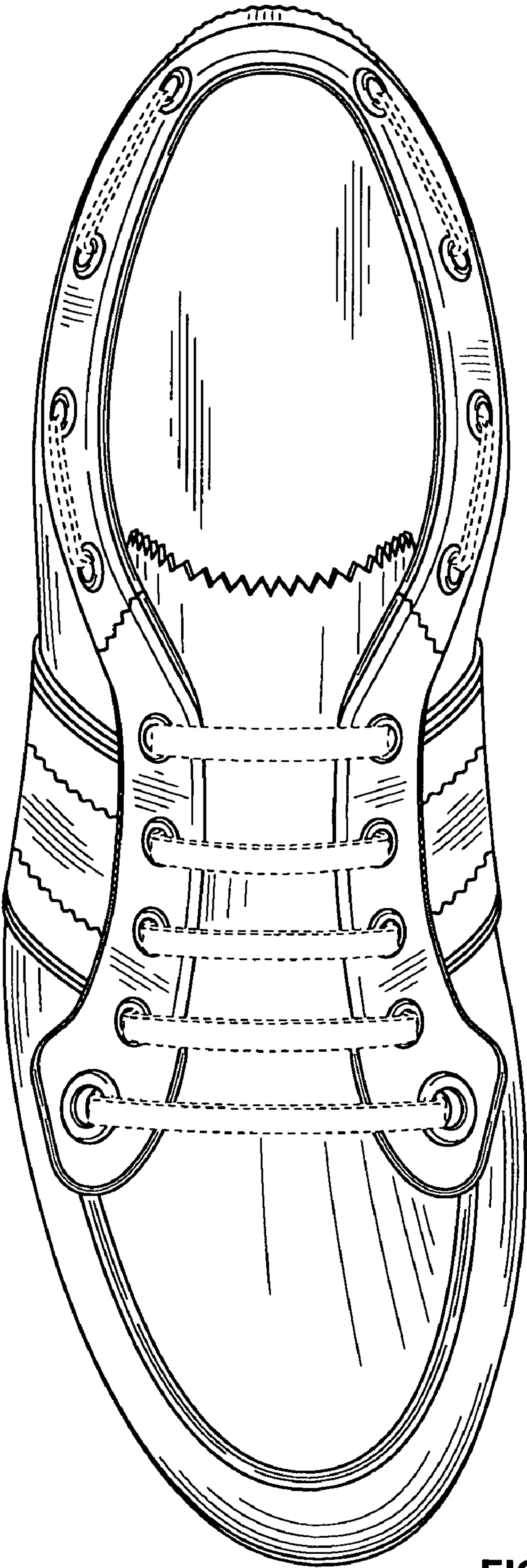

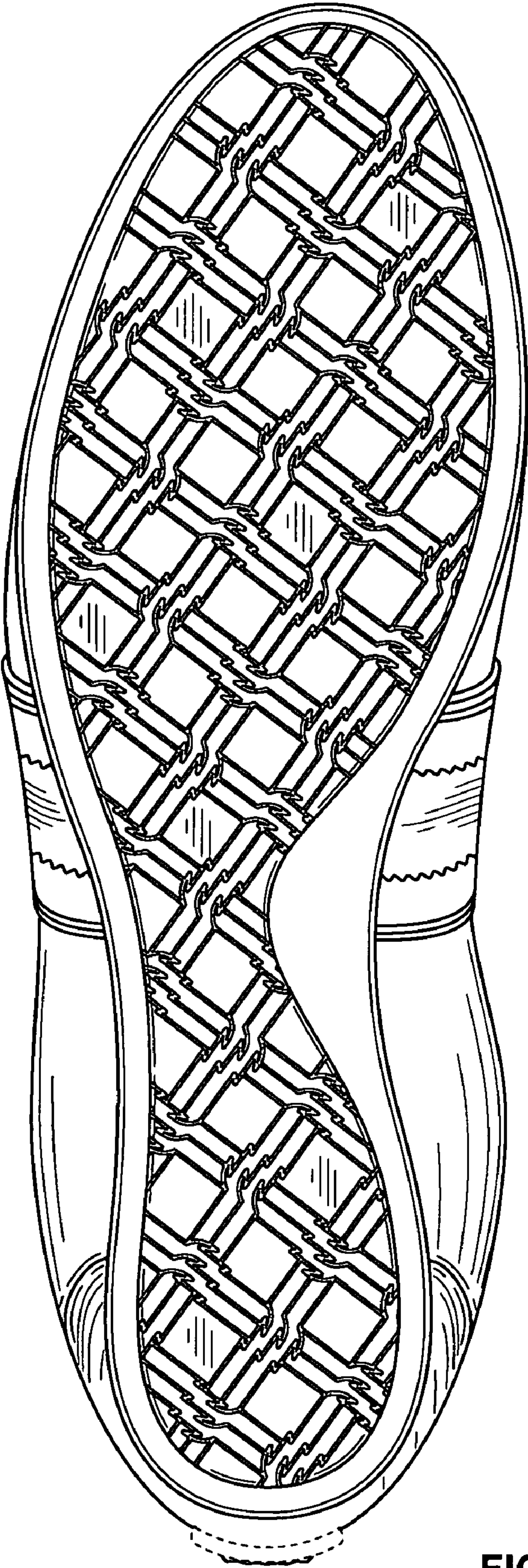
