FIG. 2 is another side view thereof;

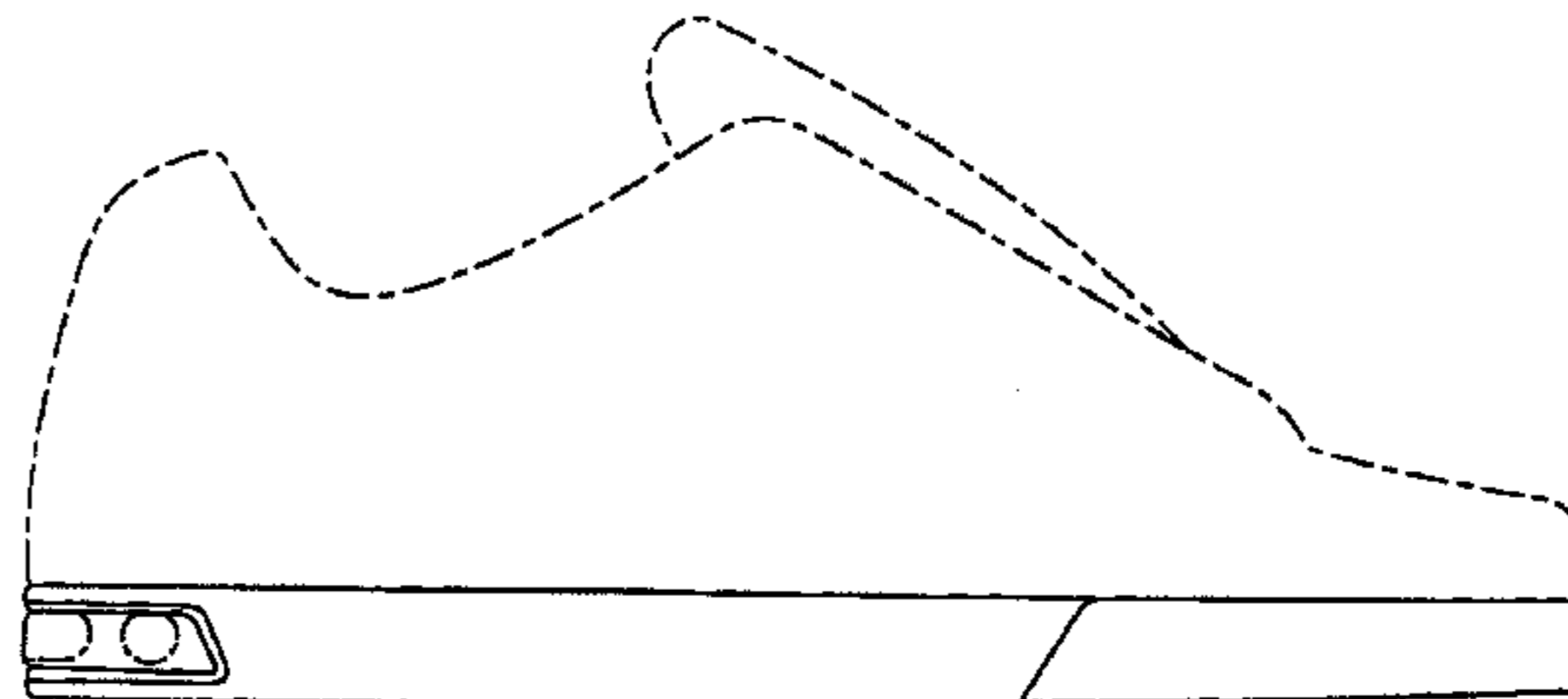
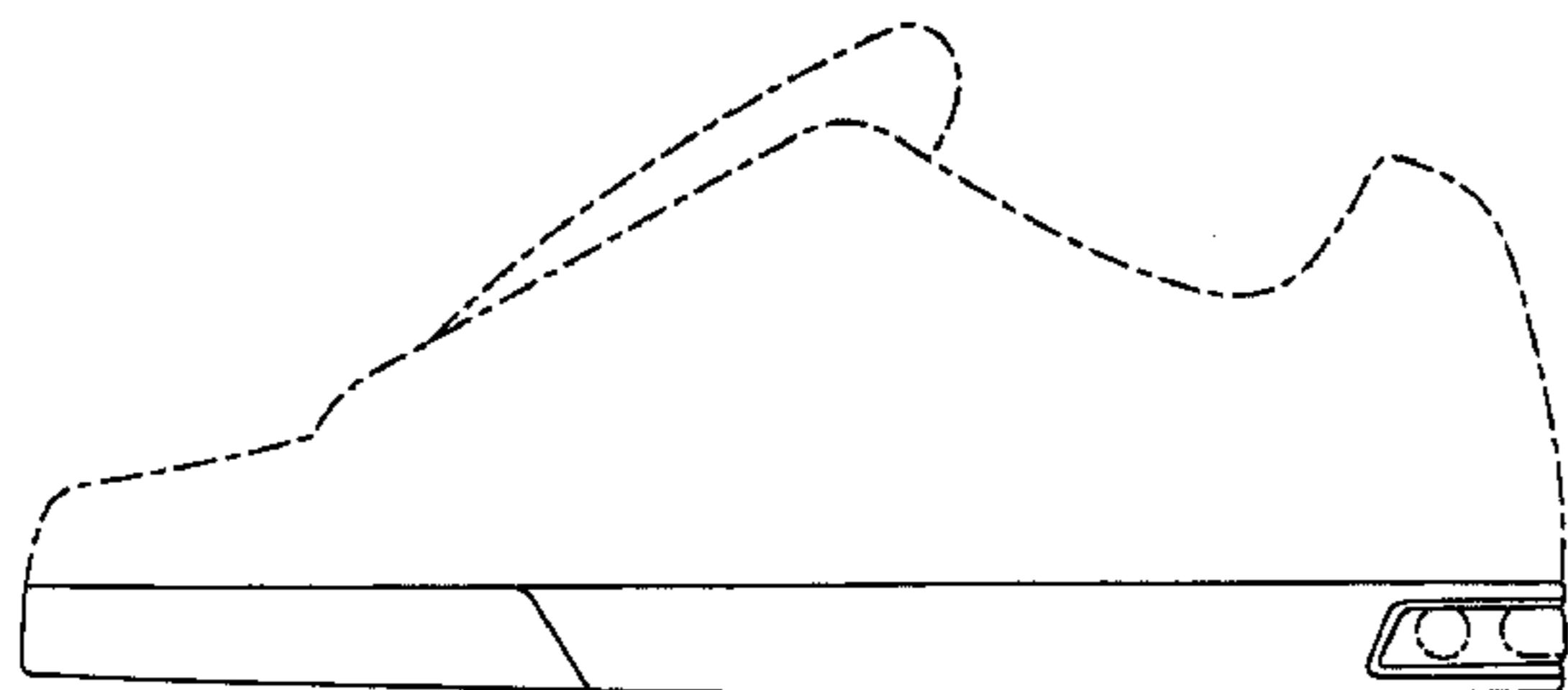
FIG. 3 is a bottom plan view thereof;

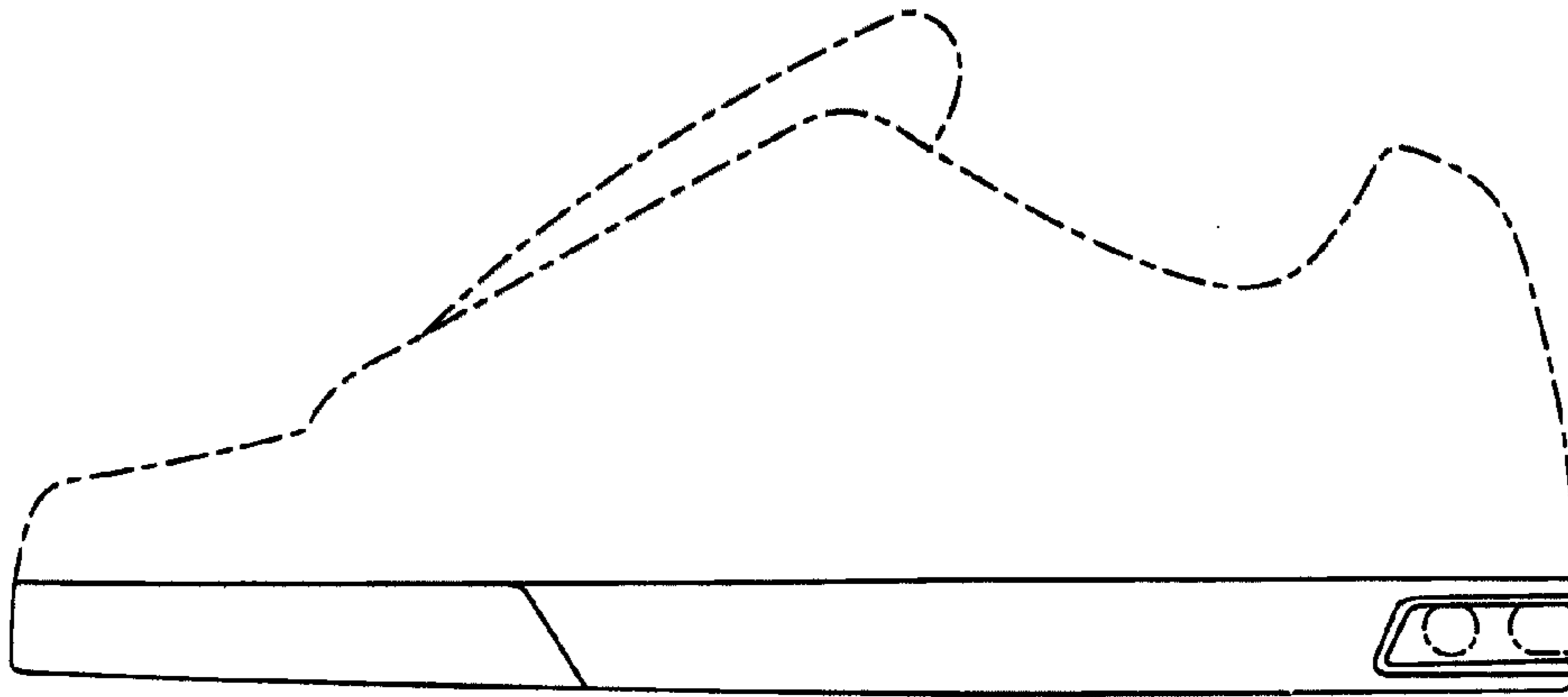

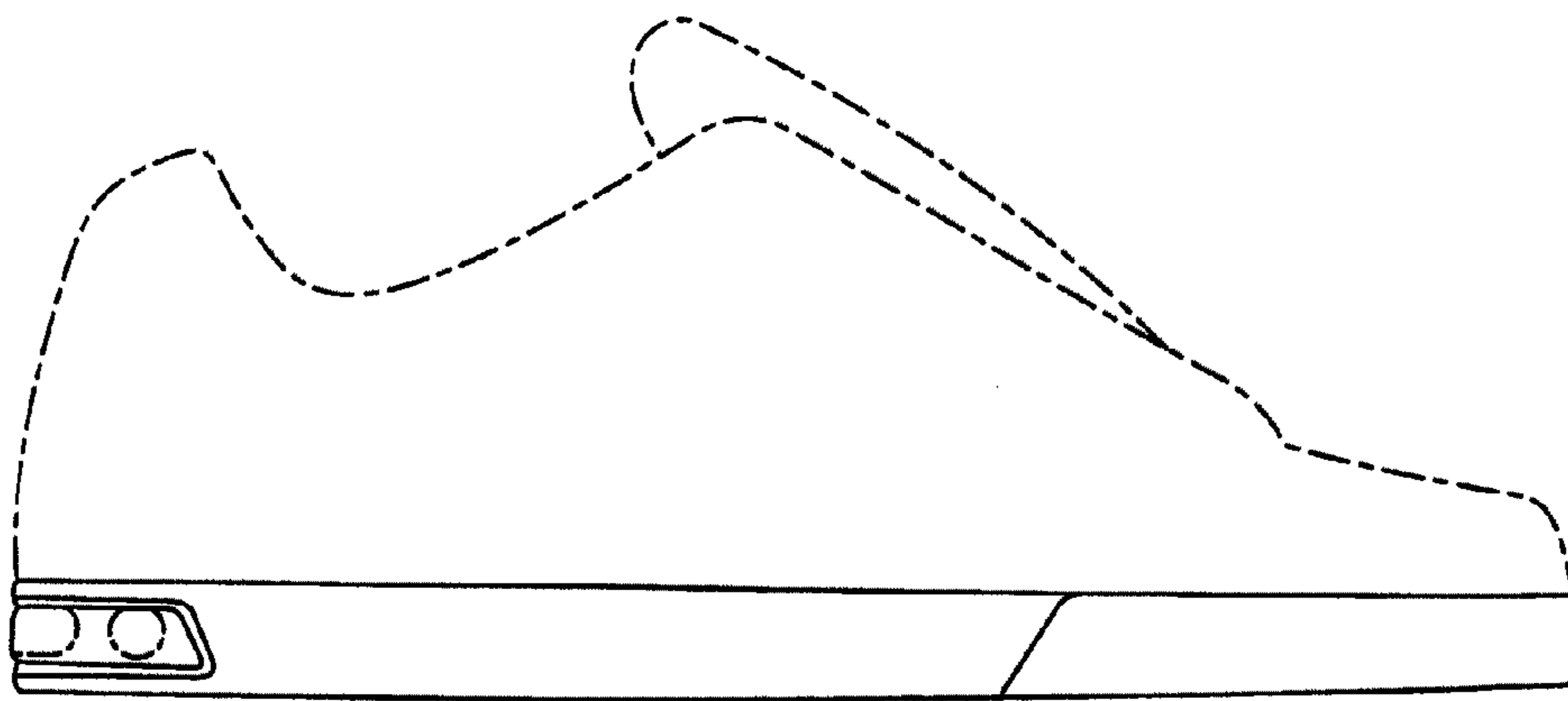

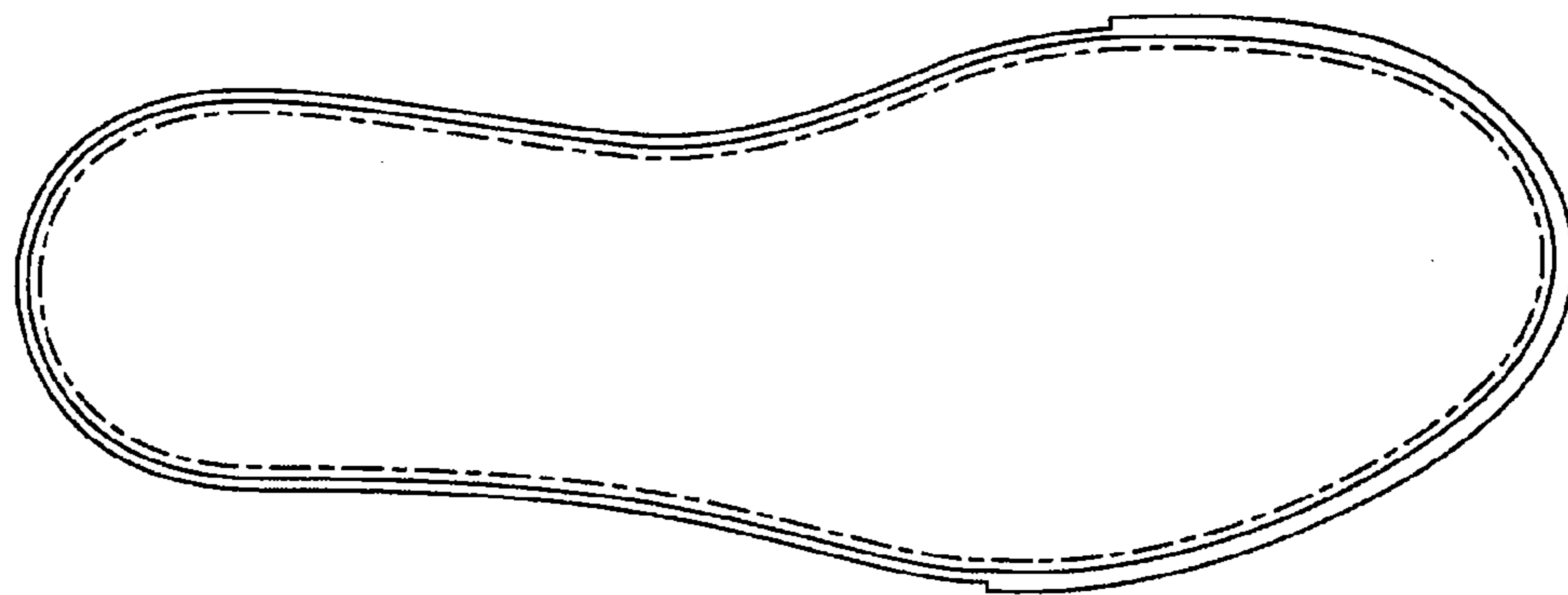

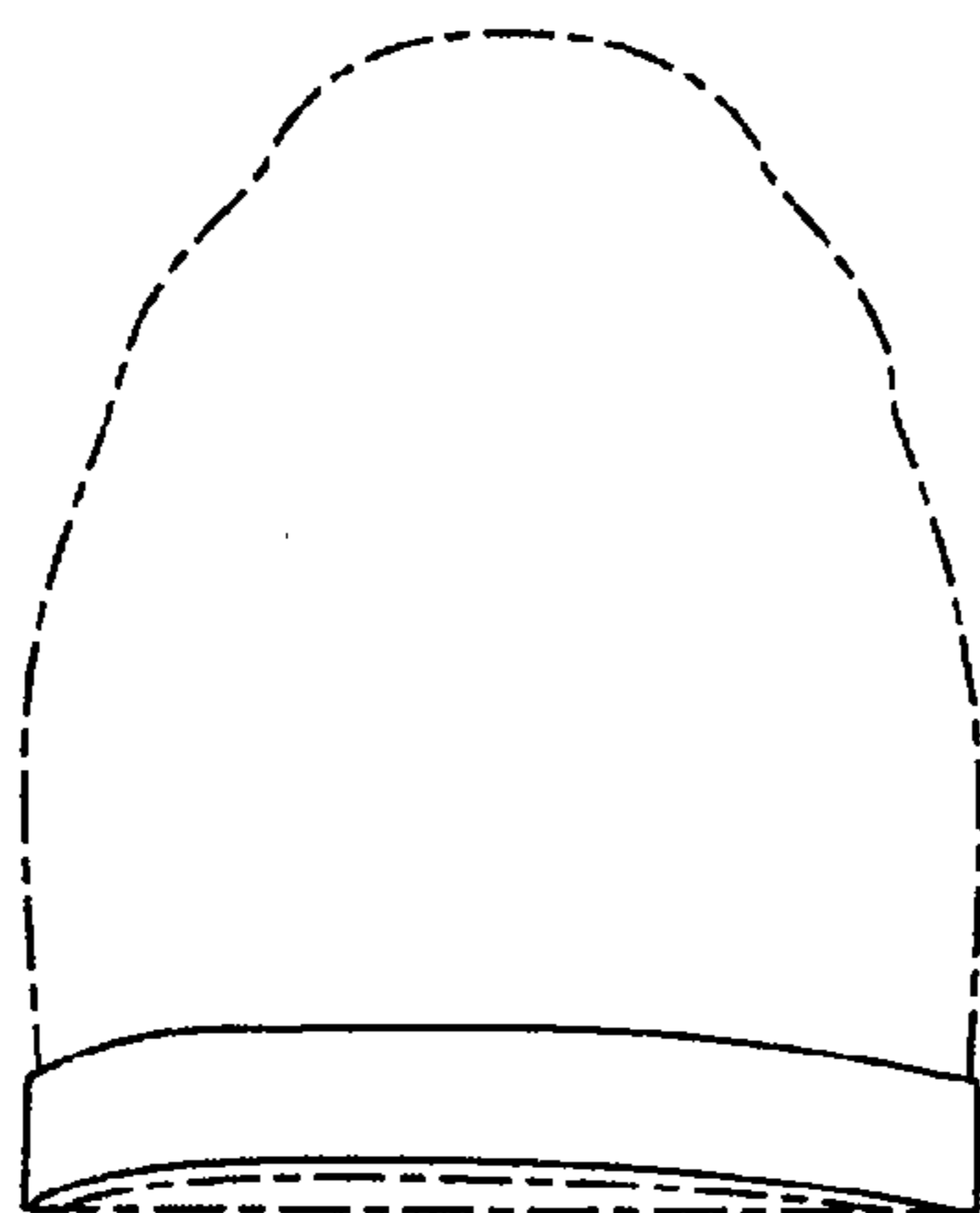

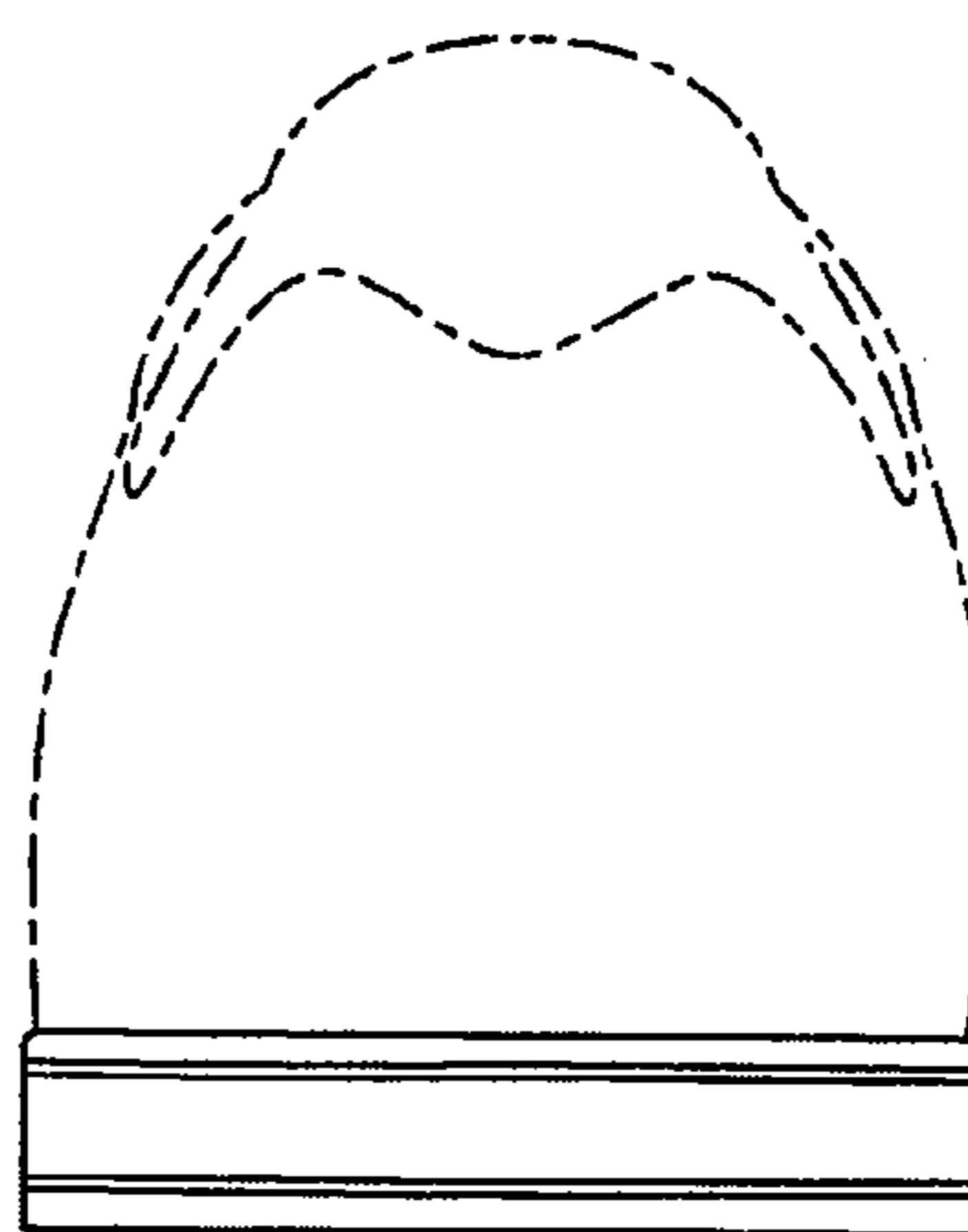
