(57) **CLAIM**

I claim the ornamental design for a keychain, as shown and described.

**DESCRIPTION**

FIG. 1 is a top left front perspective view for the keychain that shows my design;

FIG. 13 is a bottom plan view of FIG. 9;

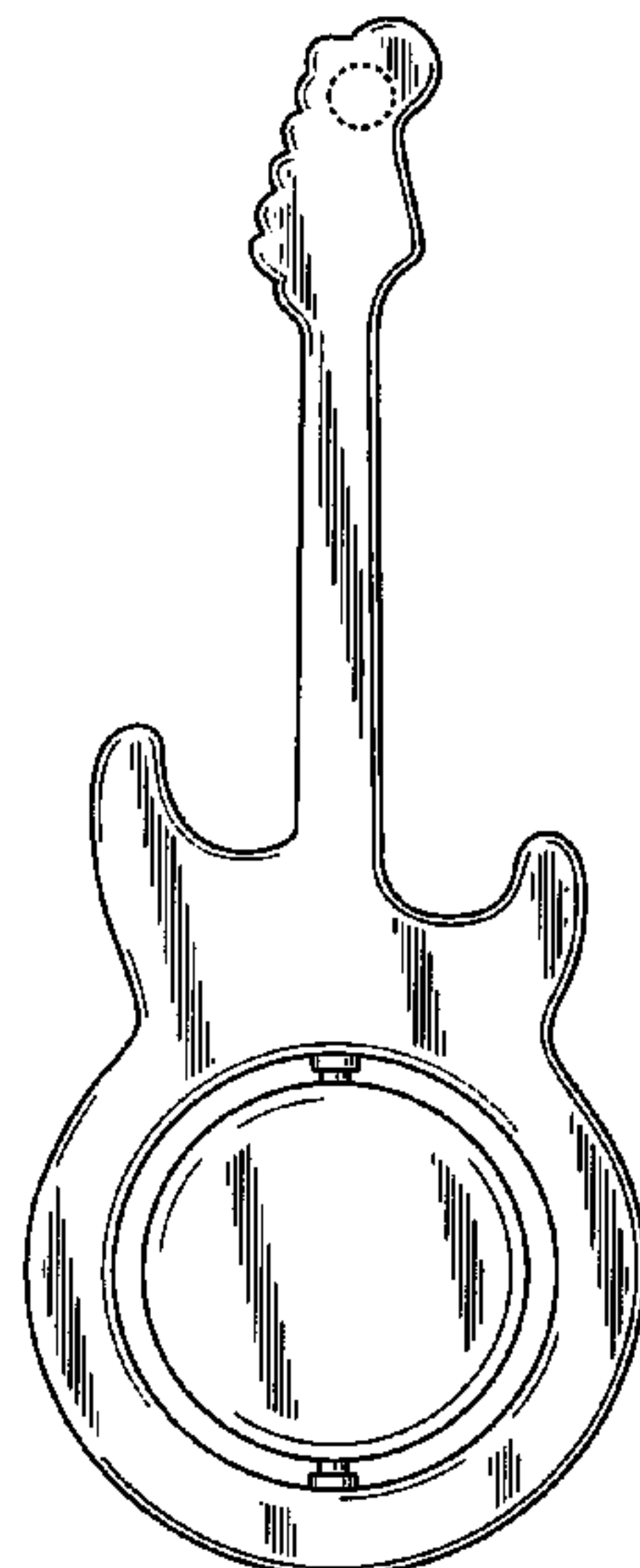
FIG. 14 is a left side elevation view of FIG. 9;

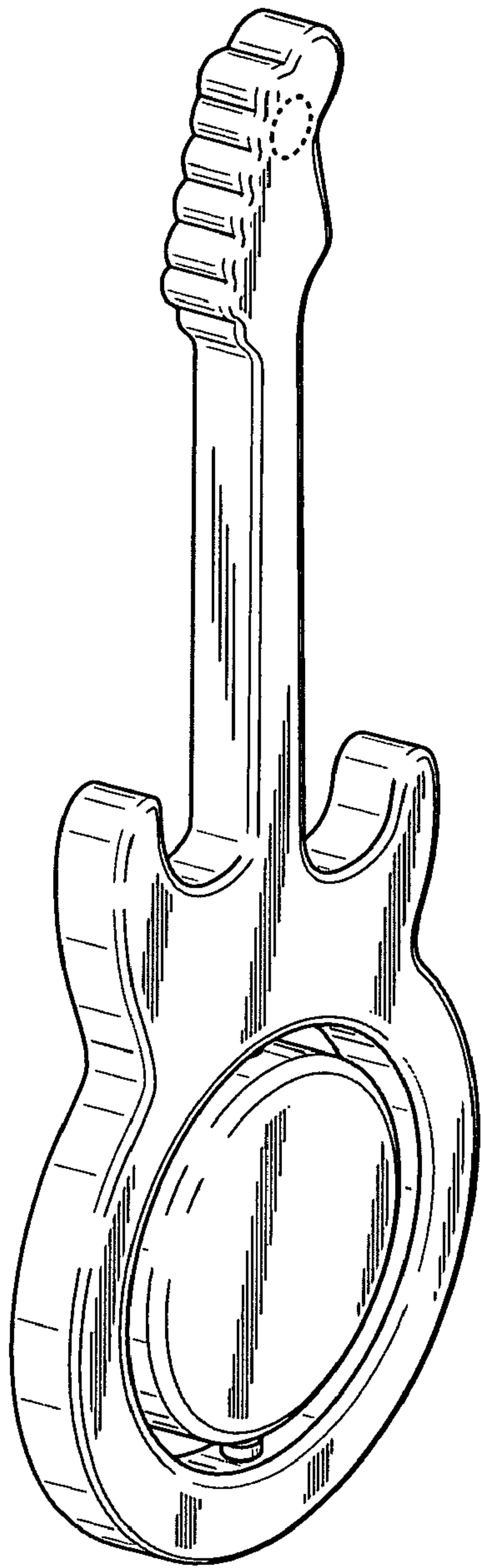
FIG. 15 is a front elevation view of FIG. 9 with the spinner shown in a rotated position; and,

FIG. 16 is a bottom plan view of FIG. 9 with the spinner shown in a rotated position.

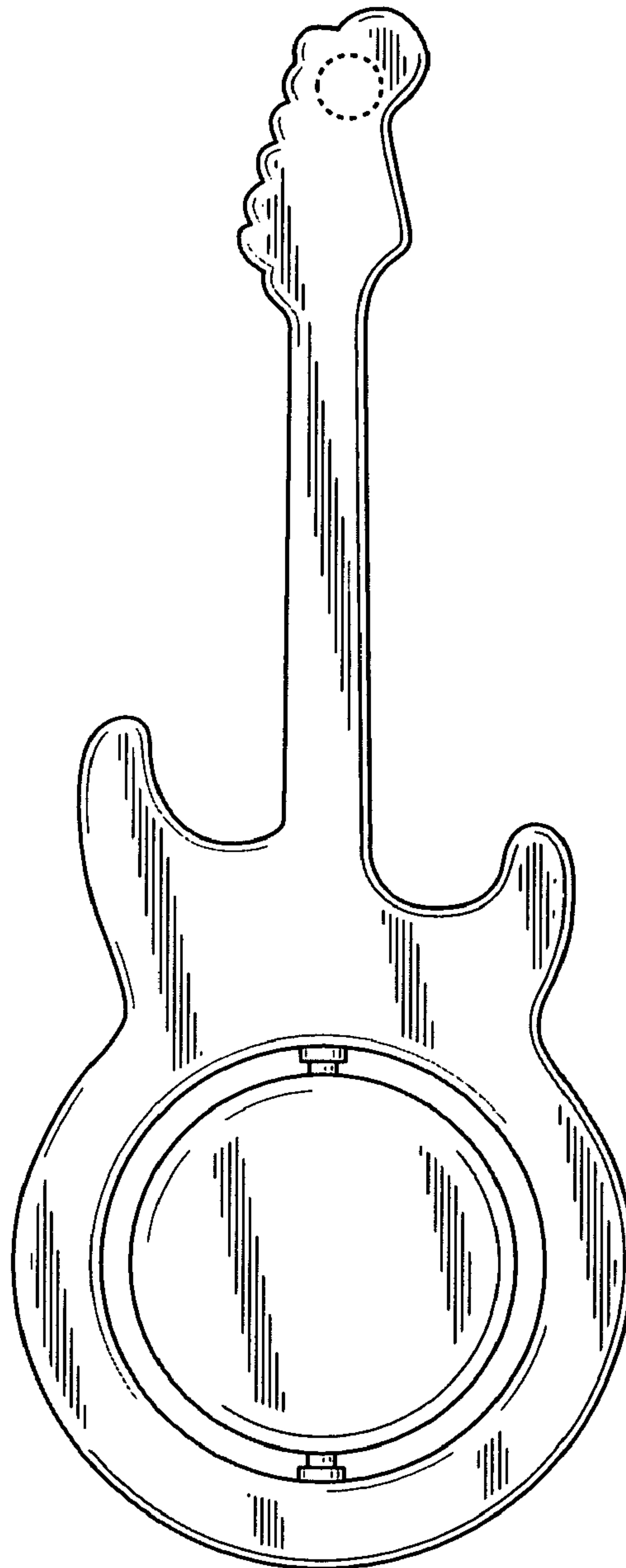
The broken line showing of an aperture is included for the purpose of illustrating environmental matter and forms no part of the claimed design.

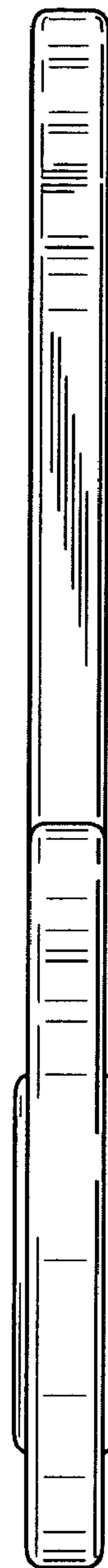

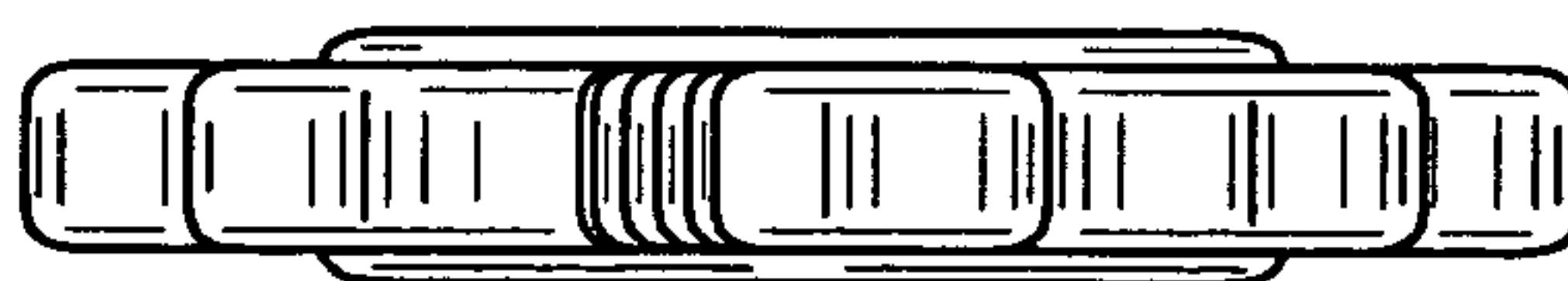

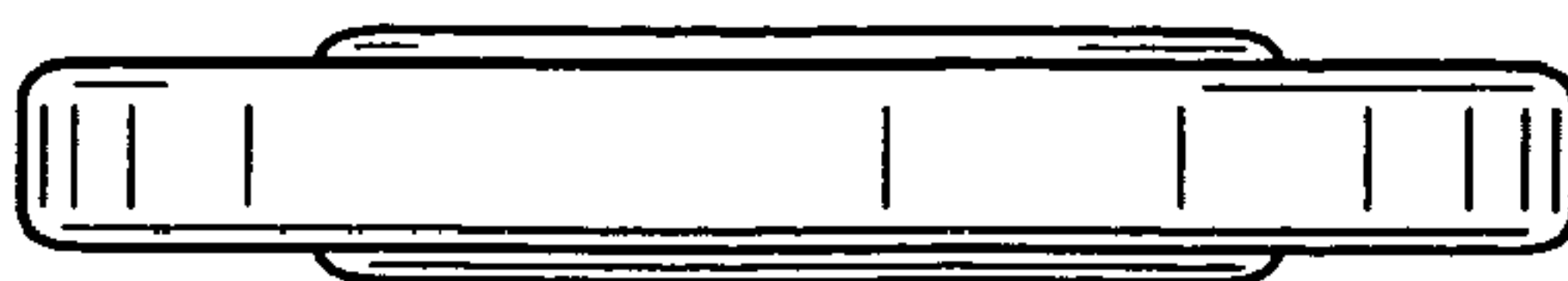


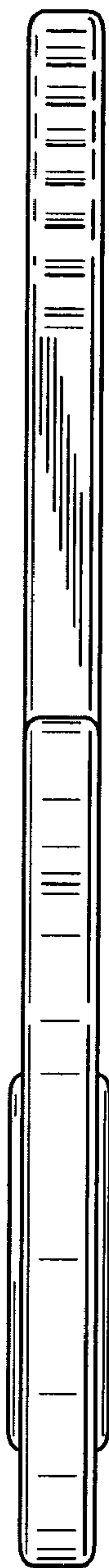

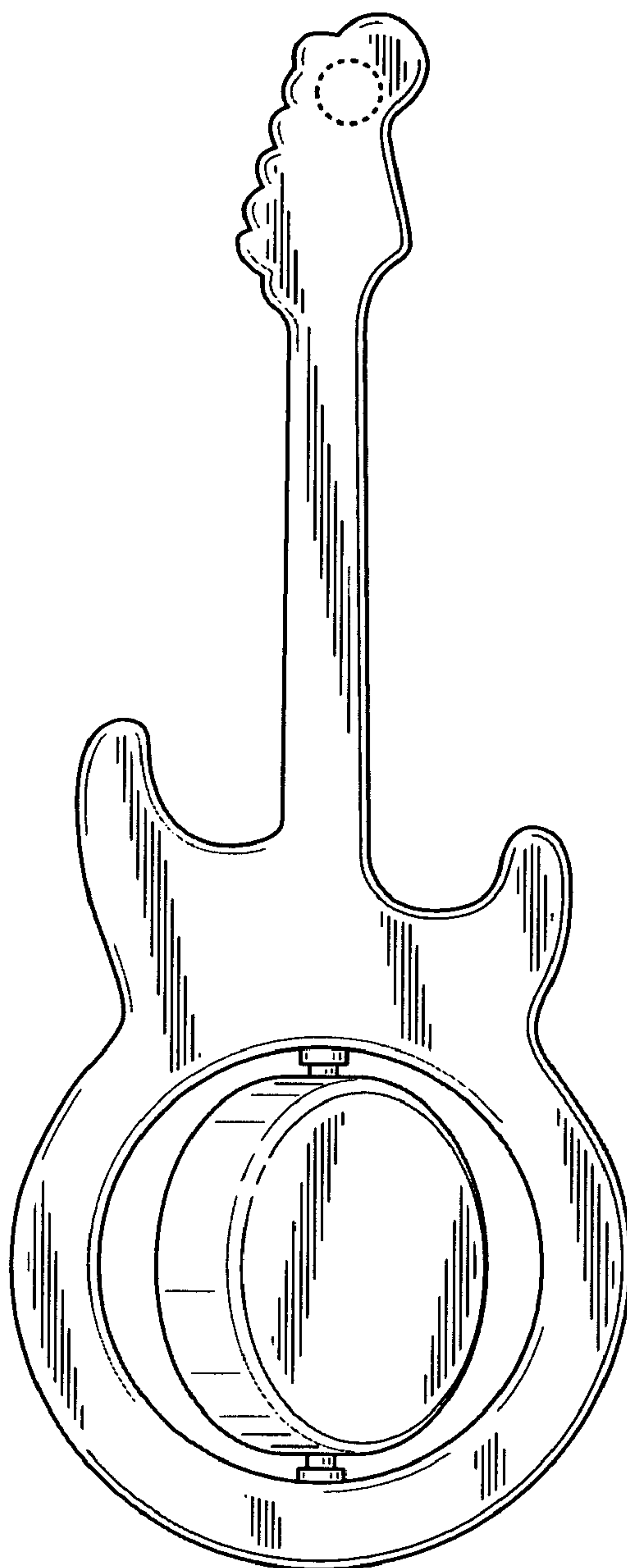

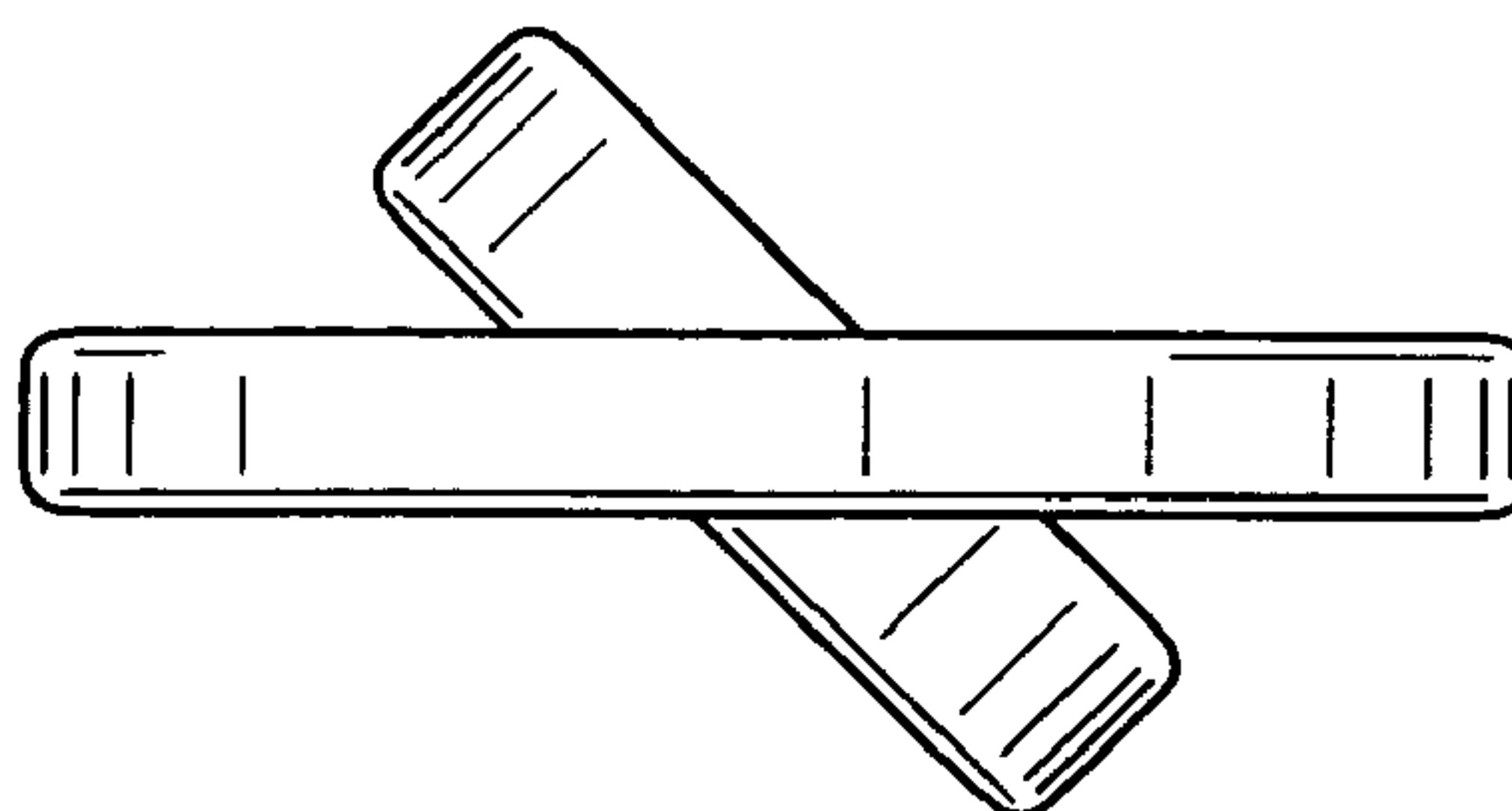


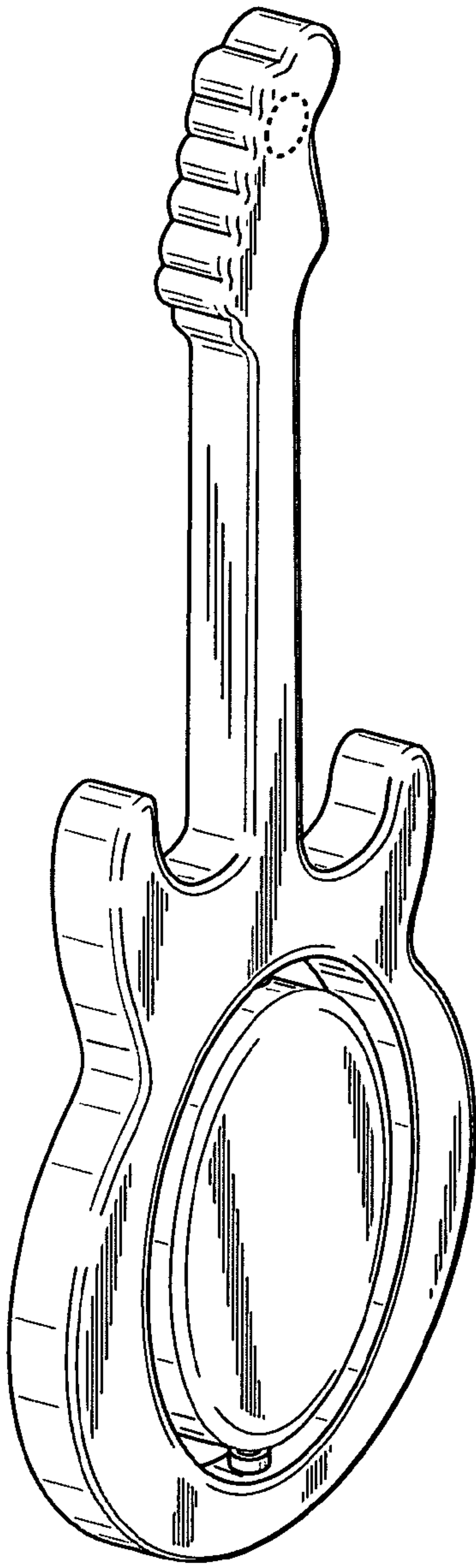

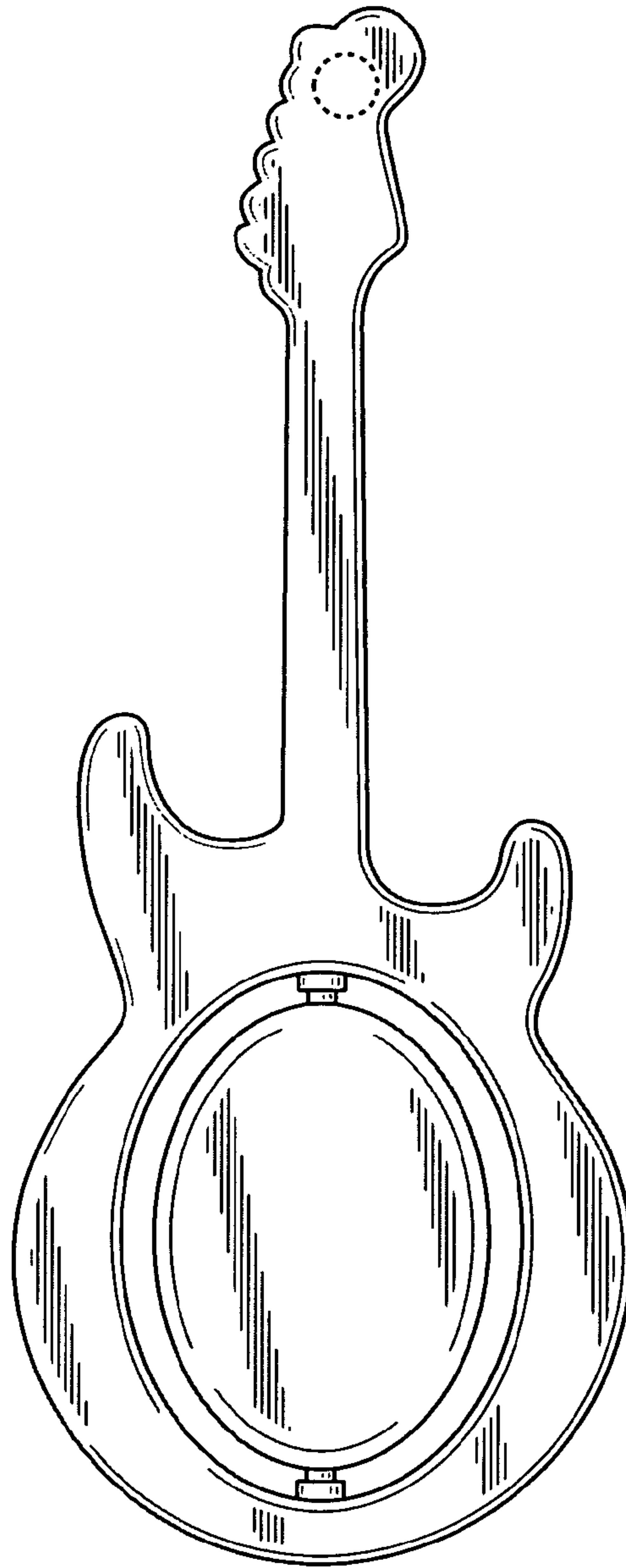

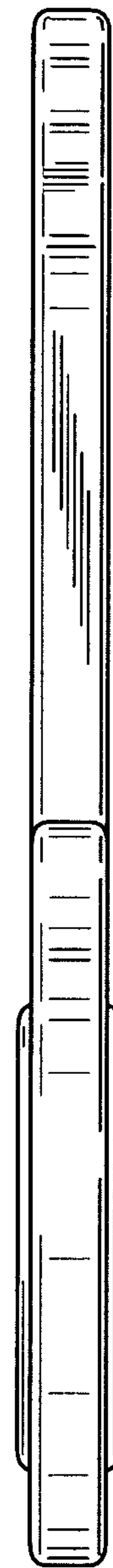

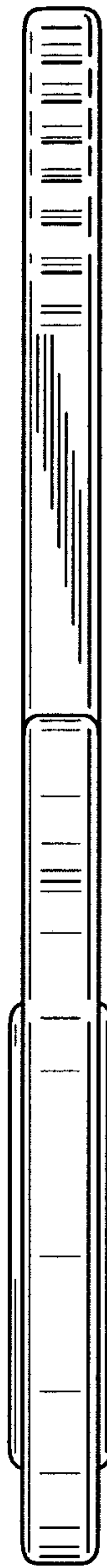

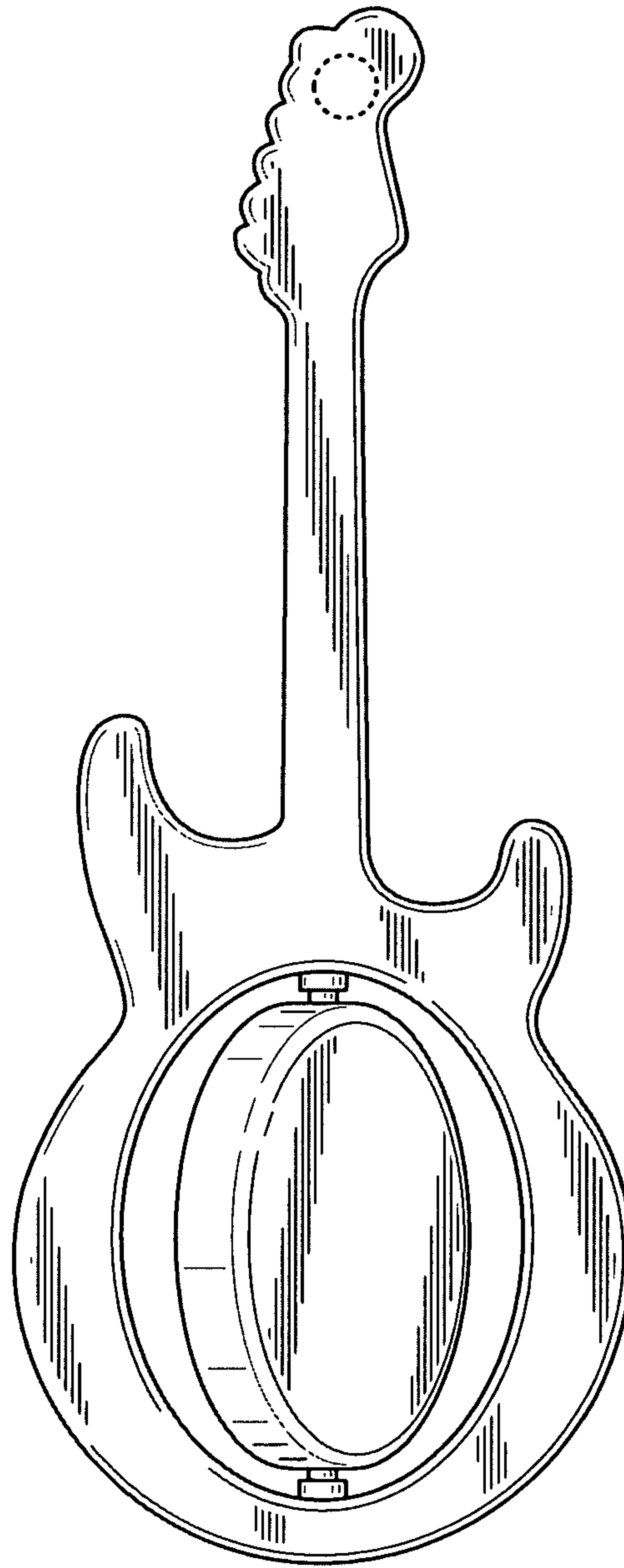
