(57) **CLAIM**

The ornamental design for a brush, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of a brush according to a first embodiment of my new design;

FIG. 2 is a second perspective view of the brush of FIG. 1;

FIG. 3 is a top plan view of the brush of FIG. 1;

FIG. 4 is a bottom plan view of the brush of FIG. 1;

FIG. 5 is a front elevational view of the brush of FIG. 1; the rear elevational view of the brush of FIG. 1 being the same as FIG. 5;

FIG. 6 is a left side elevational view of the brush of FIG. 1; the right side elevational view of the brush of FIG. 1 being the same as FIG. 6;

FIG. 7 is a perspective view of a brush according to a second embodiment of my new design;

FIG. 8 is a second perspective view of the brush of FIG. 7;

FIG. 9 is a top plan view of the brush of FIG. 7;

FIG. 10 is a bottom plan view of the brush of FIG. 7;

FIG. 11 is a front elevational view of the brush of FIG. 7; the rear elevational view of the brush of FIG. 7 being the same as FIG. 11; and,

FIG. 12 is a left side elevational view of the brush of FIG. 7; the right side elevational view of the brush of FIG. 7 being the same as FIG. 12;

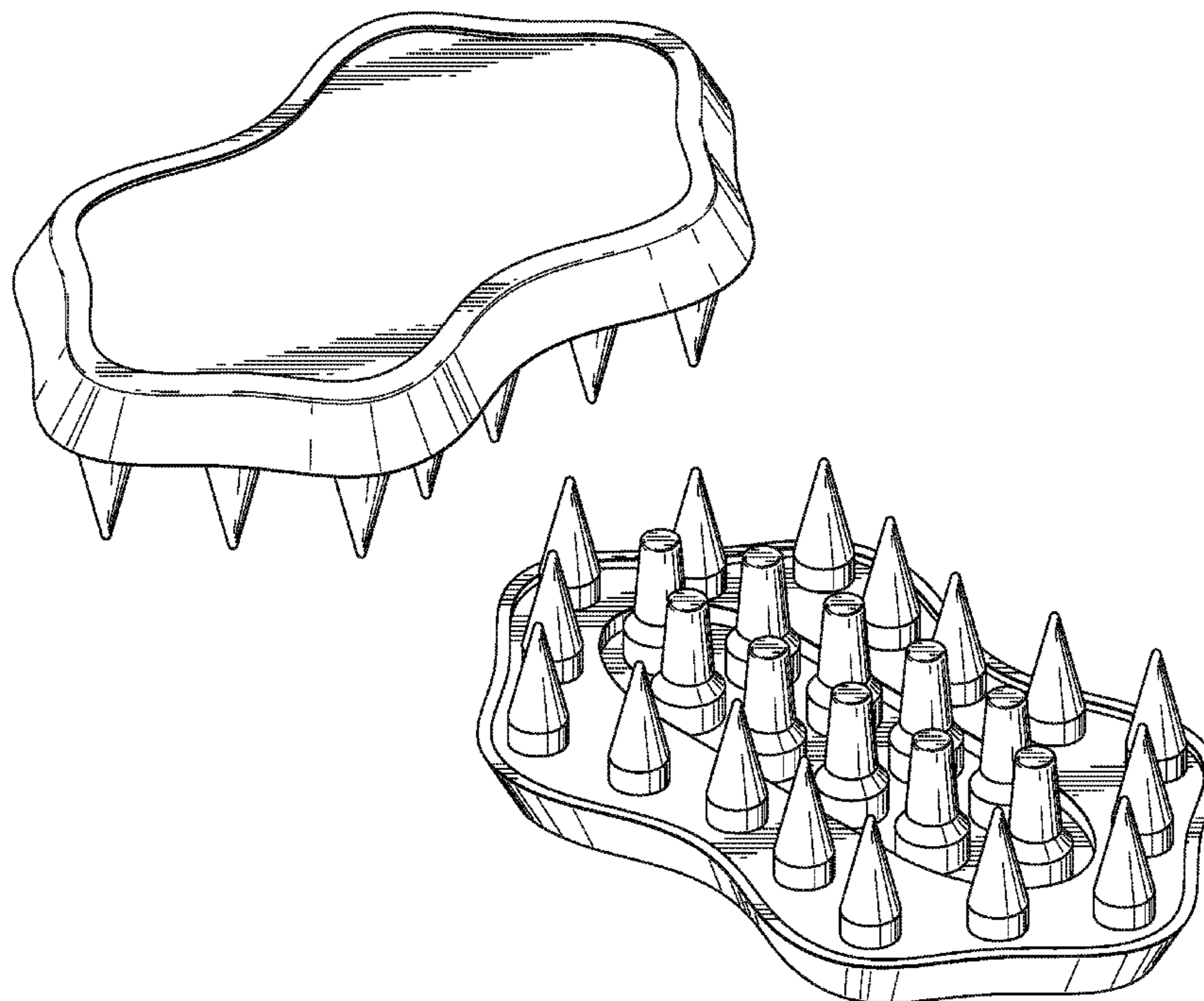

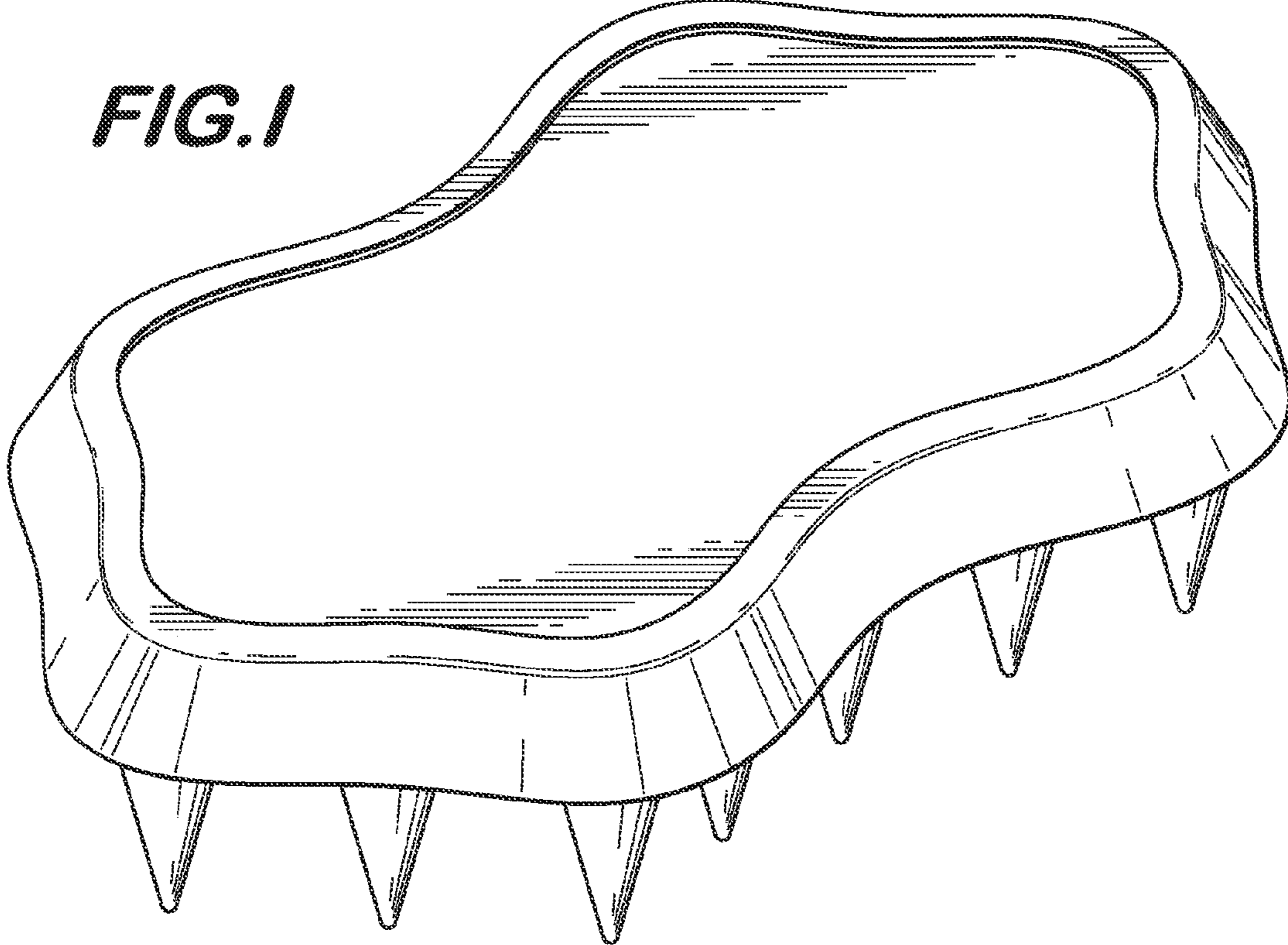

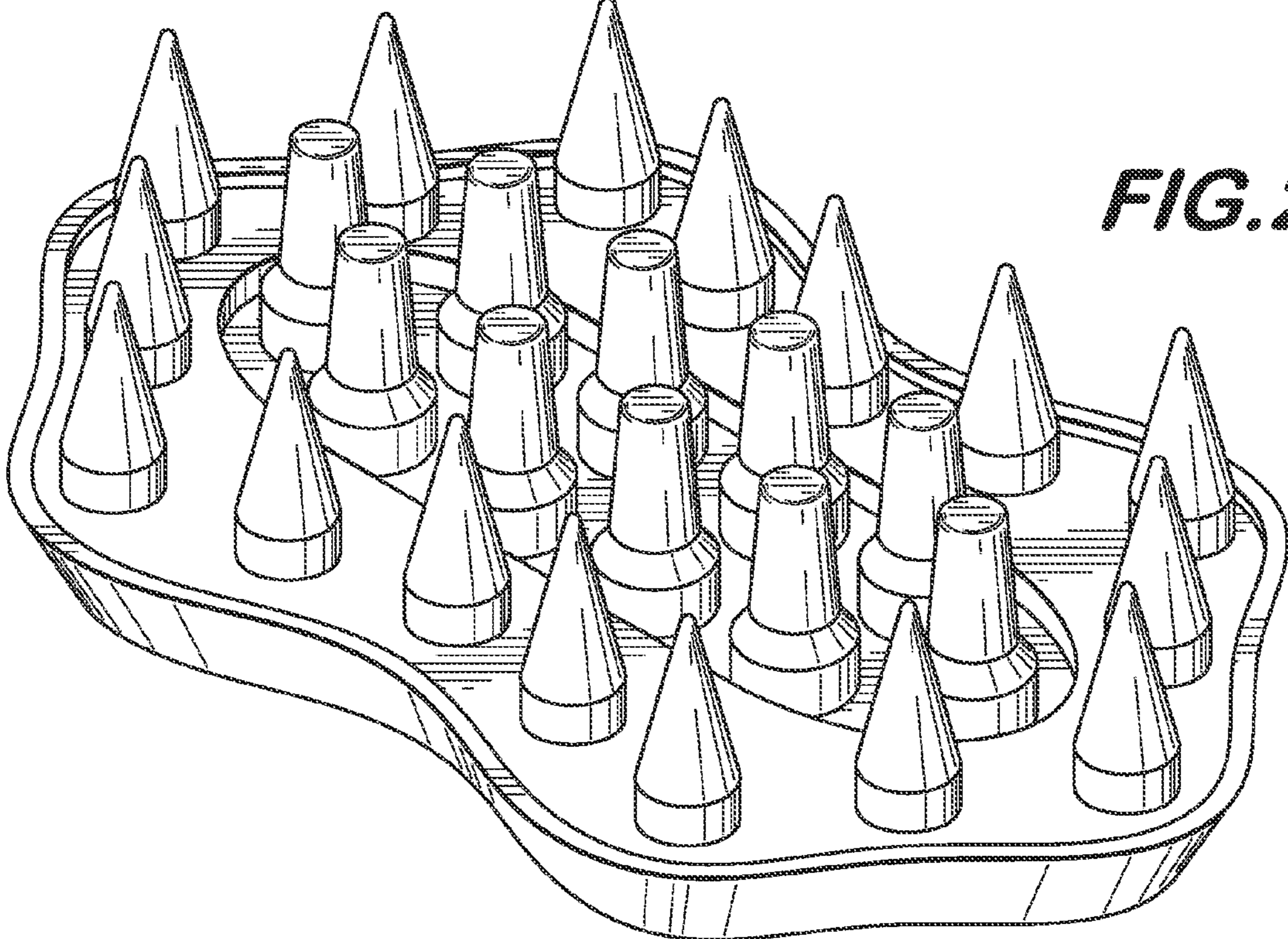

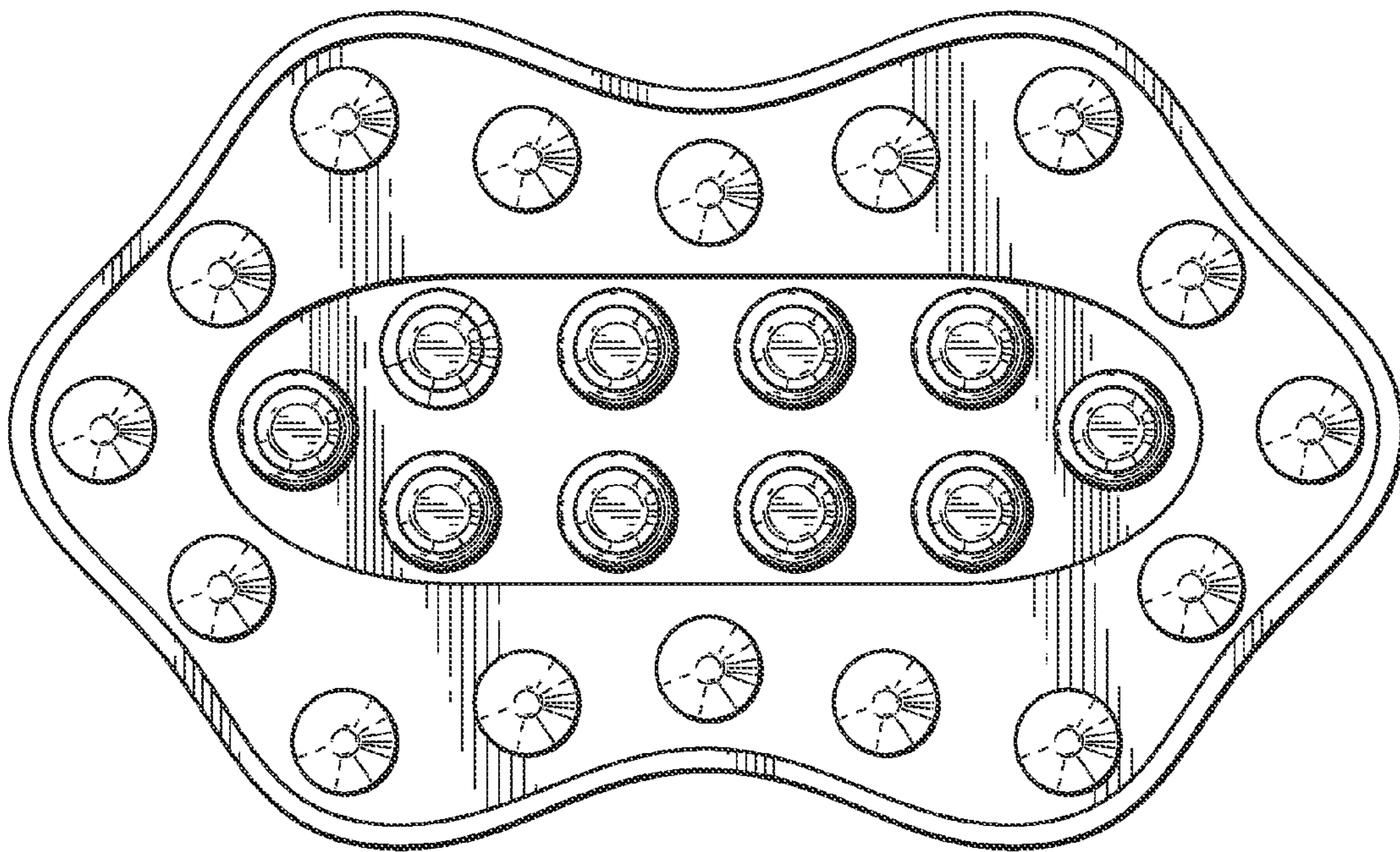
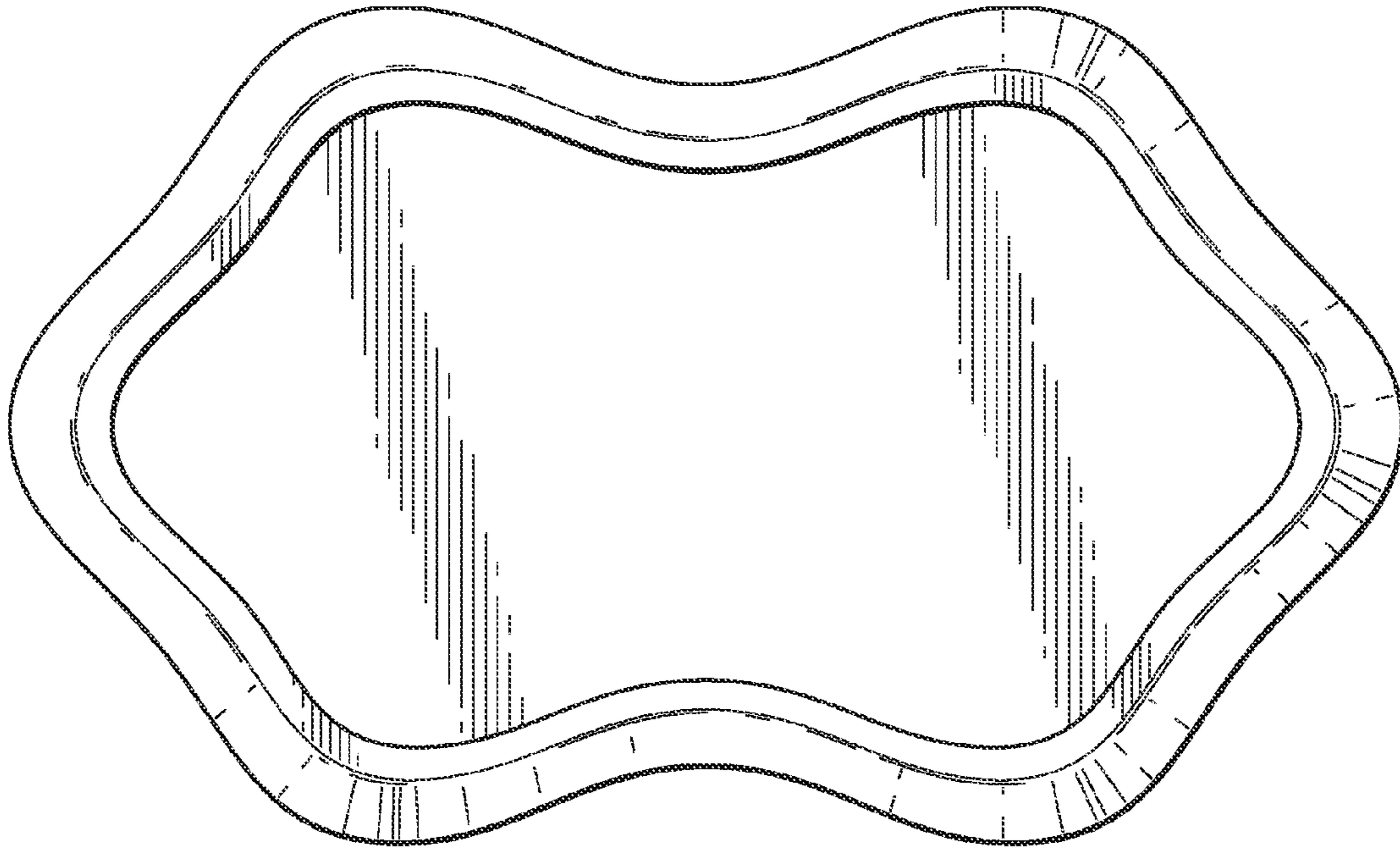

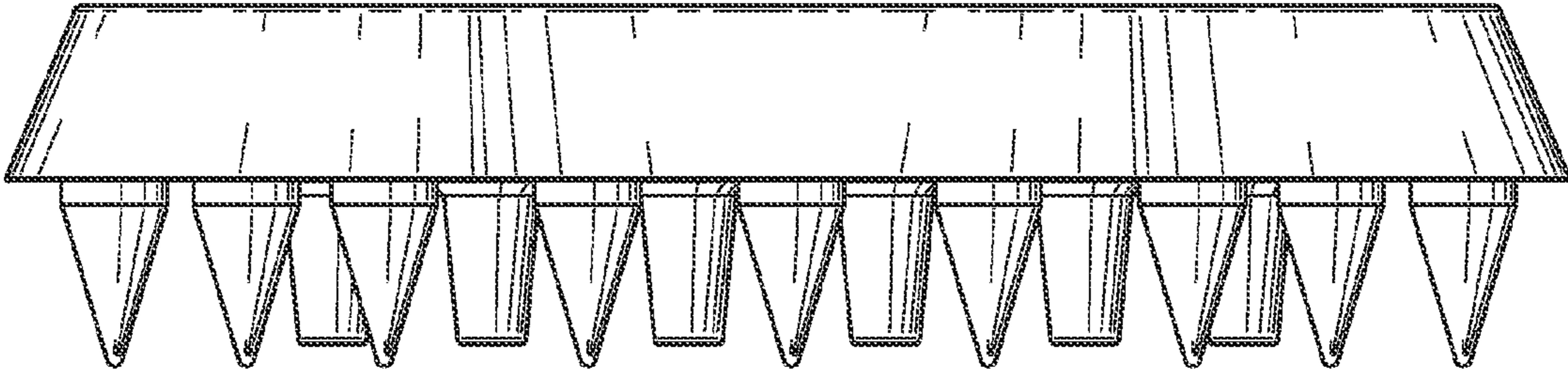

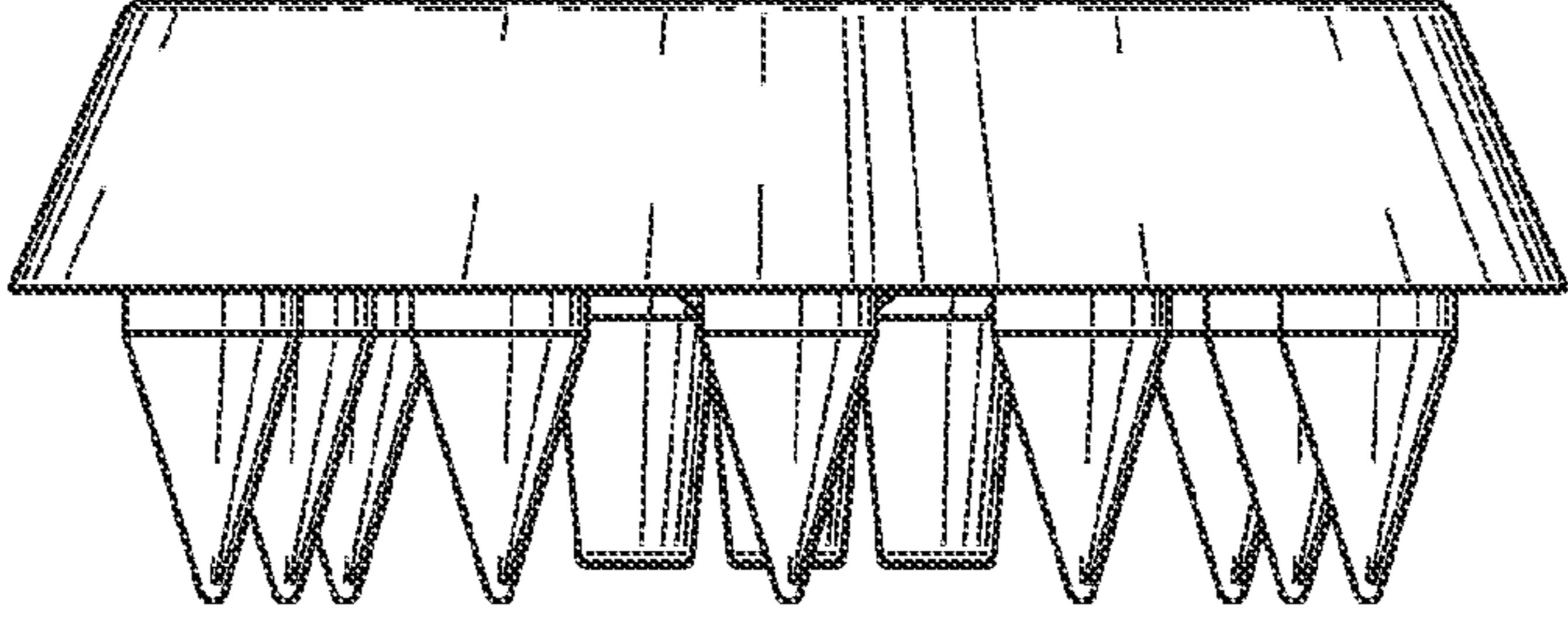
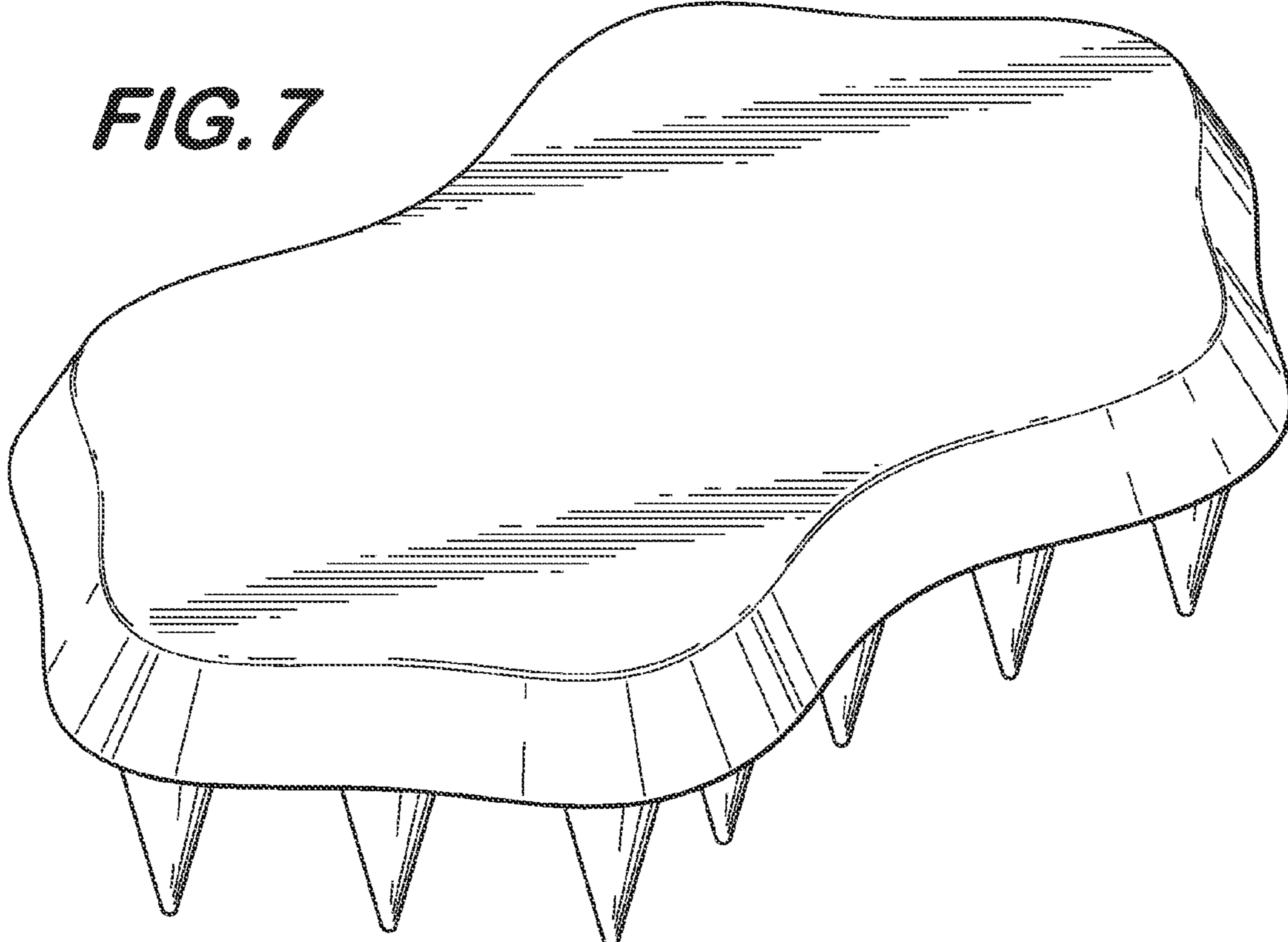

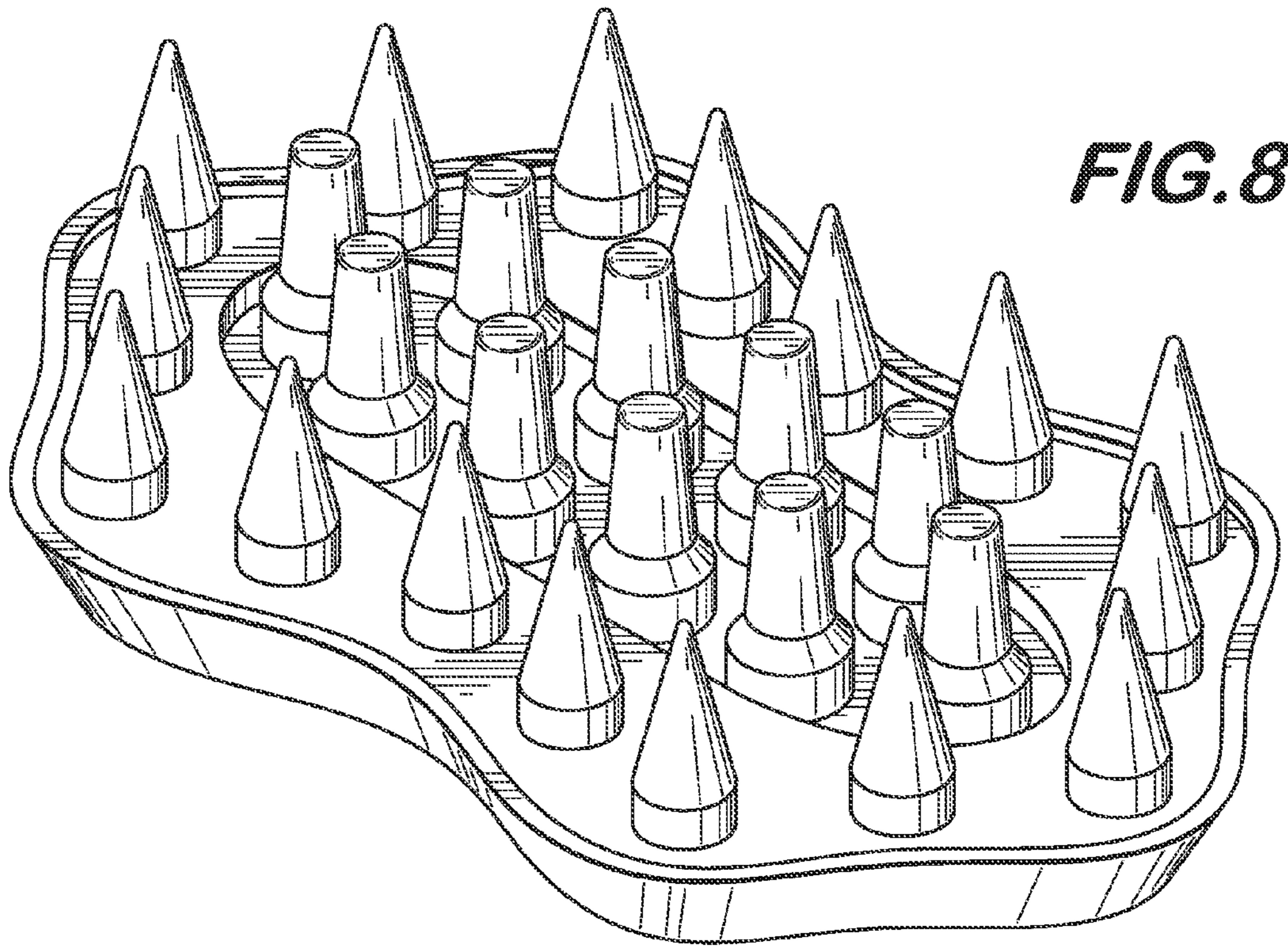

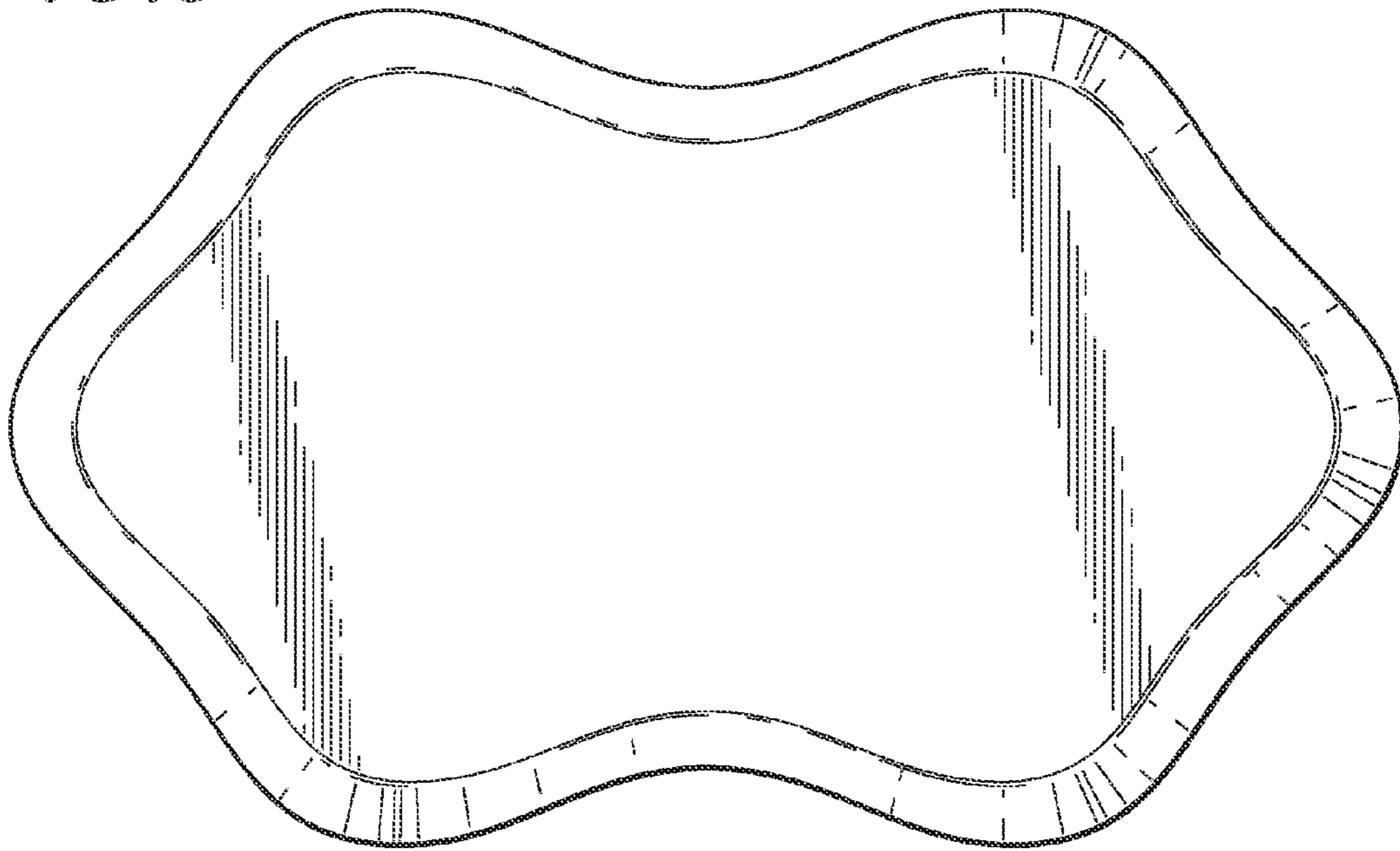

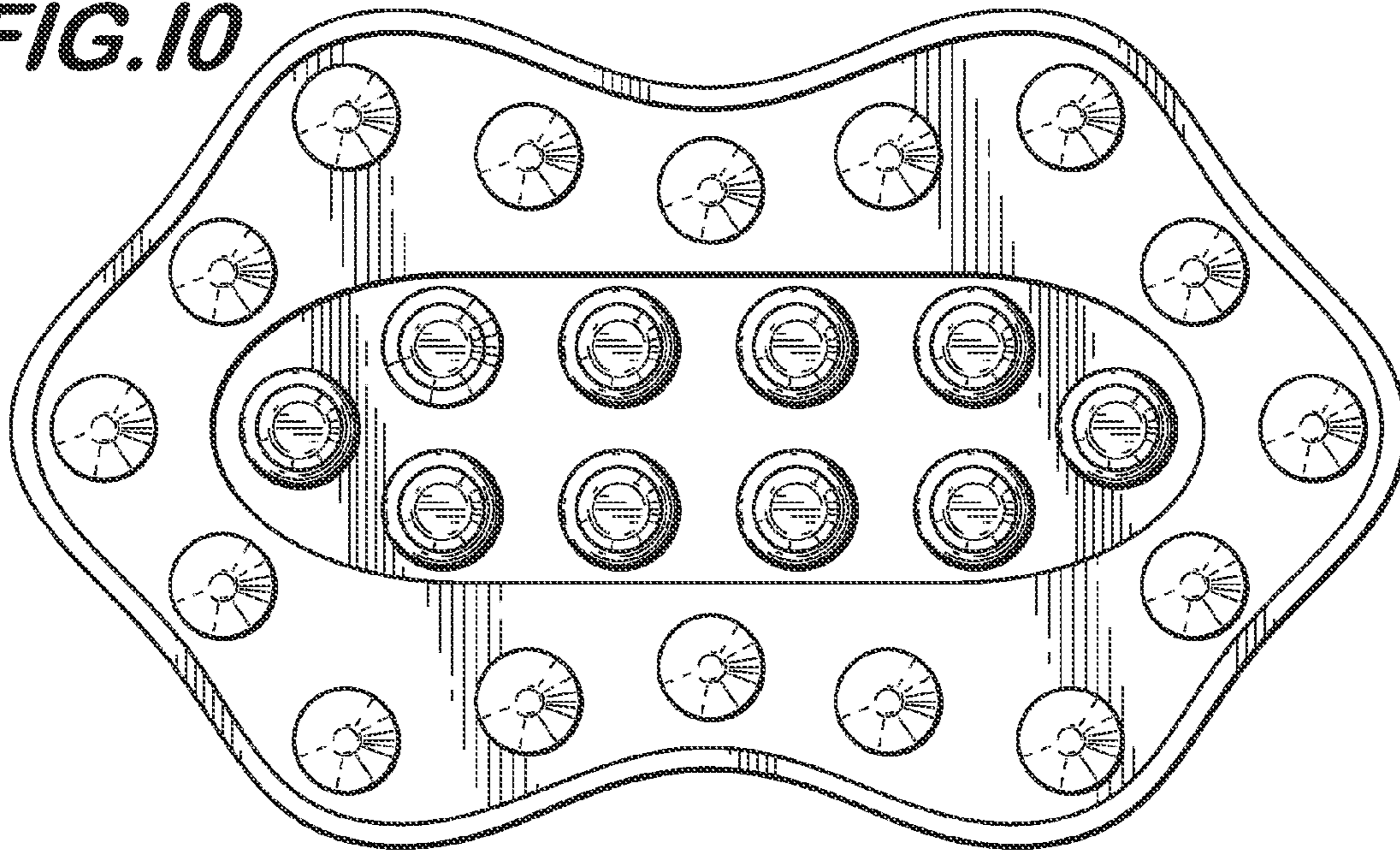

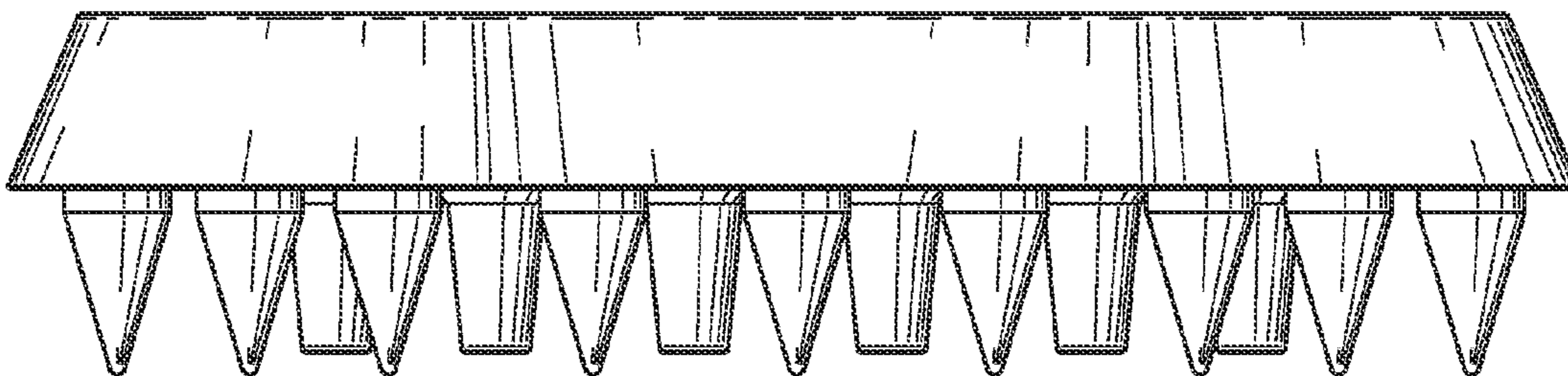
