The ornamental design for double-walled carafe, as shown and described.

DESCRIPTION

FIG. 1 is an exploded perspective view of the double-walled carafe;

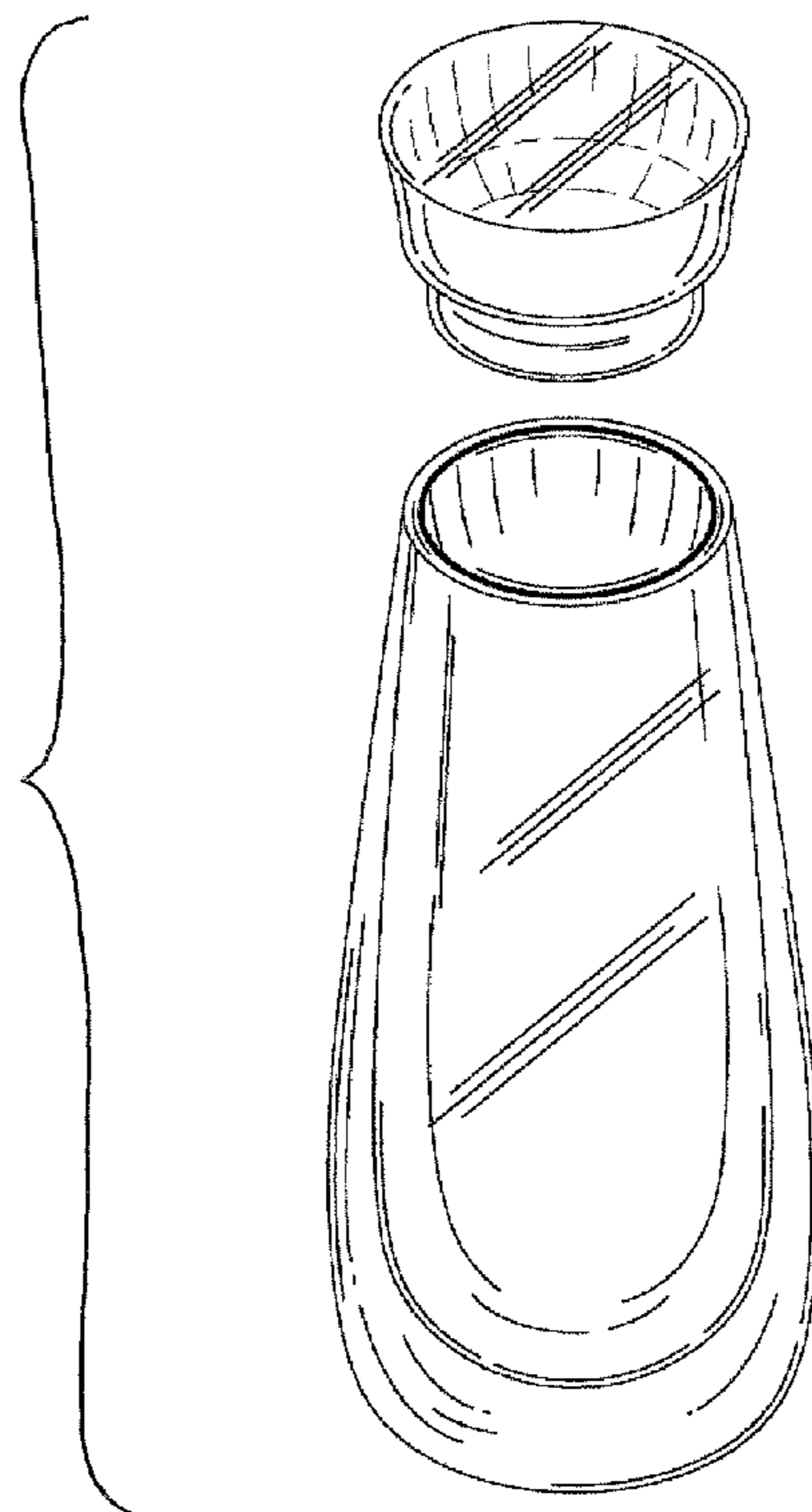
FIG. 2 is a side view of the double-walled carafe shown in FIG. 1;

FIG. 3 an enlarged cross-sectional view of the double-walled carafe of FIG. 2 along the A—A axis;

FIG. 4 is an enlarged top plan view of the double-walled carafe shown in FIG. 1; and,

FIG. 5 is an enlarged bottom plan view of the double-walled carafe shown in FIG. 1.

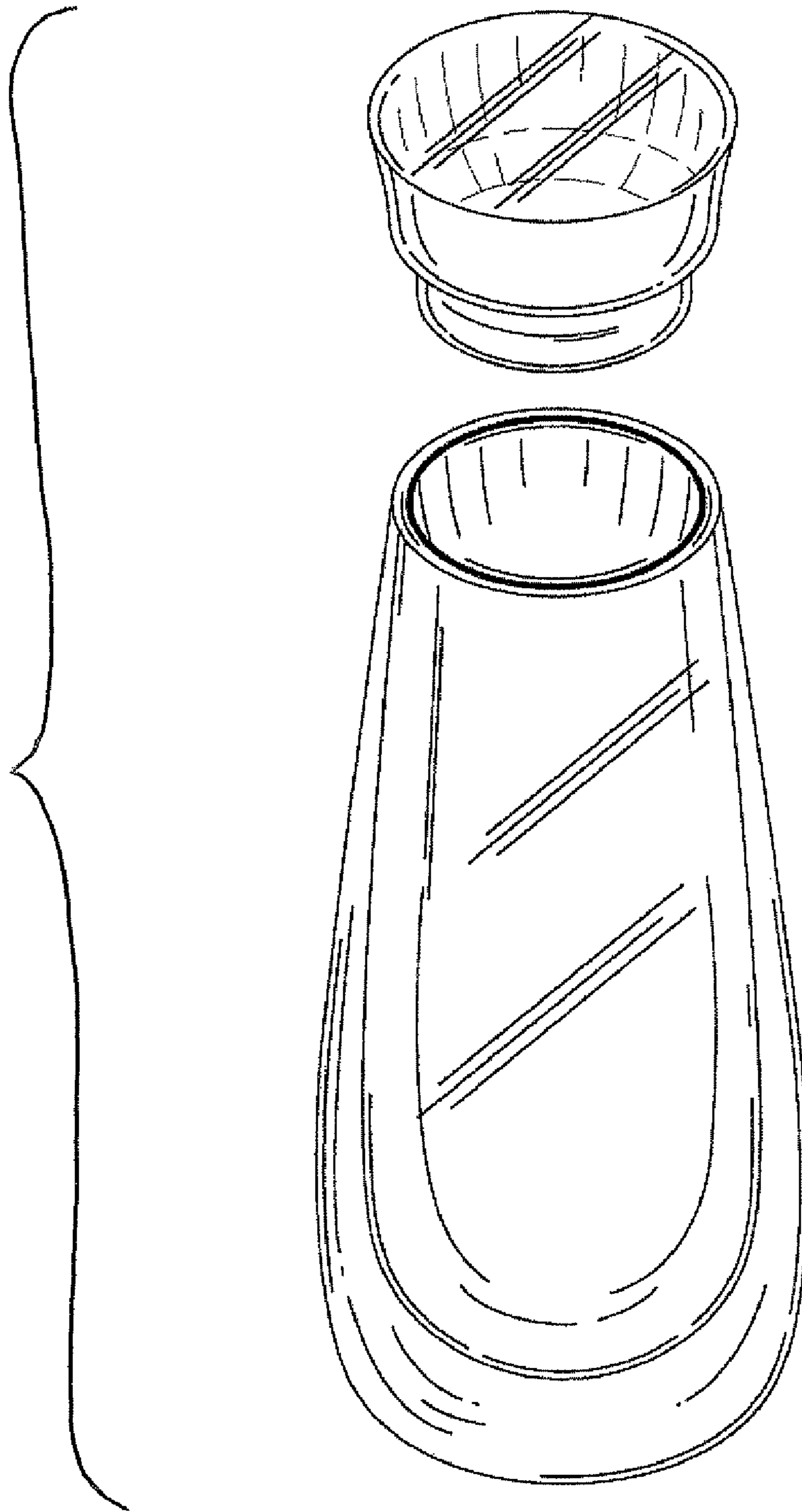

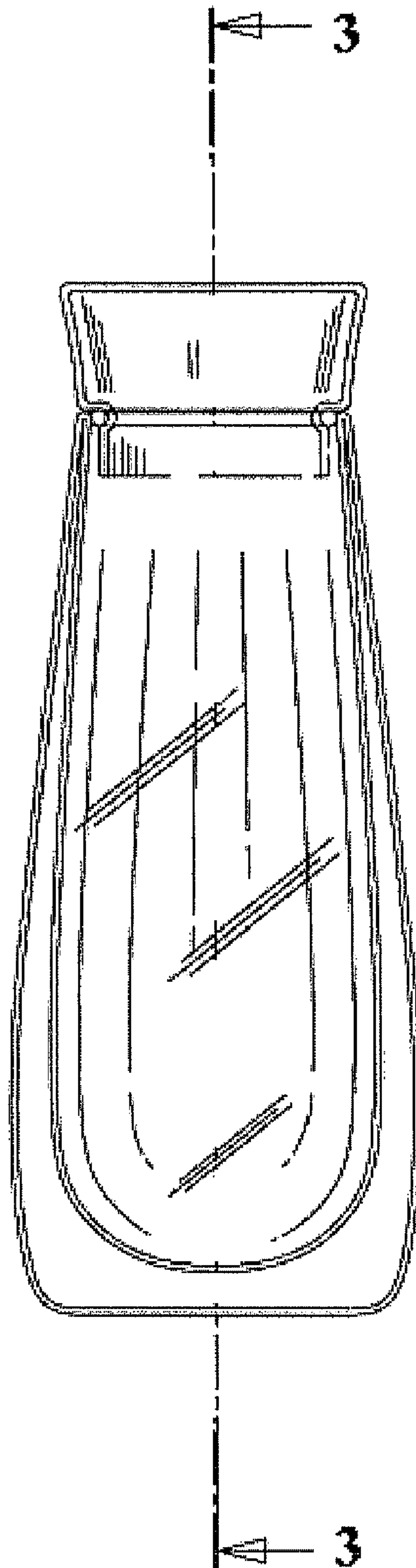

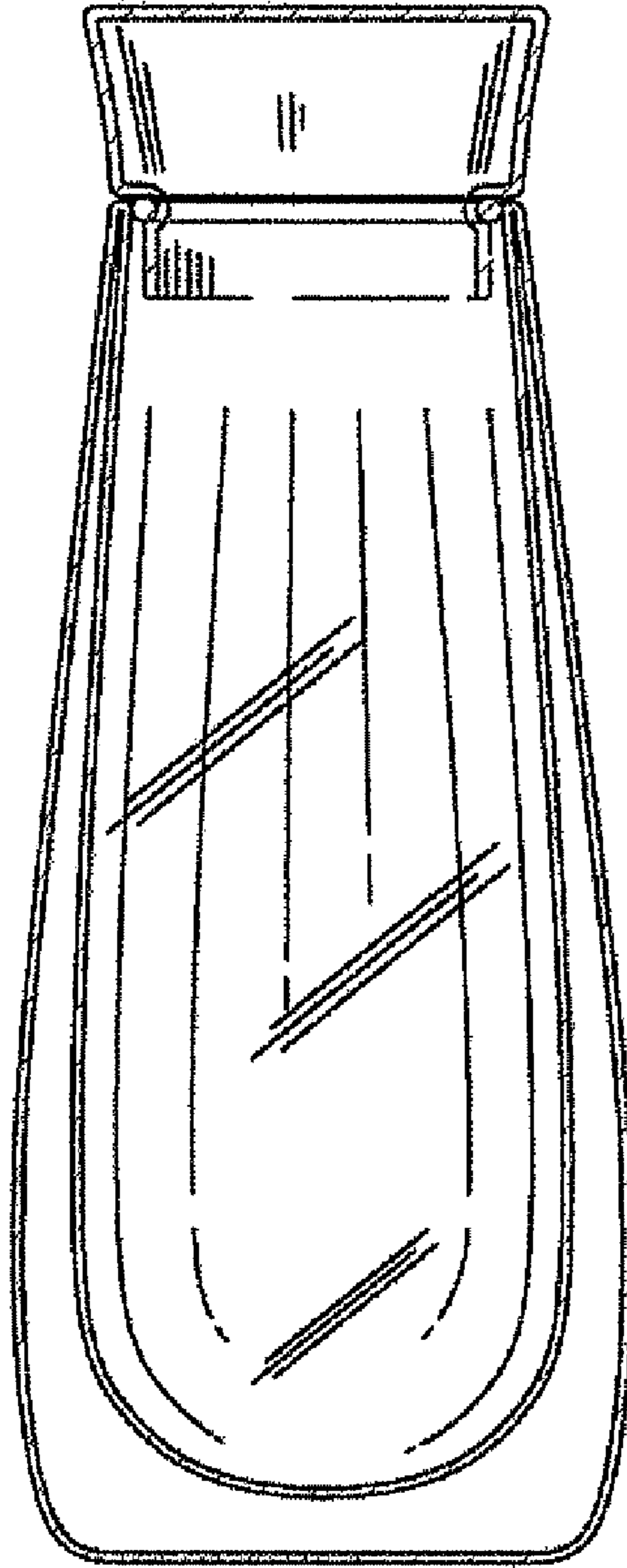

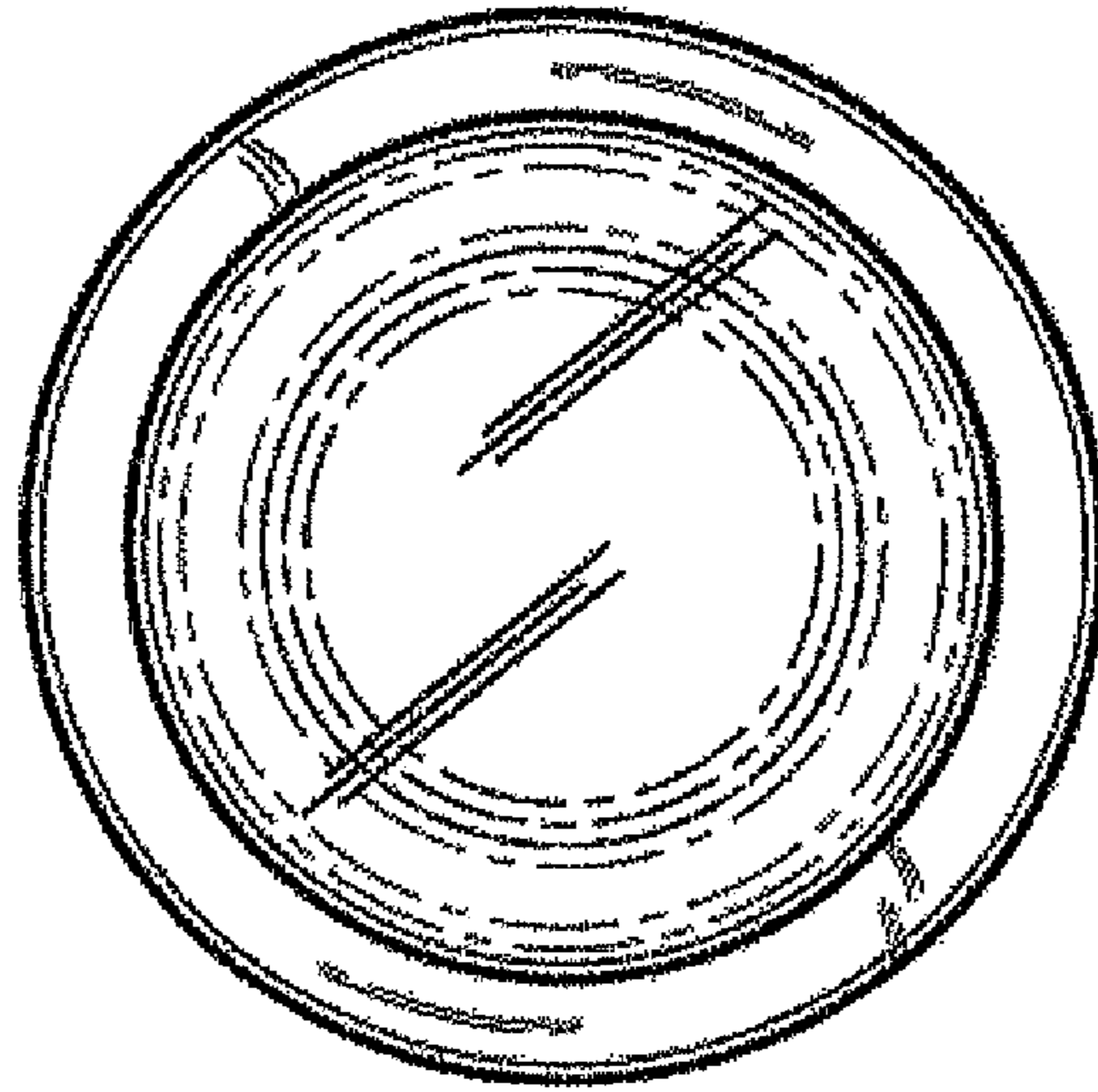

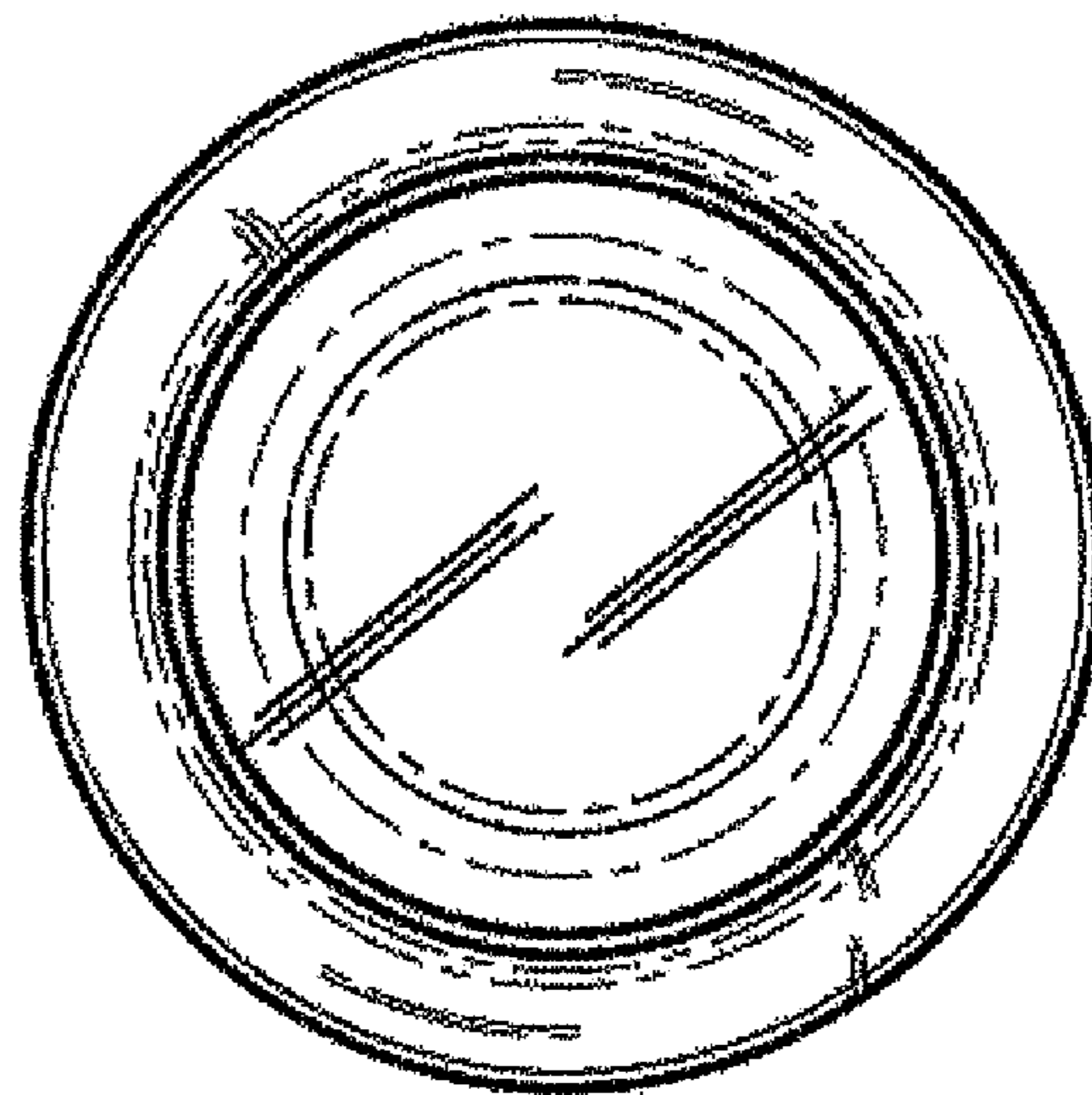
