FIG. 1 is a front view of the taco holder.

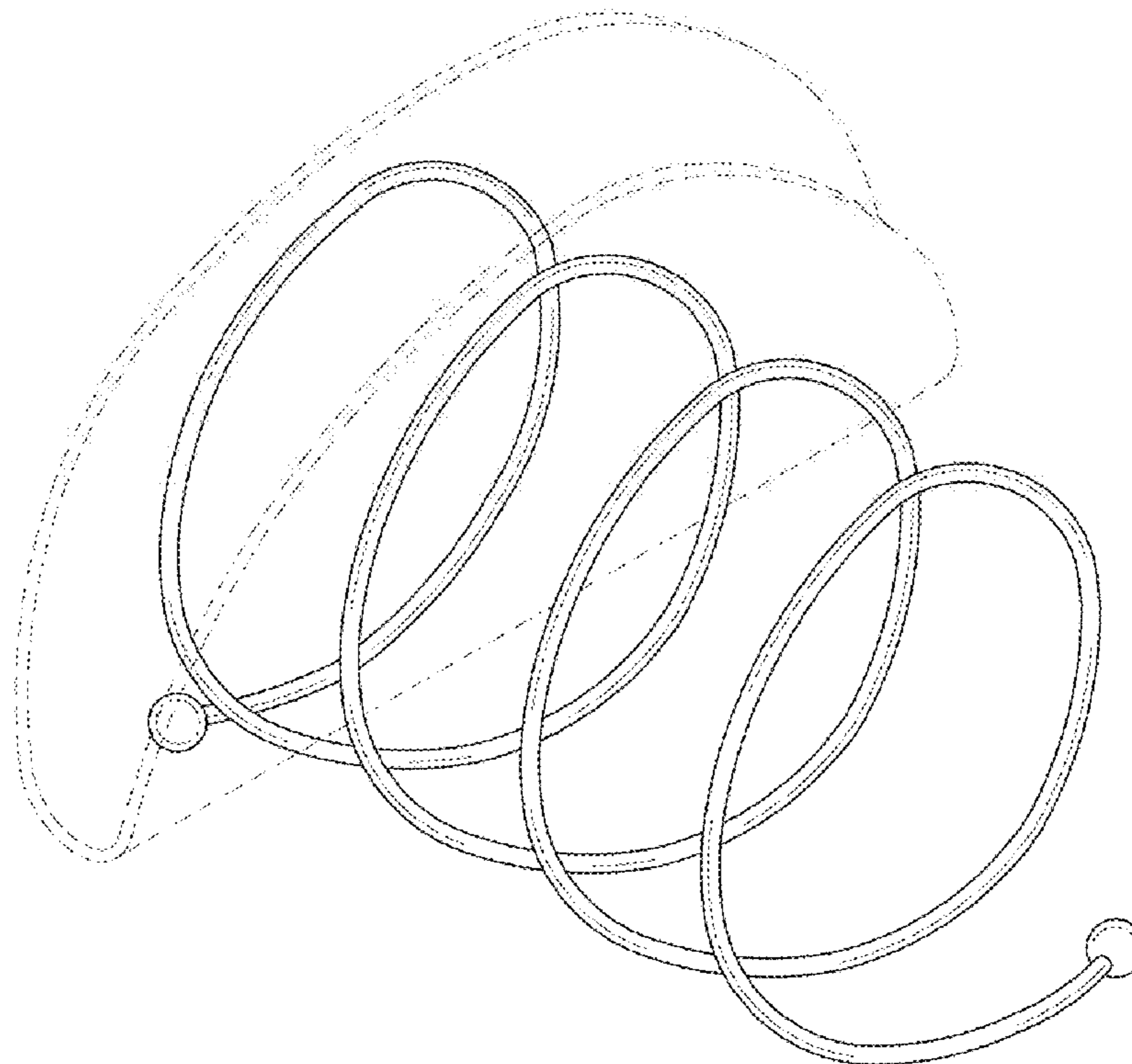
FIG. 2 is an end view of the claimed design.

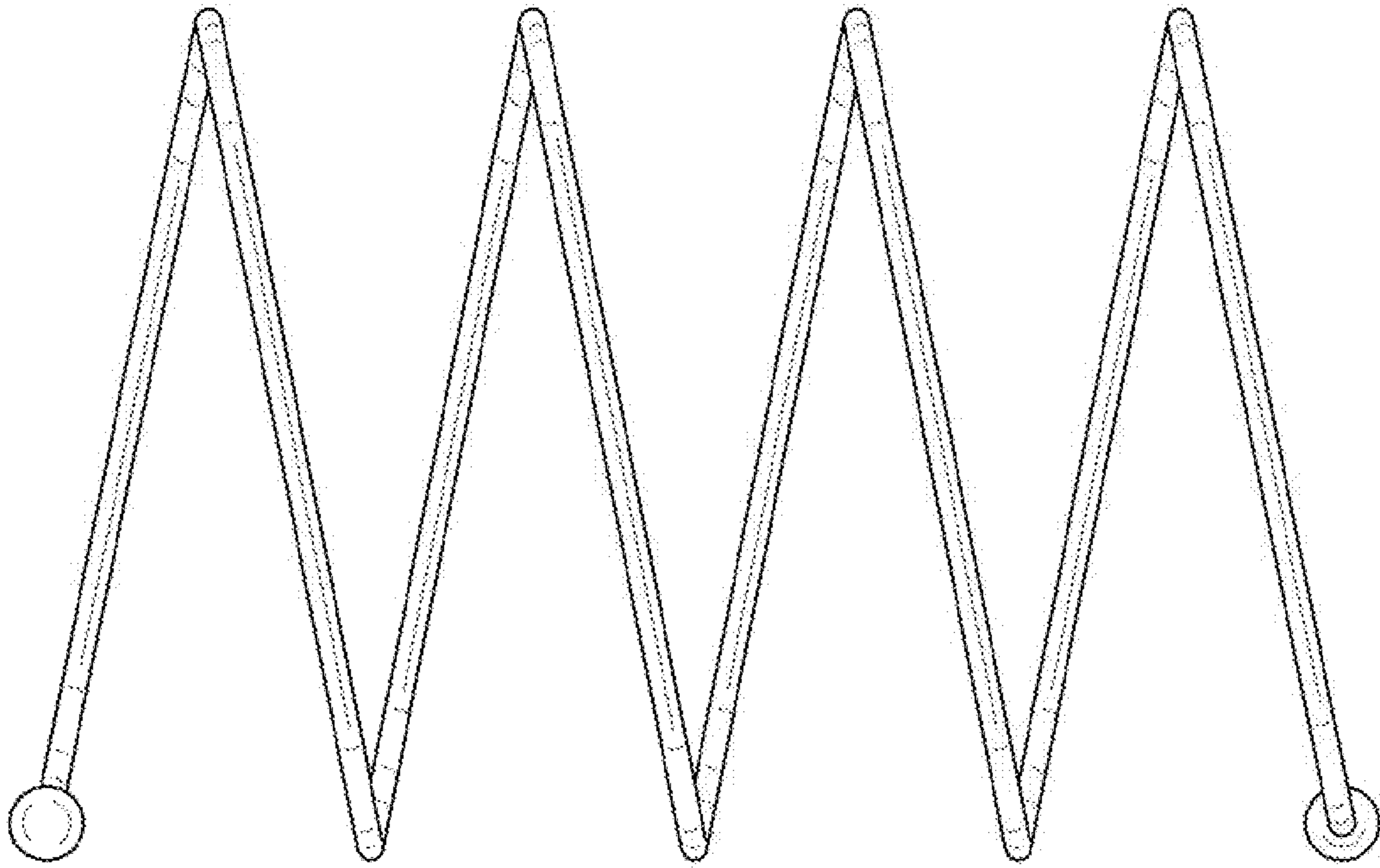

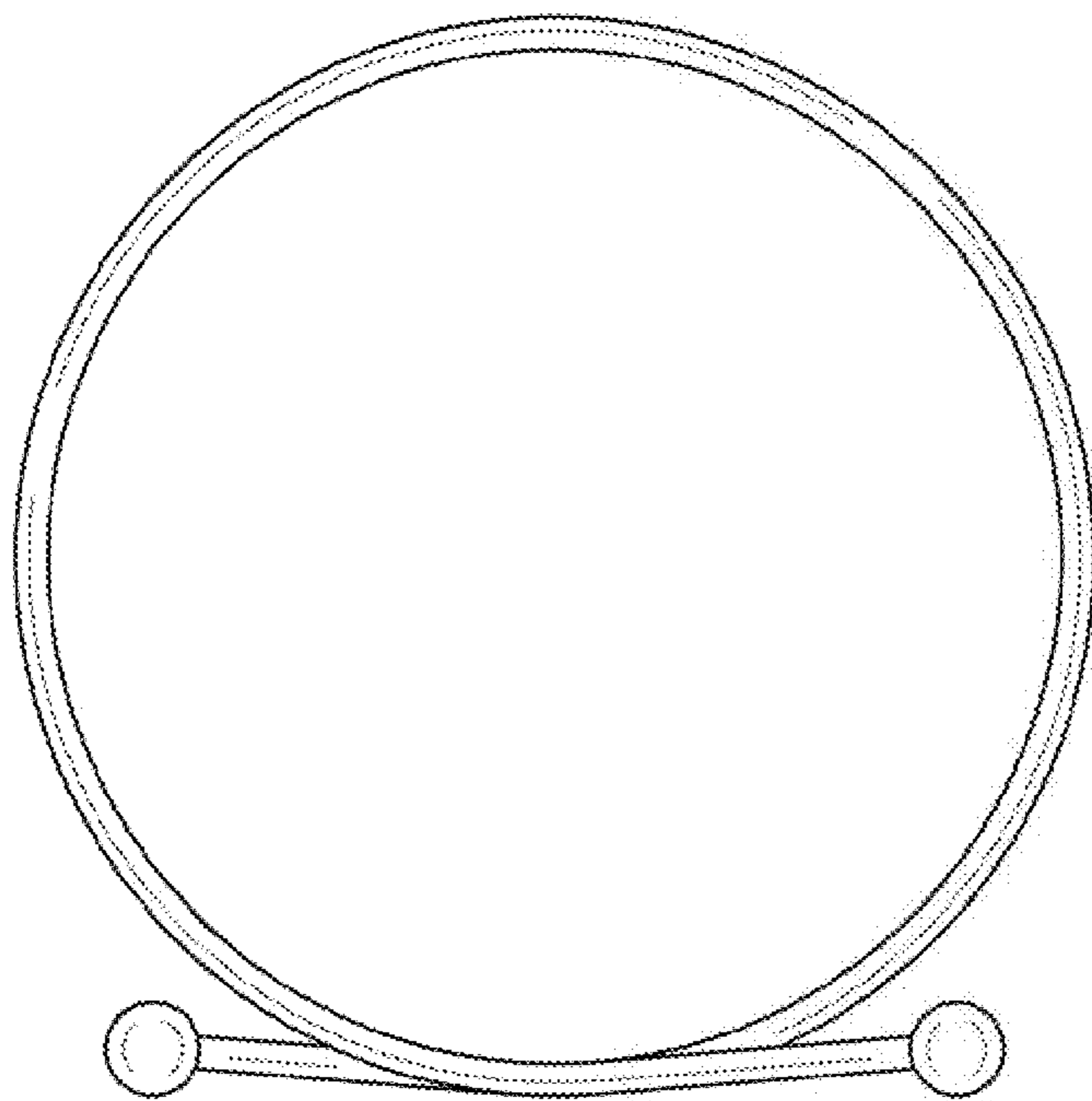

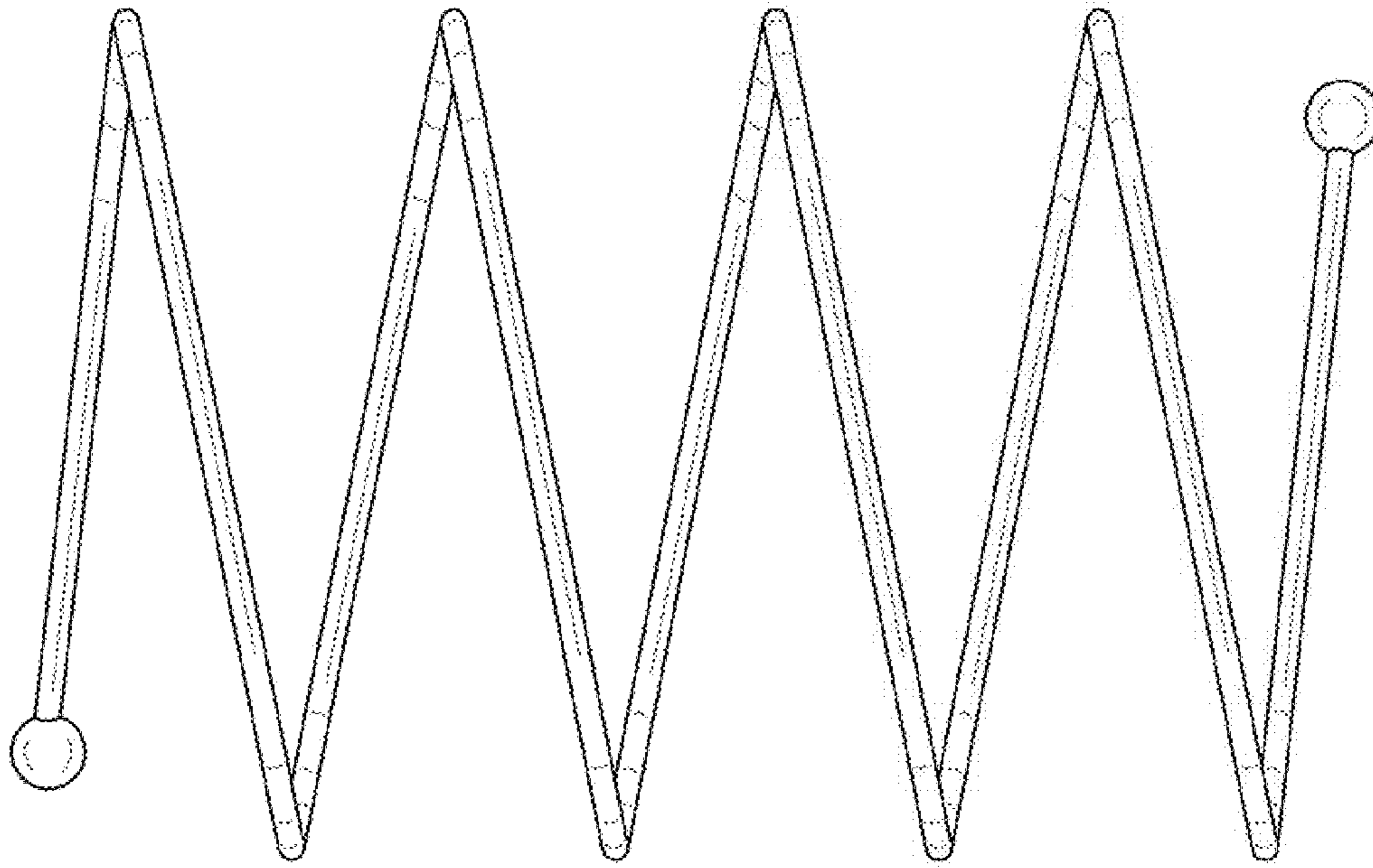

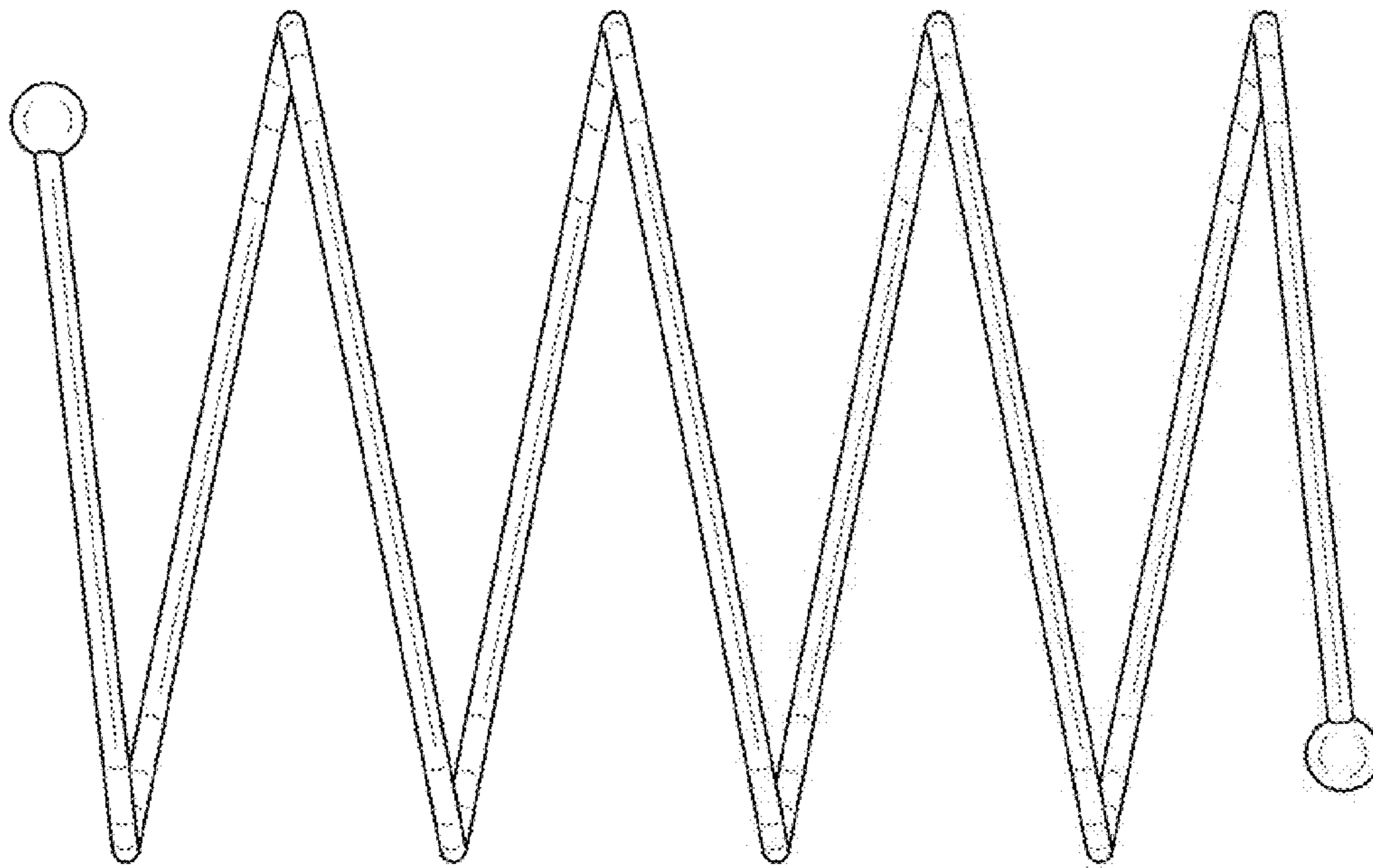

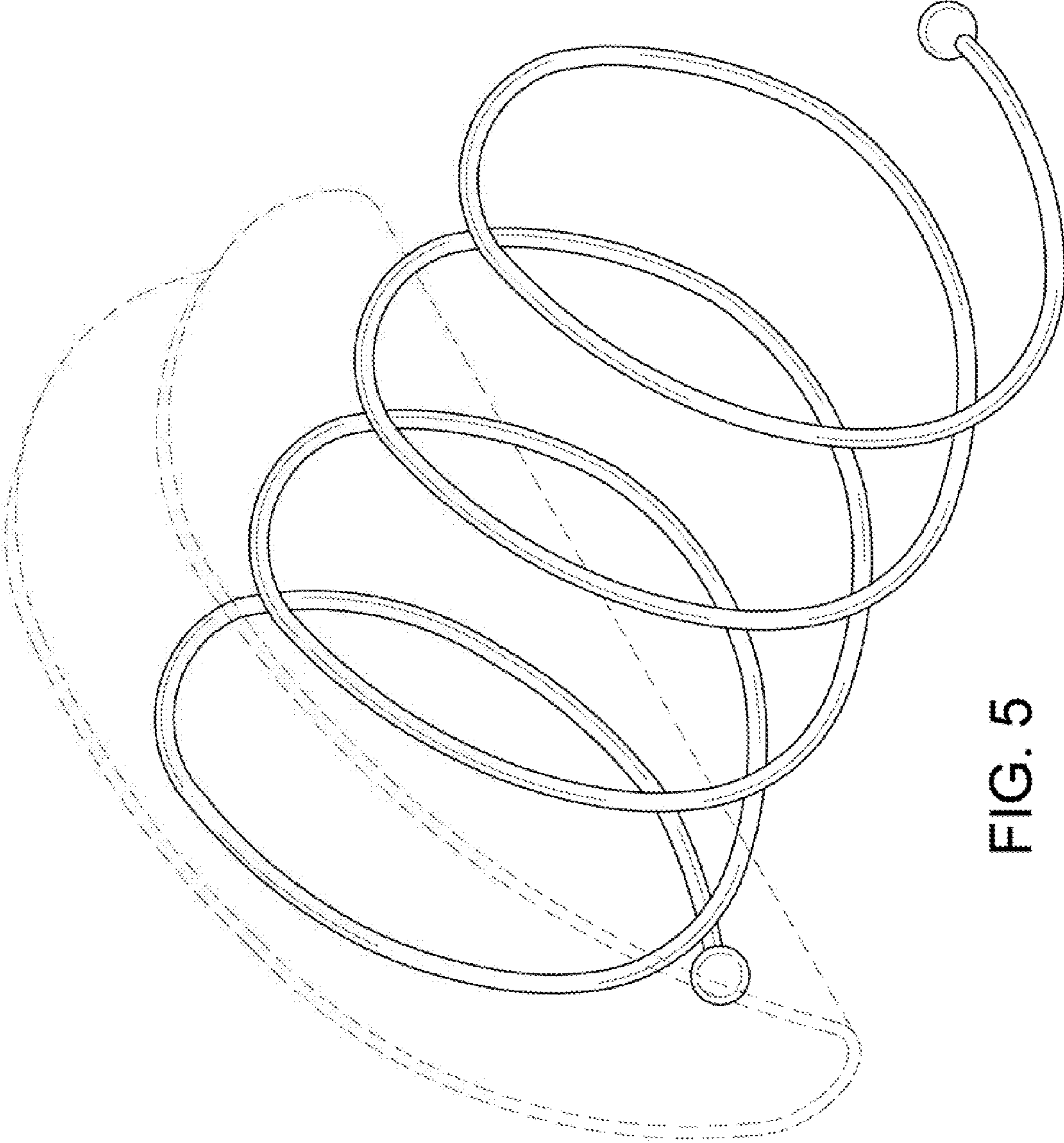
