(57) **CLAIM**

The ornamental design for a toddler's drinking cup with sleeve and top, substantially as shown.

DESCRIPTION

FIG. 1 is a perspective view of a toddler drinking cup and top showing my new design;

FIG. 2 is a front view of the toddler's drinking cup with sleeve and top, thereof;

FIG. 3 is a rear view of the toddler's drinking cup with sleeve and top, thereof;

FIG. 4 is a right side view of the toddler's drinking cup with sleeve and top, thereof;

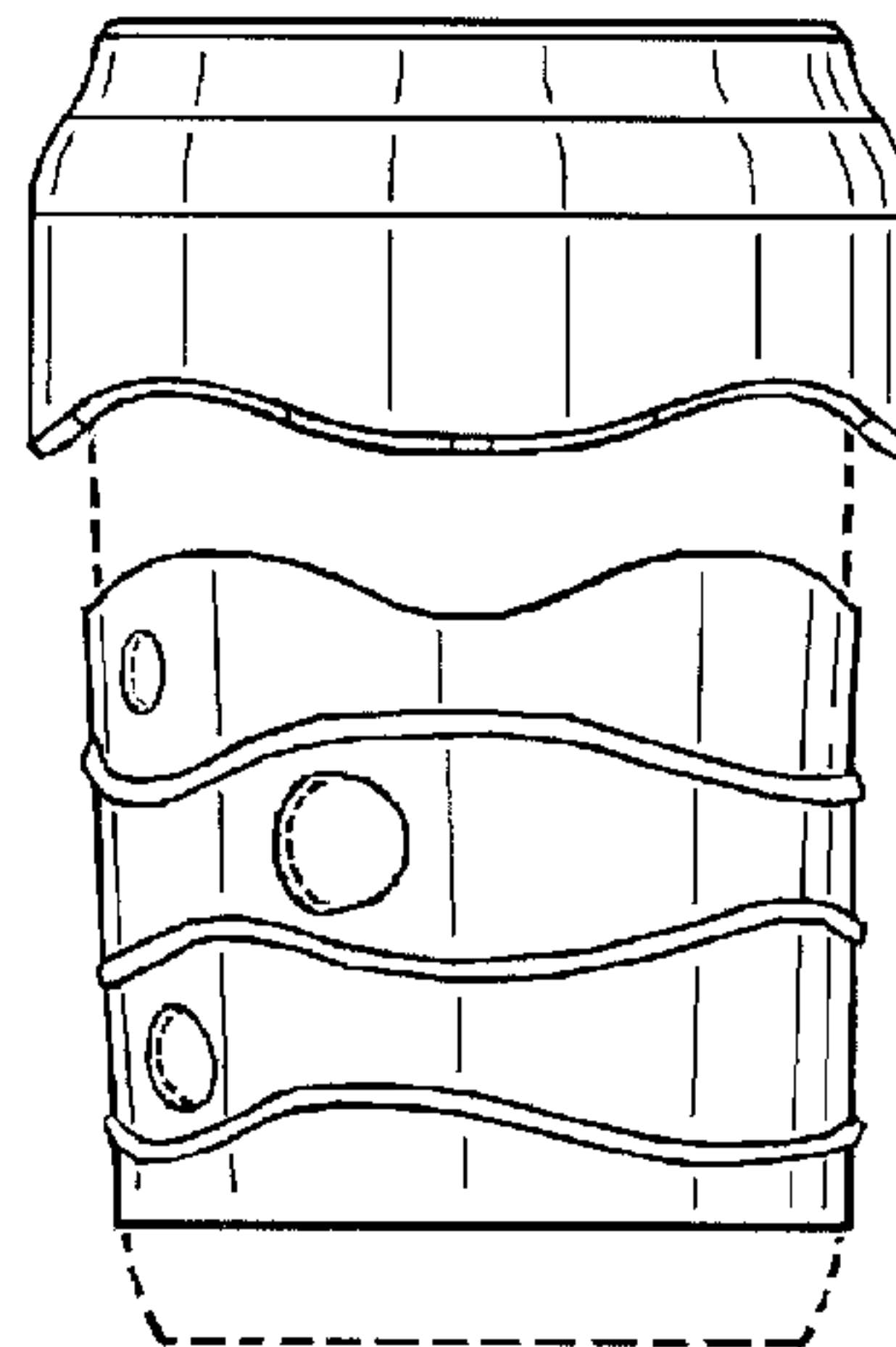
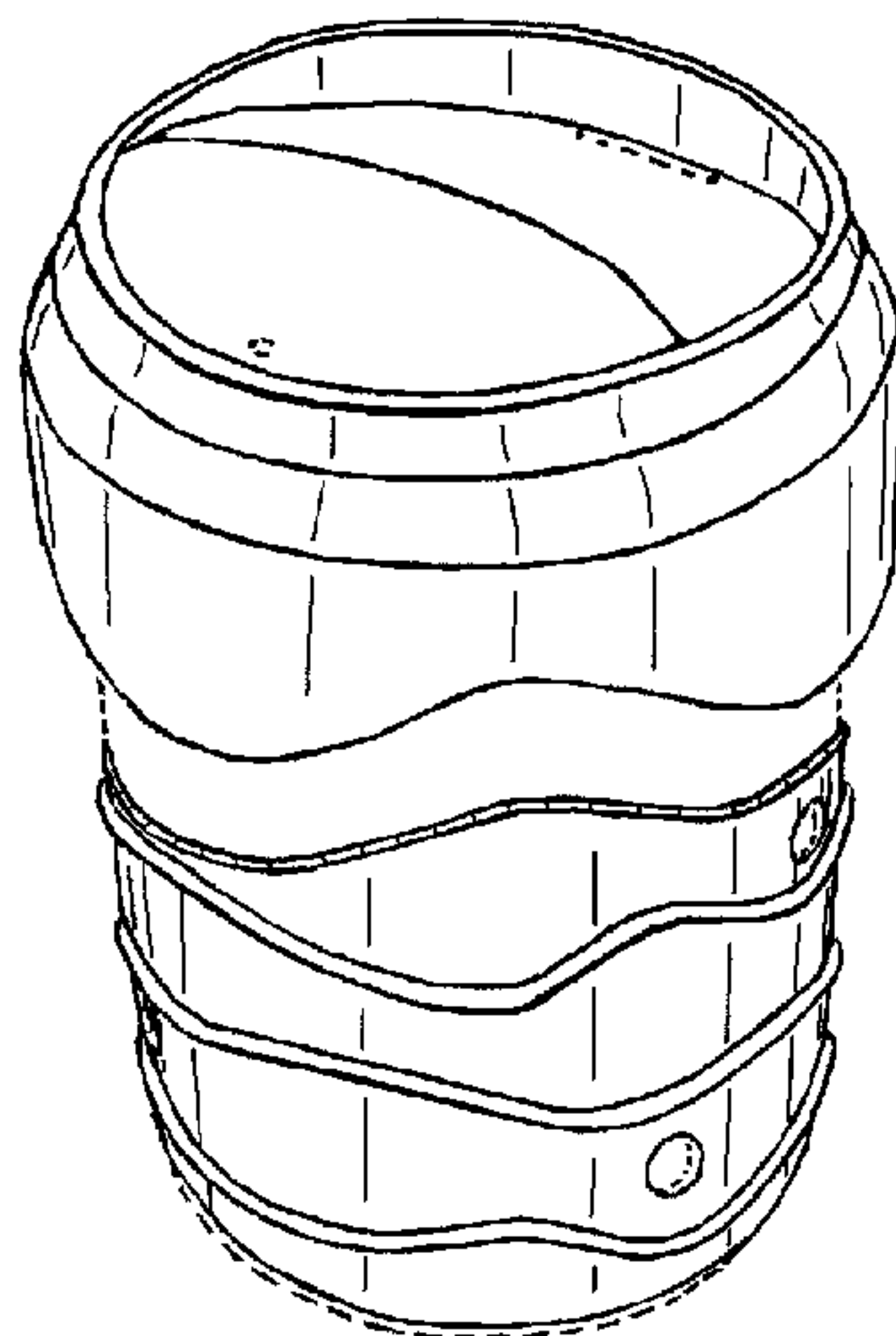
FIG. 5 is a left side view of the toddler's drinking cup with sleeve and top, thereof;

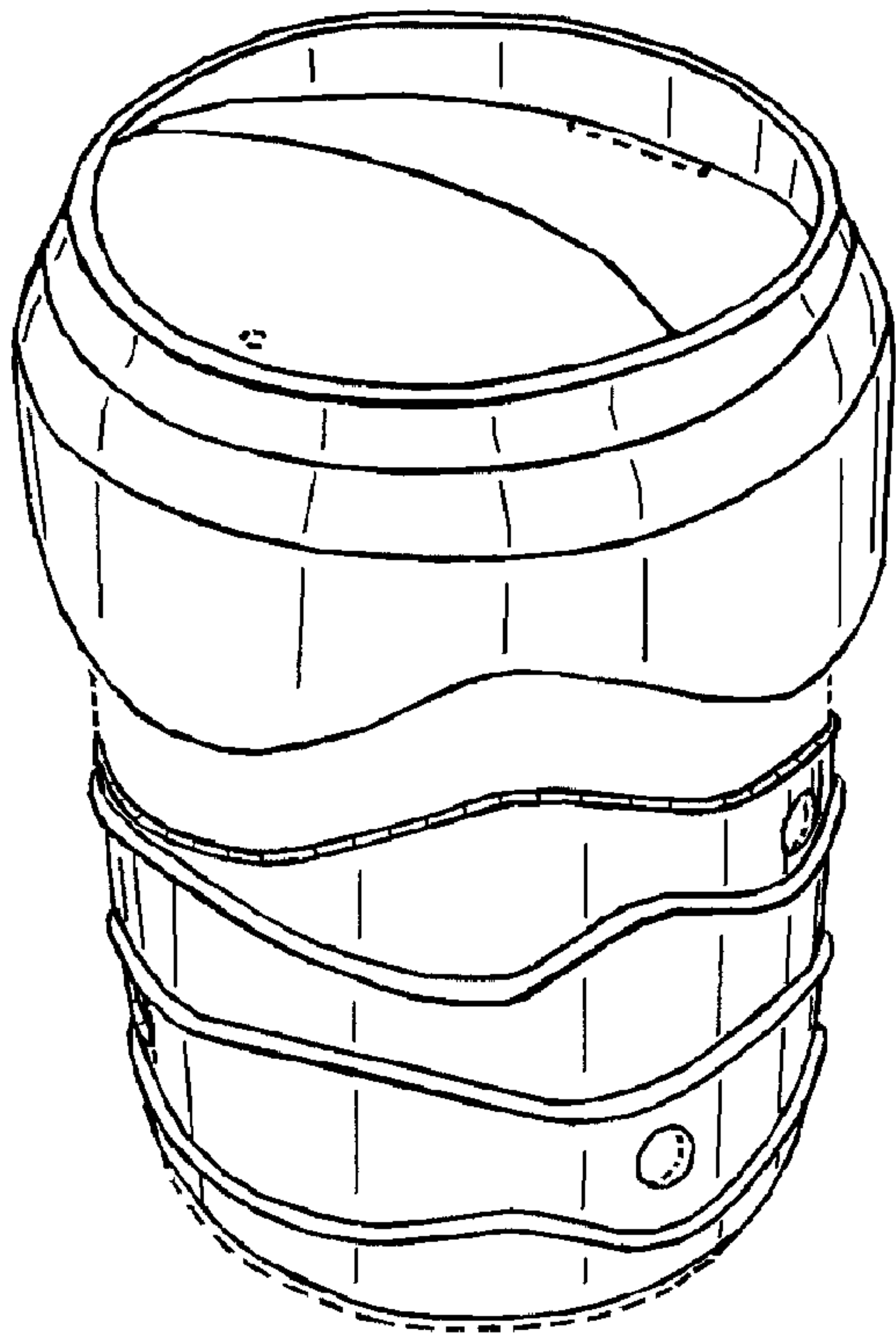

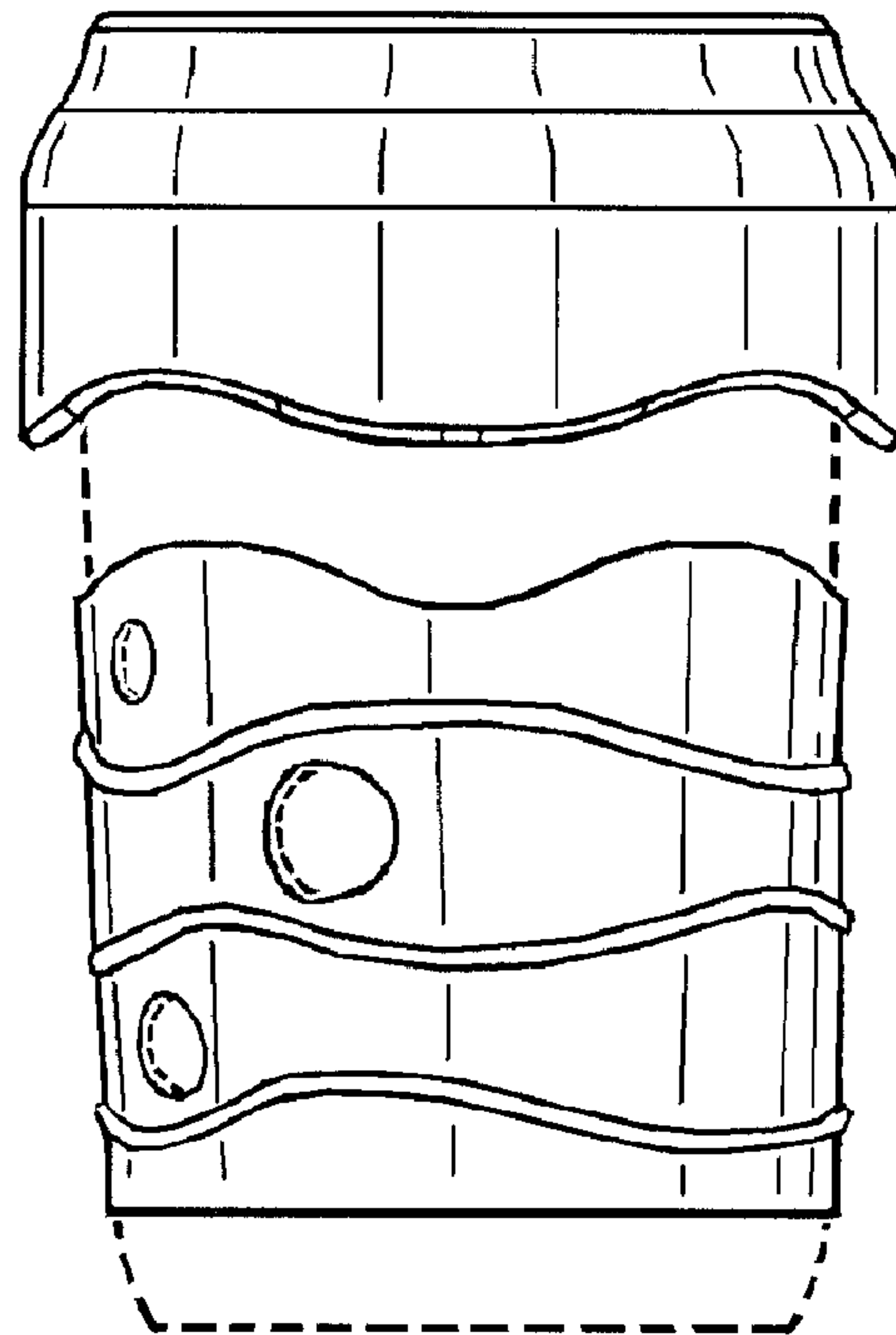

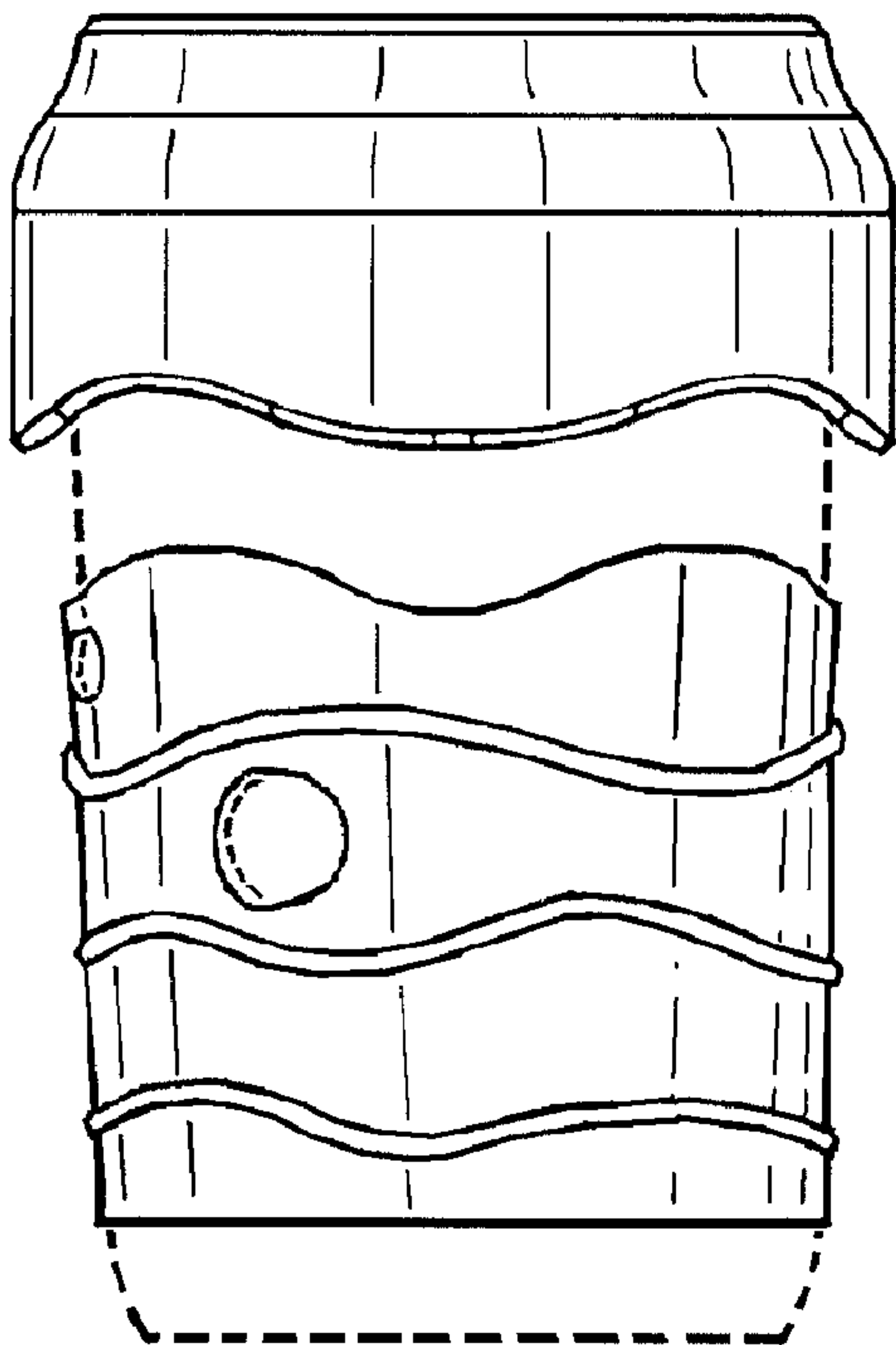

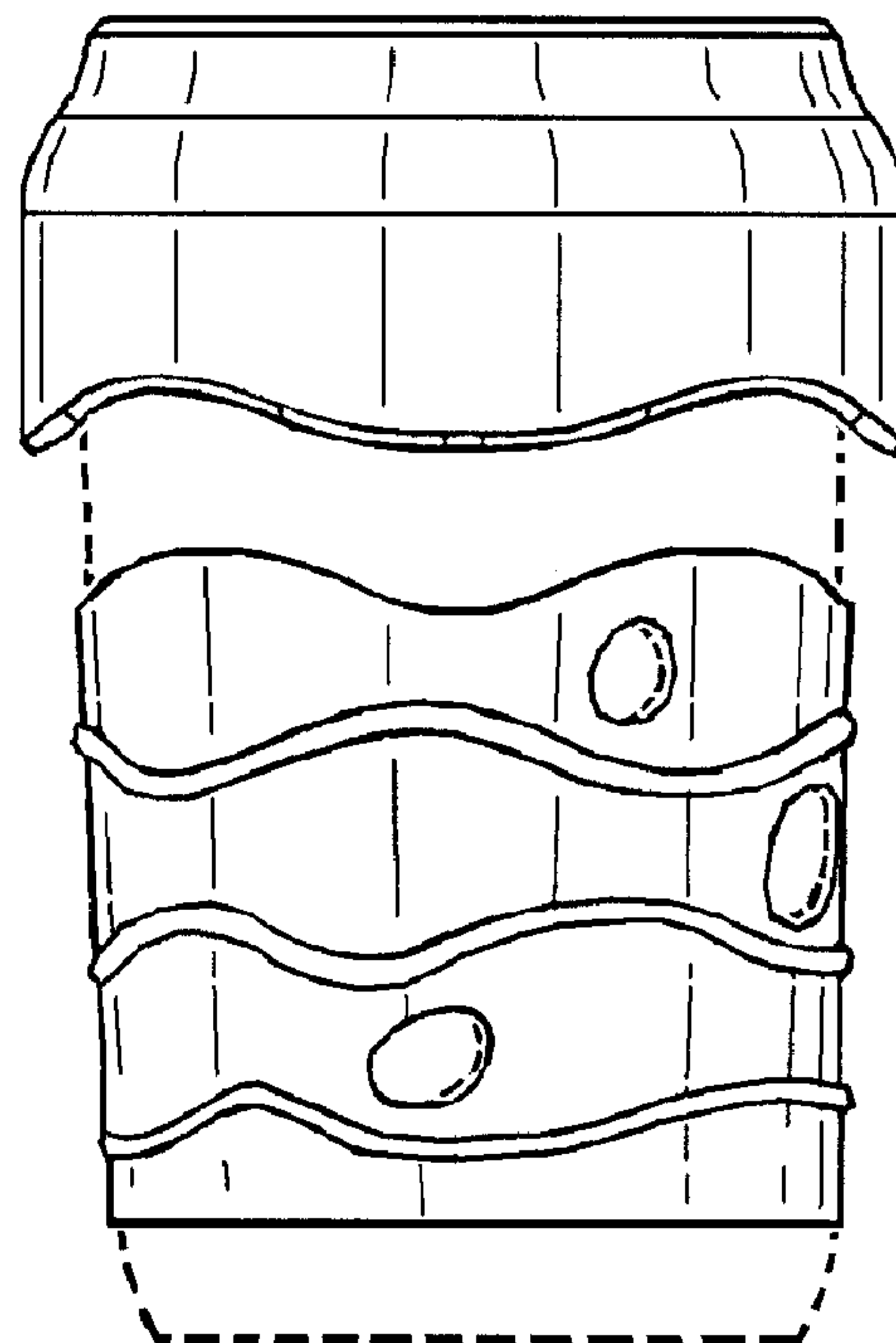

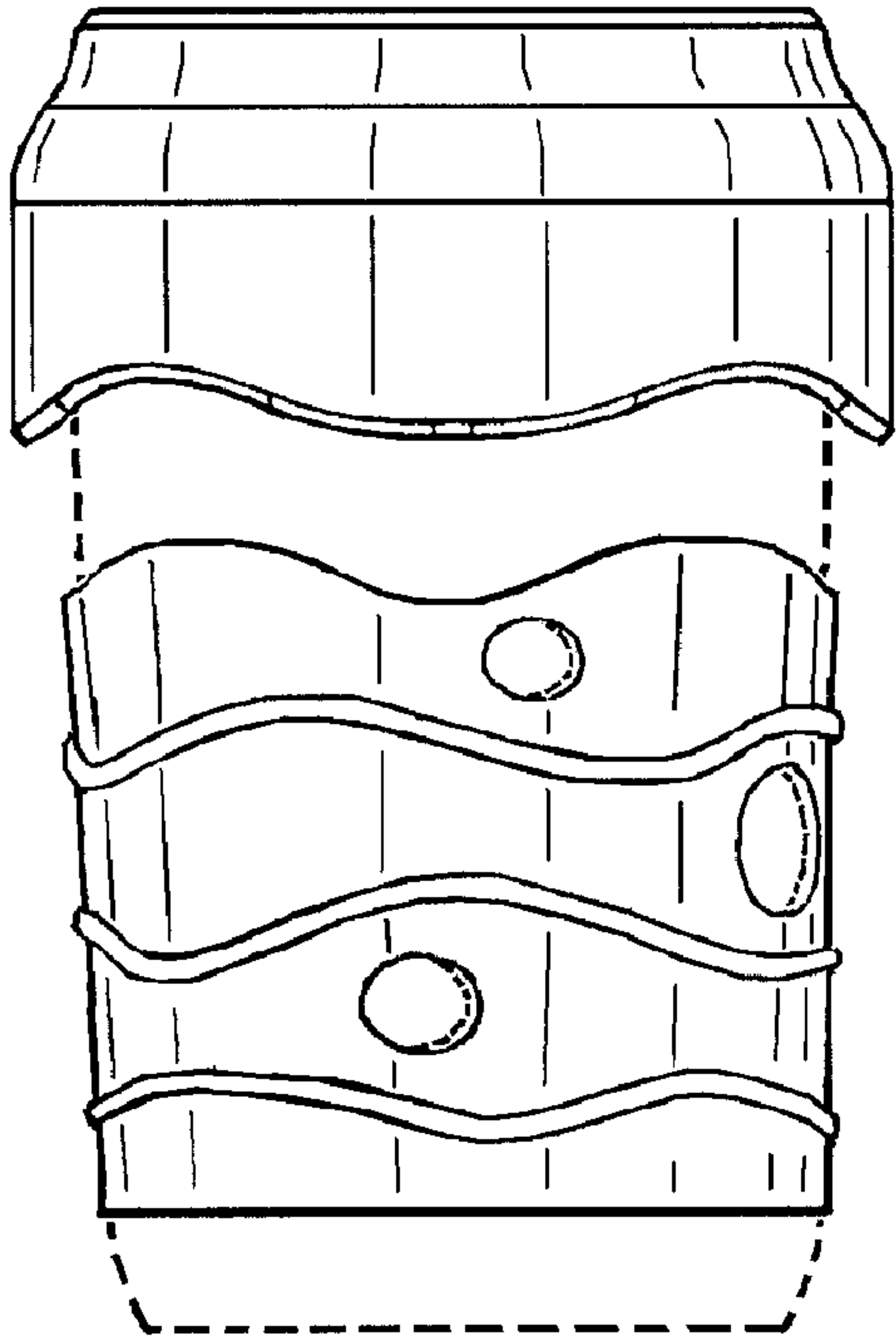

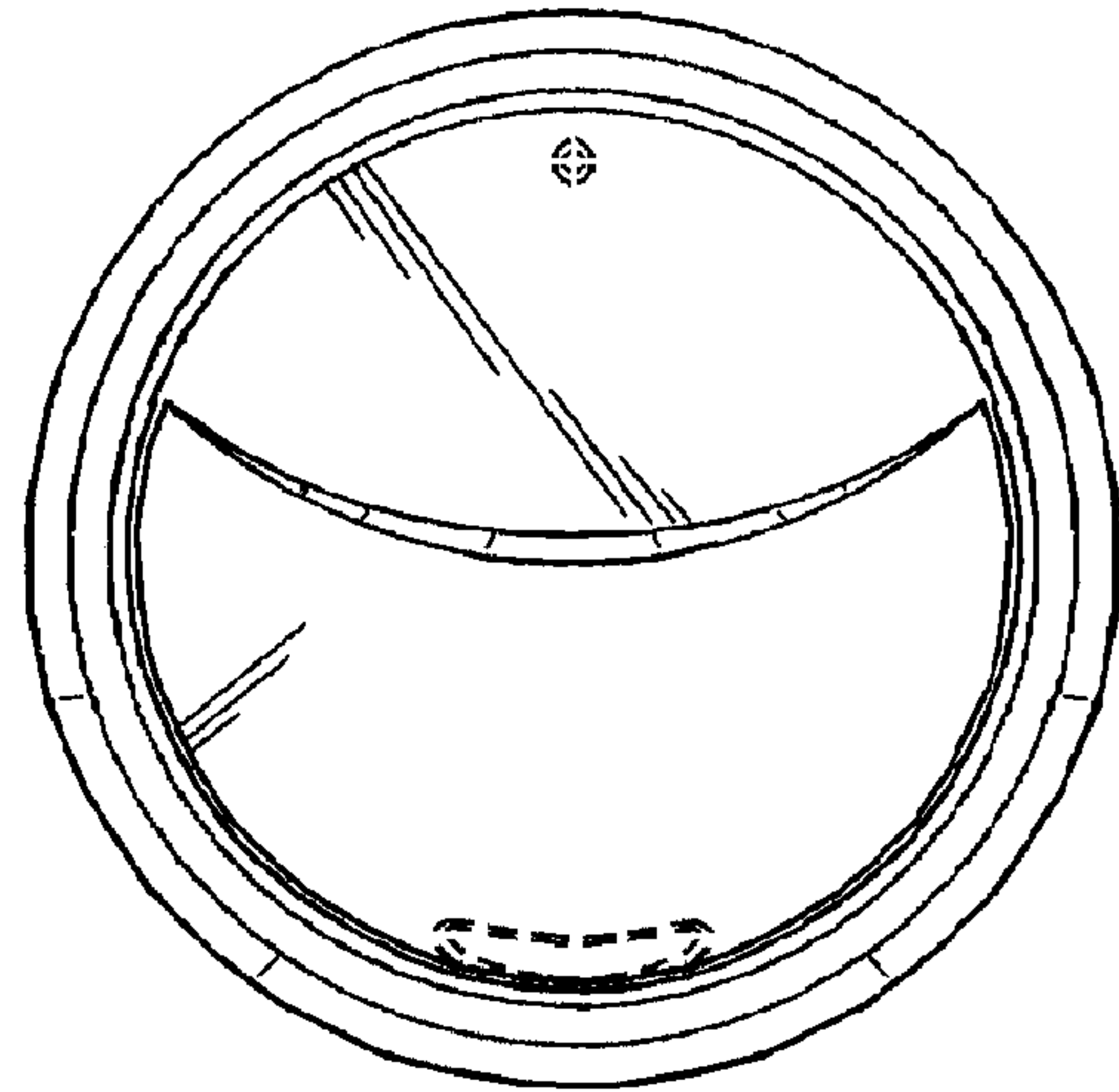

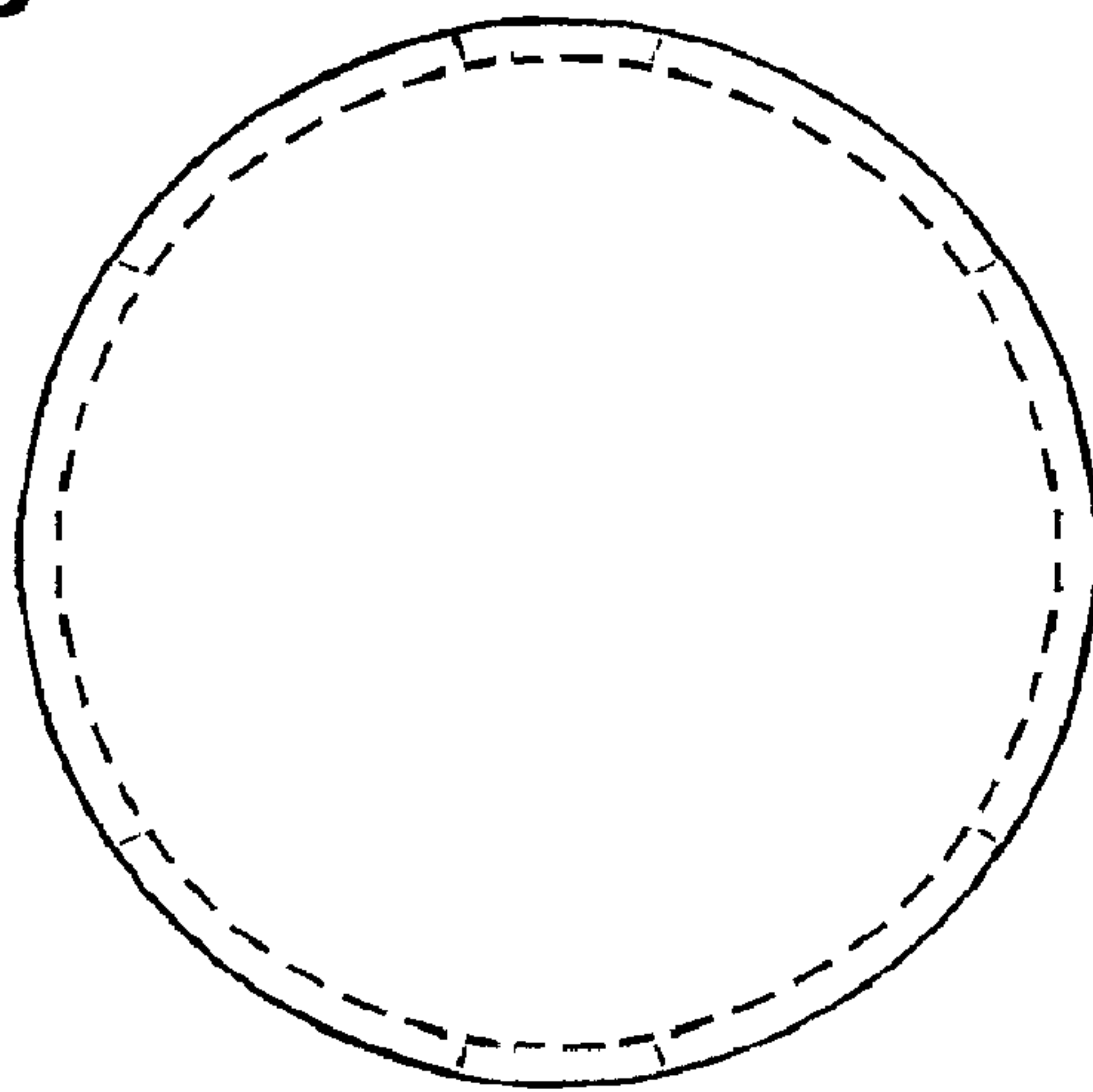
