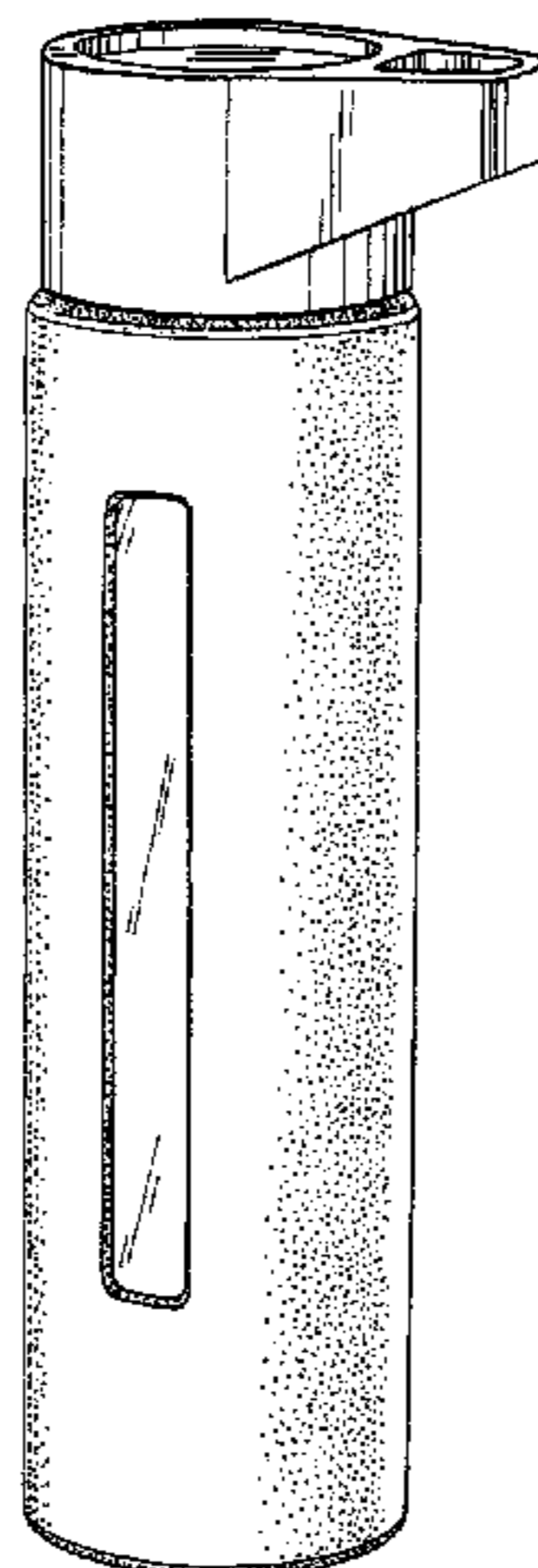
(57) **CLAIM**

FIG. 1 is a perspective view of a container with sleeve showing our new design;

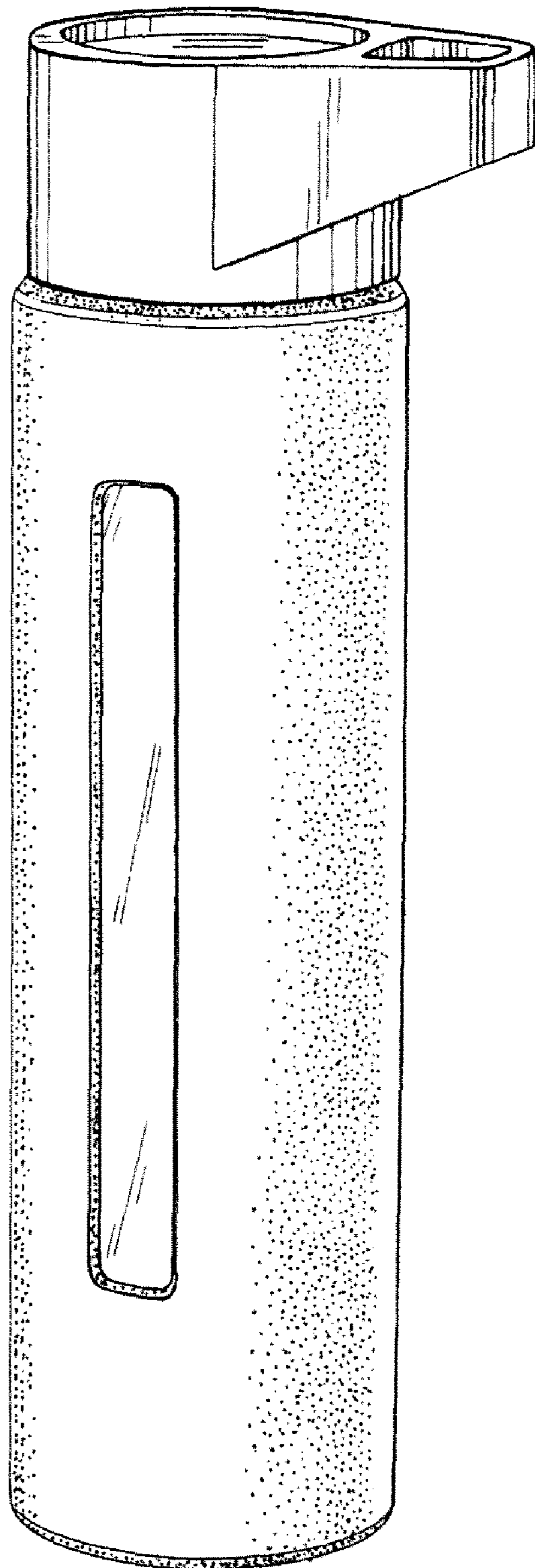

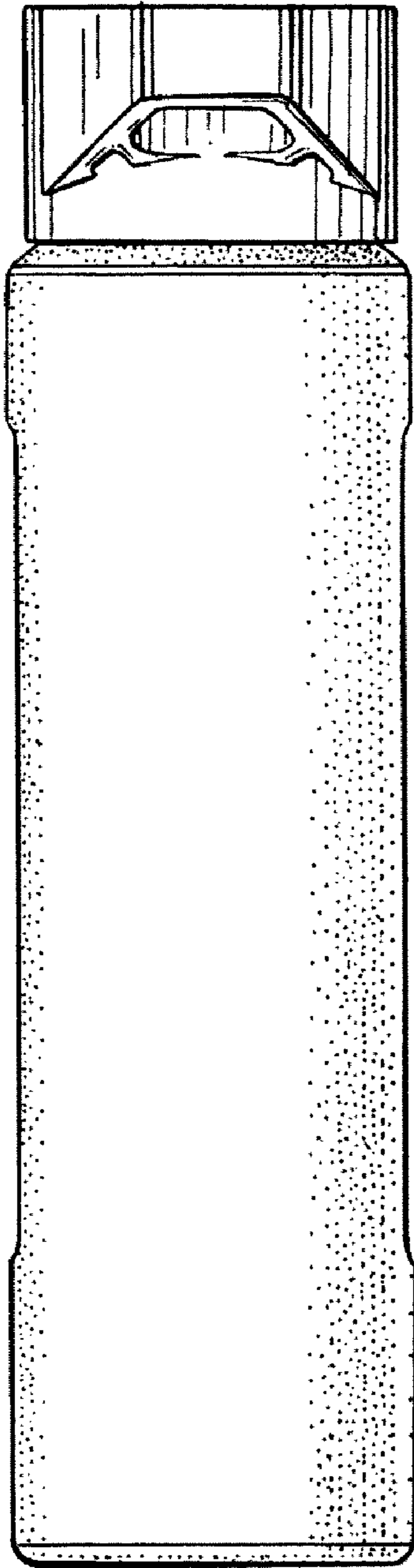

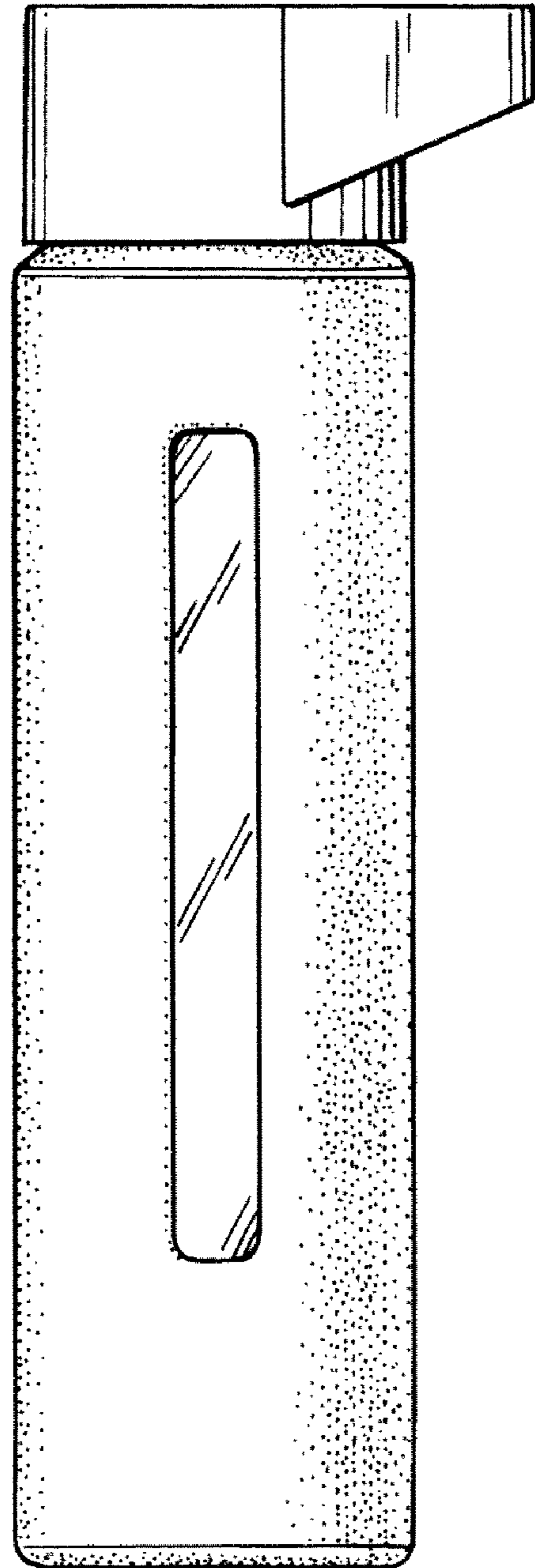

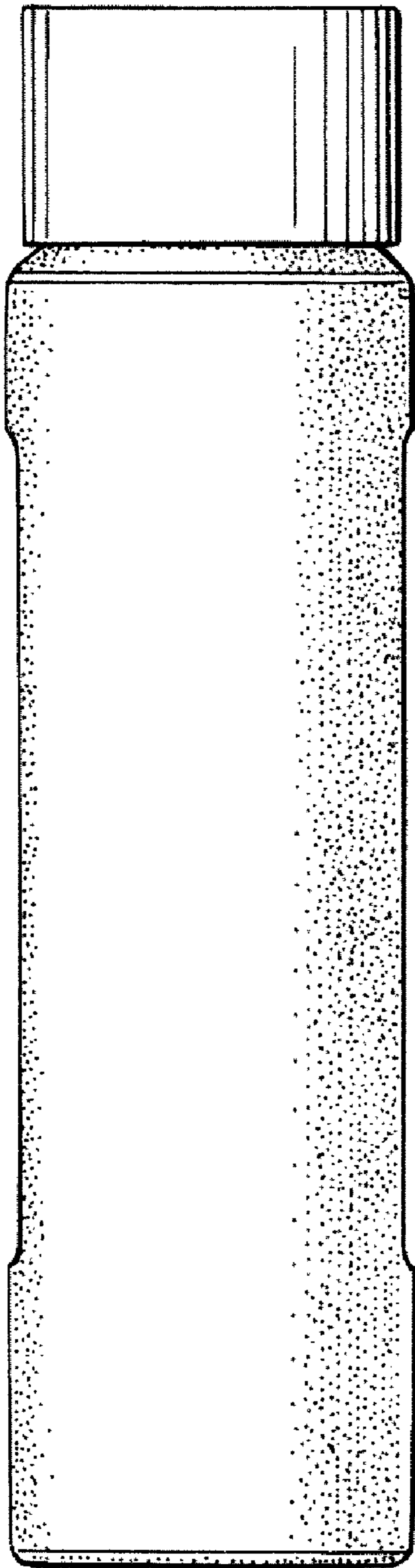

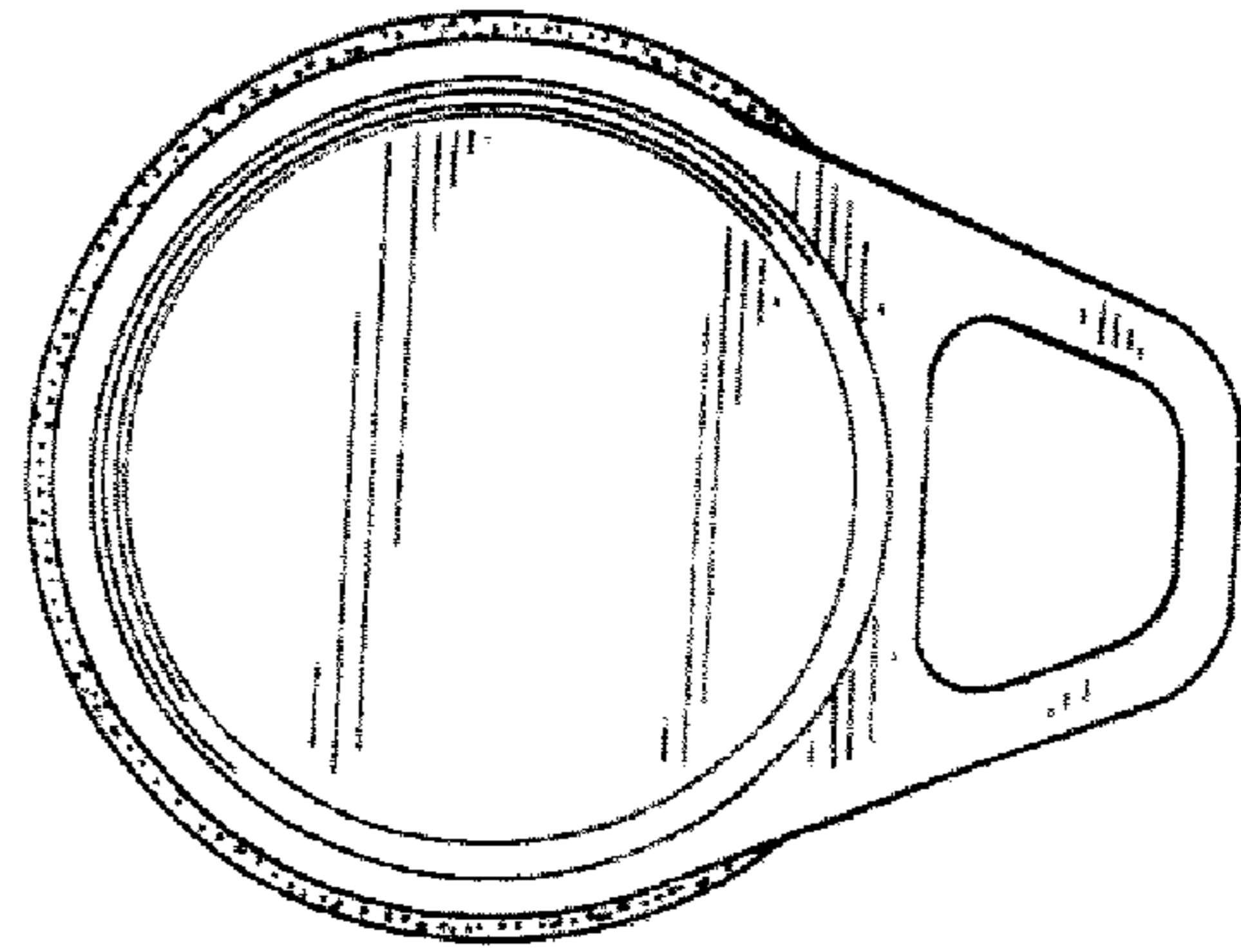

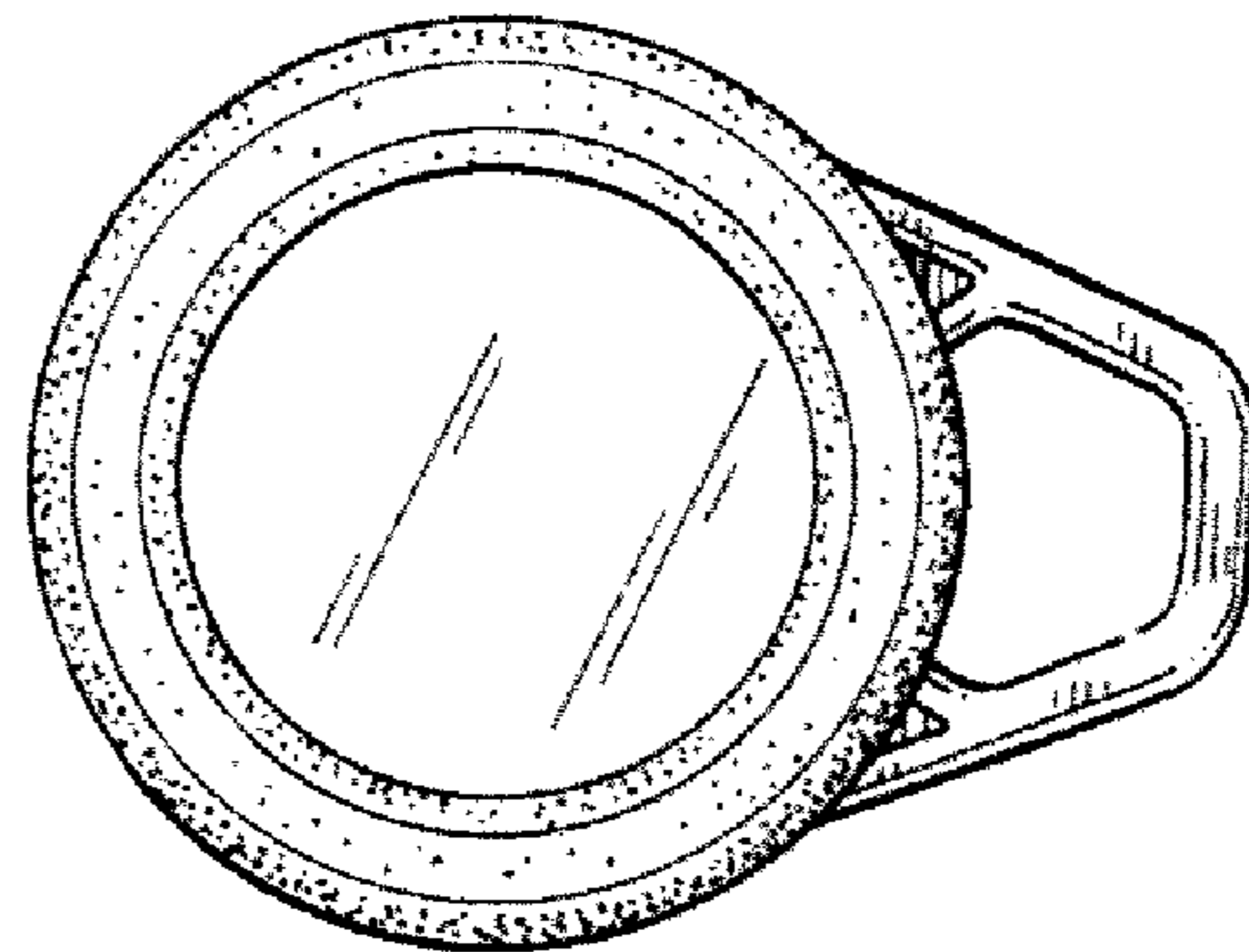
