DESCRIPTION

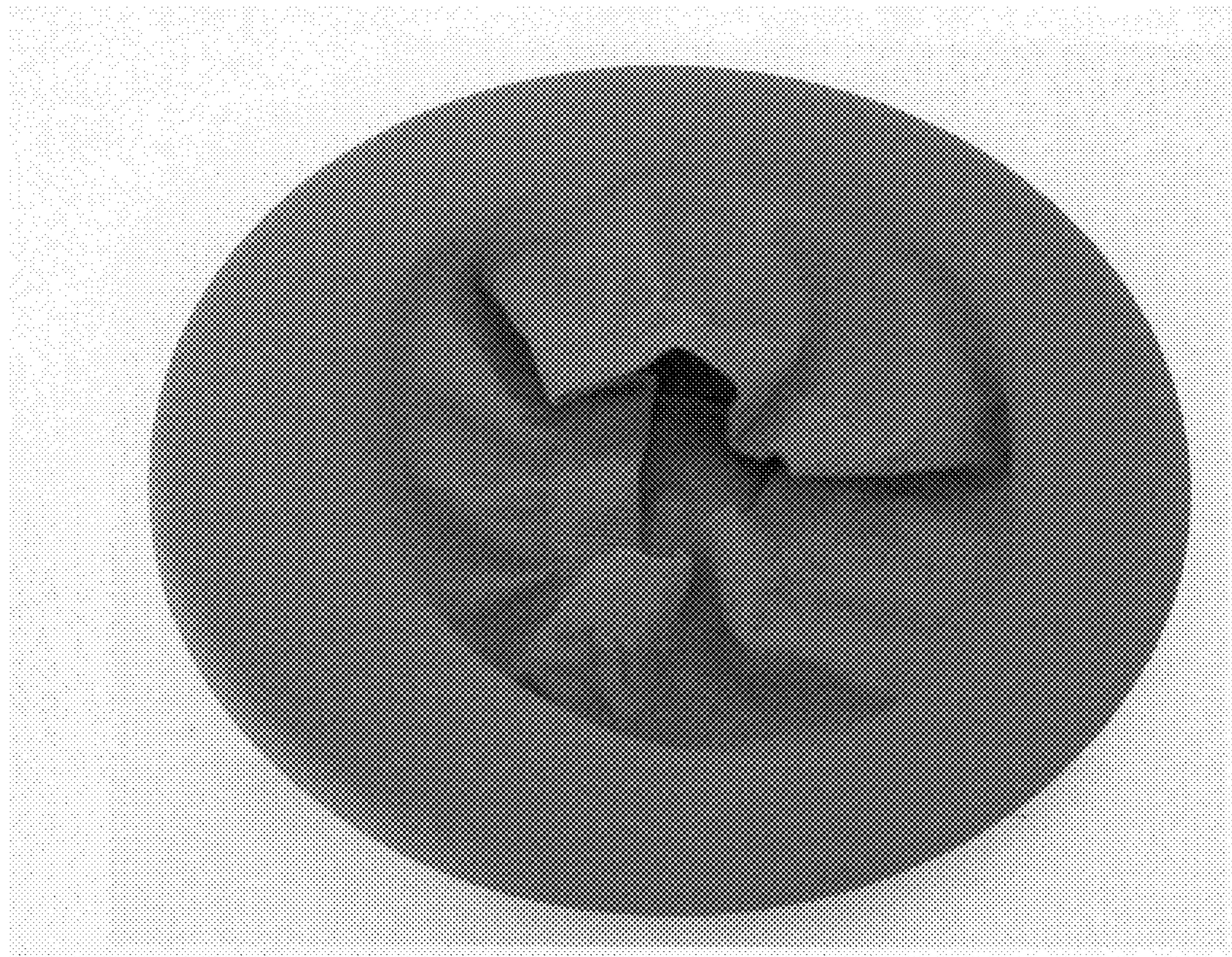
FIG. 1 is a perspective view of a package and container for the

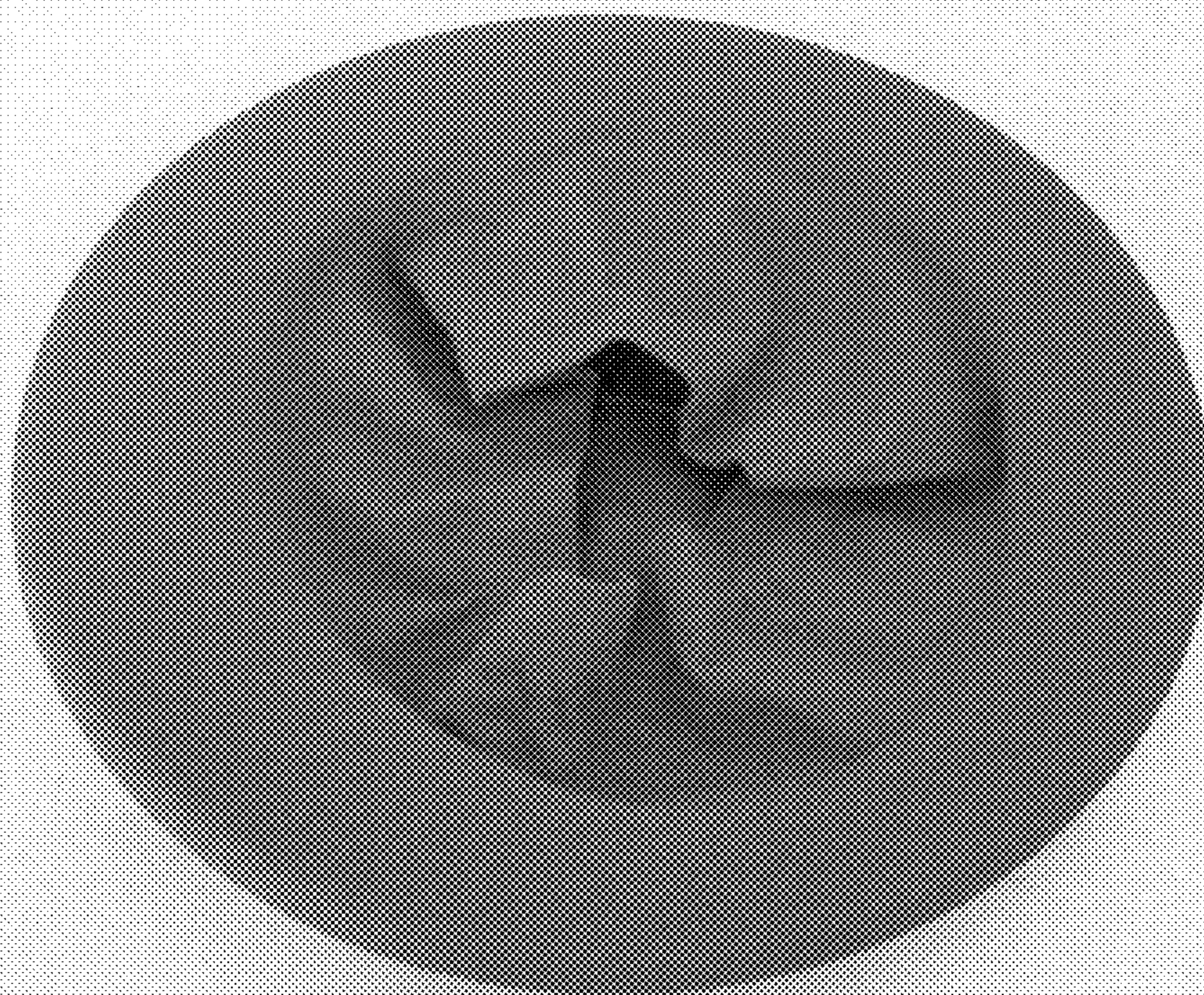

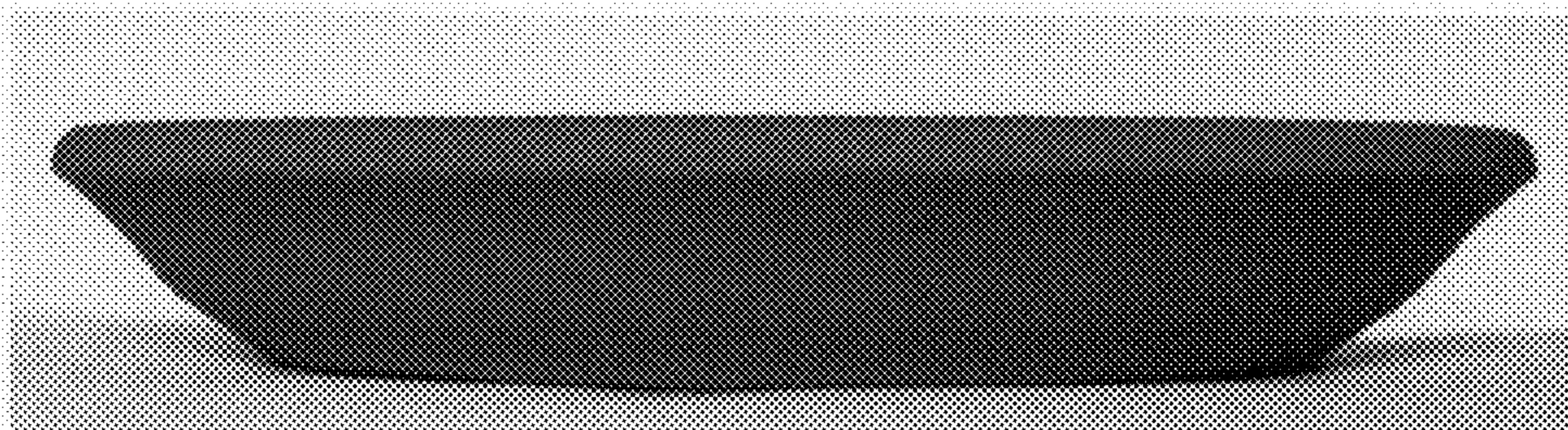

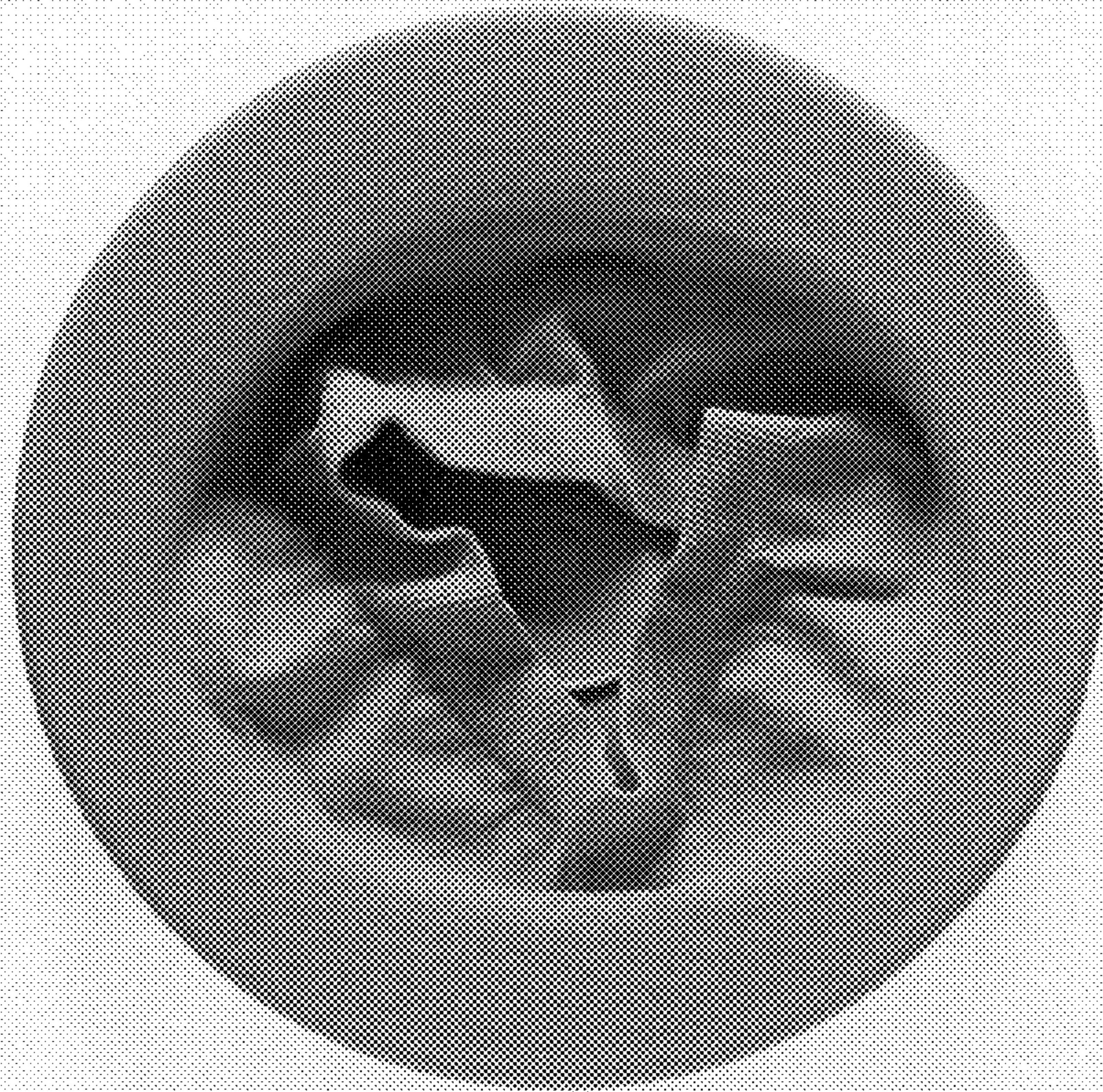
