FIG. 7 is a rear view of the measuring container shown in FIG. 1.

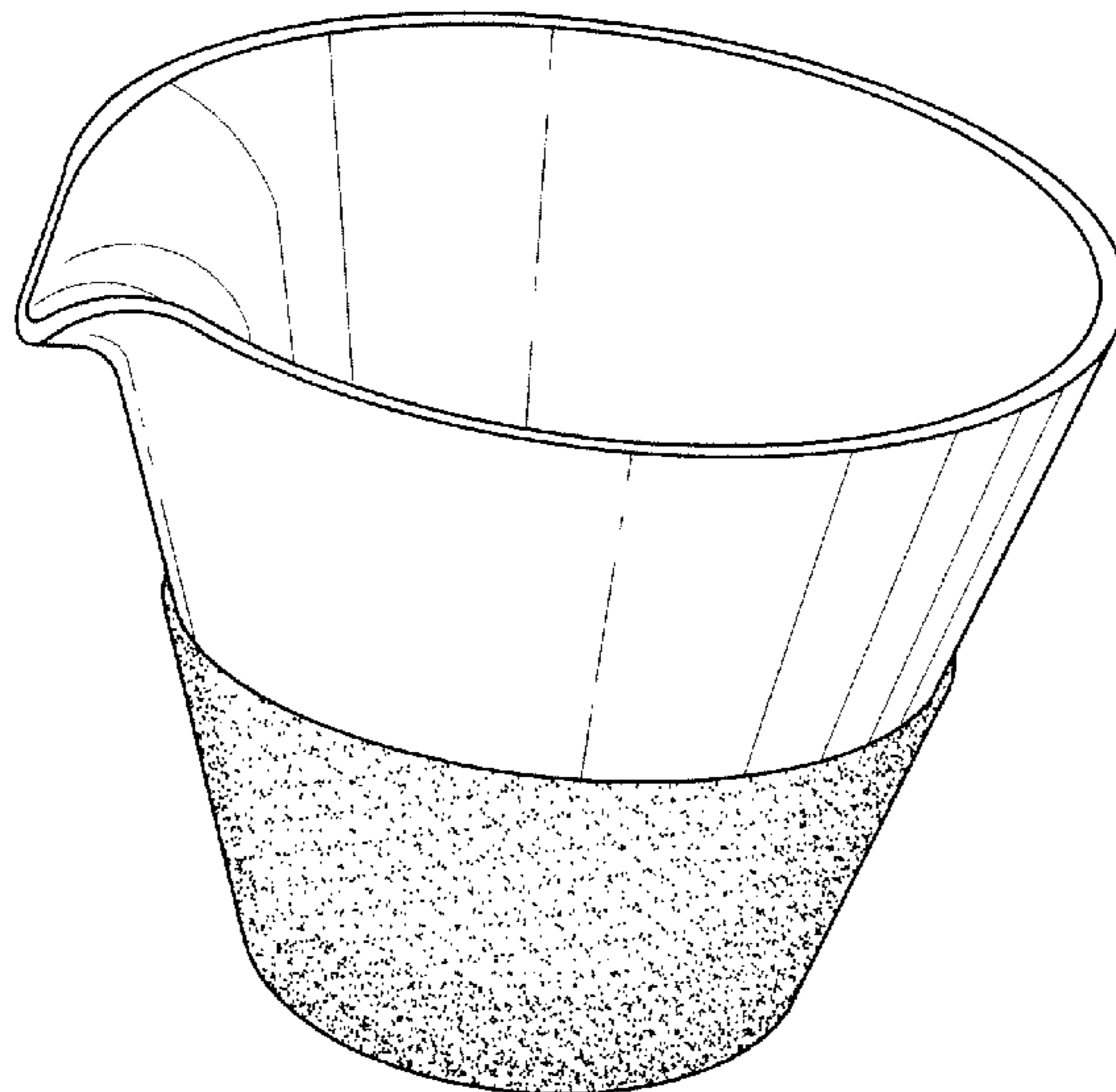

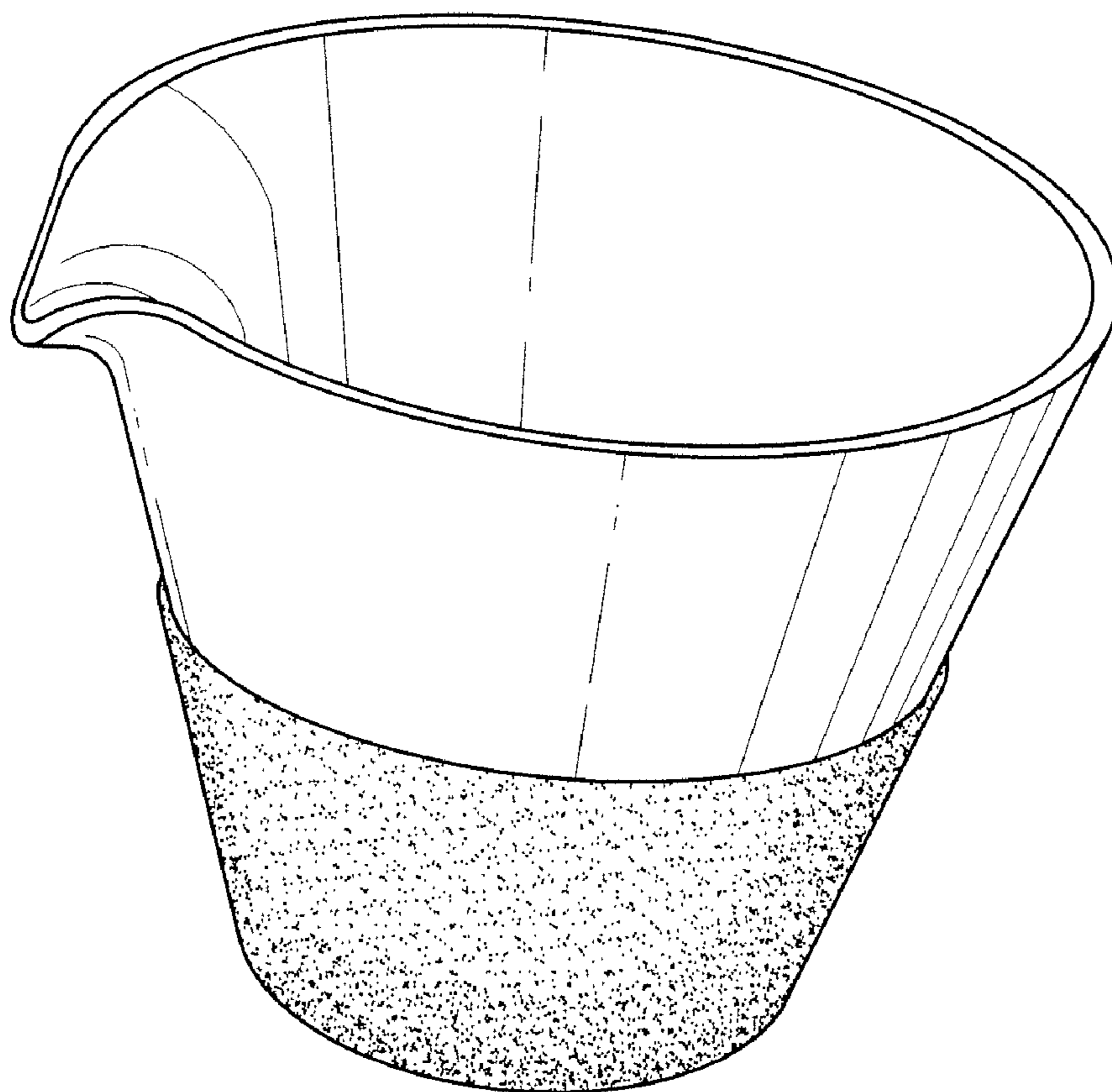

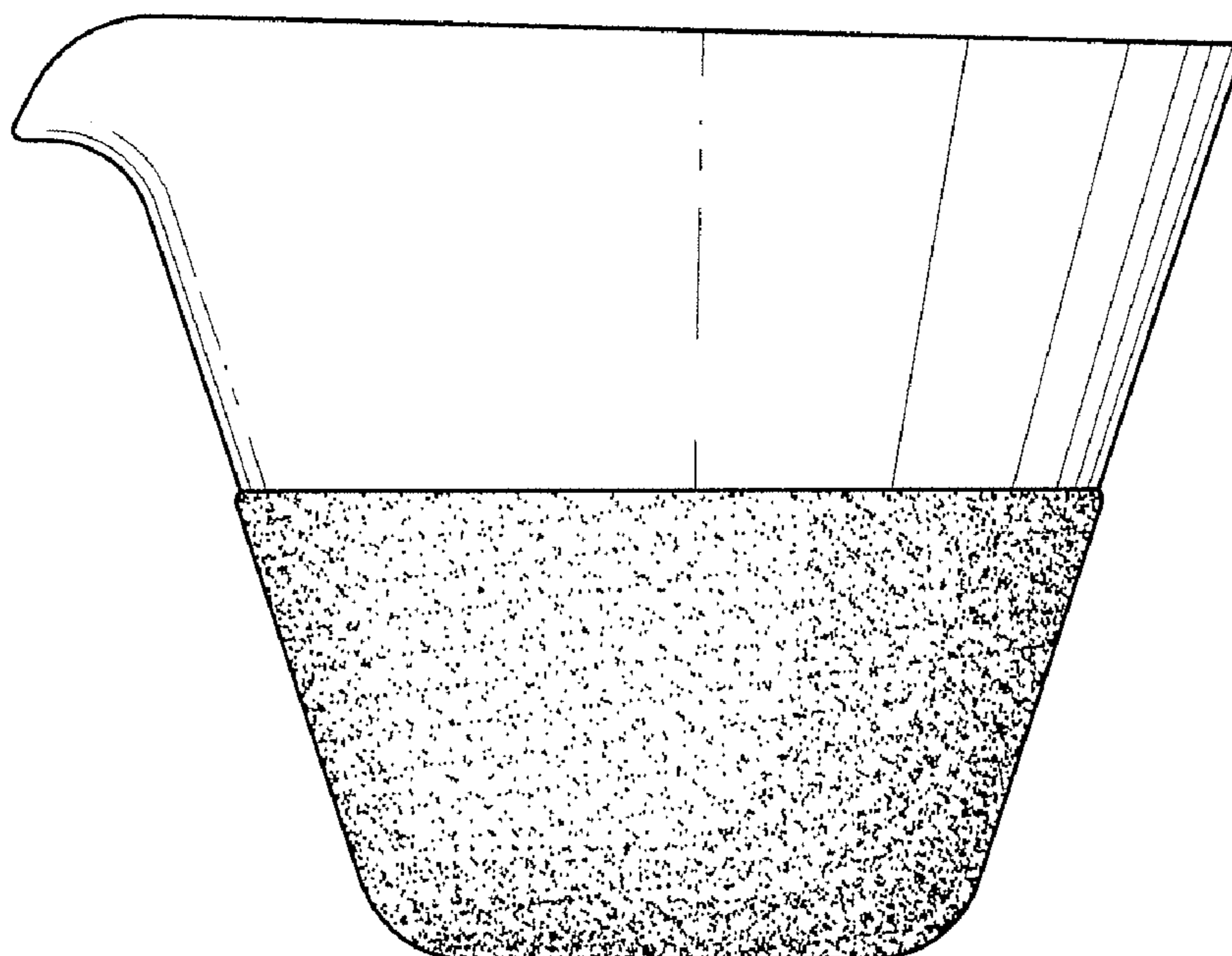

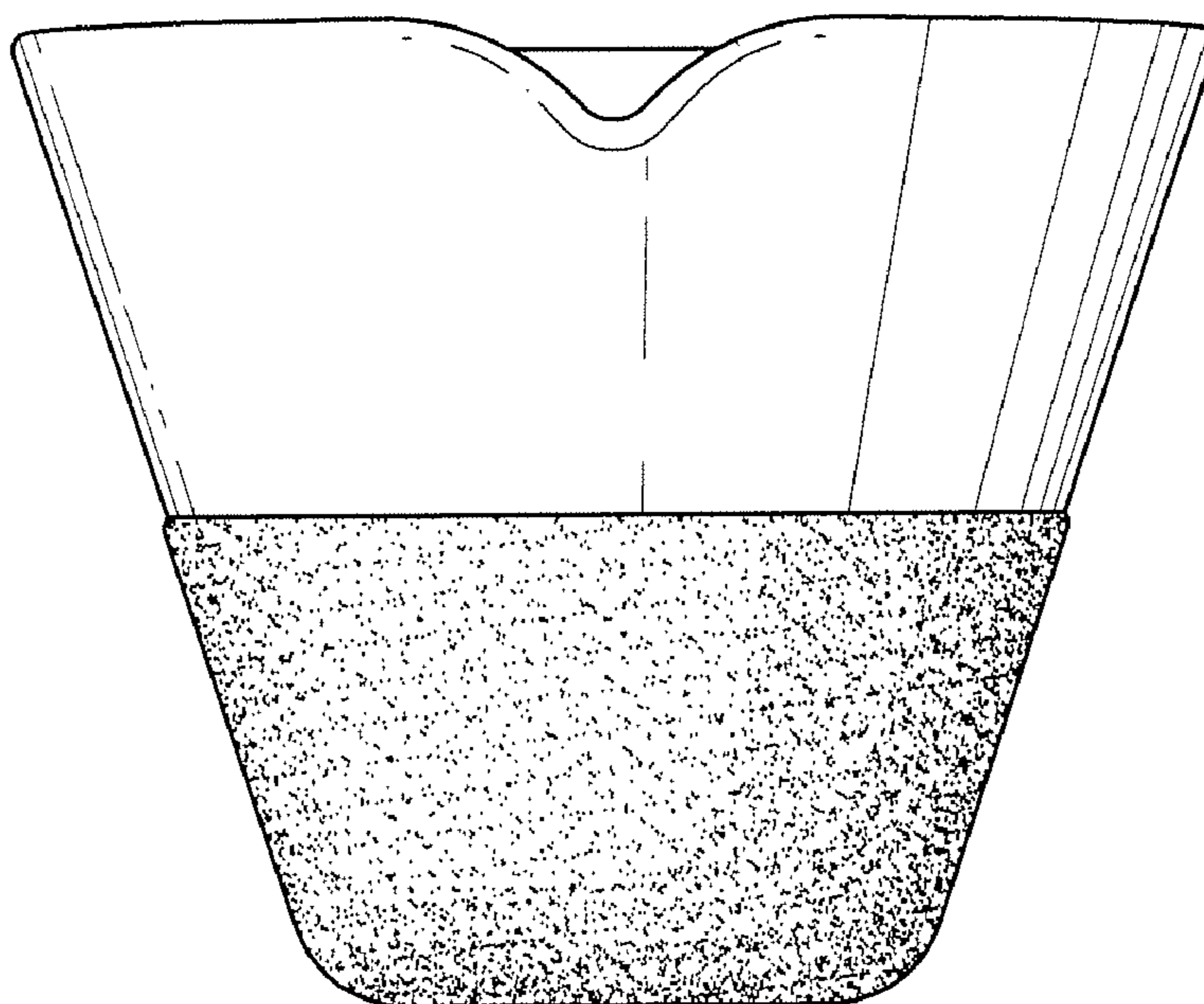

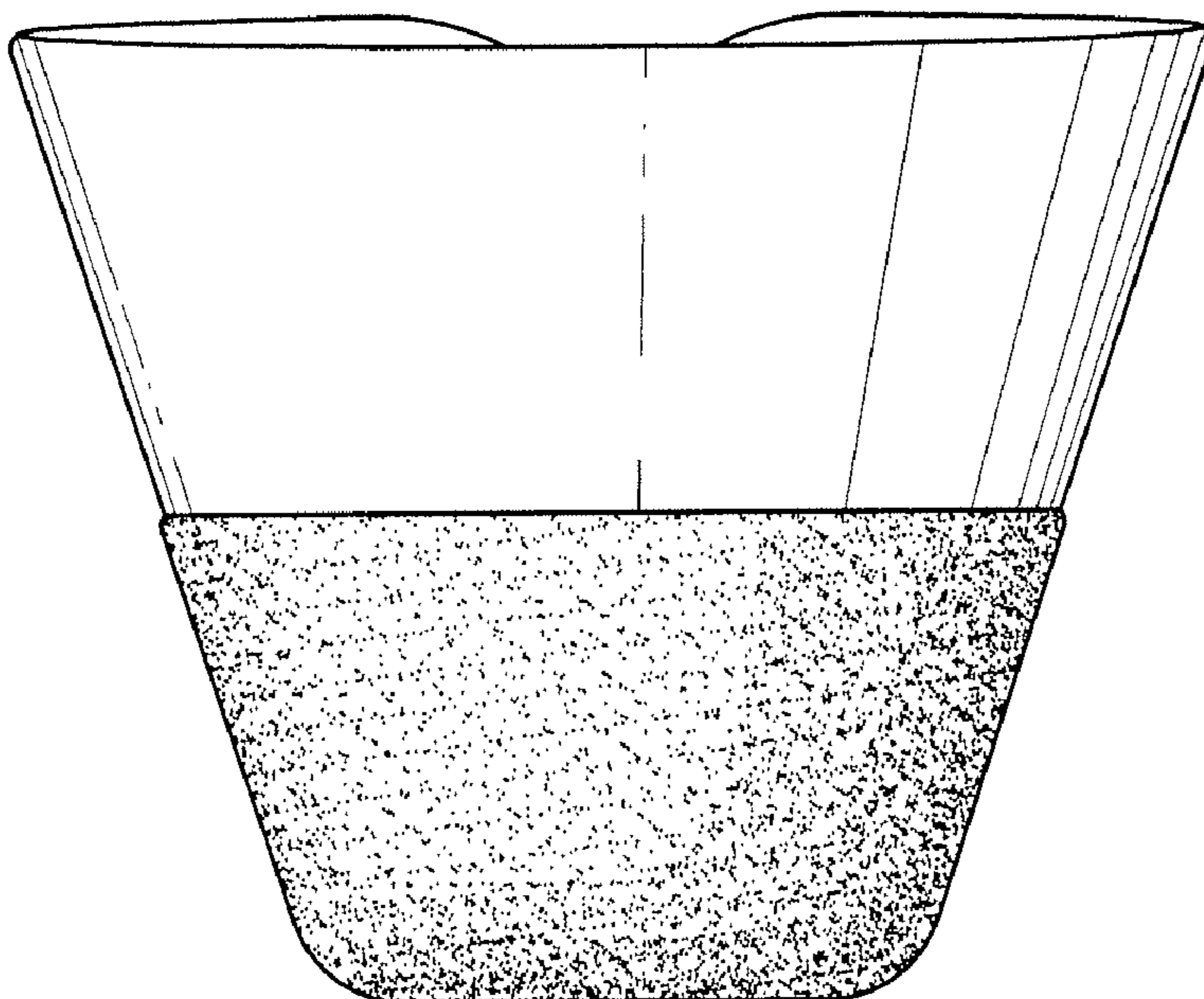

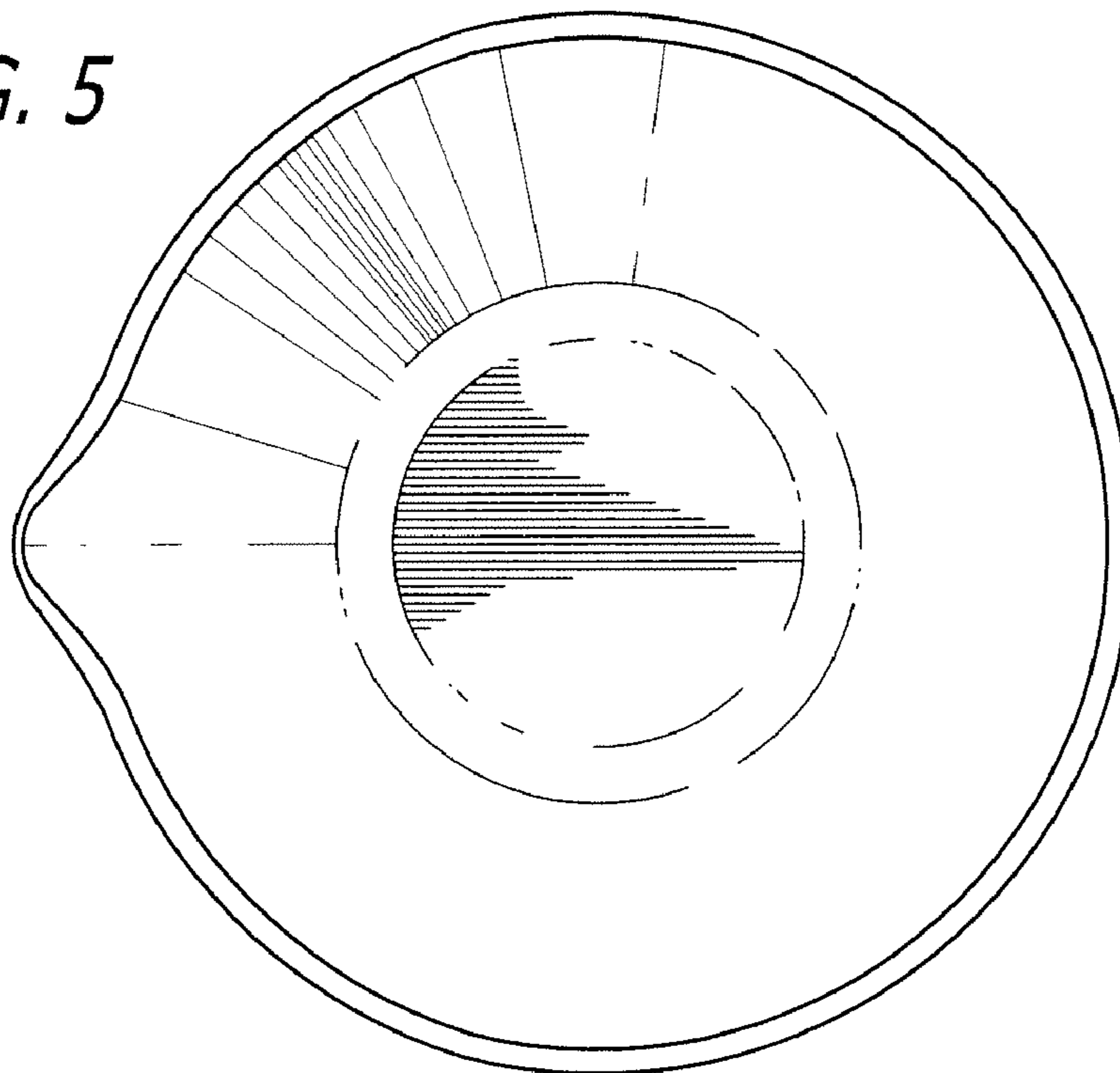

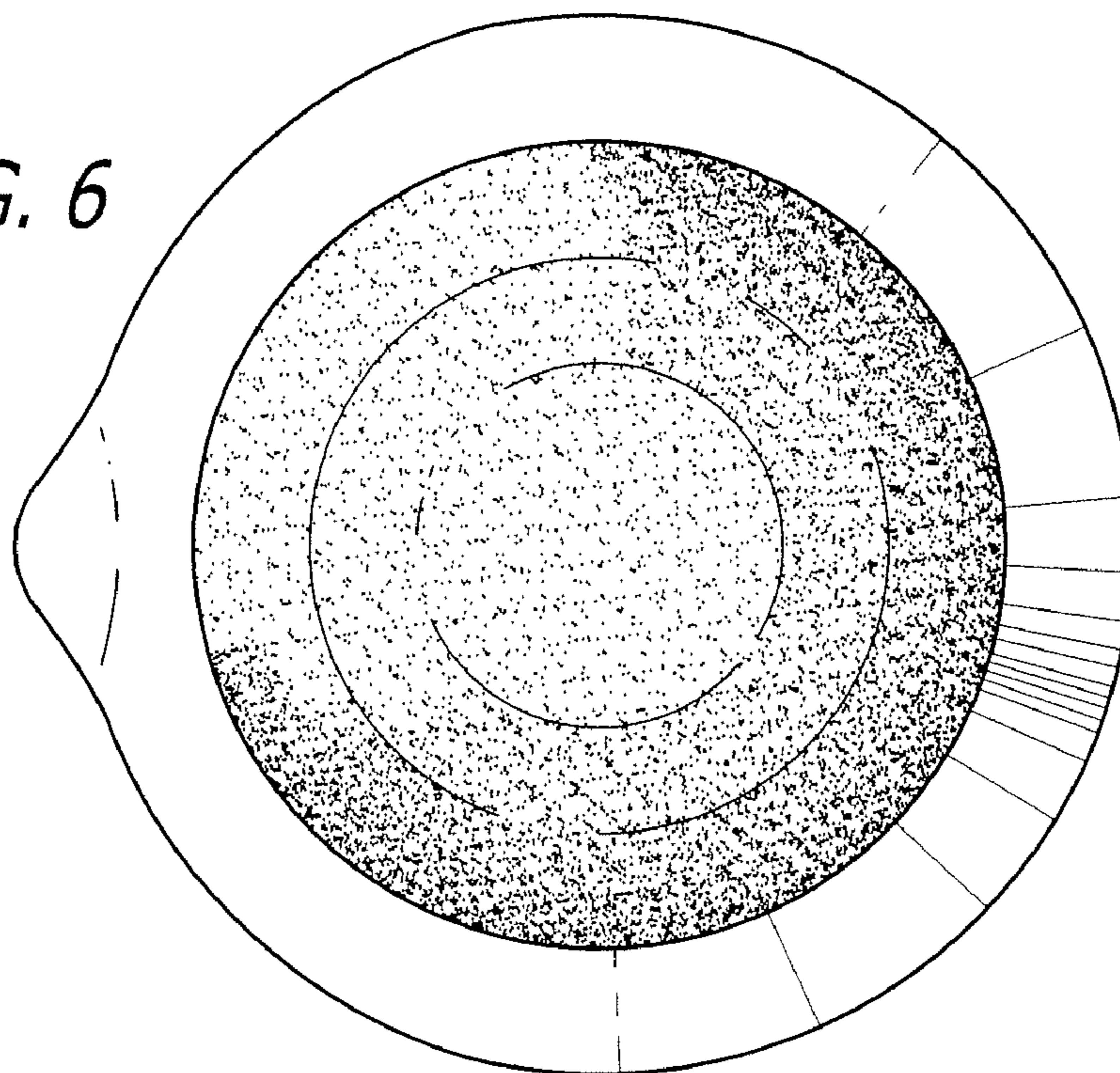
