(57) **CLAIM**

The ornamental design for a stencil for children, as shown and described.

**DESCRIPTION**

The sole FIGURE is a top plan view of the stencil for children. The bottom plan view is a mirror image of the top plan view. The front, rear, left and right side views are flat lines as the stencil has minimum thickness.
