FIG. 3 is a rear left perspective view thereof.

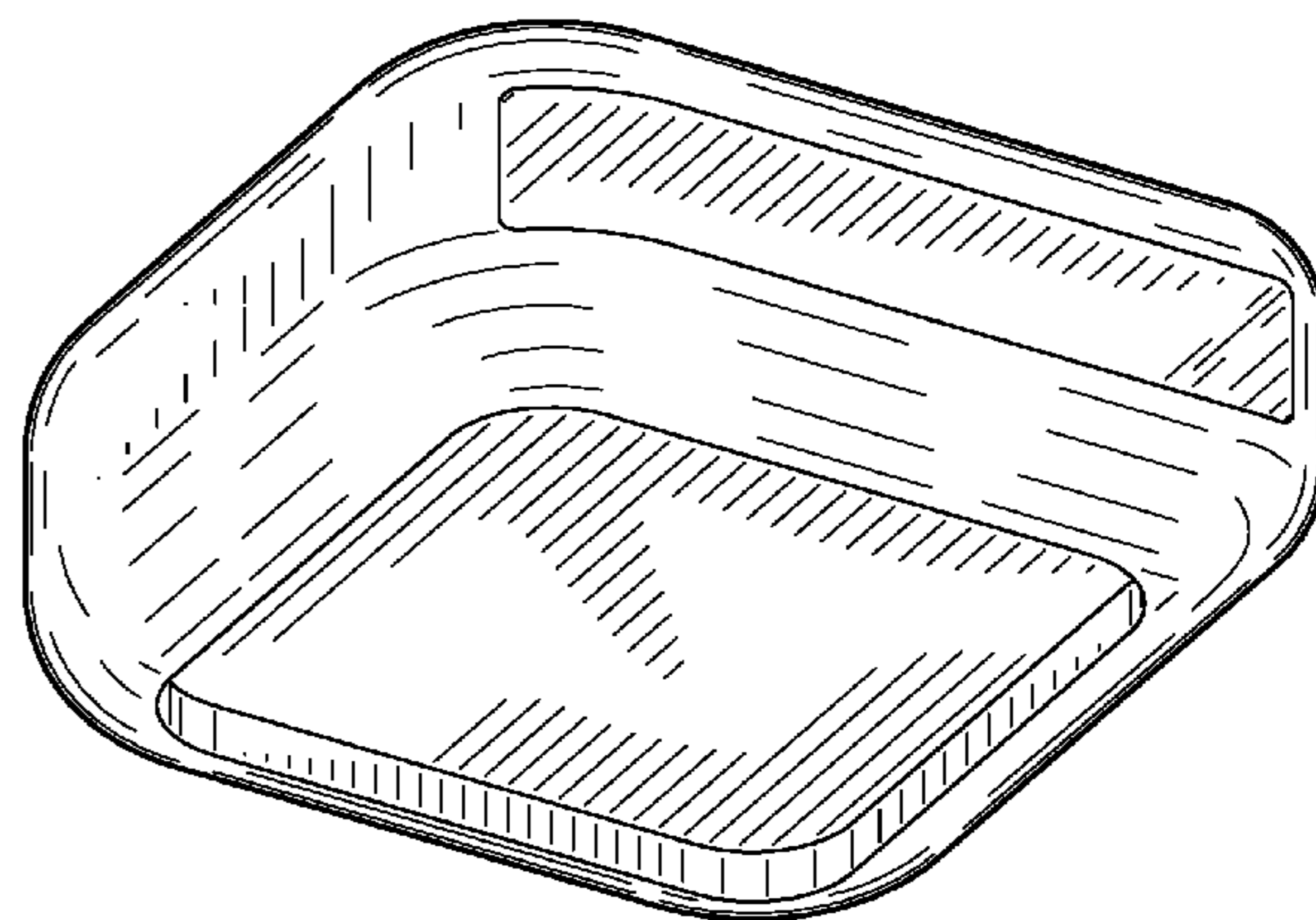
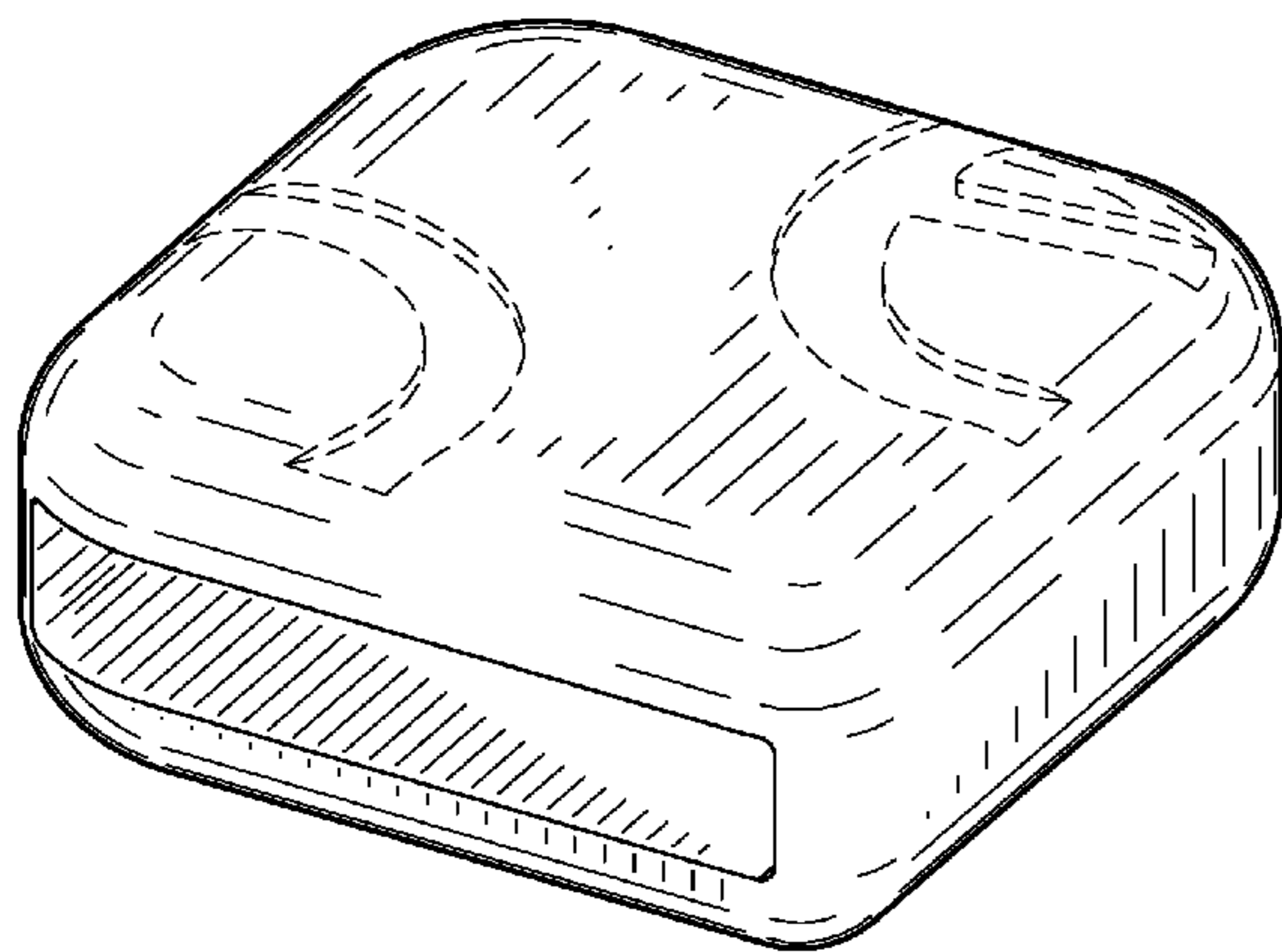
FIG. 4 is a left side elevational view thereof.

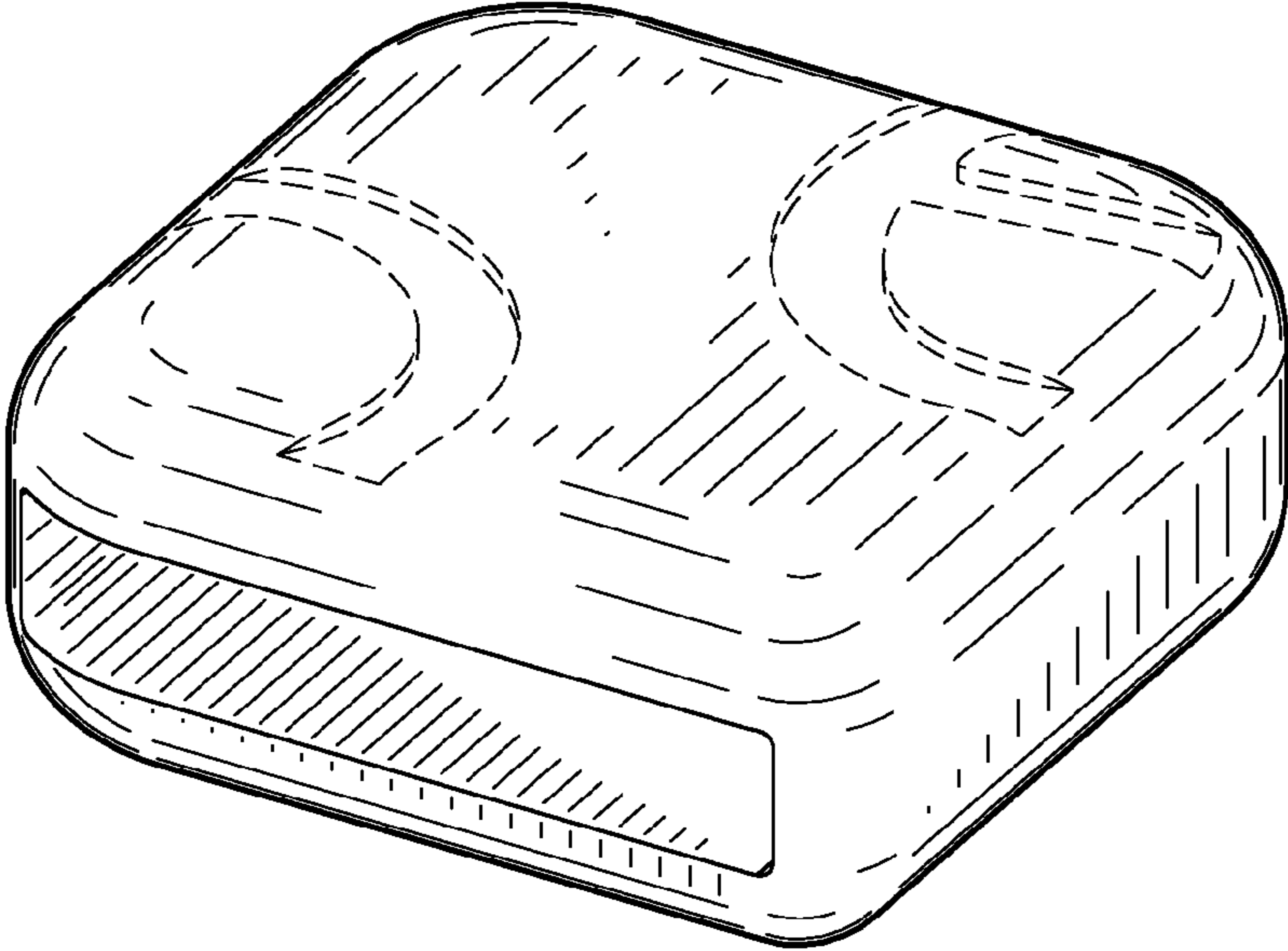

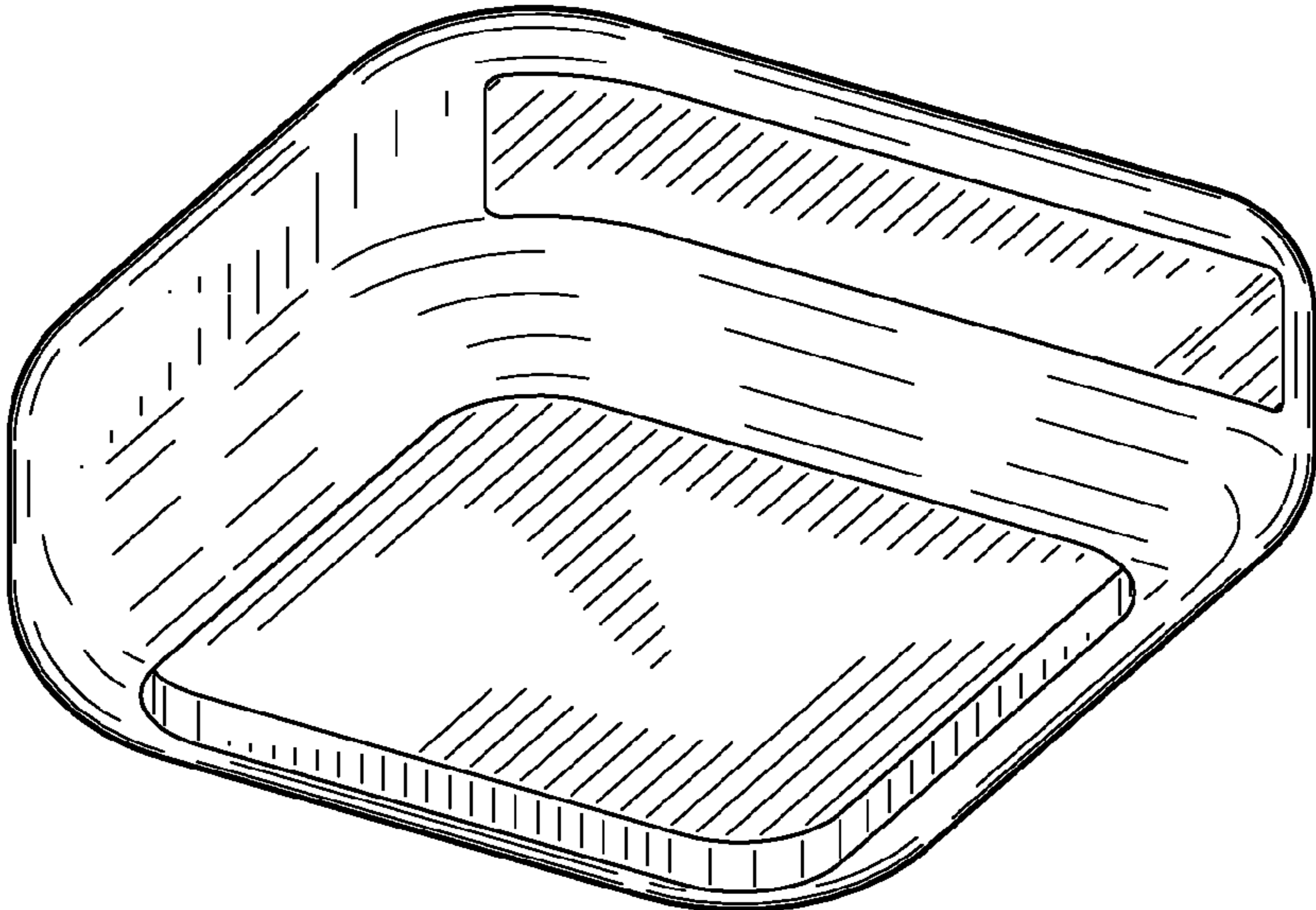

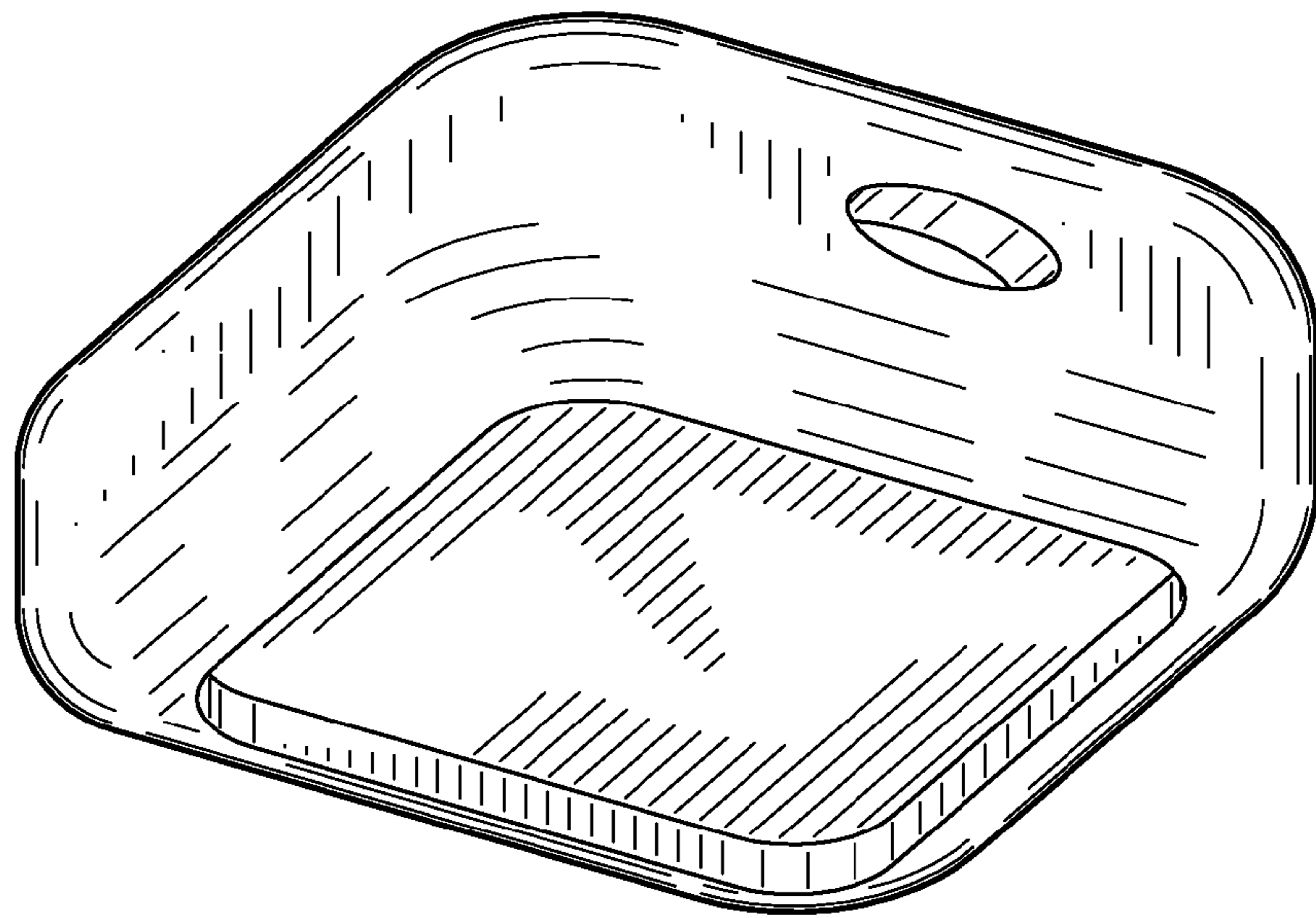

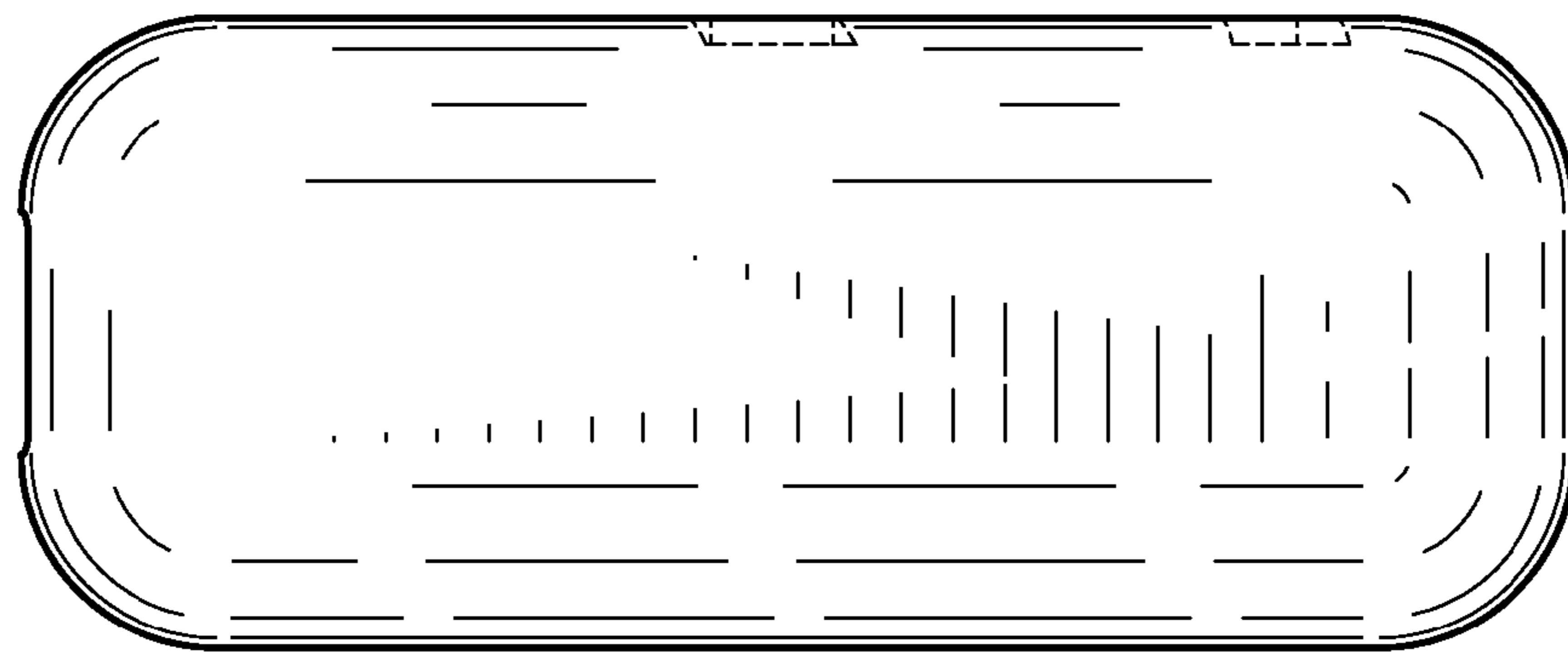

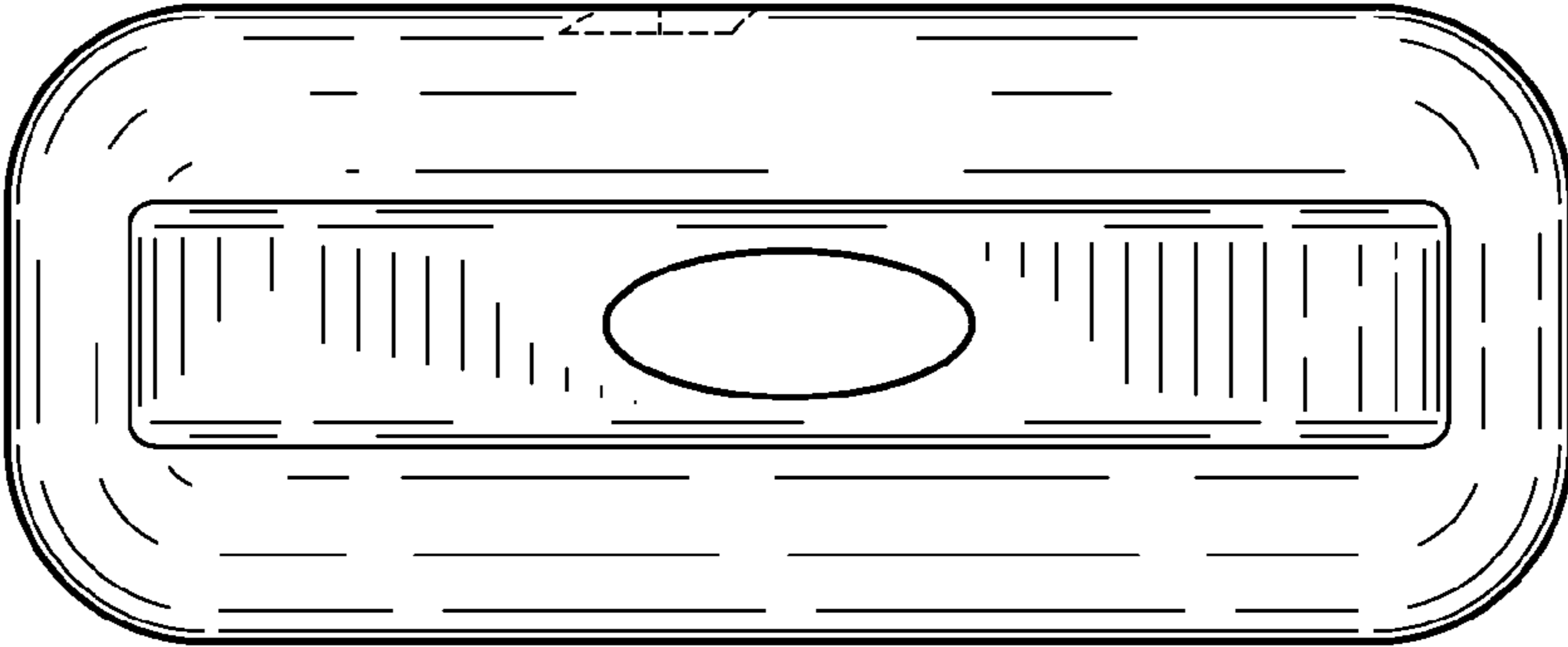

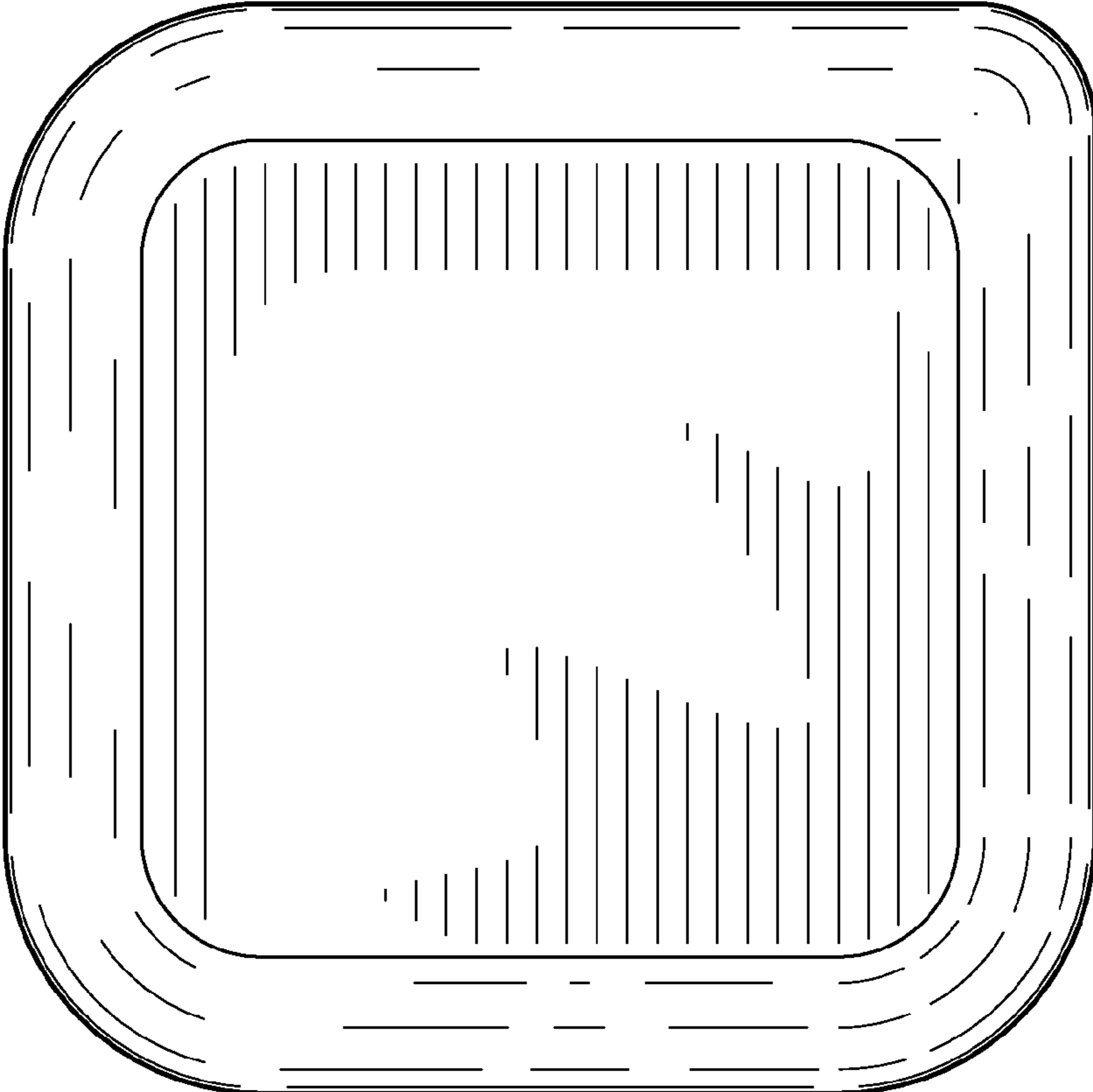
