(57) **CLAIM**

We claim the ornamental design for condom, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, perspective view of a condom in an inflated state, showing our new design;

FIG. 2 is a side elevational view thereof, the opposite side elevational view being identical thereto;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a side elevational view of FIG. 1 in an un-inflated state, the opposite side elevational view being identical thereto;

FIG. 6 is a top plan view thereof; and,

FIG. 7 is a bottom plan view thereof.

The broken lines showing in FIGS. 4 and 7 are for environmental purposes only and form no part of the claimed design.

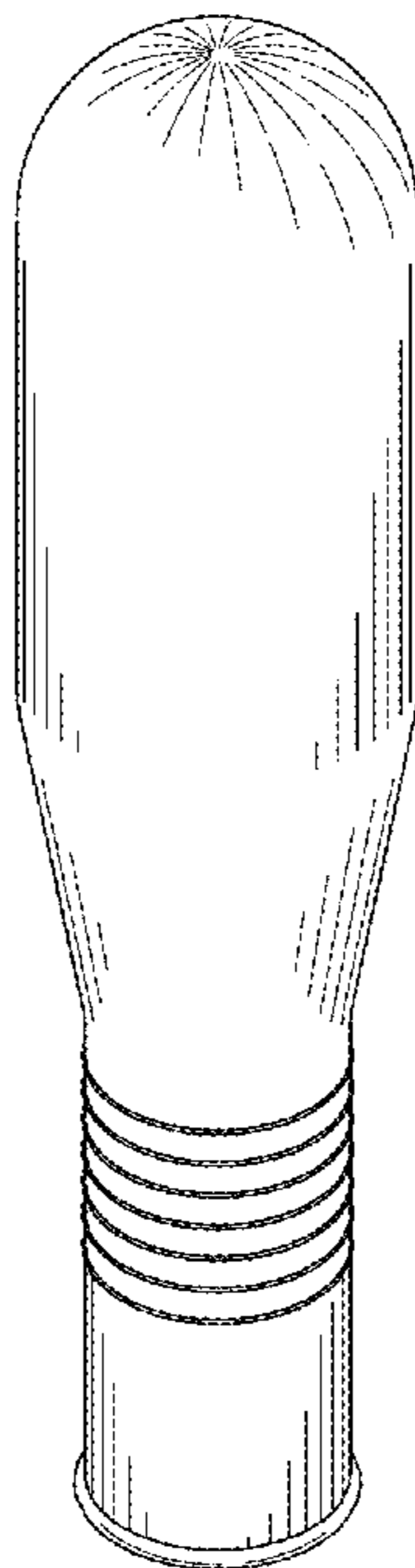

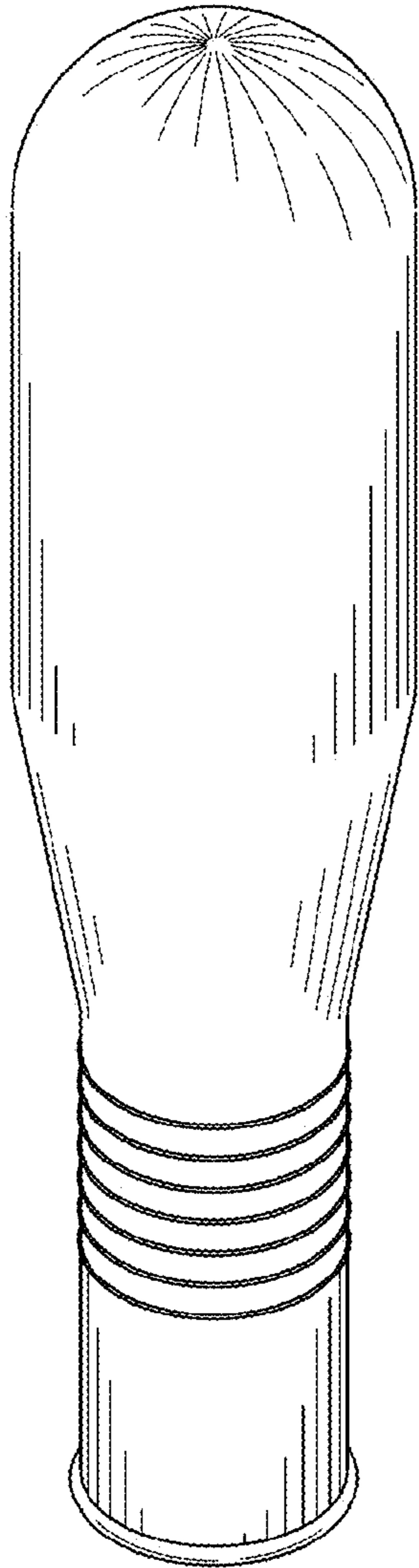

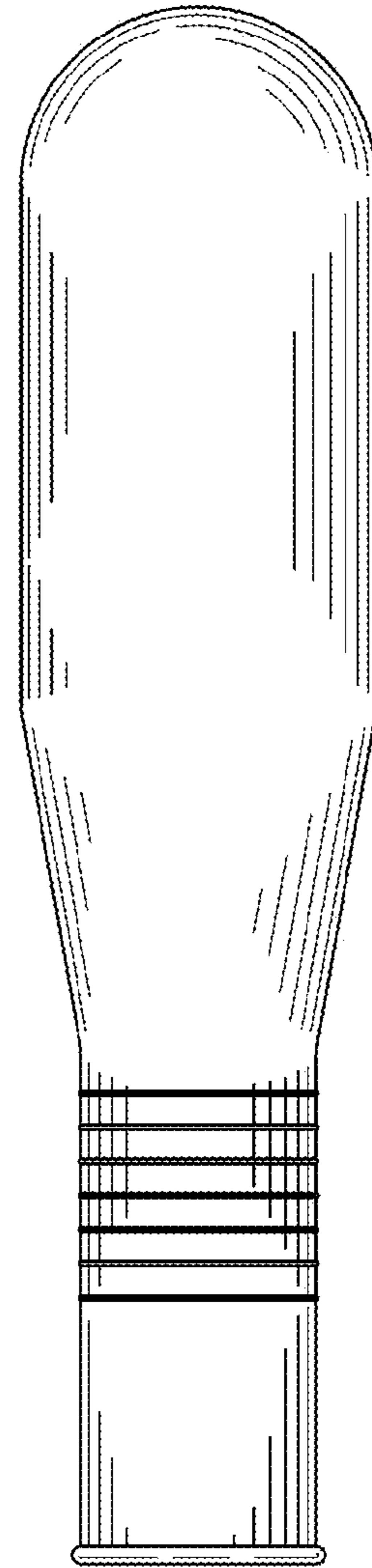

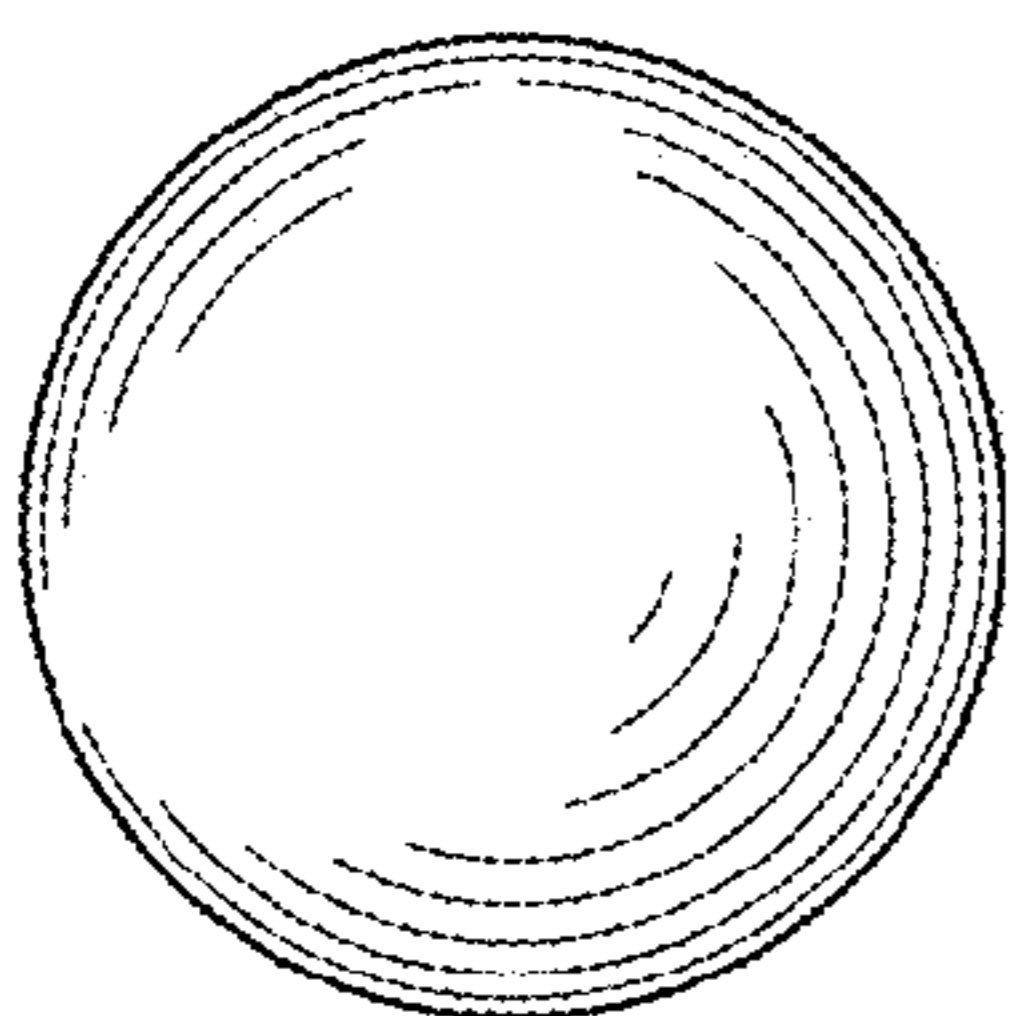

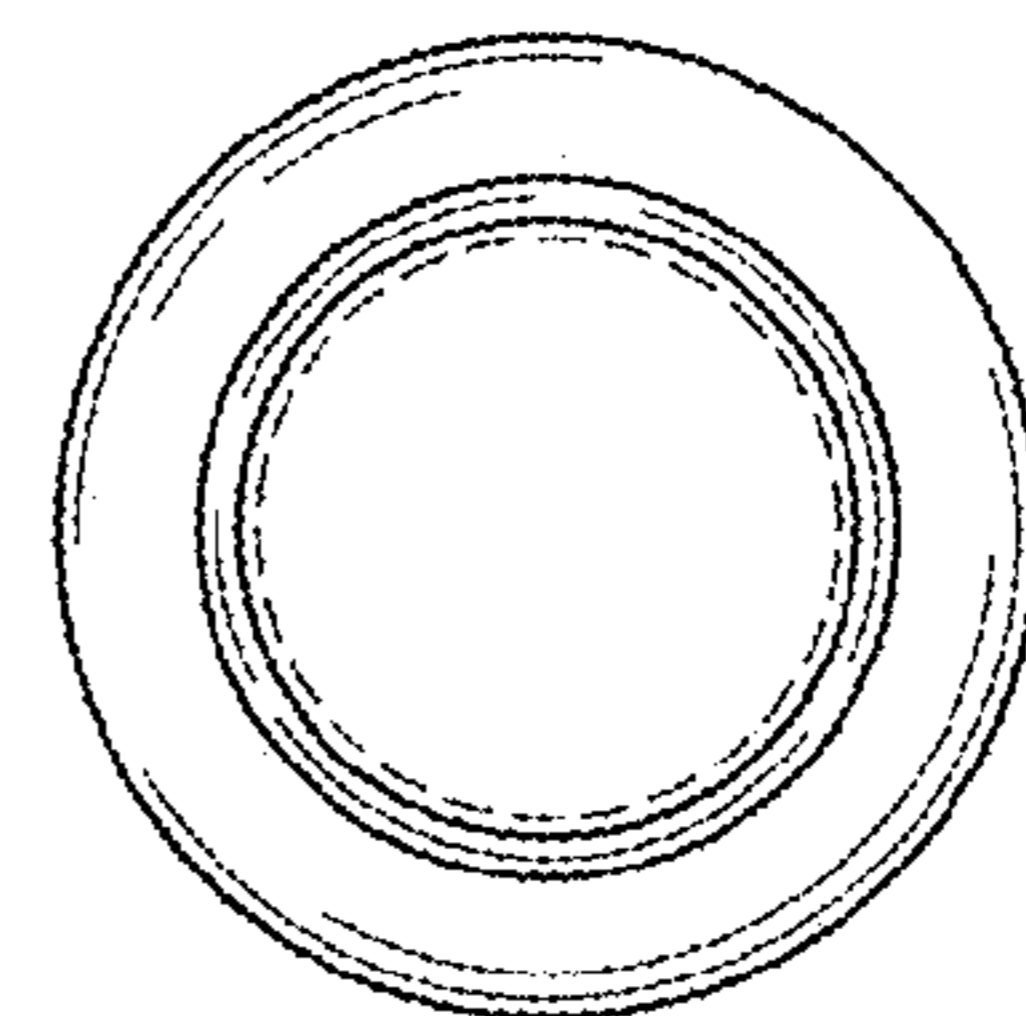

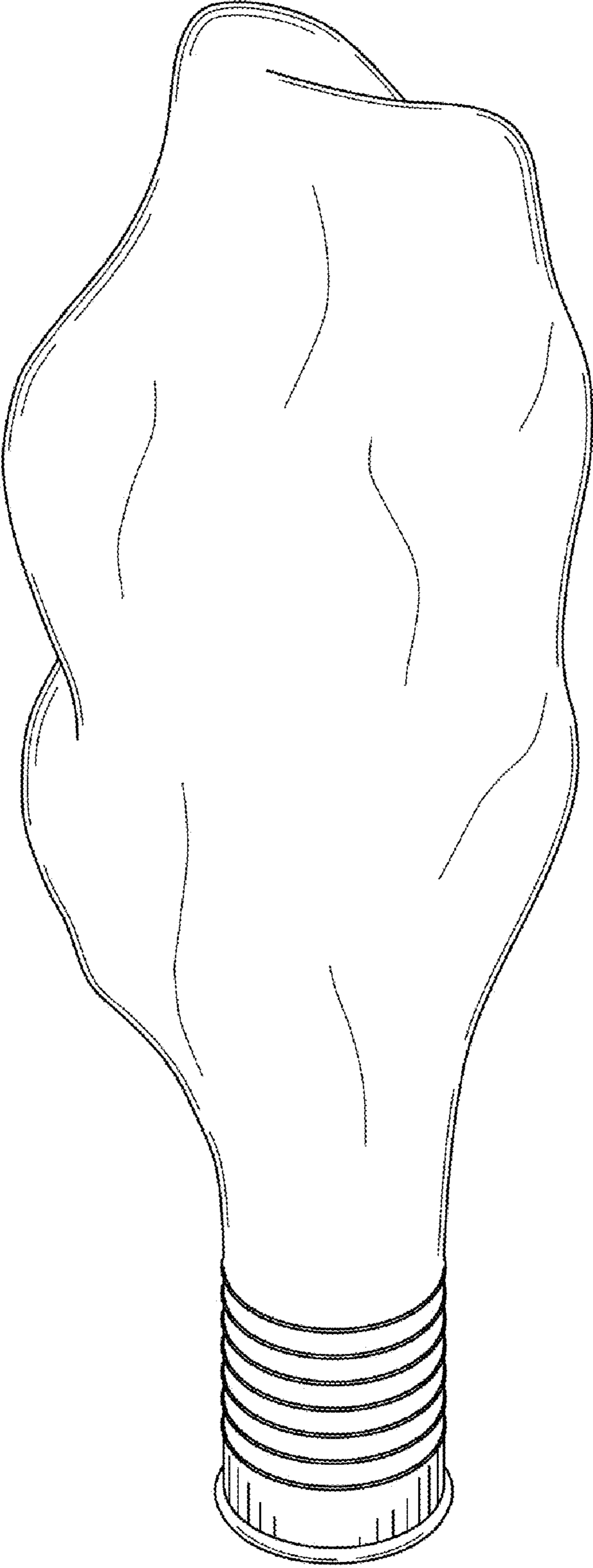

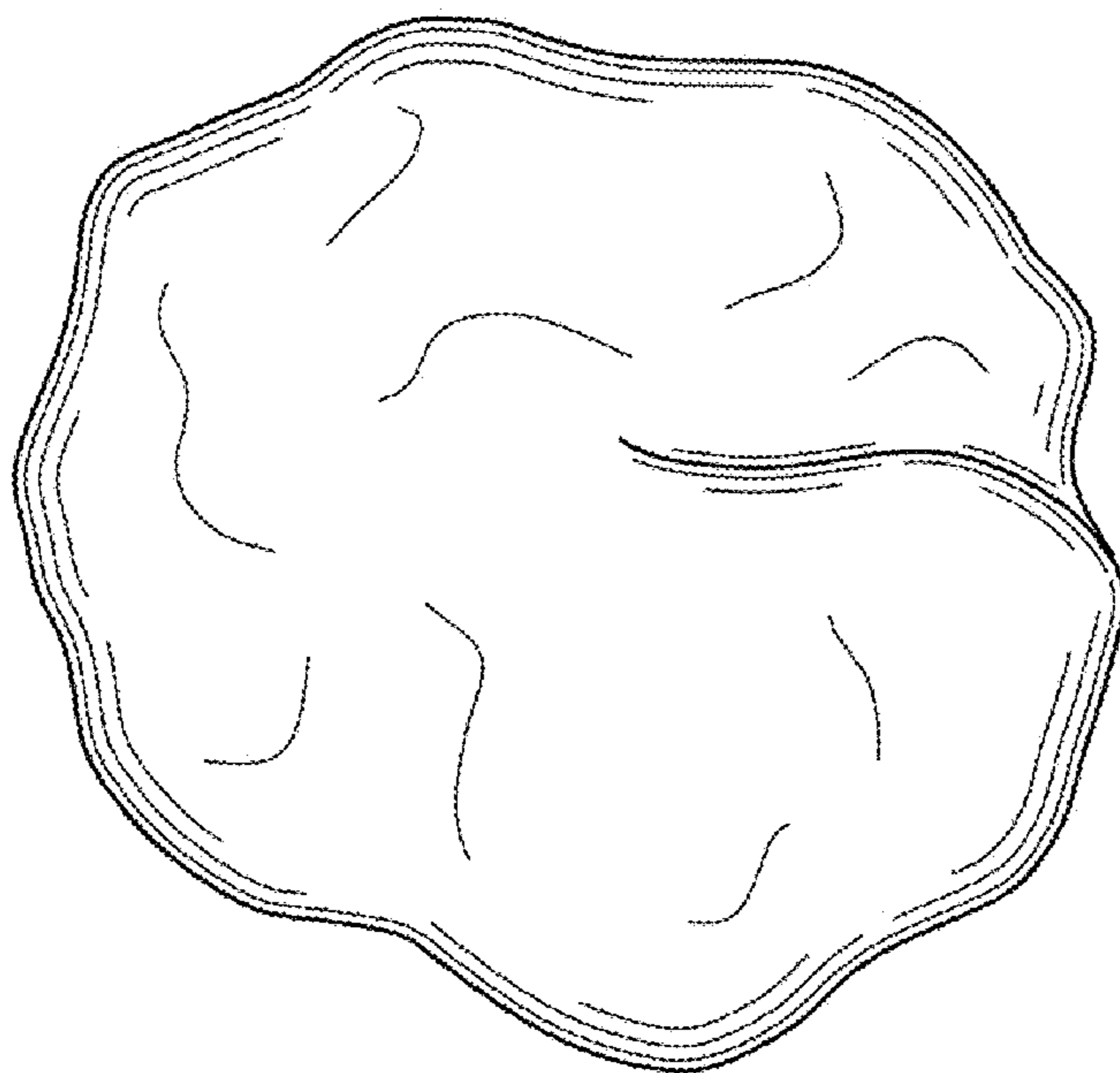
