FIG. 1 is a front isometric view of a medical implant or medical prosthesis in accordance with the new design;

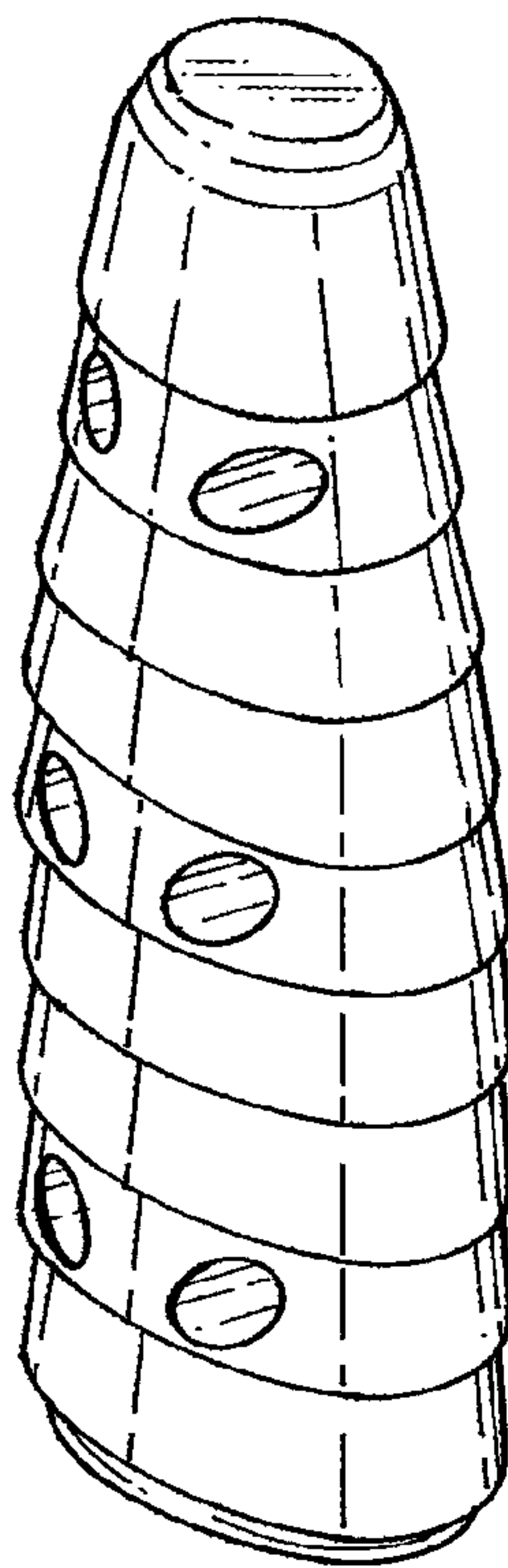
FIG. 2 is a front and rear view thereof;

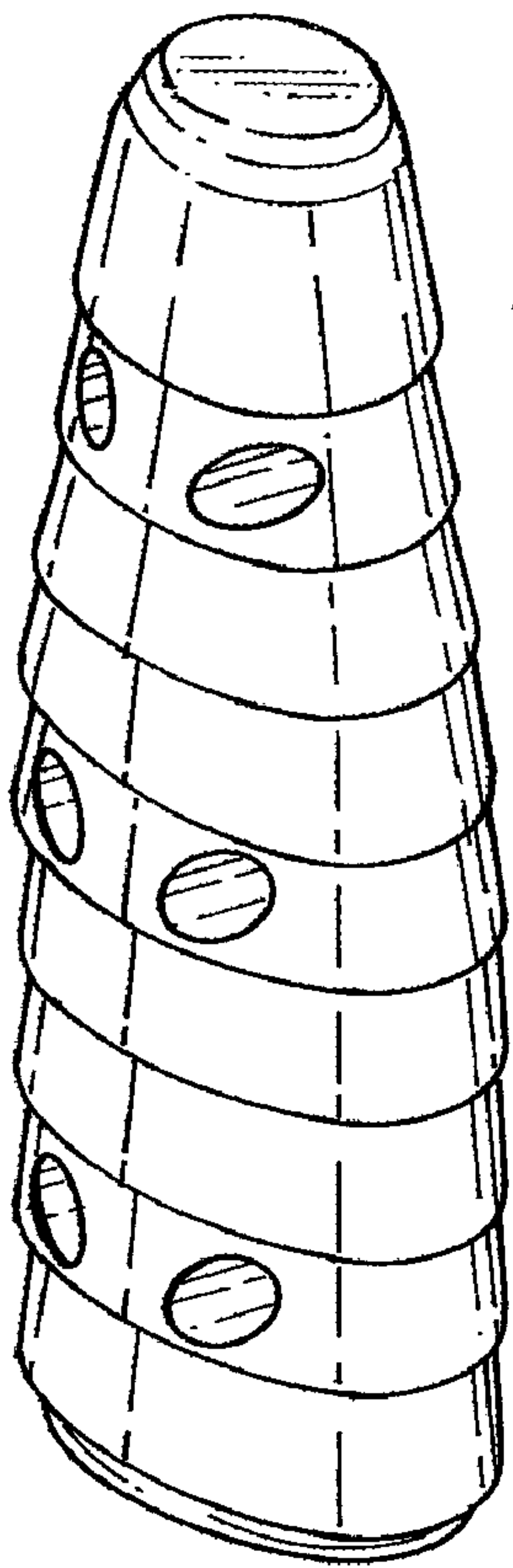

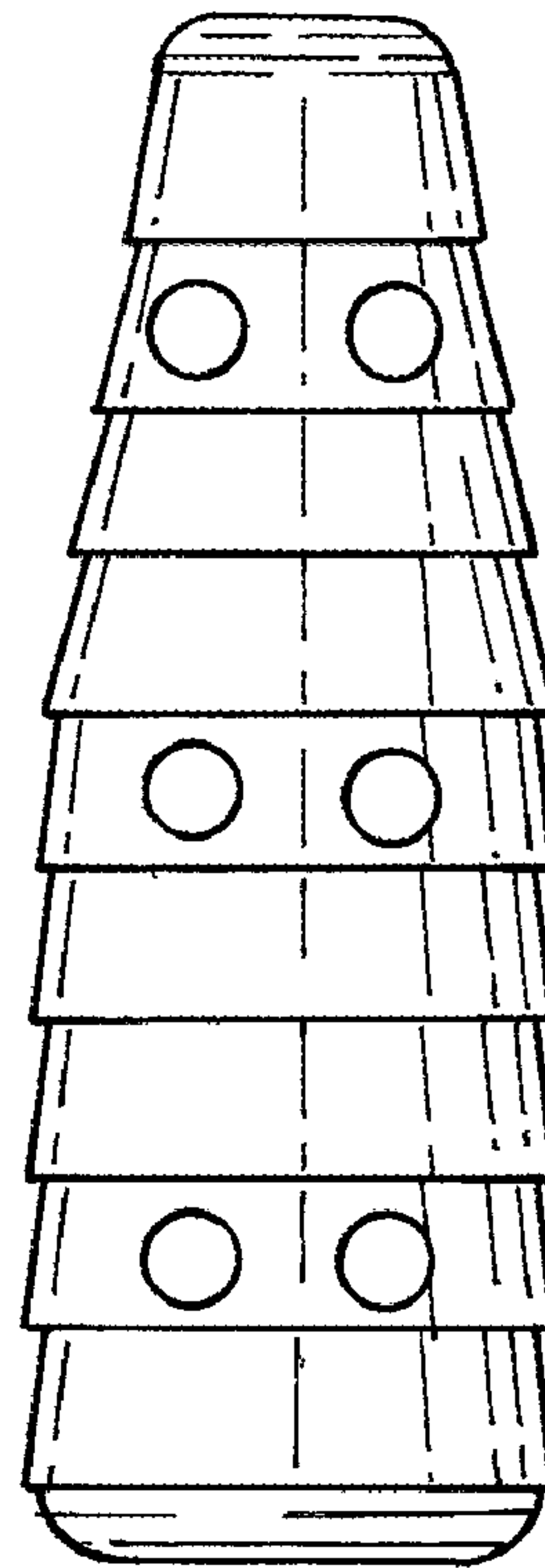

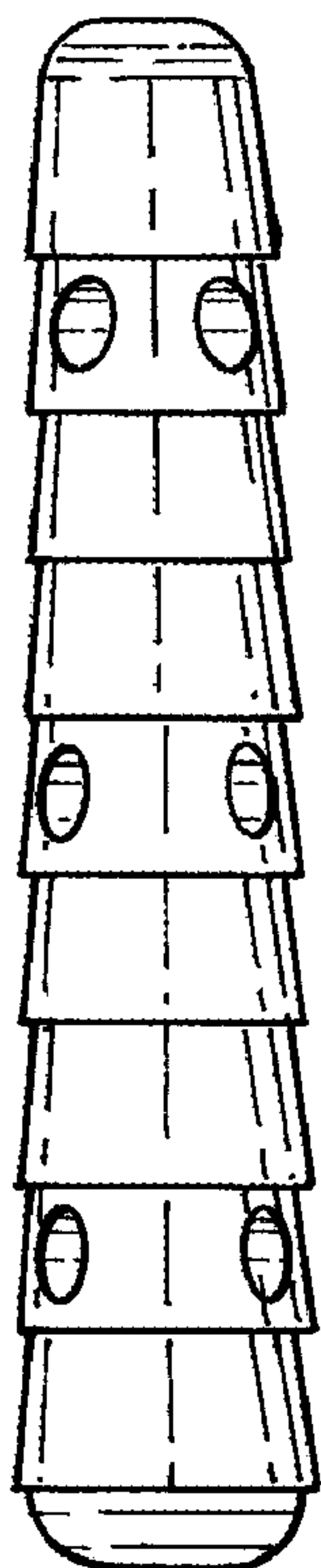

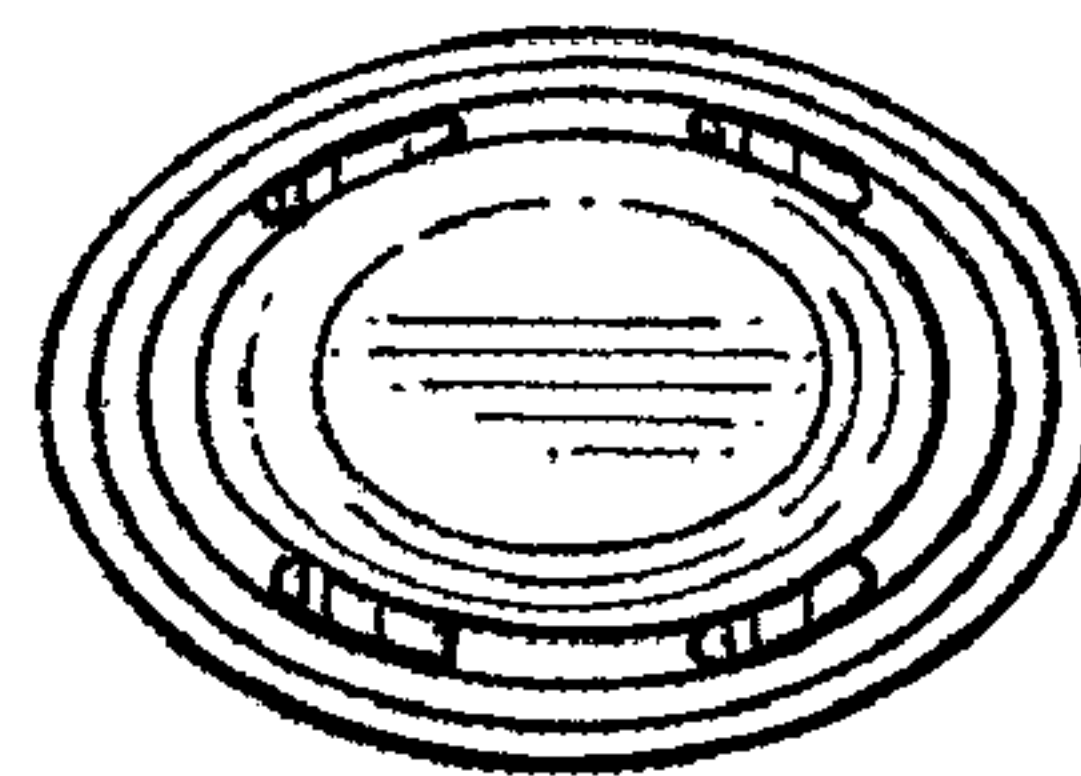

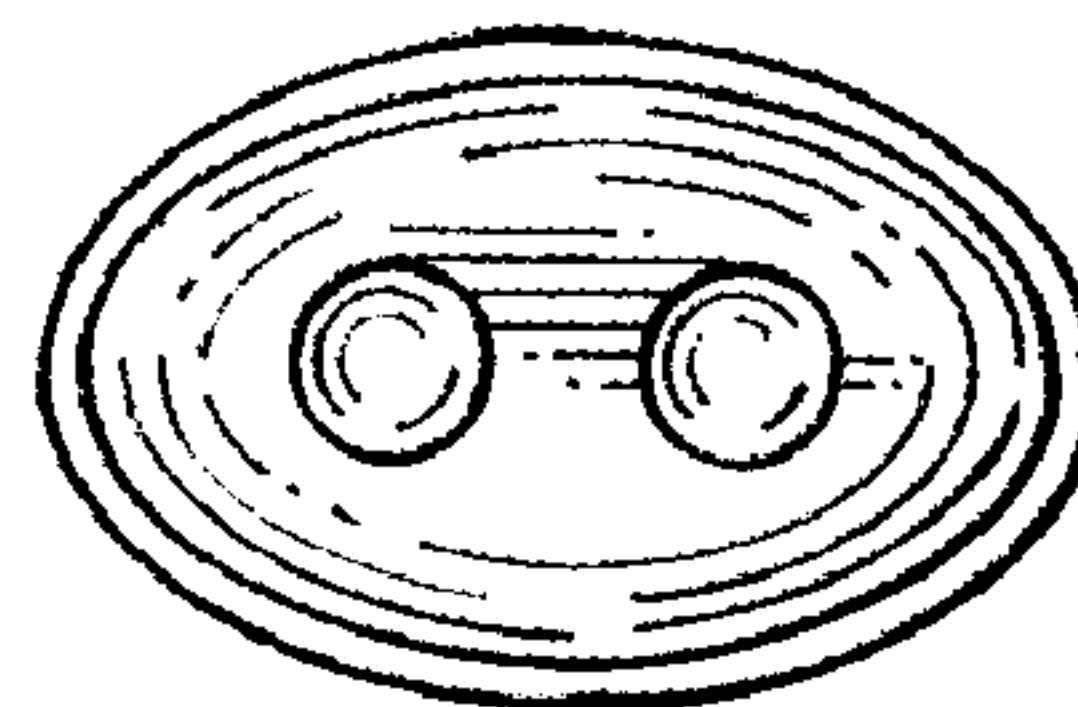
