FIG. 1.

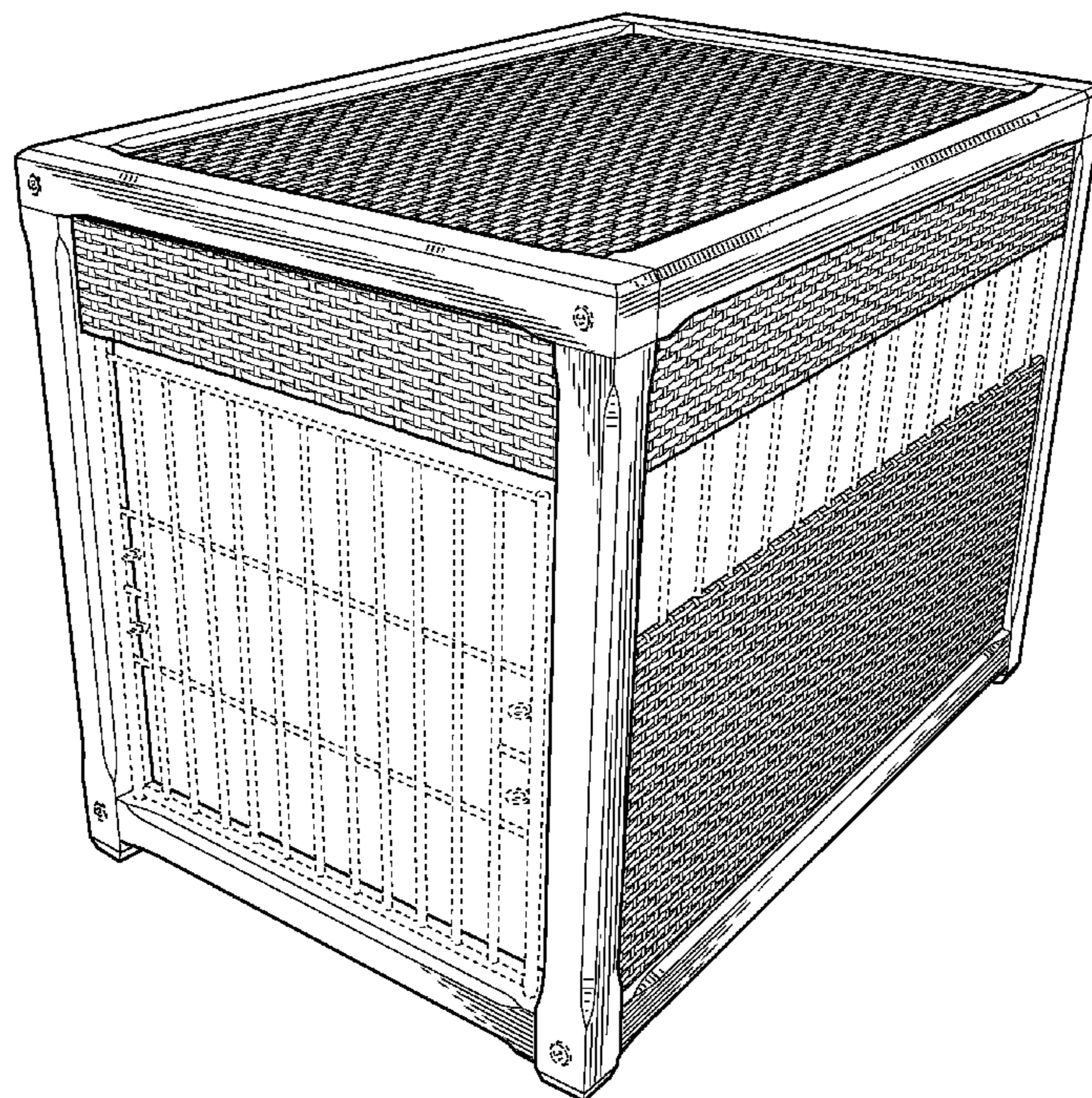
FIG. 3 is a first side view of the decorative indoor pet home of

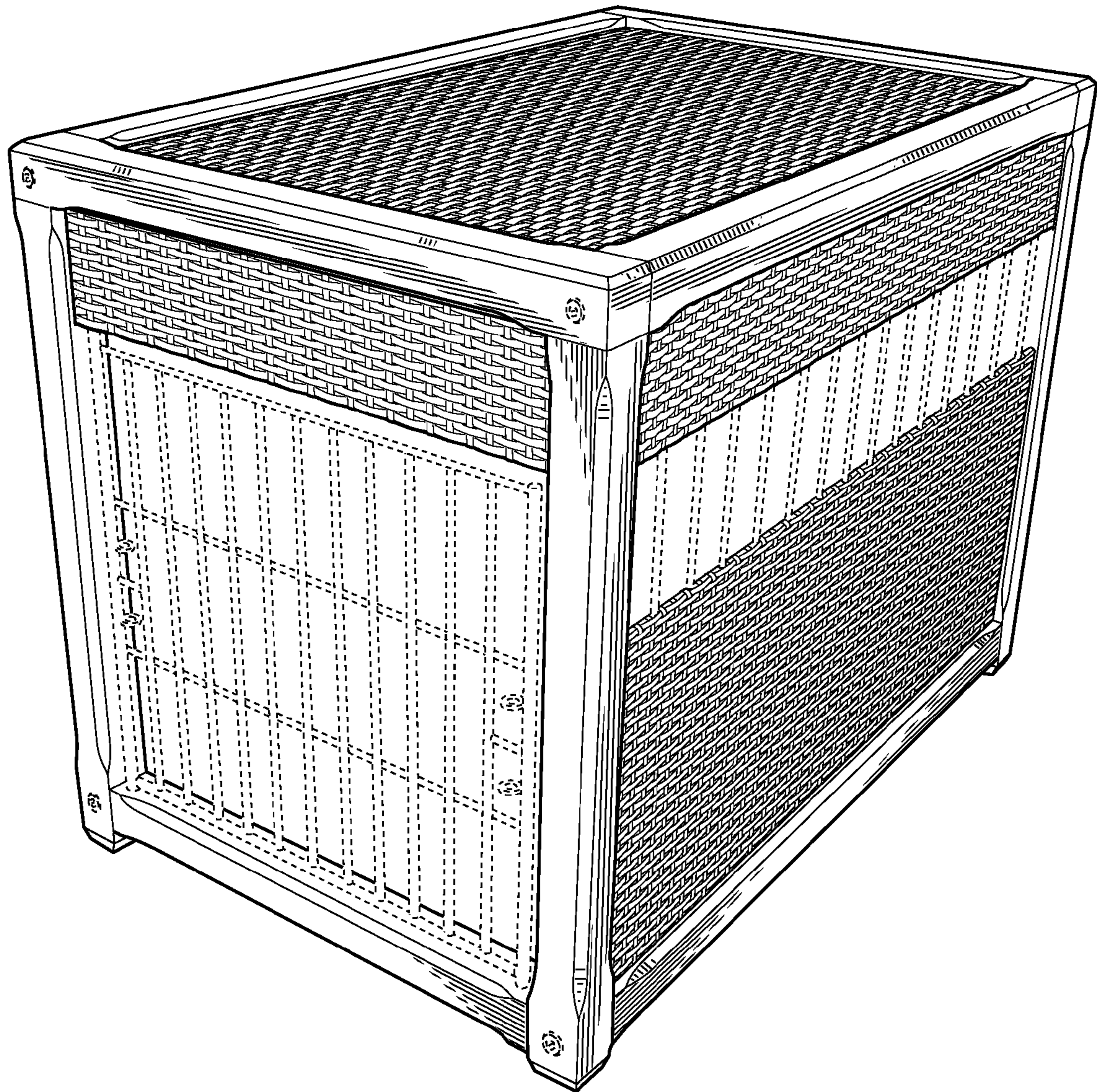

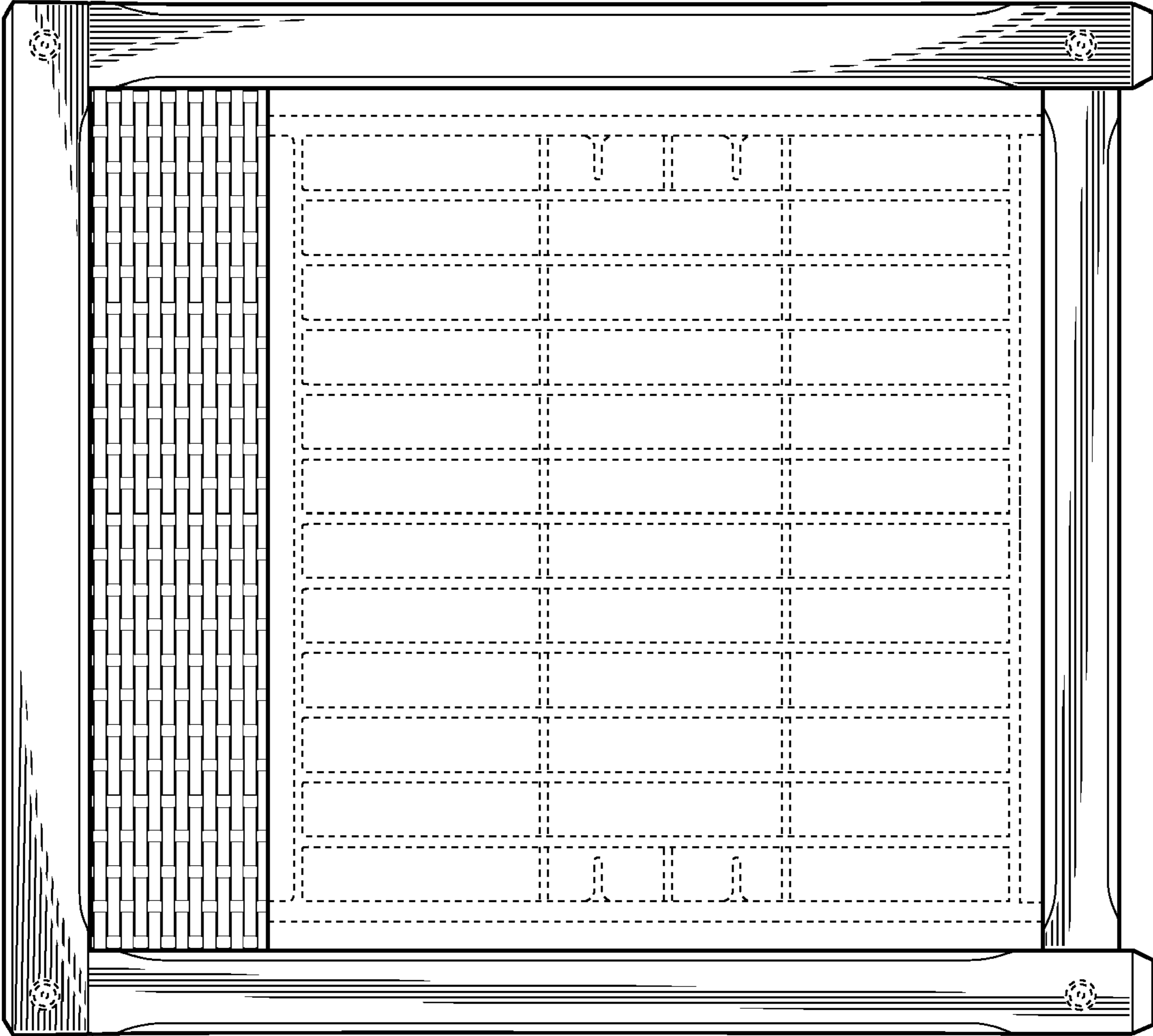

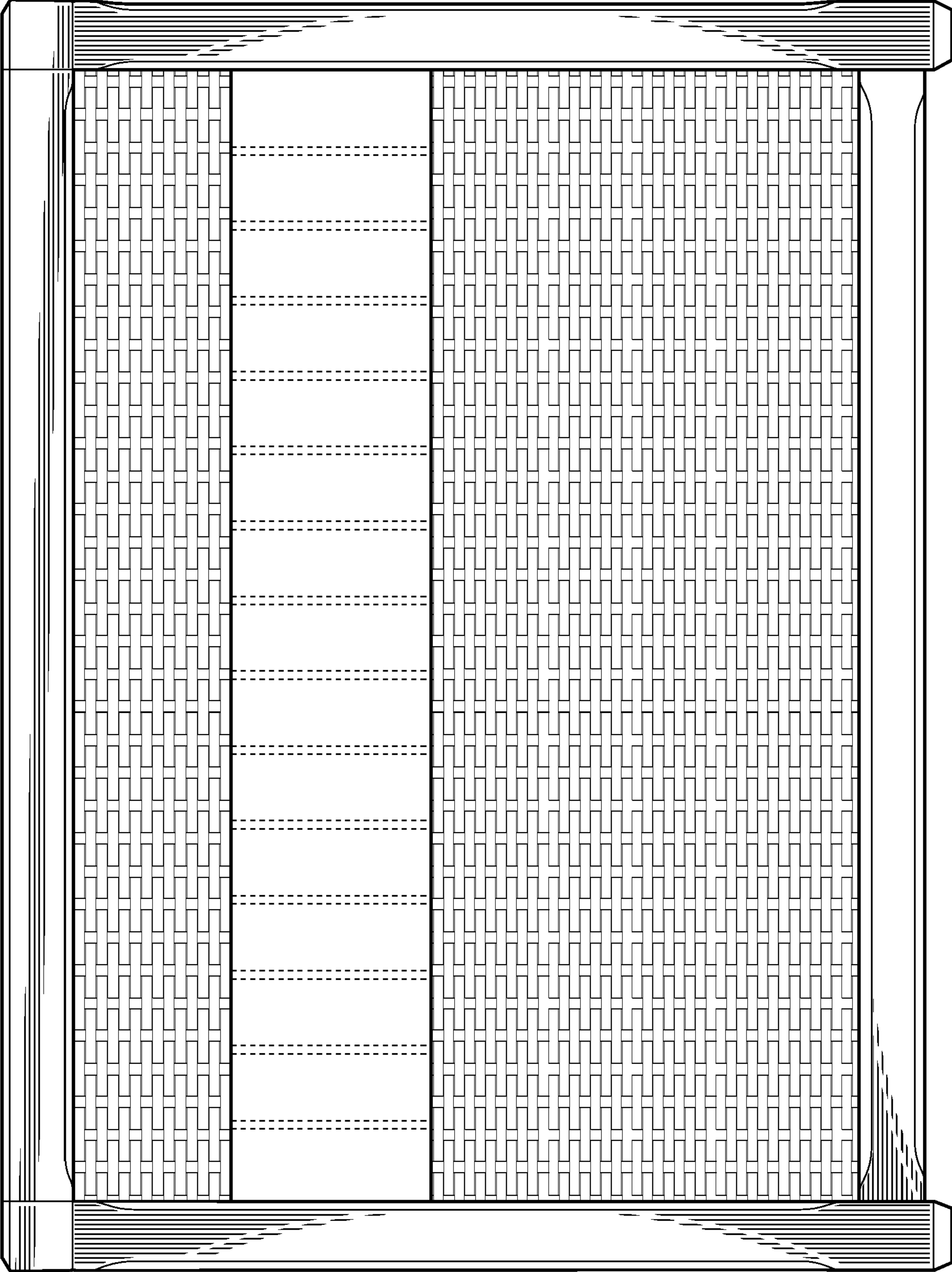

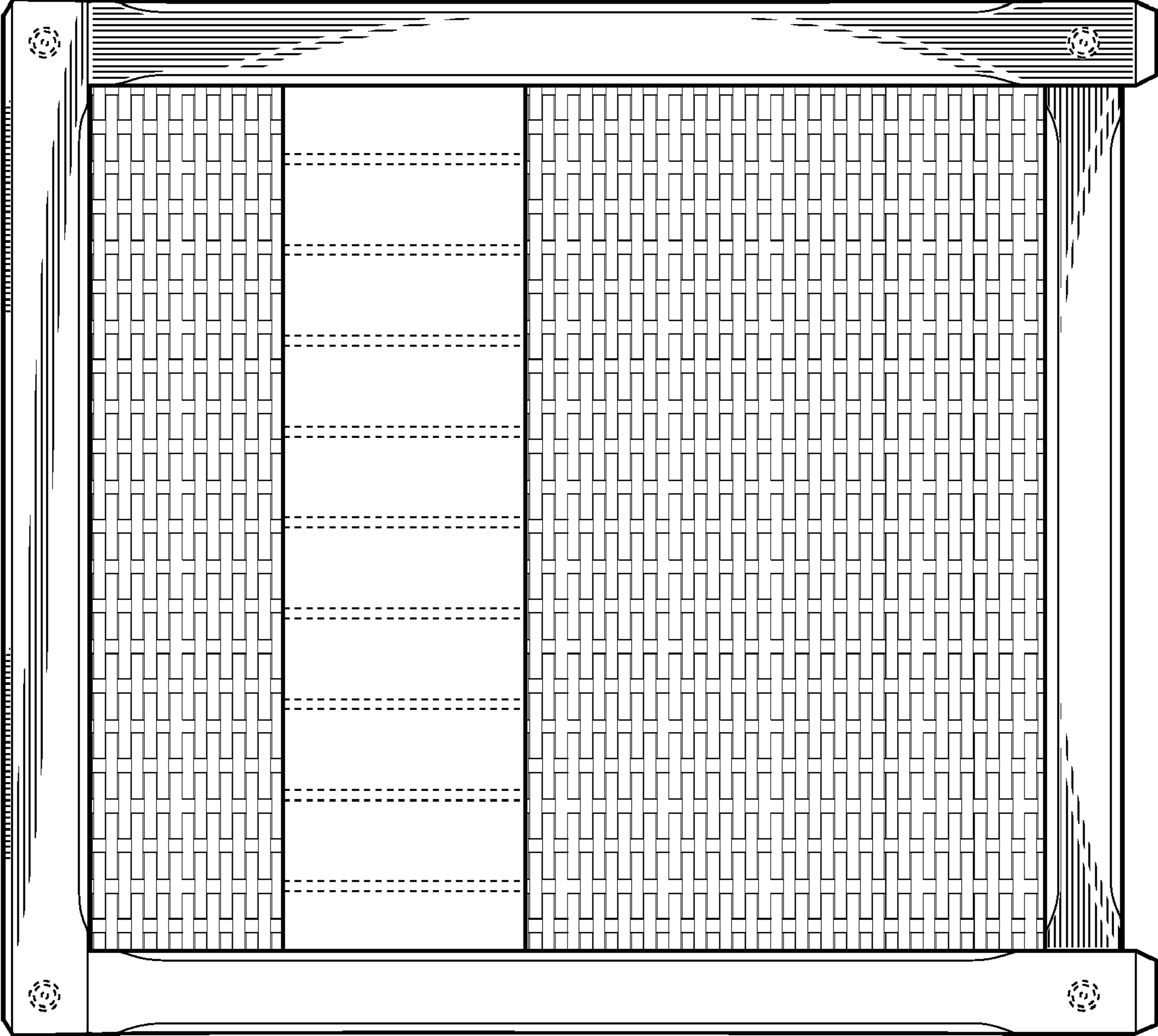

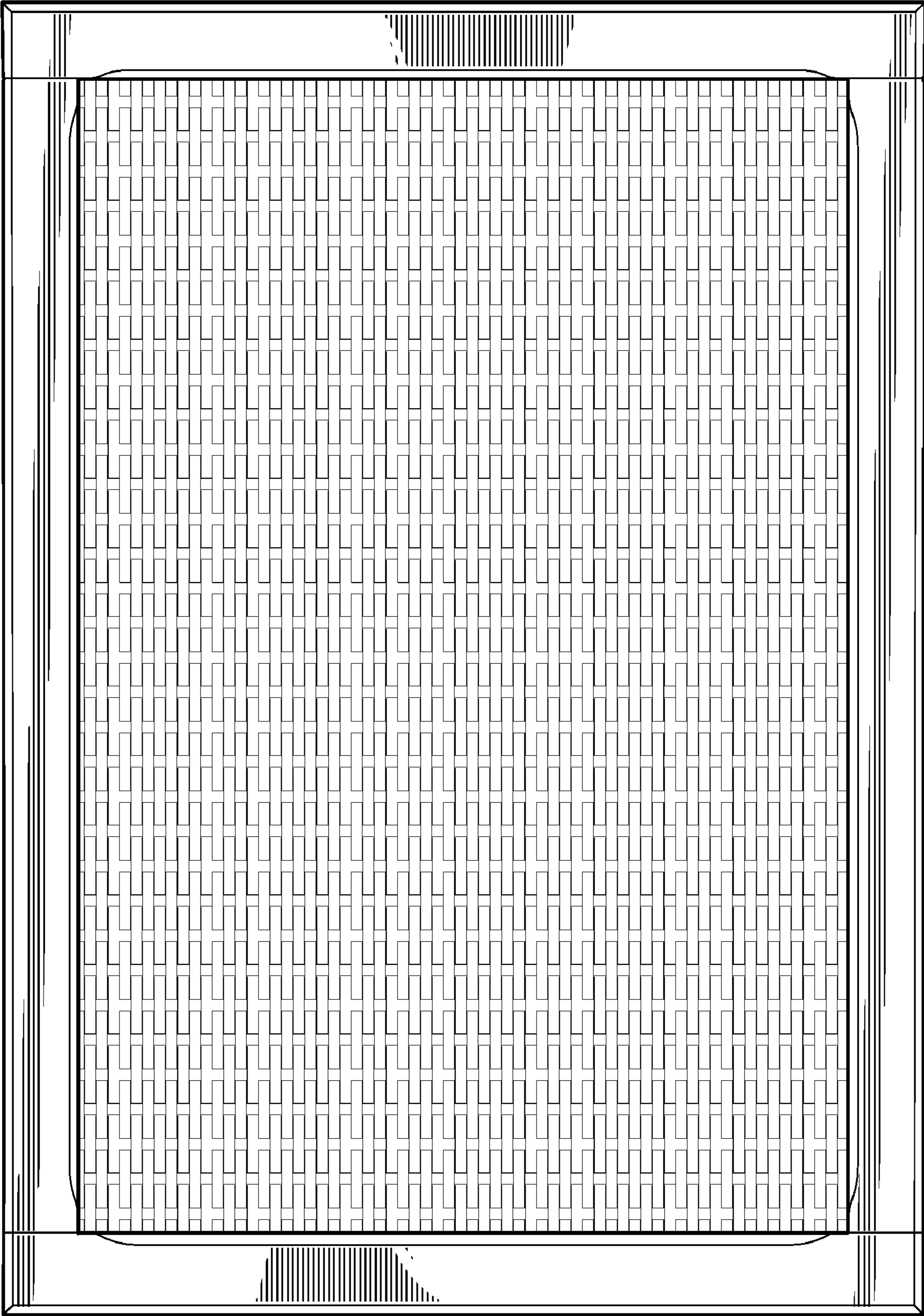
