(57) **CLAIM**

The ornamental design for a display device, as shown and described.

DESCRIPTION

FIG. 1 illustrates an exterior front perspective view of a display device including display elements in an open position.

FIG. 2 illustrates a front elevation view of FIG. 1 in an open position.

FIG. 3 illustrates an interior front elevation view of FIG. 1 in an open position.

FIG. 4 illustrates a side view of FIG. 1 in an open position.

FIG. 5 illustrates a top view of FIG. 1 in an open position.

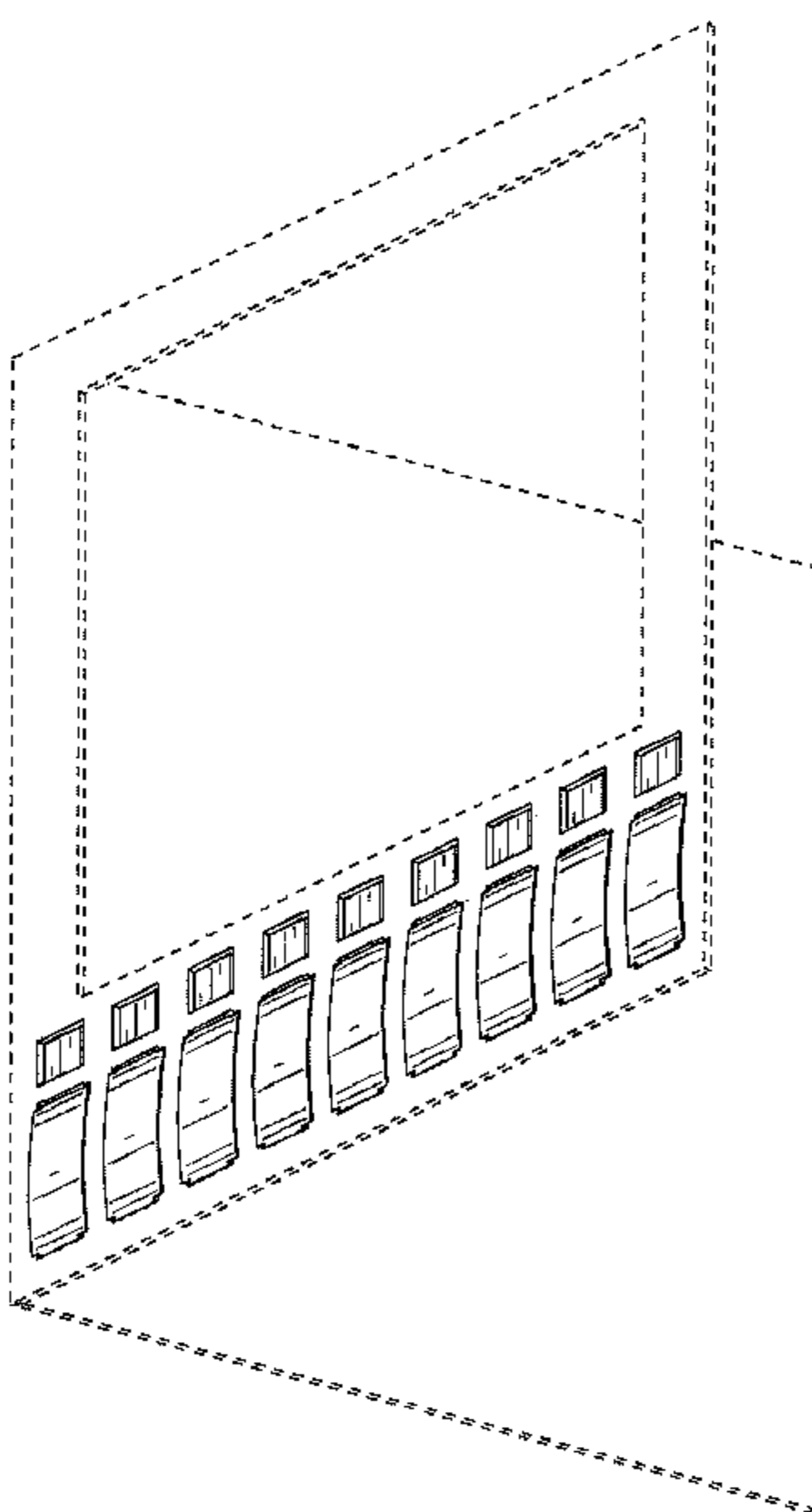
FIG. 6 illustrates a bottom view of FIG. 1 in an open position.

FIG. 7 illustrates an exploded front perspective view of FIG. 1 in an open position with a display element removed from the display device; and,

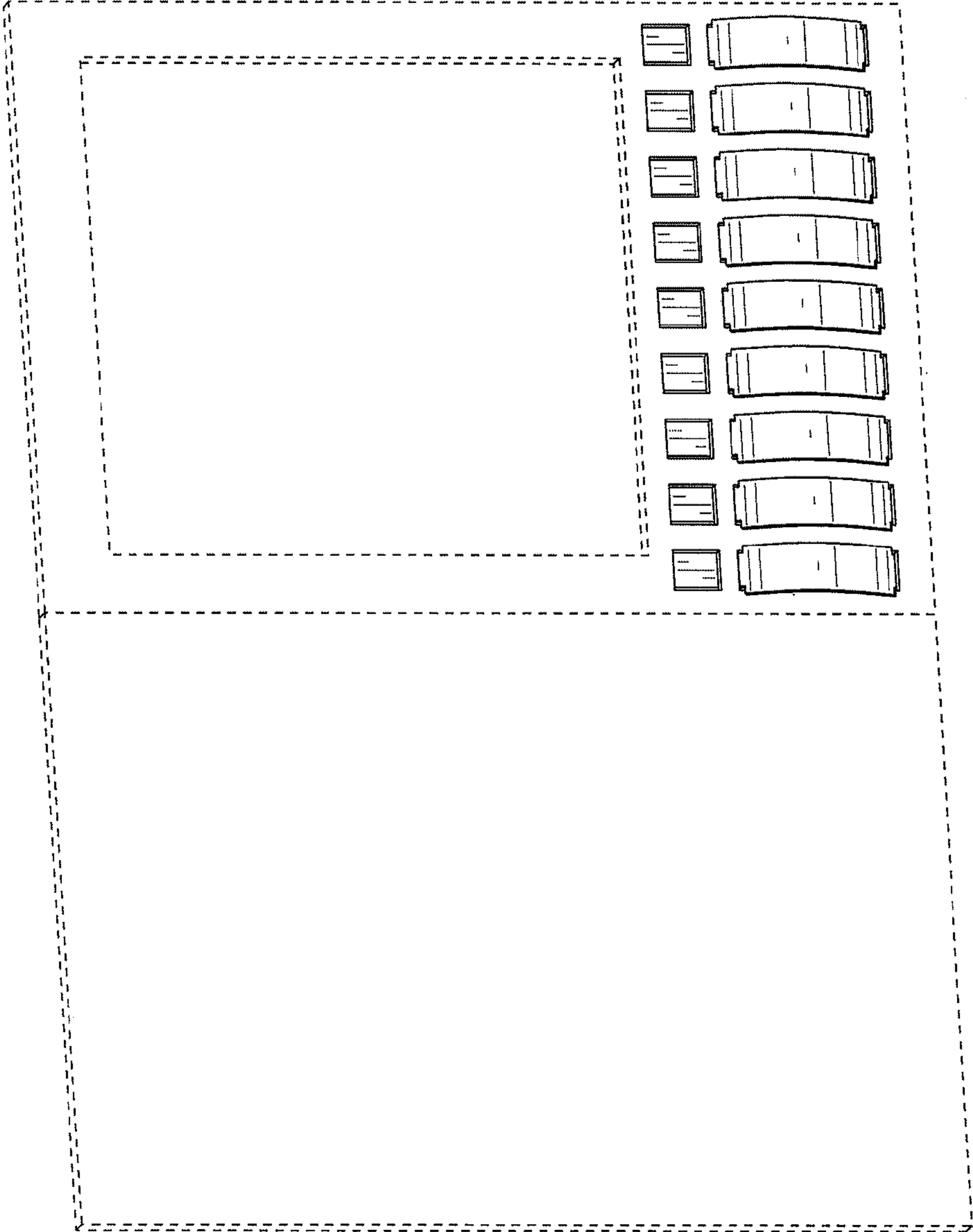

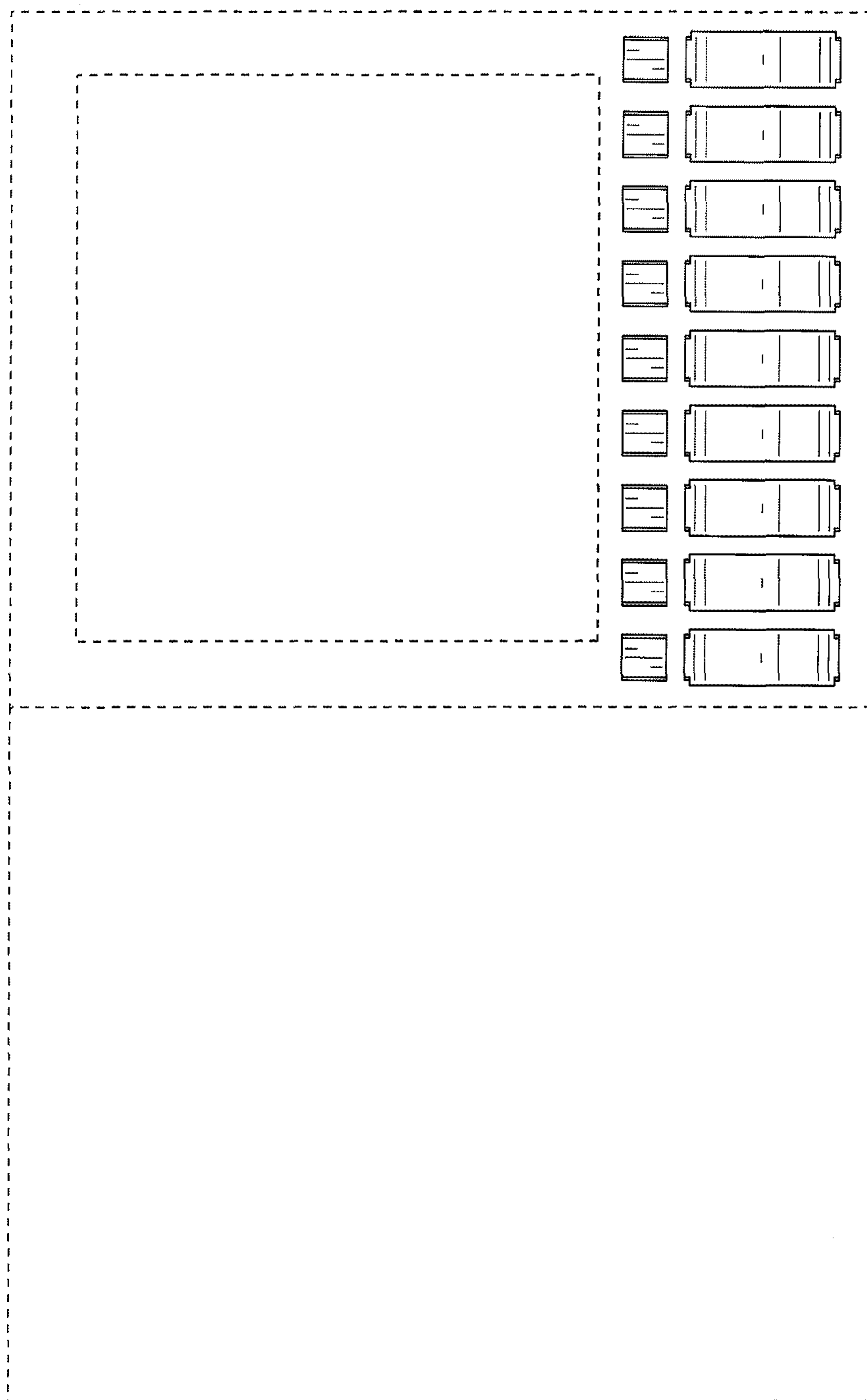

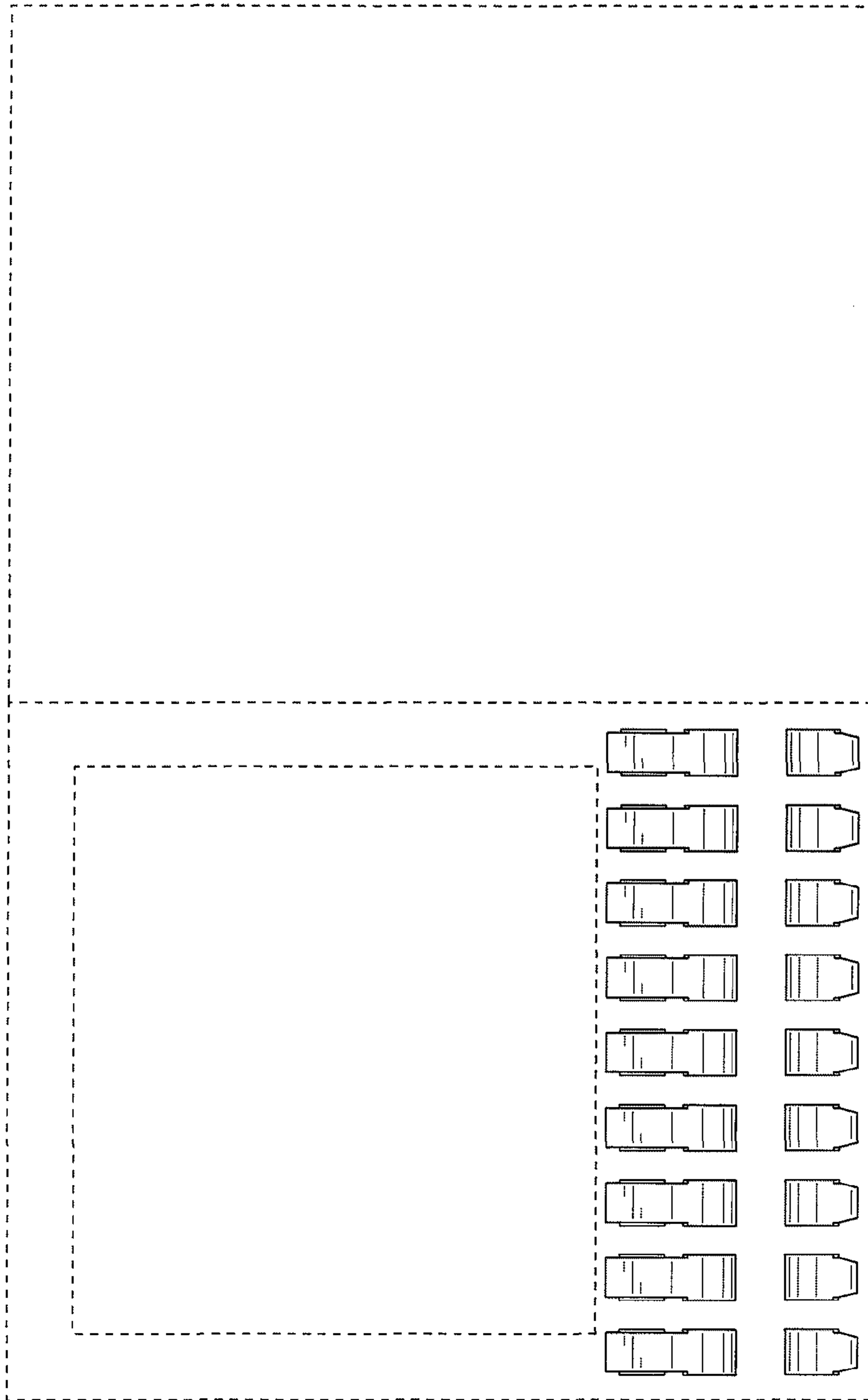

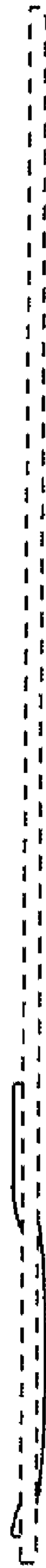

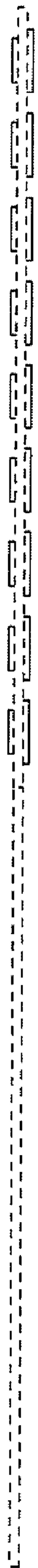

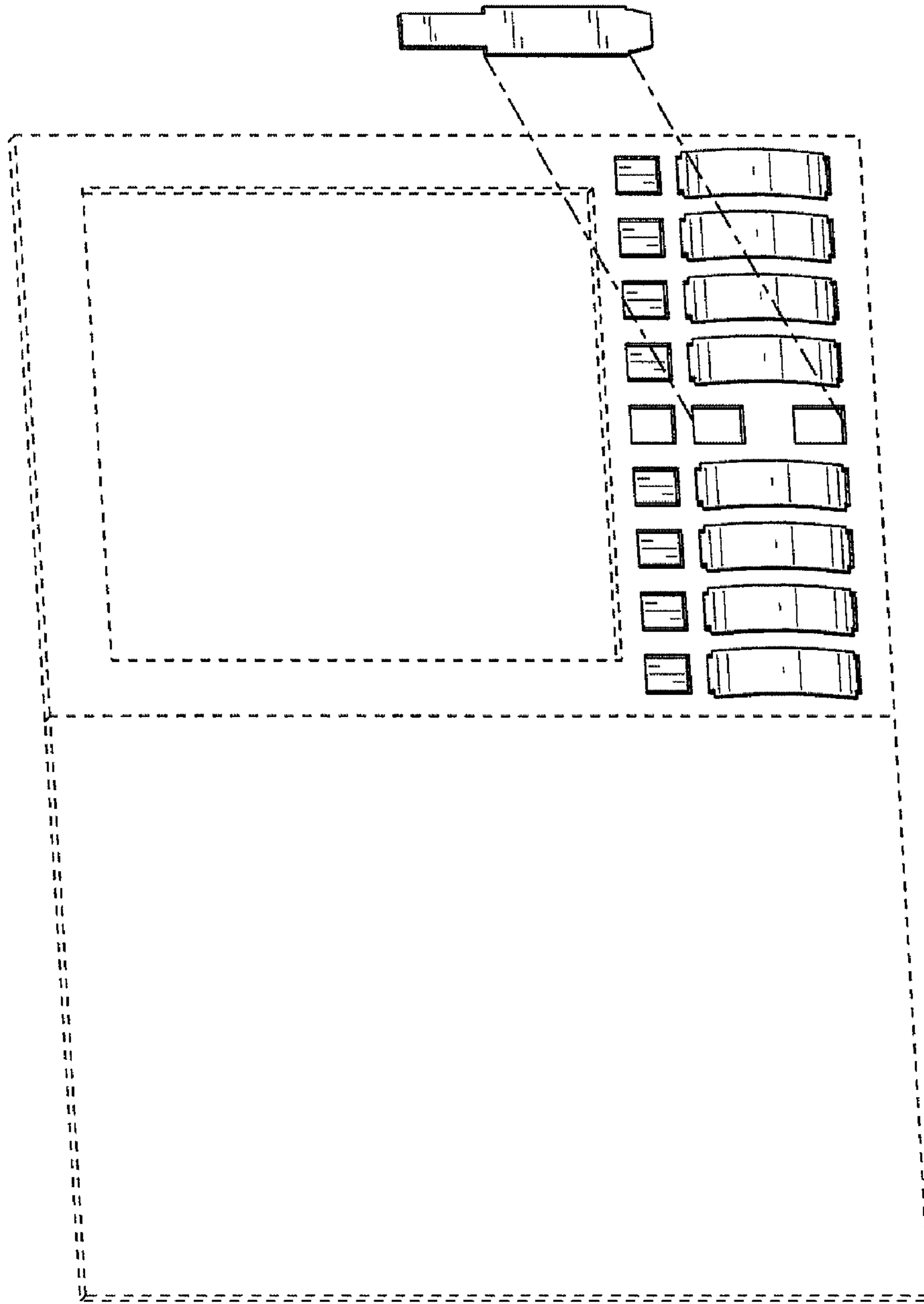

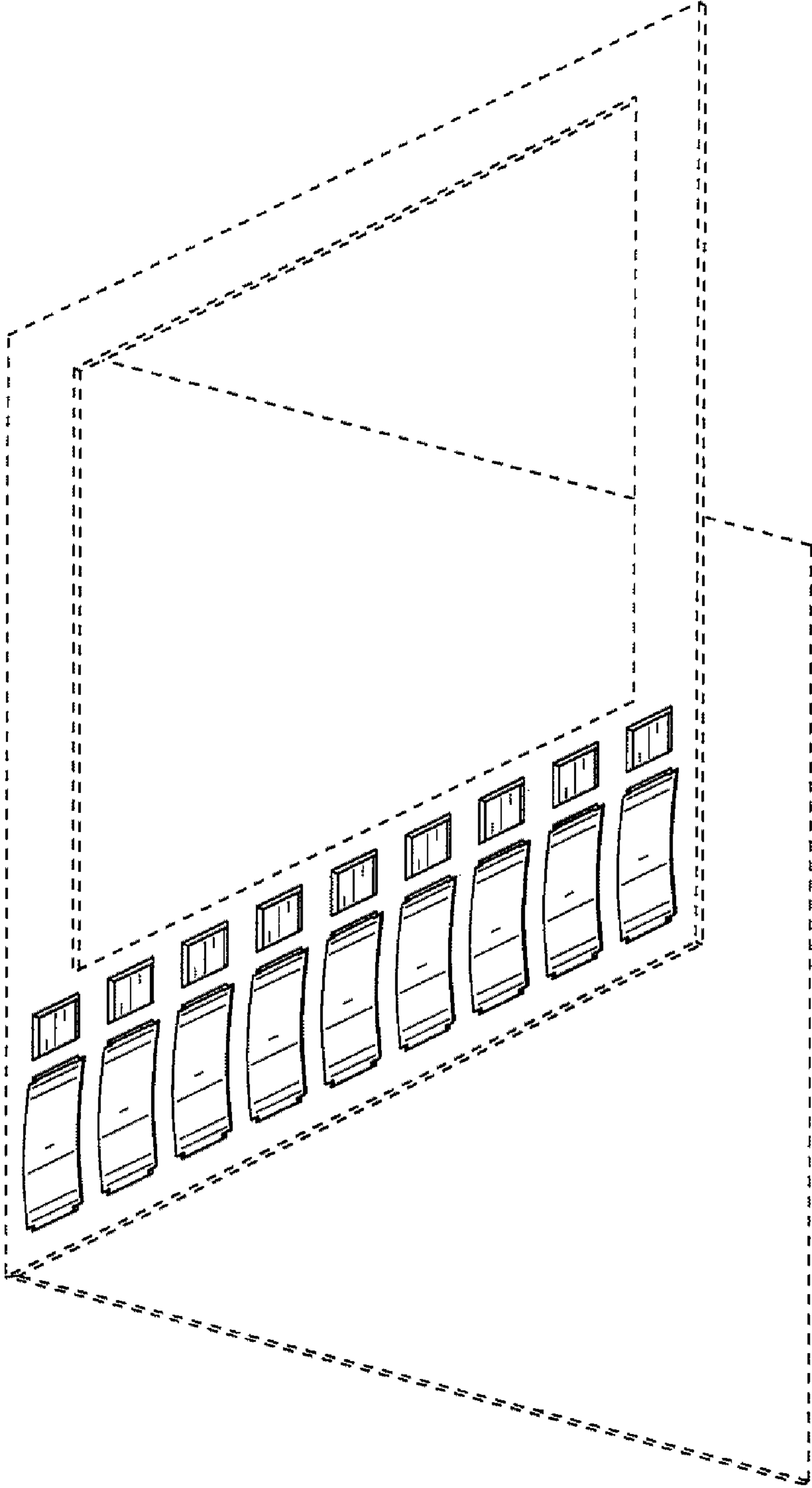
