DESCRIPTION

FIG. 1 is a top right side isometric view of a beverage container handle showing our new design.

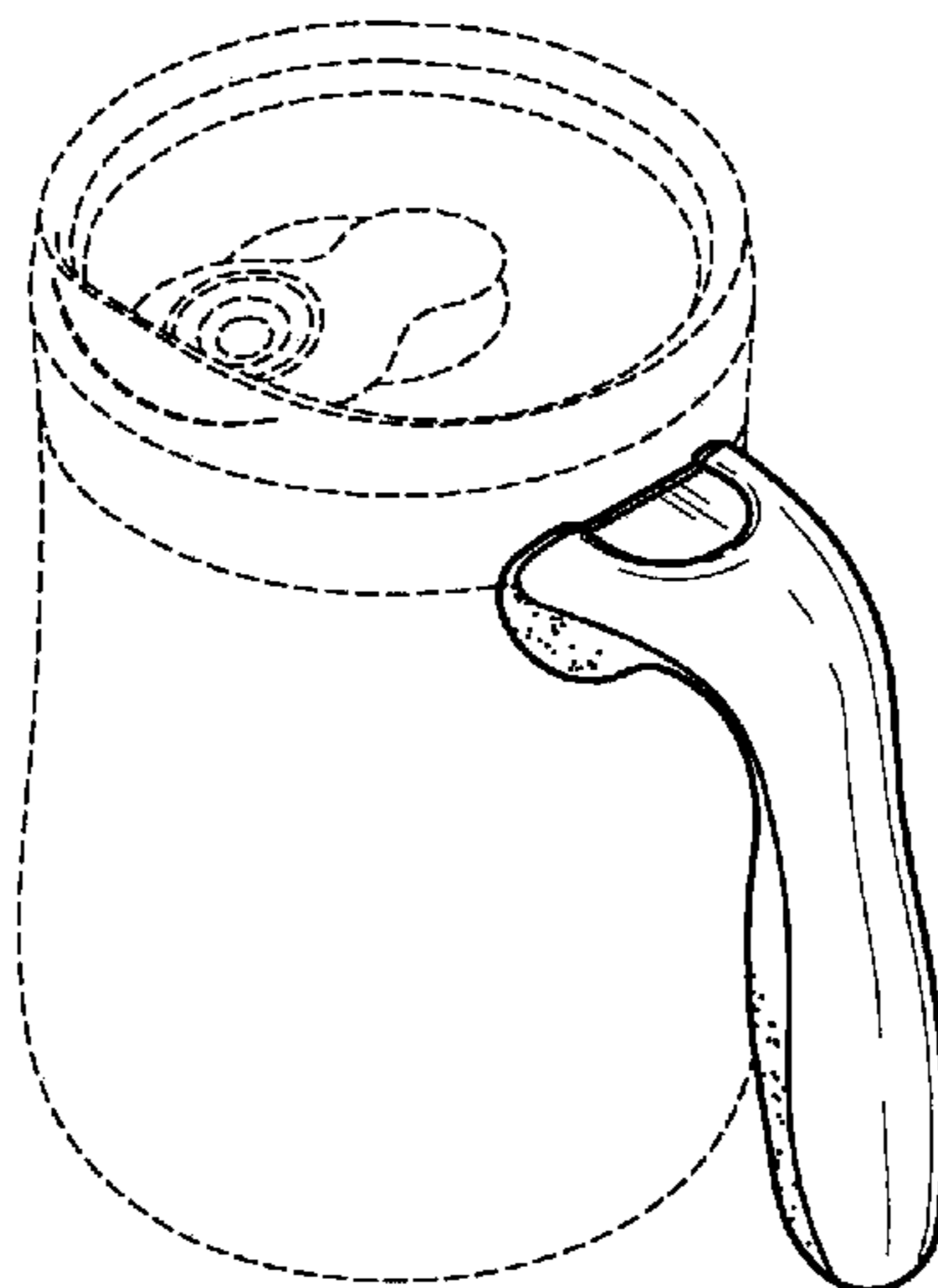

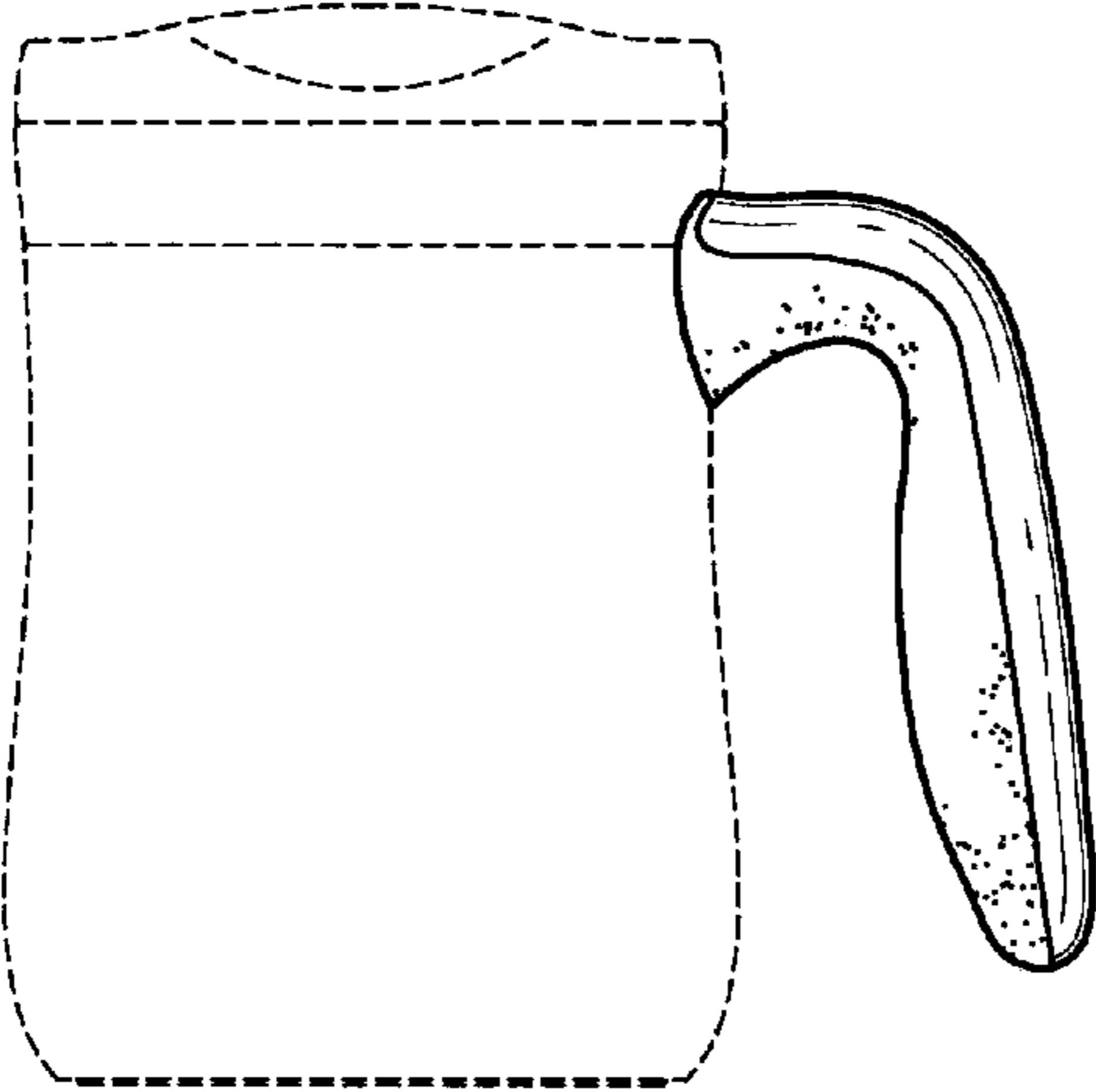
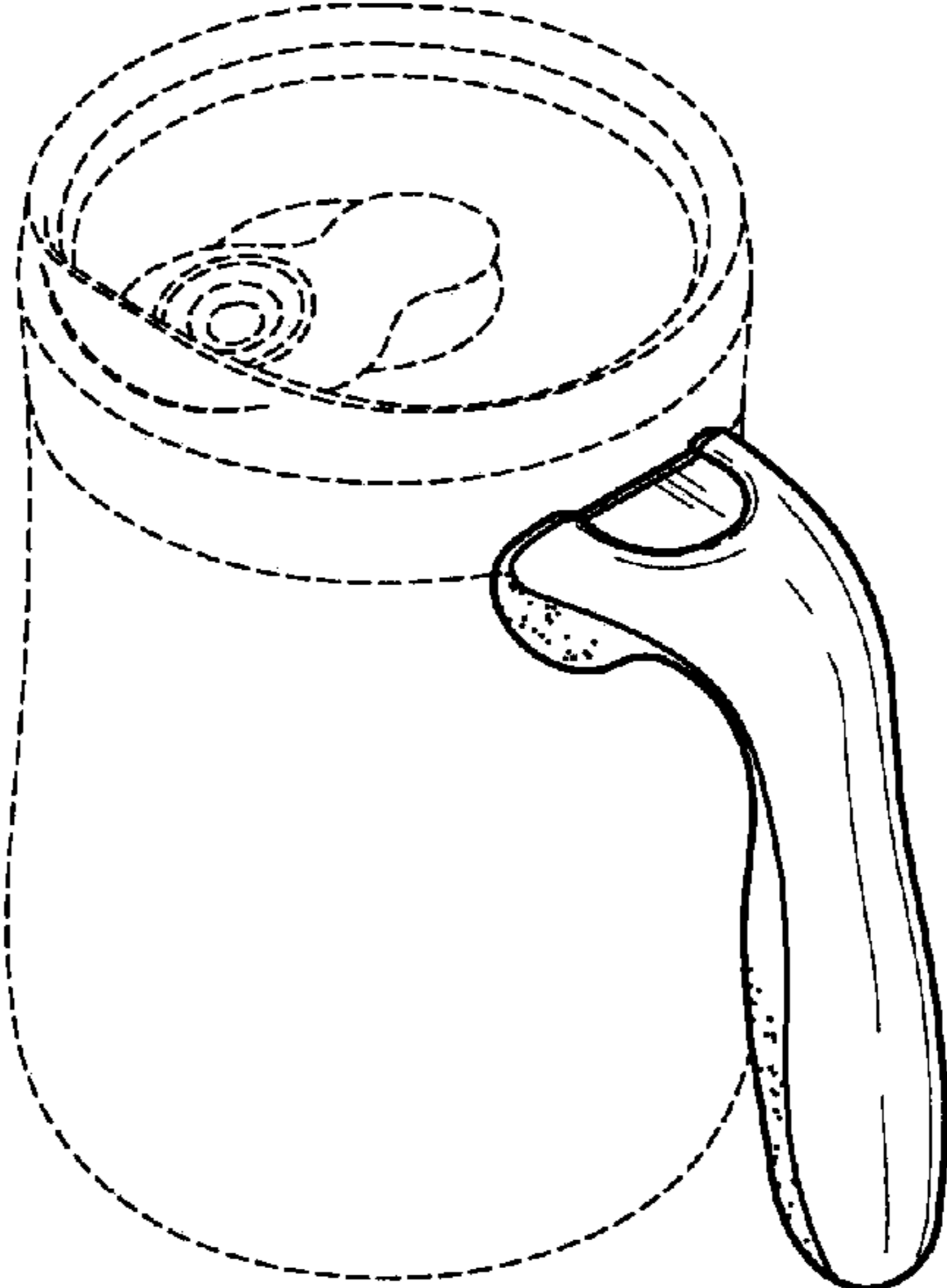

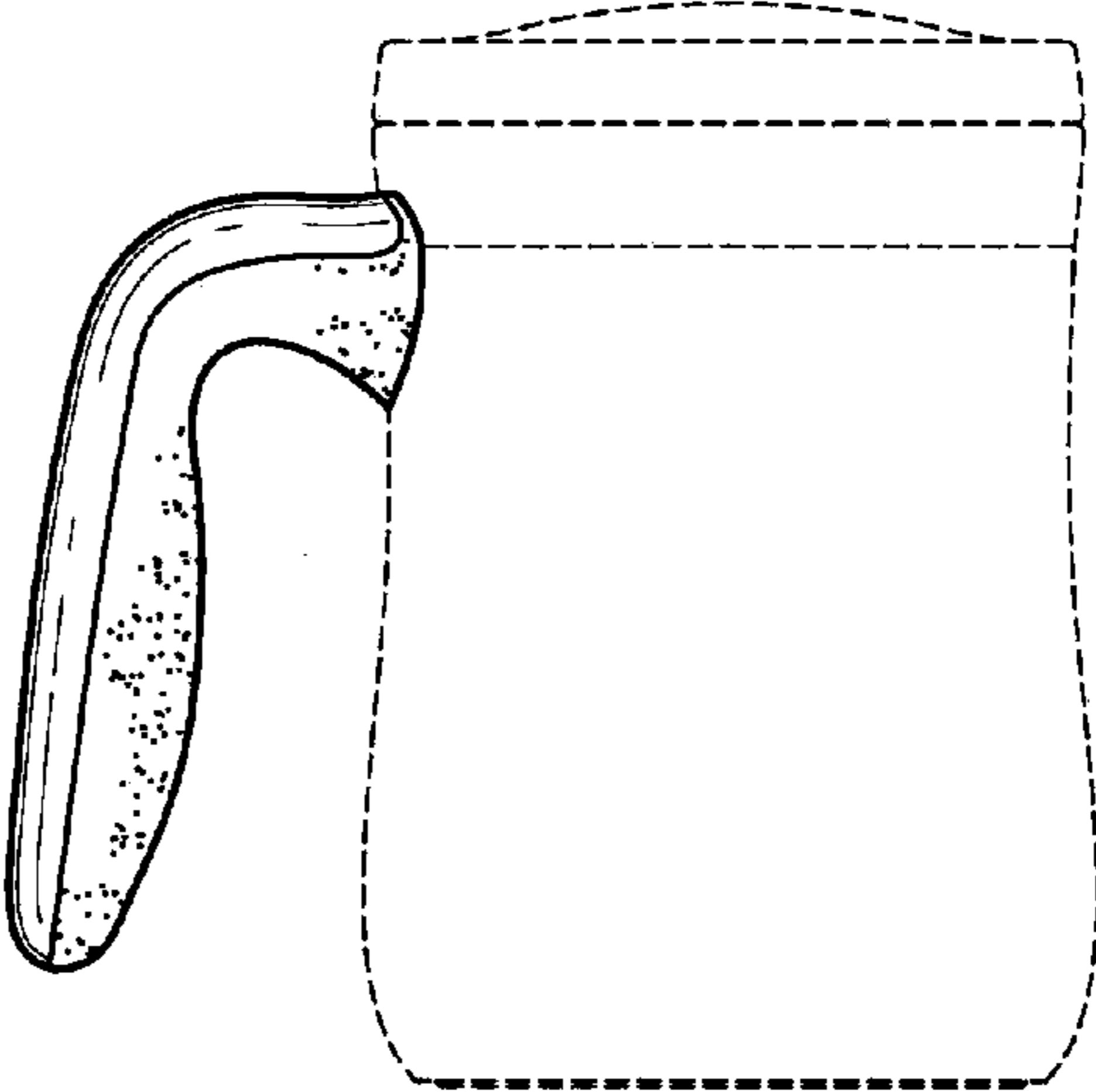

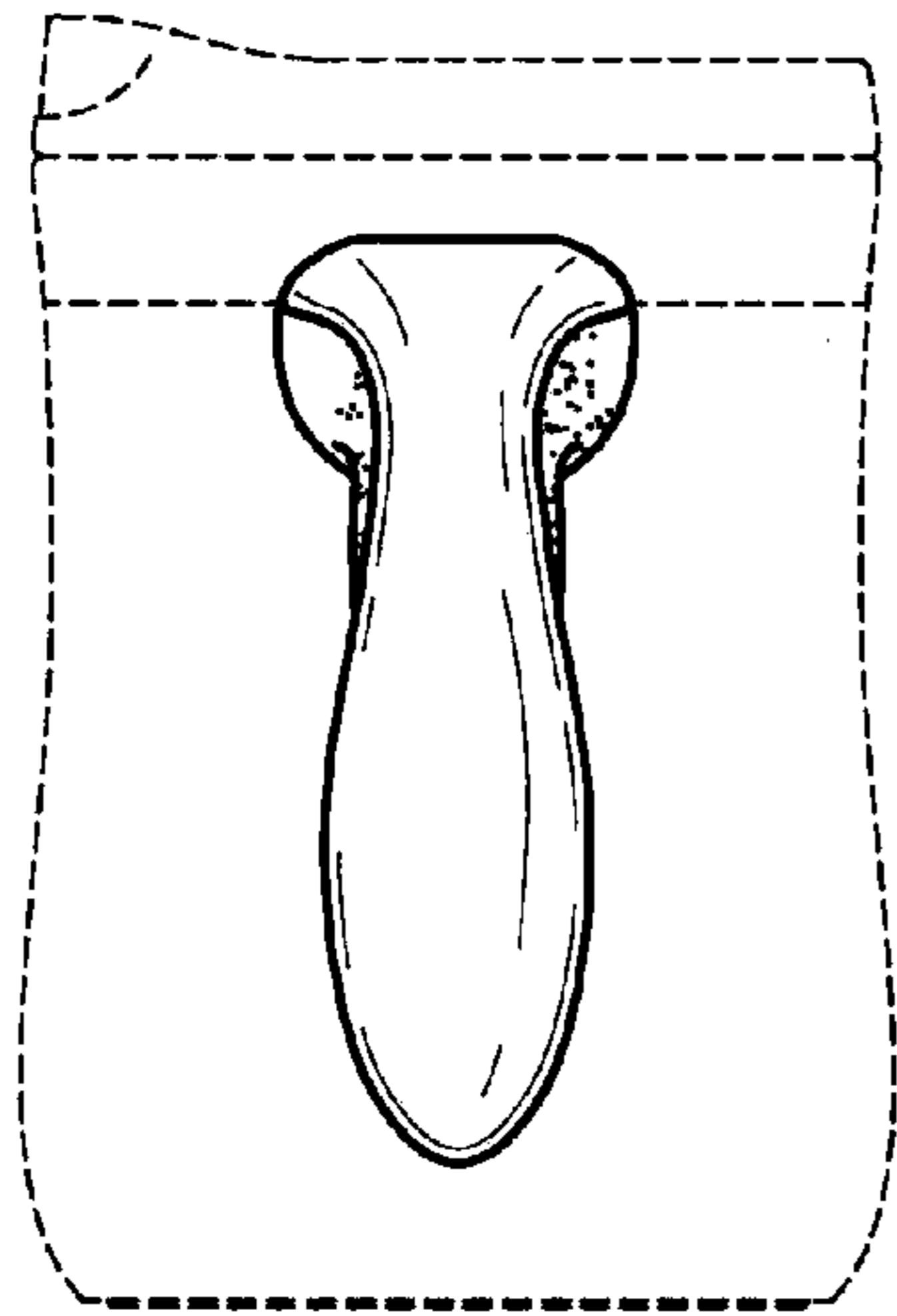

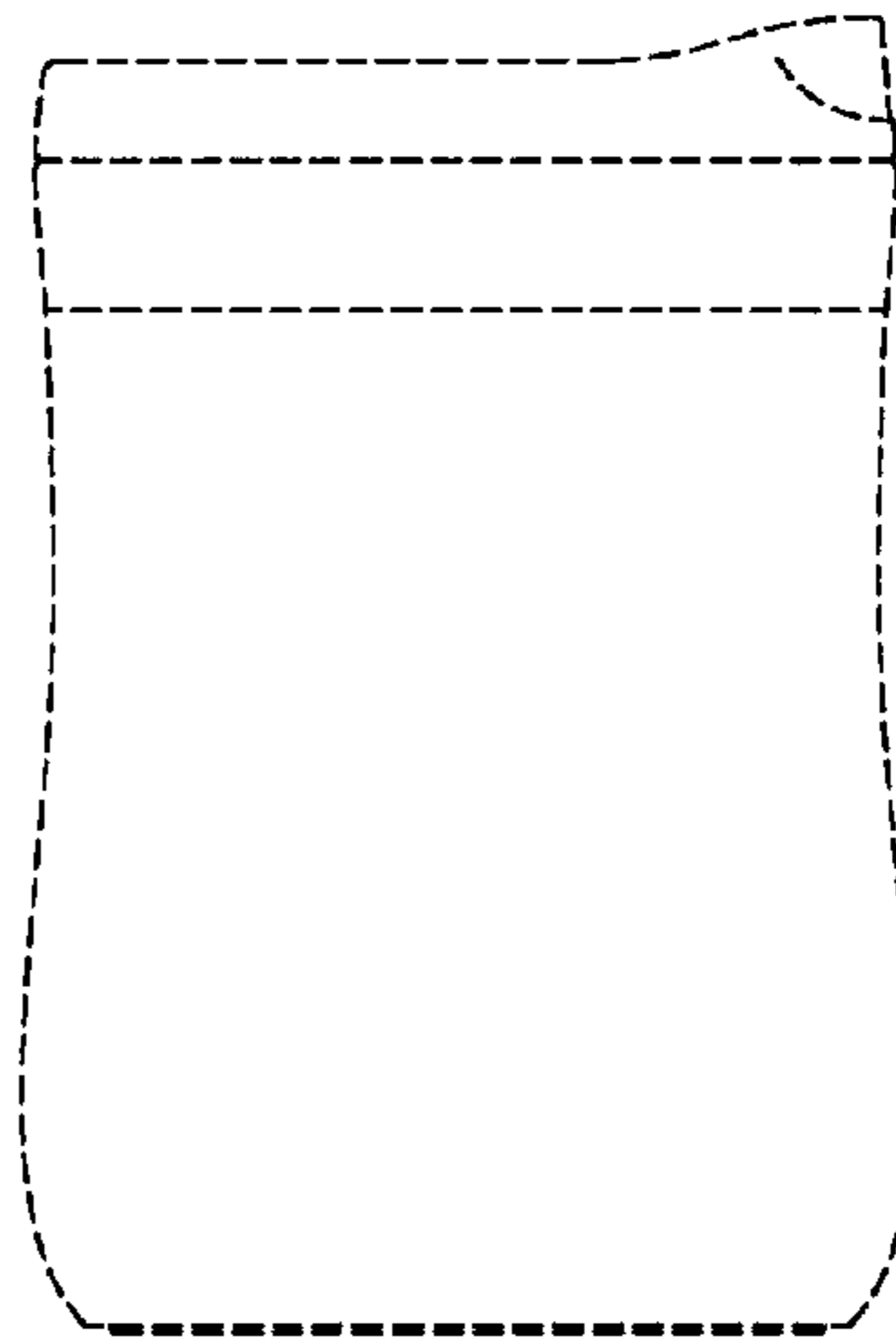

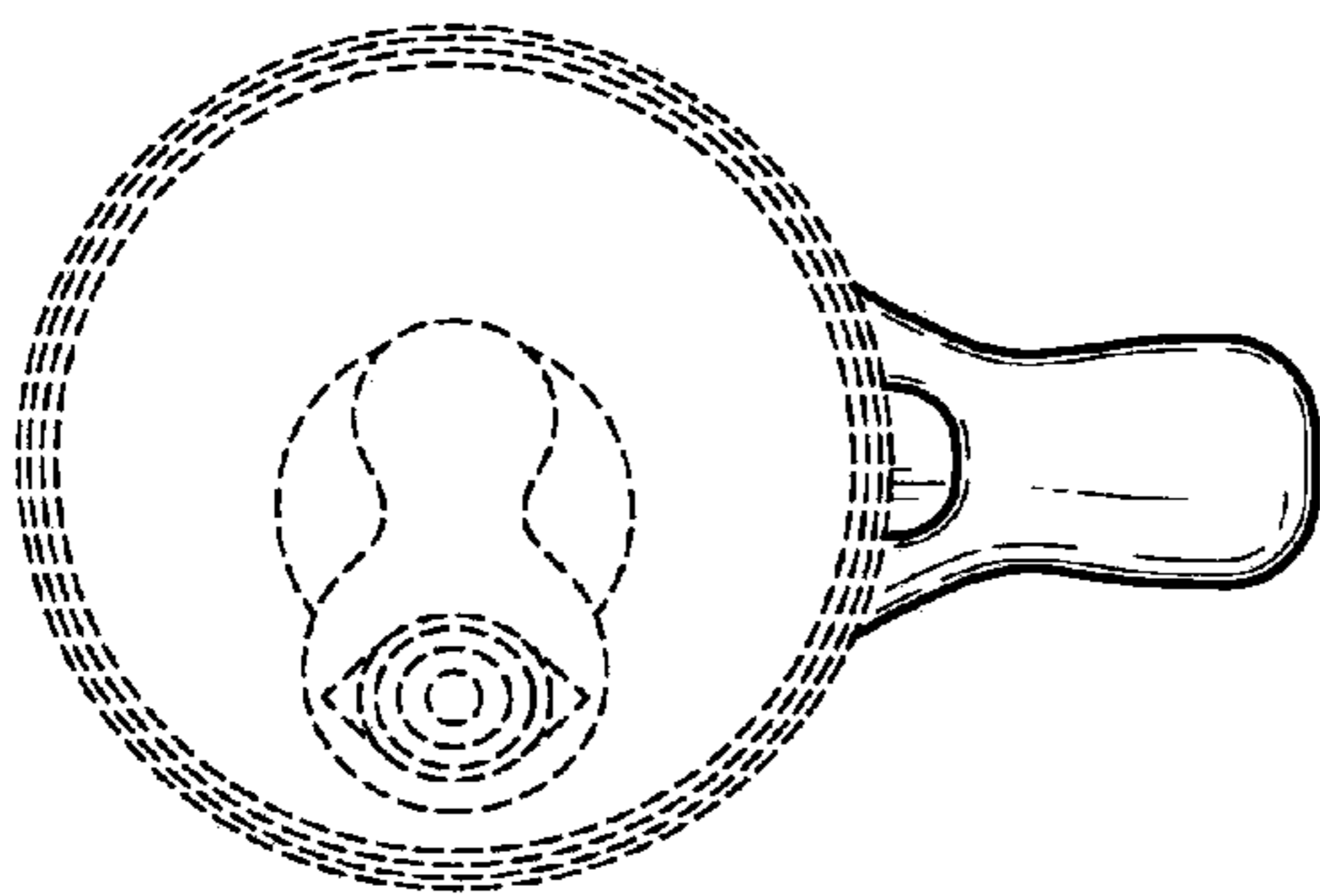

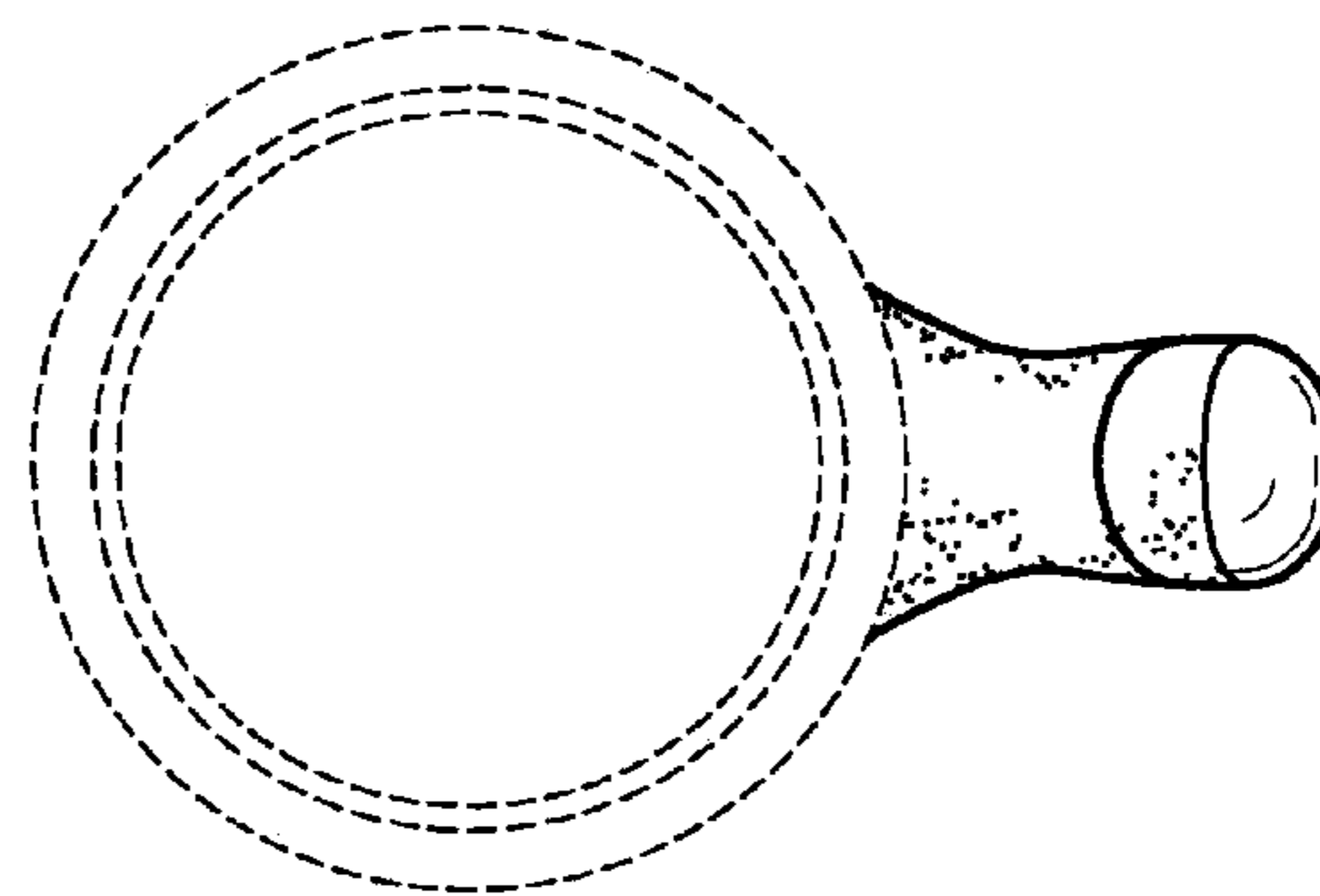
