FIG. 4 is a left side elevation view thereof;

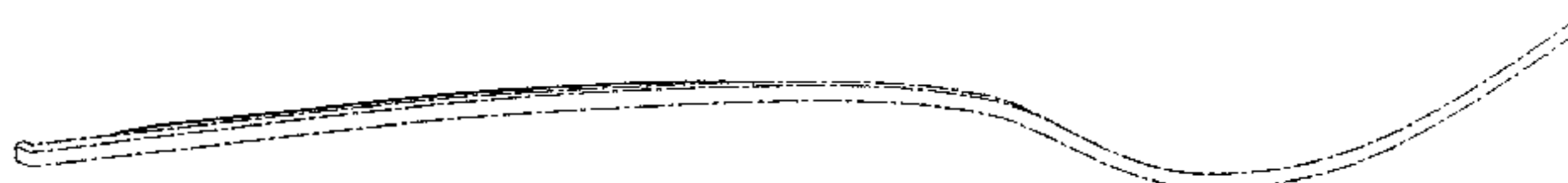
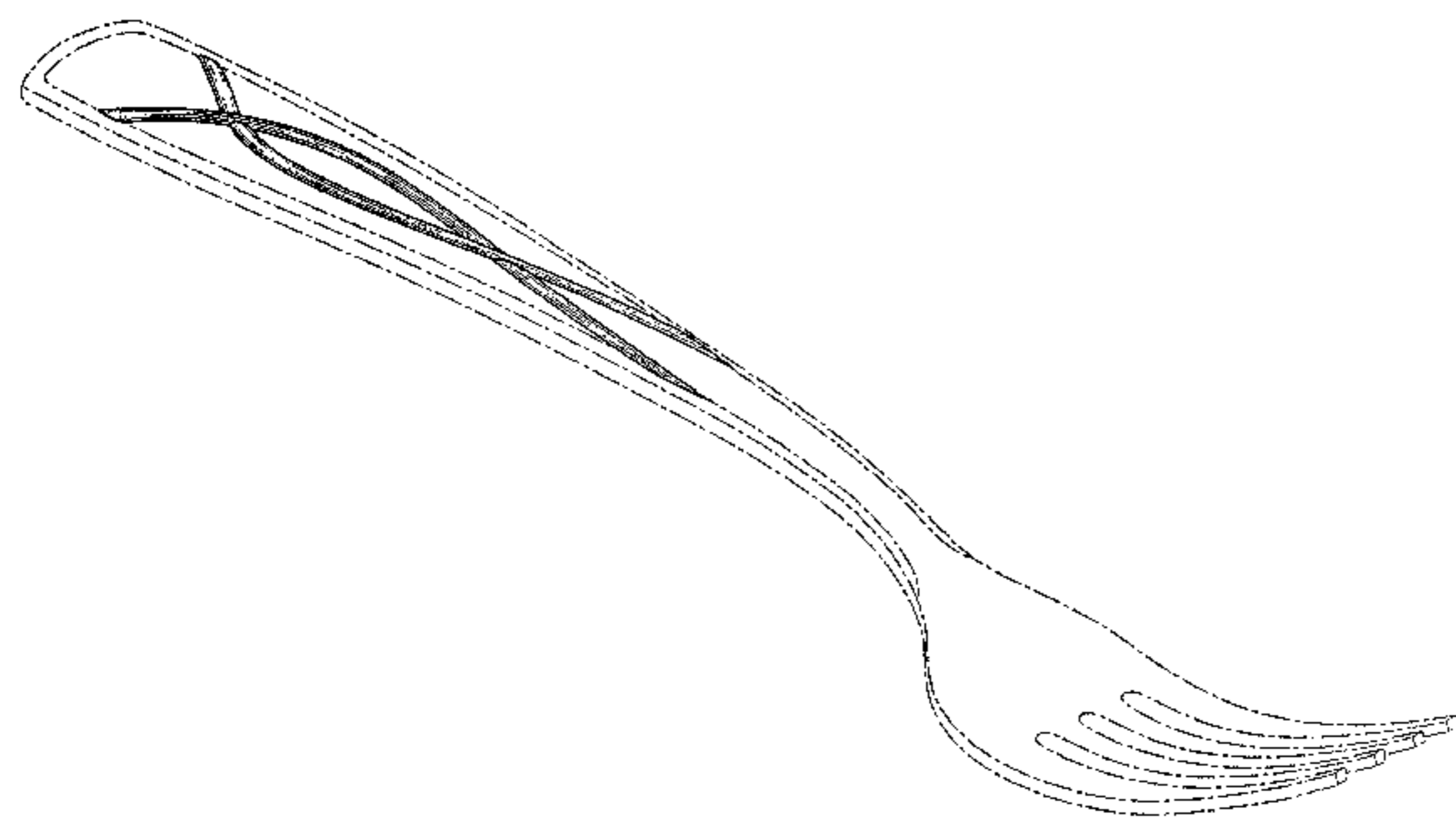
FIG. 5 is an end elevation view thereof;

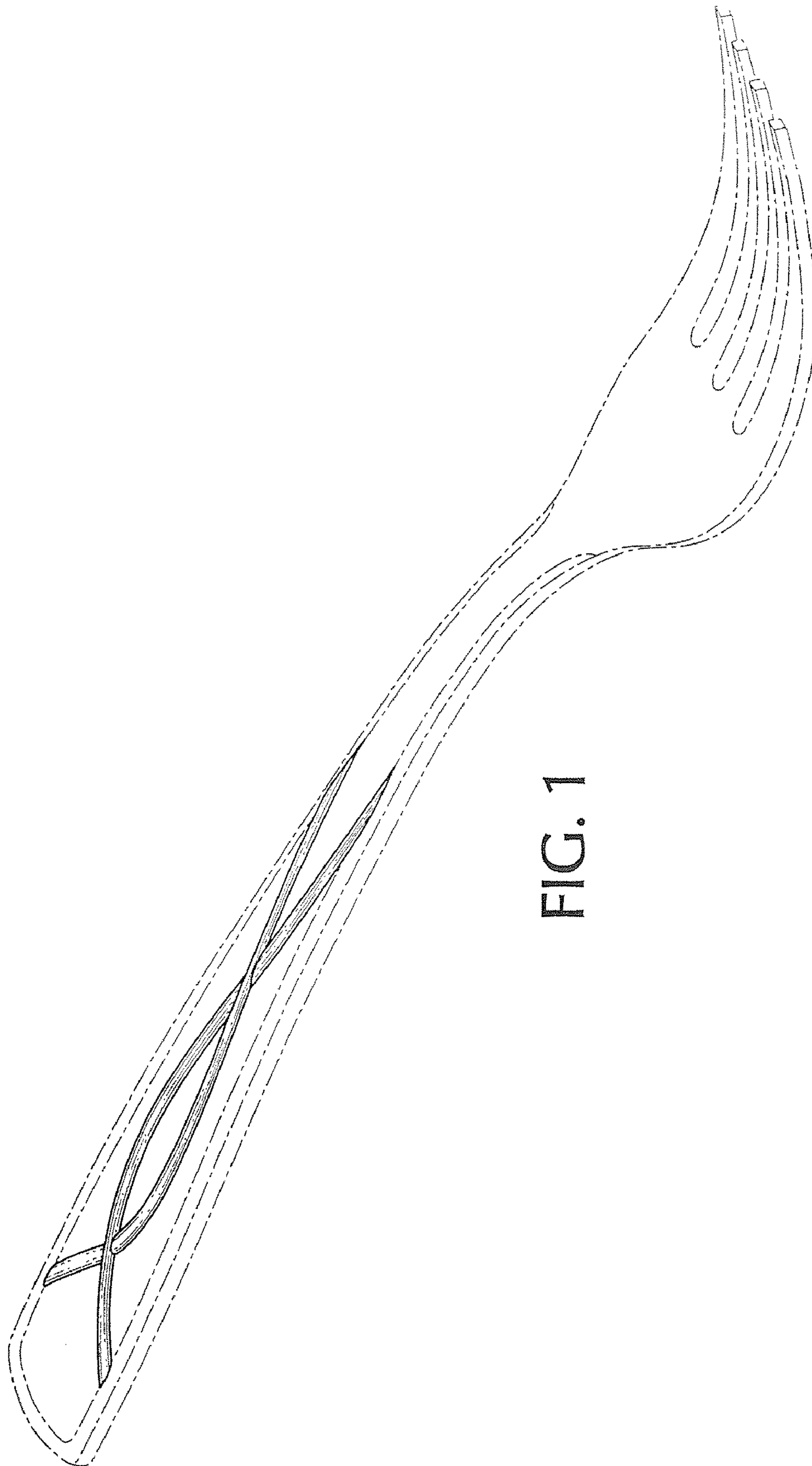

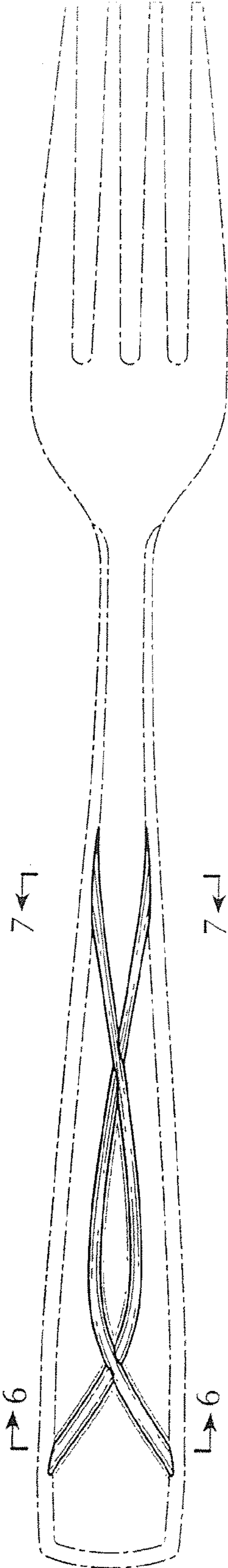

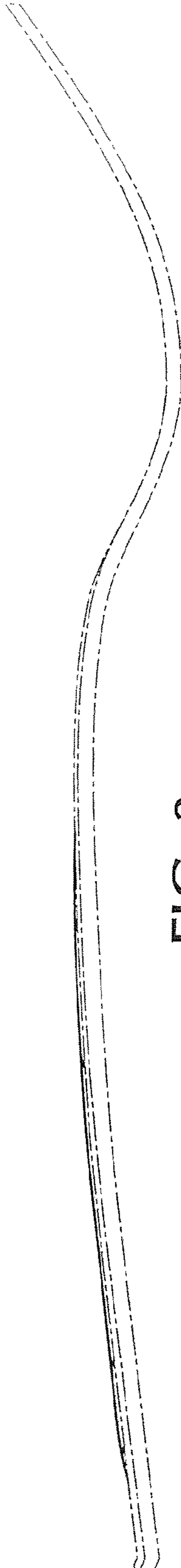

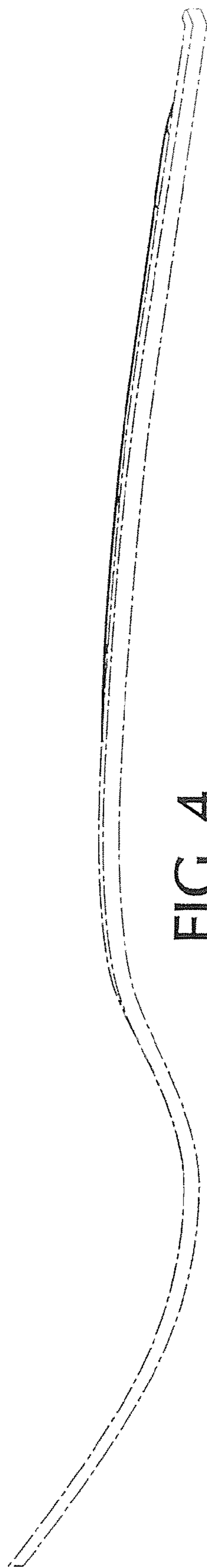

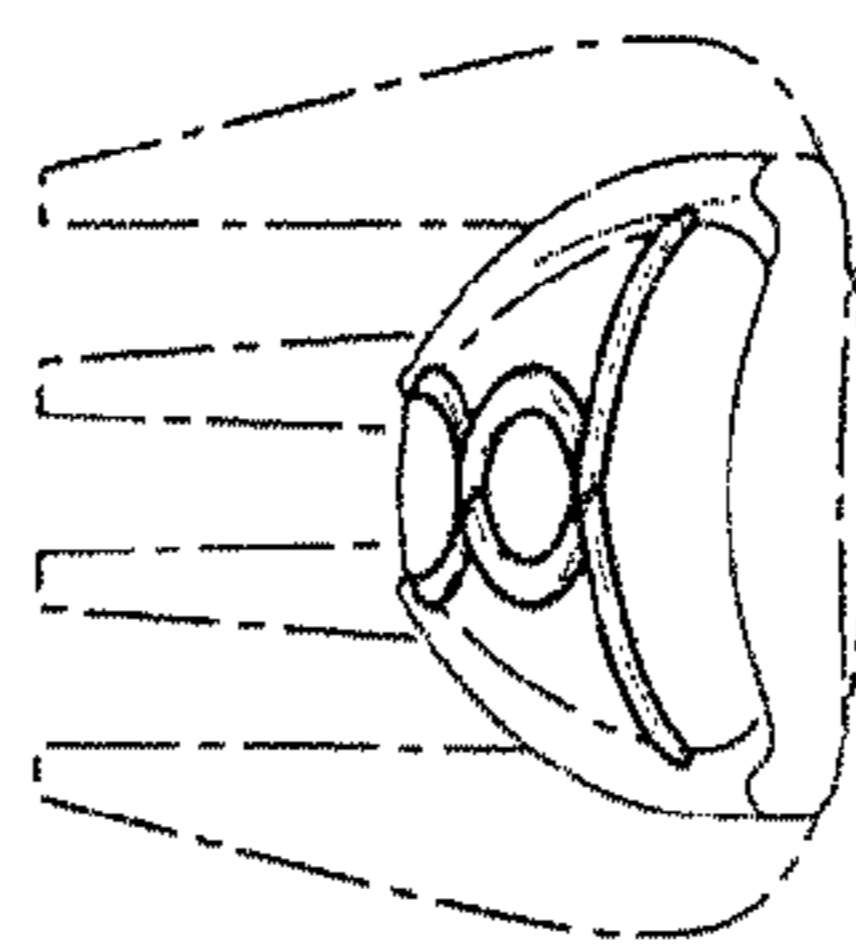

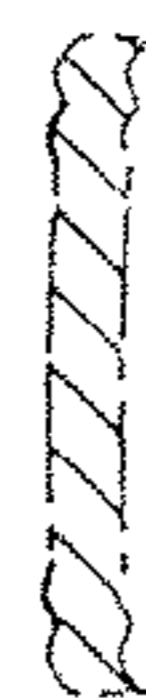

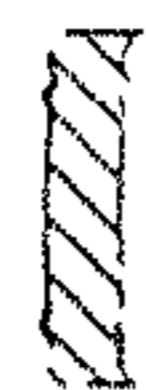
