**DESCRIPTION**

FIG. 1 is a top, rear and left side perspective of a mixing bowl showing our new design;

FIG. 3 is a top plan view thereof;

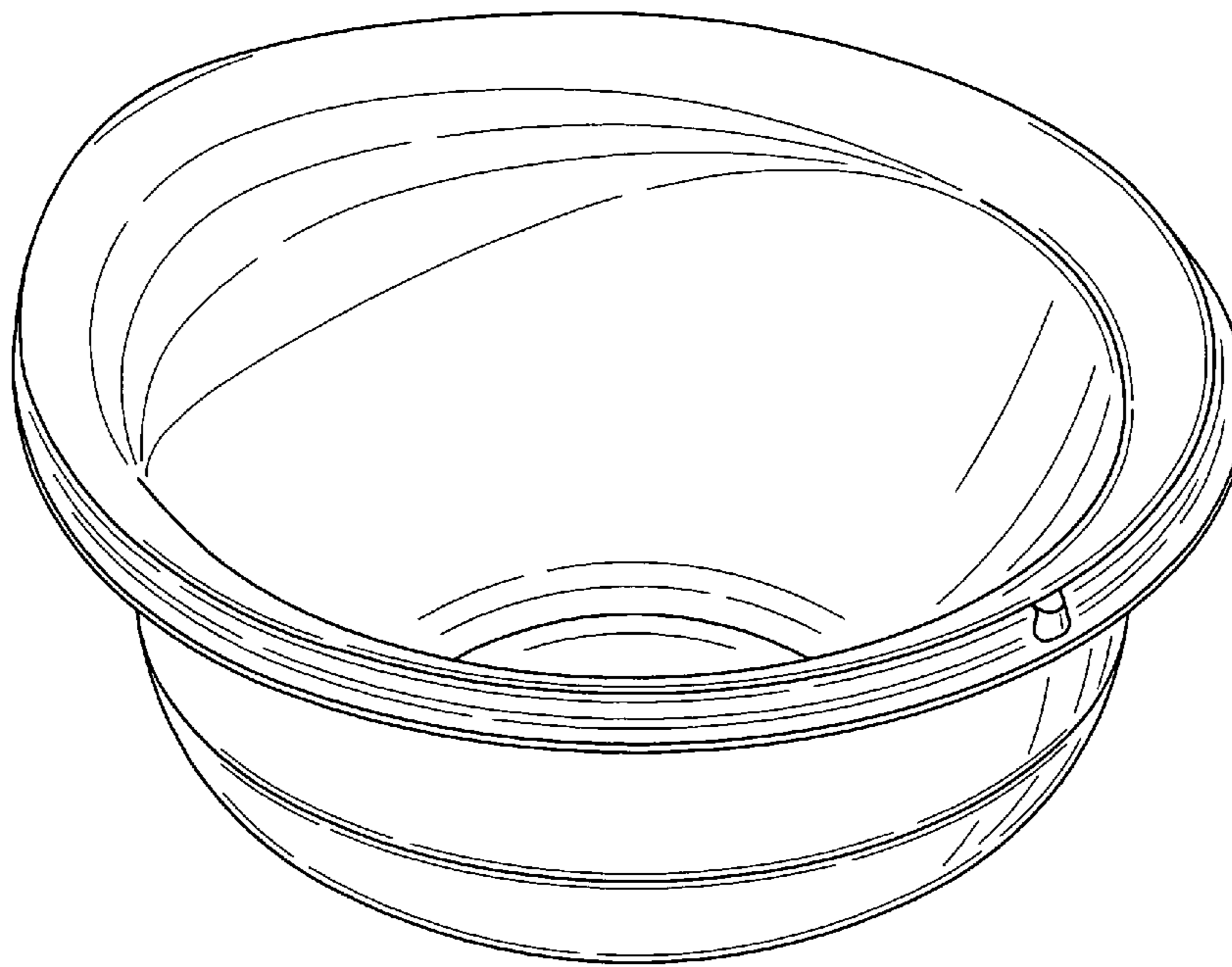
FIG. 4 is a bottom plan view thereof;

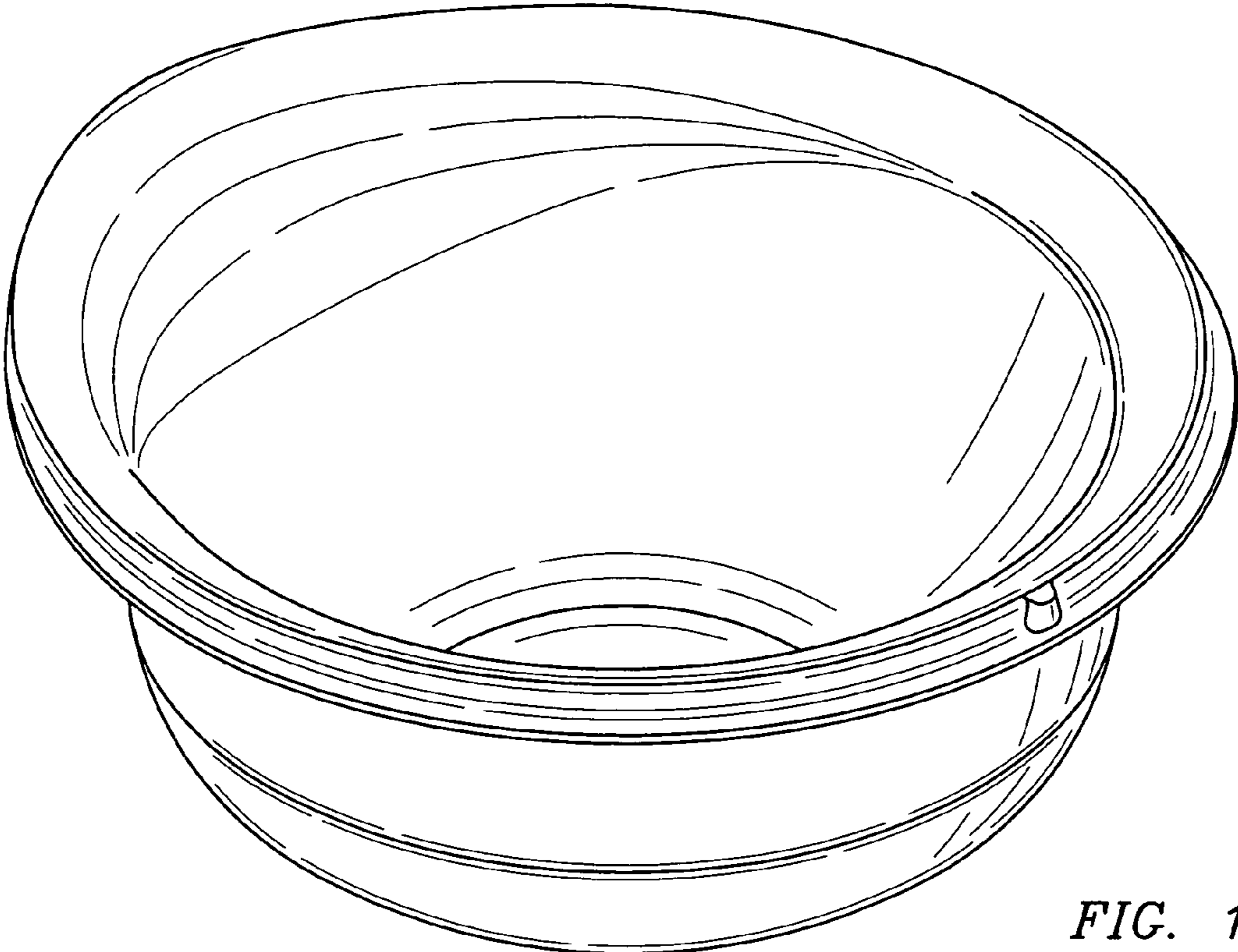

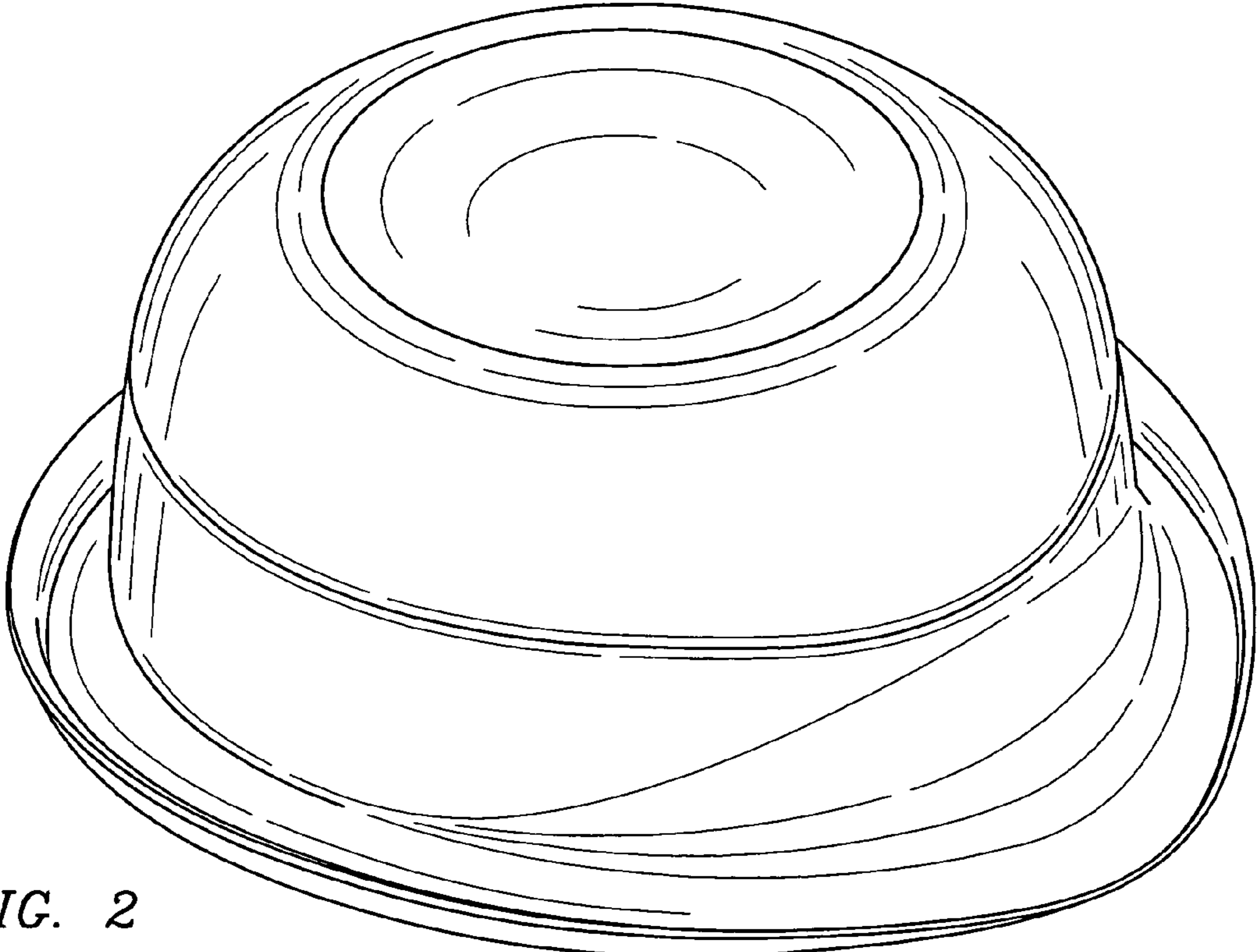
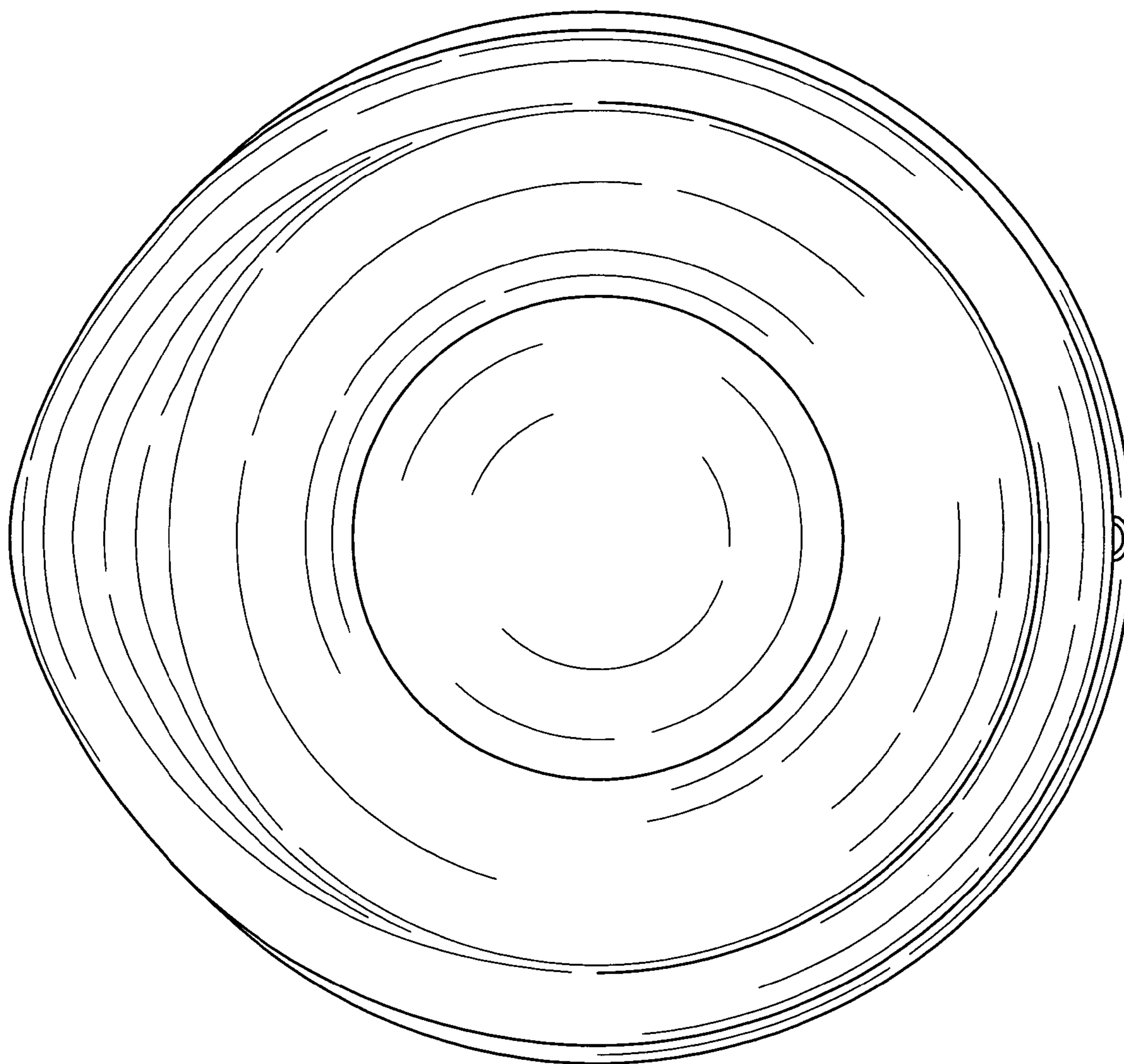
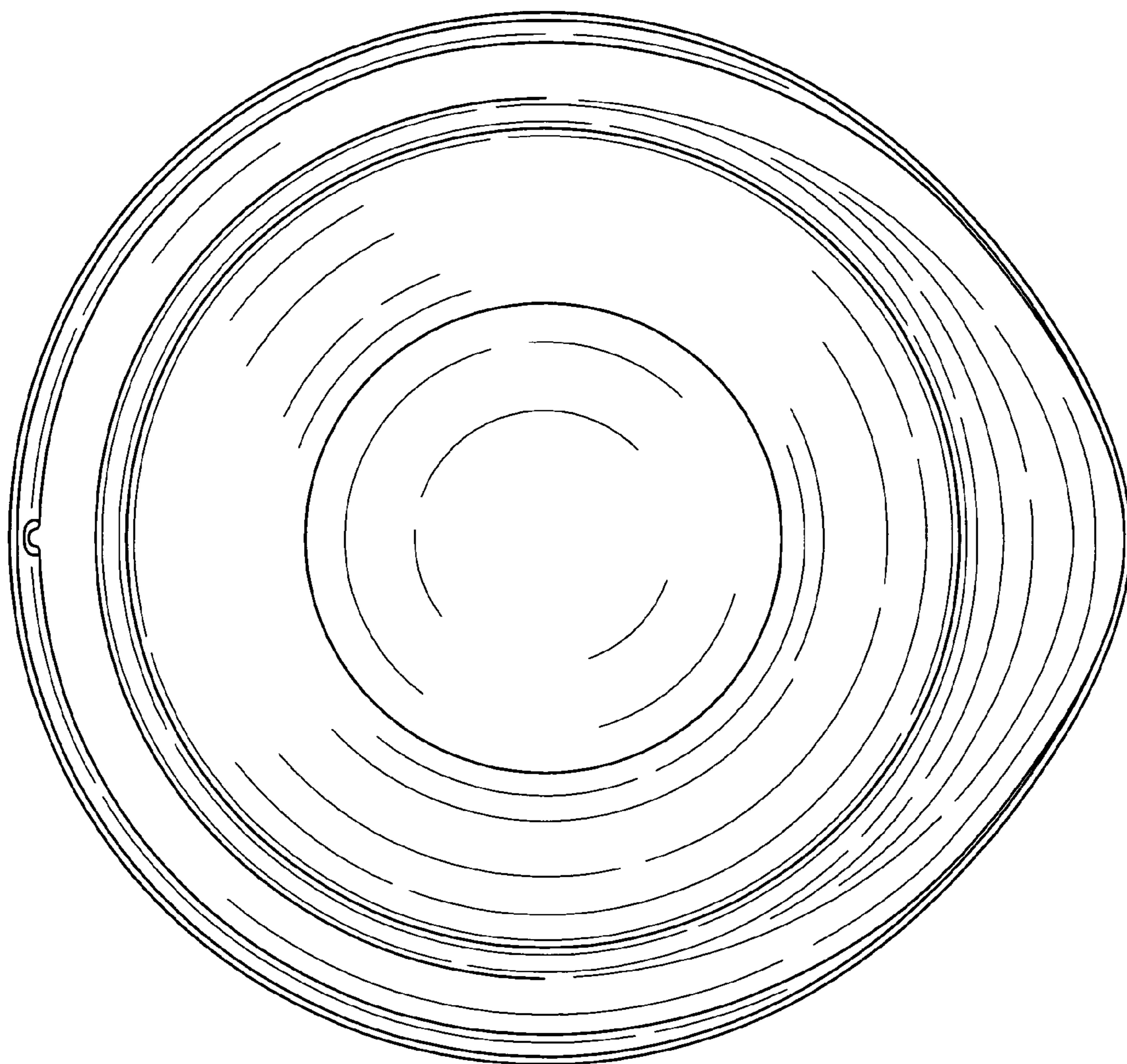

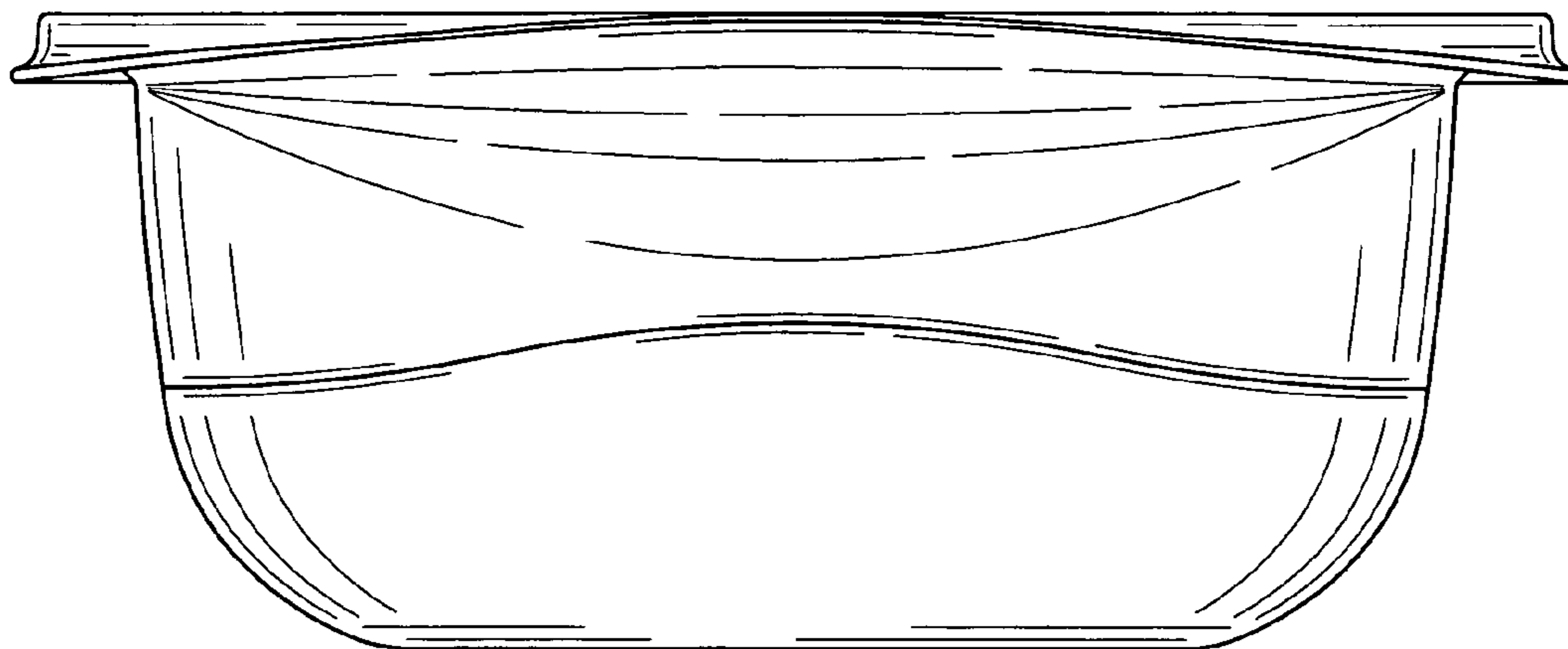

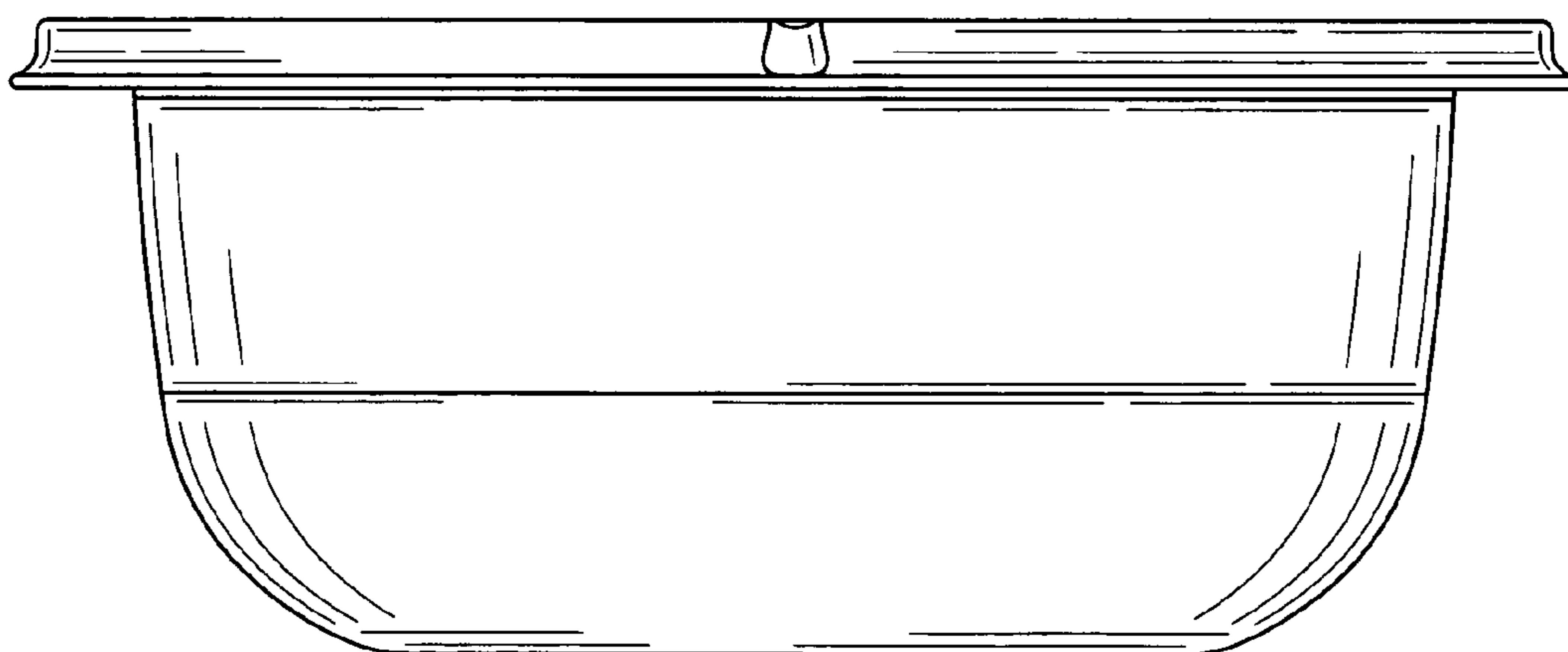

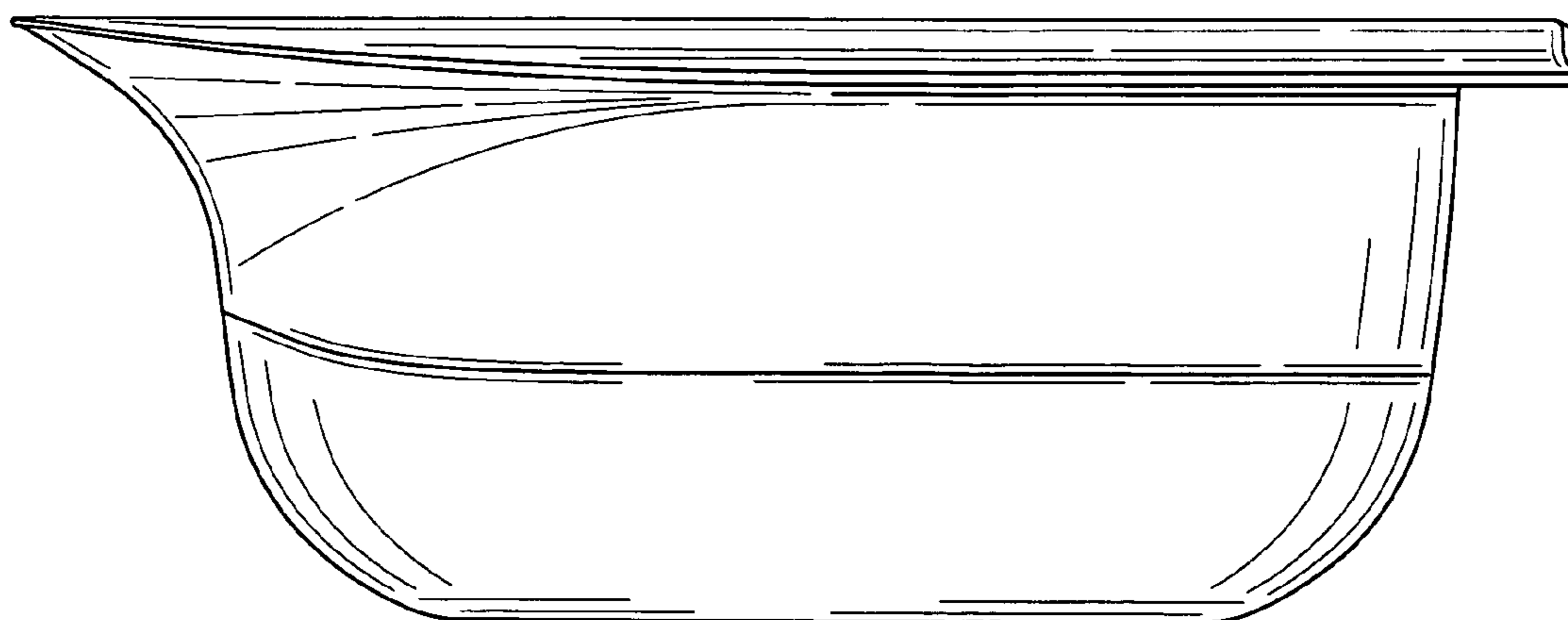
