FIG. 11 is a rear view of FIG. 7;

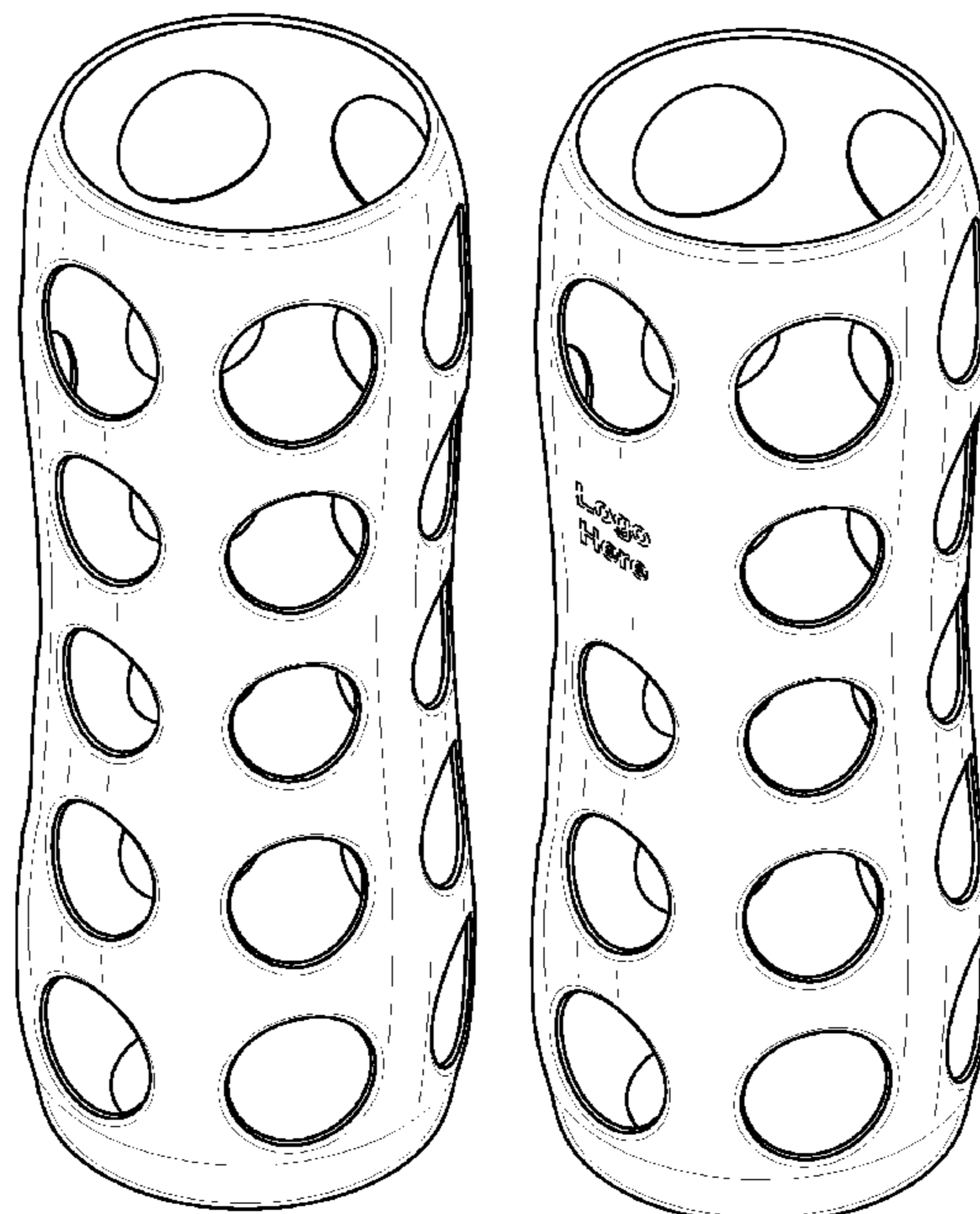
FIG. 12 is a left side view of FIG. 7;

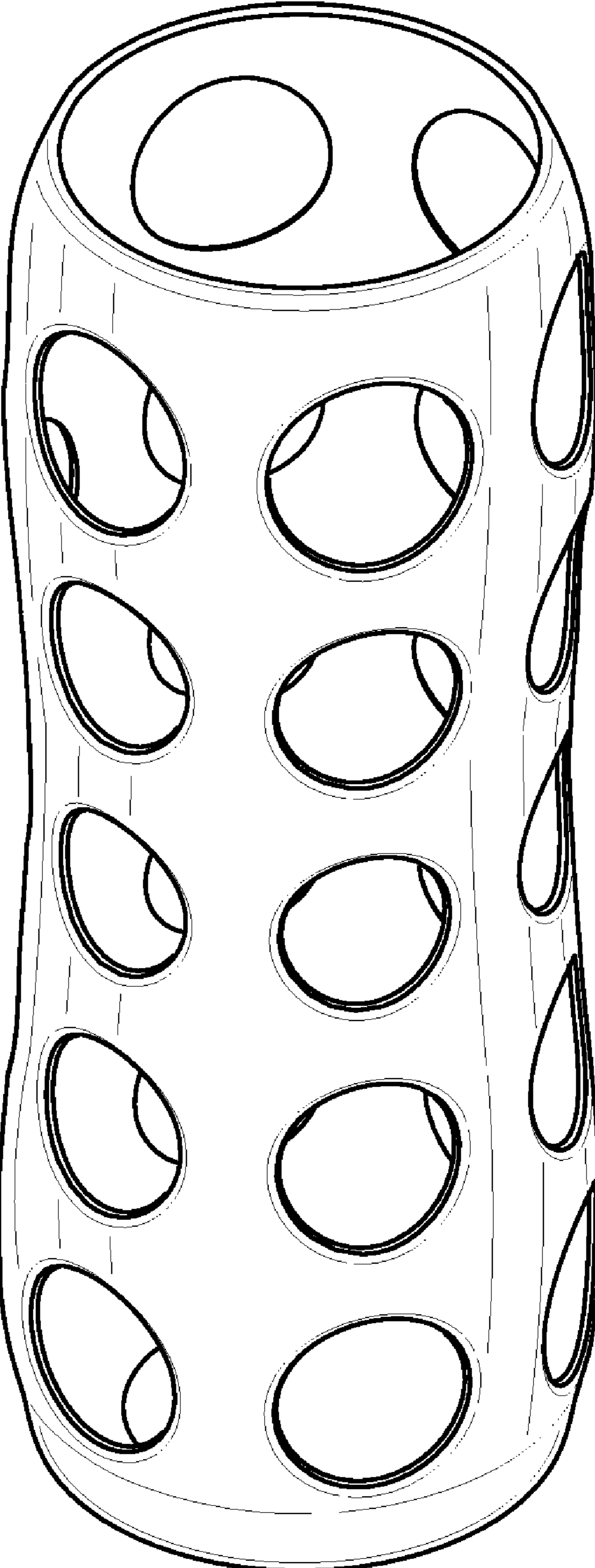

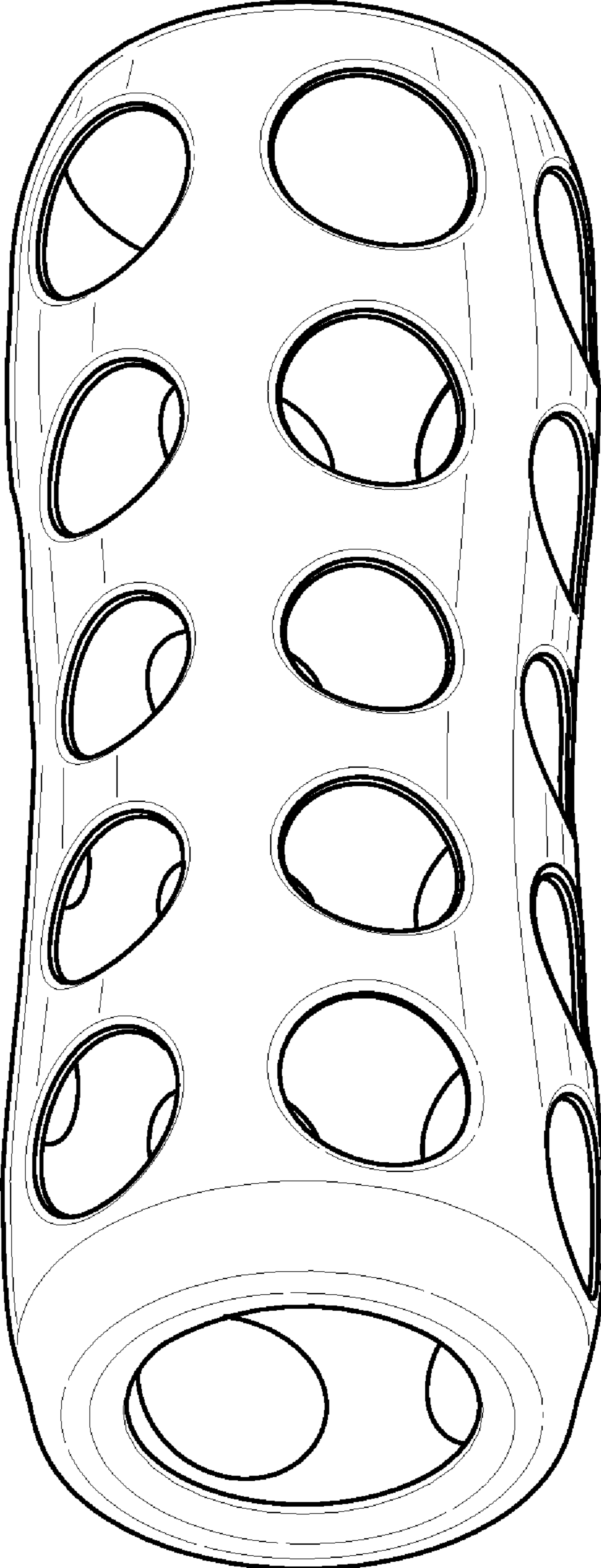

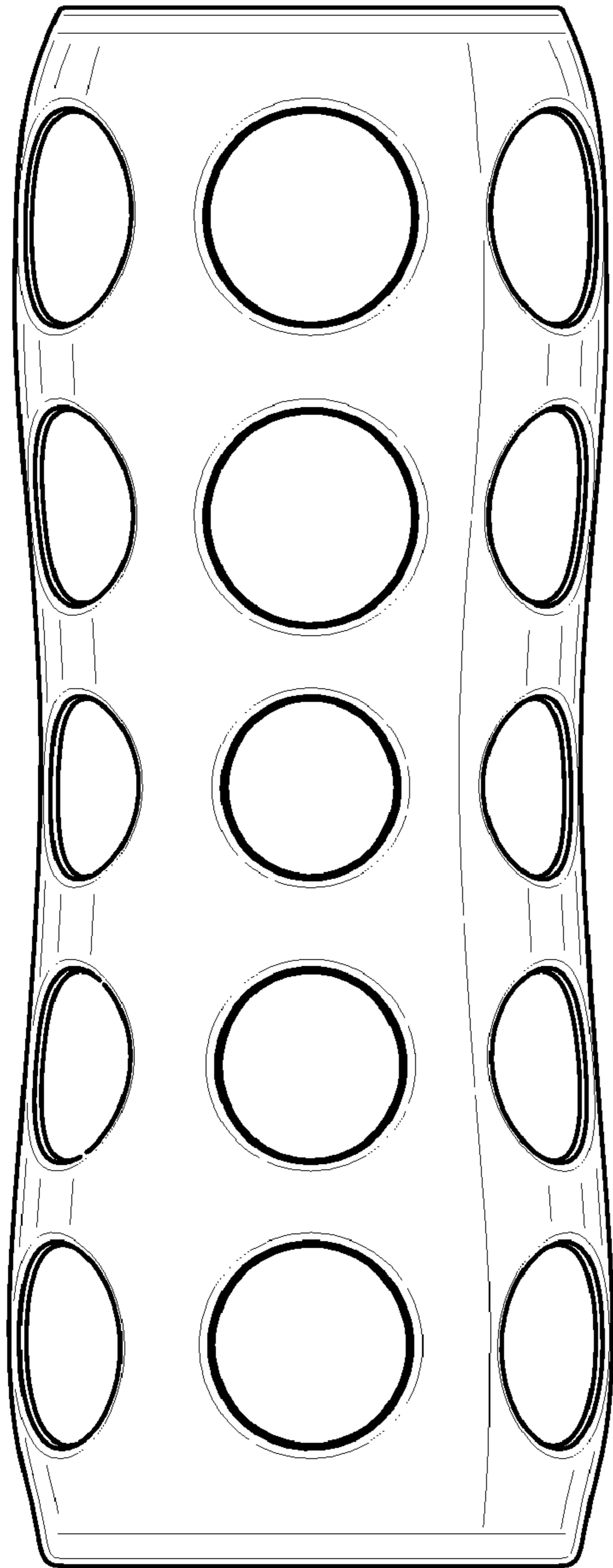

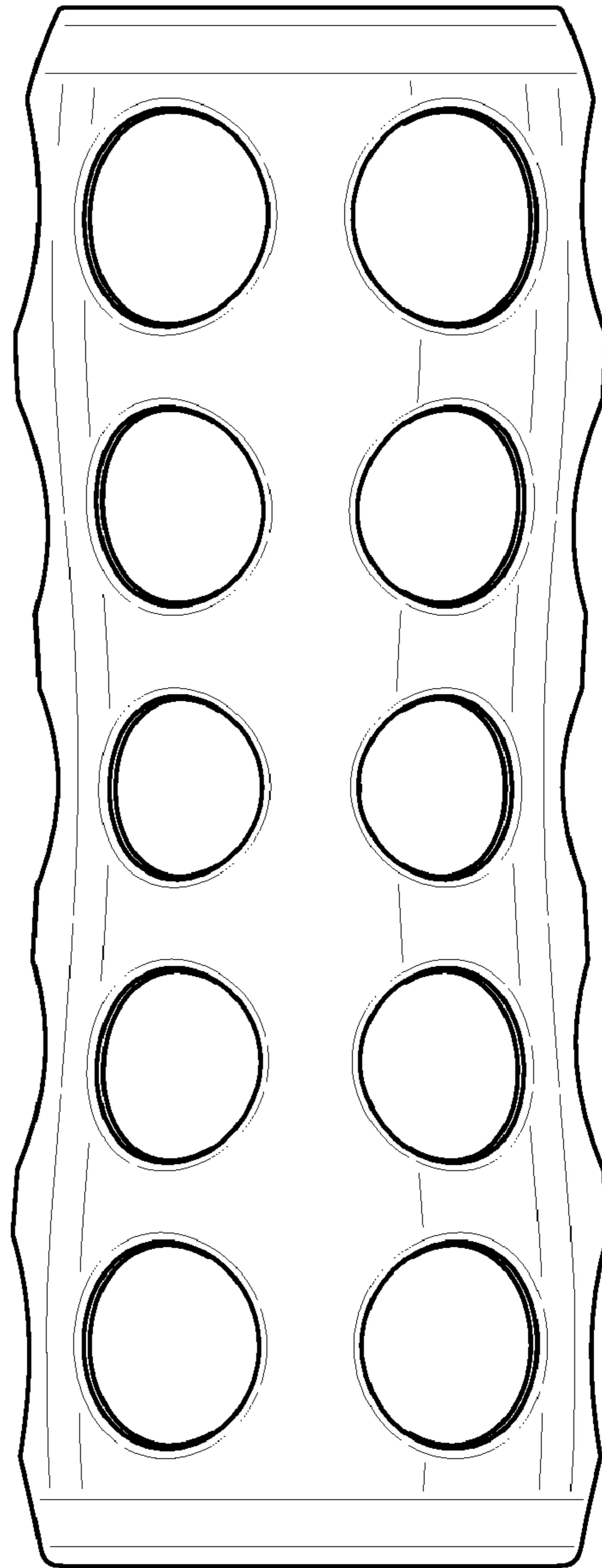

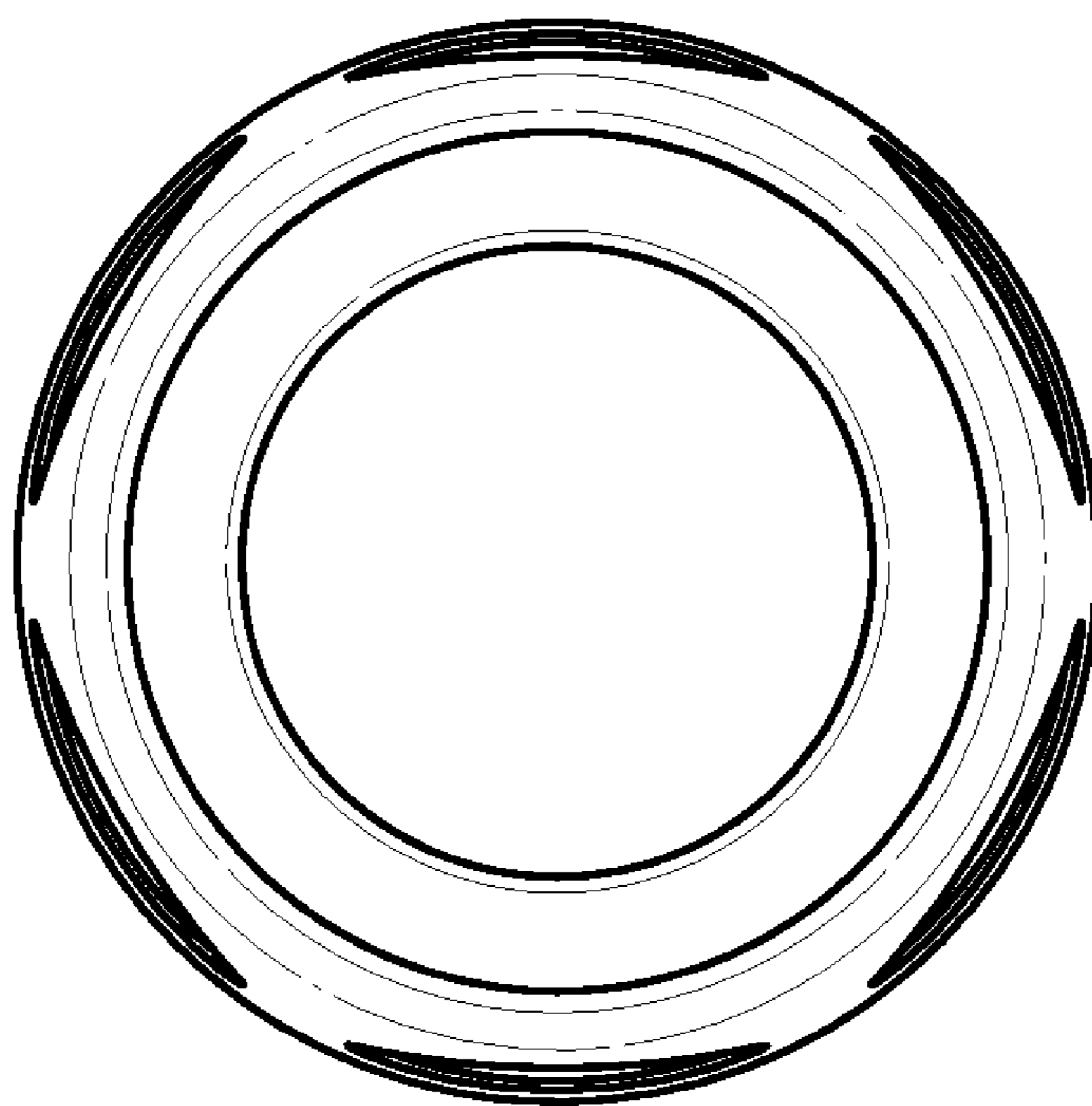

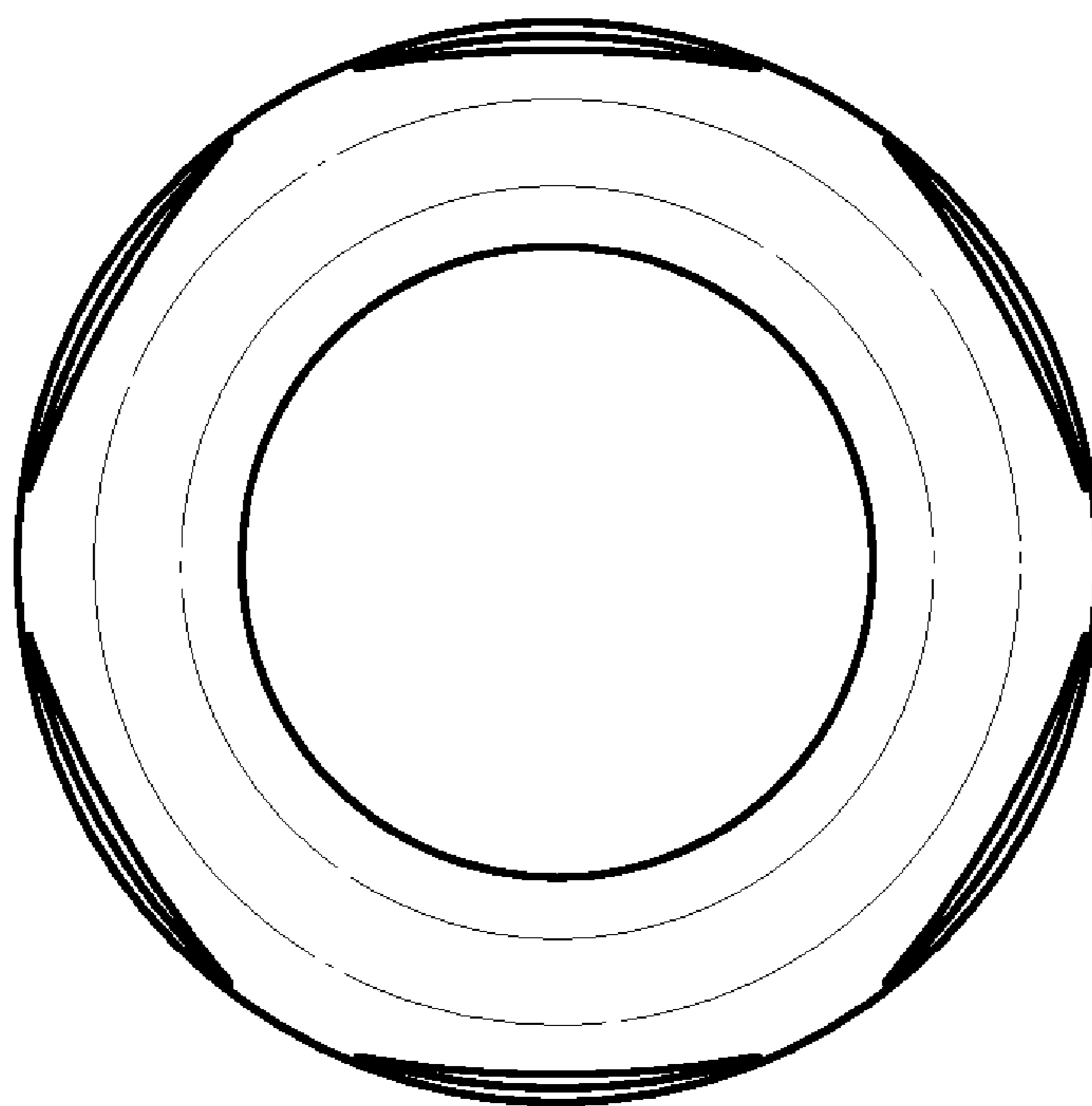

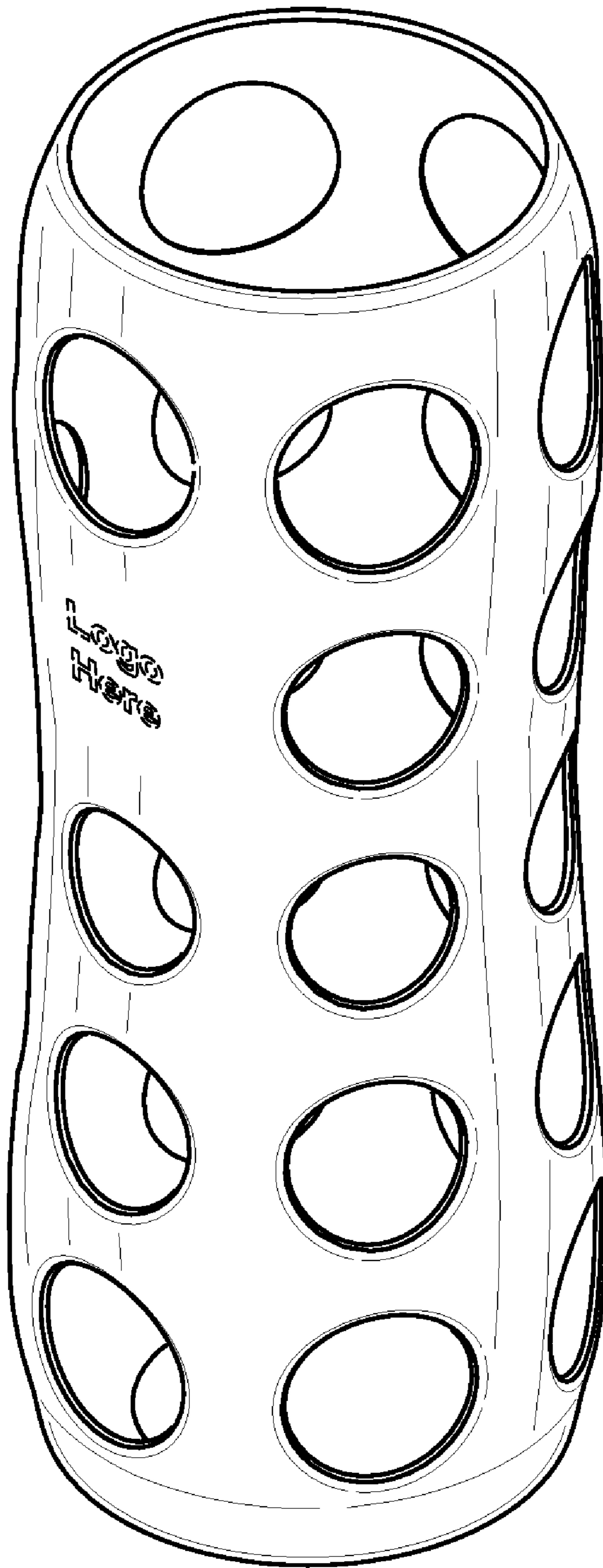

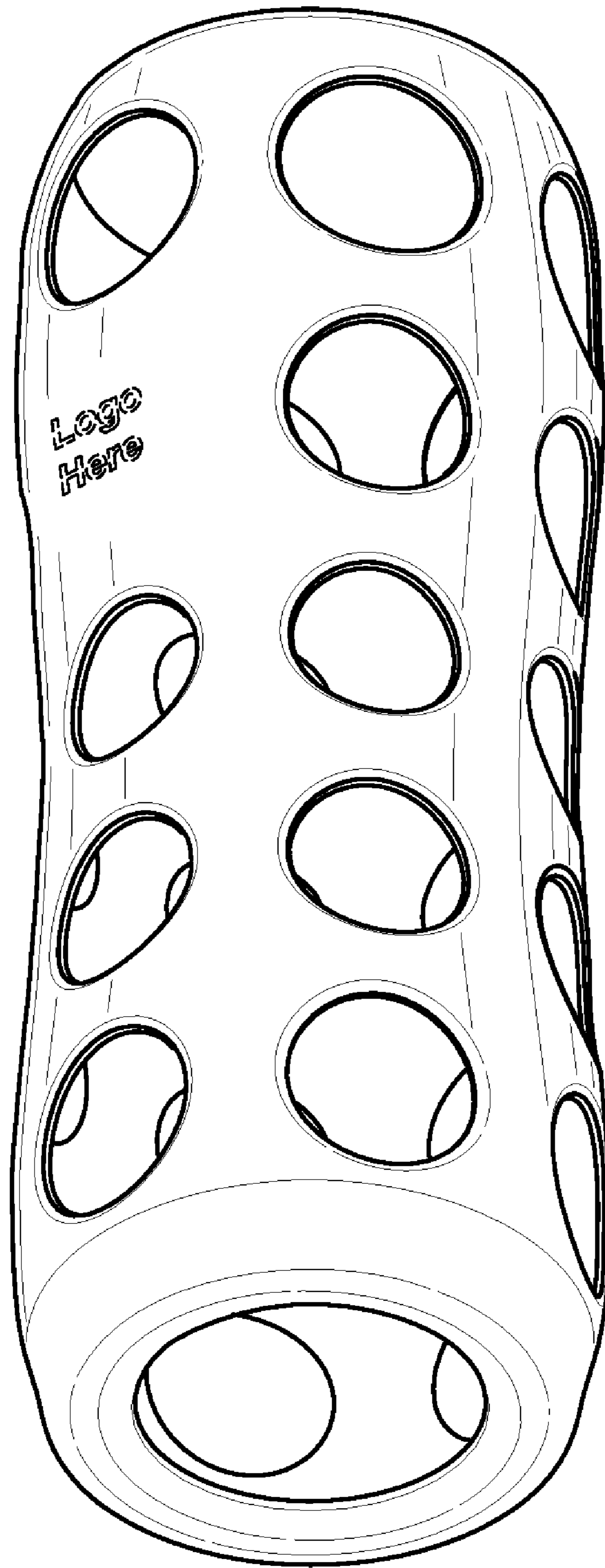

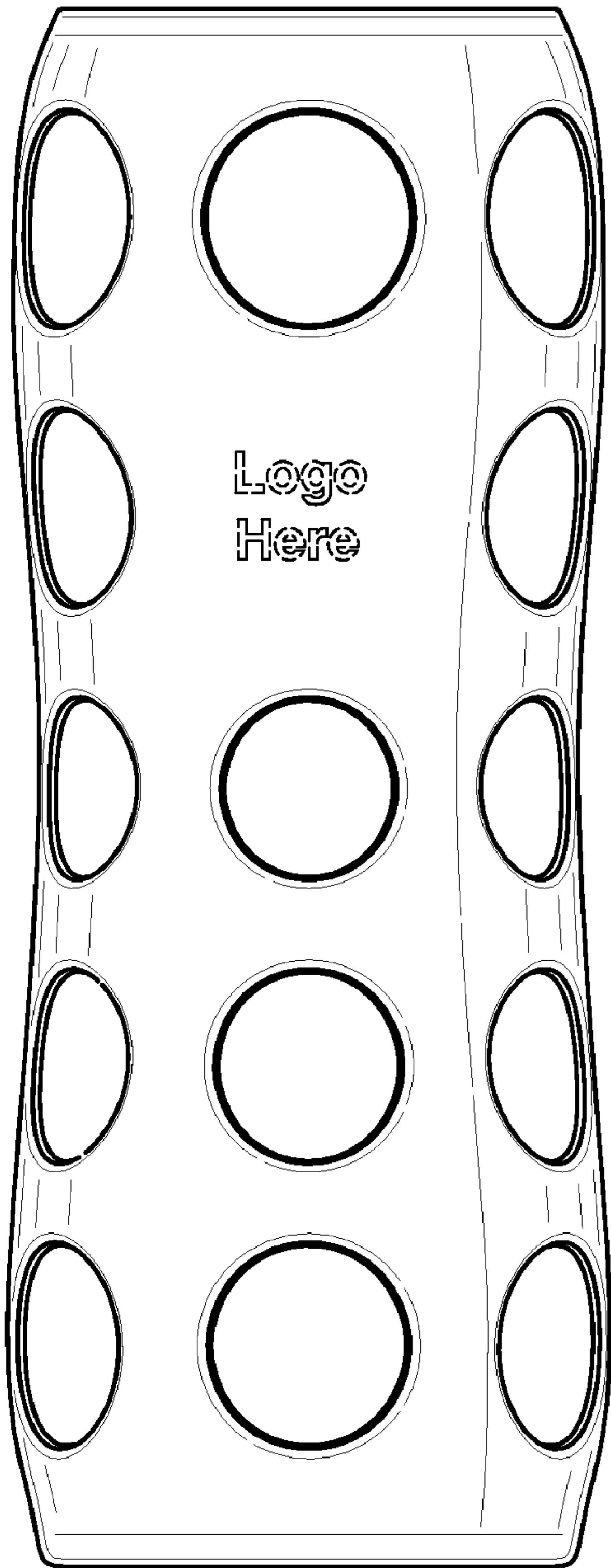

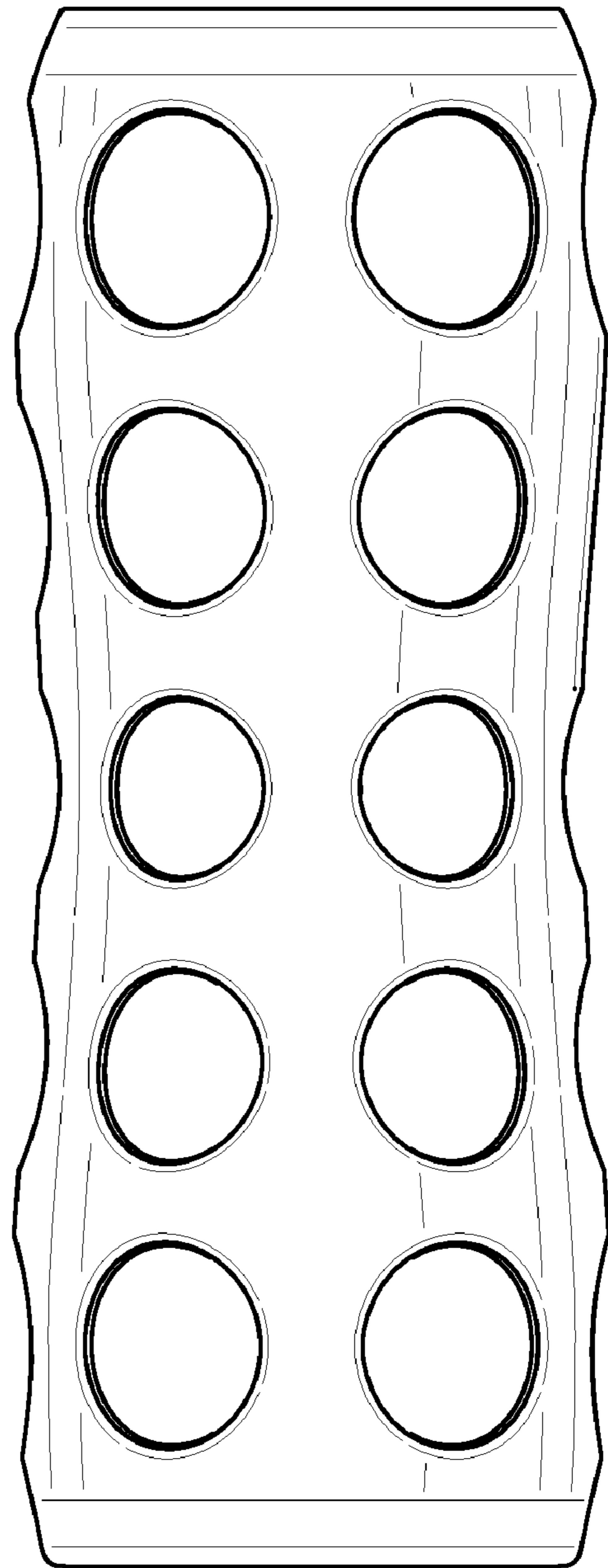

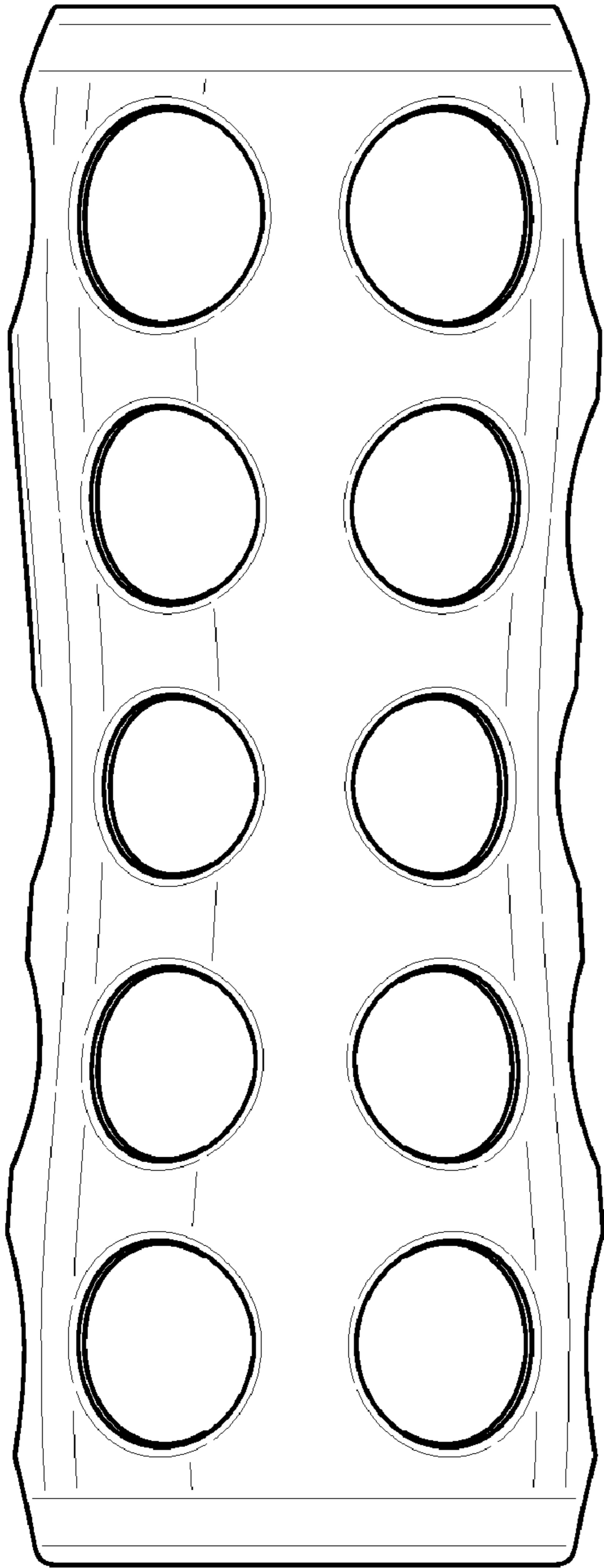

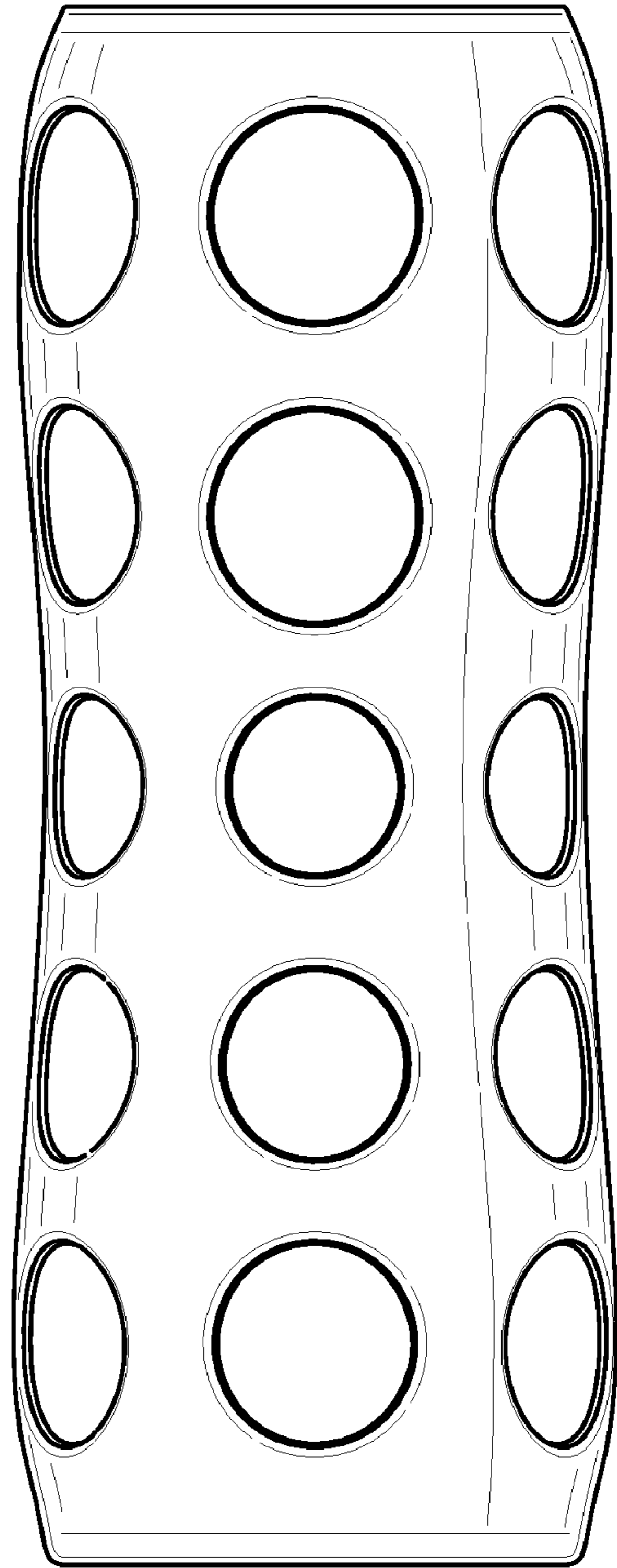

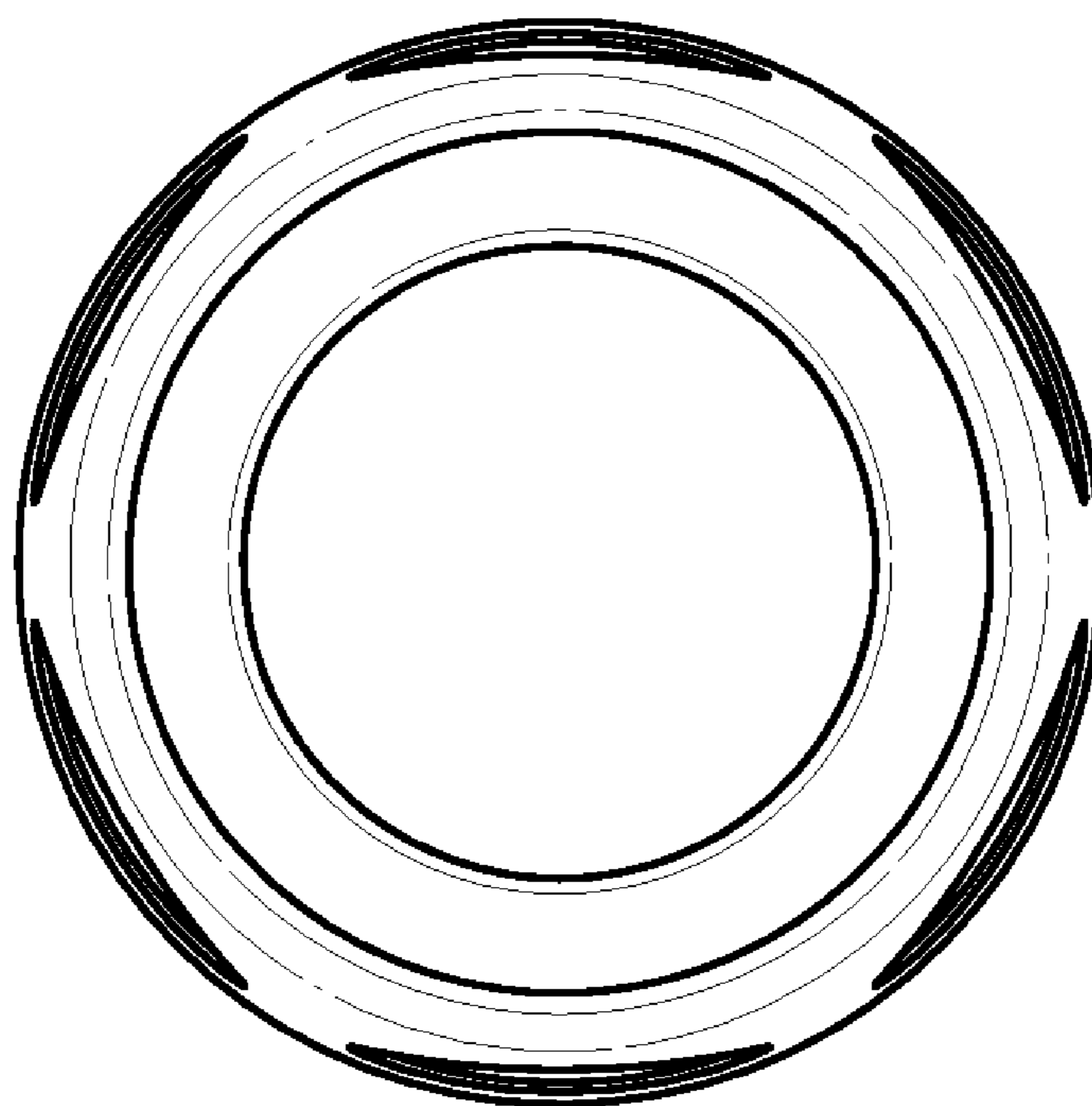

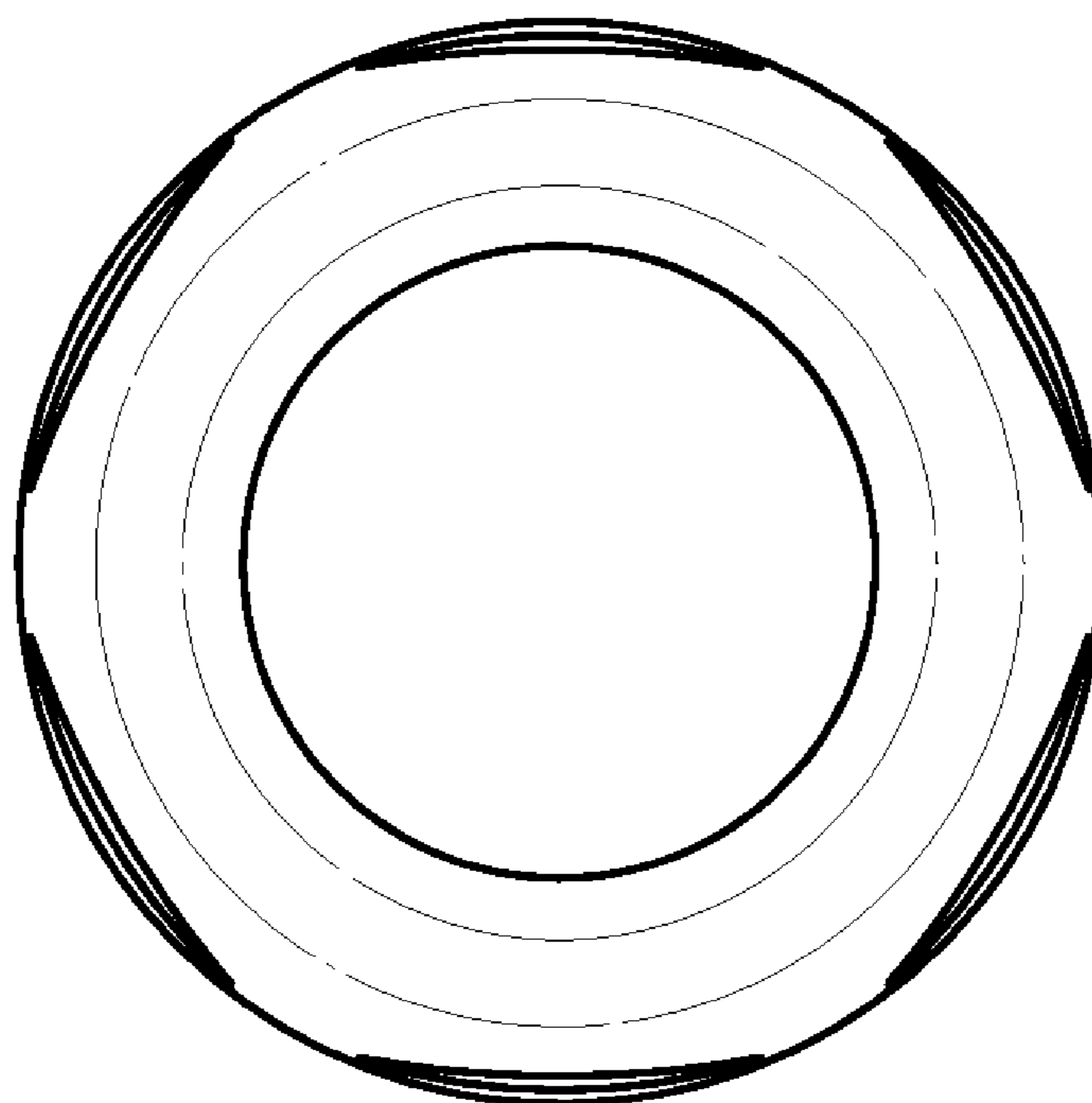
