(57) **CLAIM**

The ornamental design for a “combined bottle, cap, pouring mechanism and interior temperature regulating mechanism,” as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the combined bottle, cap, pouring mechanism and interior temperature mechanism showing my new design;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a left side elevation view thereof;

FIG. 5 is a right side elevation view thereof;

FIG. 6 is a top plan view thereof;

FIG. 7 is a bottom plan view thereof;

FIG. 8 bottom plan view of the cap of the combined bottle, cap, pouring mechanism and interior temperature mechanism;

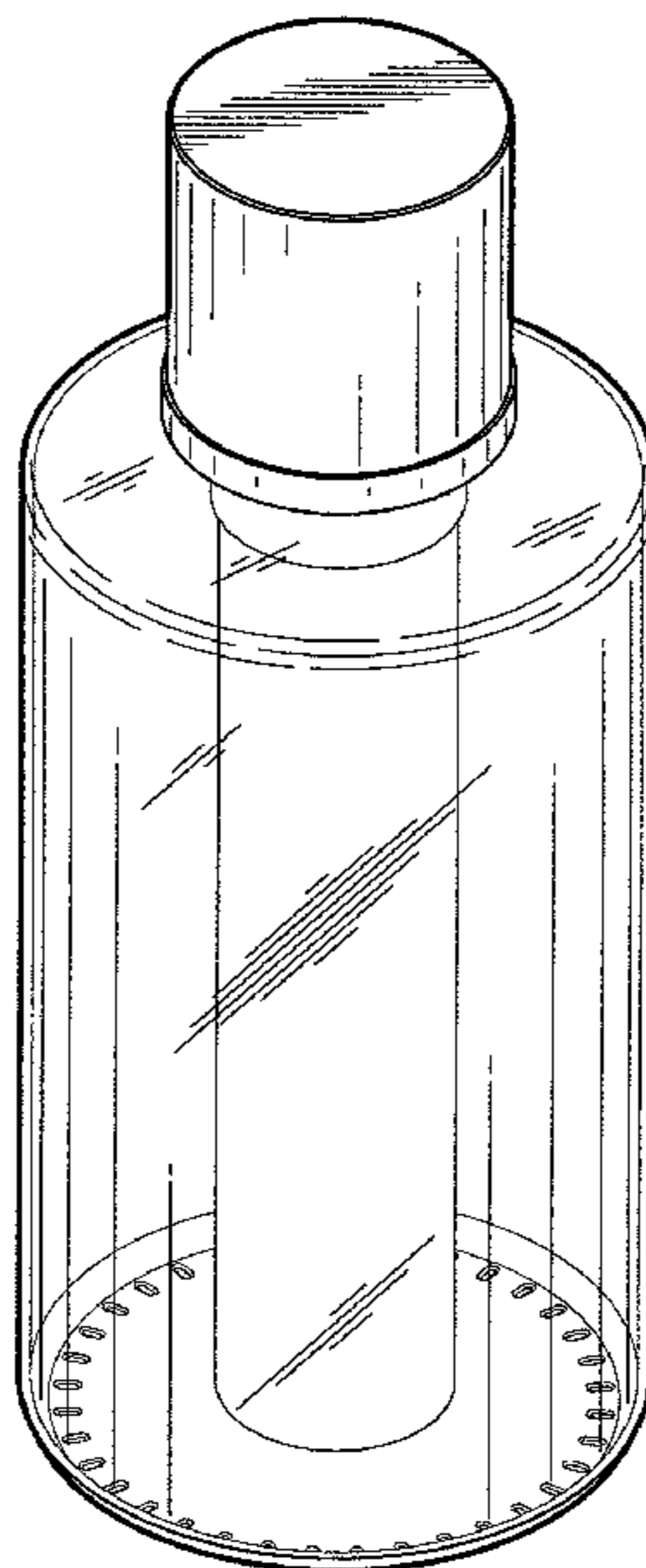
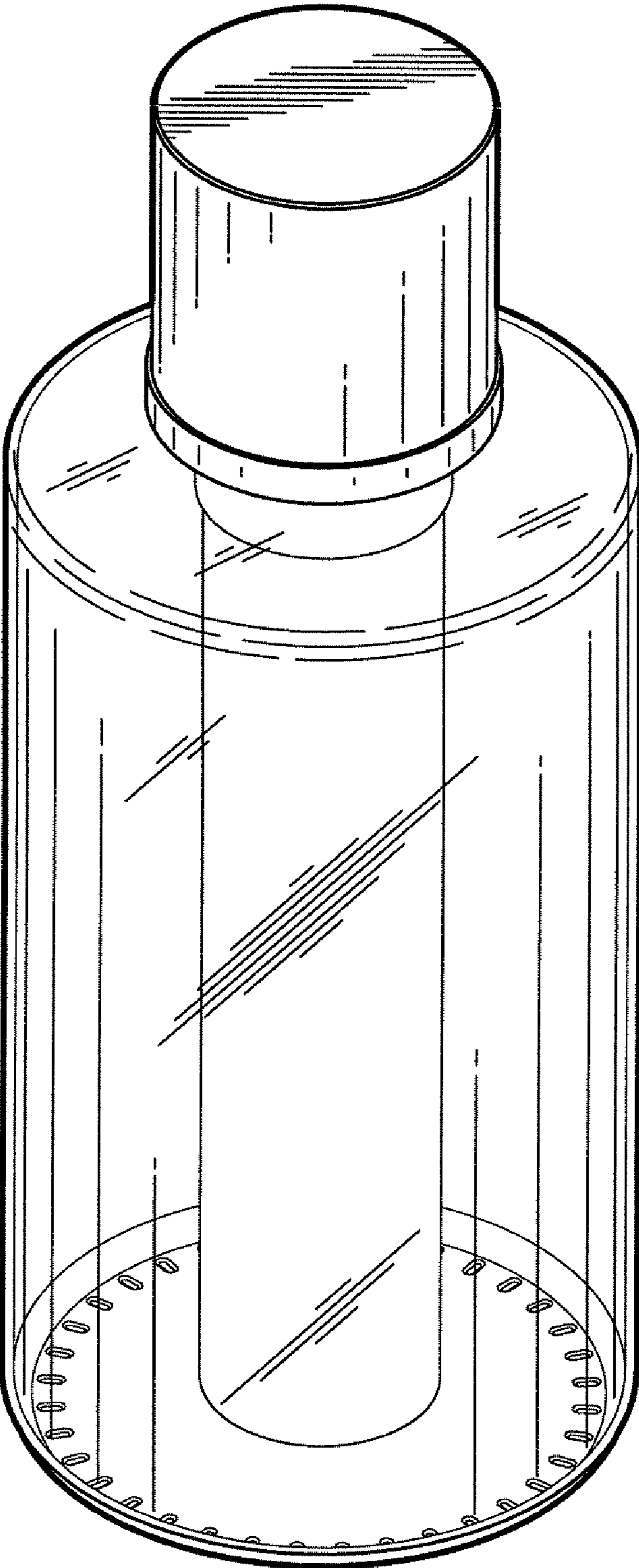

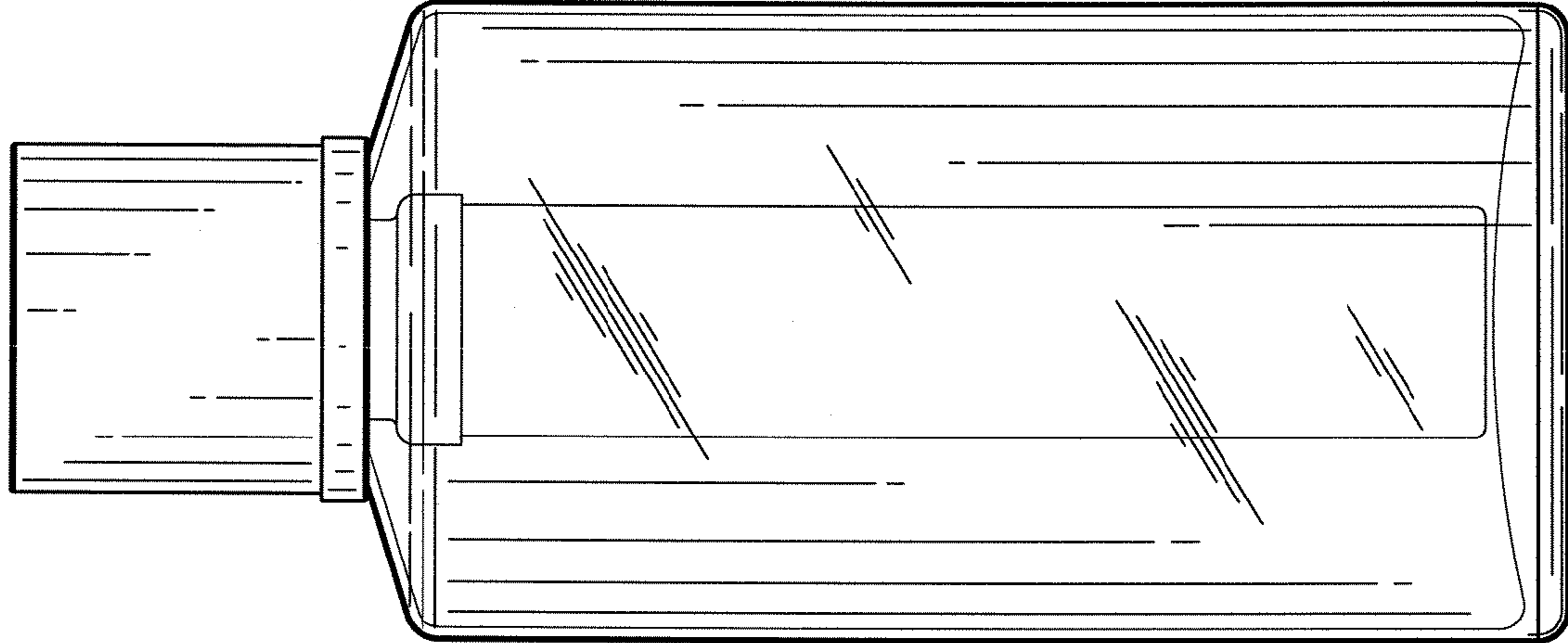

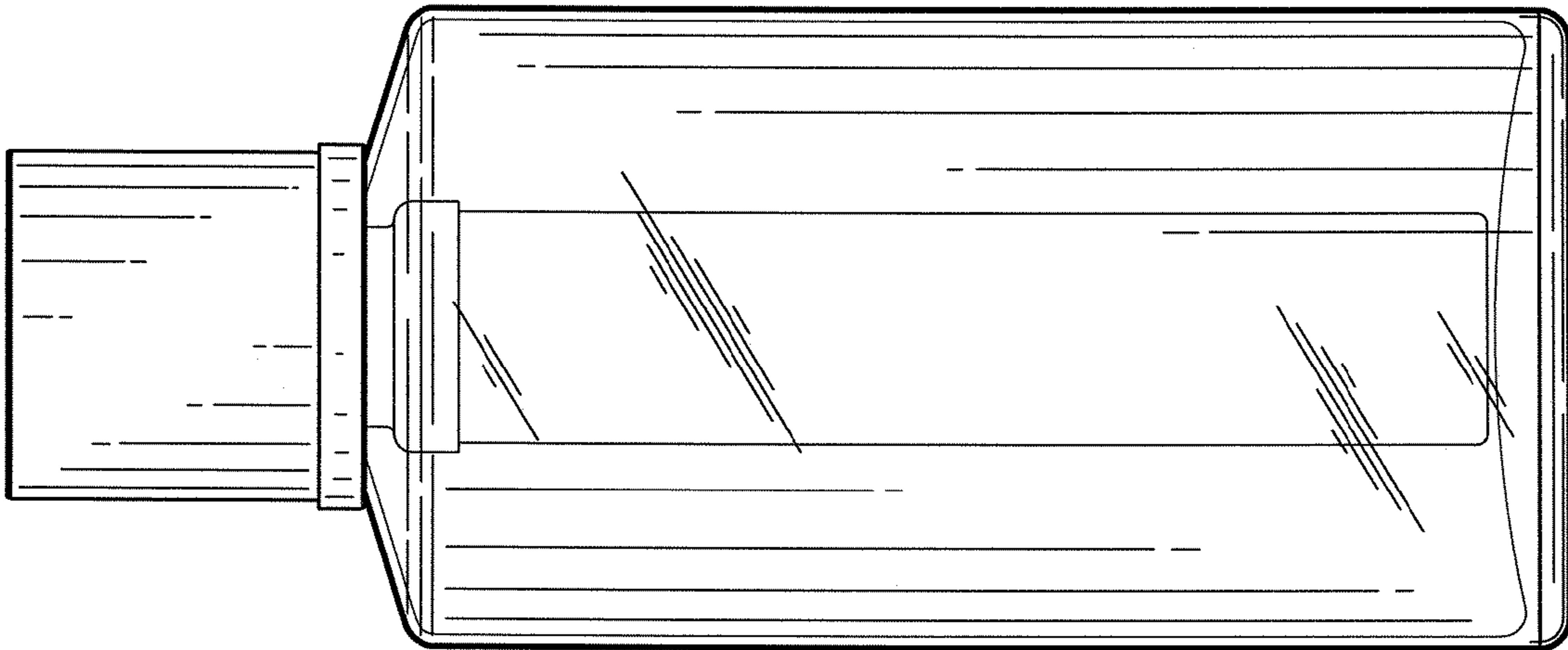

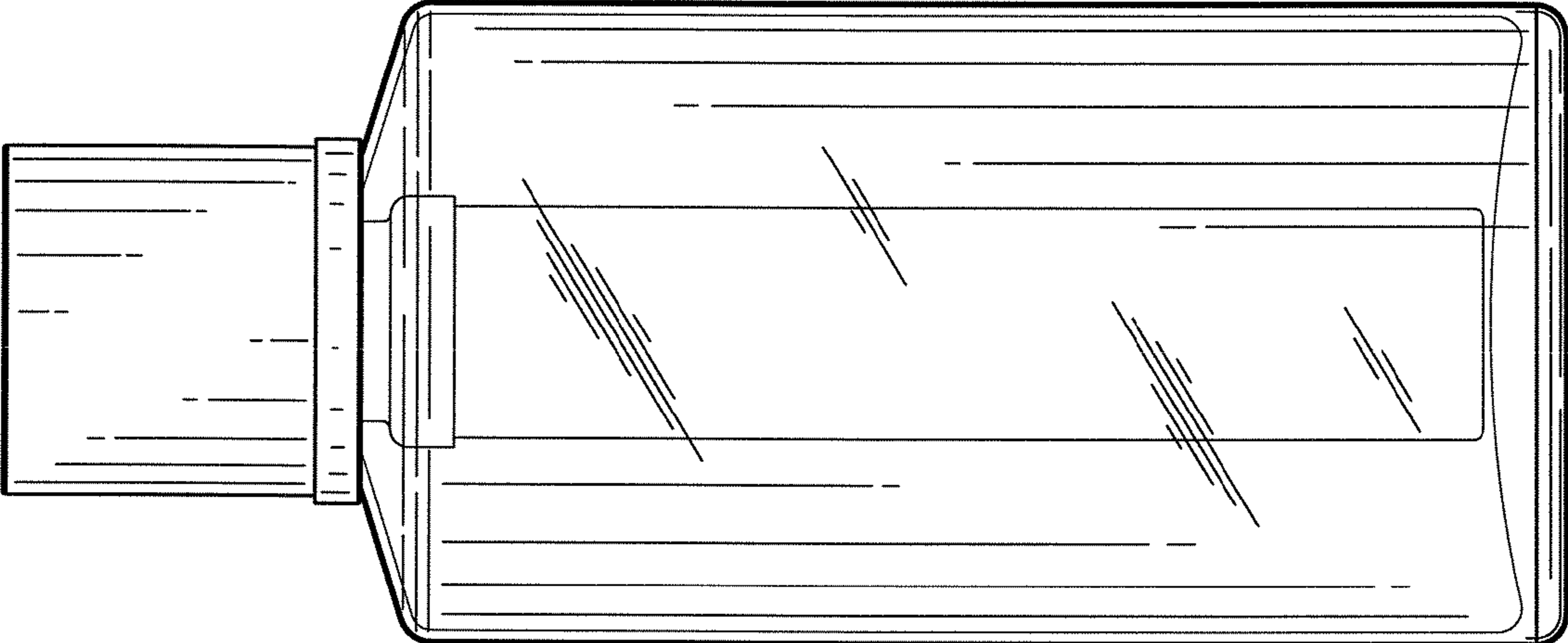

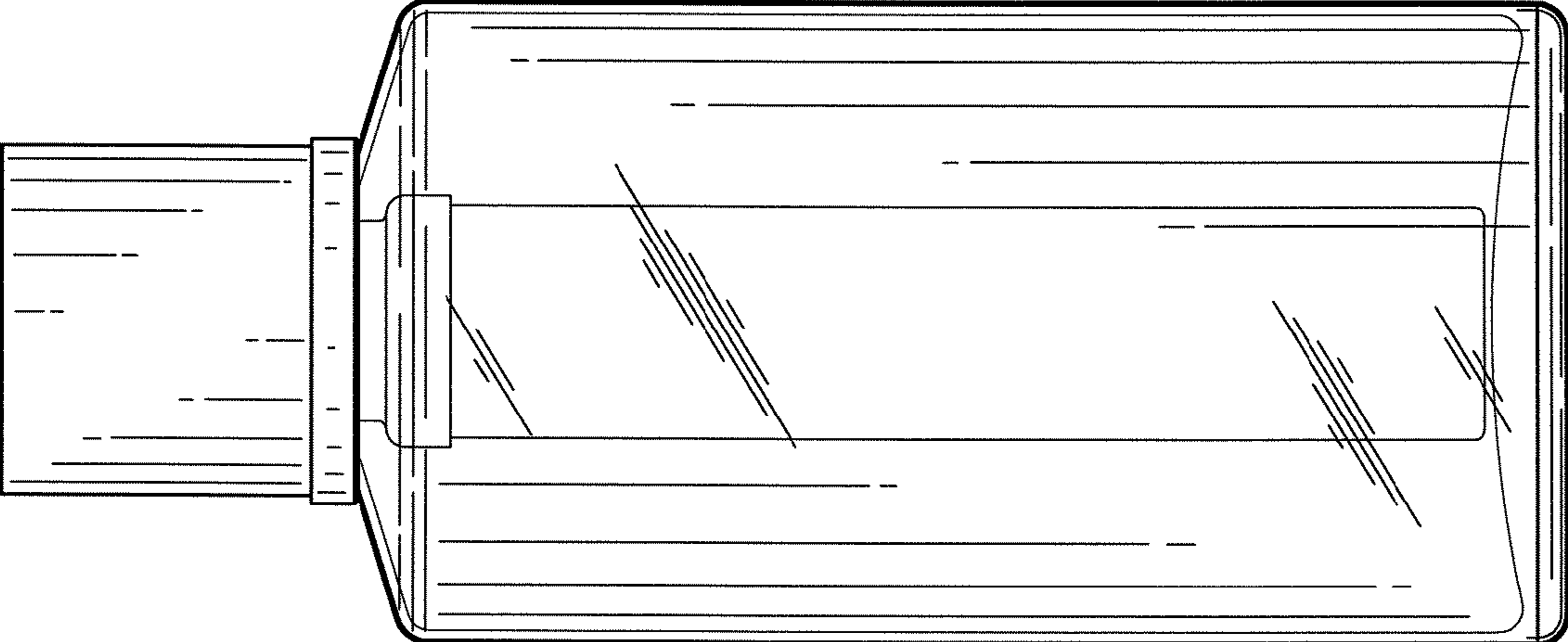

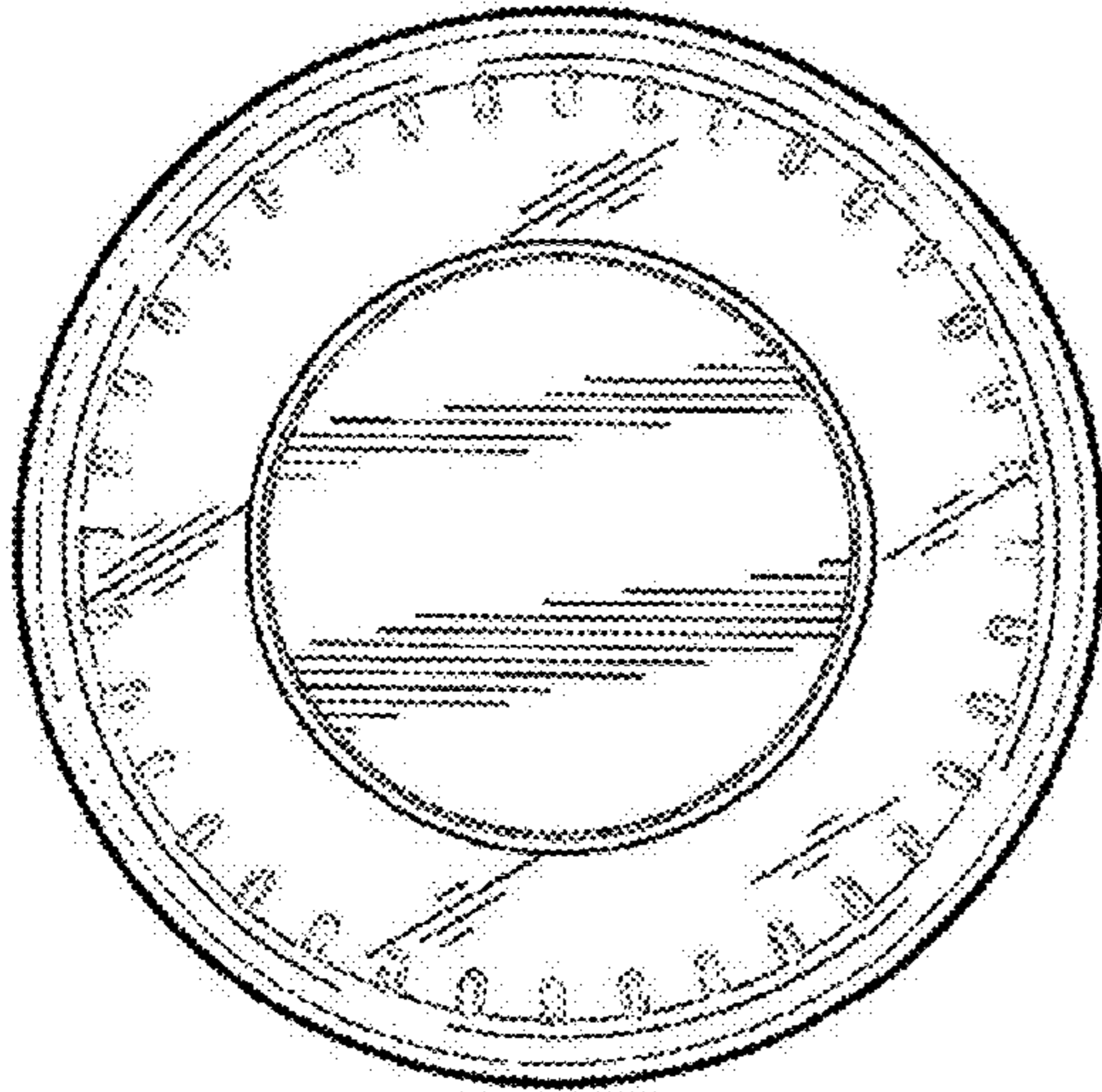

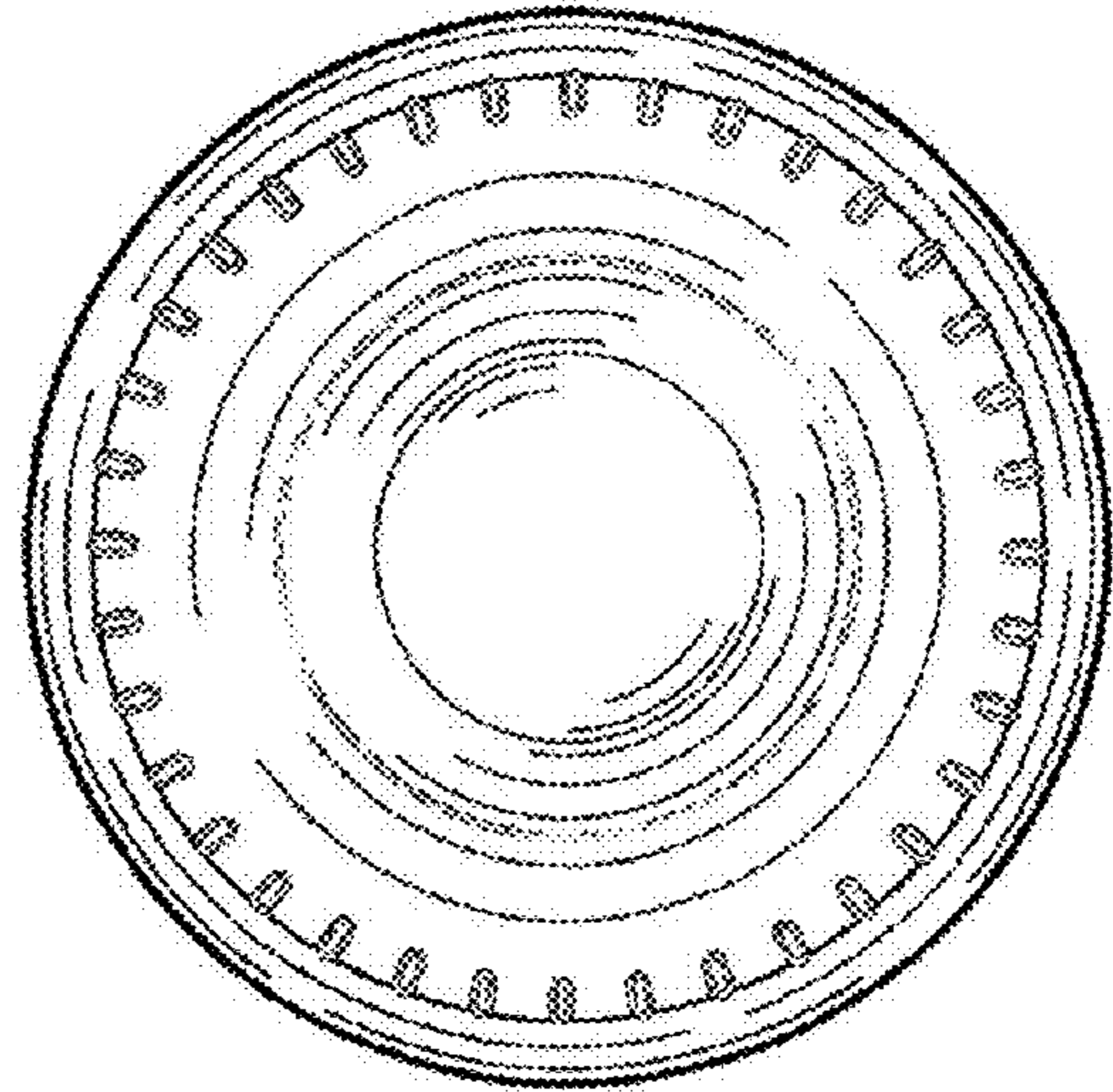

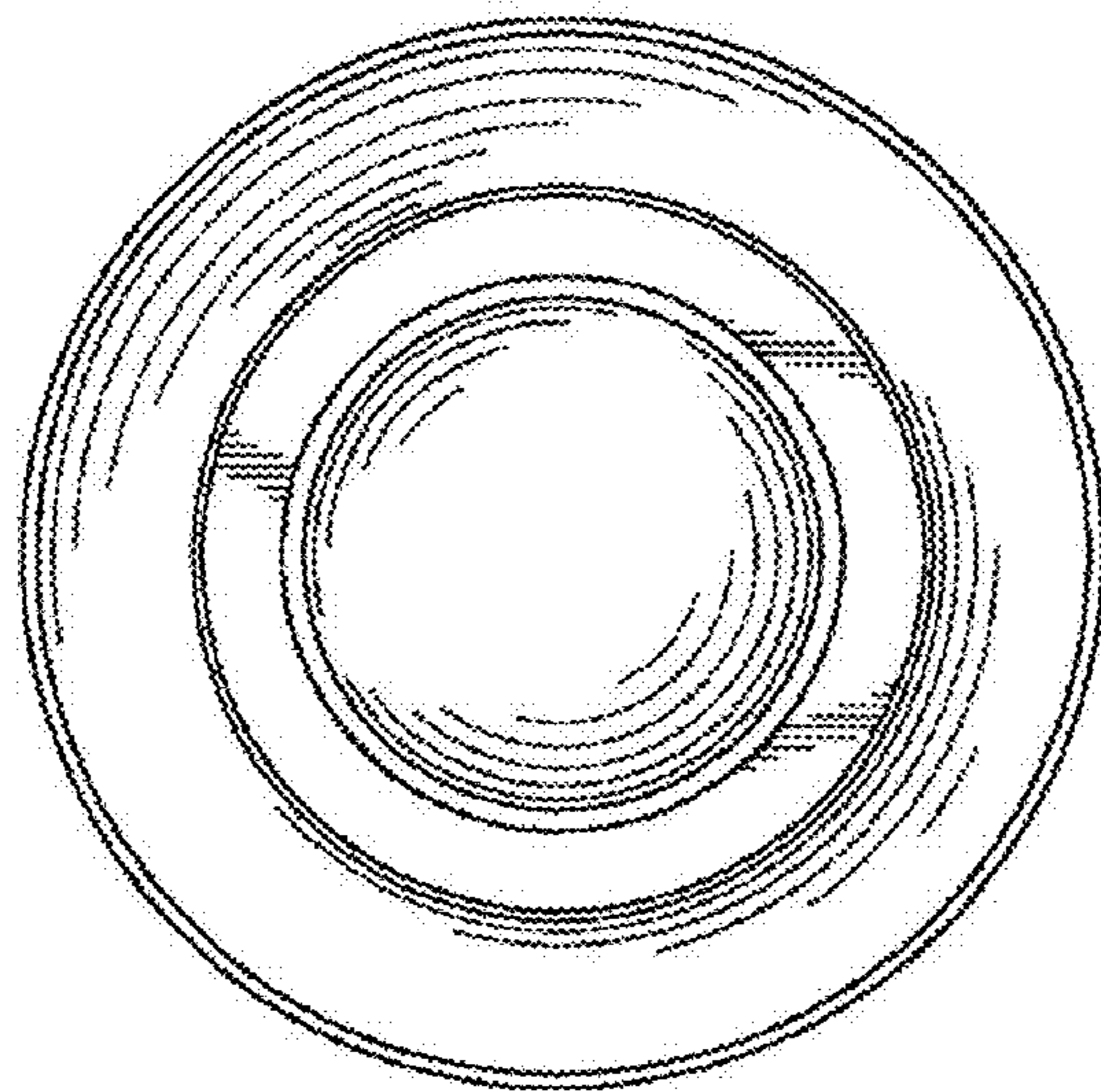

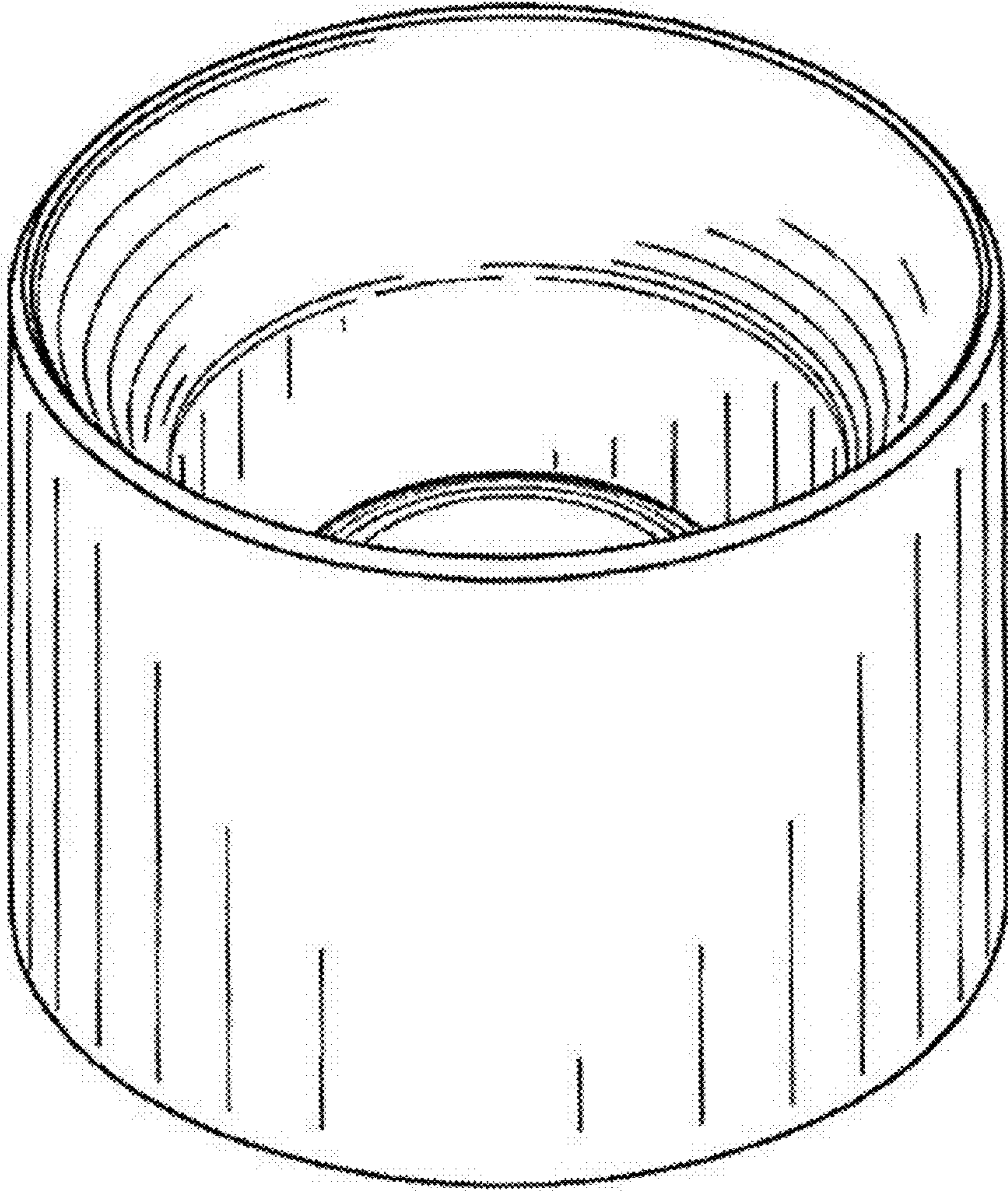
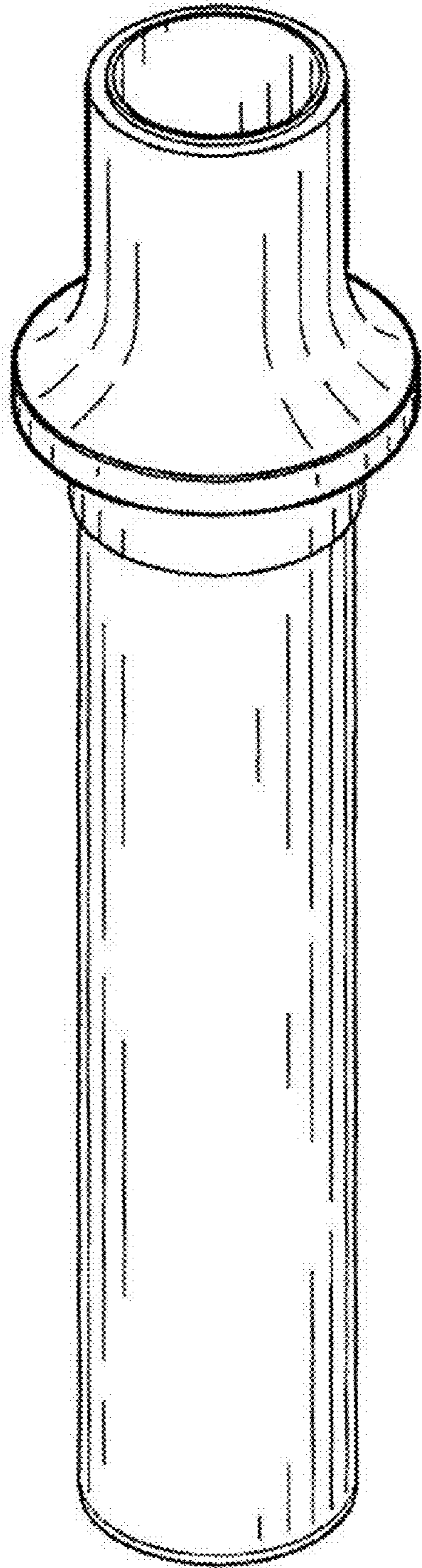

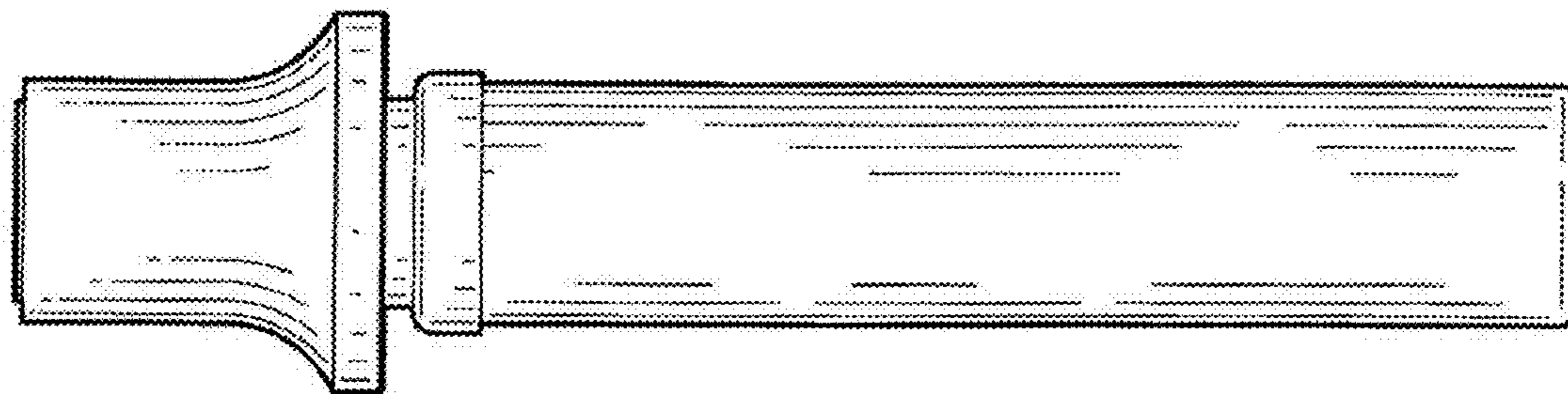

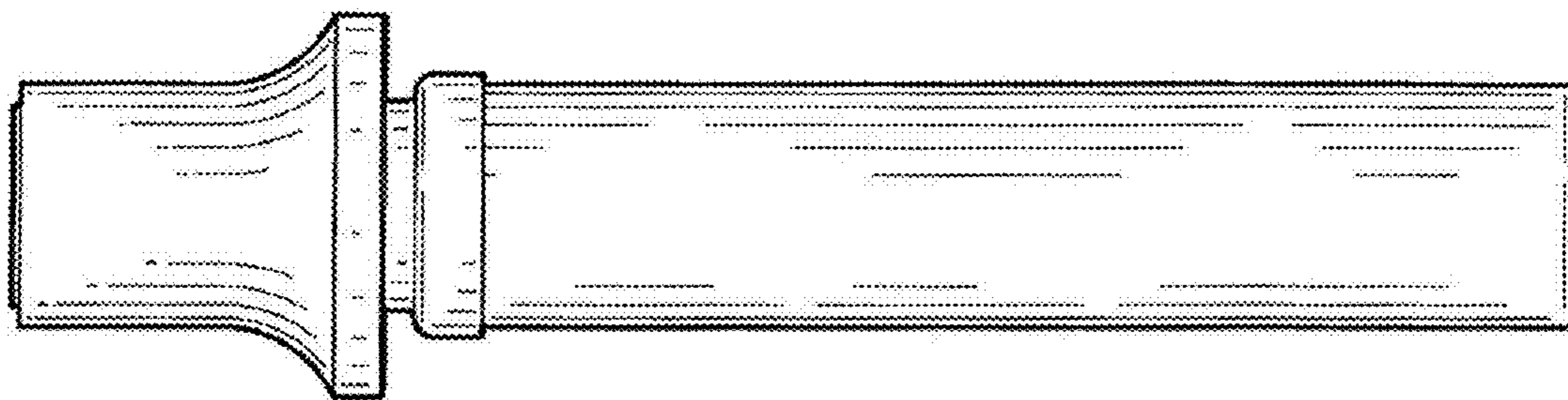

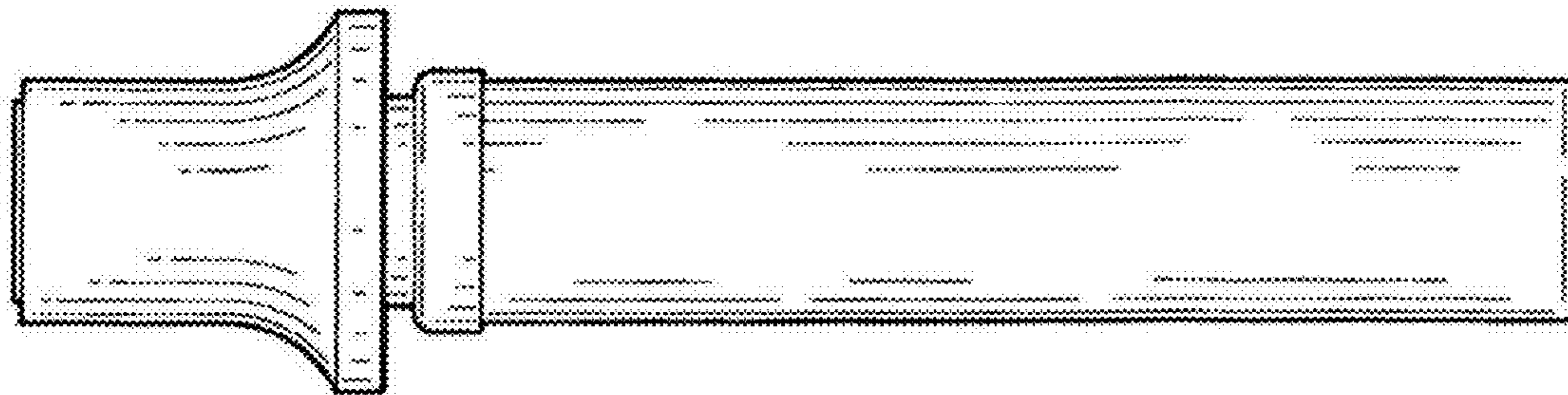

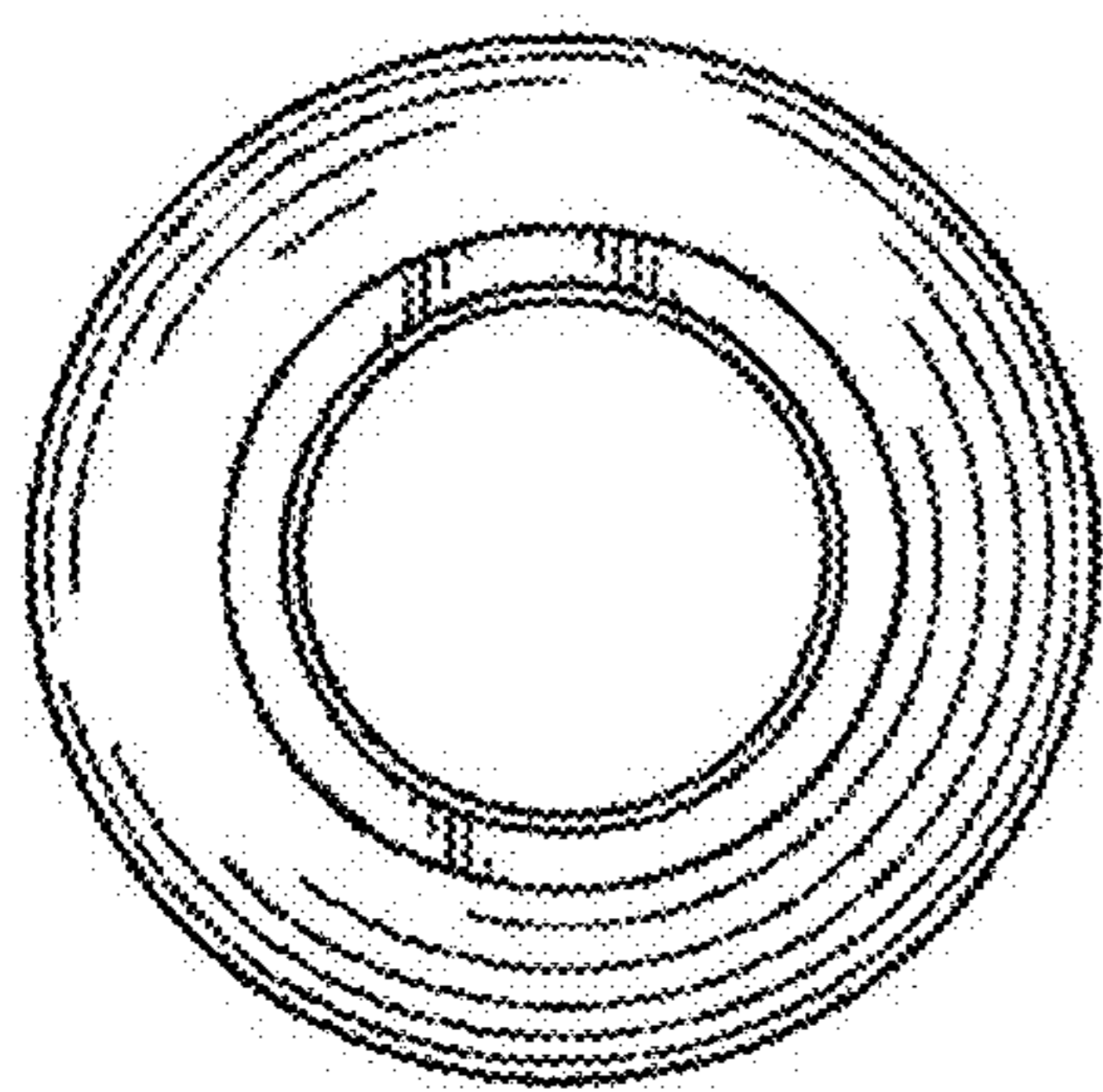
