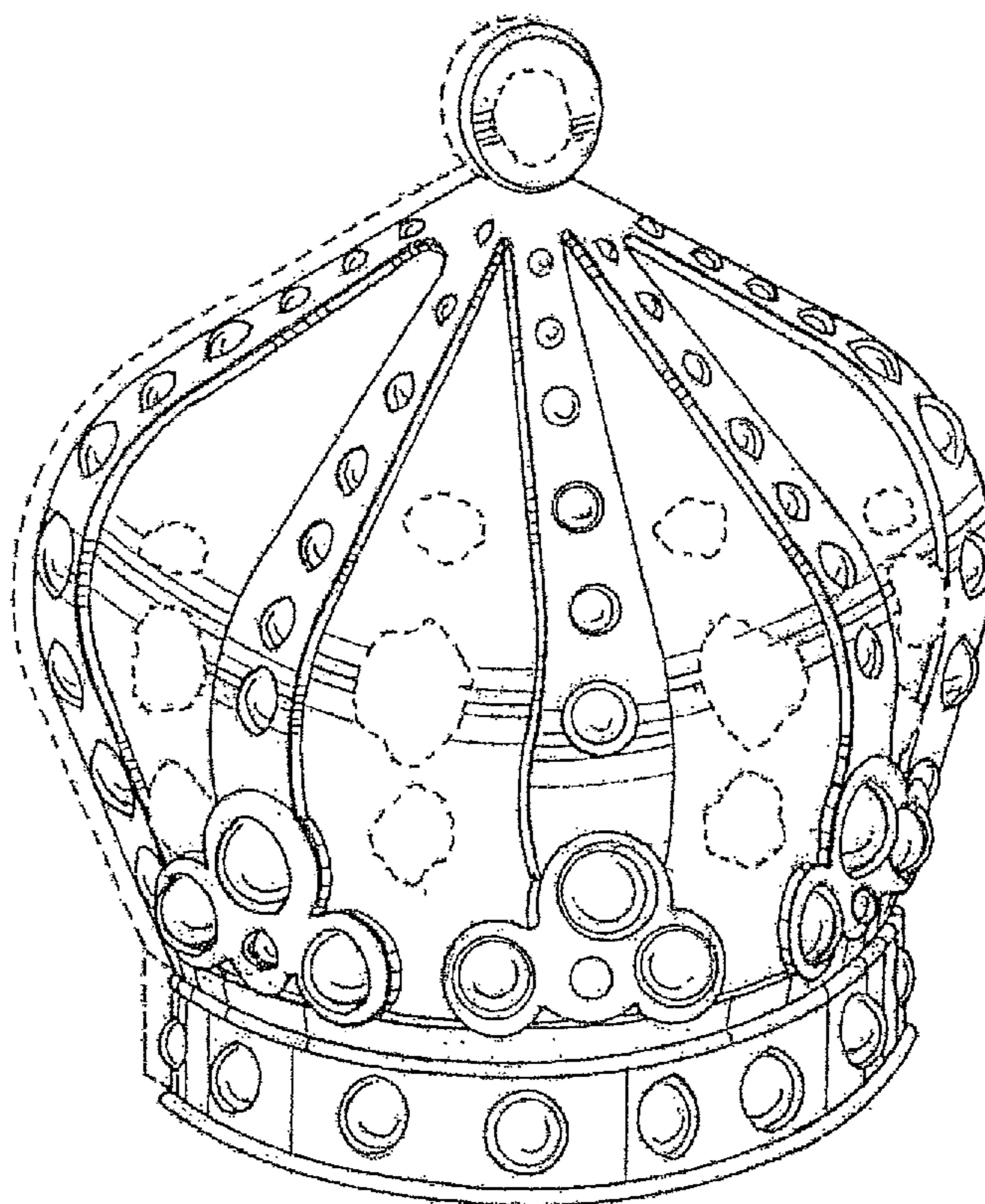
FIG. 6 is the front elevation view of FIG. 2, now showing the crown-styled clothing closure in relation to a pocket.

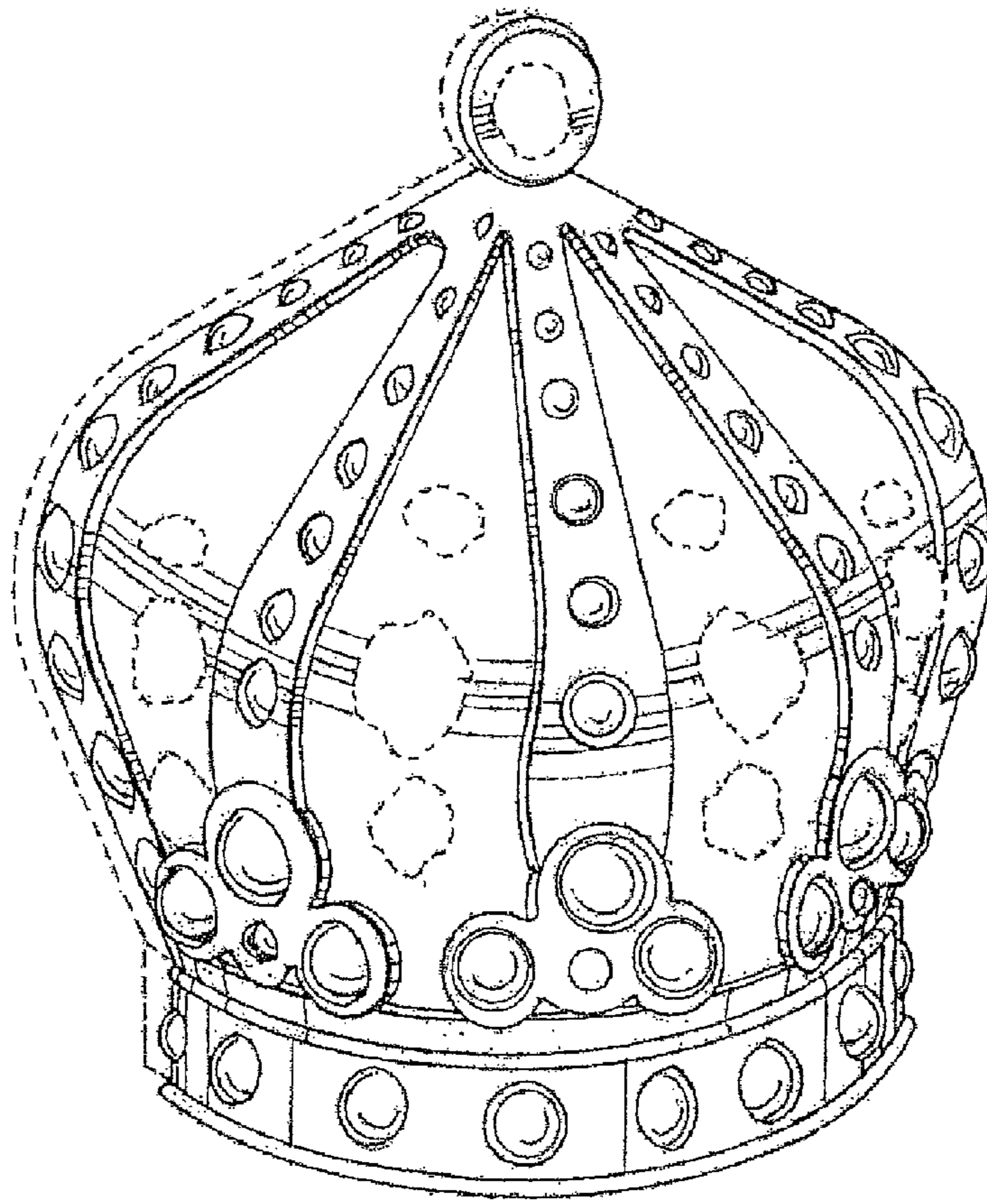

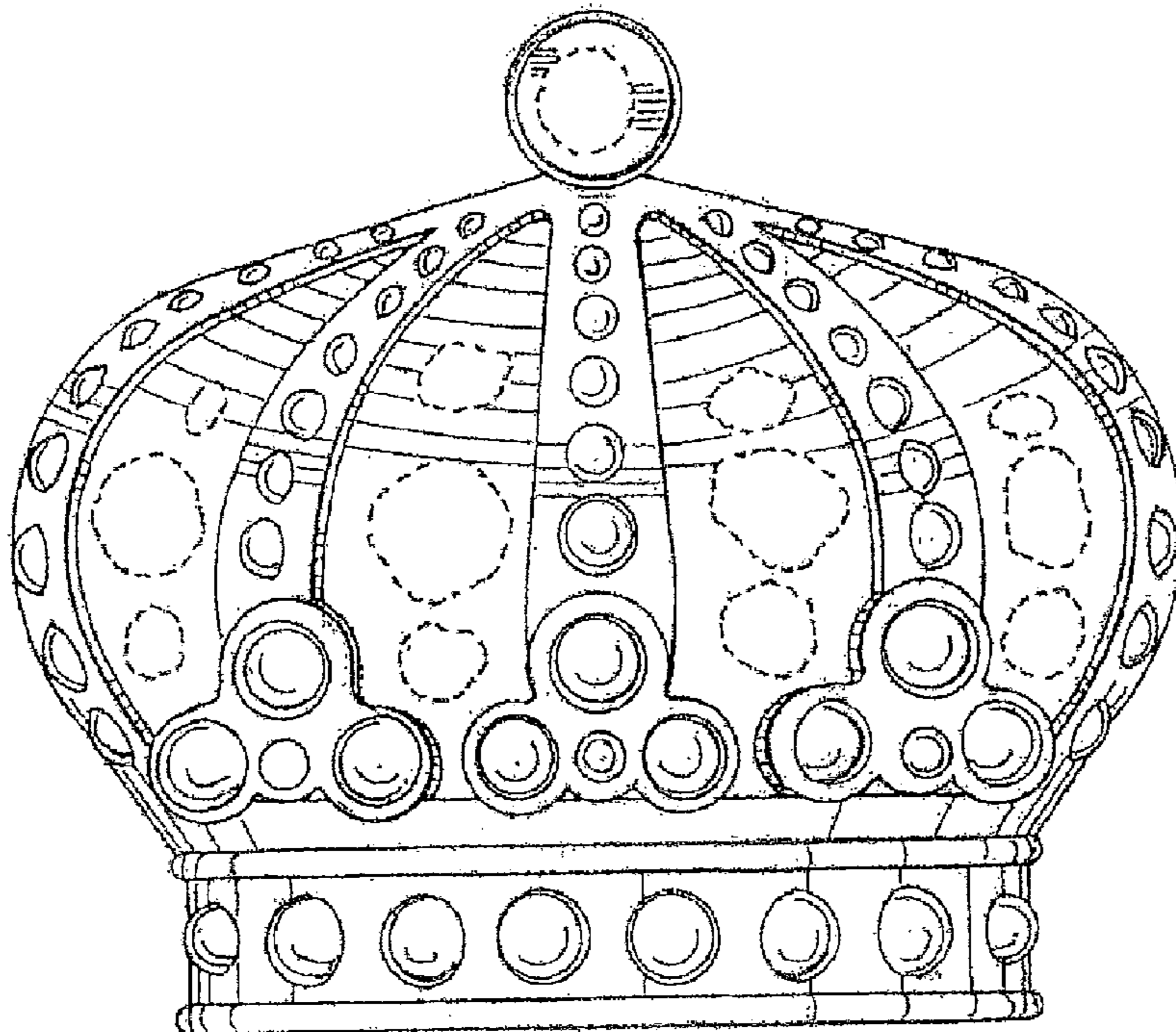

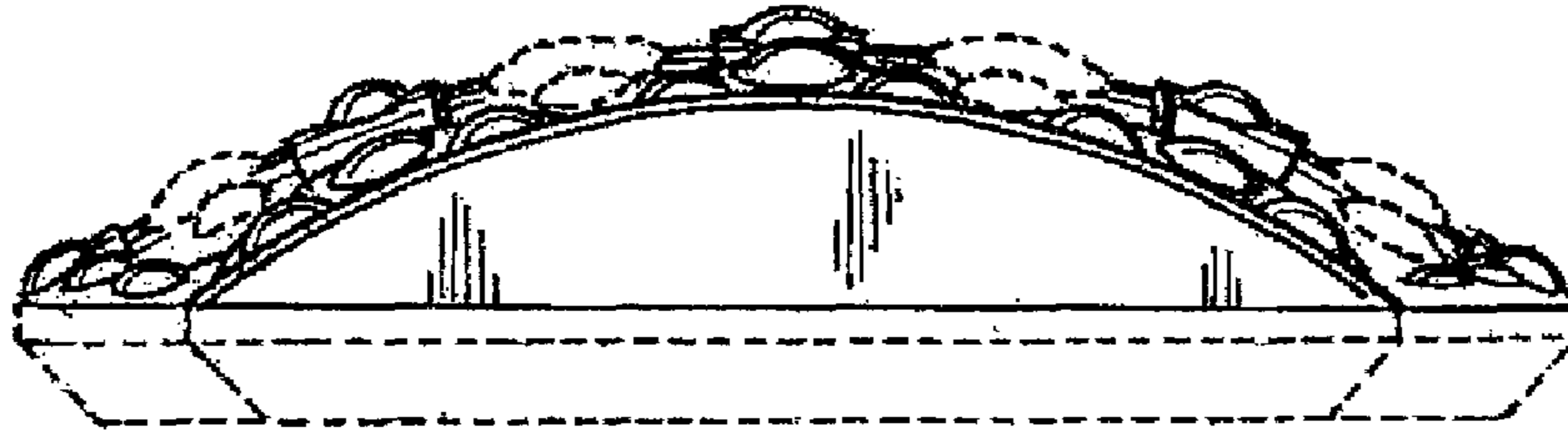

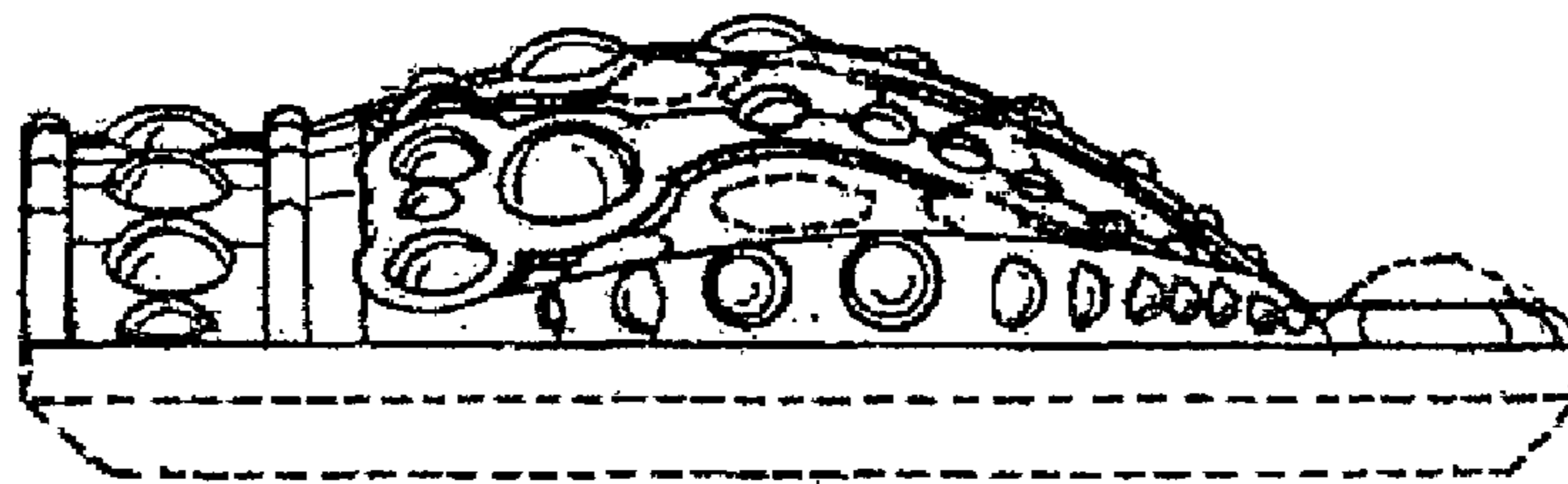

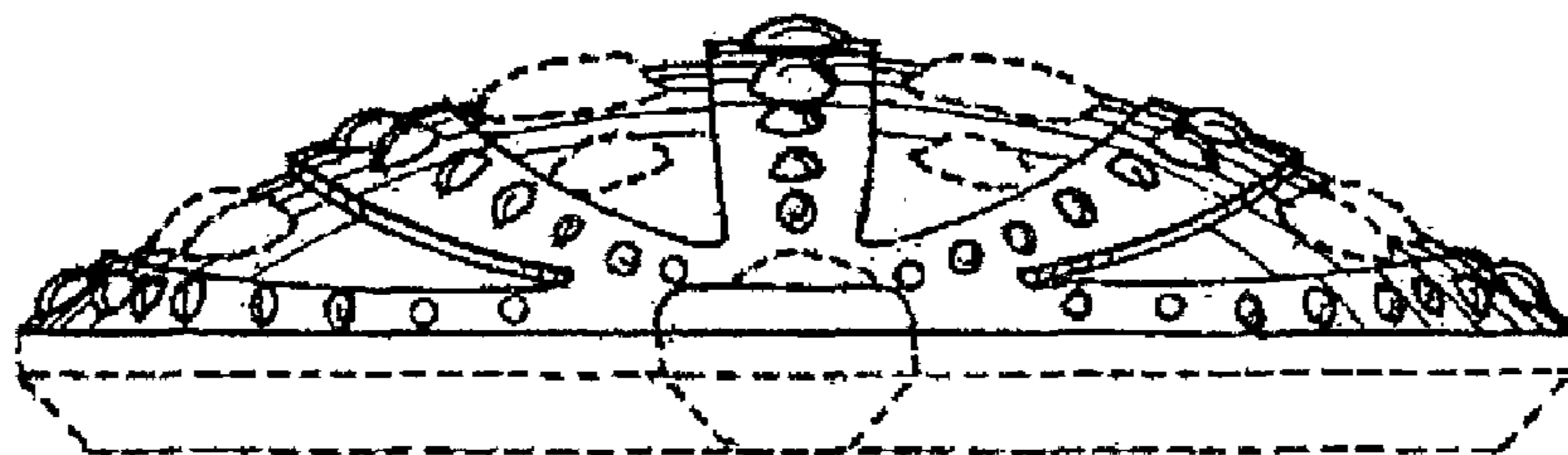
