(57) **CLAIM**

We claim the ornamental design for an LCD television receiver, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an LCD television receiver showing our new design:

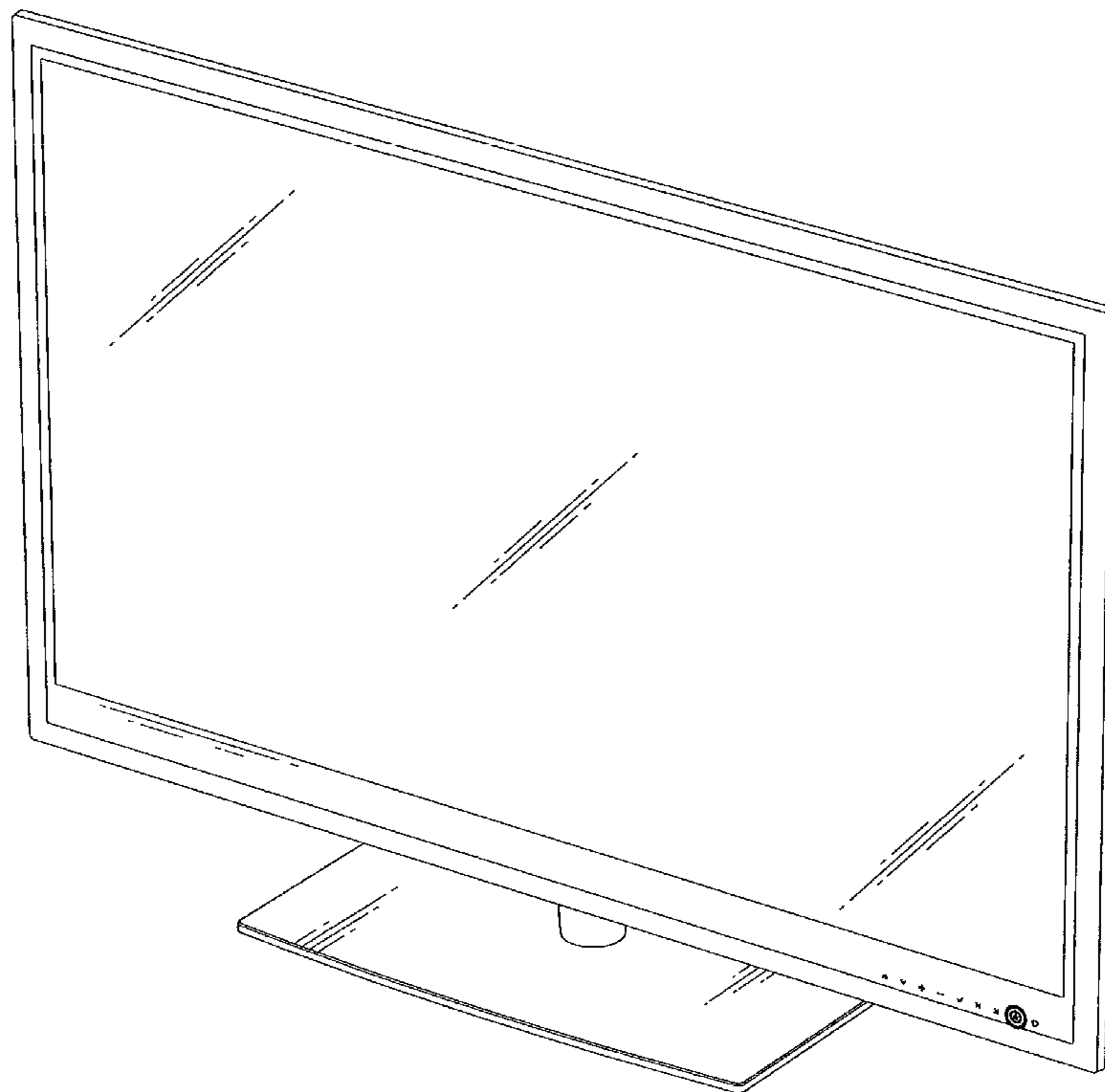

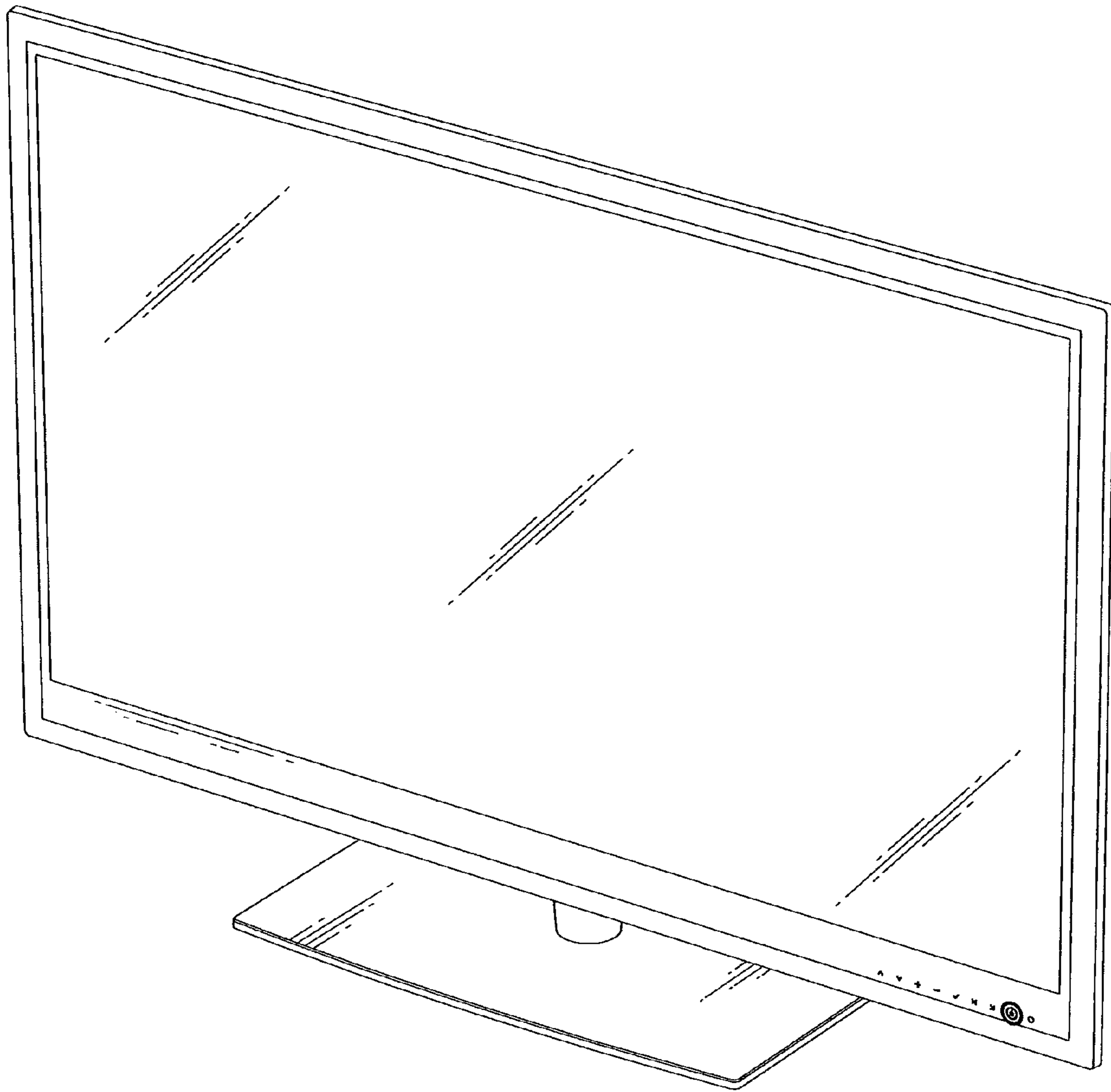

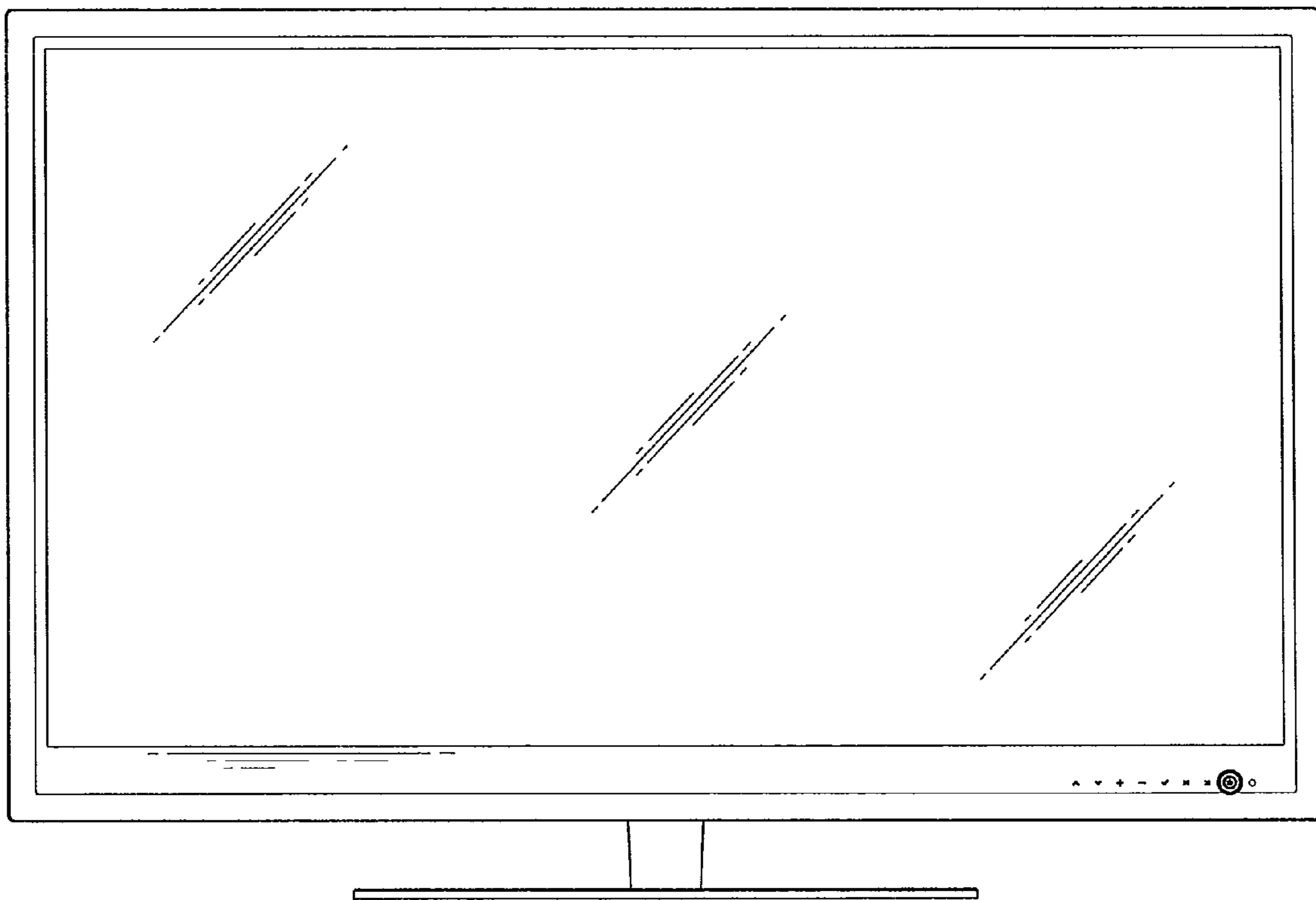

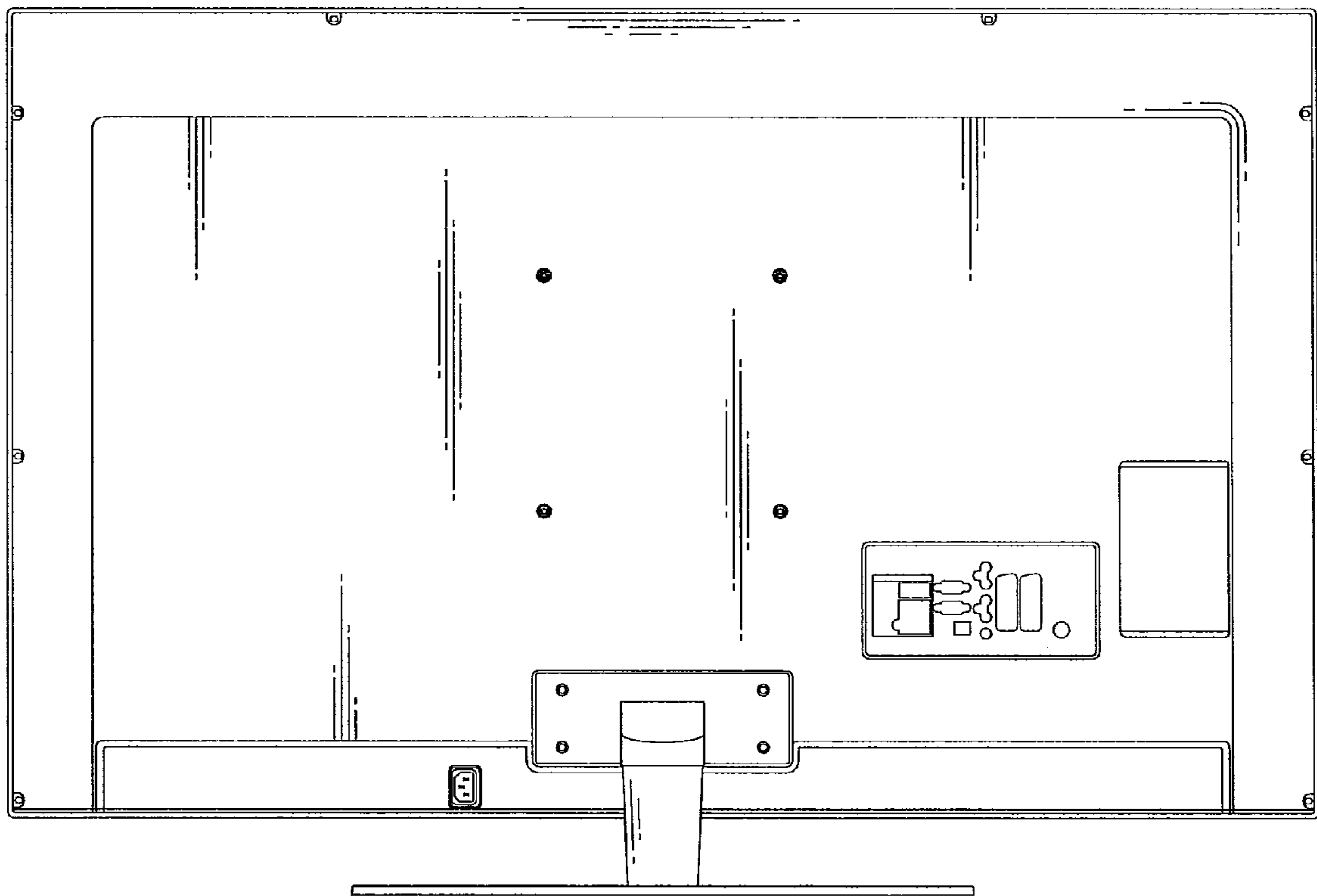

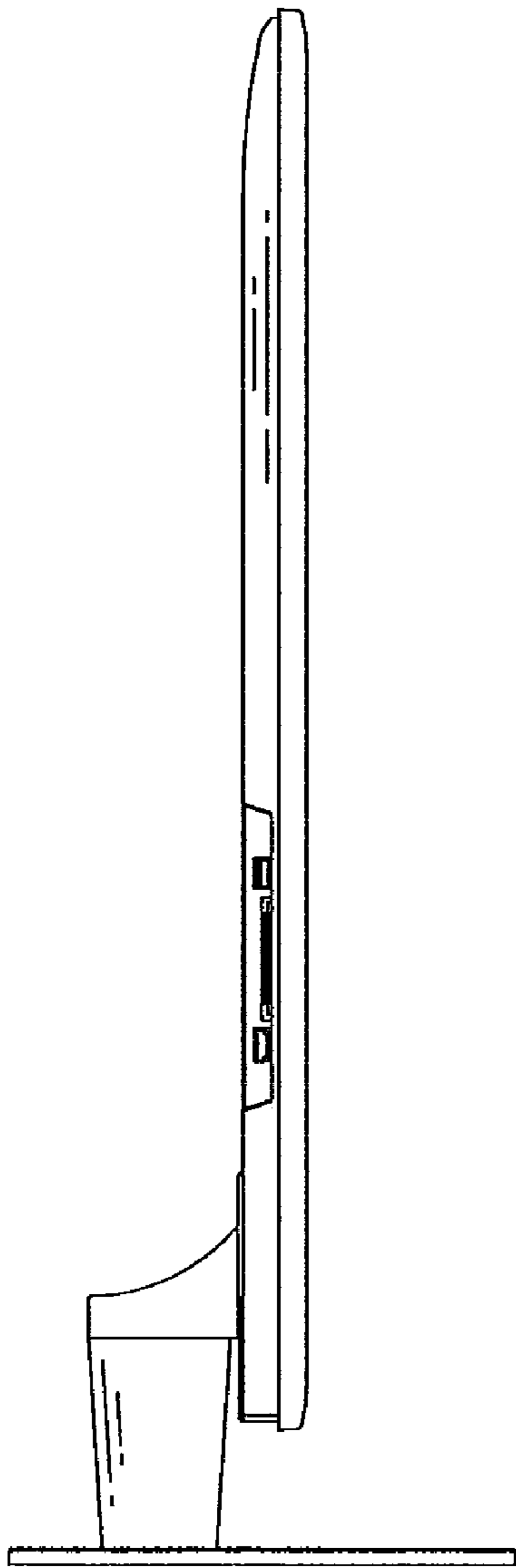

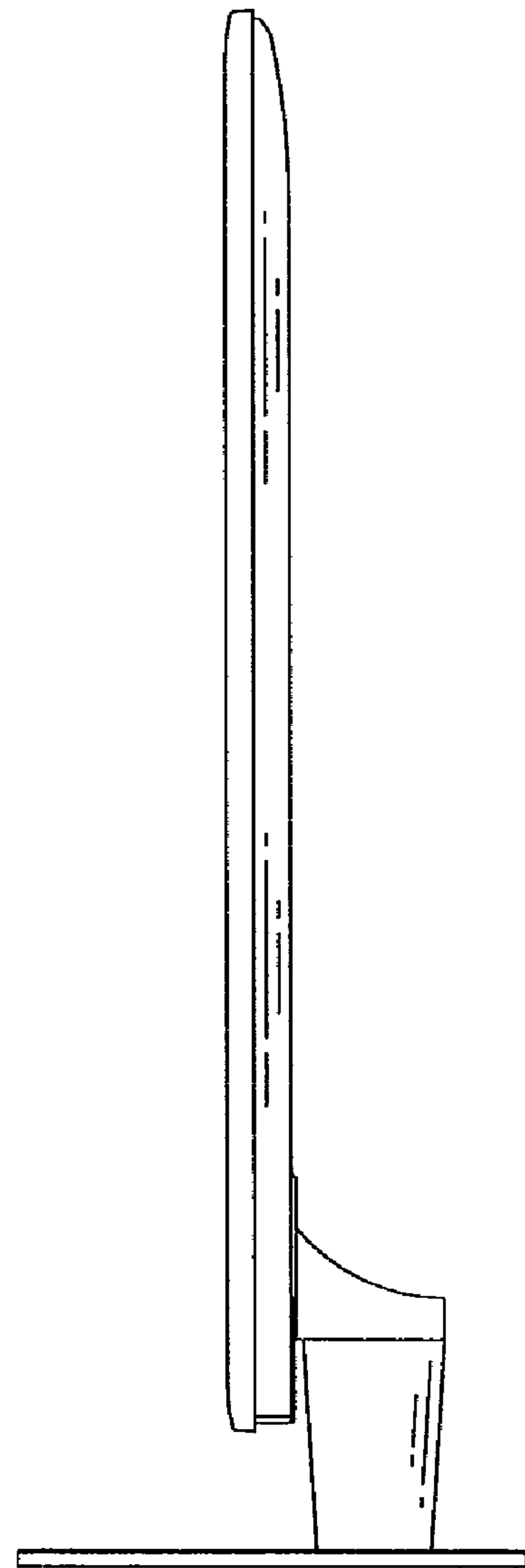

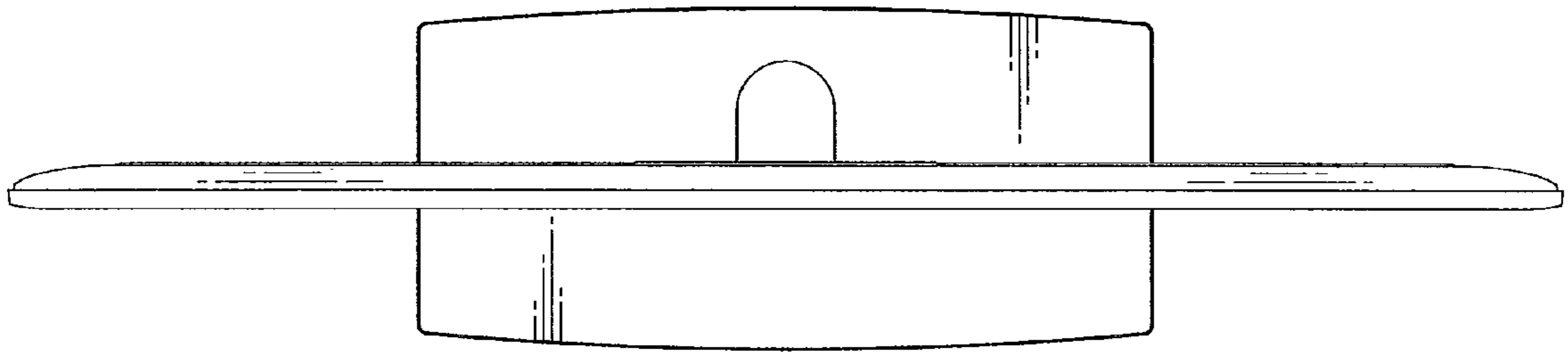
