(57) **CLAIM**

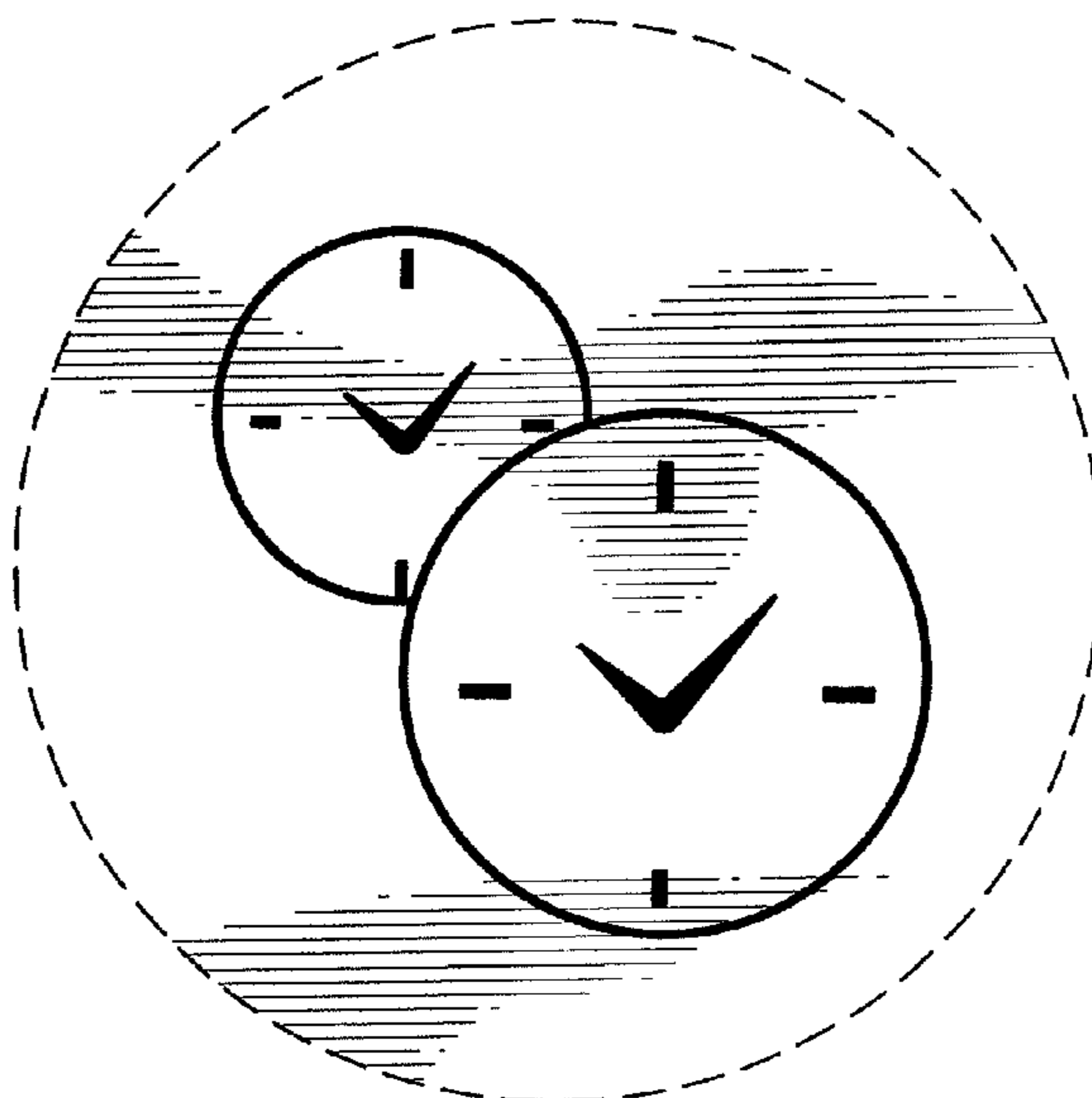
The ornamental design for portion of liquid crystal panel with icon image, as shown and described.
