(57) **CLAIM**

The ornamental design for a transport vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a right side view of a transport vehicle showing our new design;

FIG. 2 is a left side view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a rear view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a right front perspective view thereof;

FIG. 7 is a left front perspective view thereof; and,

FIG. 8 is a right rear perspective view thereof.

The parts of the photographs shown in coarse dot pattern and outlined in dashed lines illustrate a portion of the transport vehicle that forms no part of the claimed design.

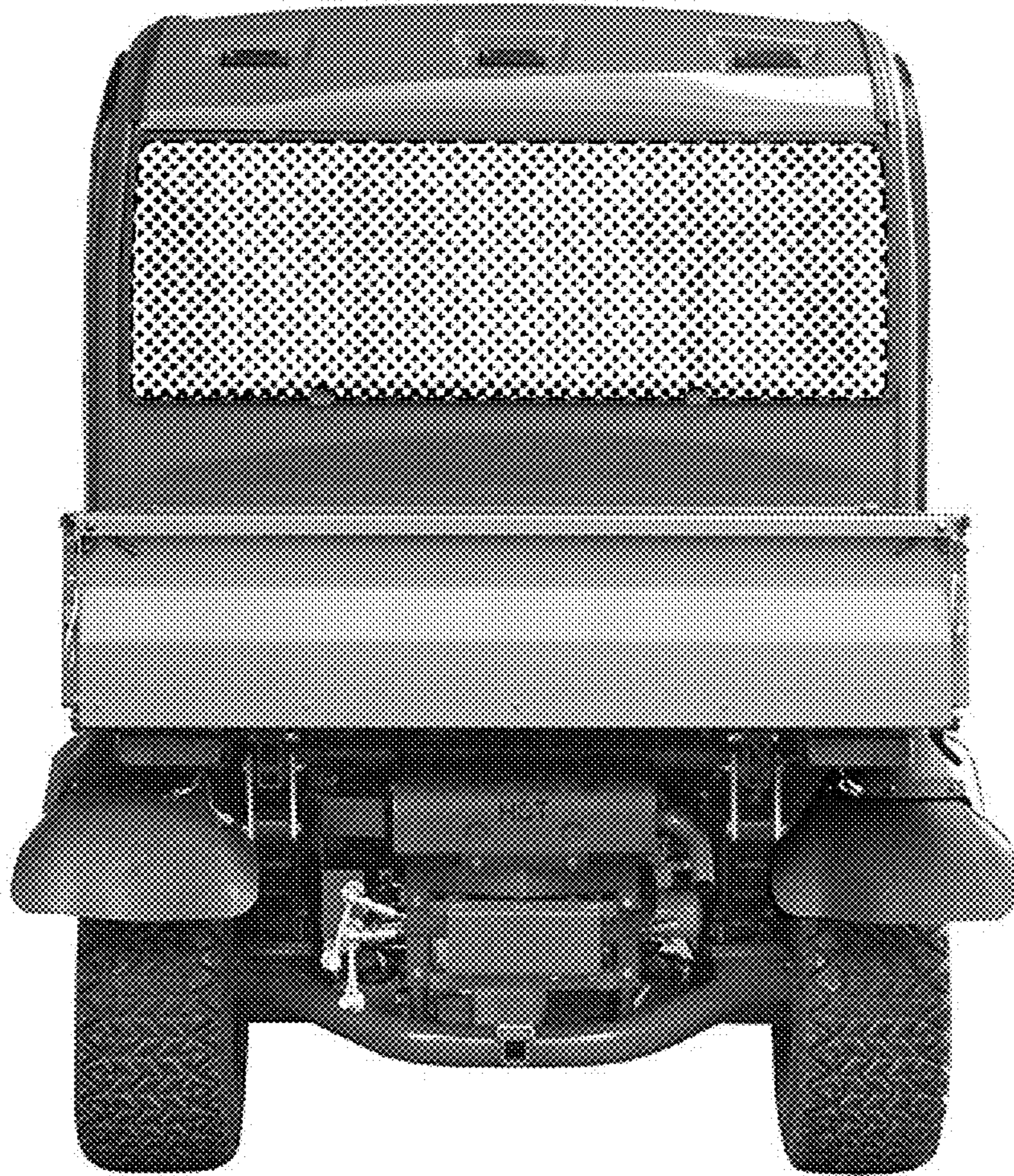
