**DESCRIPTION**

FIG. 1 is a top, front and side perspective view seen from right side of a printer showing our new design;

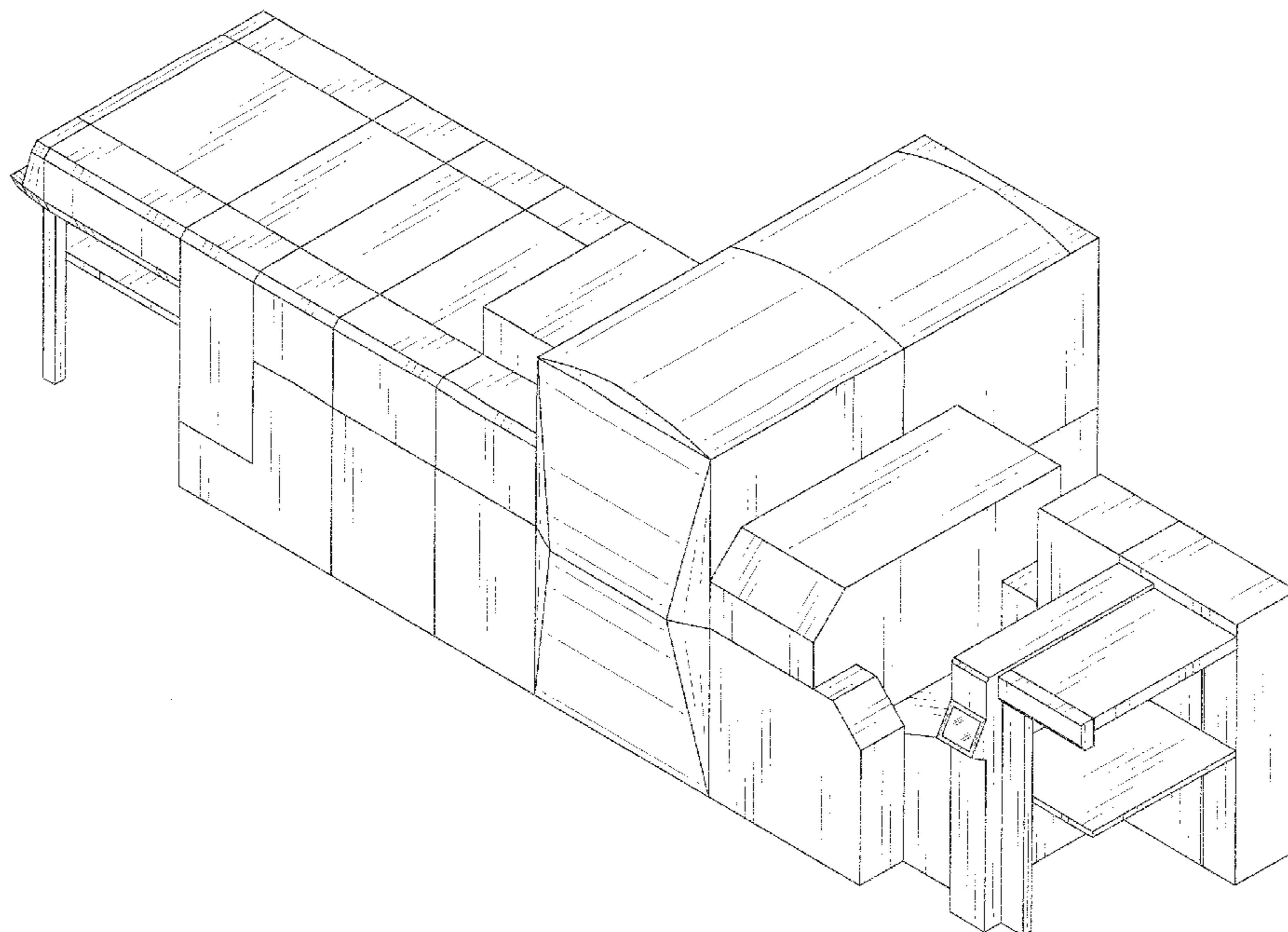

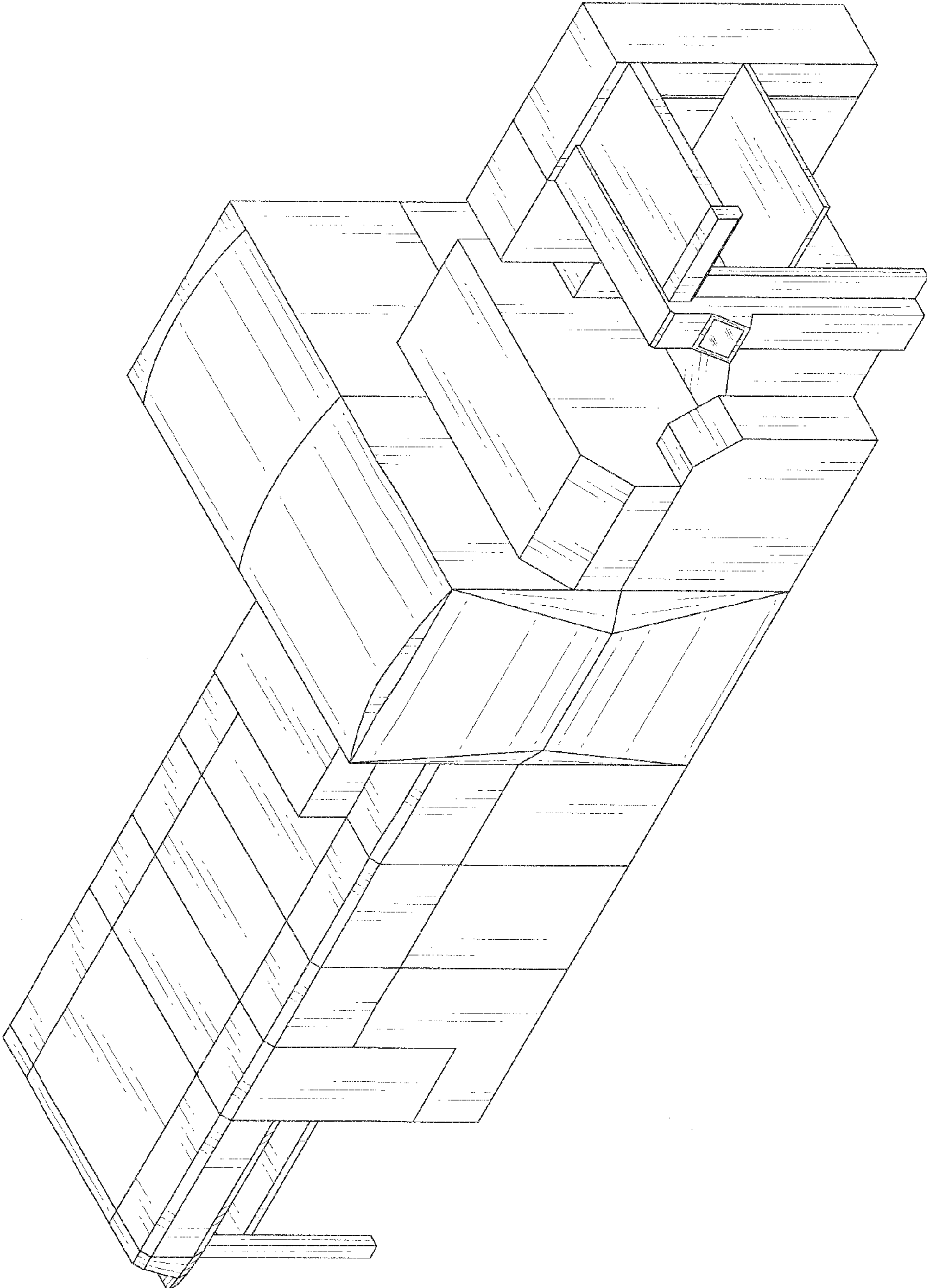

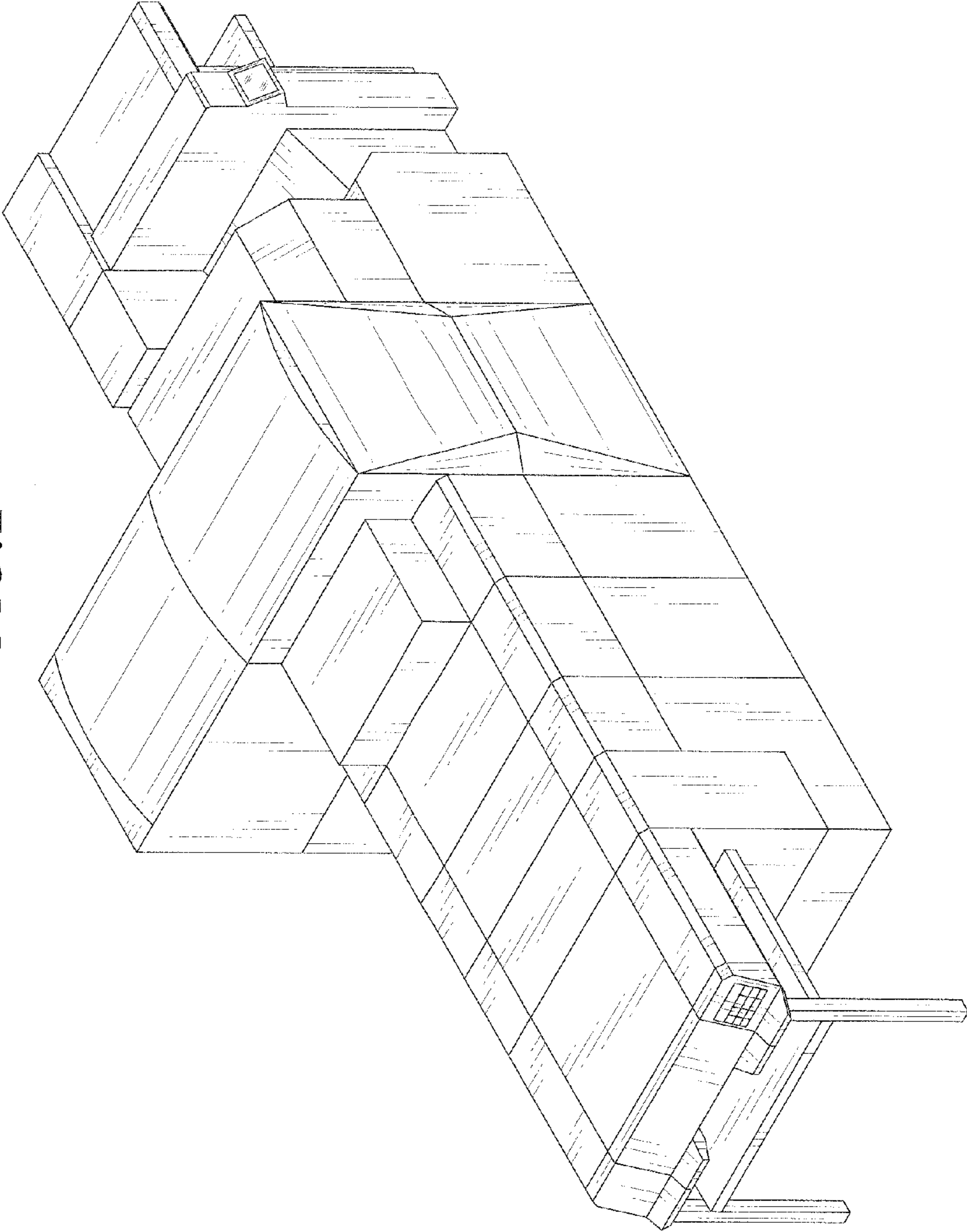

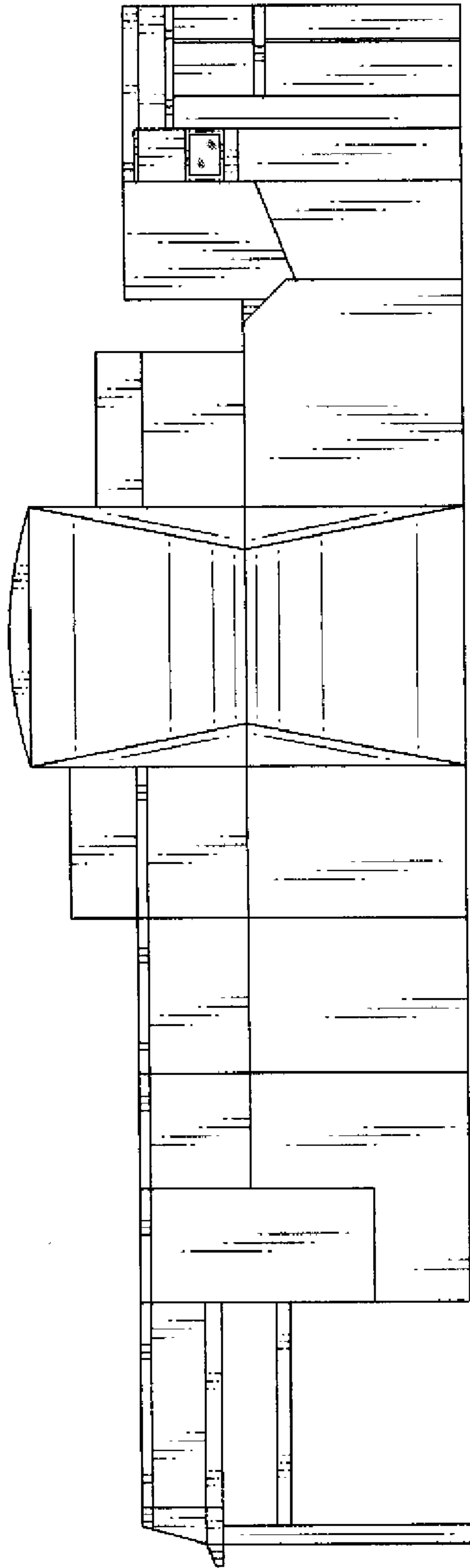

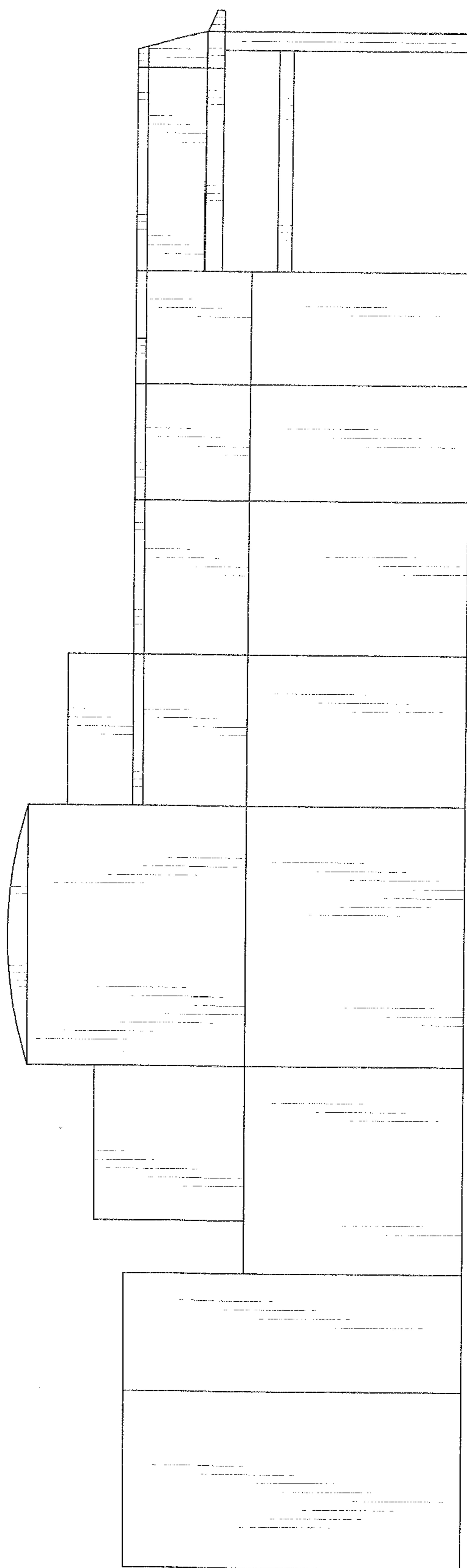

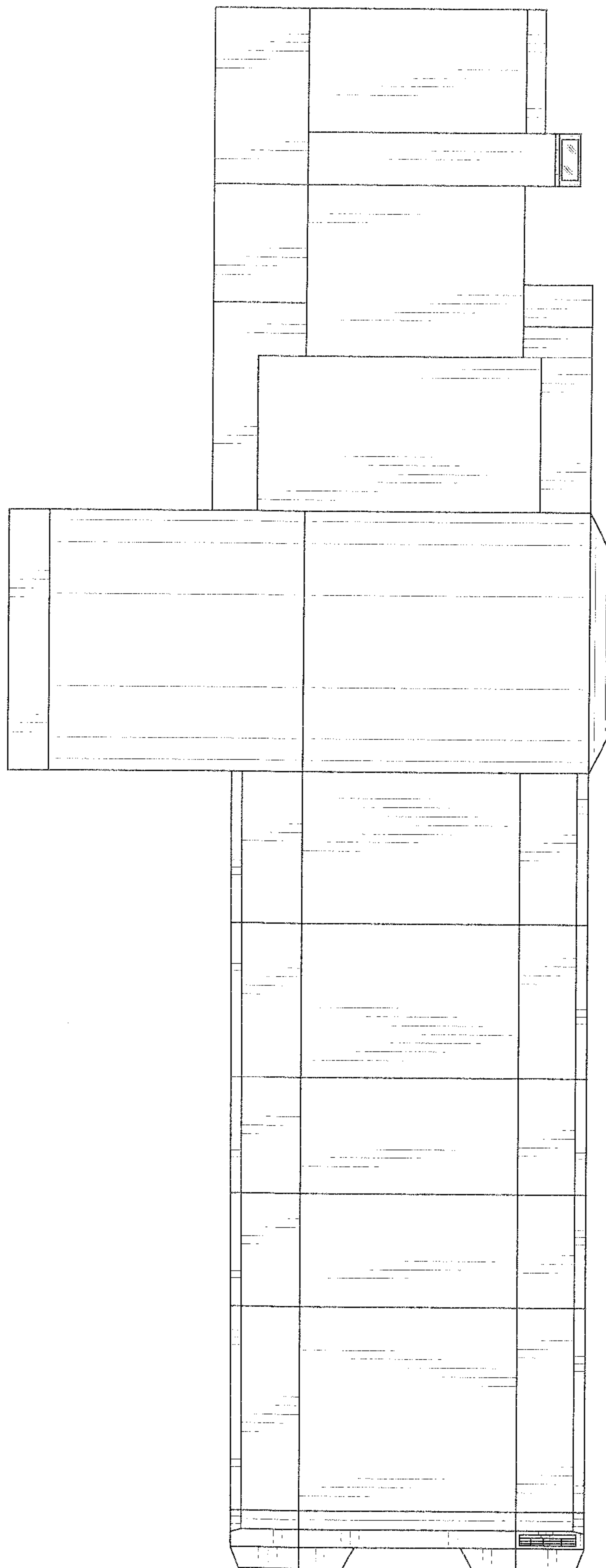

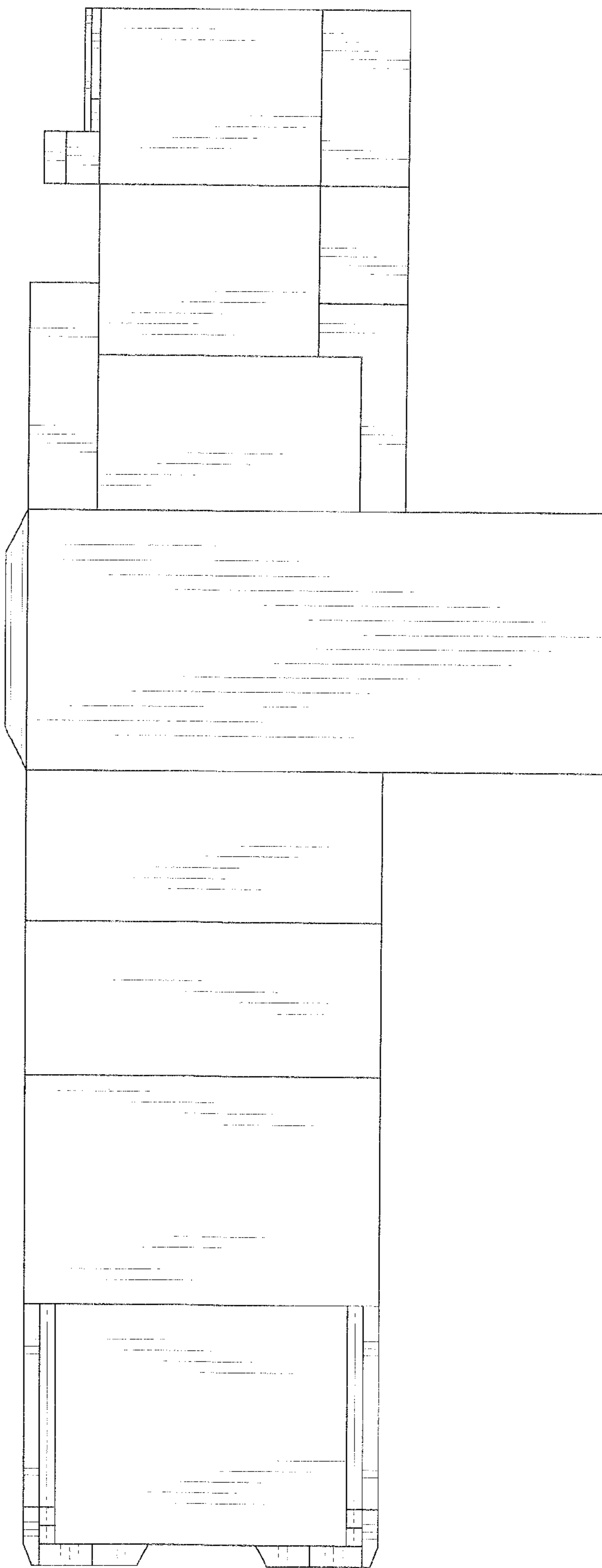

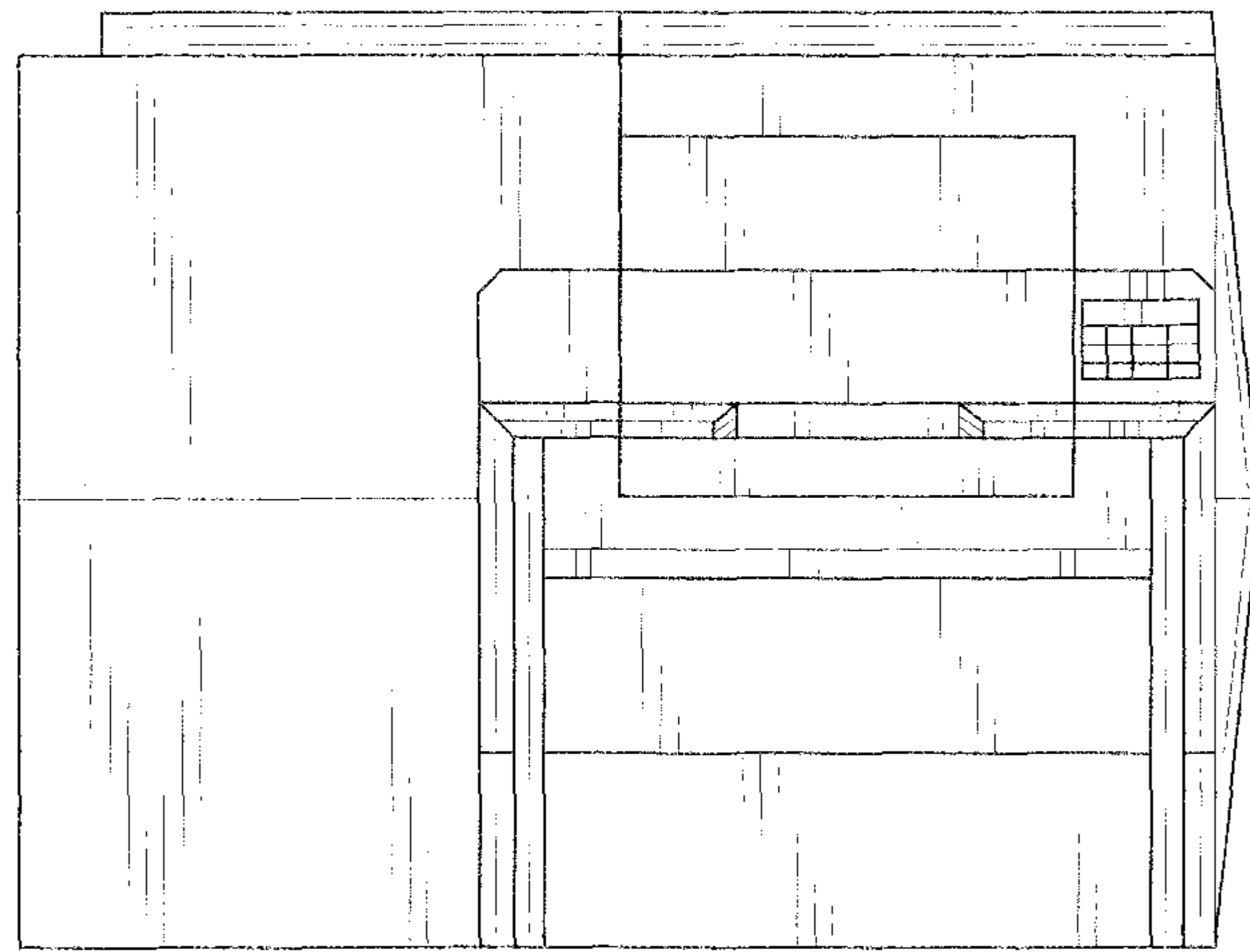
