I claim the ornamental design for a golf tee, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a golf tee embodying the design;

FIG. 3 is a first side view of the golf tee;

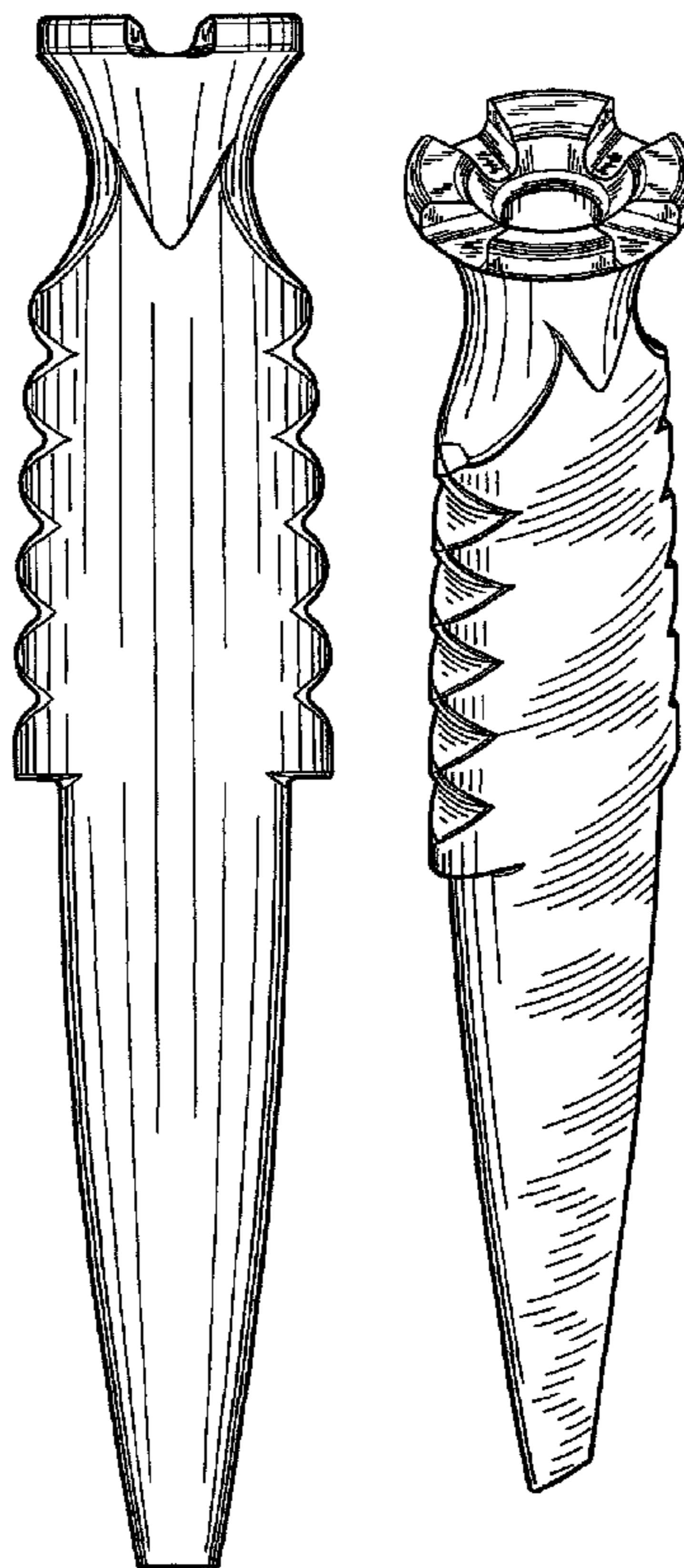
FIG. 4 is a second side view of the golf tee;

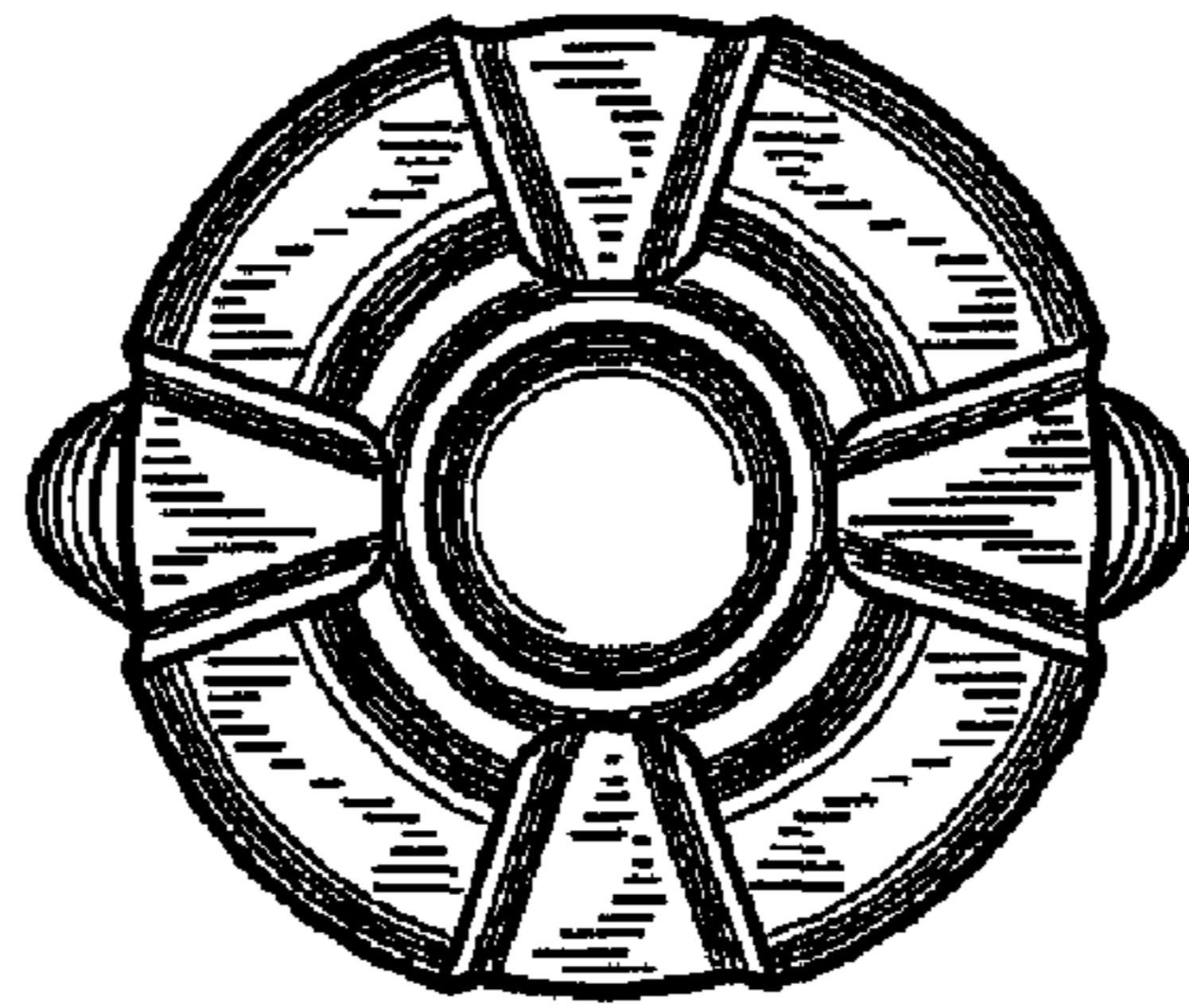

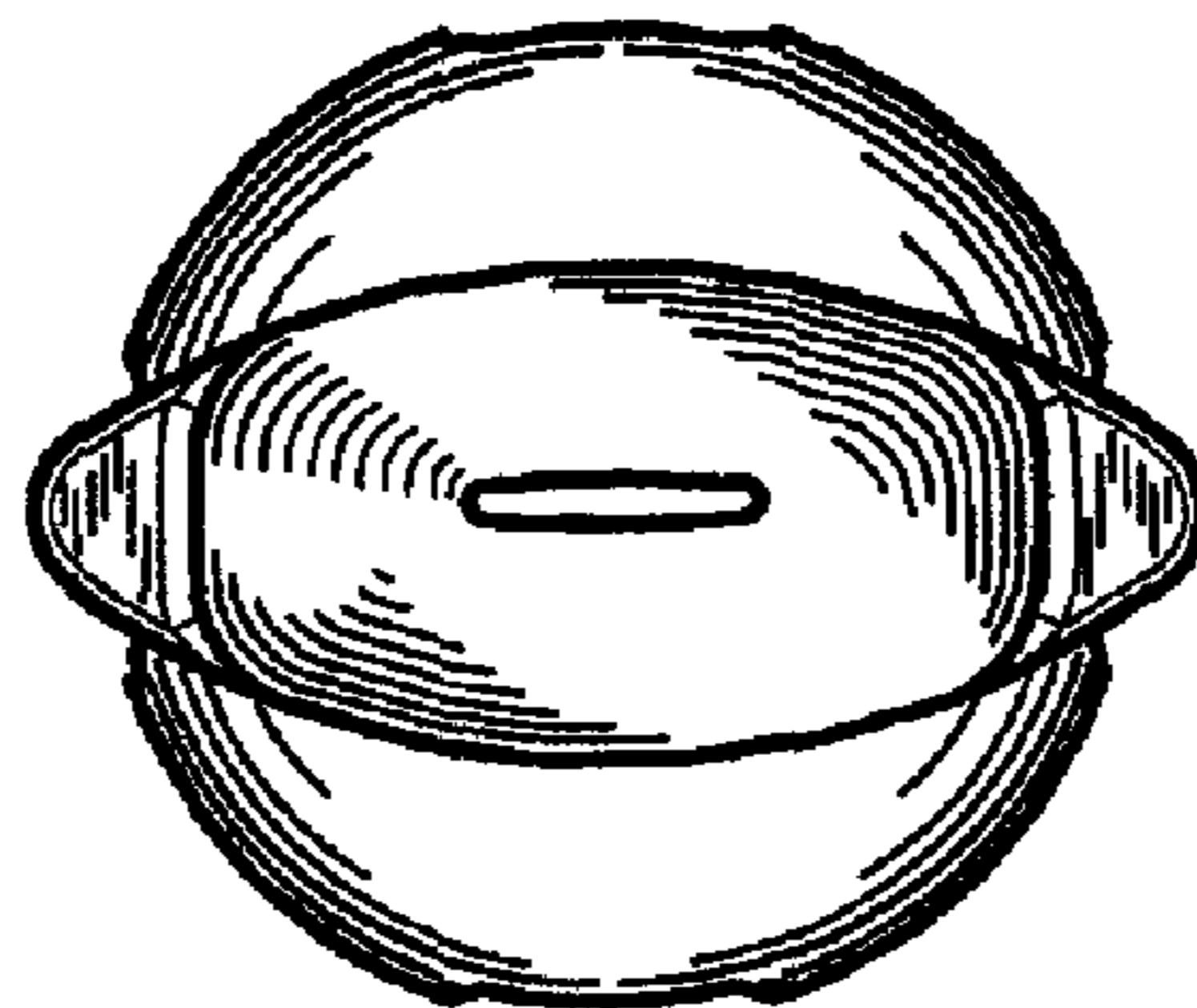

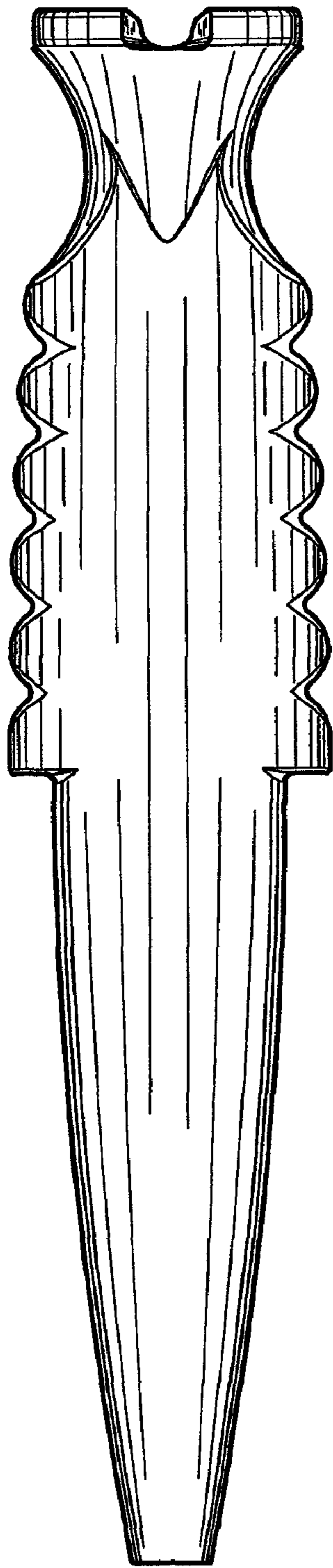

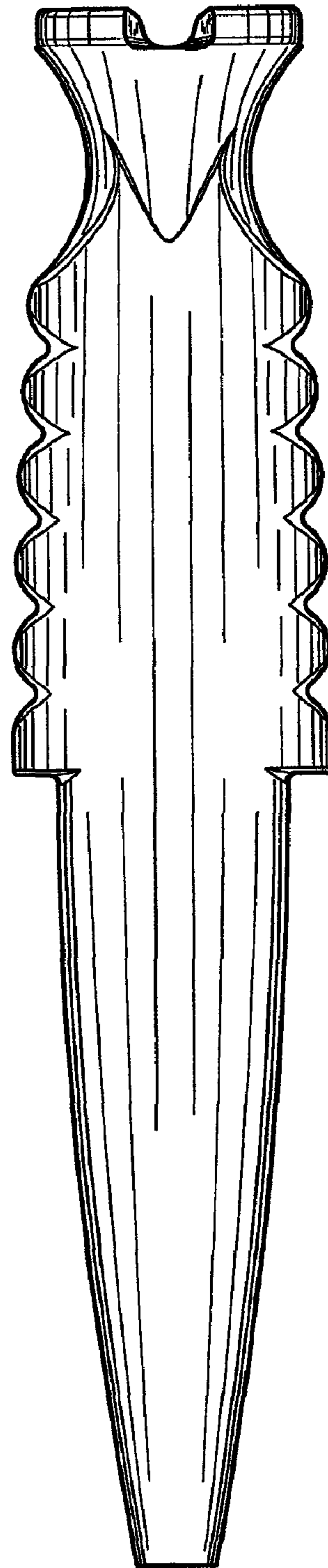

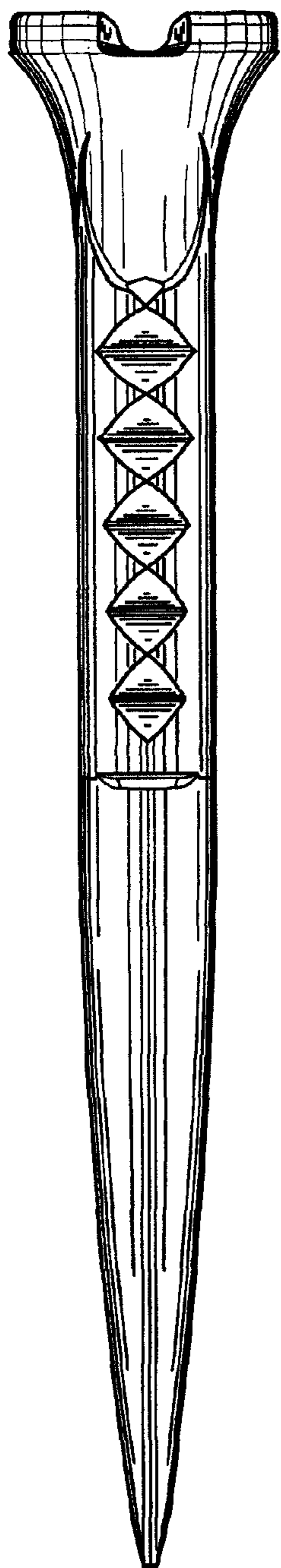

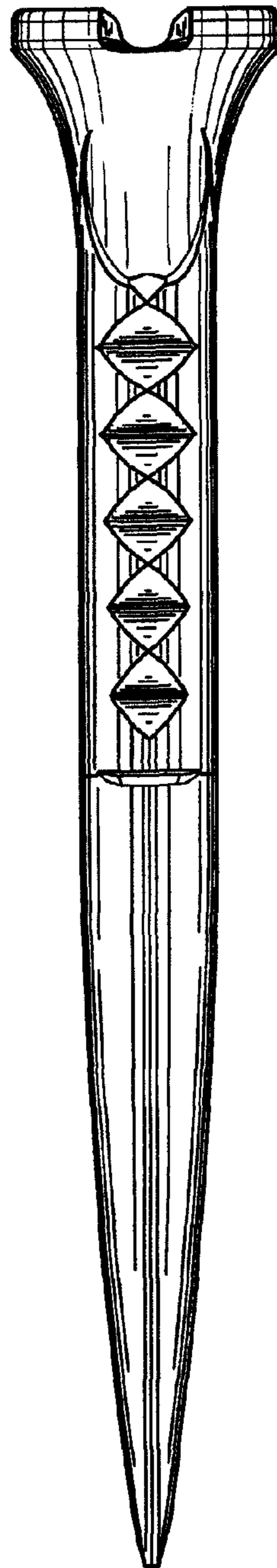

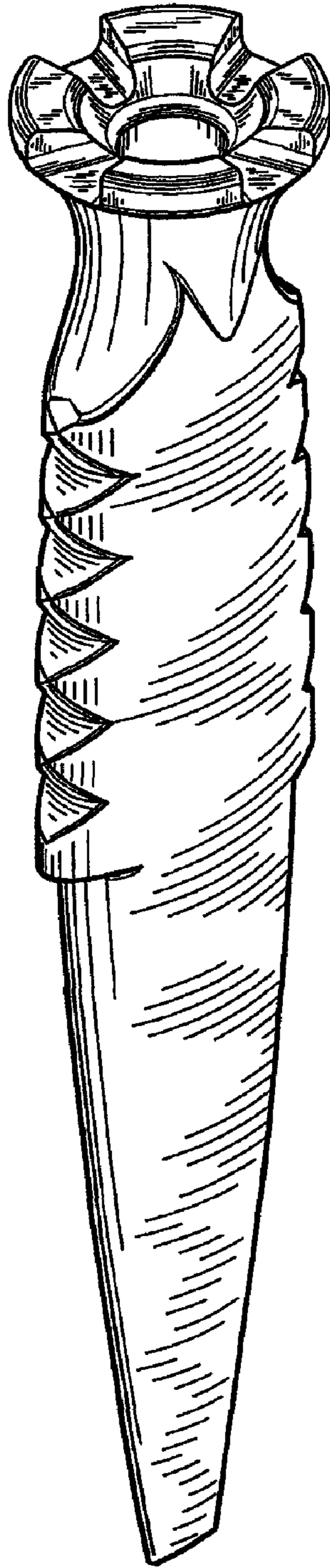
