FIG. 4 is a bottom view of the rain gutter cover;

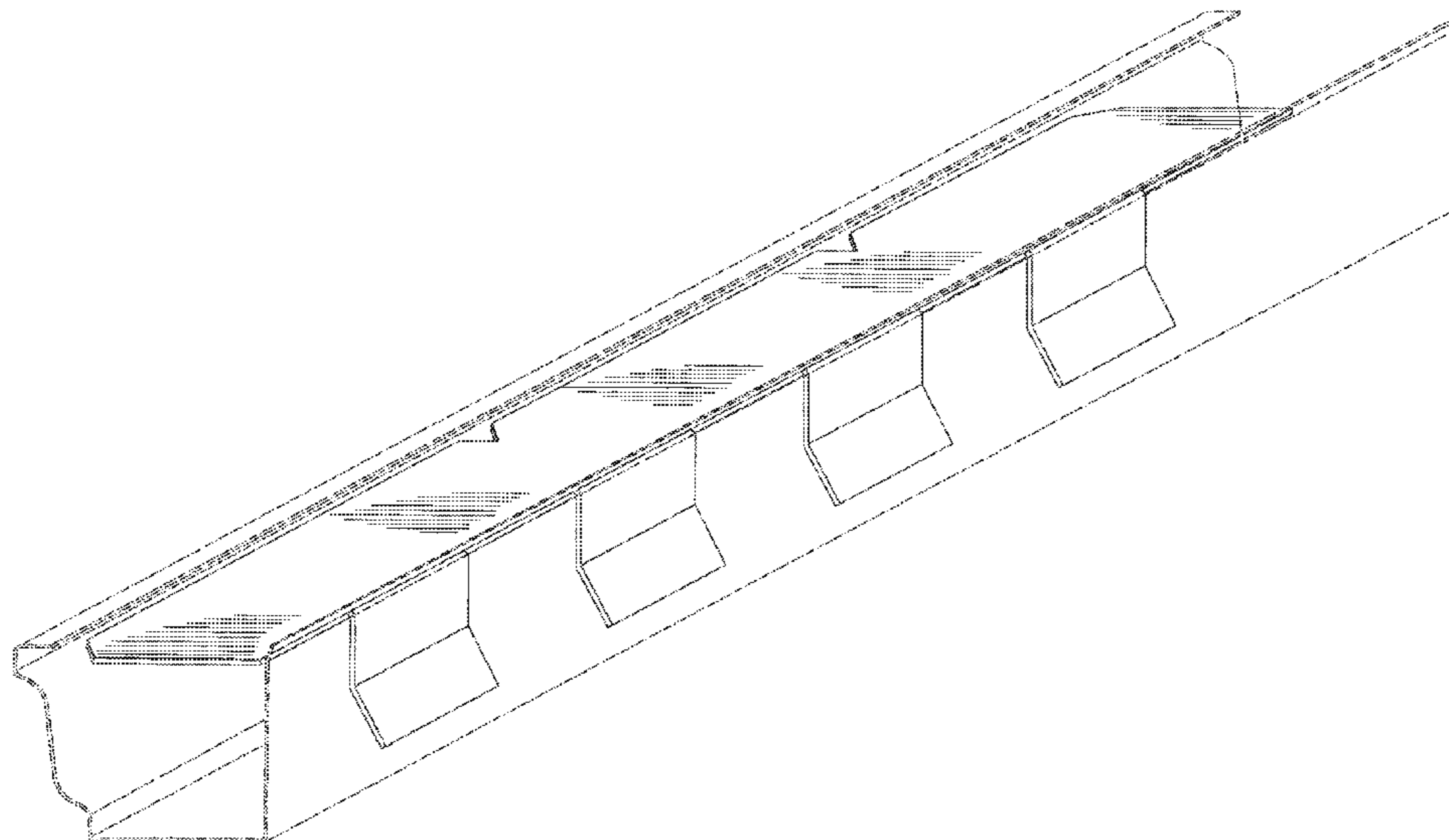
FIG. 5 is a front view of the rain gutter cover;

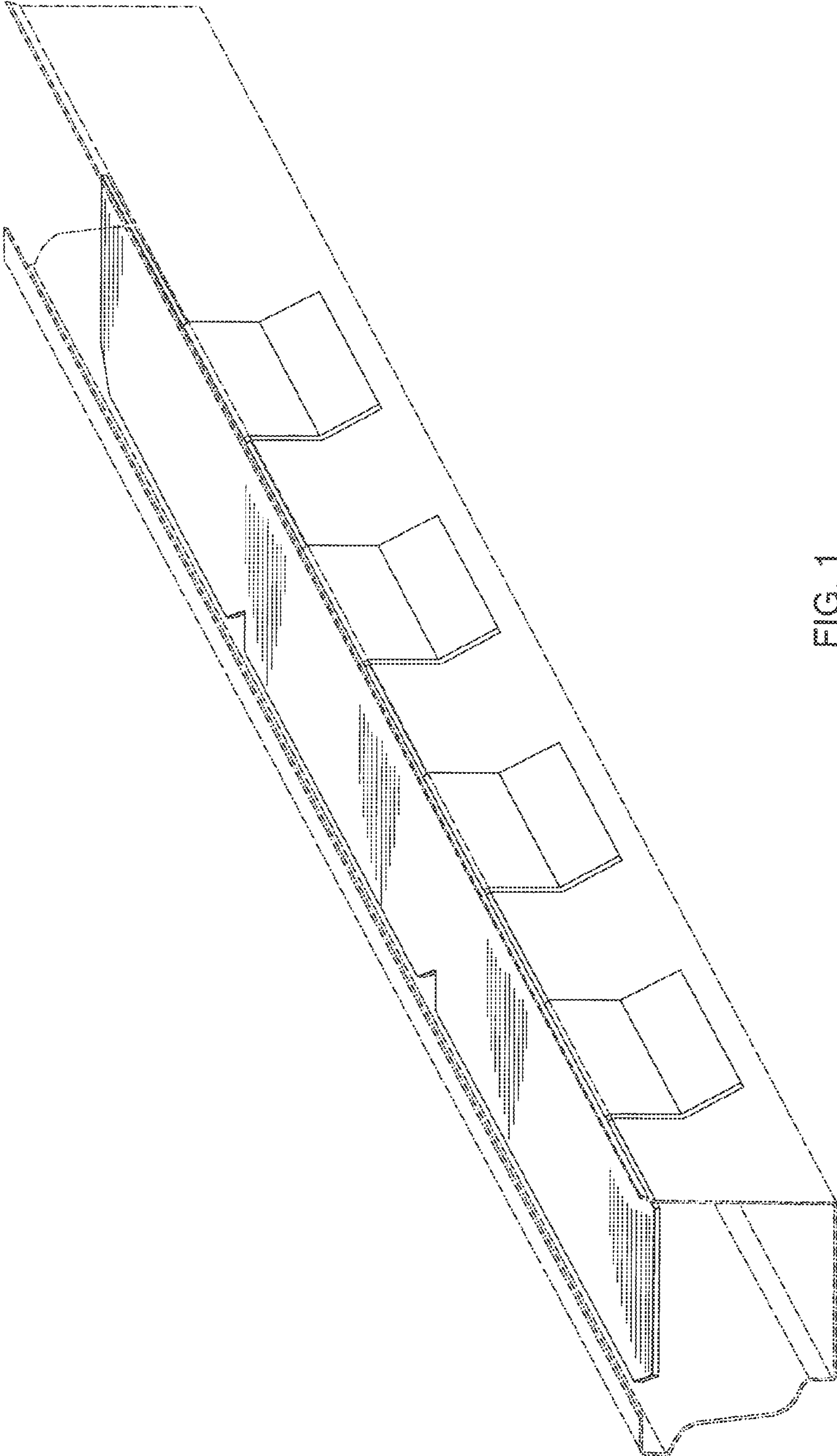

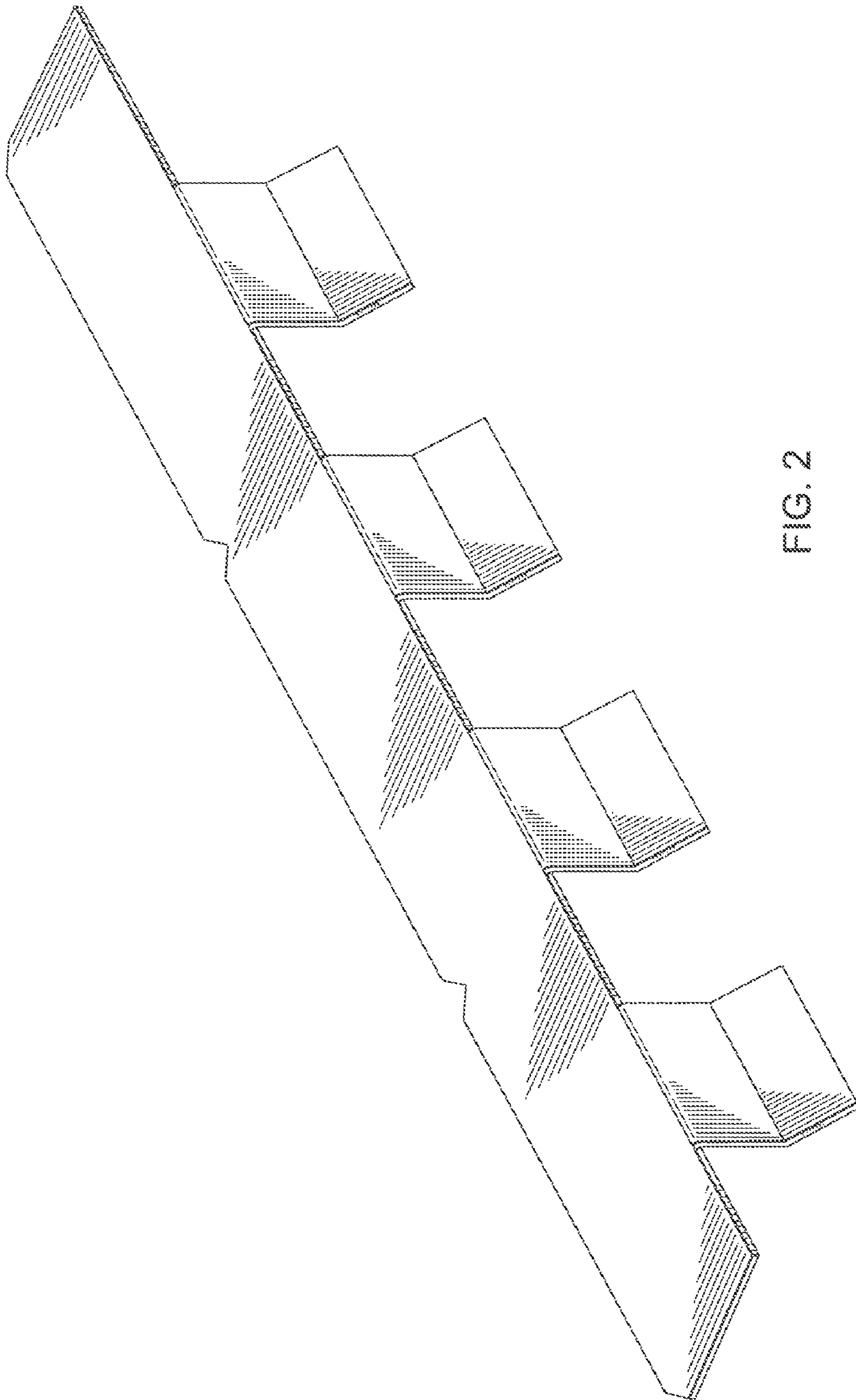

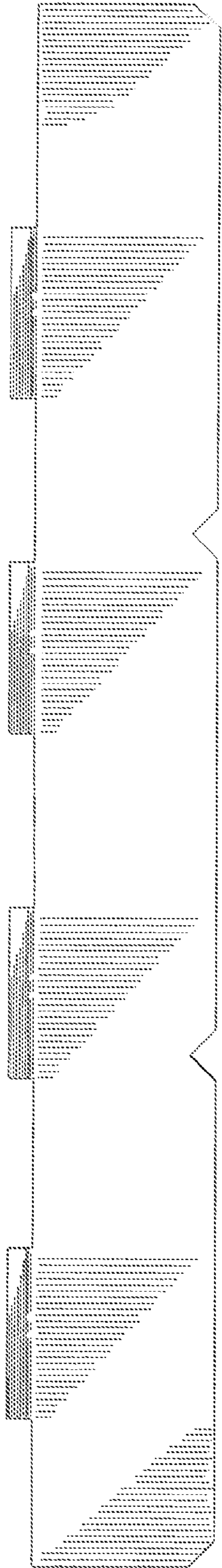

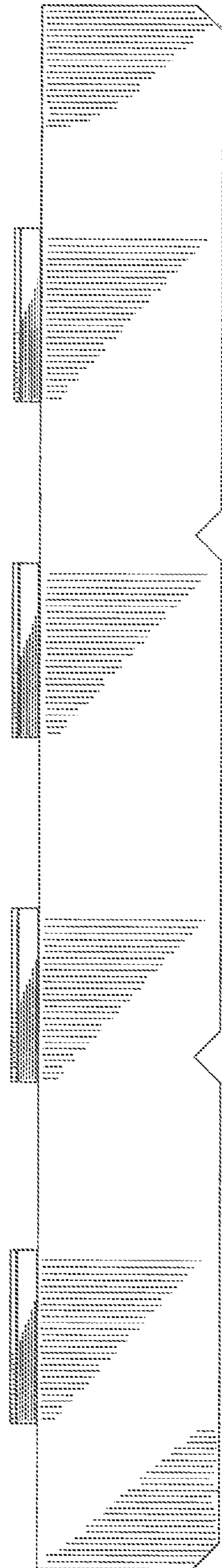

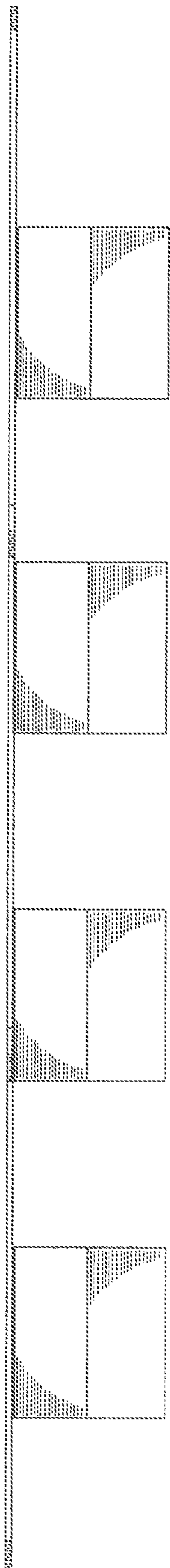

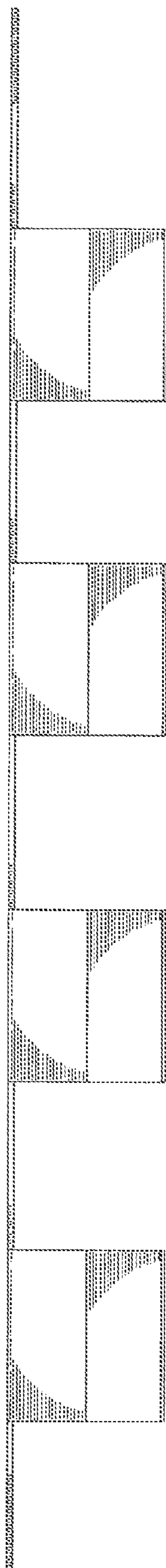

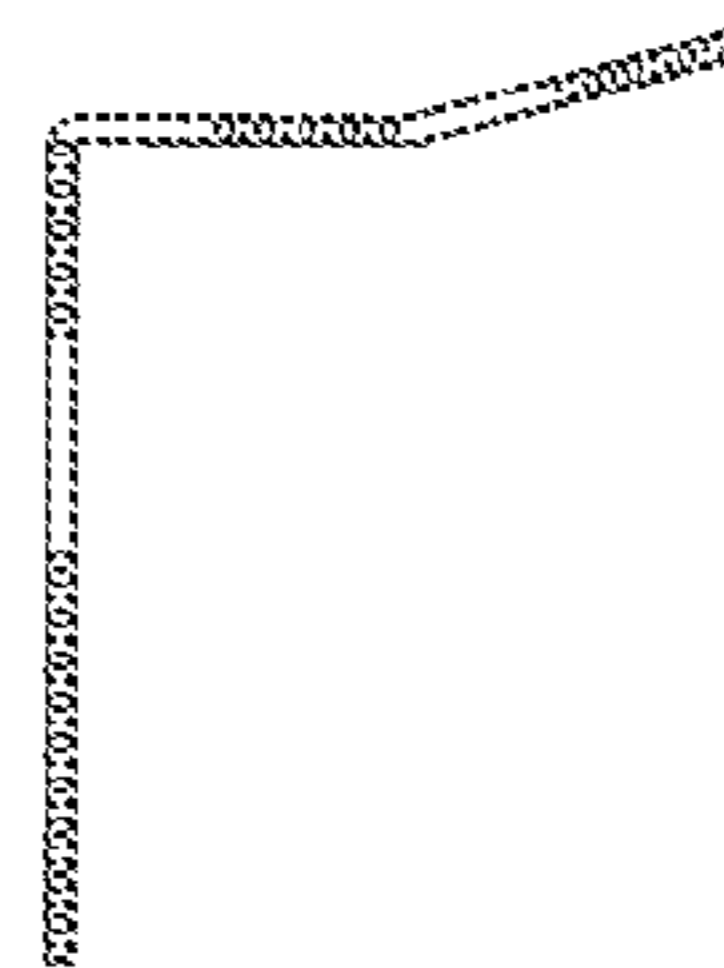
