**DESCRIPTION**

FIG. 1 is a front perspective view of a scrub showing our design;

FIG. 2 is an exploded front elevational view thereof;

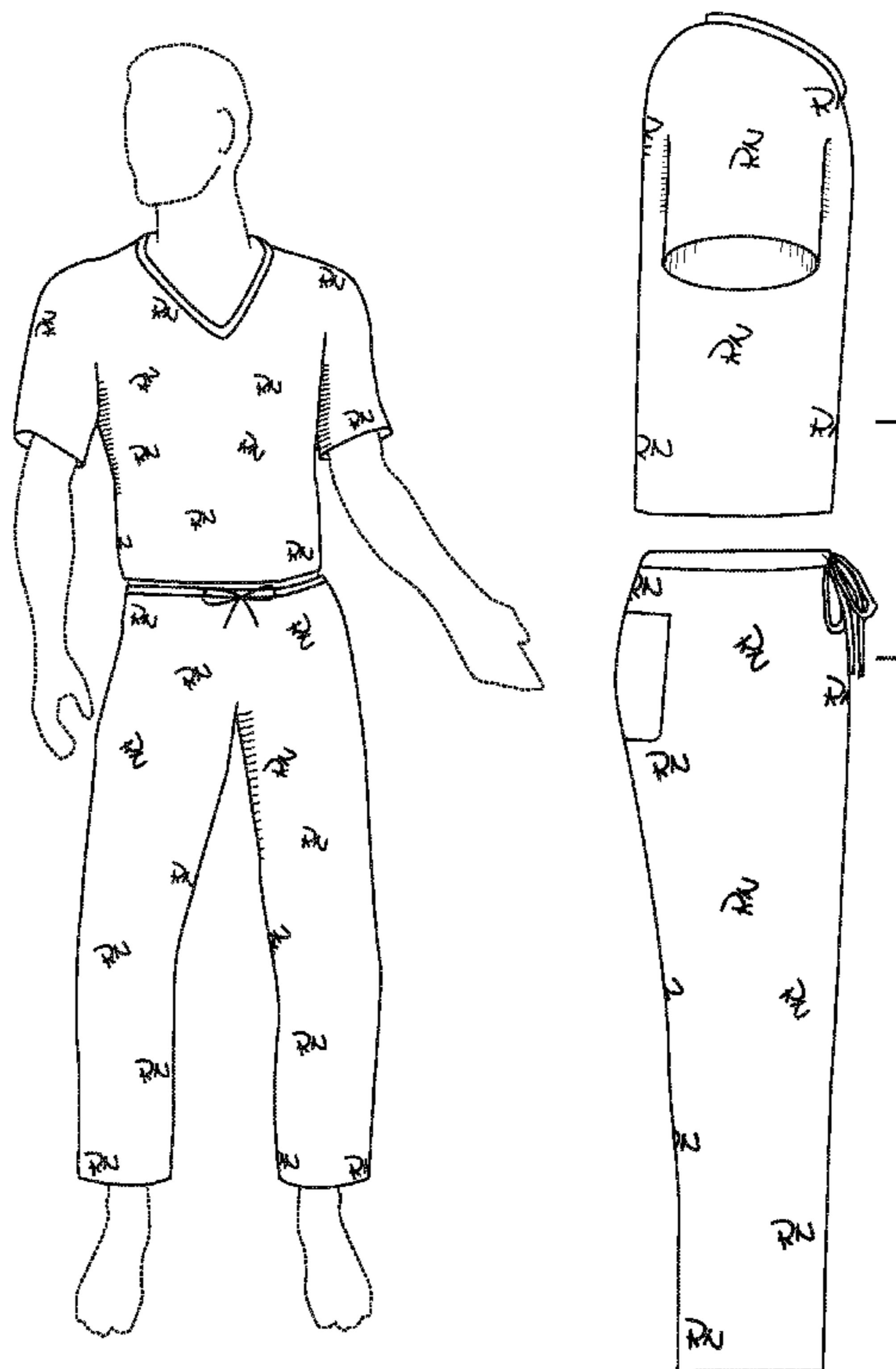

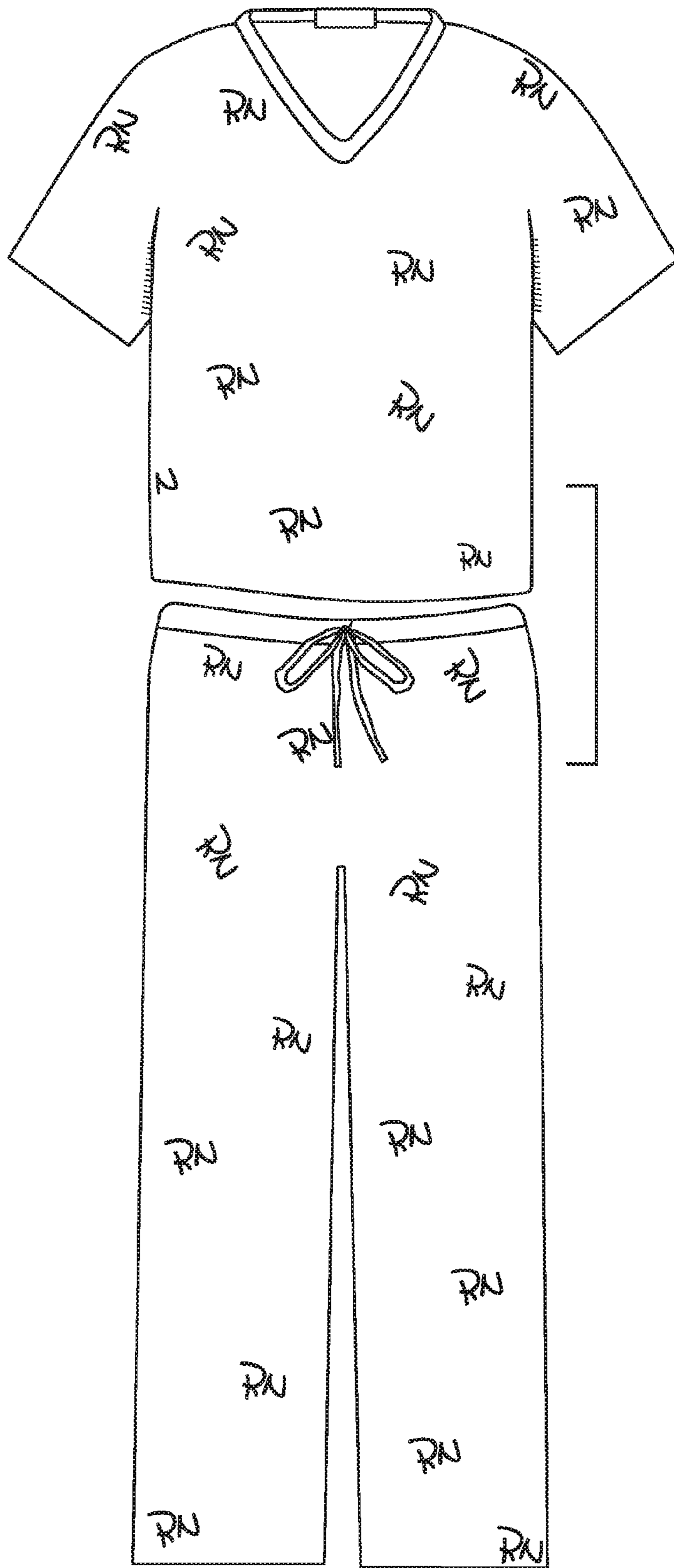

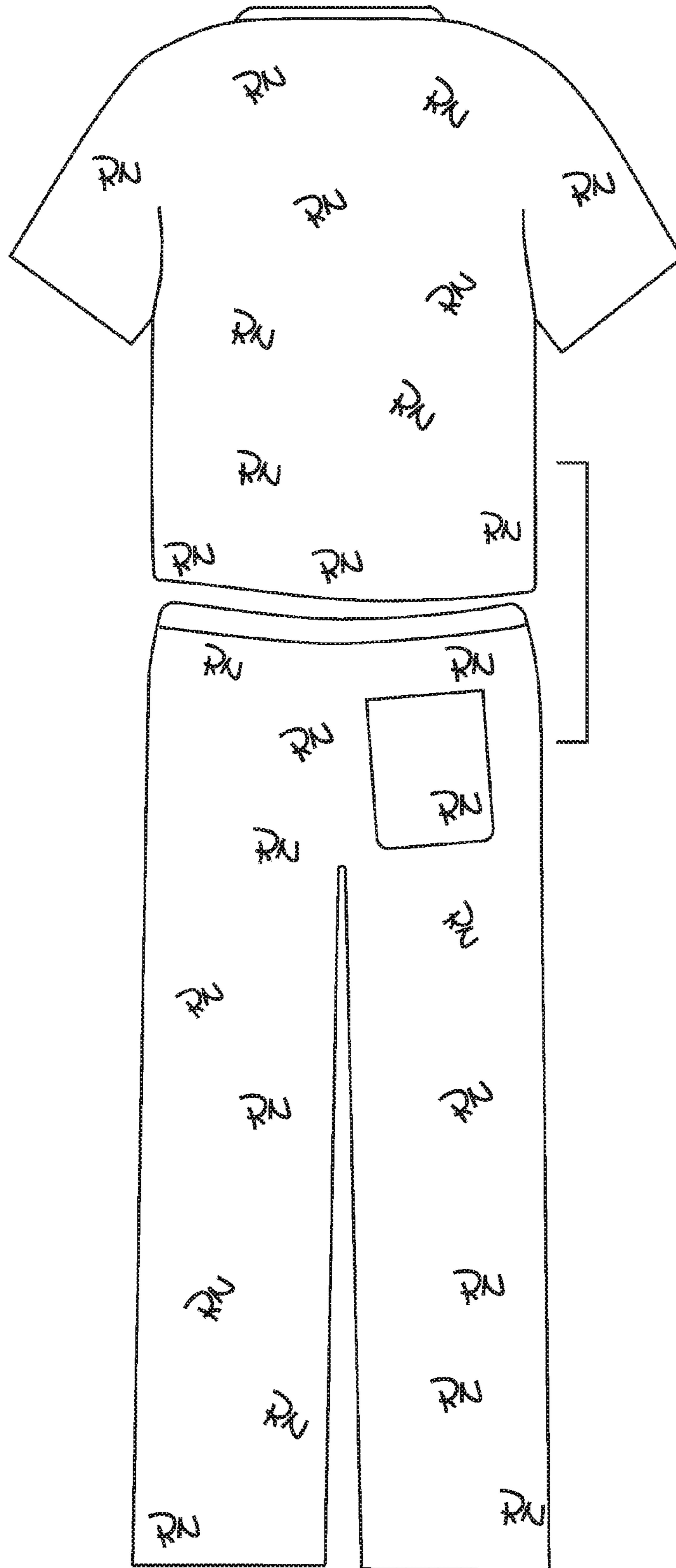

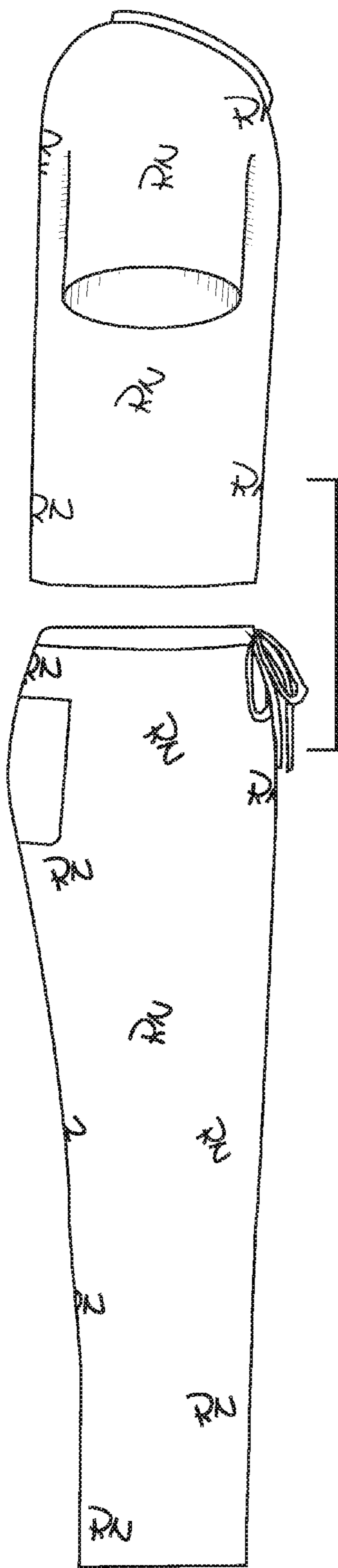
