(57) **CLAIM**

The ornamental design for a hat with bandana, as shown and described.

DESCRIPTION

FIG. 1 is a rear perspective view of the hat with bandana;

FIG. 2 is a back elevation view of the hat with bandana;

FIG. 3 is a front elevation view of the hat with bandana;

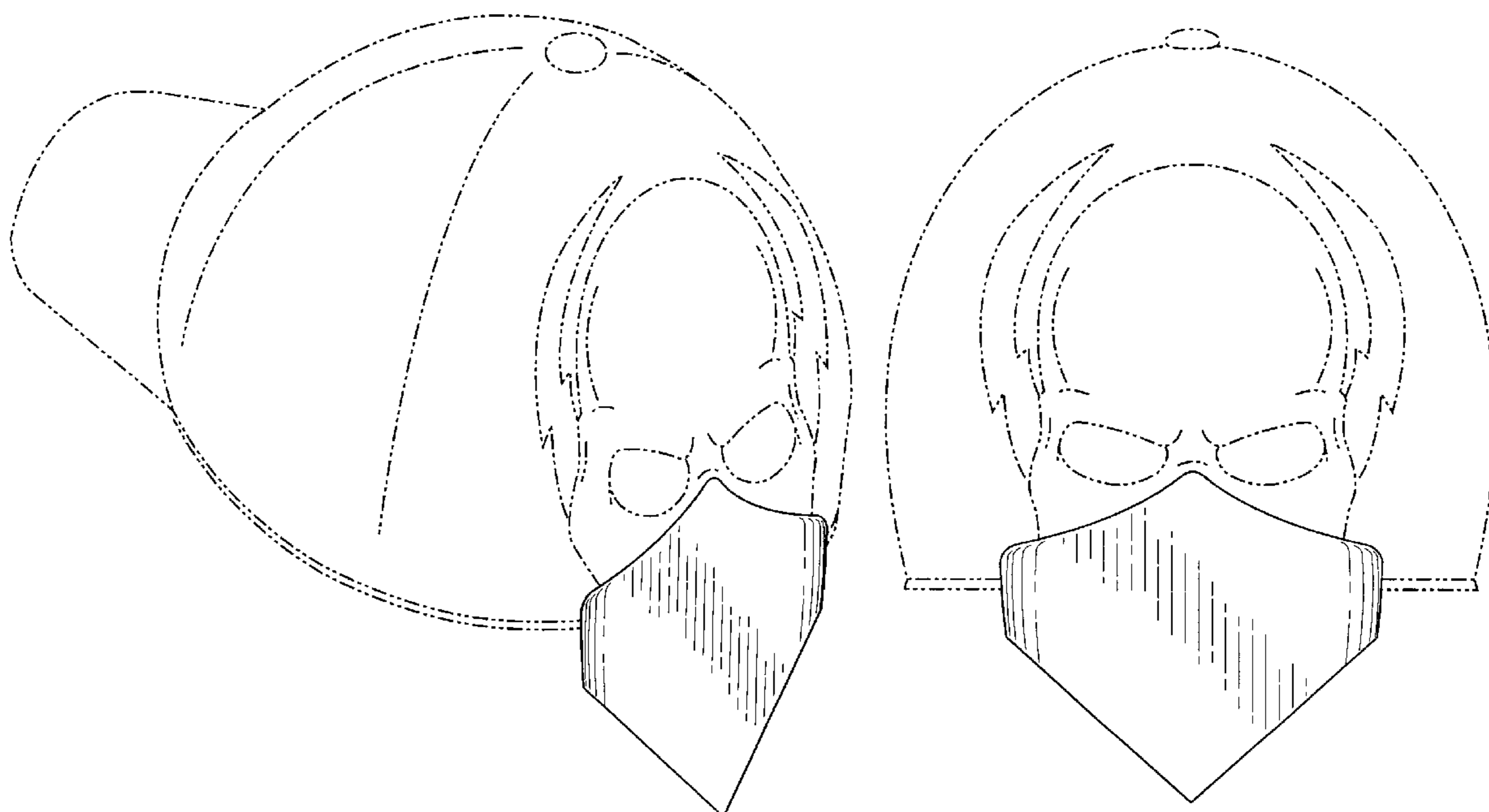
FIG. 4 is a side elevation view of the hat with bandana; the opposite side is a mirror image of the hat with bandana shown in FIG. 4;

FIG. 5 is a top plan view of the hat with bandana; and,

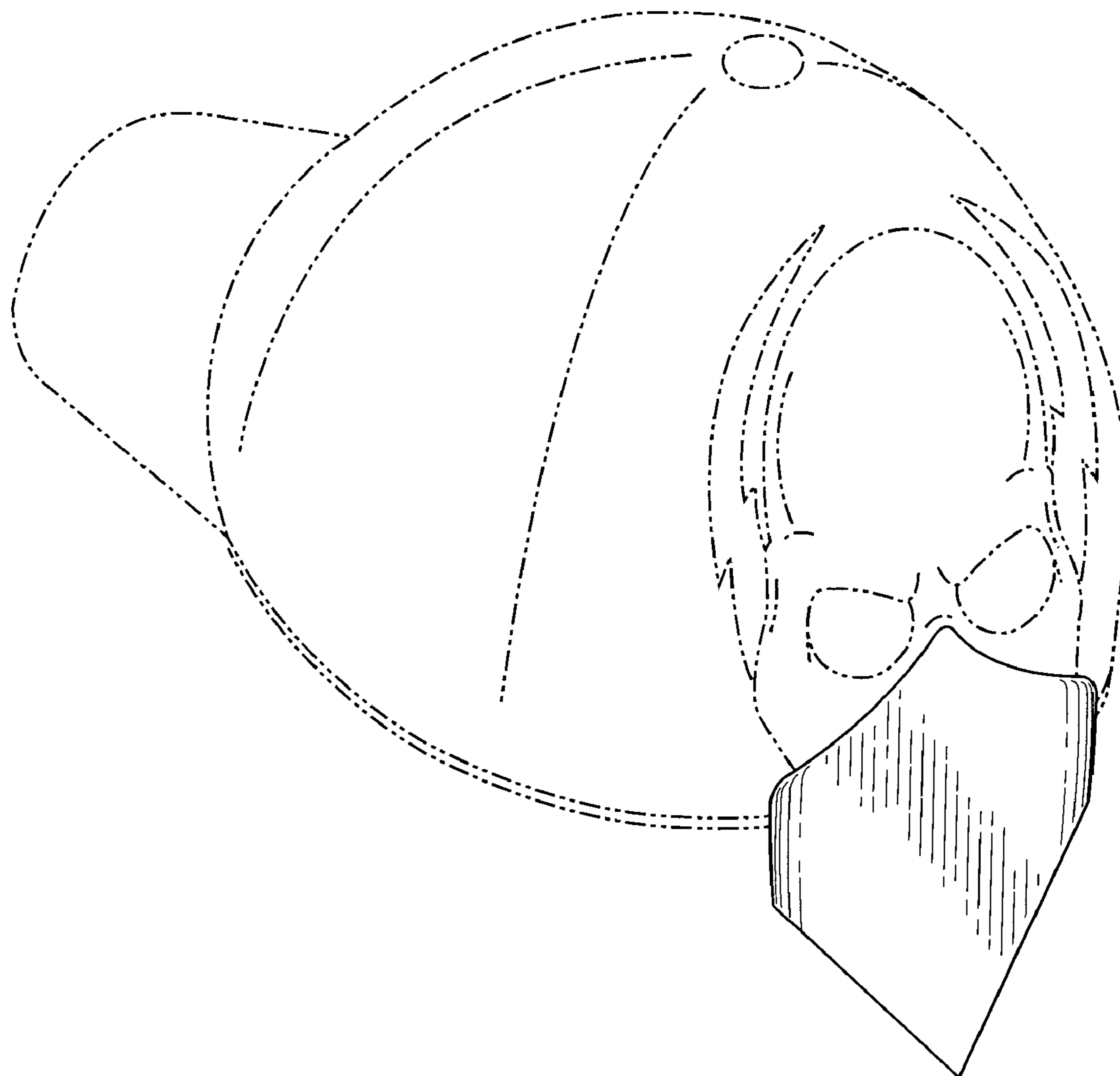

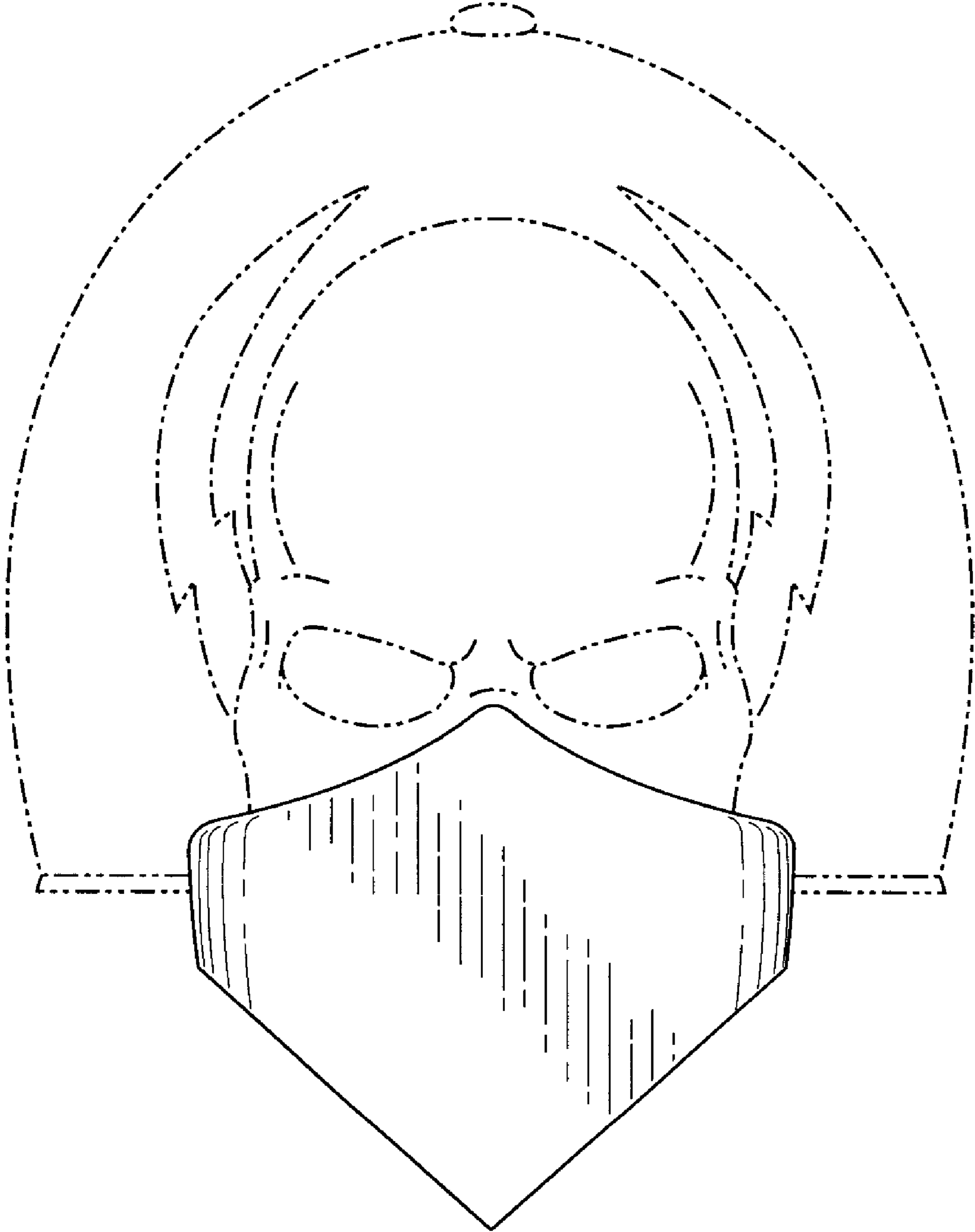

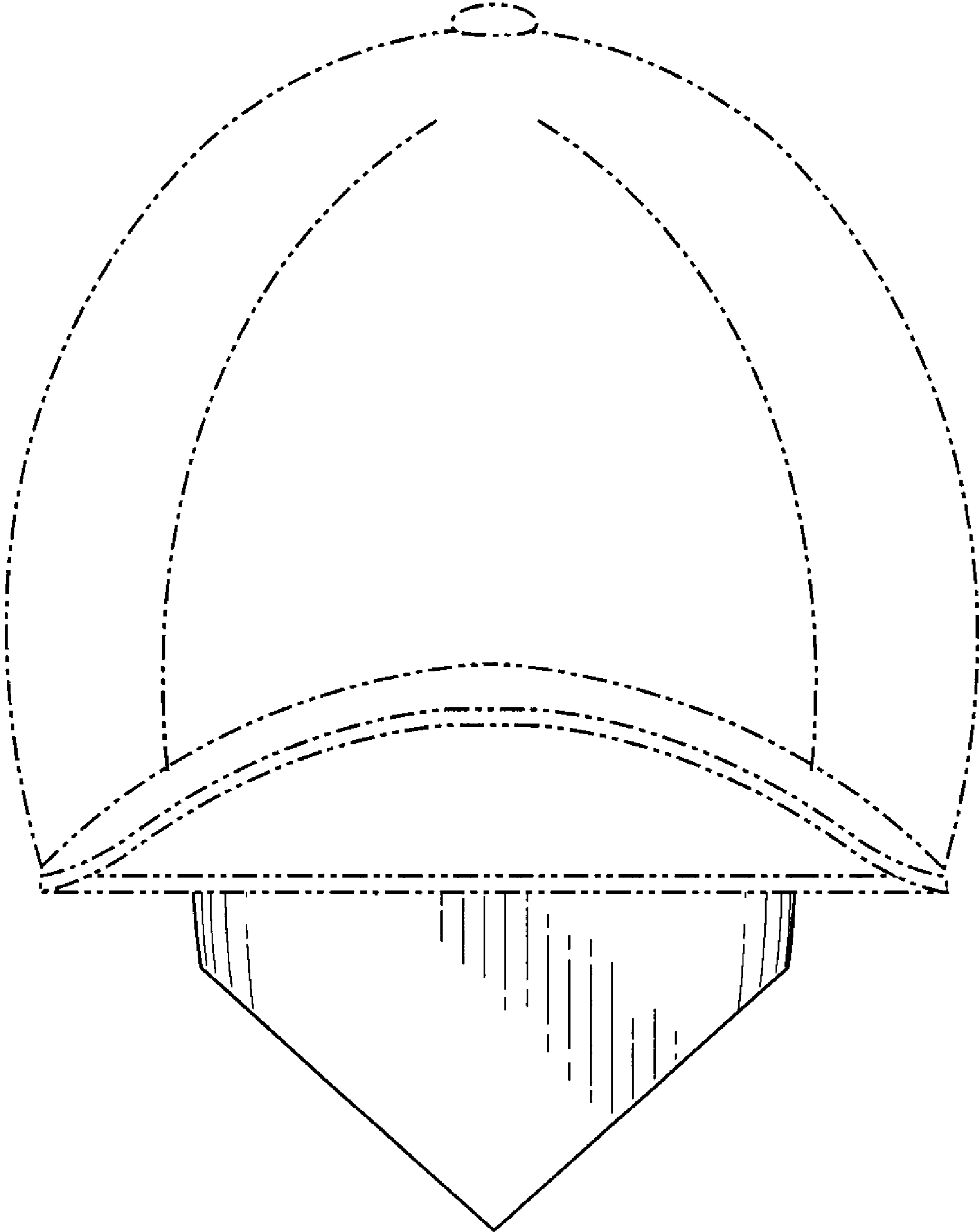

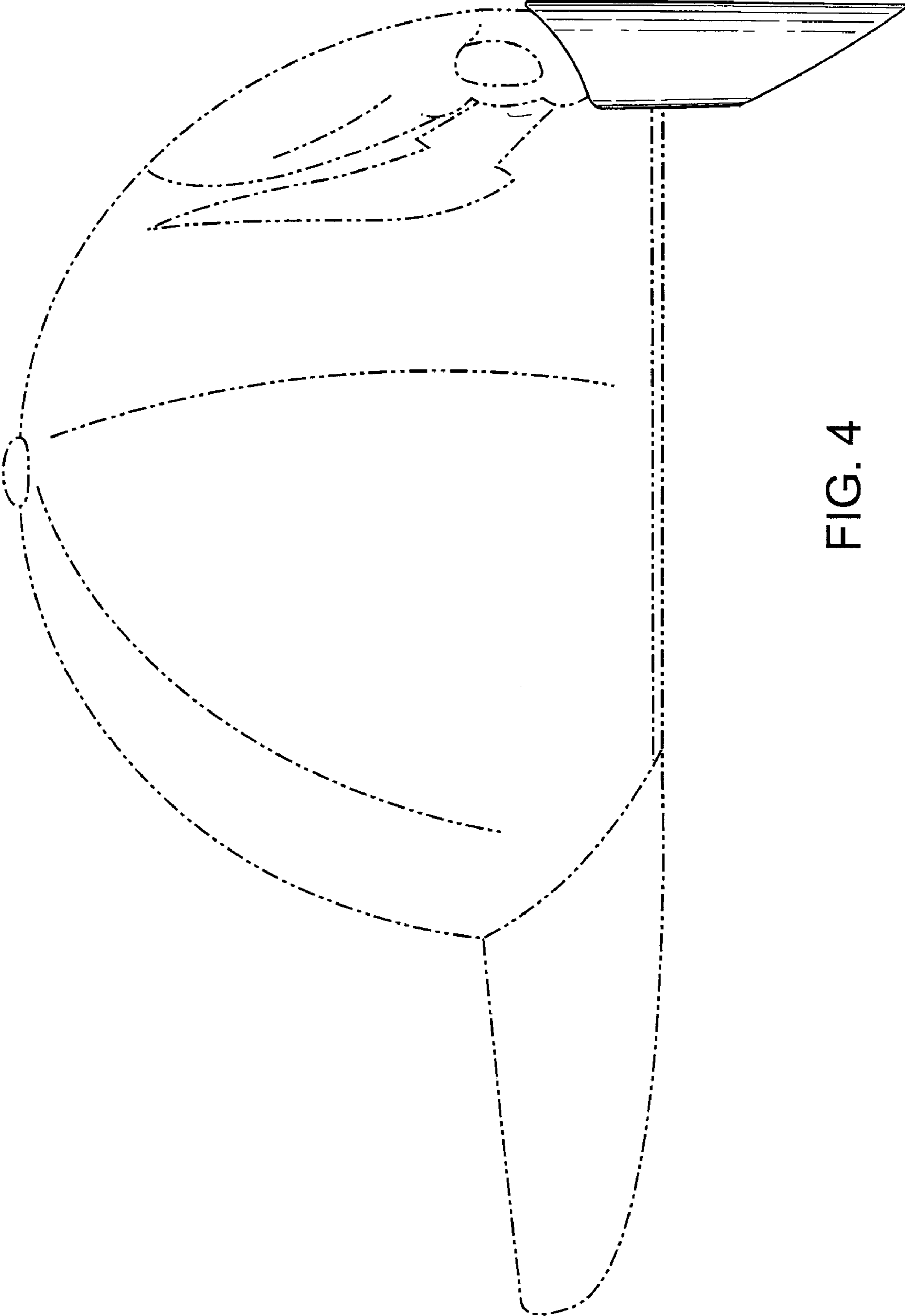

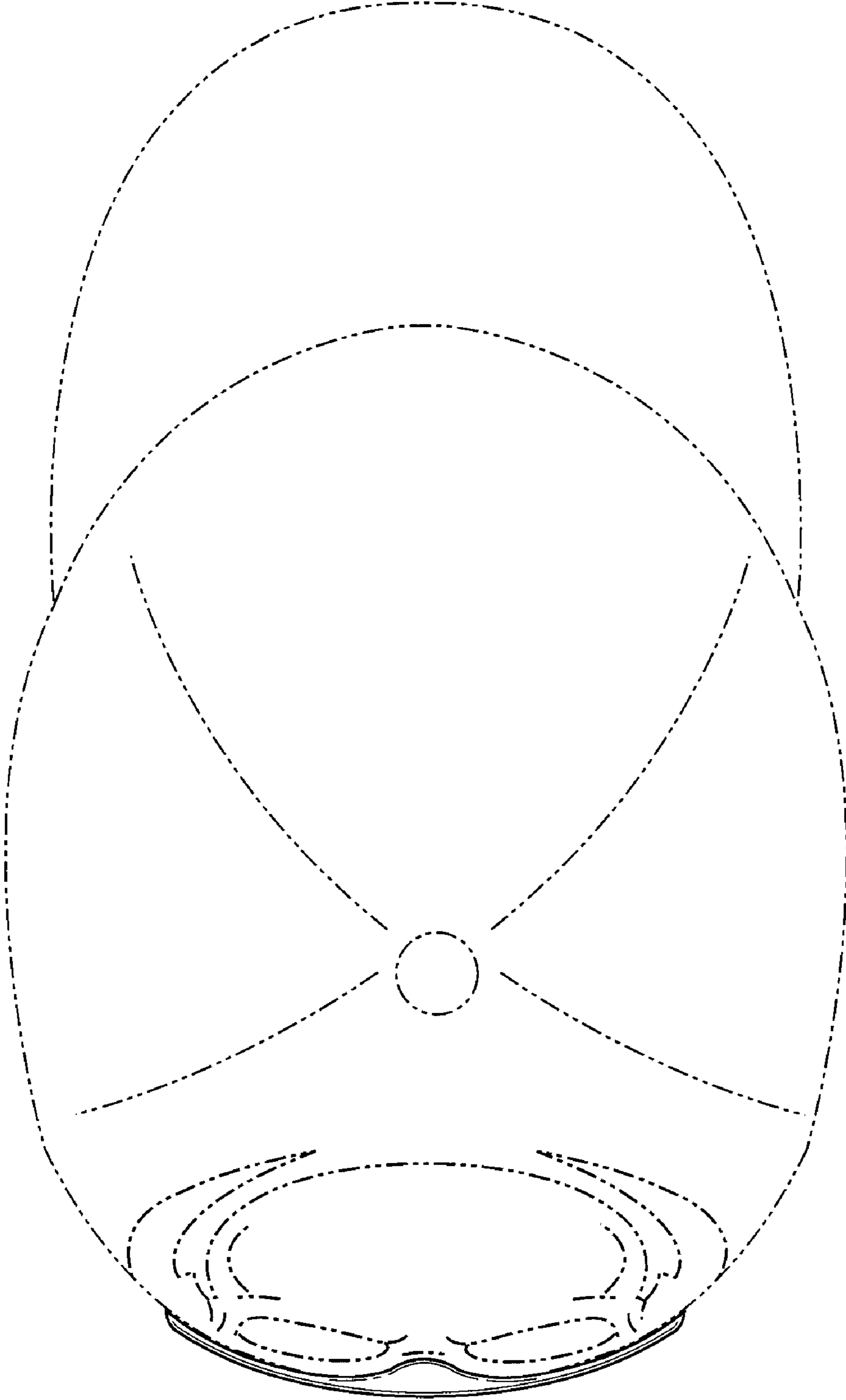

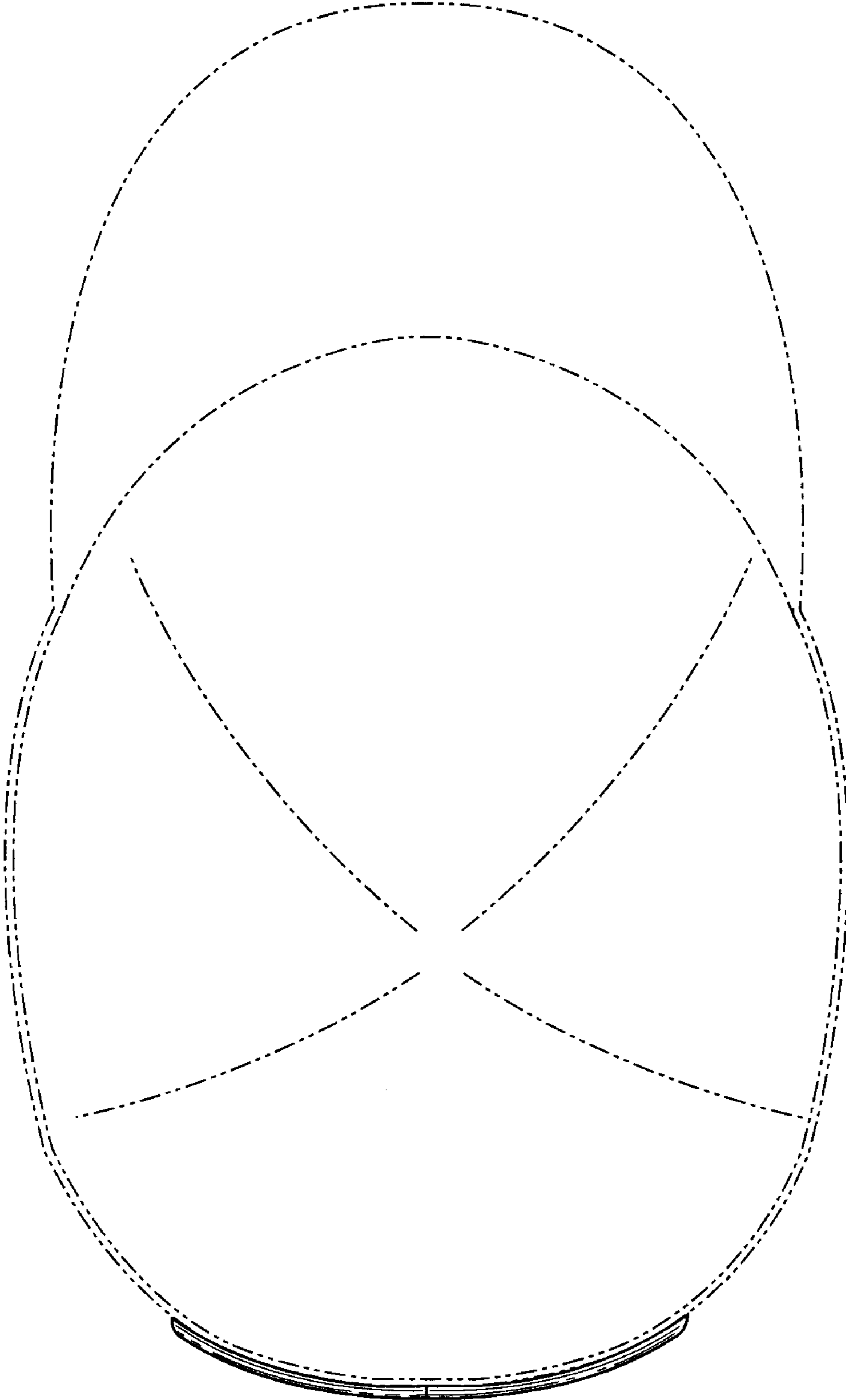
