DESCRIPTION

FIG. 1 is an upper perspective view of a sandal showing my design;

FIG. 2 is a lower perspective view of the sandal of FIG. 1;

FIG. 3 is a bottom plan view of the sandal of FIG. 1;

FIG. 4 is a top plan view of the sandal of FIG. 1;

FIG. 5 is right side elevational view of the sandal of FIG. 1;

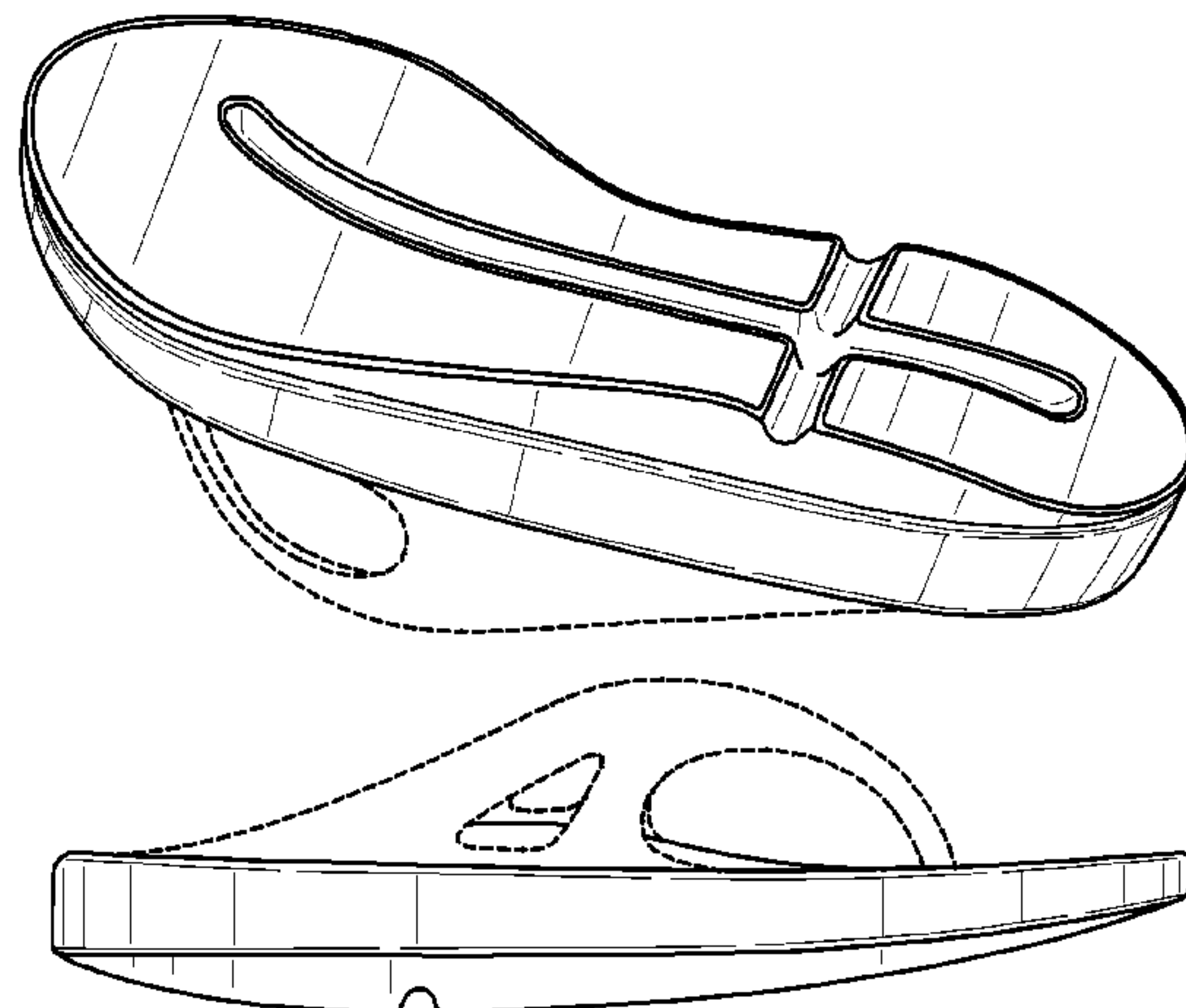
FIG. 6 is left side elevational view of the sandal of FIG. 1;

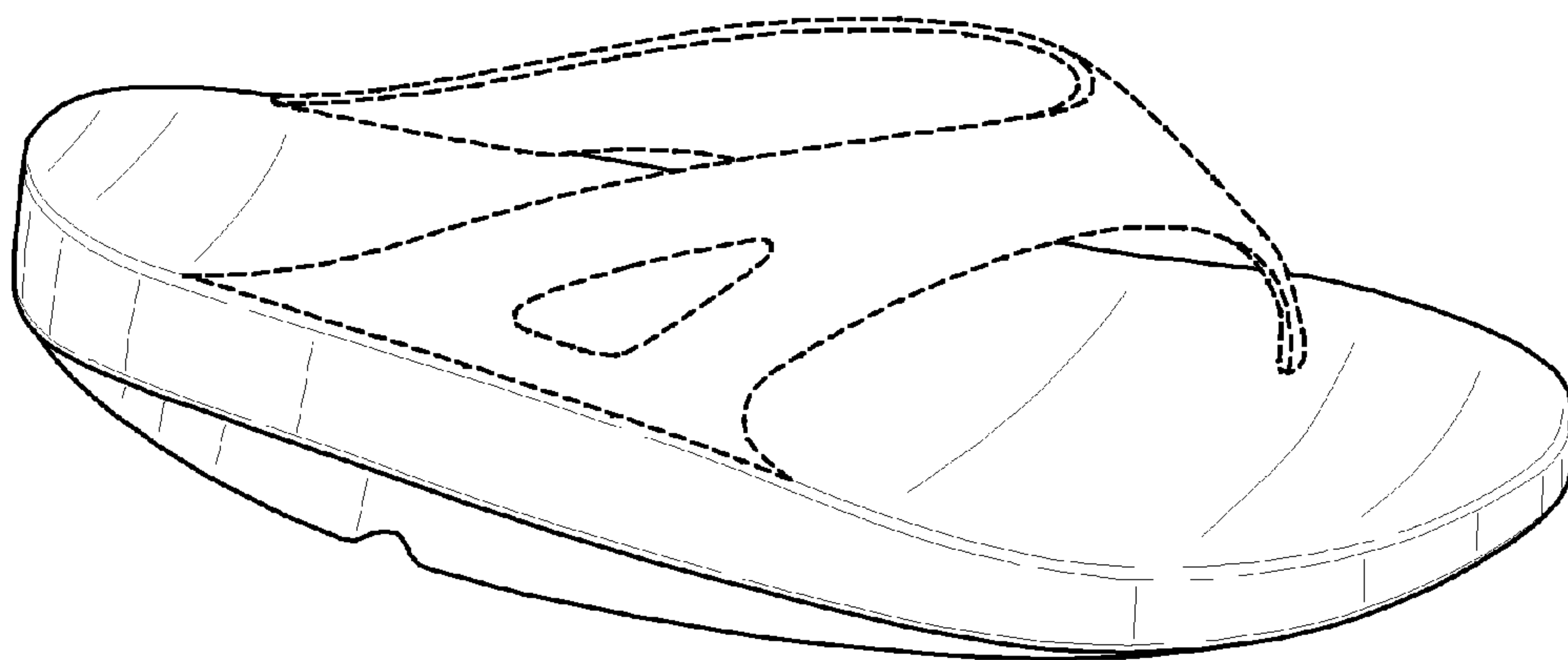

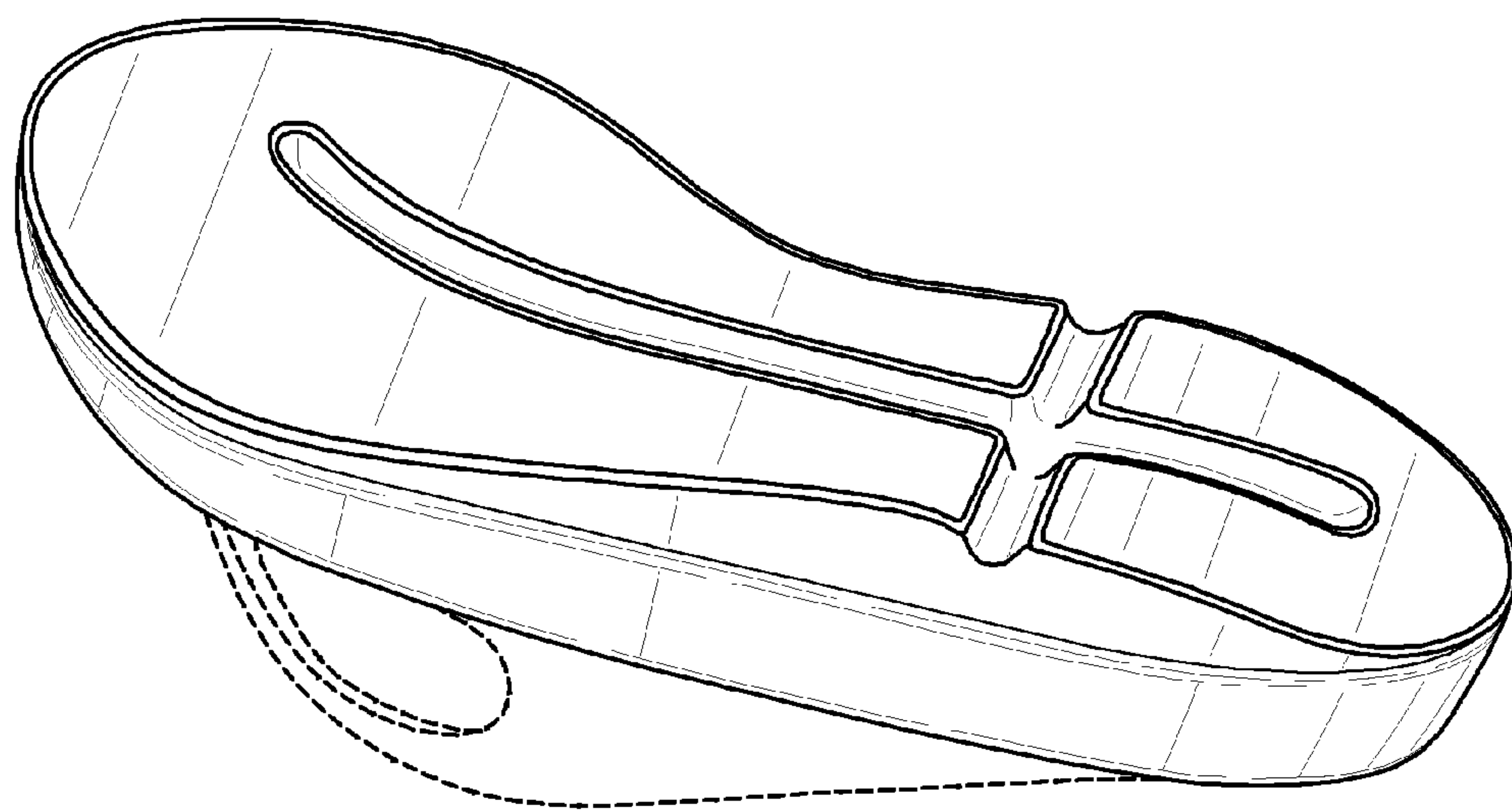

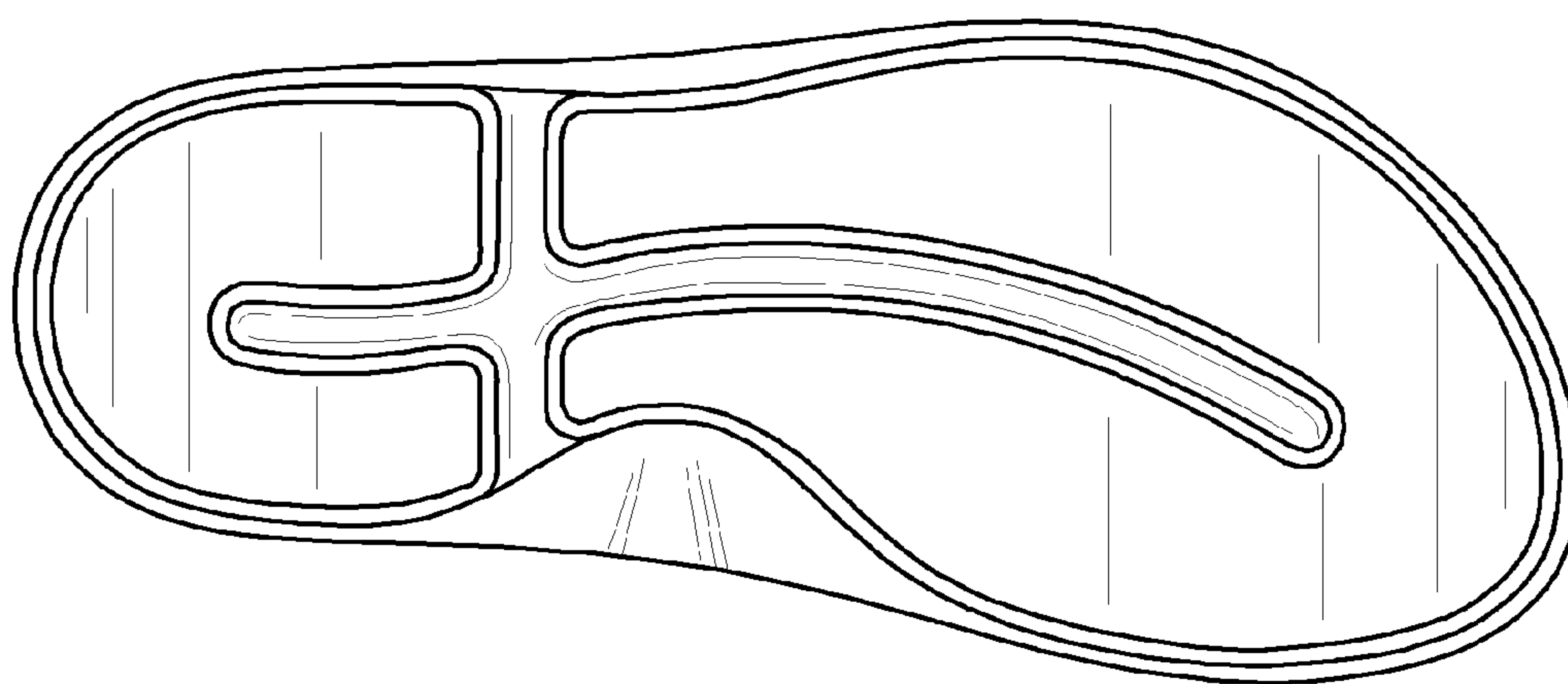

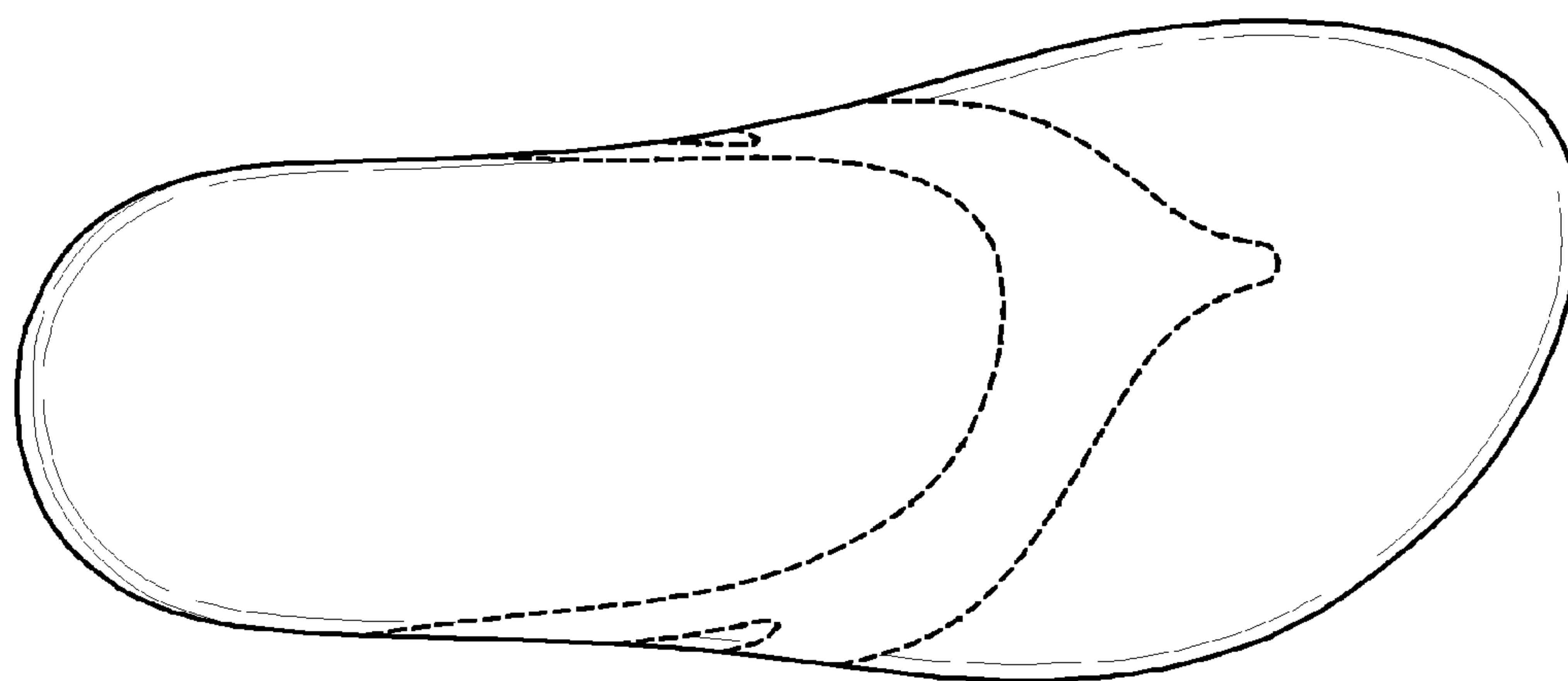

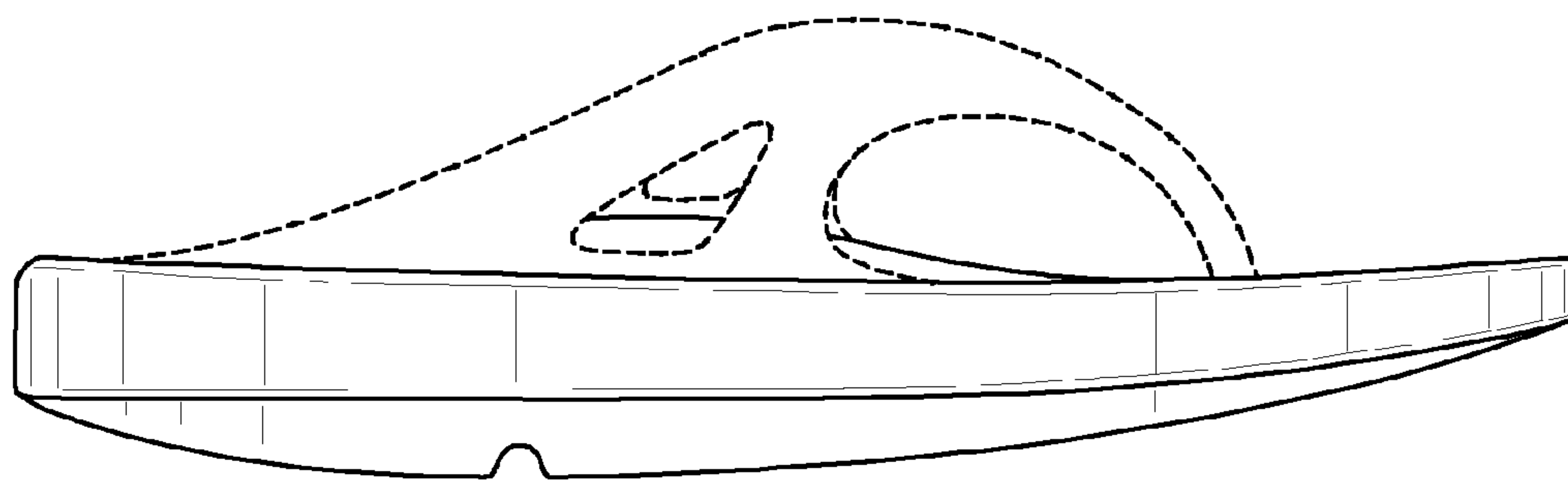

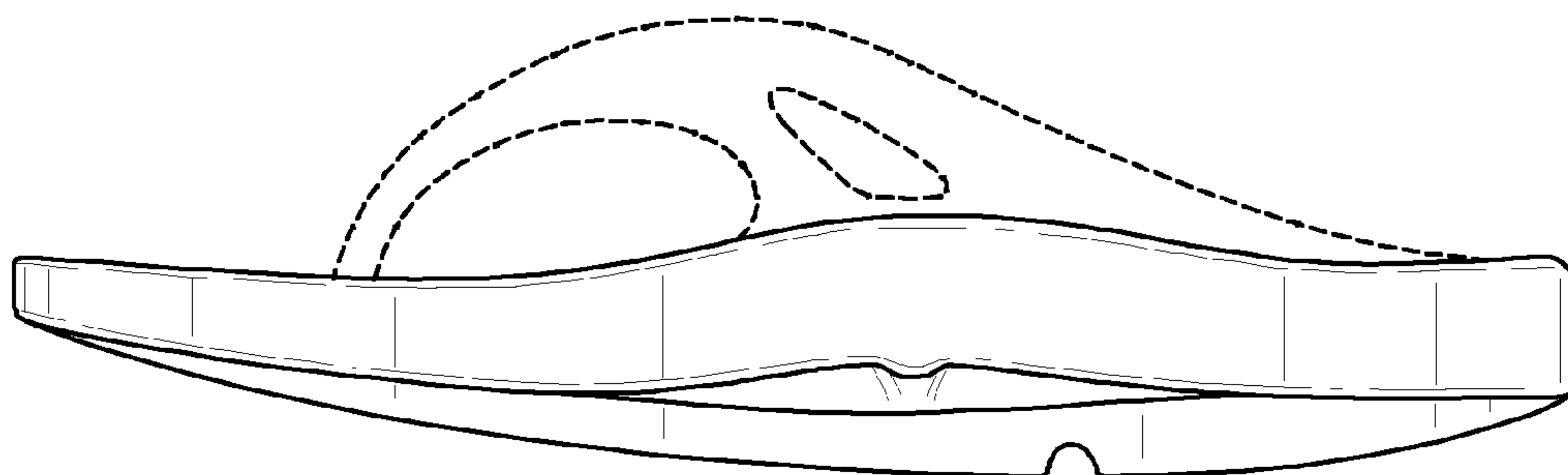

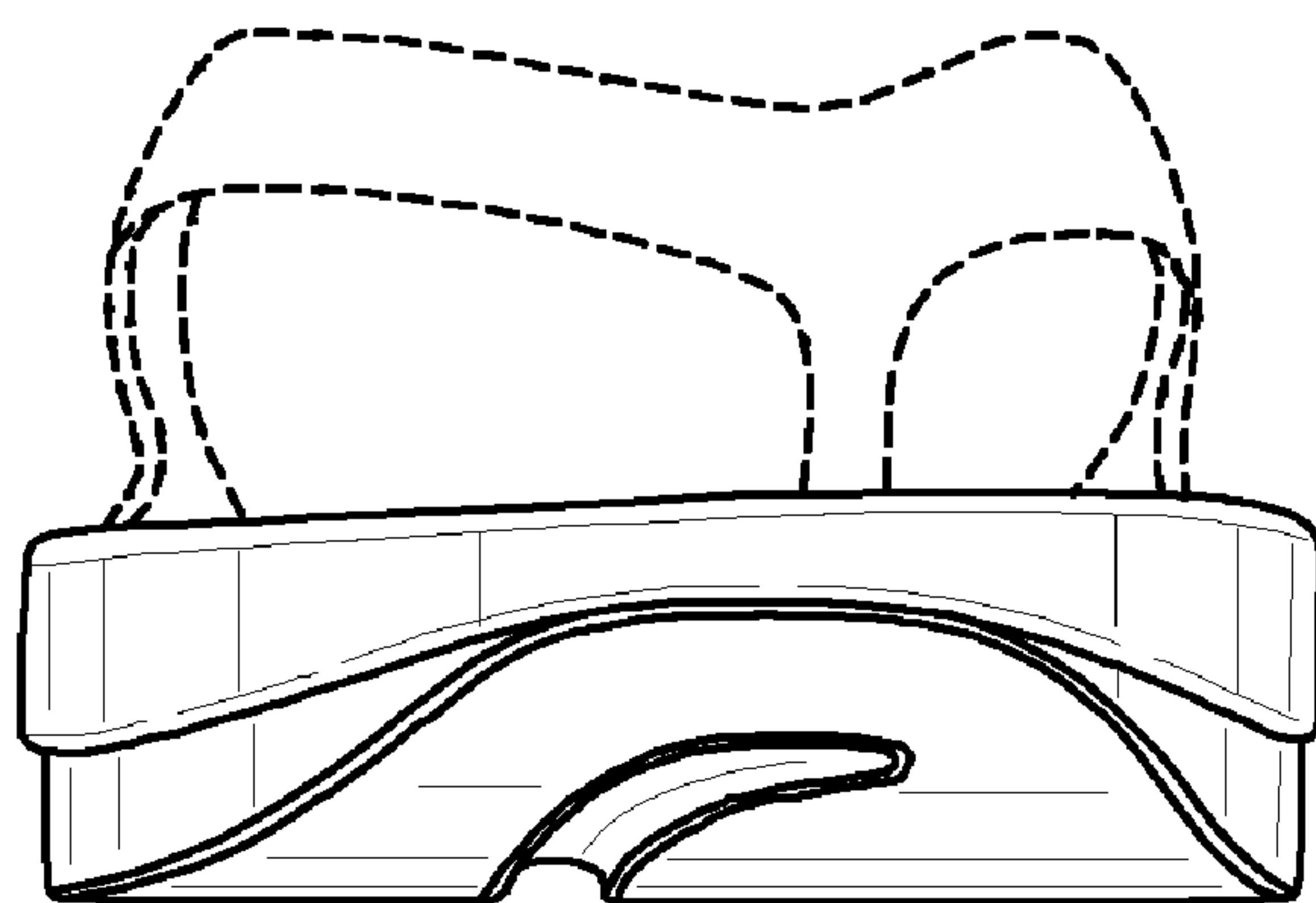

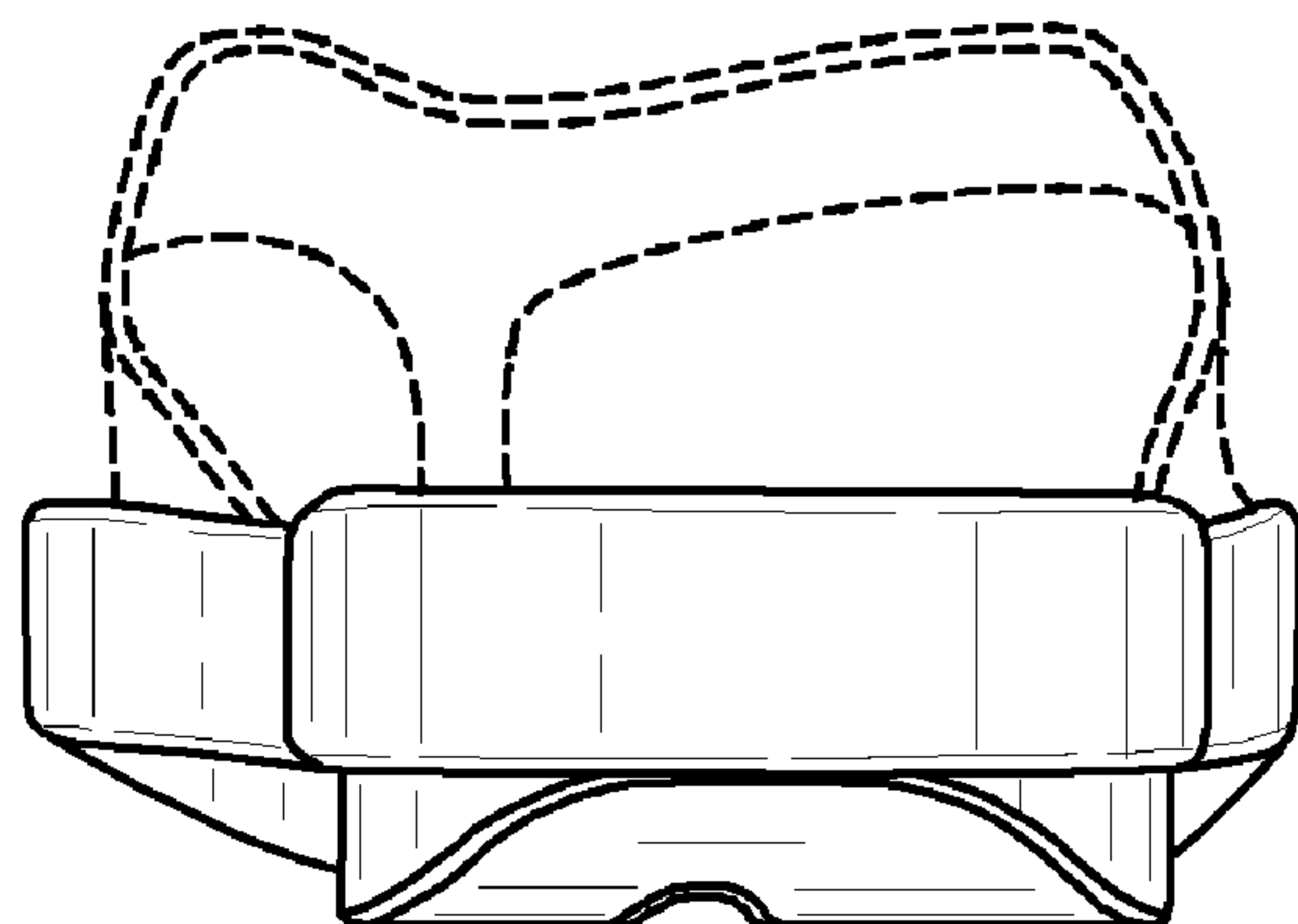
