(57) **CLAIM**

The ornamental design for a clog shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view from the front left side of a clog shoe.

FIG. 2 is a front elevation view of the clog shoe of FIG. 1.

FIG. 3 is a left side elevation view of the clog shoe of FIG. 1.

FIG. 4 is a perspective view from the front right side of the clog shoe of FIG. 1.

FIG. 5 is a rear elevation view of the clog shoe of FIG. 1.

FIG. 6 is a top plan view of the clog shoe of FIG. 1; and,

FIG. 7 is a bottom plan view of the clog shoe of FIG. 1.

The elements of the sole of the clog shoe encircled by broken lines are for illustration only and form no part of the claimed design. The drawings are not lined for color, and the design is not limited to any color, color contrast or color combination.

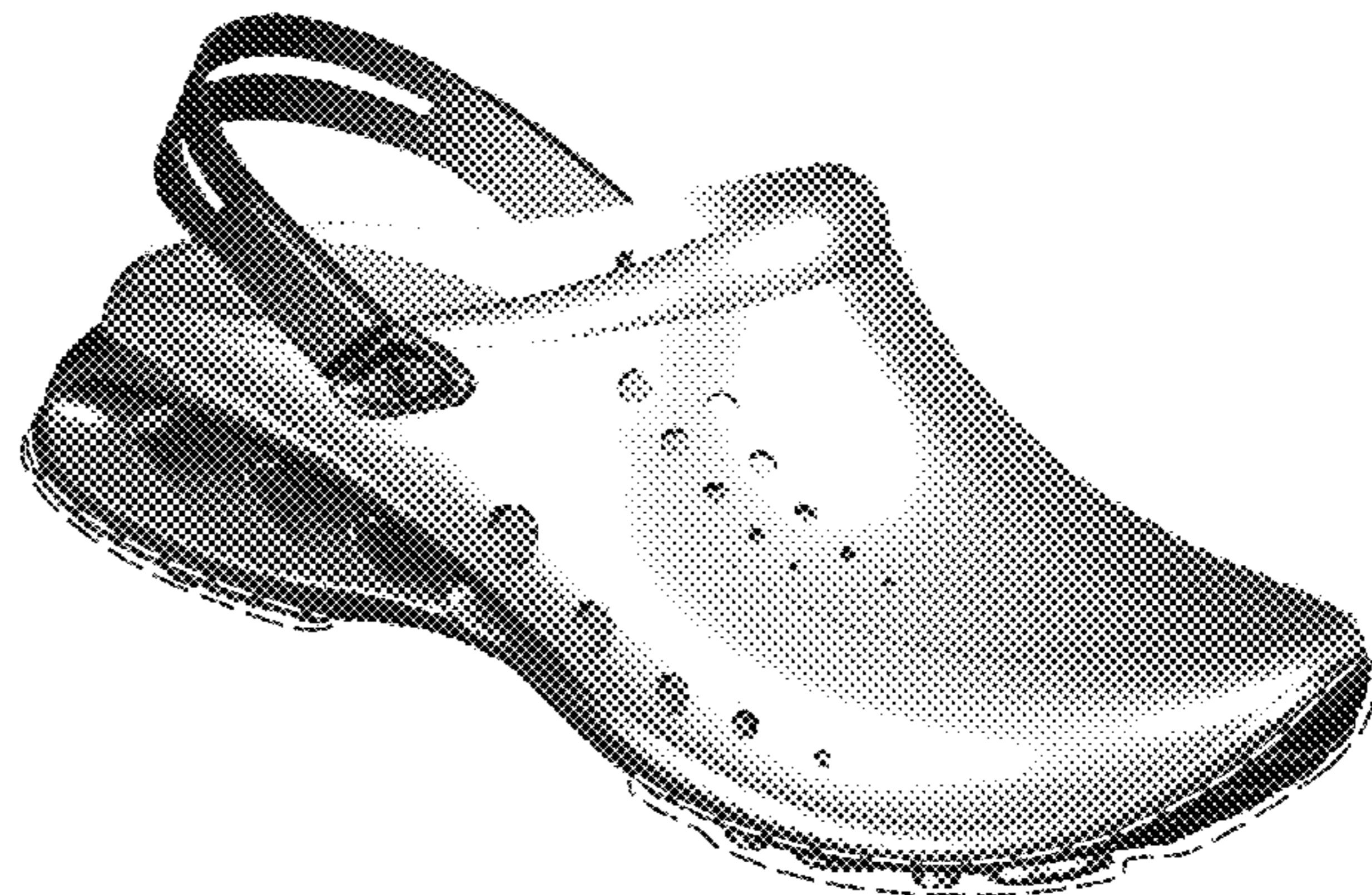

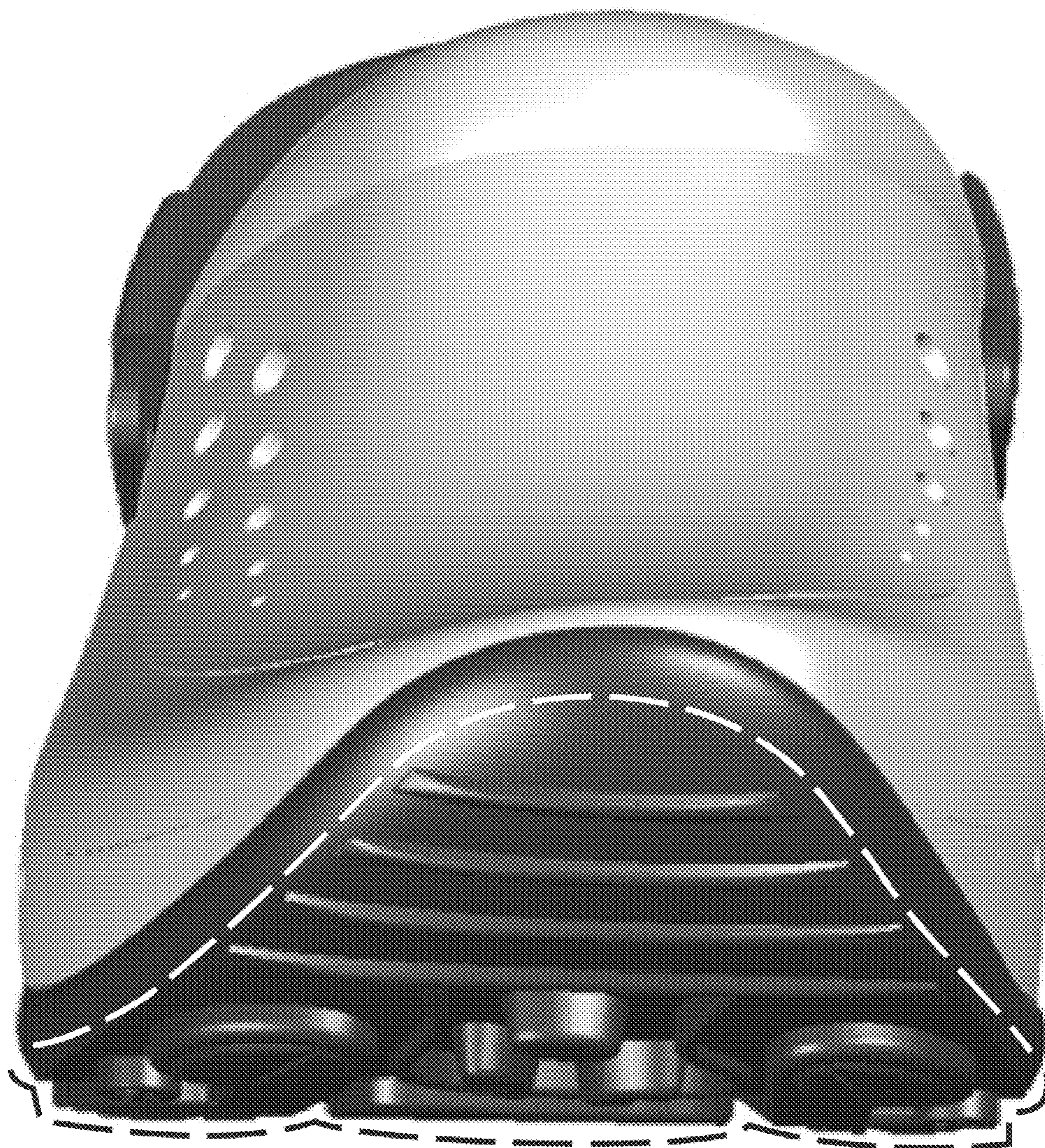
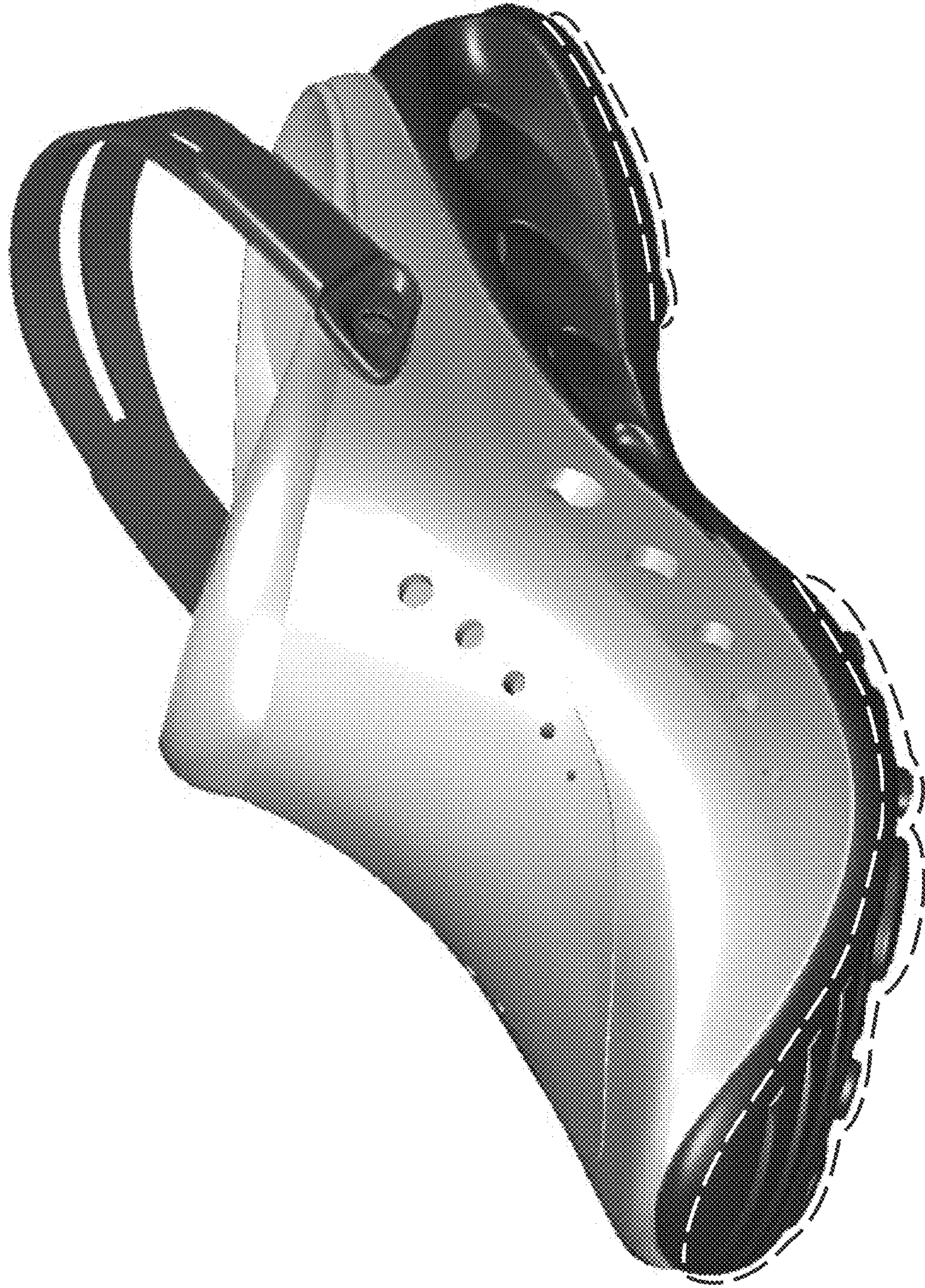

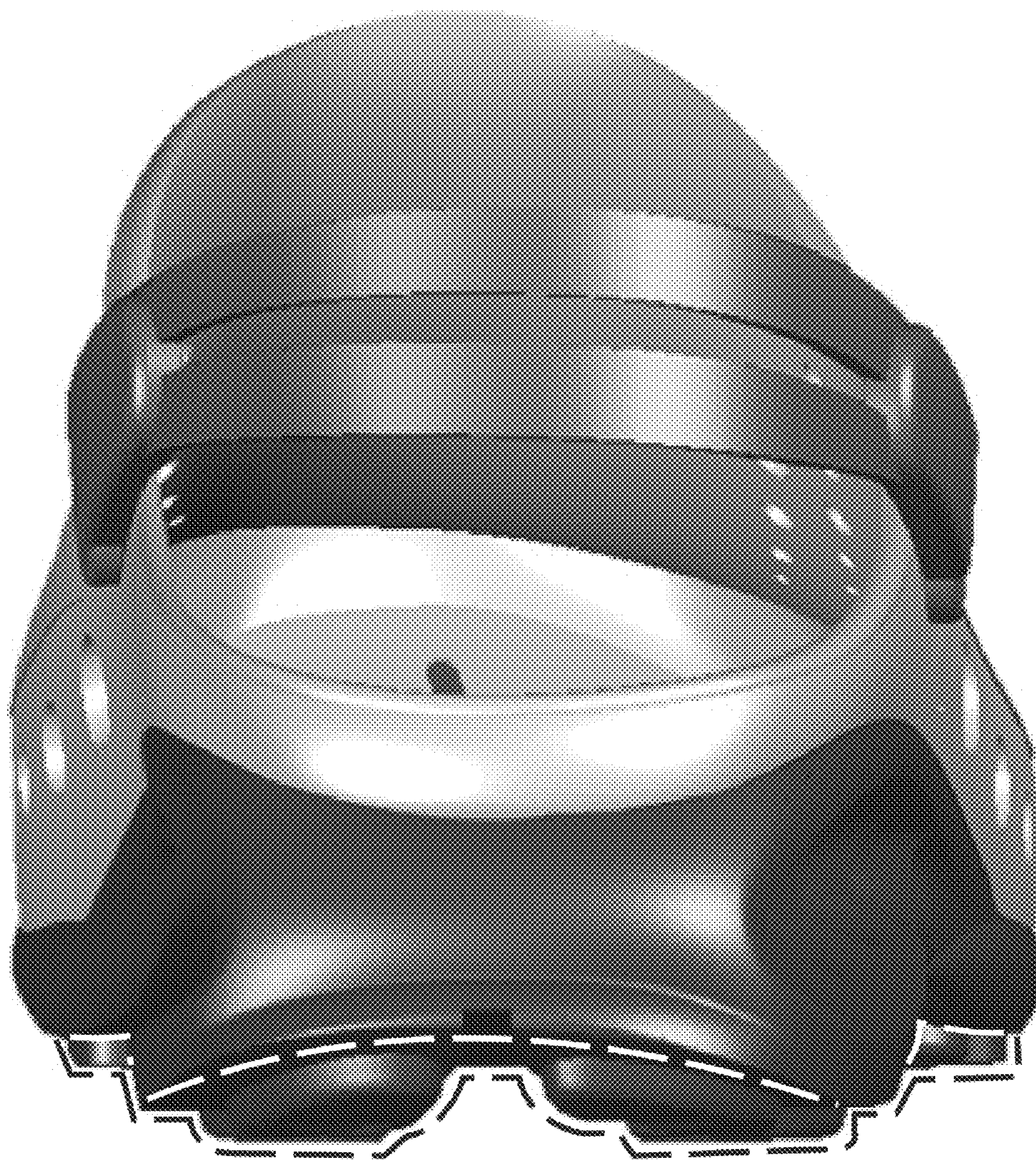

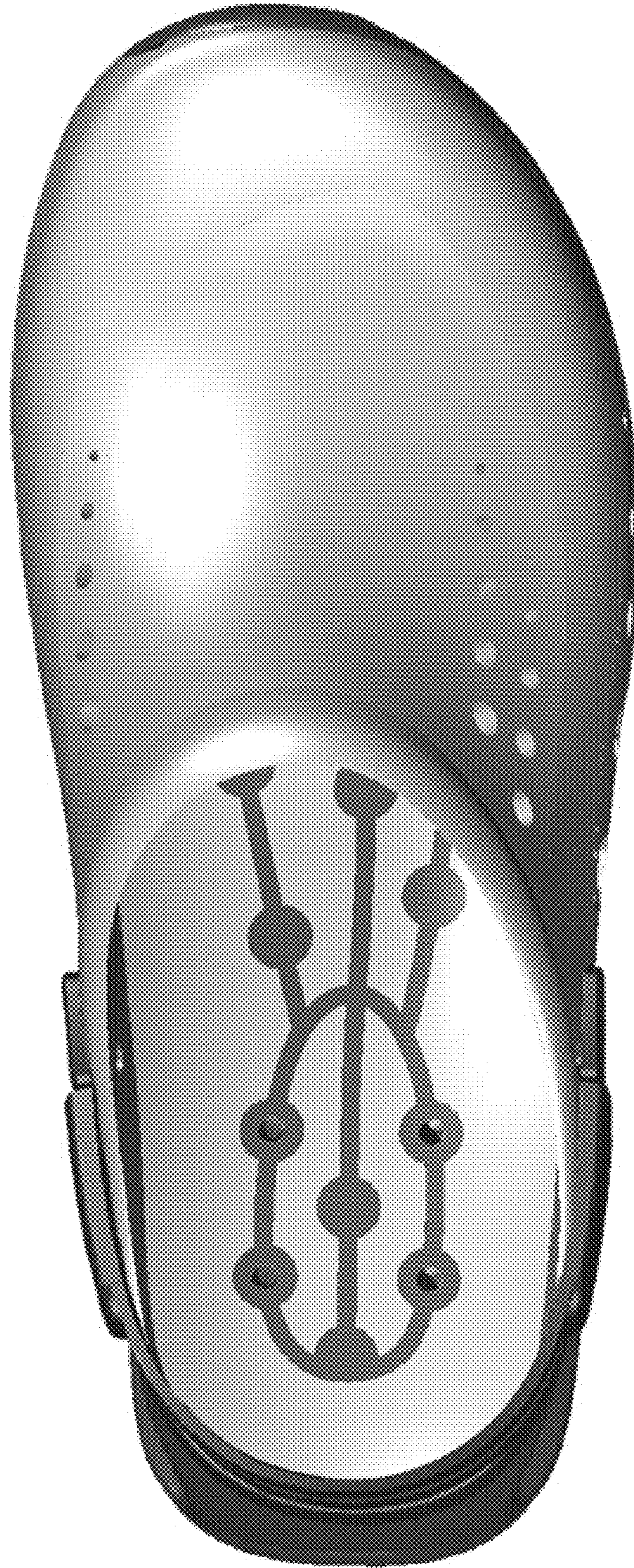
