(57) **CLAIM**

The ornamental design for hedge rake, as shown and  
described.

rakes, showing my new design;

environment;

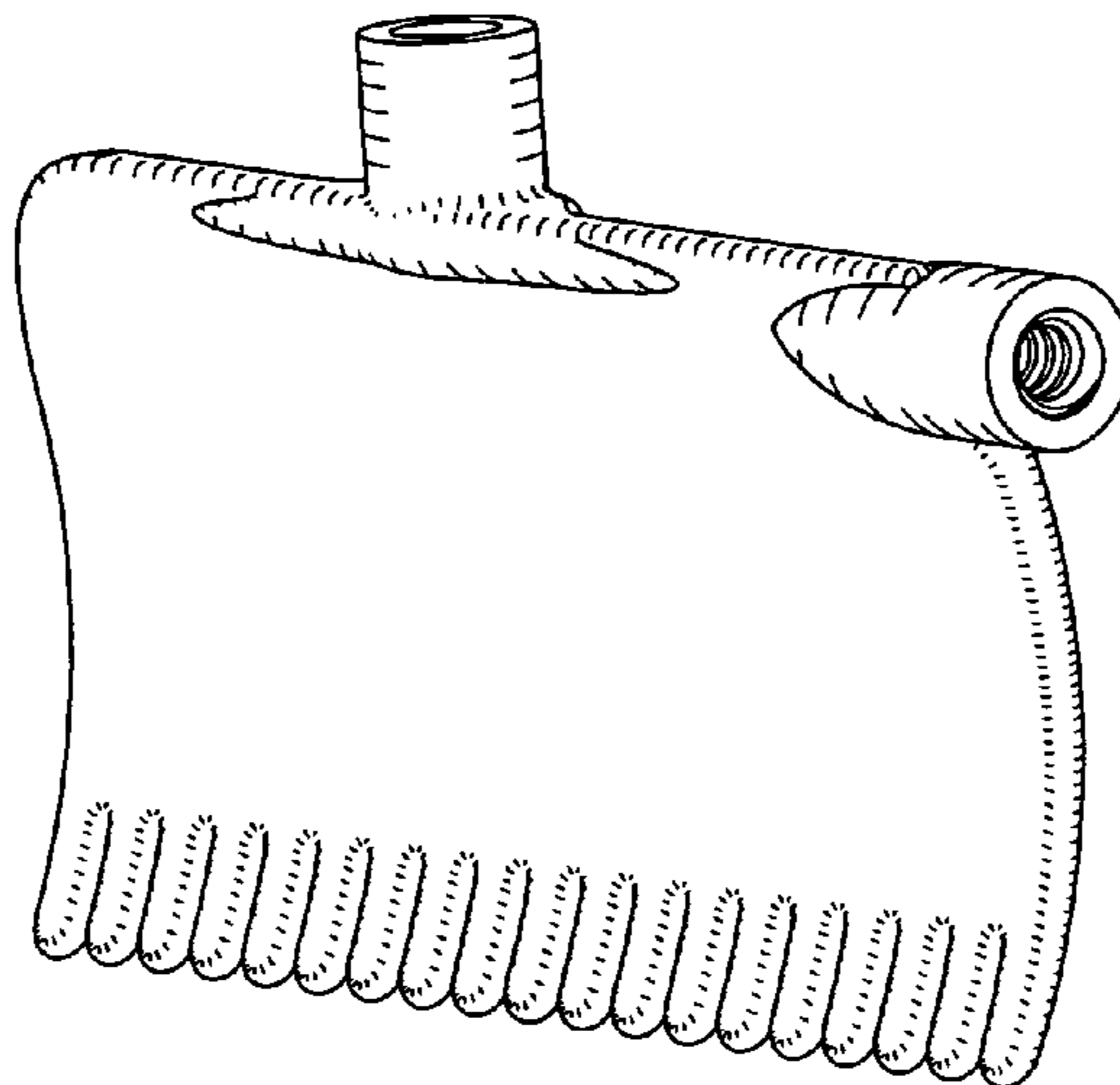
FIG. 18 shows the hedge rake of FIG. 2 in a different possible

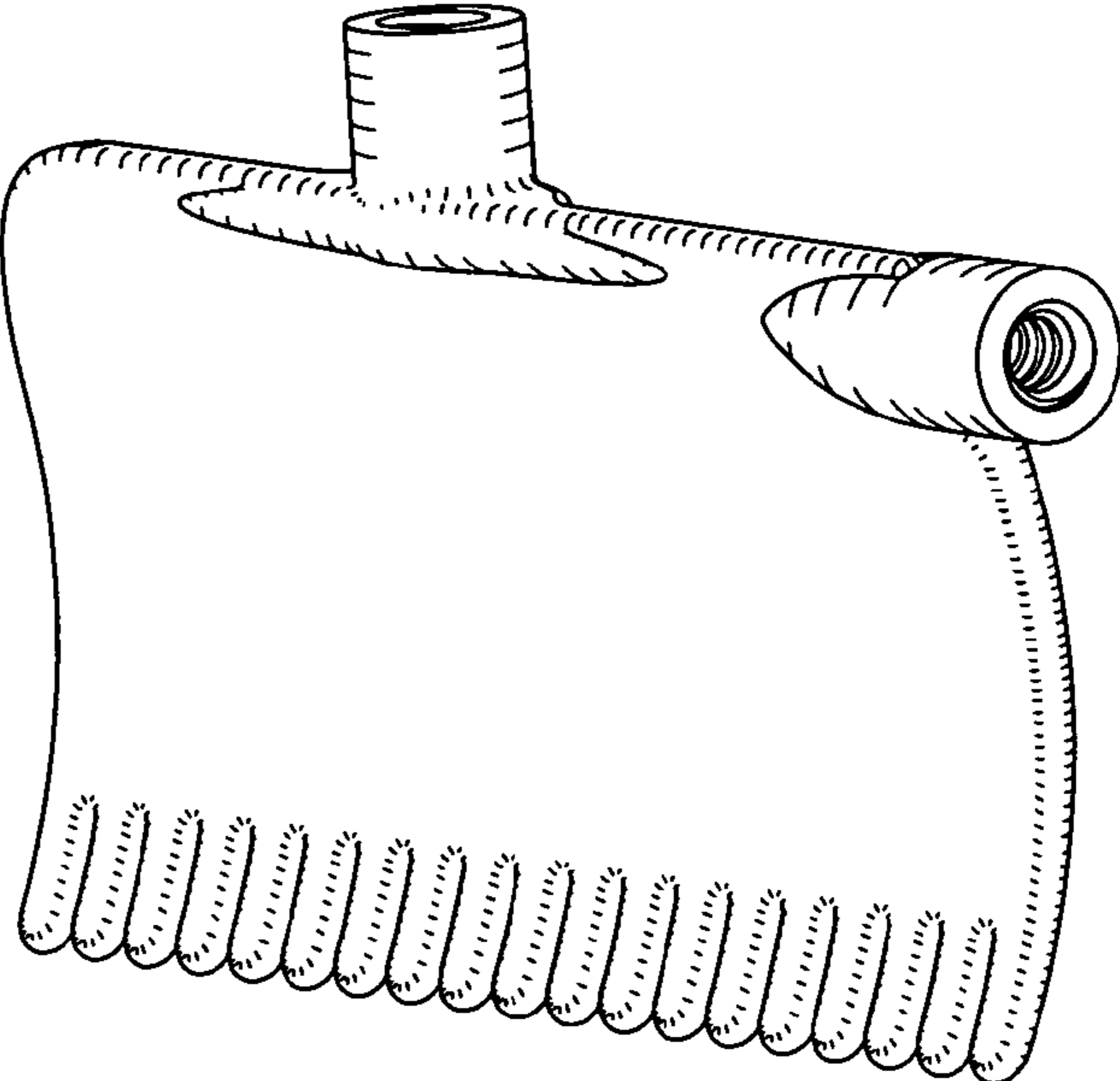

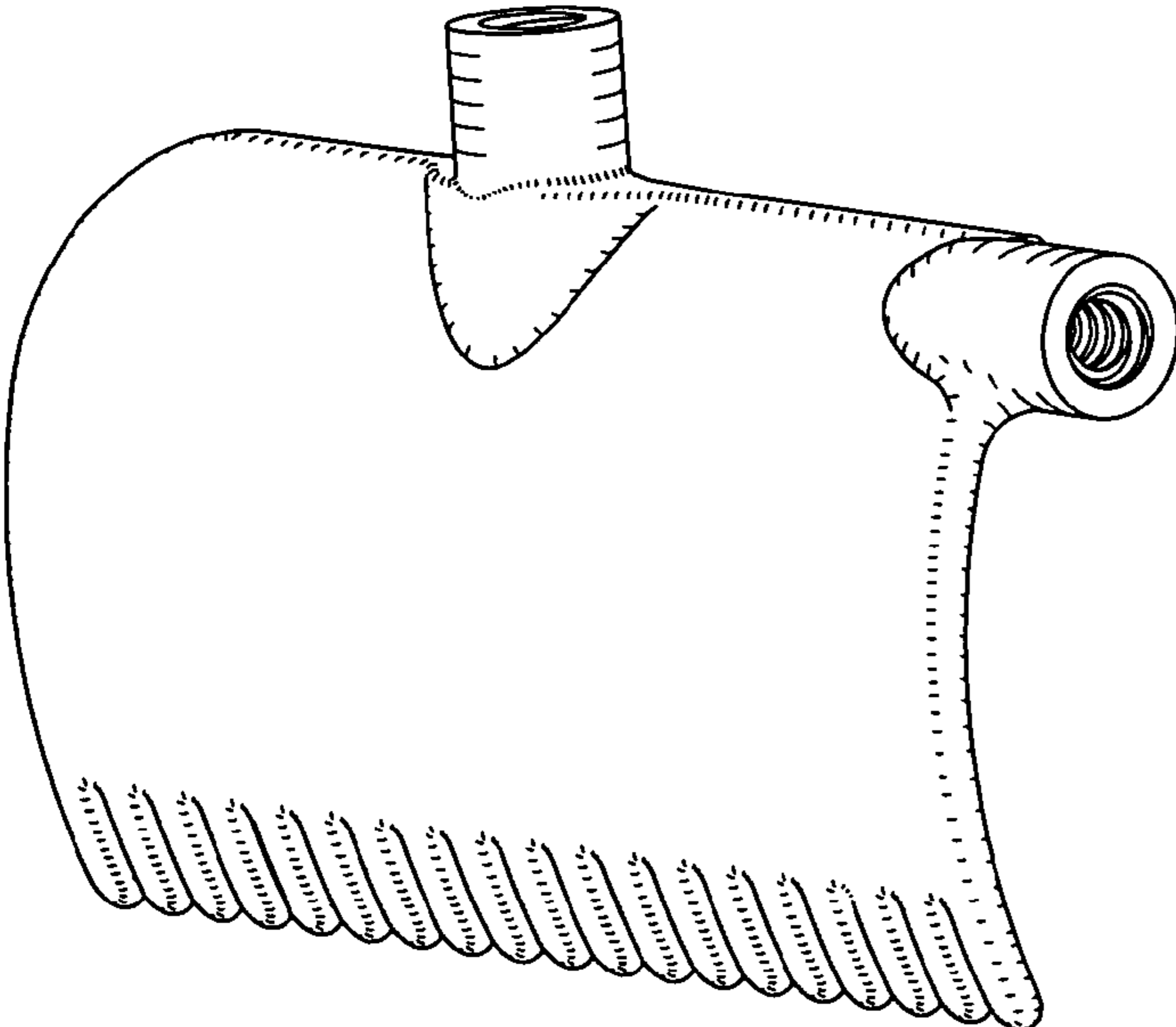

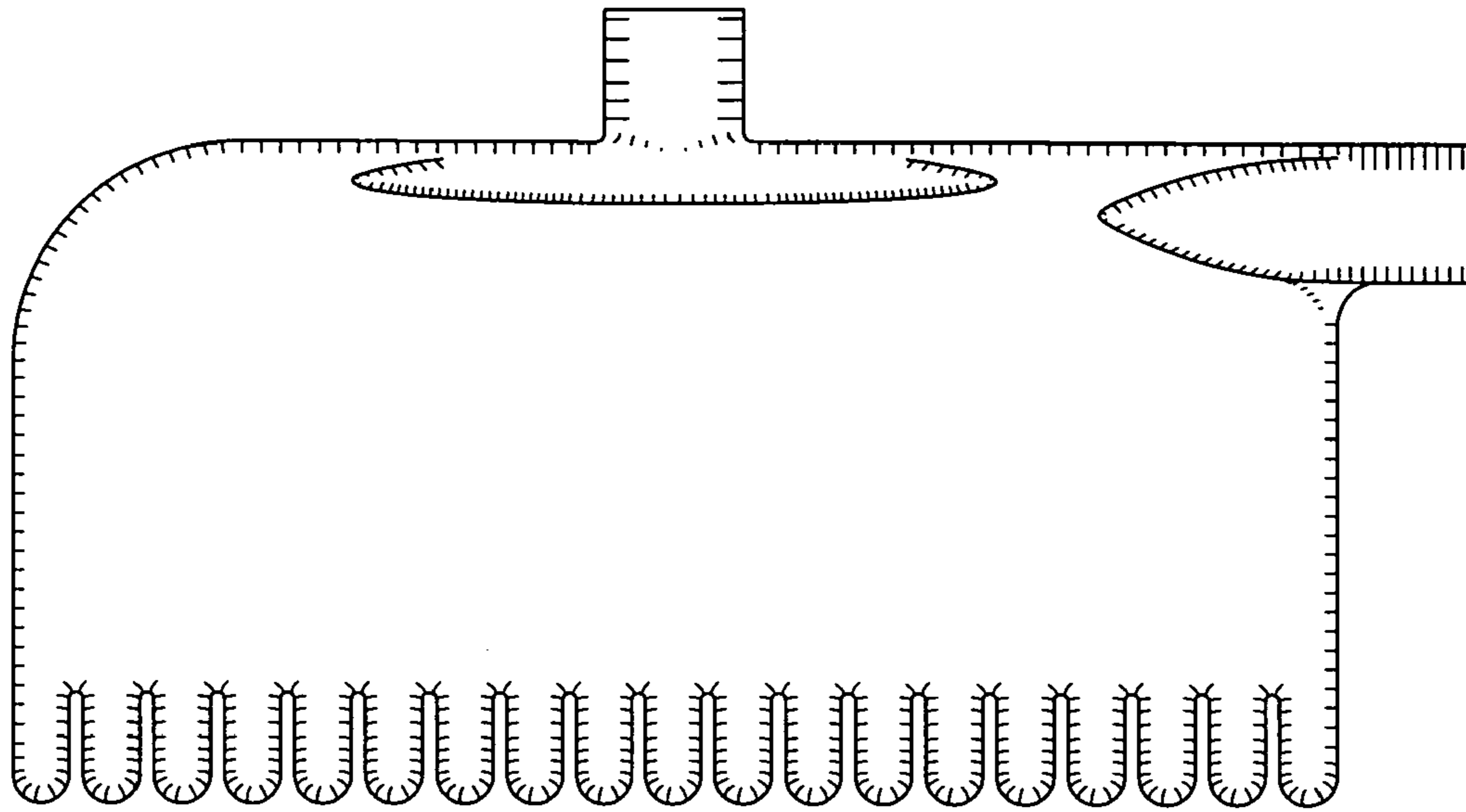

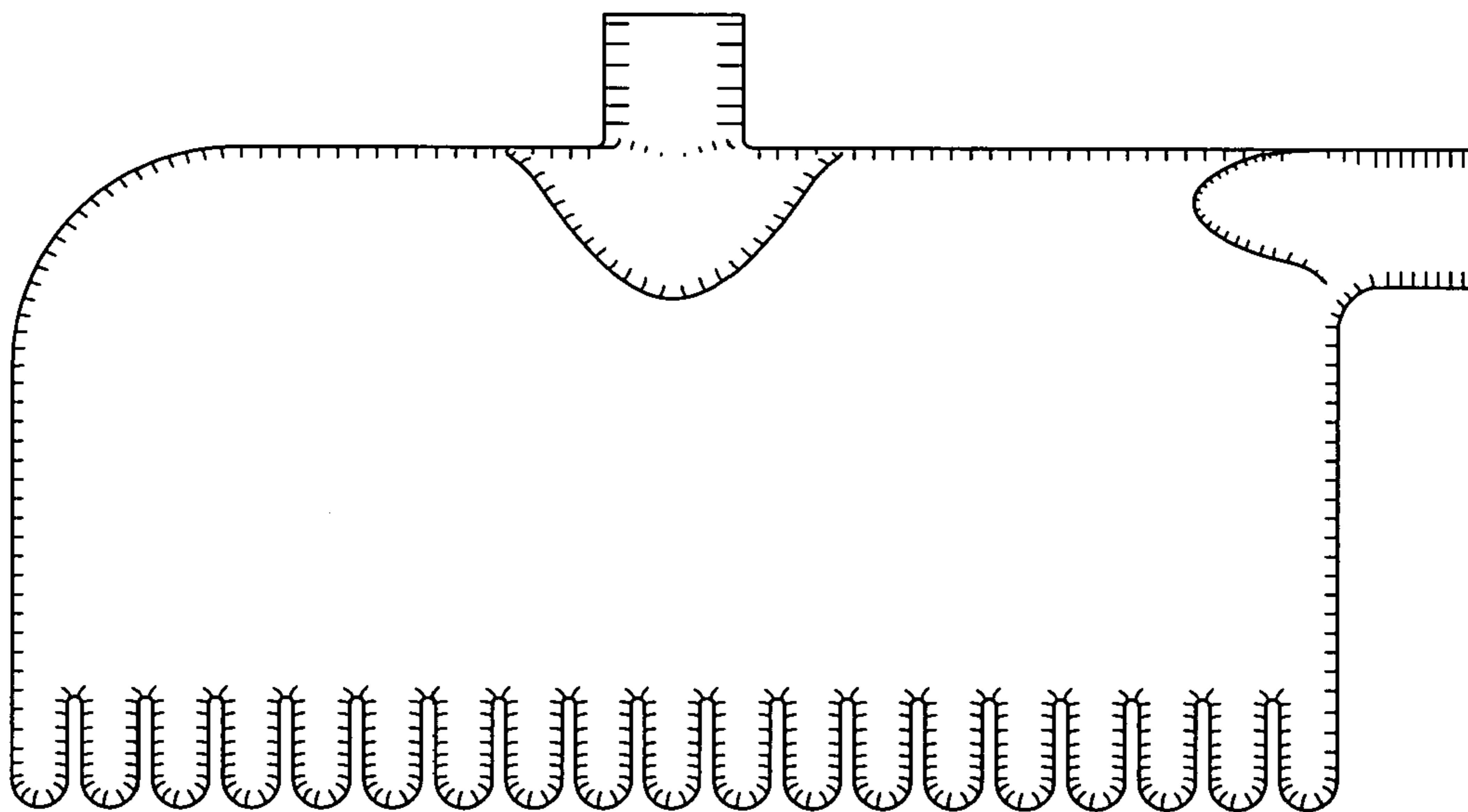

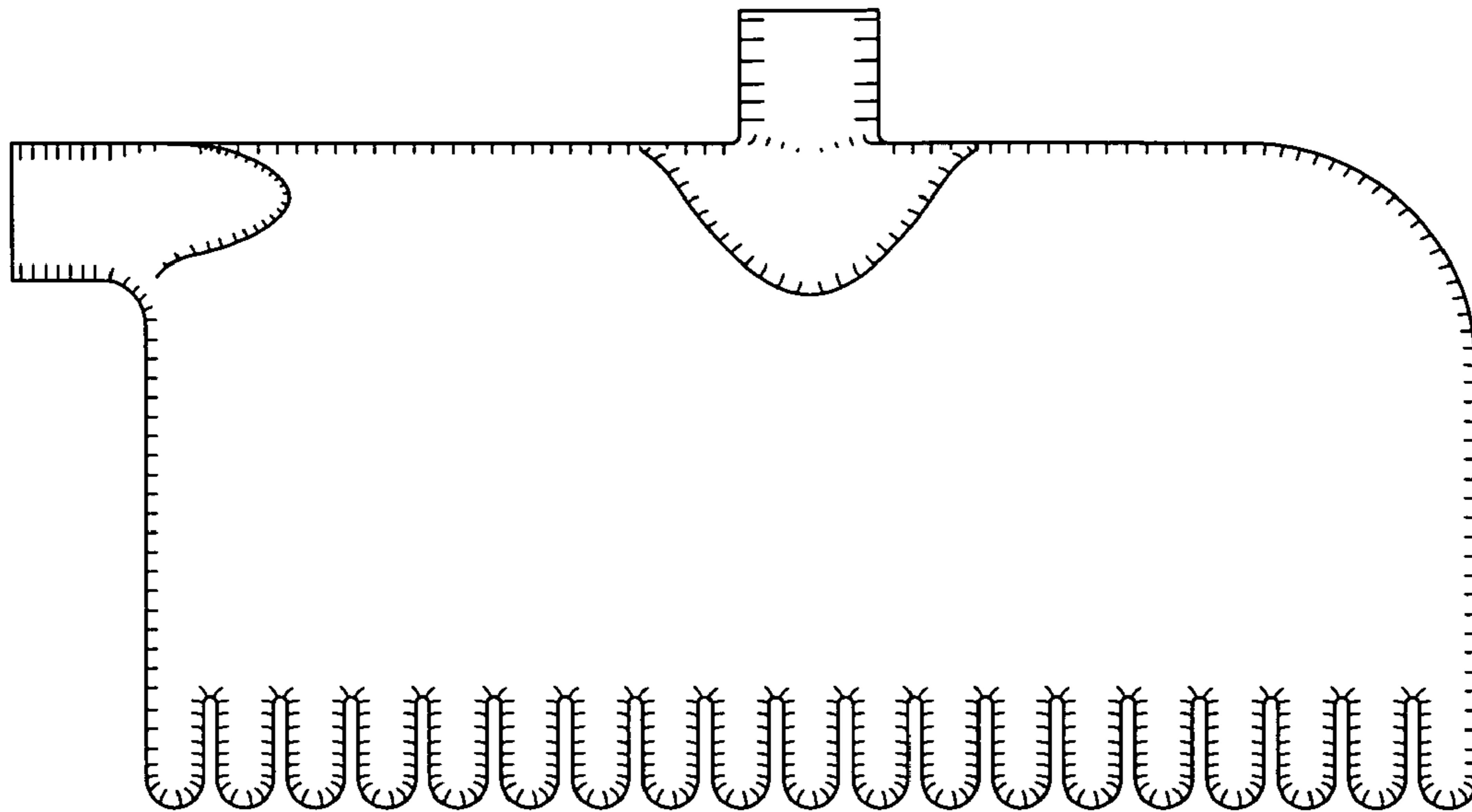

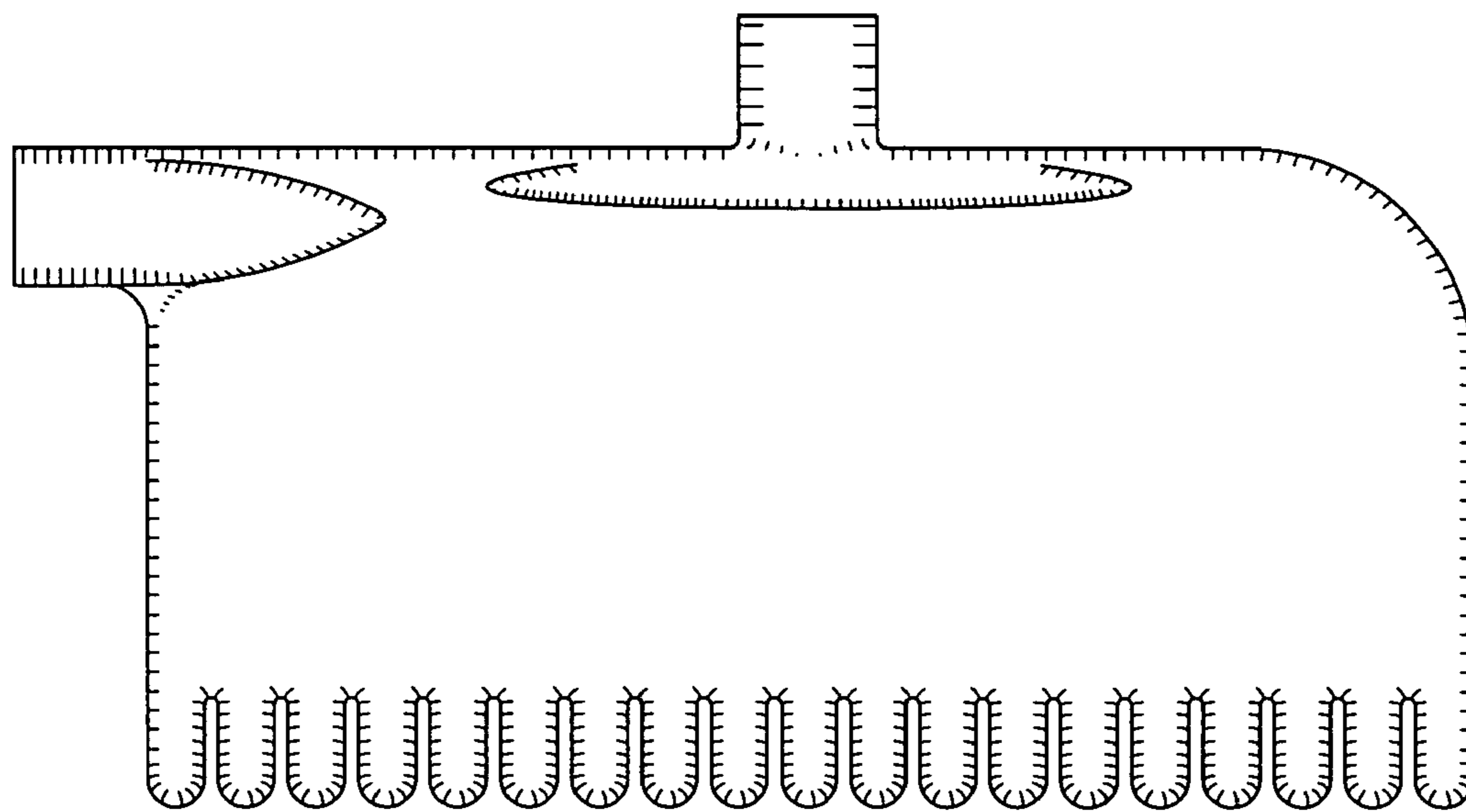

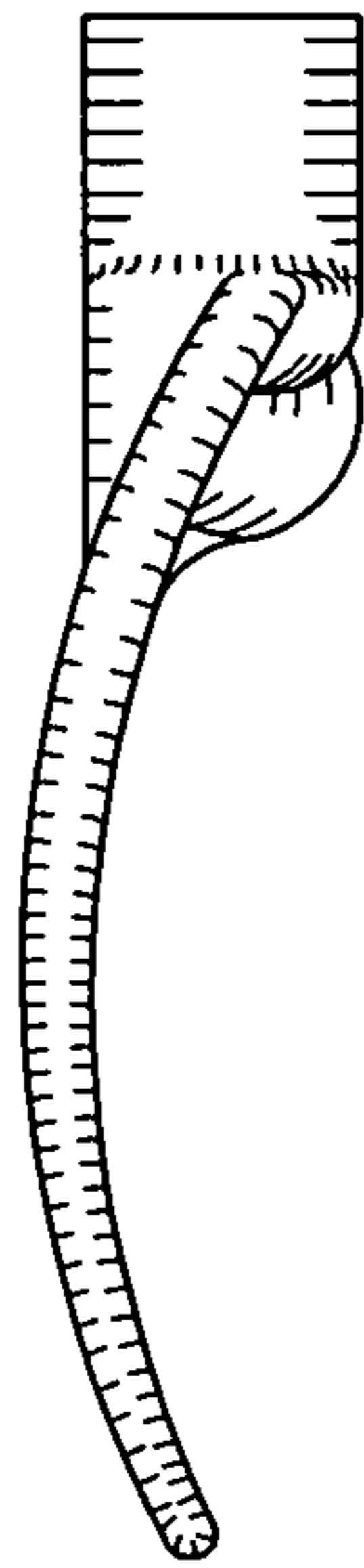

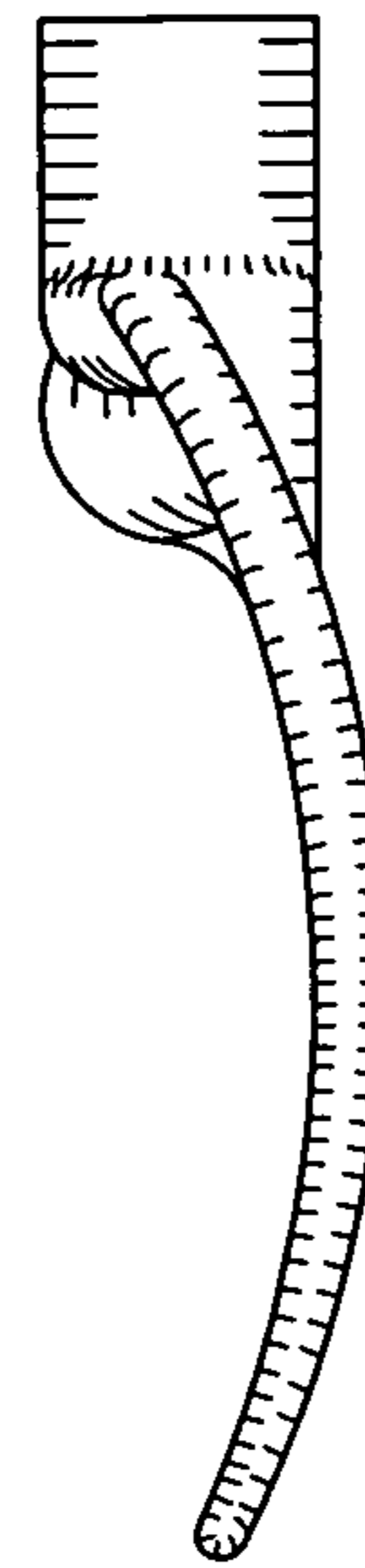

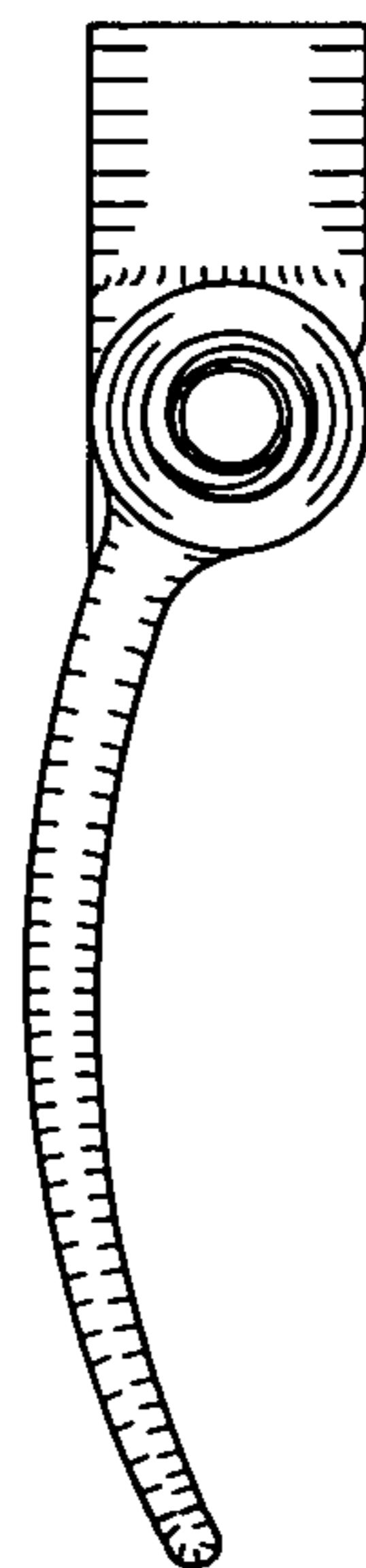

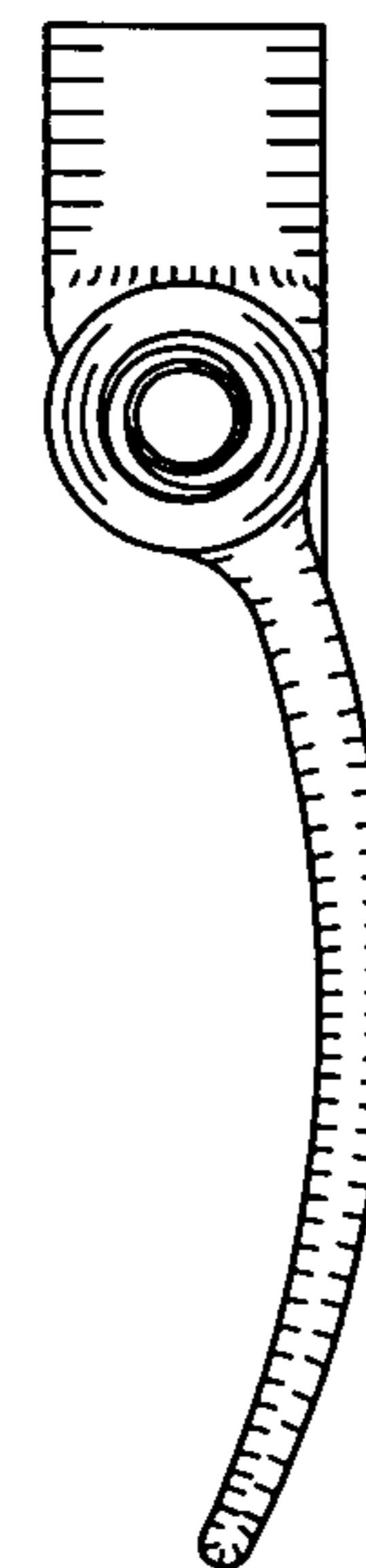

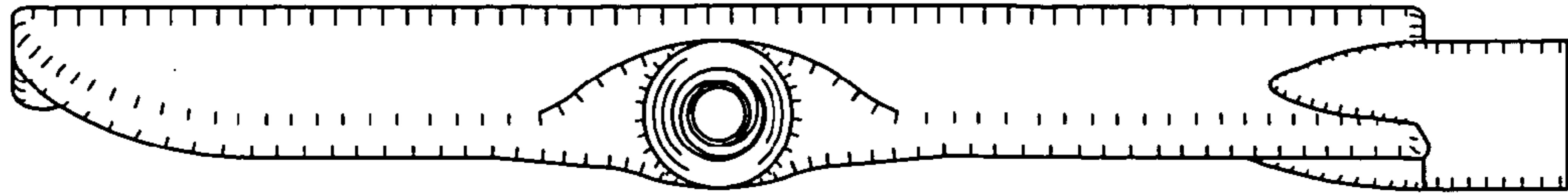

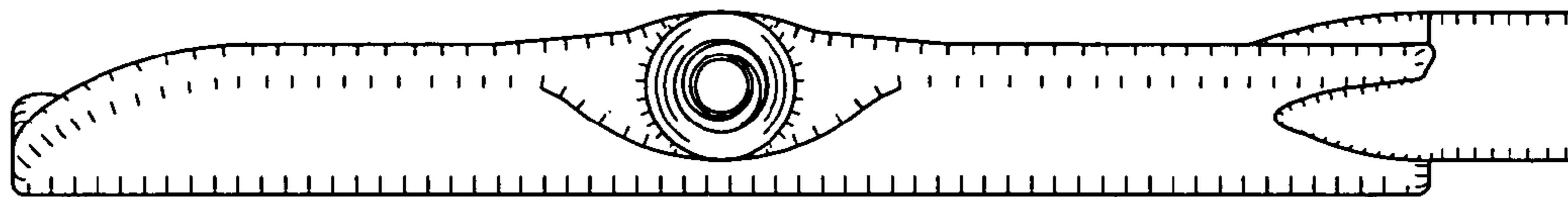

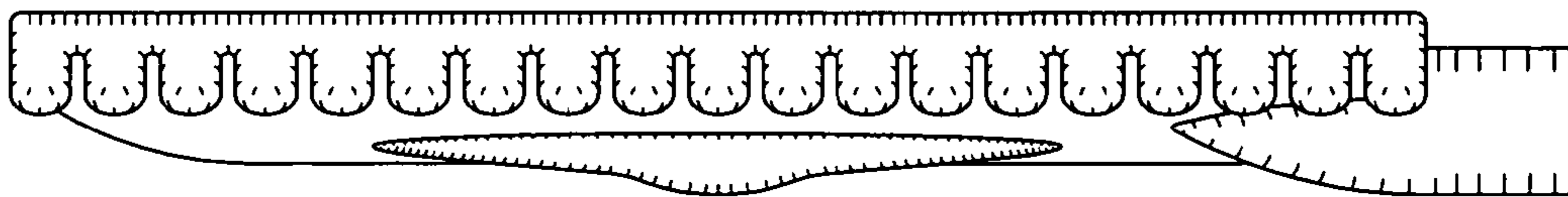

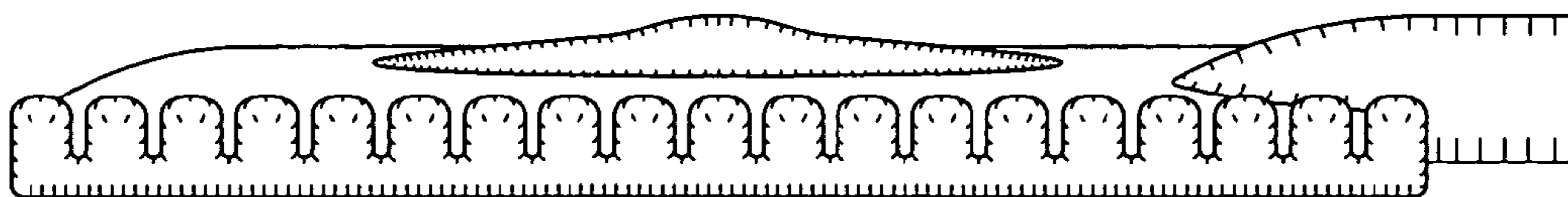

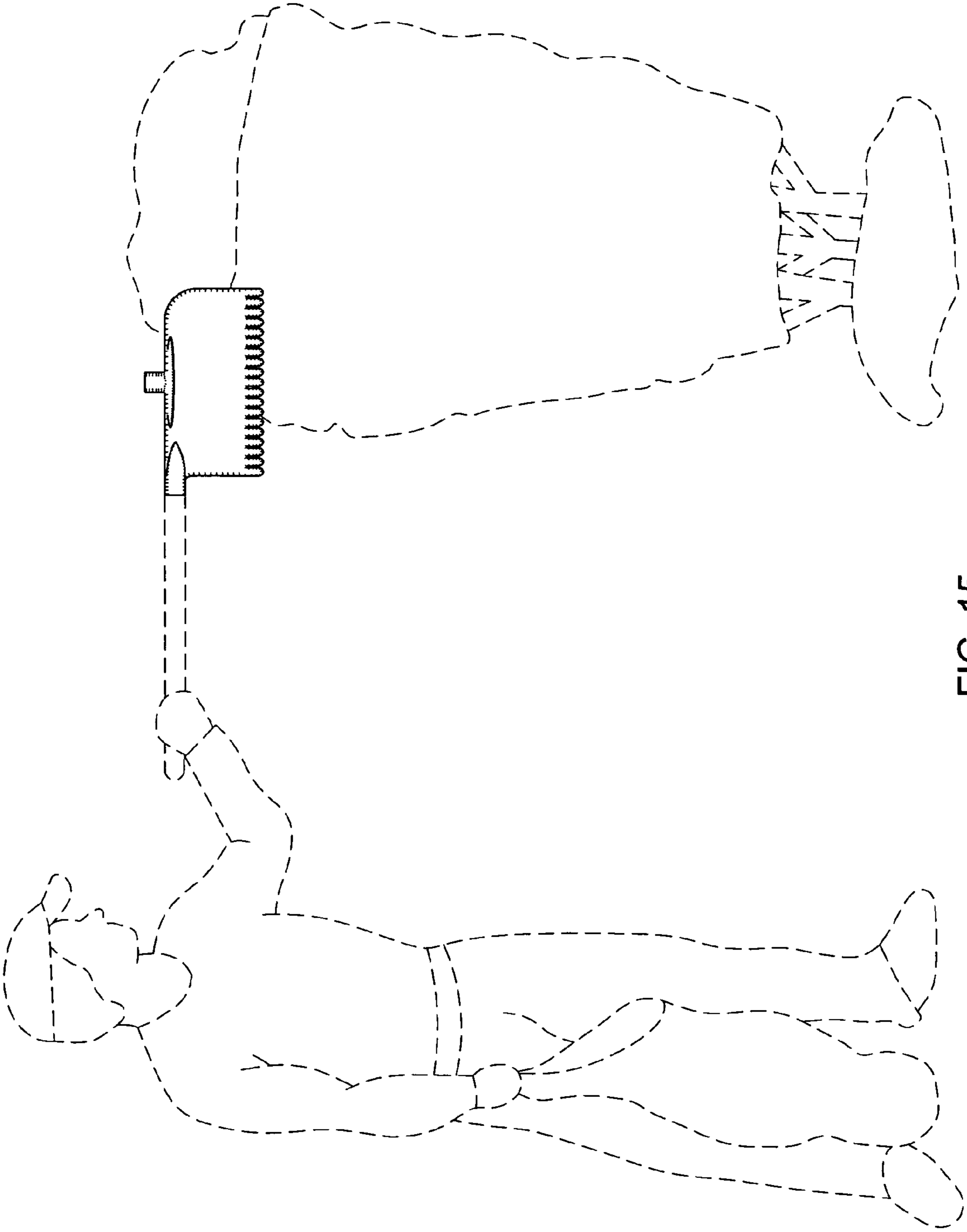

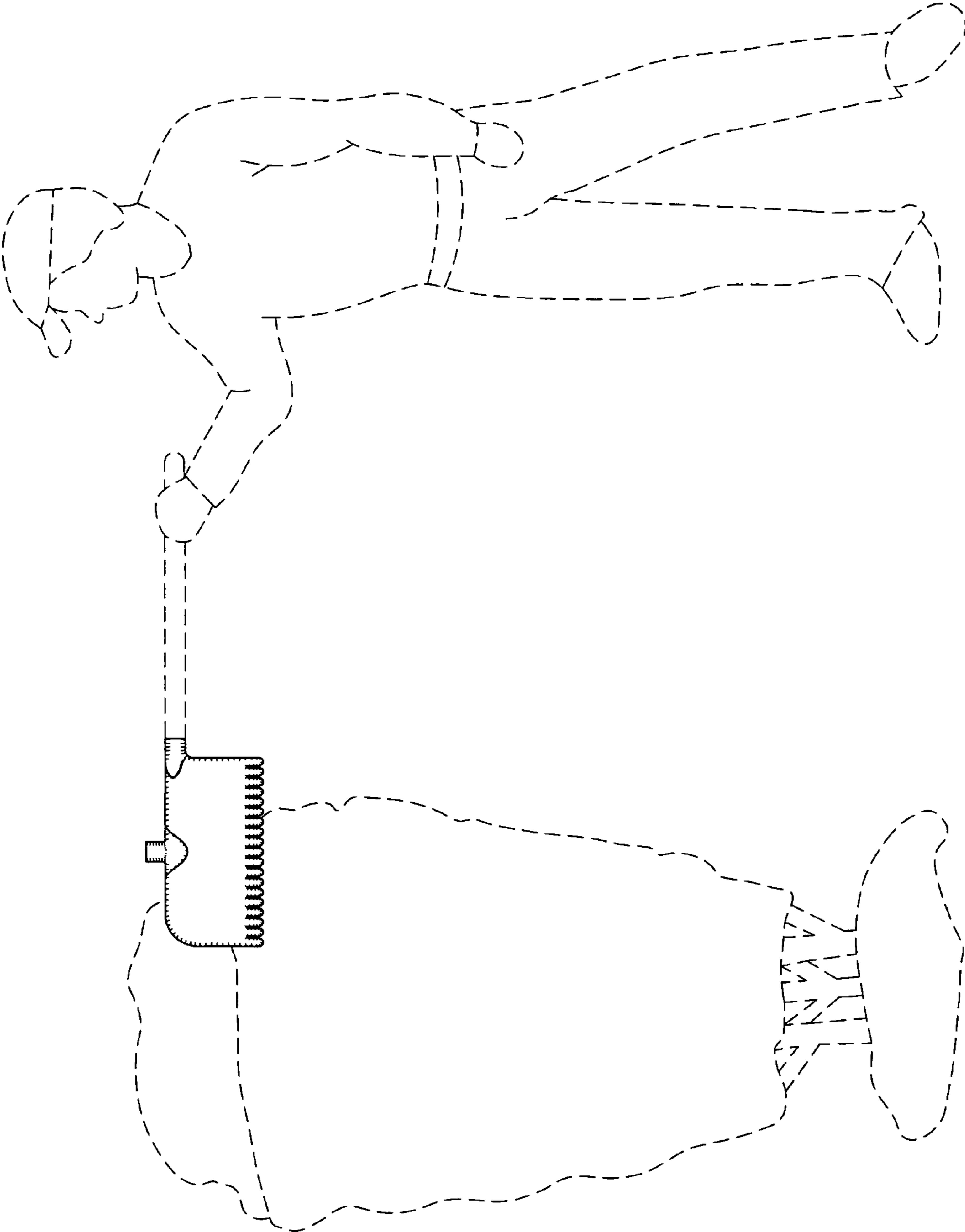

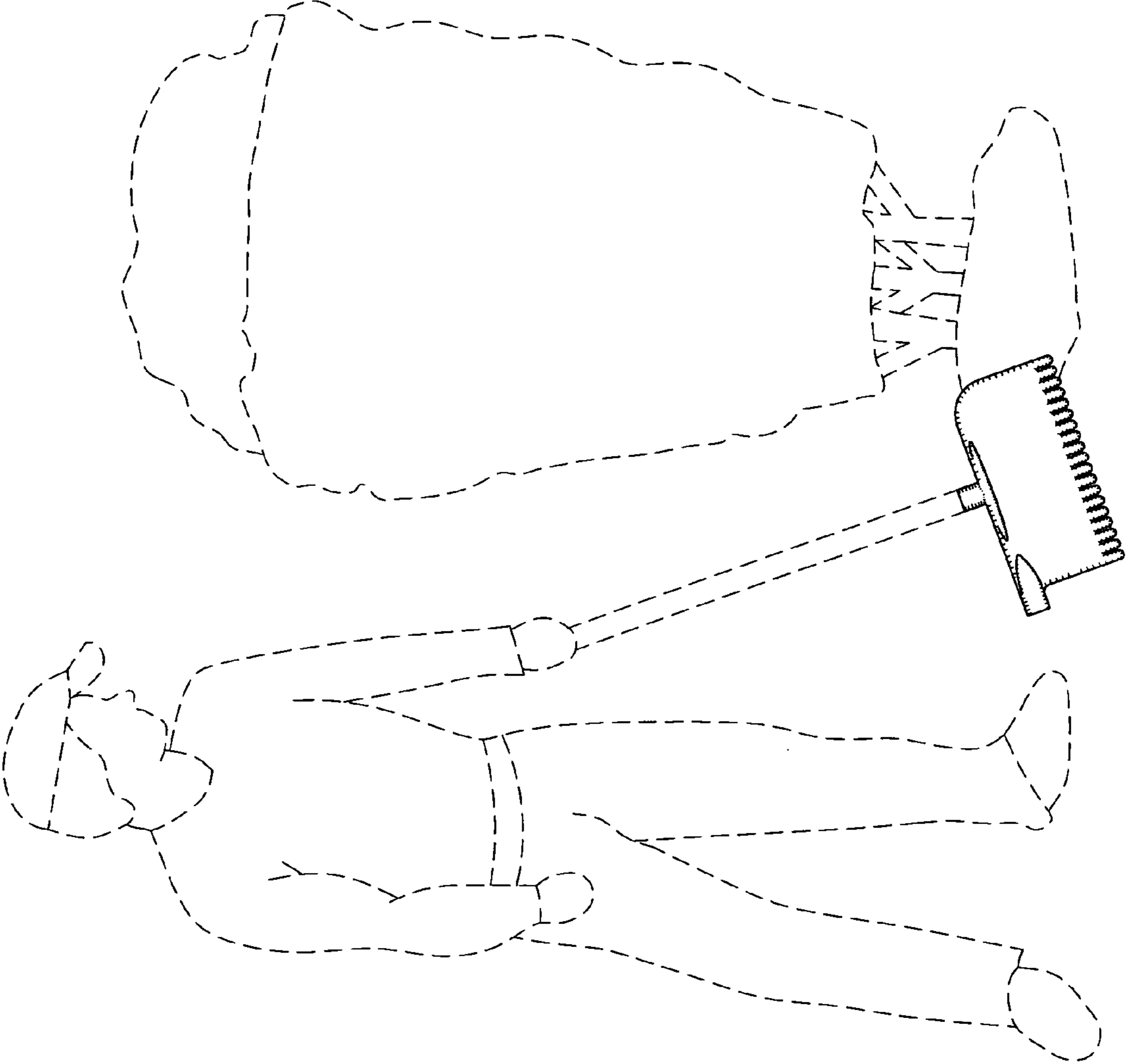

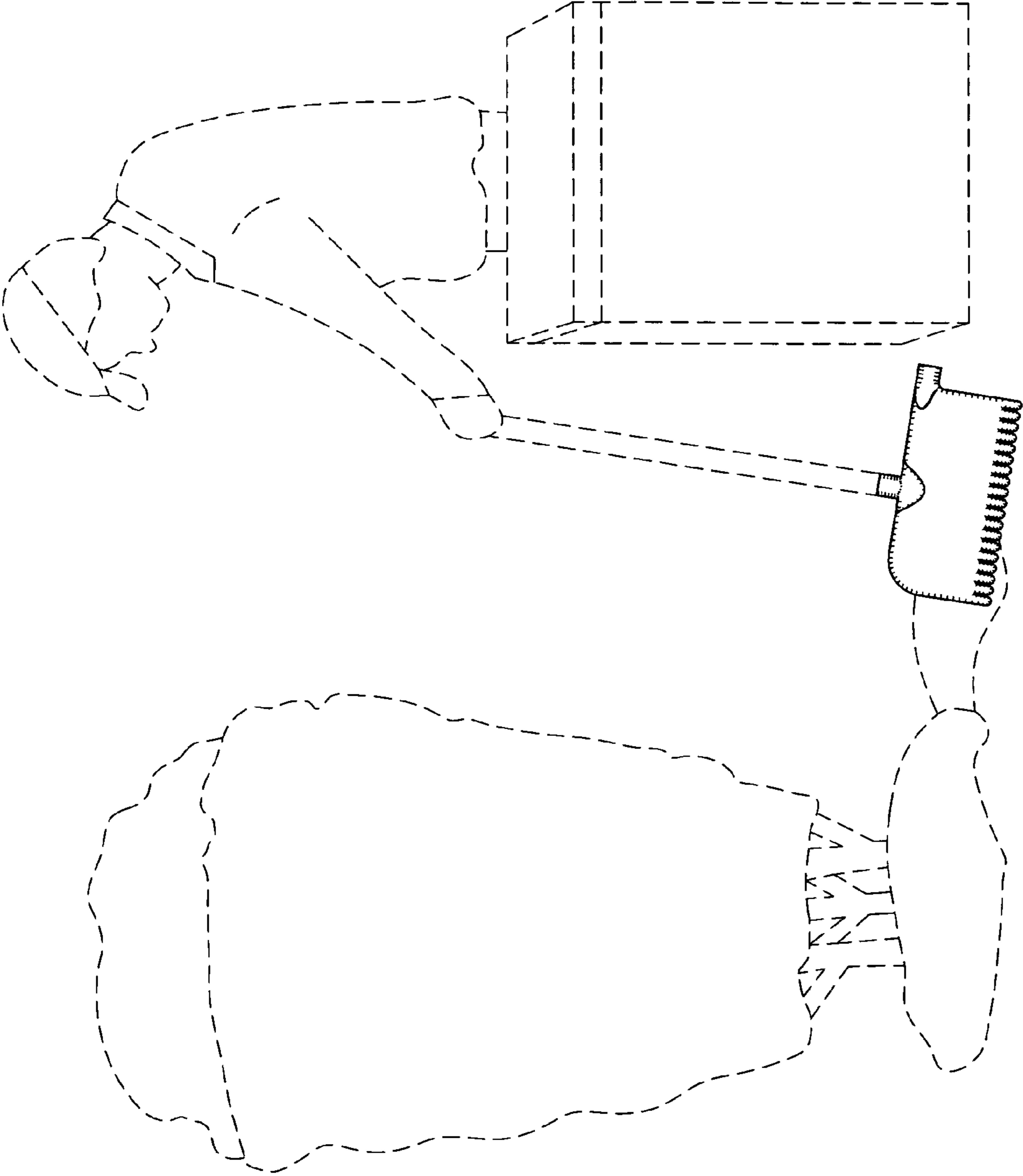

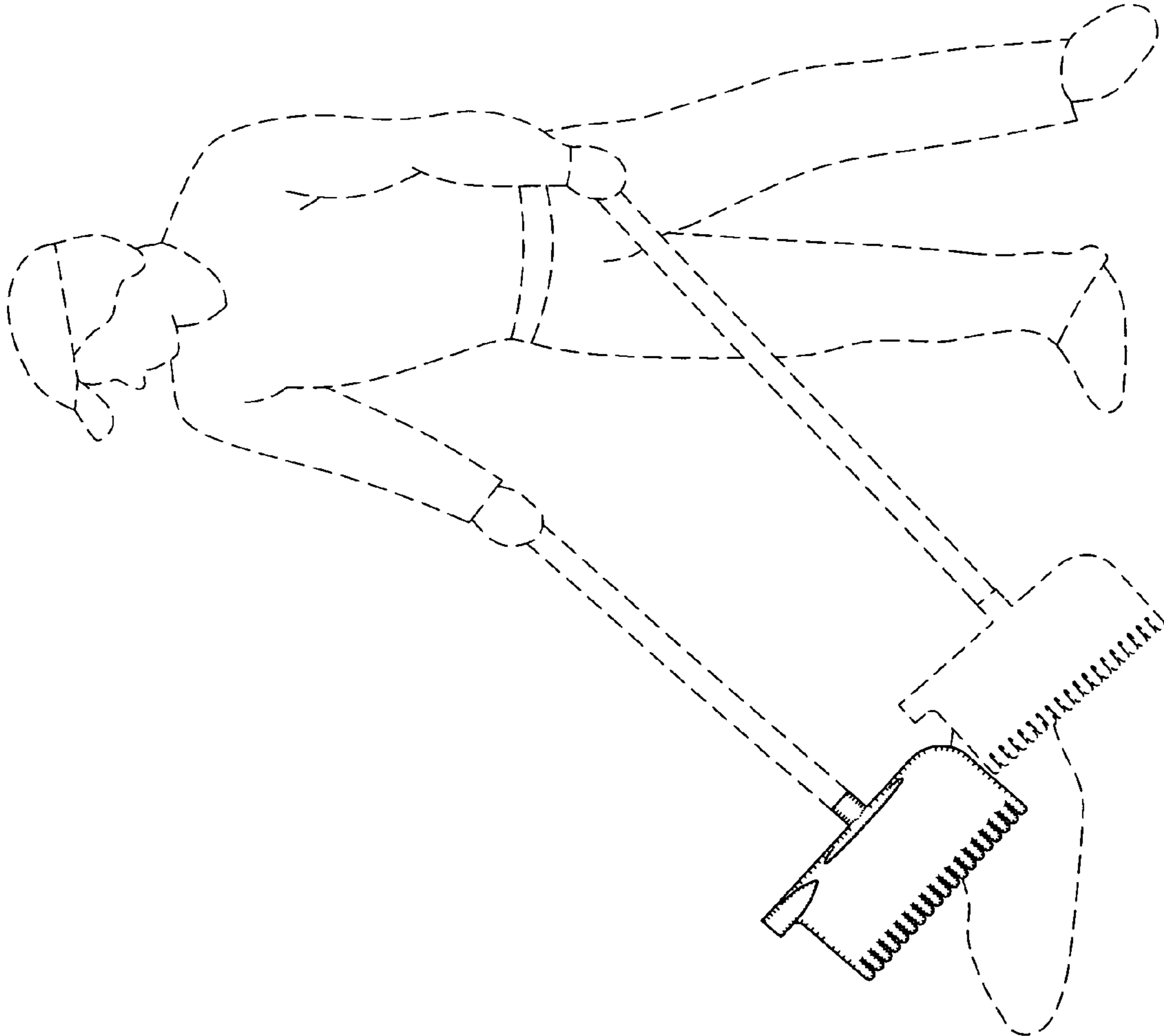

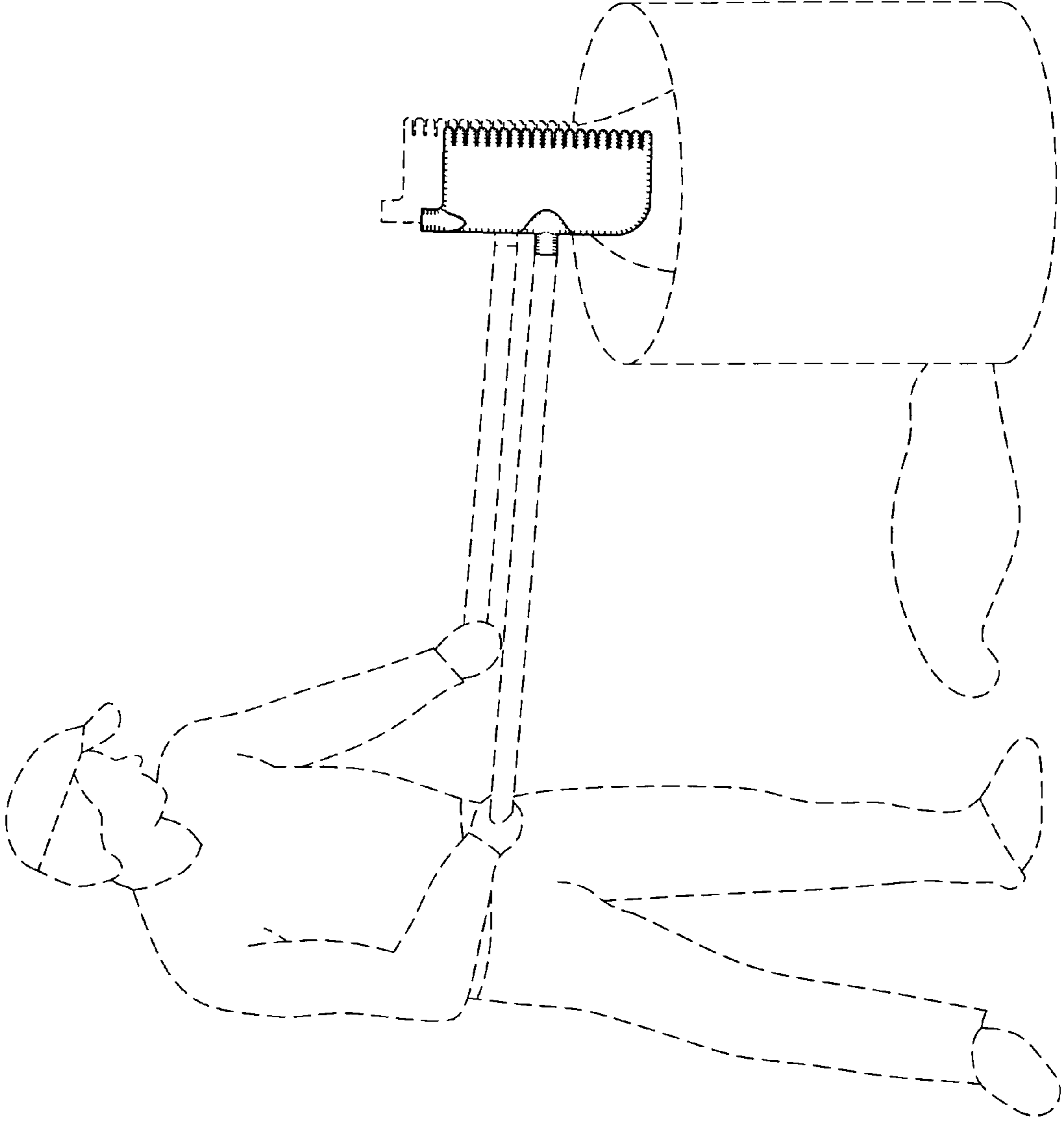
