(57) **CLAIM**

The ornamental design for a lift and turn compression latch, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view of an embodiment of a lift and turn compression latch of my new design;

FIG. 2 is a perspective view of the embodiment of FIG. 1;

FIG. 3 is a top plan view of an alternate embodiment of the lift and turn compression latch;

FIG. 4 is a perspective view of the embodiment of FIG. 3;

FIG. 5 is a left side elevational view of the embodiments of FIG. 1 and FIG. 3; and,

FIG. 6 is a bottom plan view of the embodiments of FIG. 1 and FIG. 3.

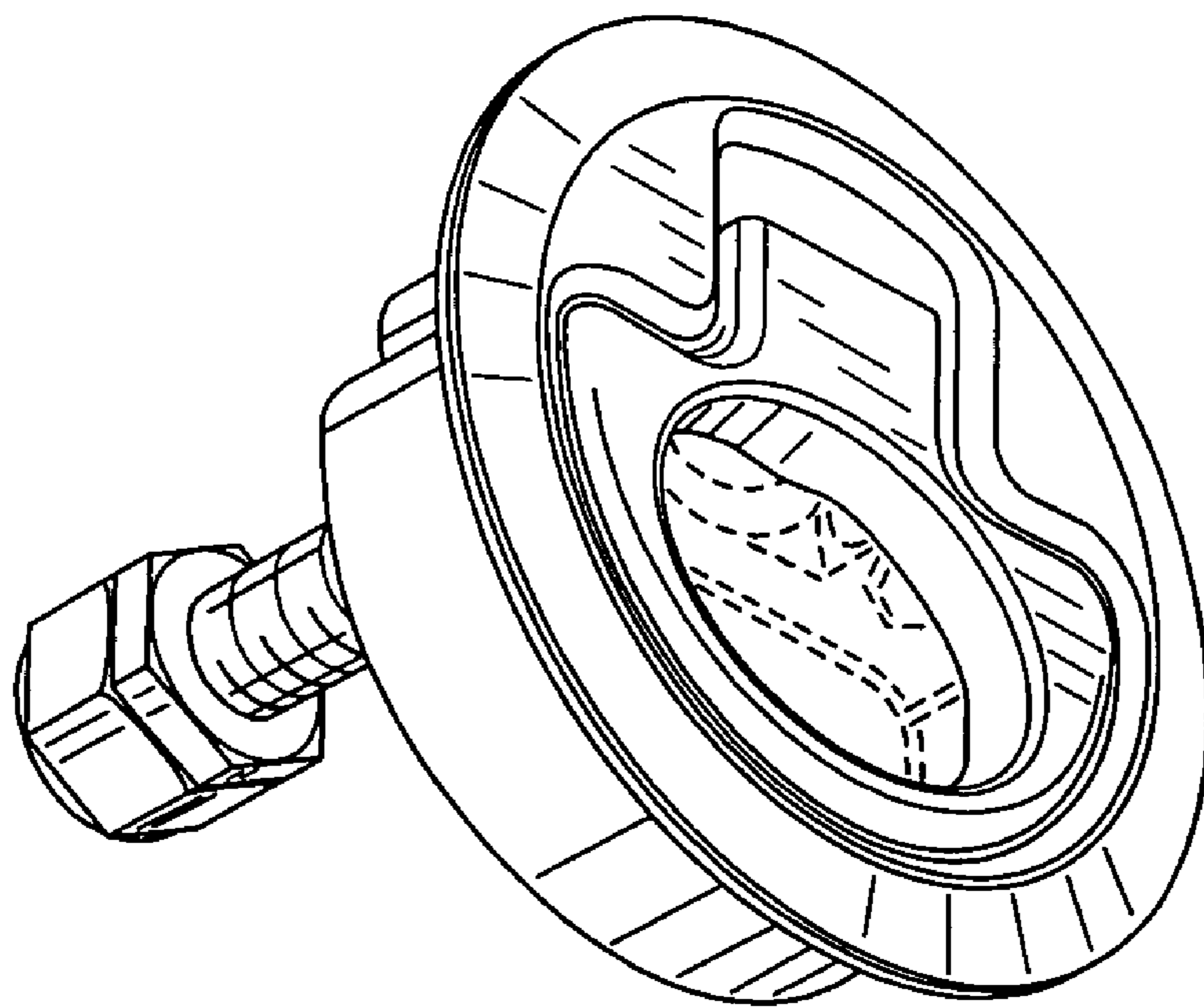

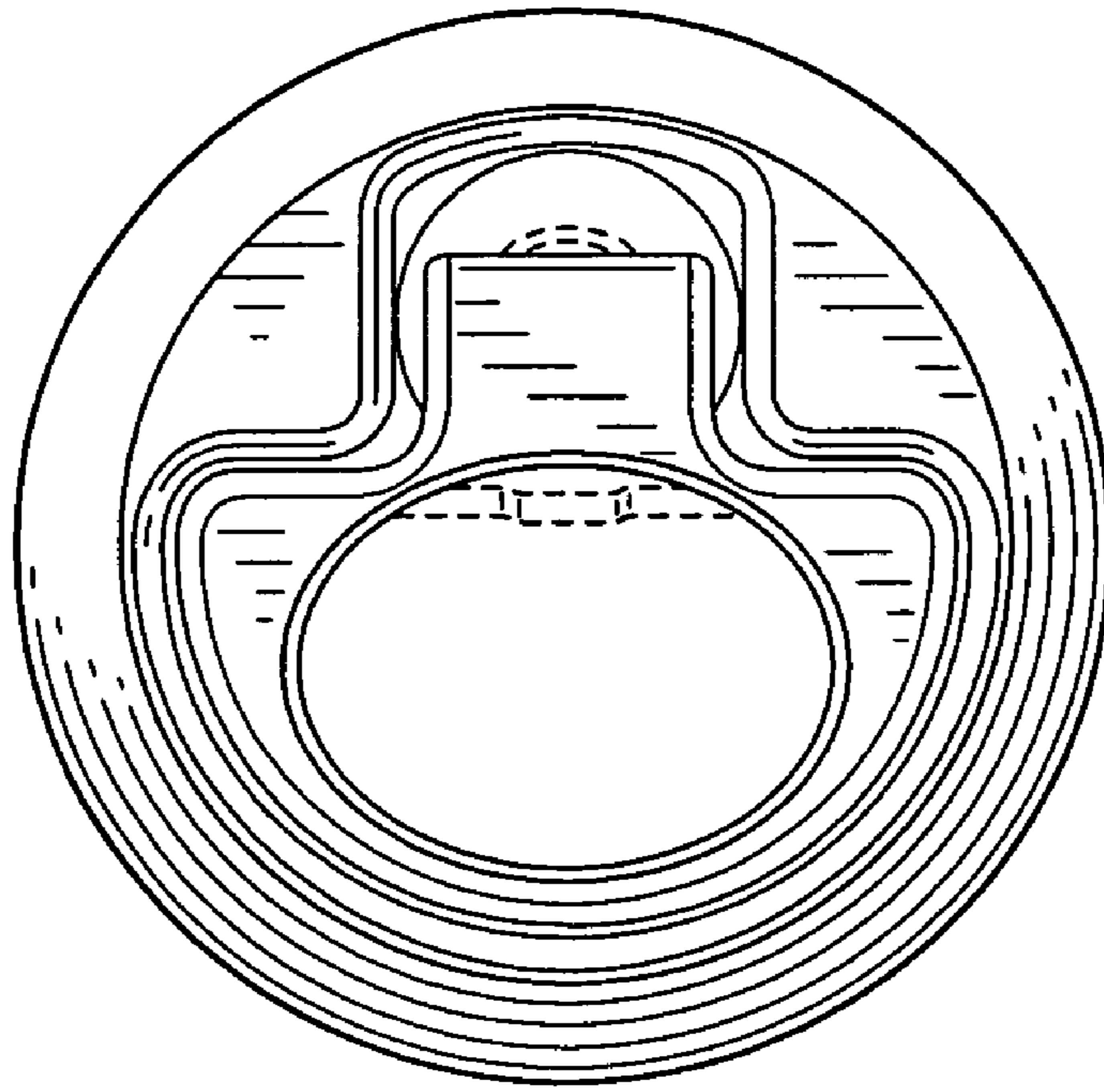

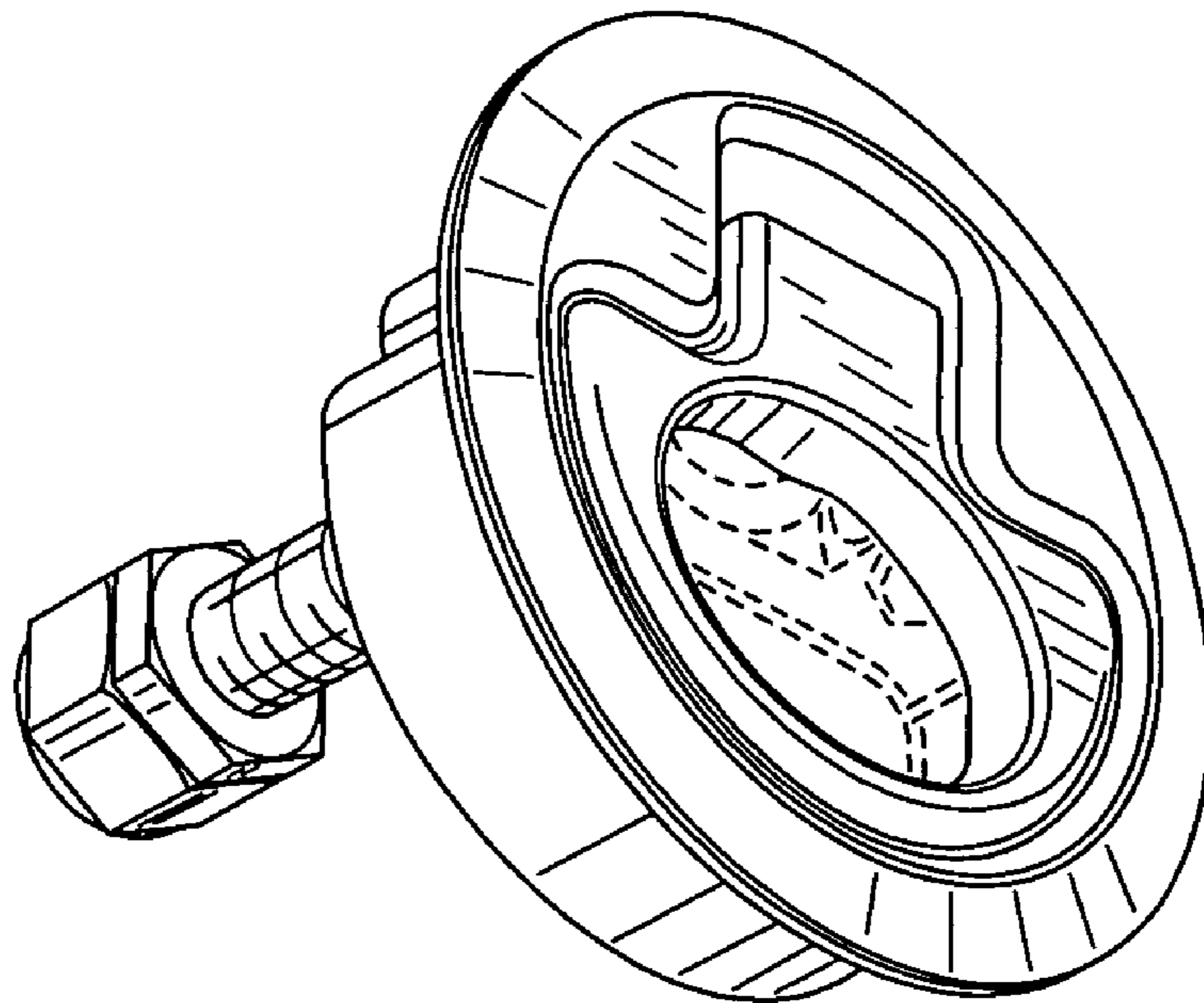

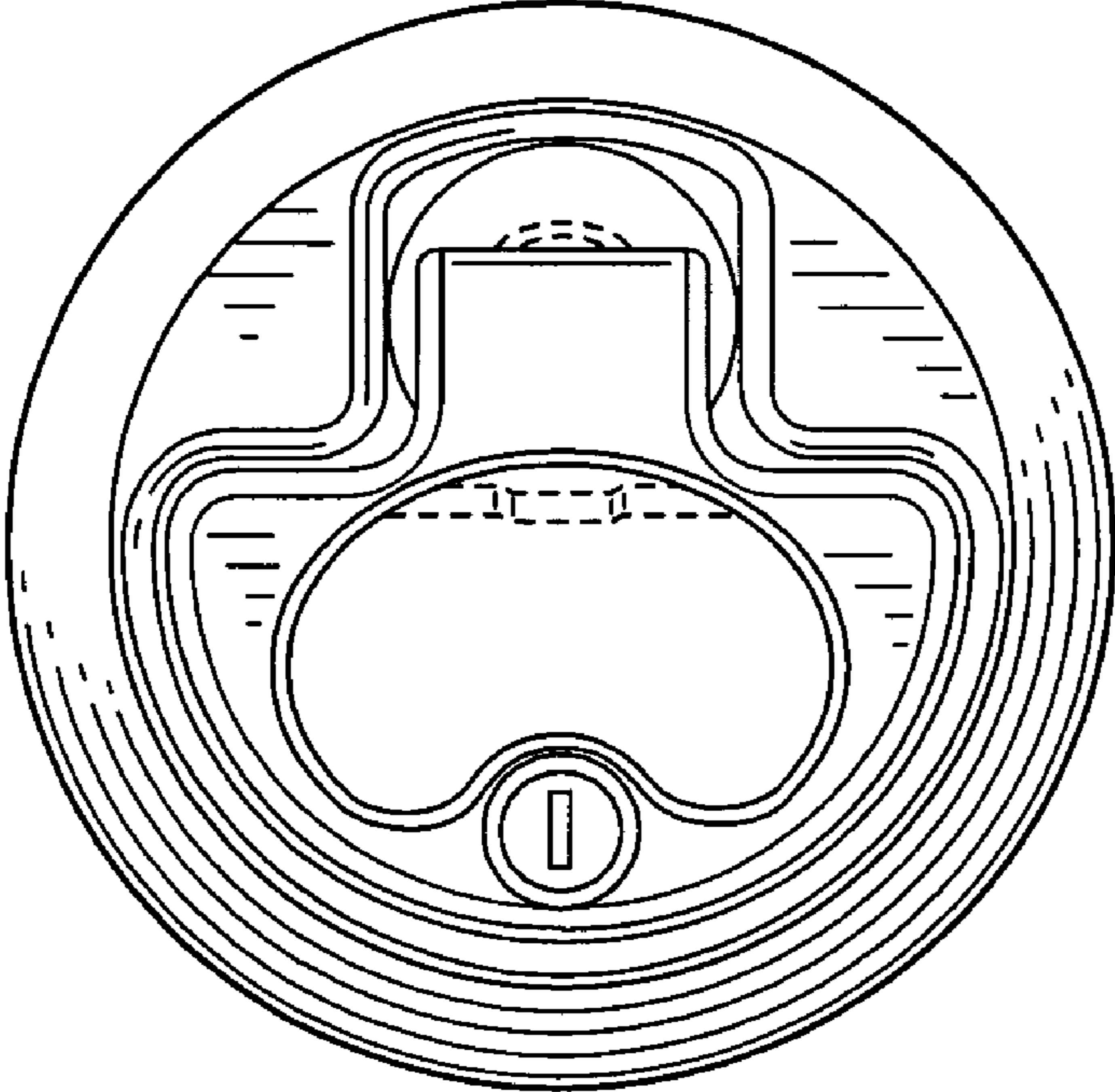

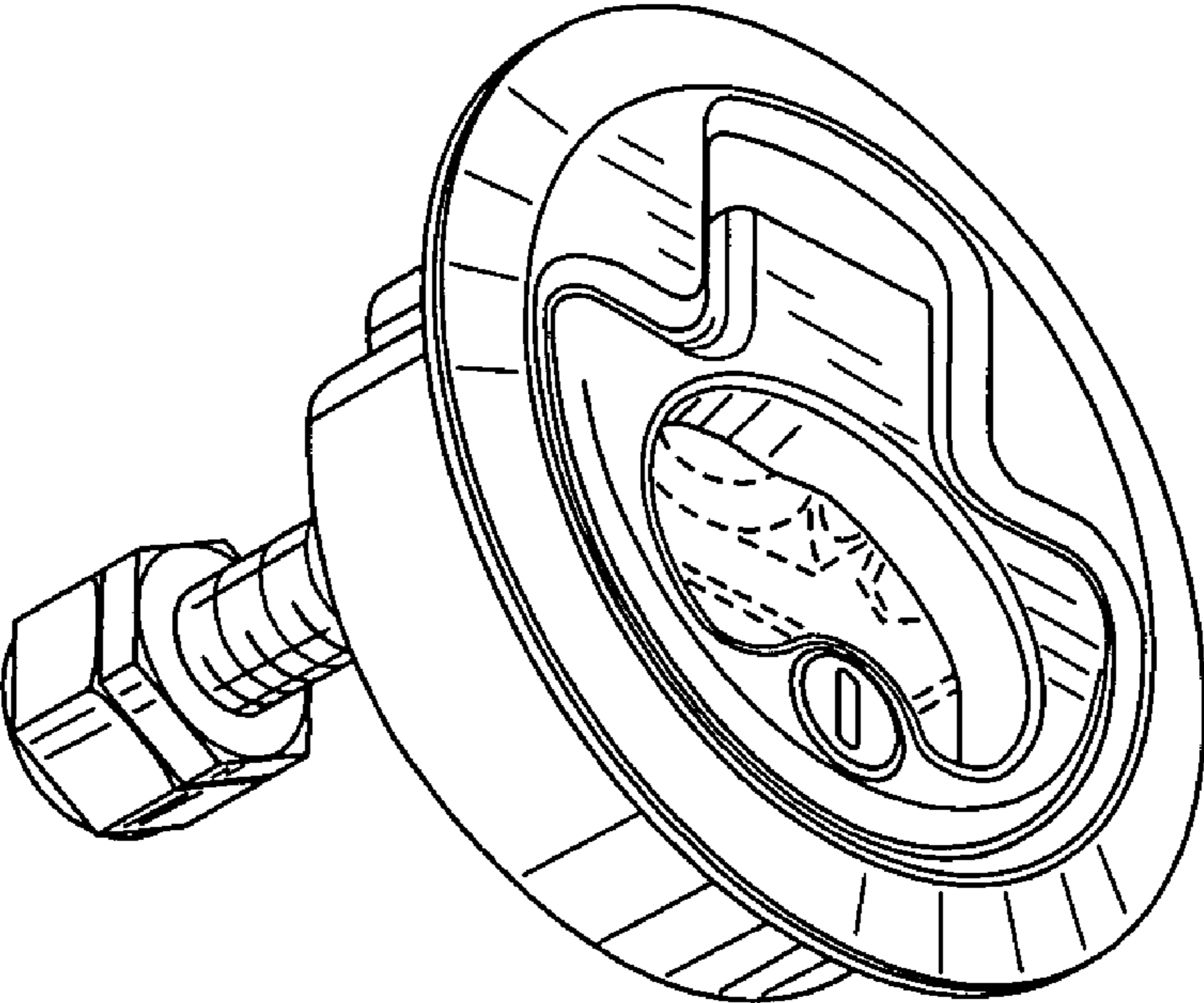

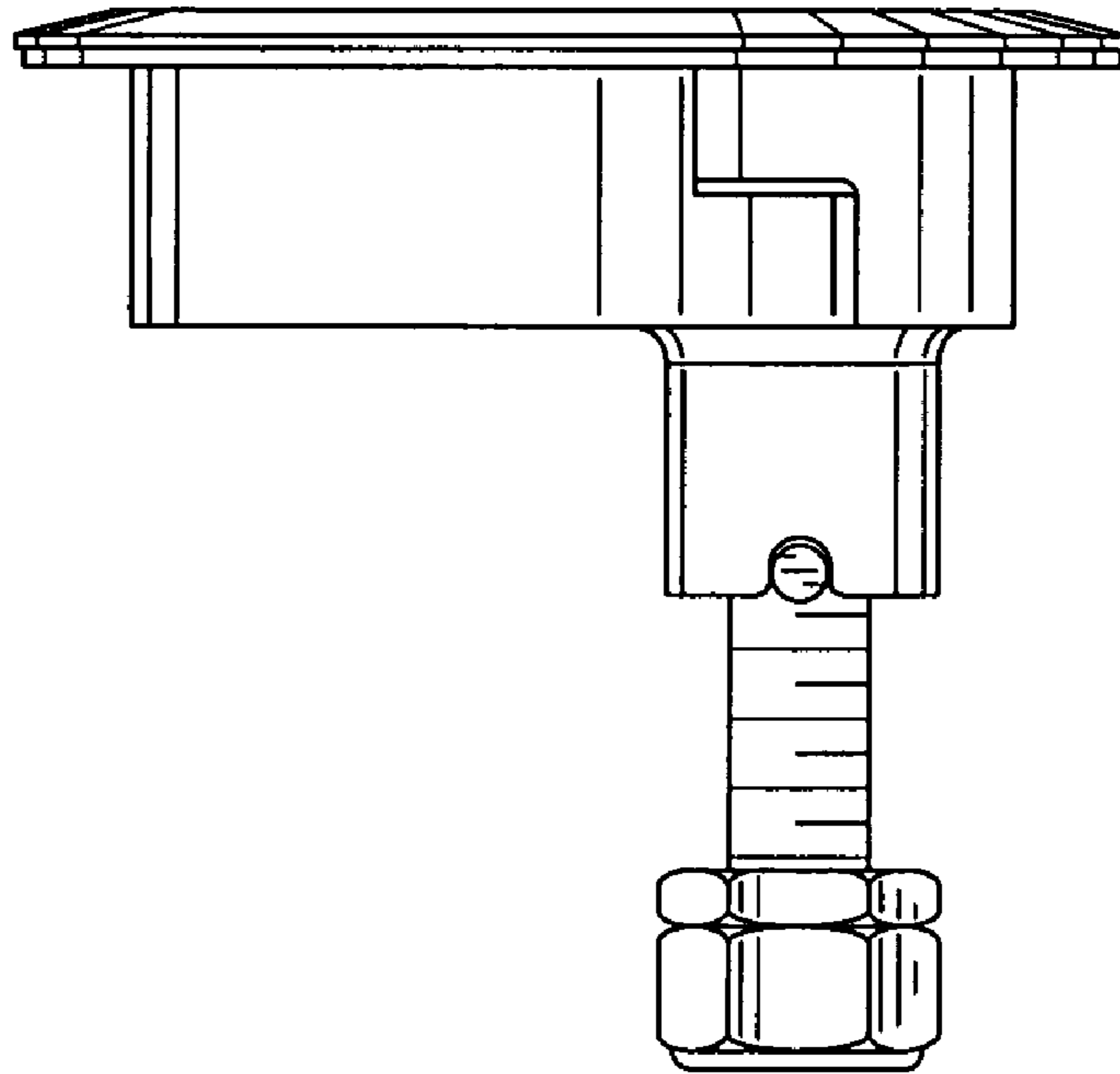
