FIG. 4 is a bottom plan view thereof;

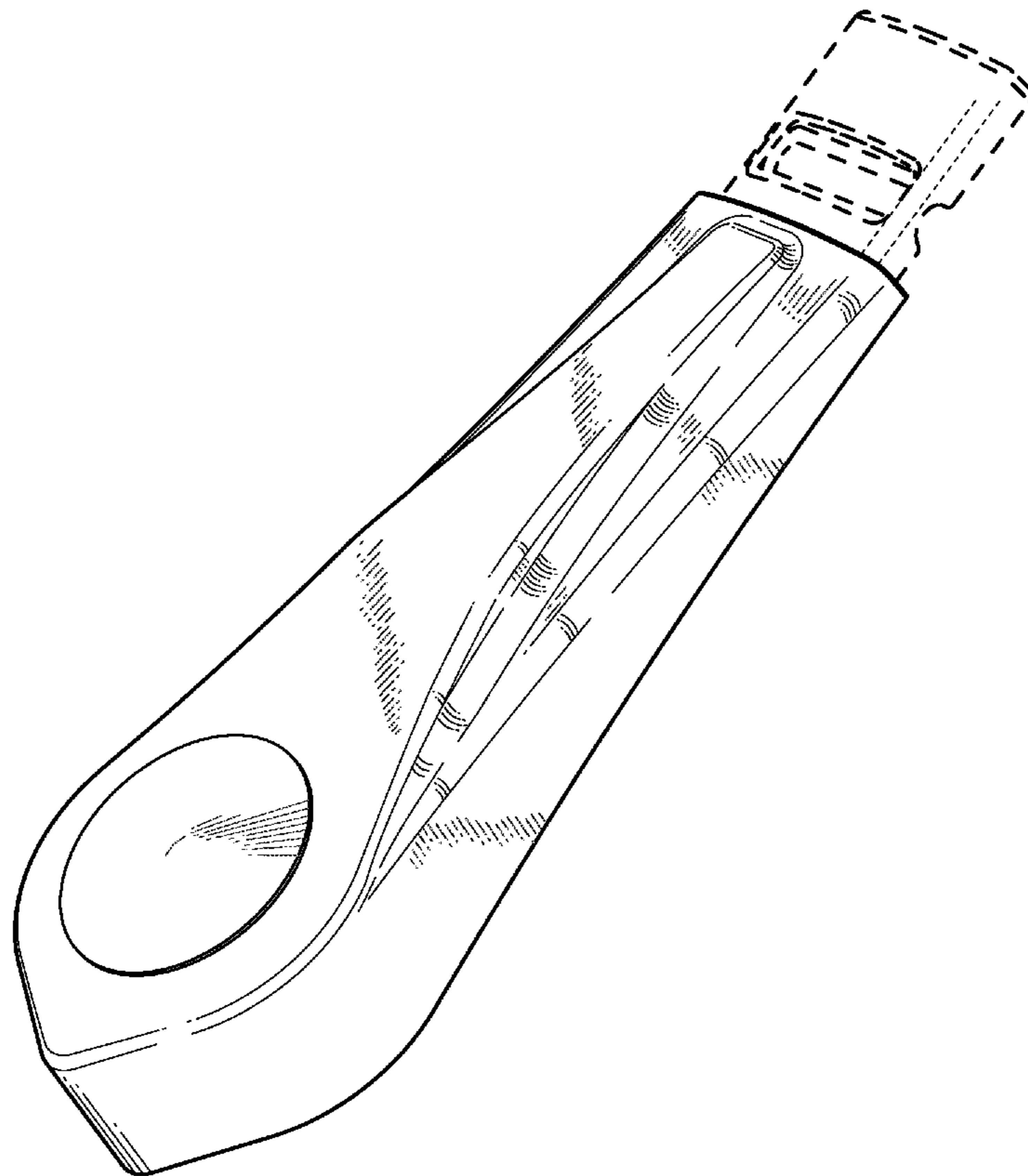
FIG. 5 is a left side elevational view thereof, the right side being a mirror image thereof;

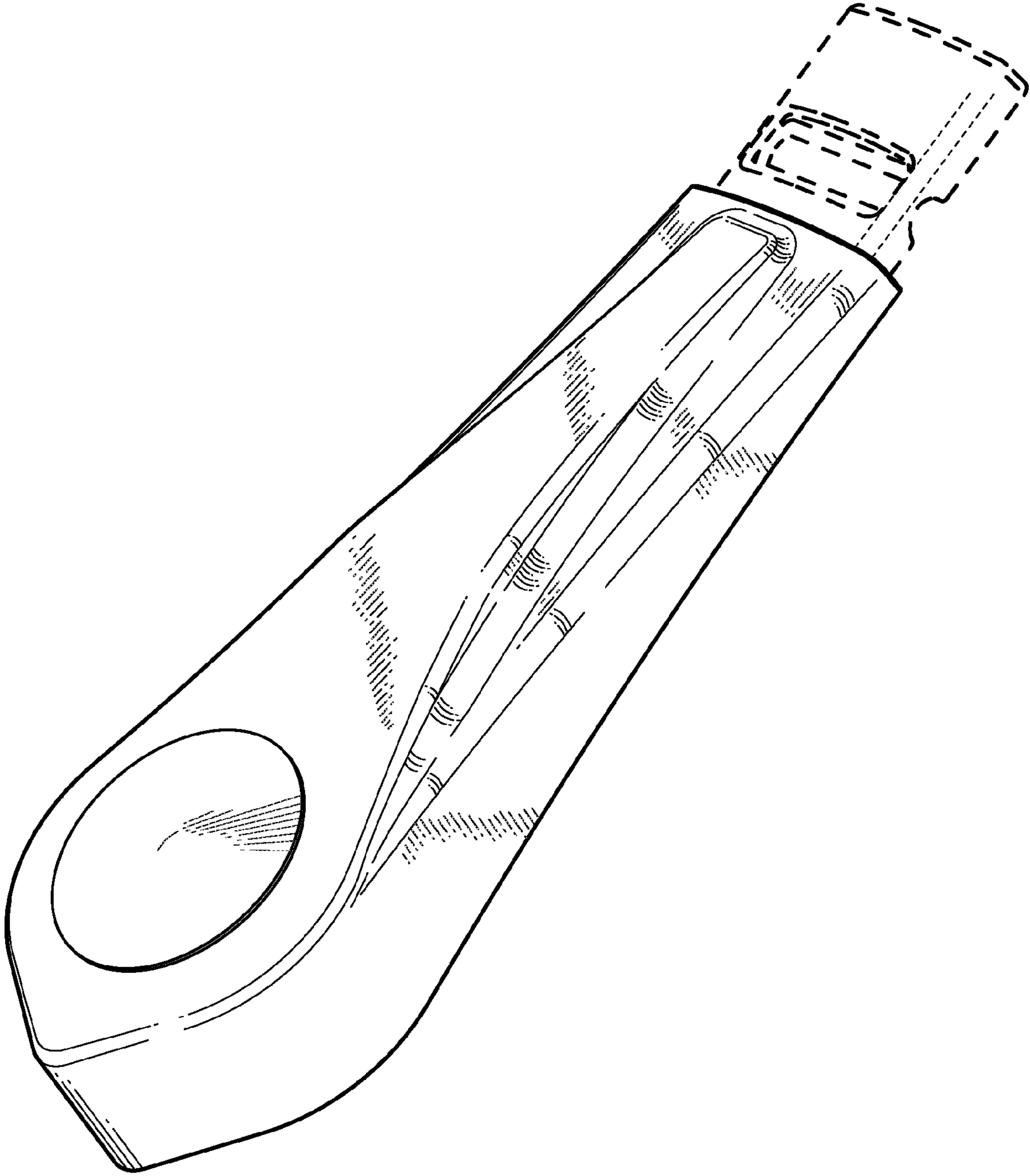

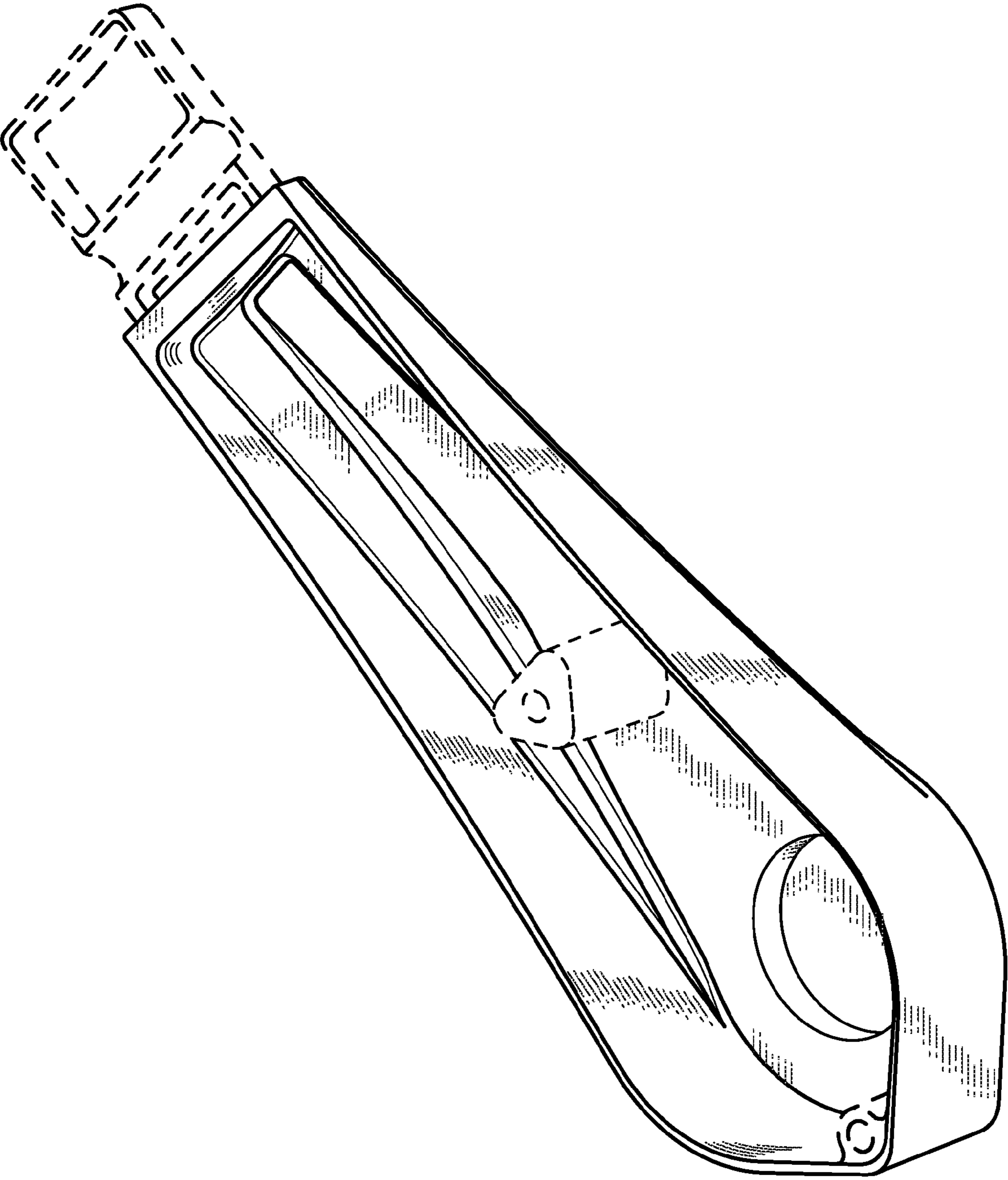

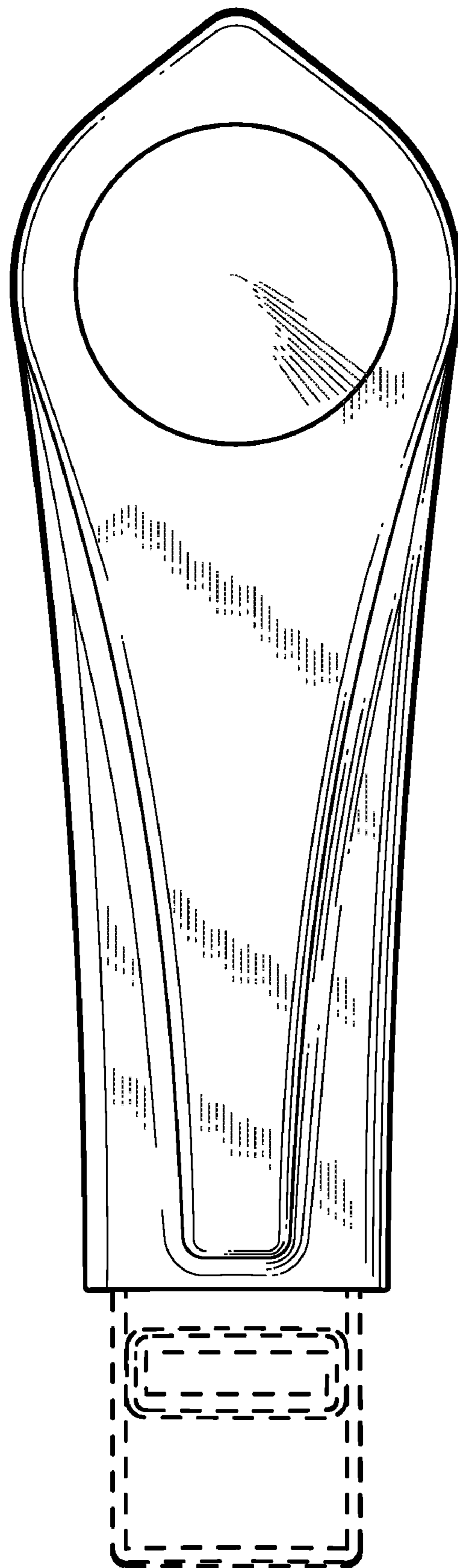

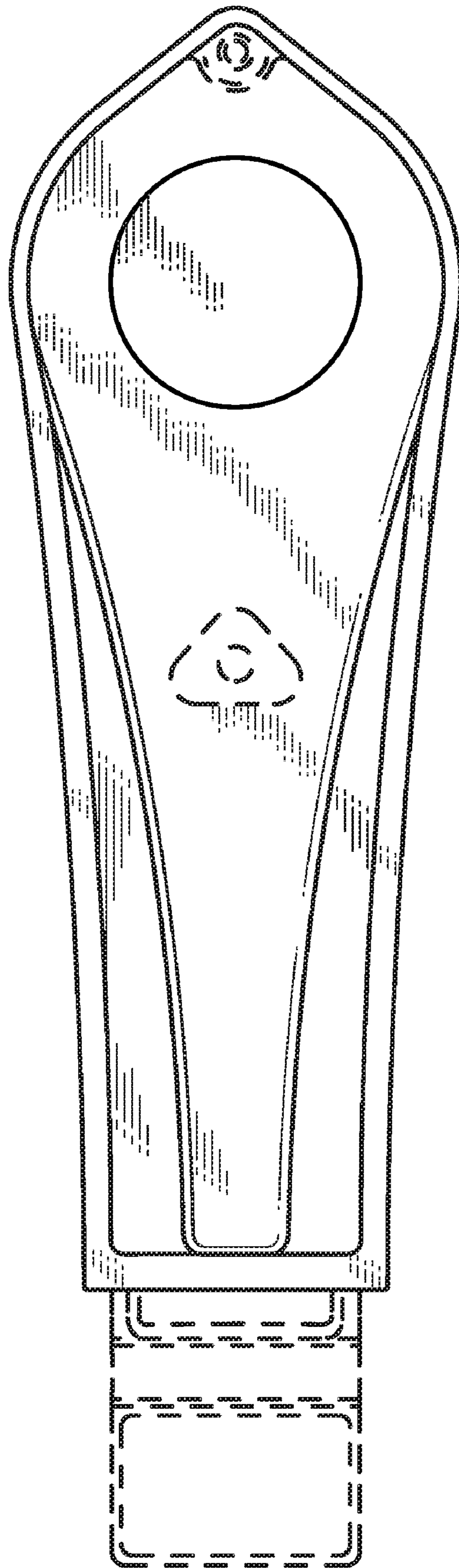

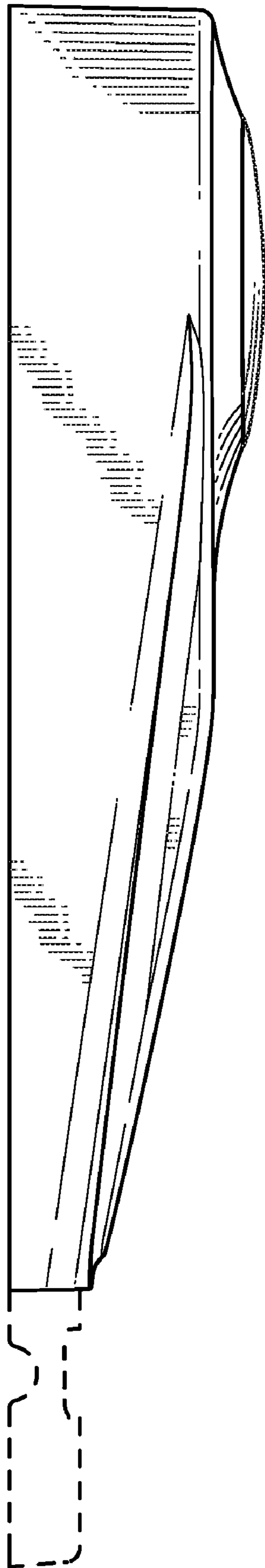

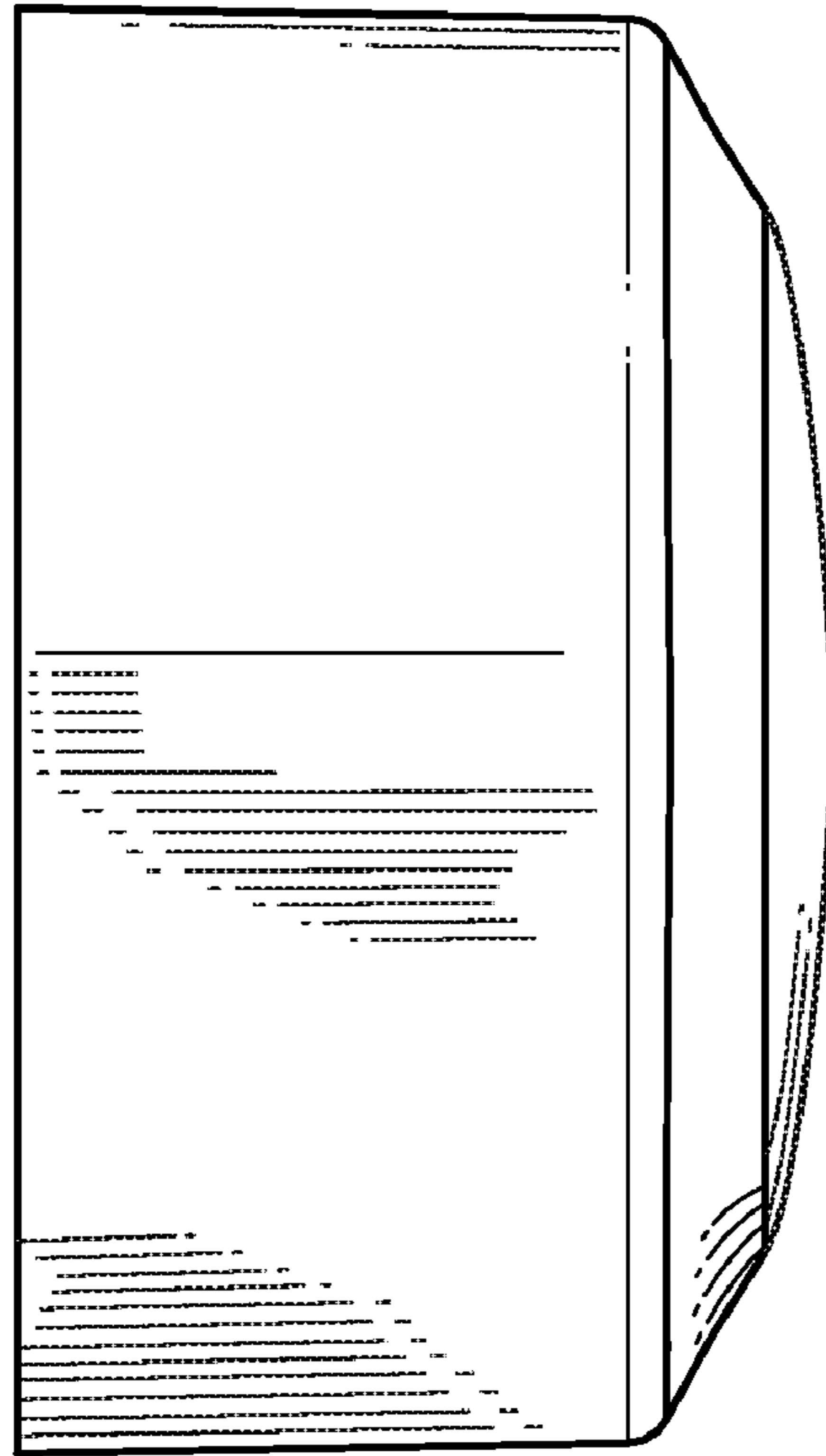

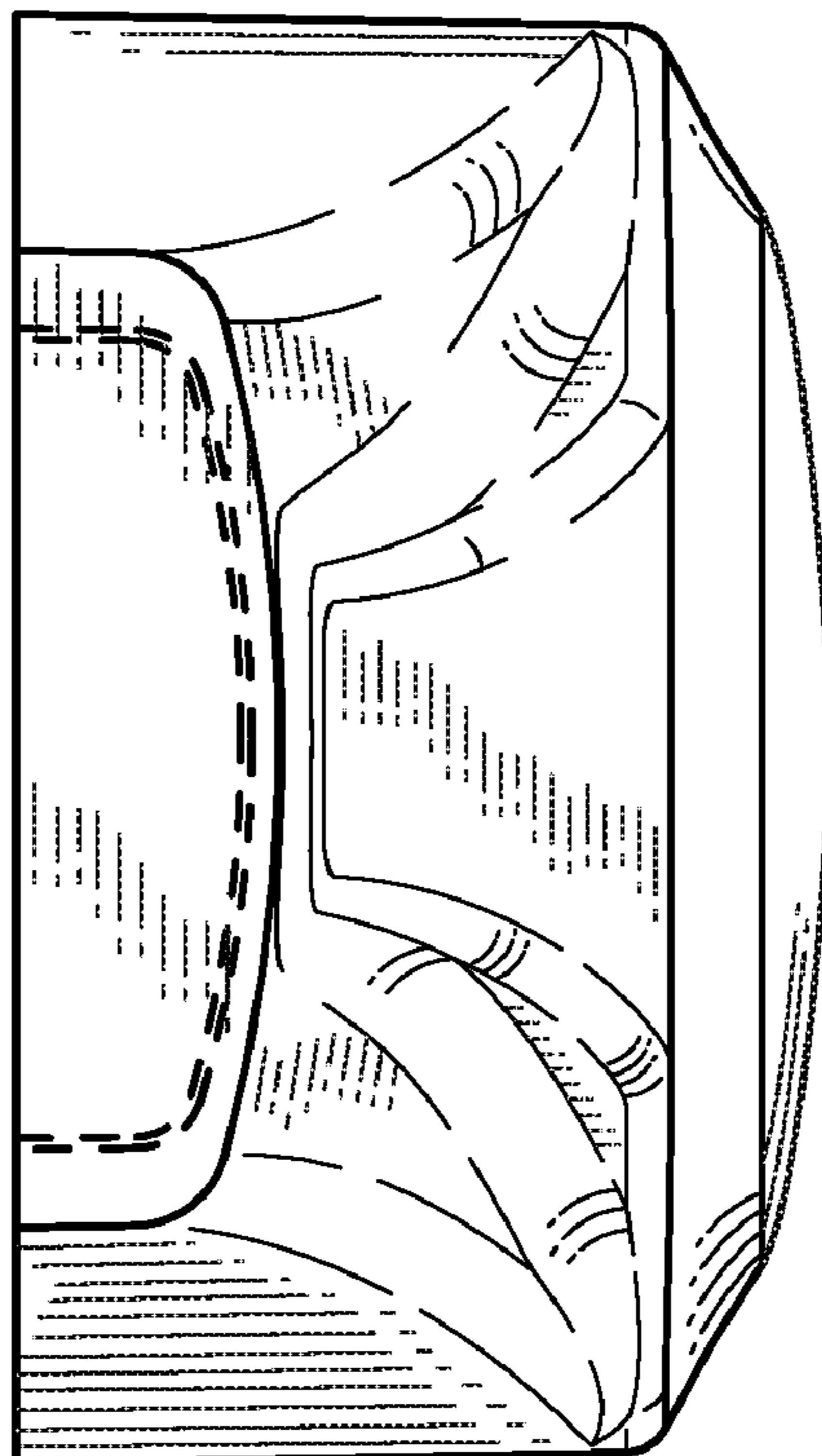
