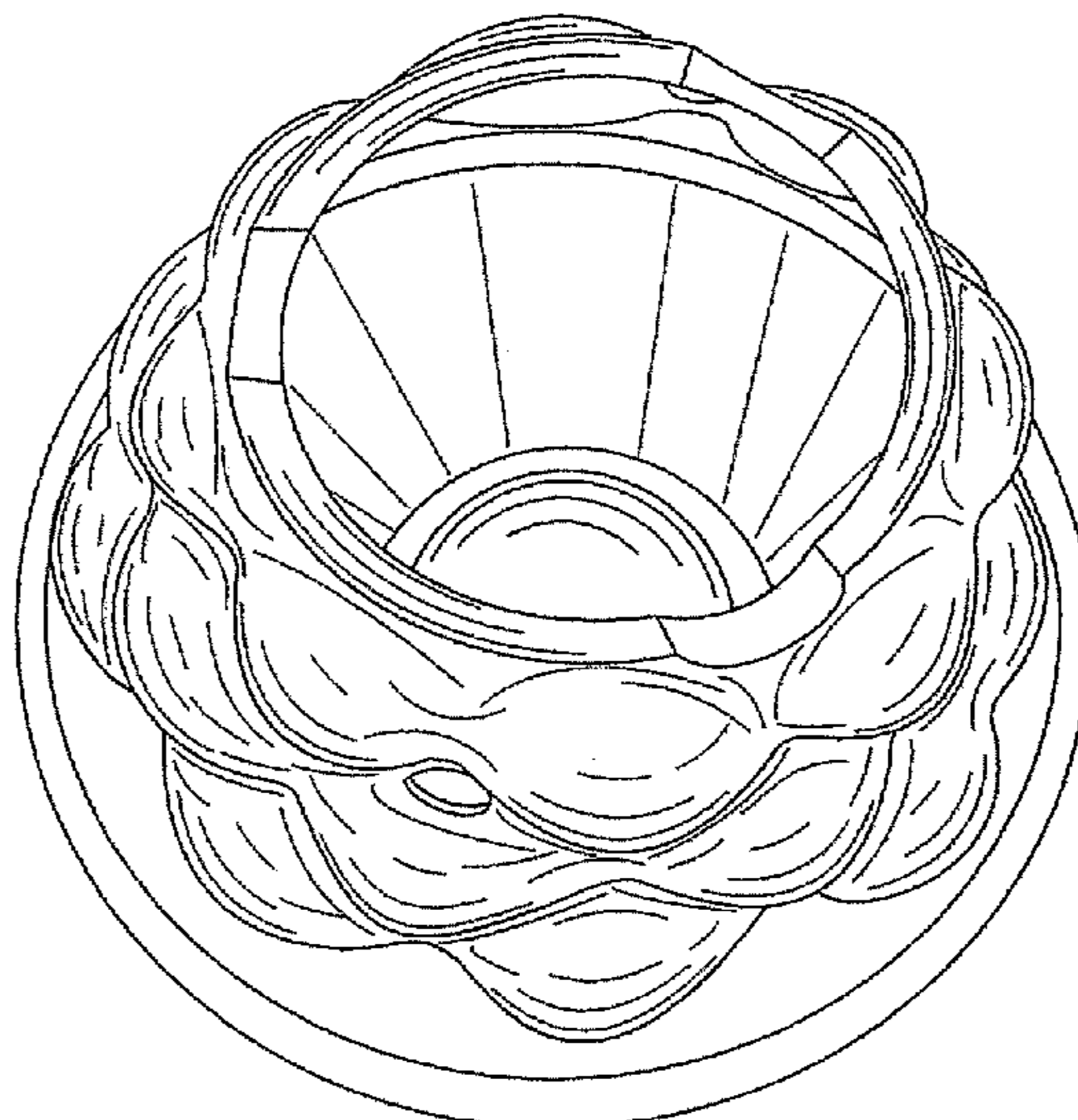
The ornamental design for a produce container, as shown and described.

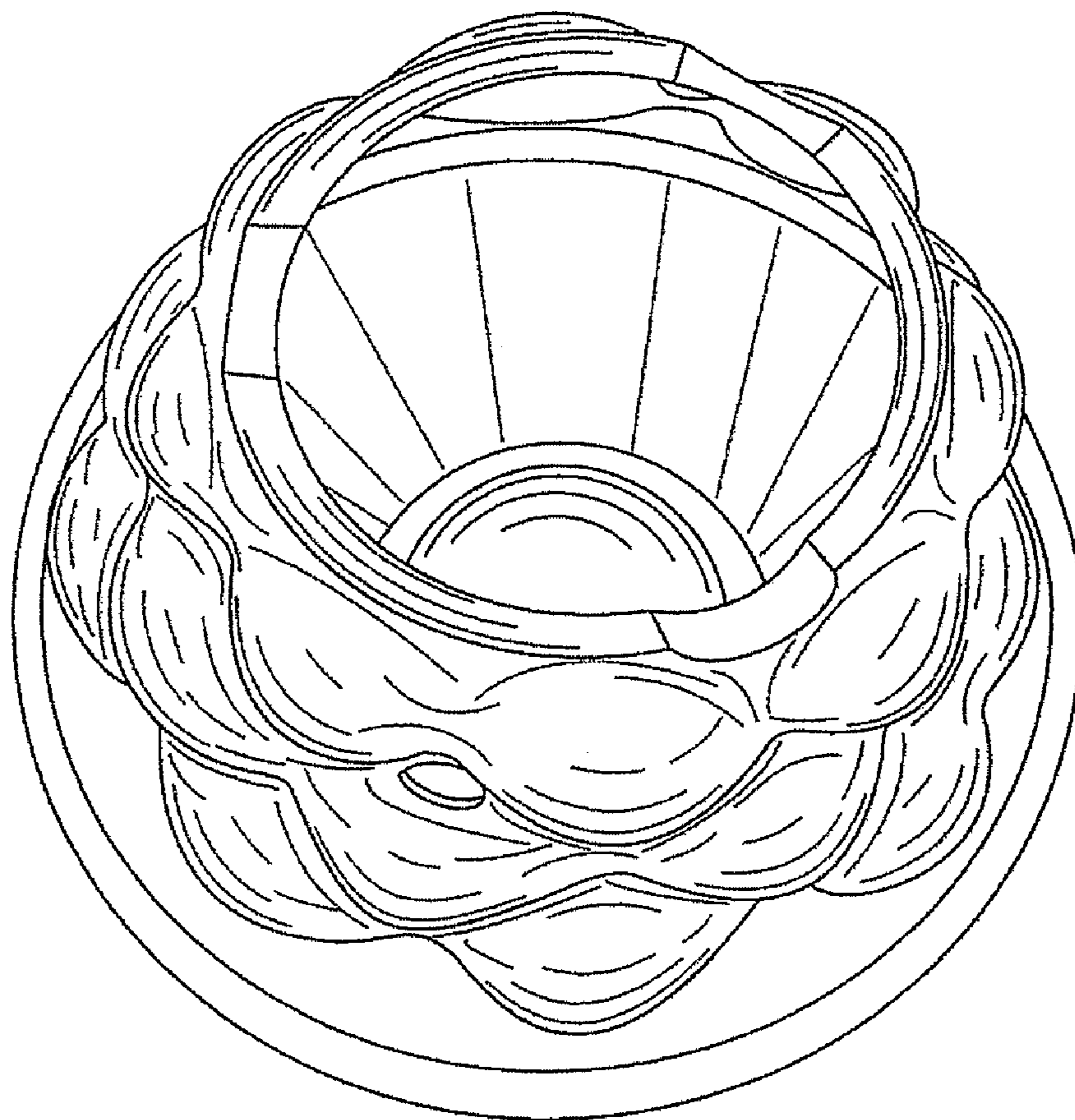
**DESCRIPTION**
