FIG. 12 is a back view of the cover illustrated in FIG. 8.

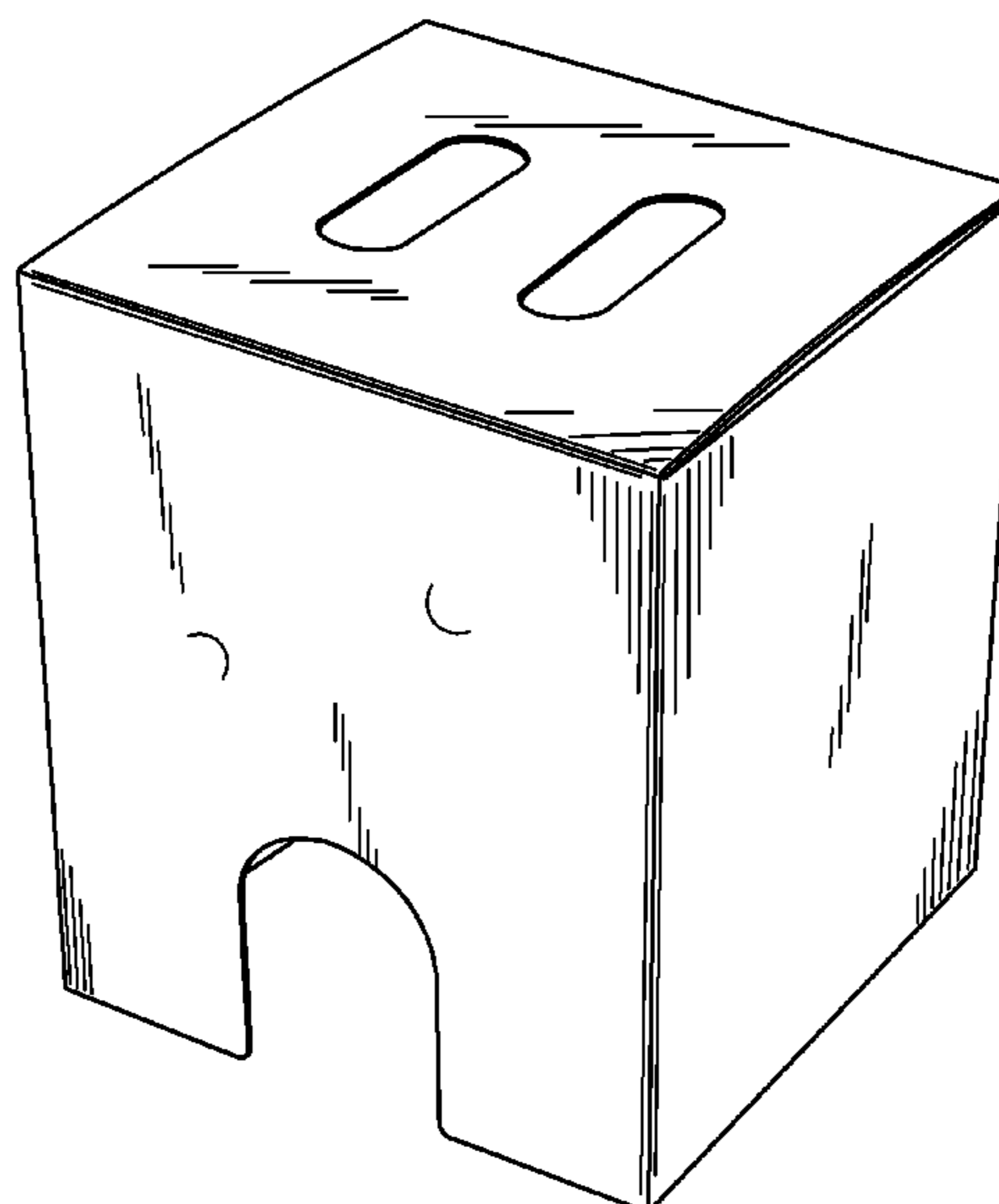
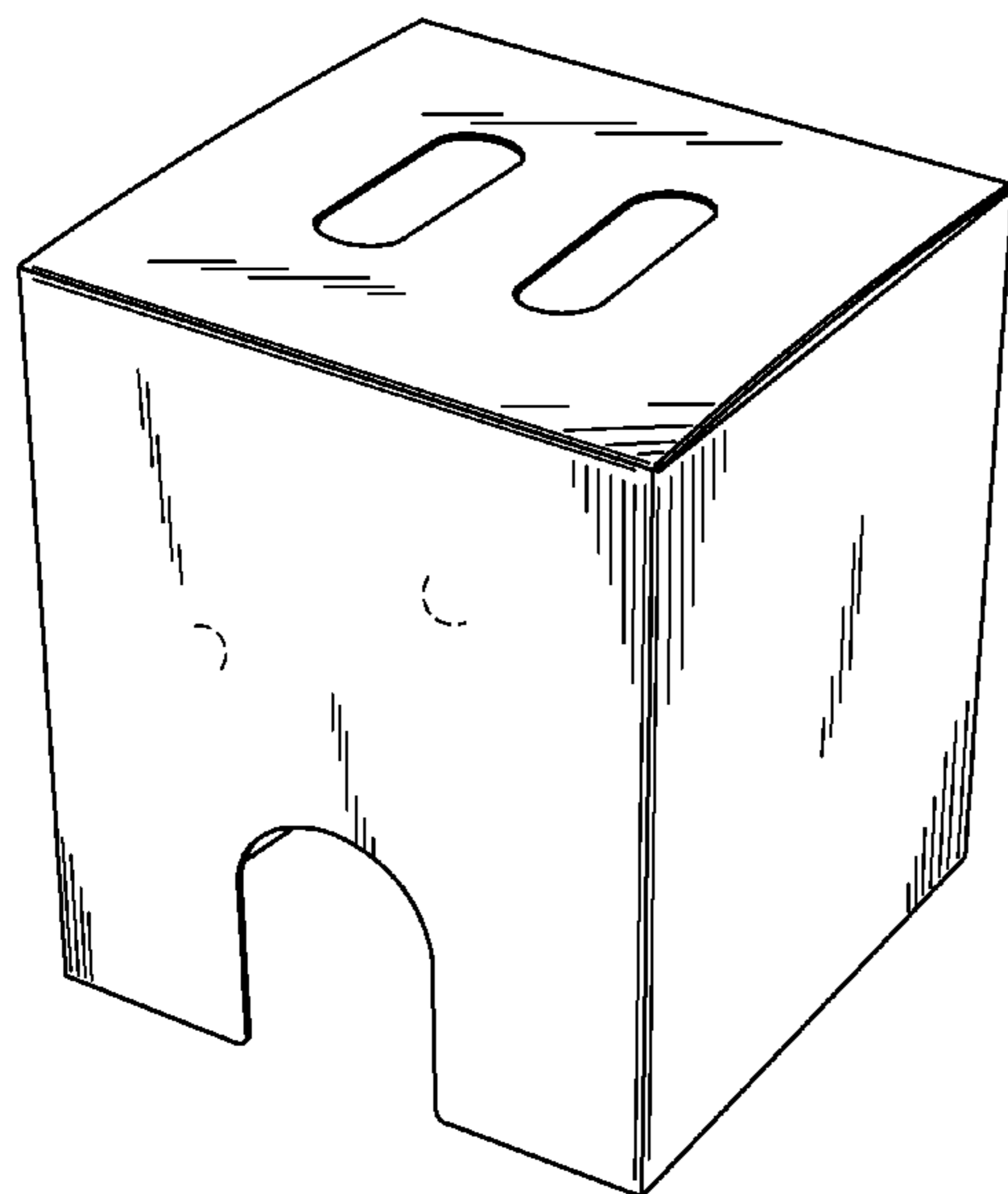
FIG. 13 is a top view of the cover illustrated in FIG. 8; and,

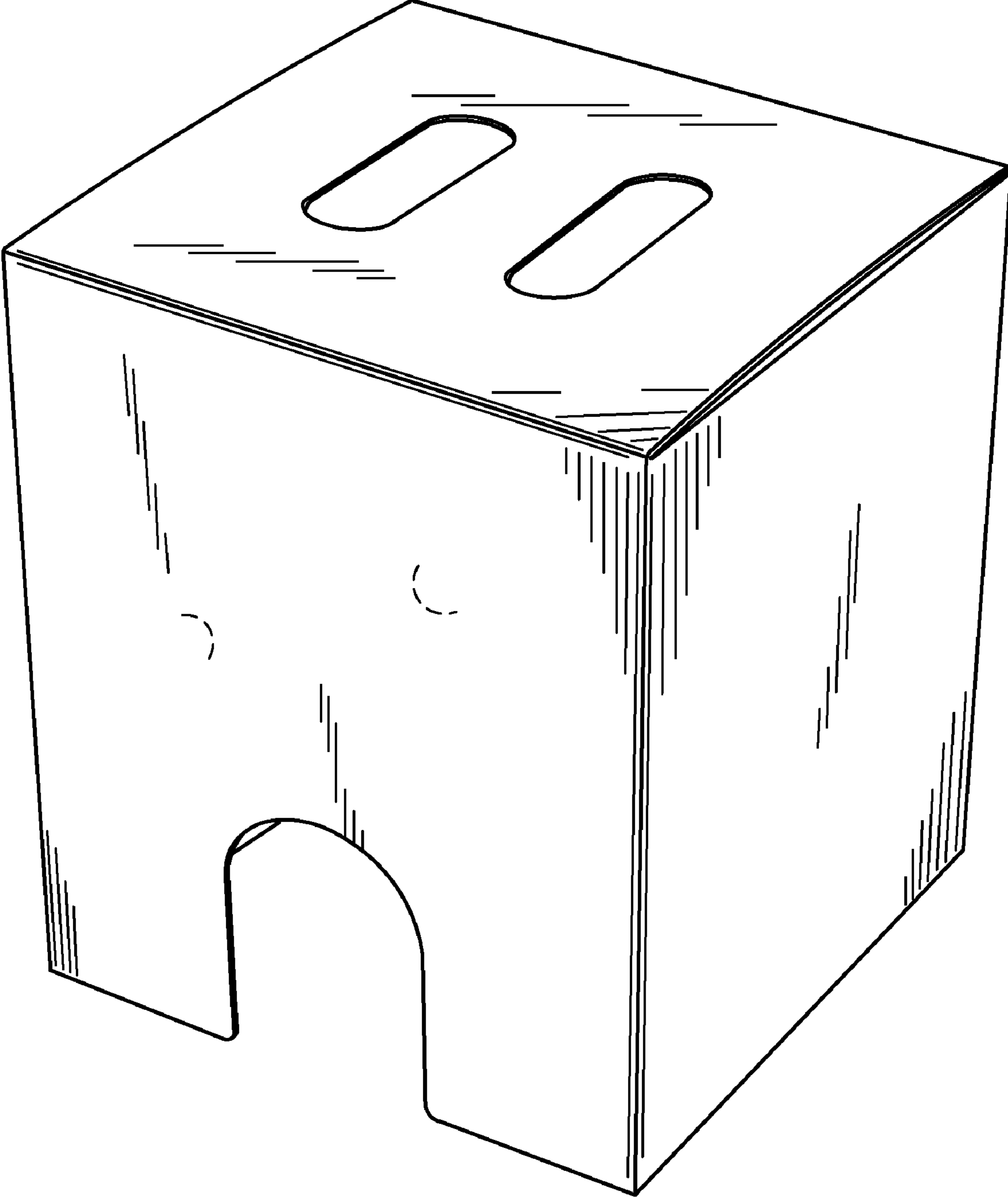

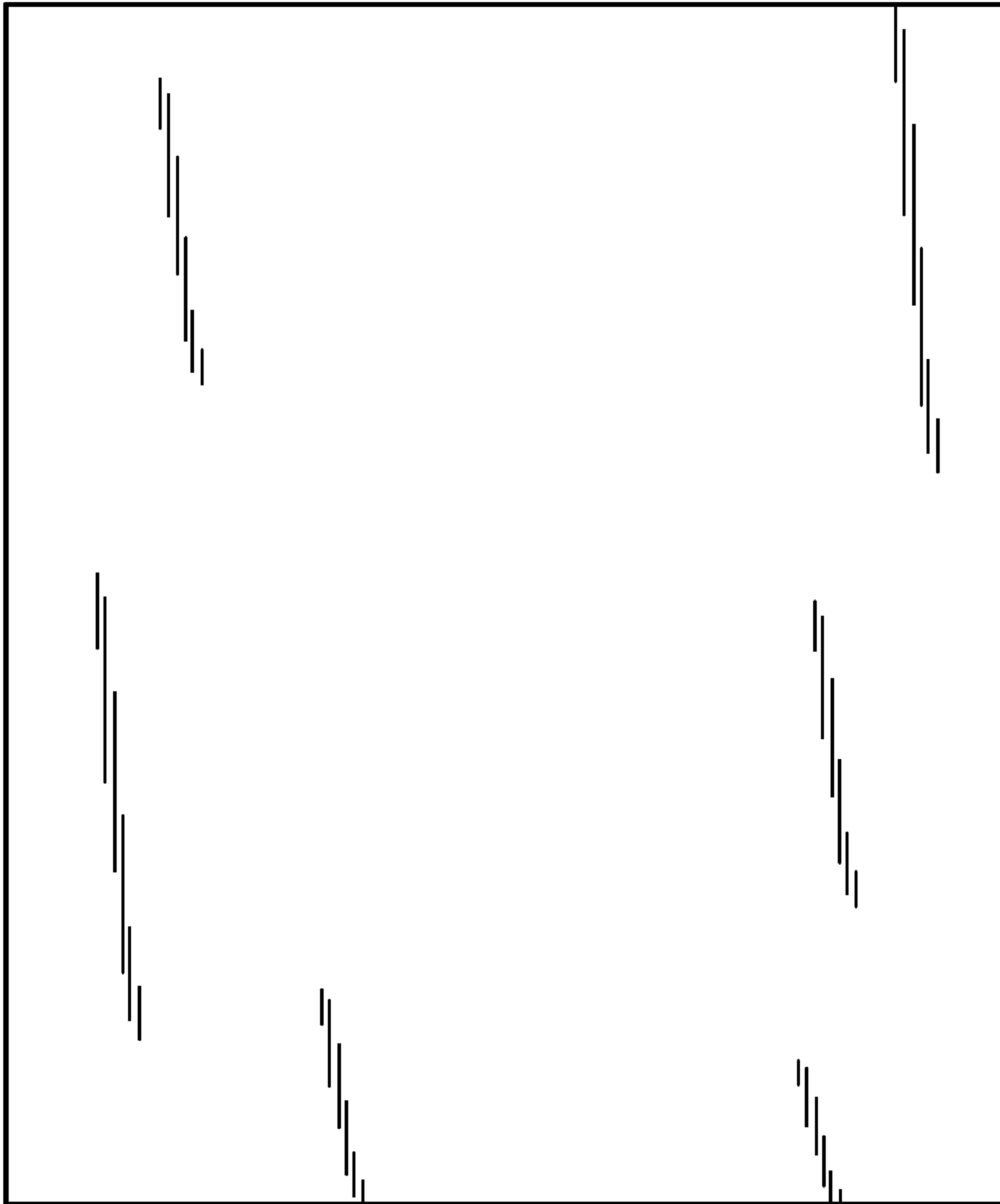

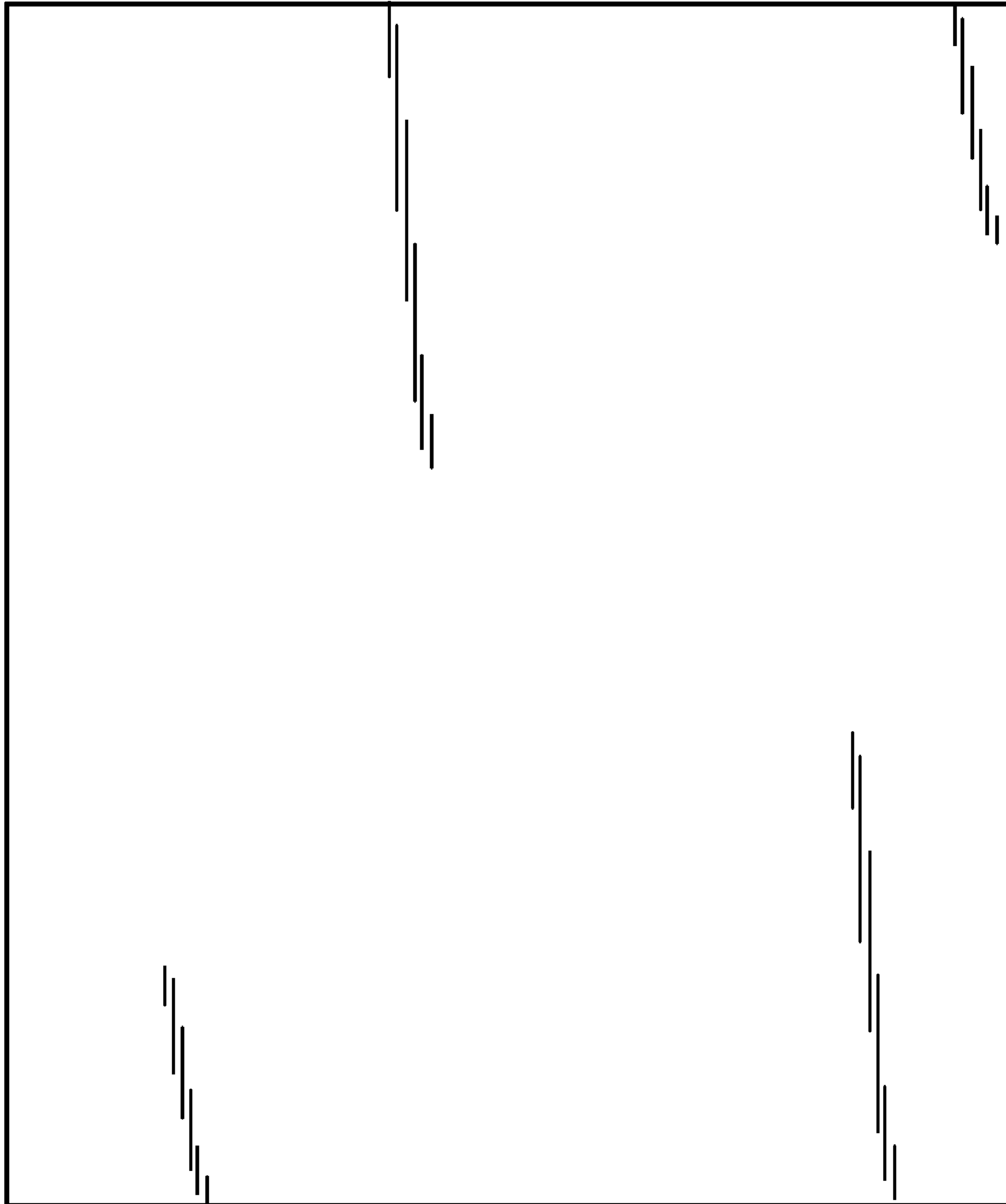

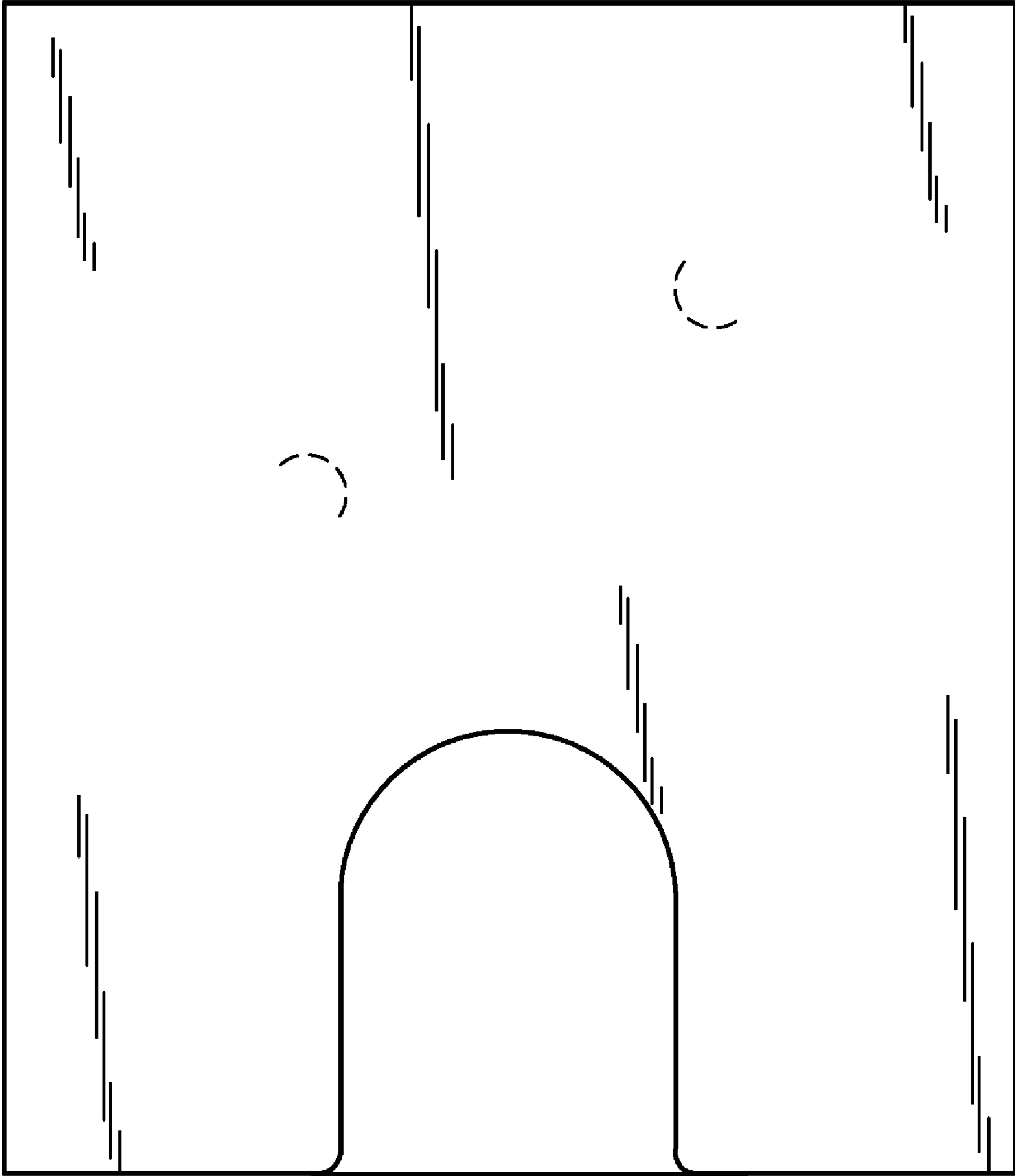

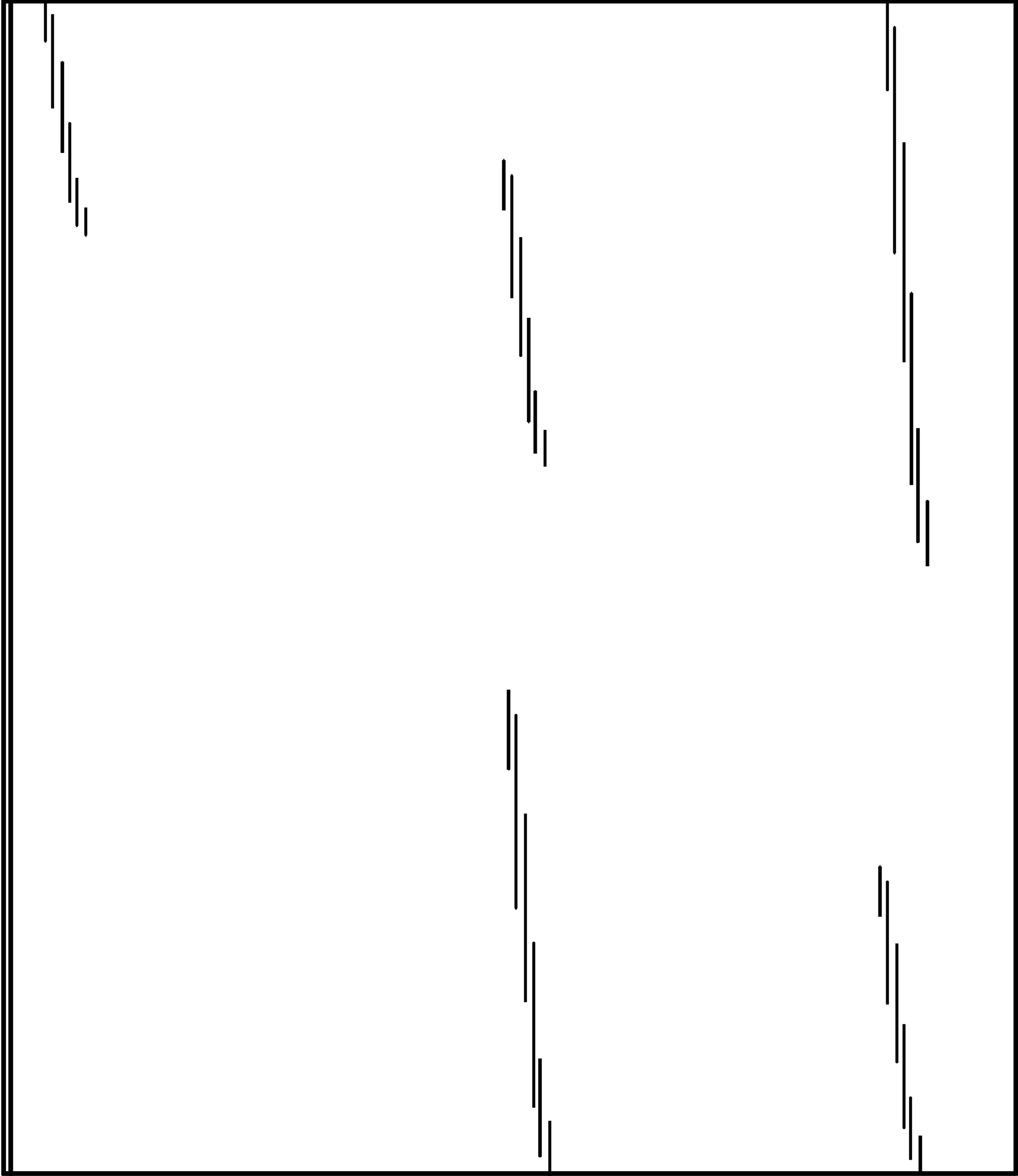

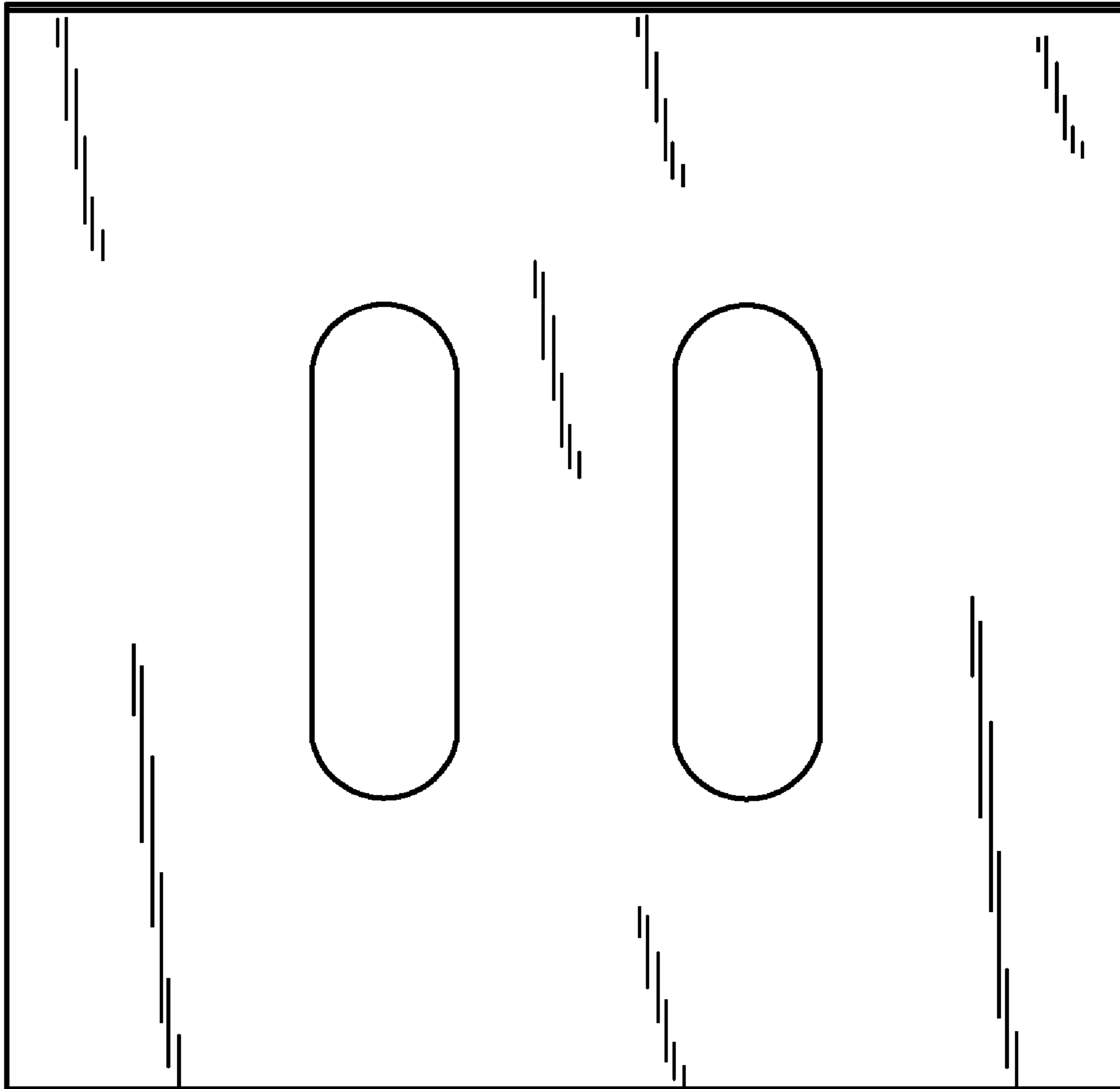

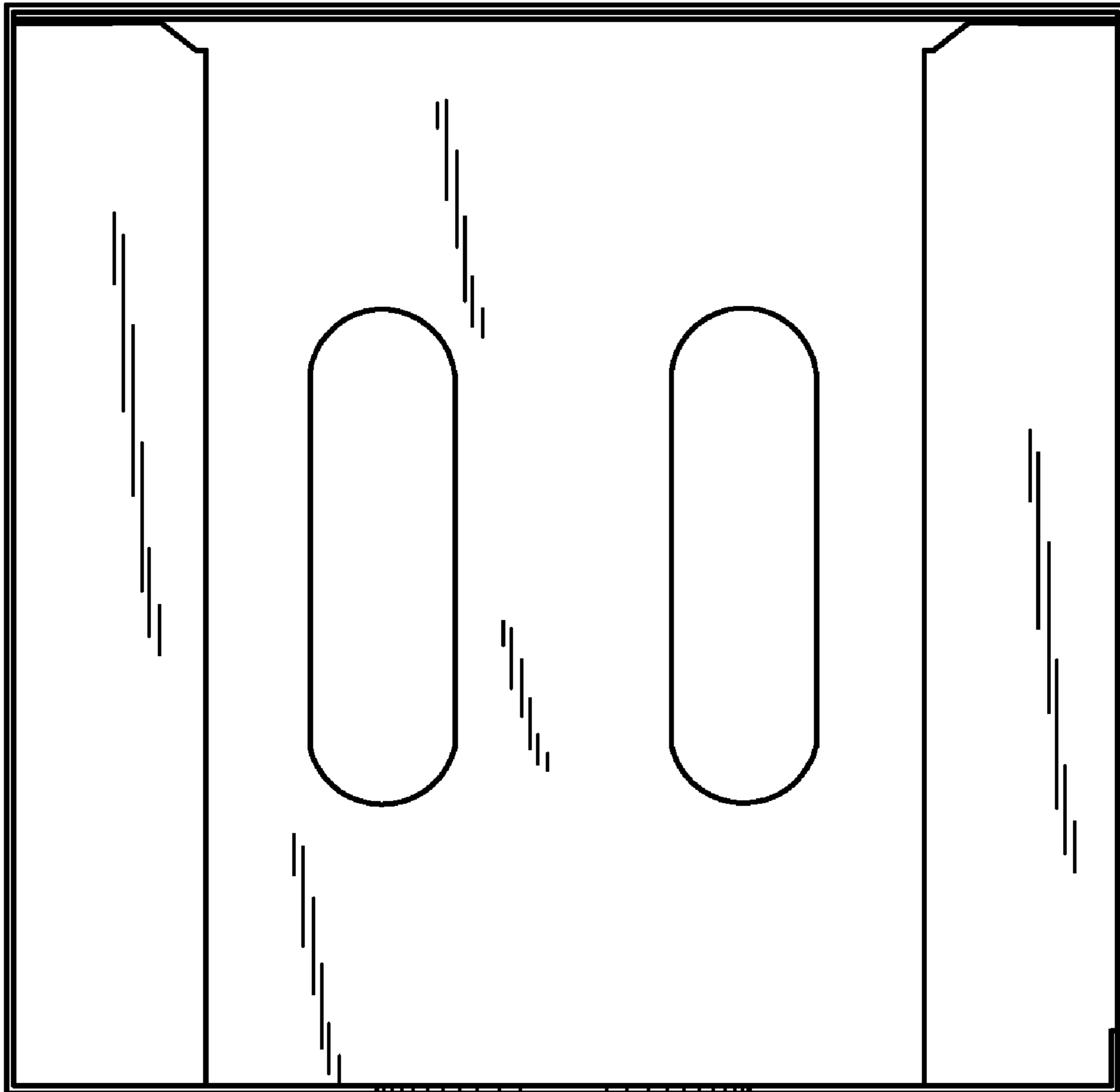

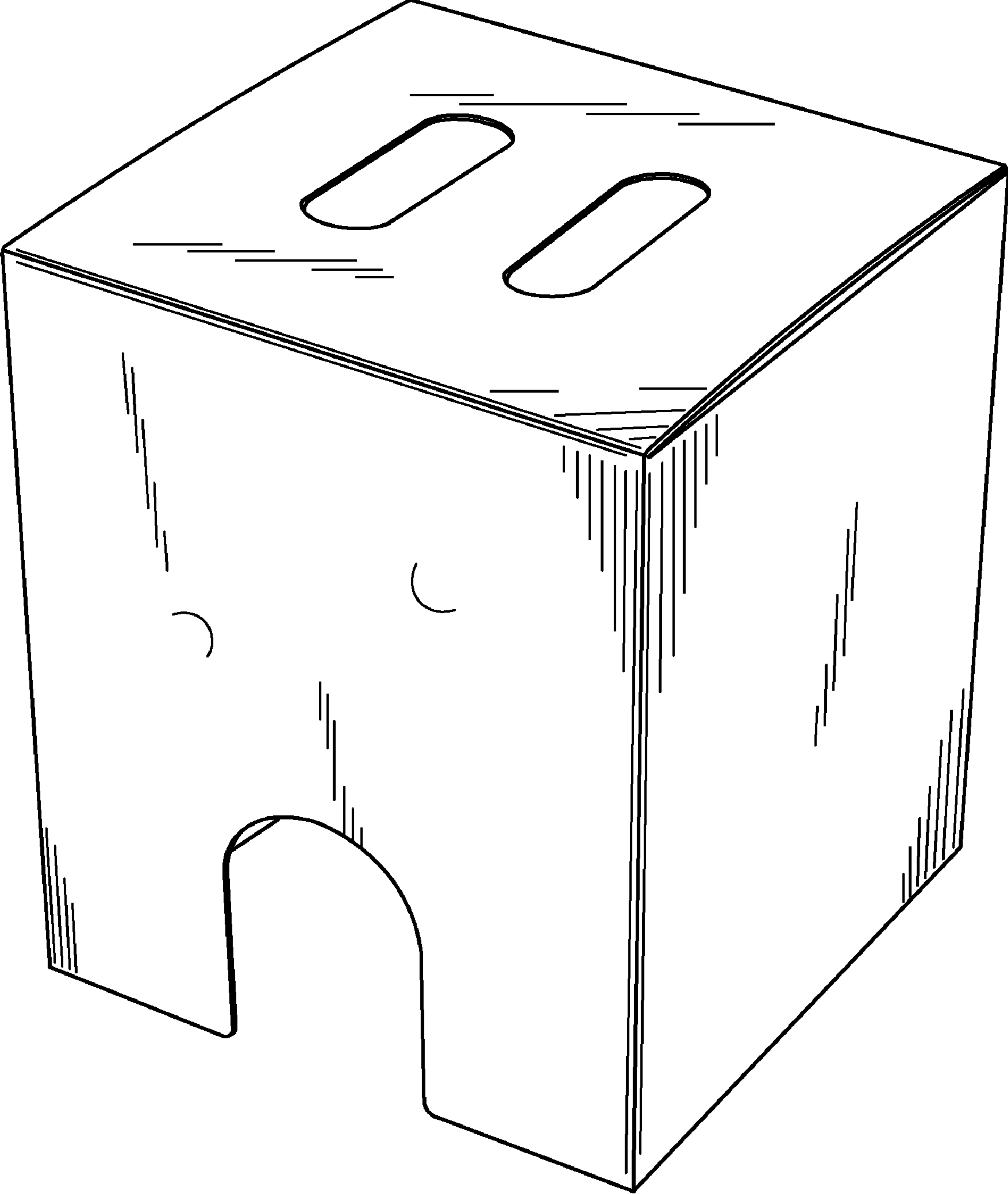

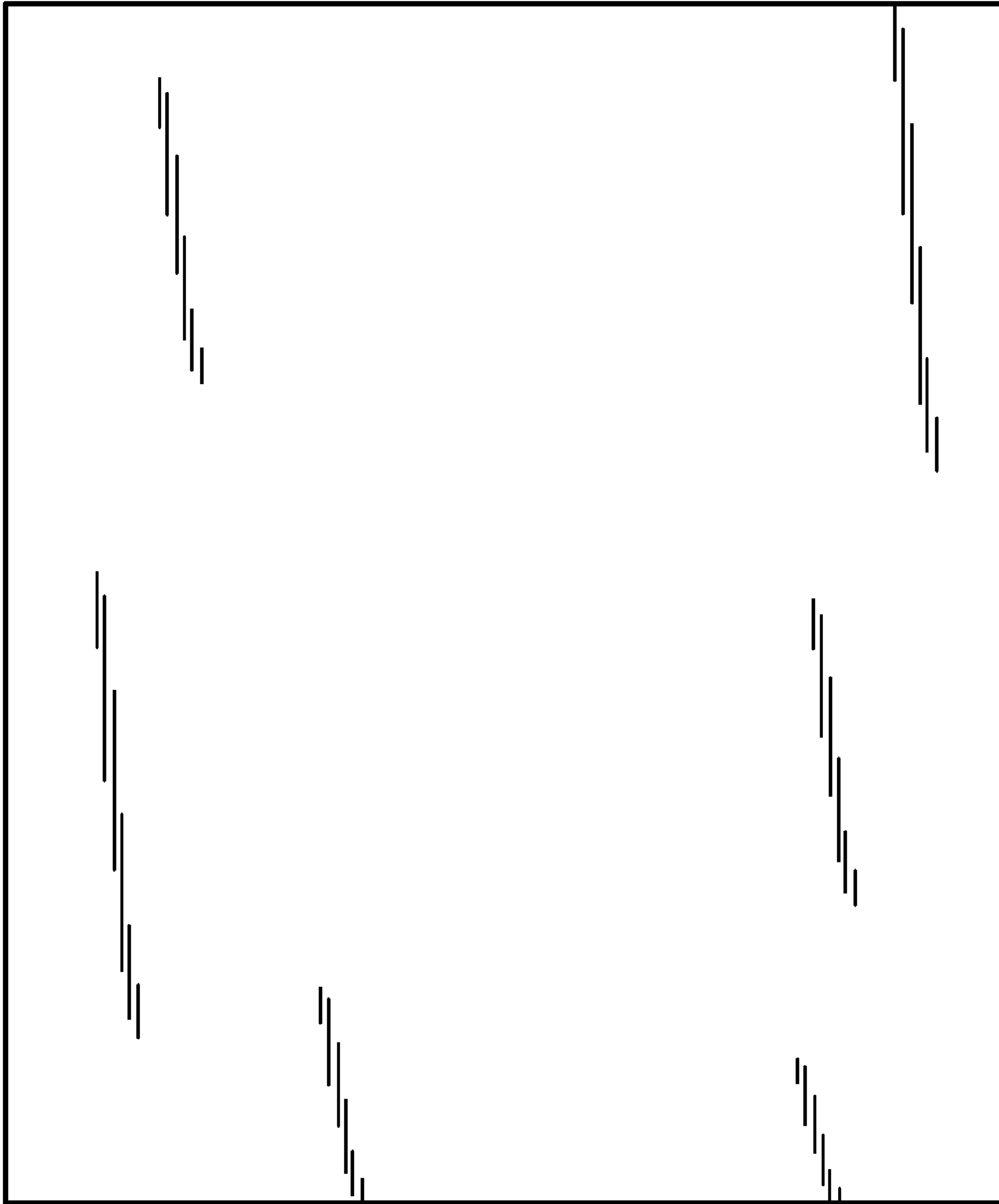

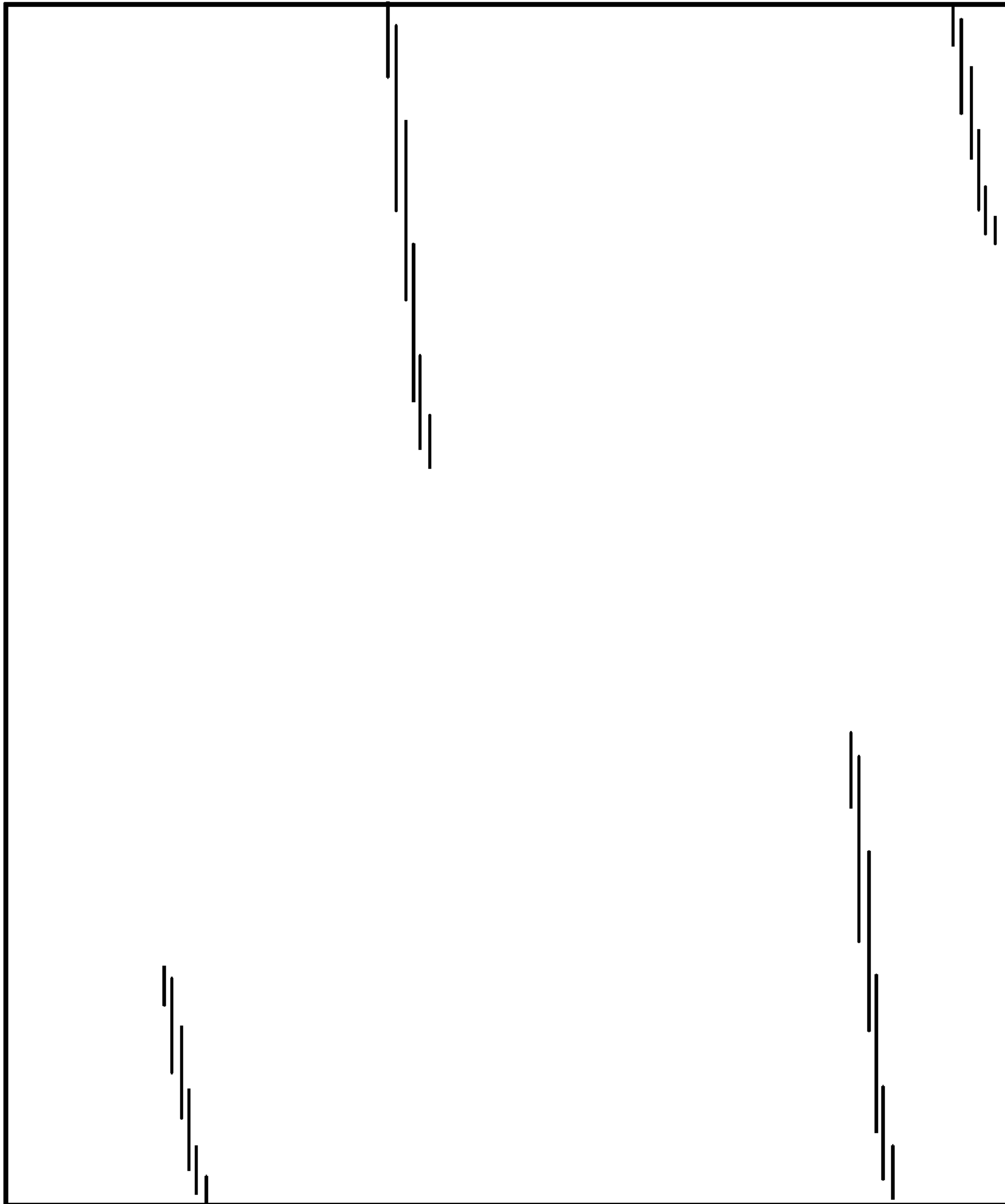

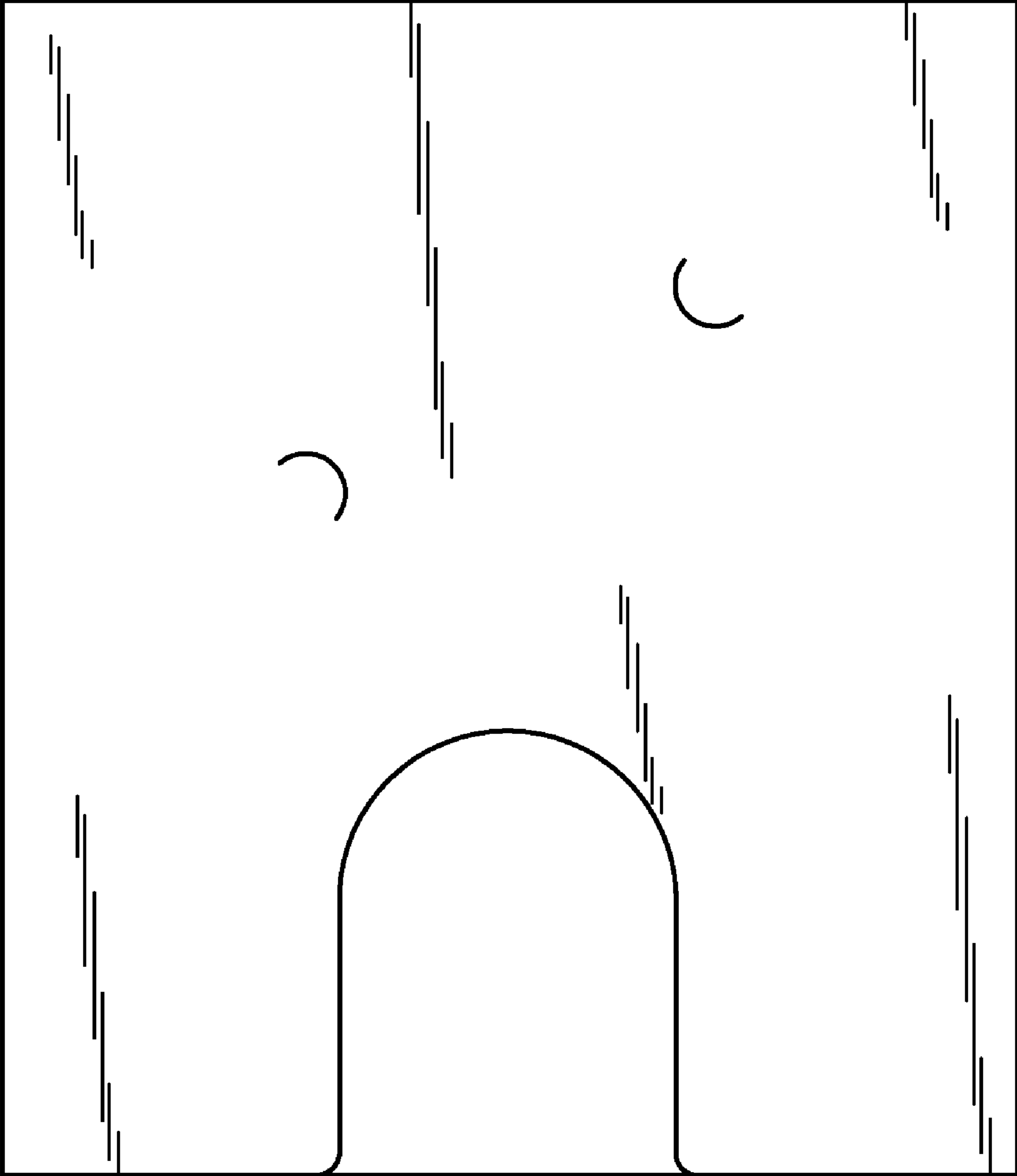

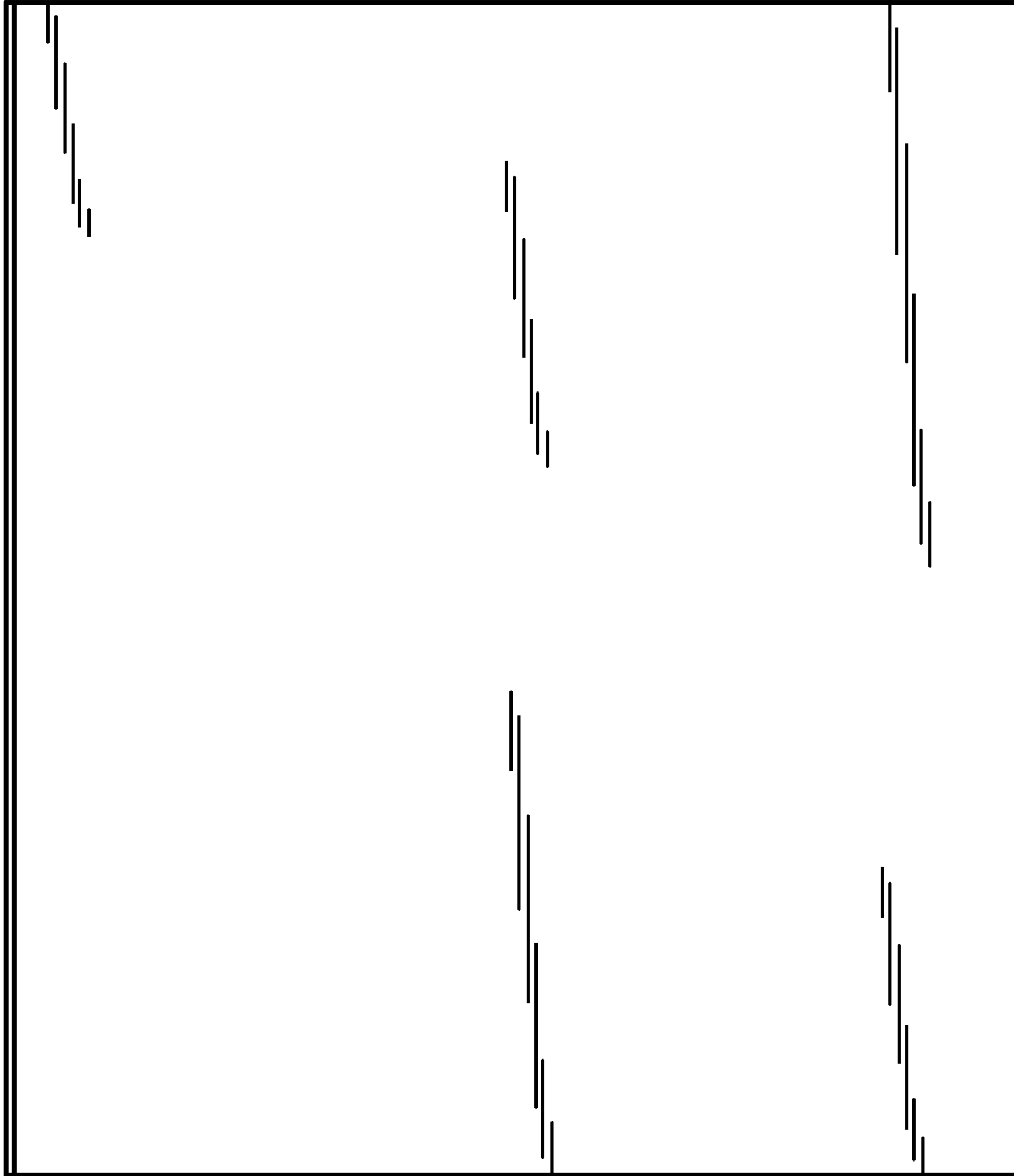

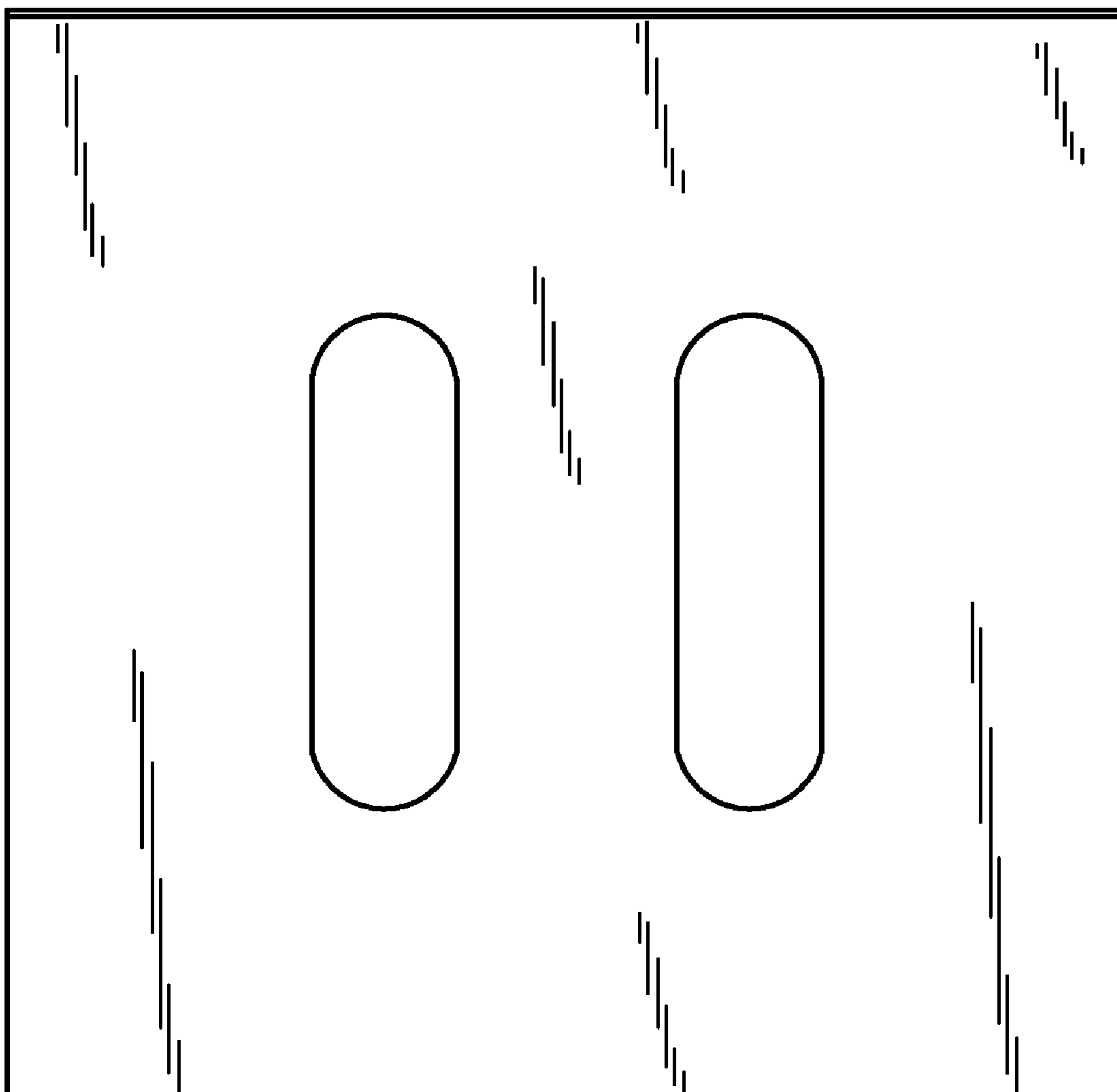

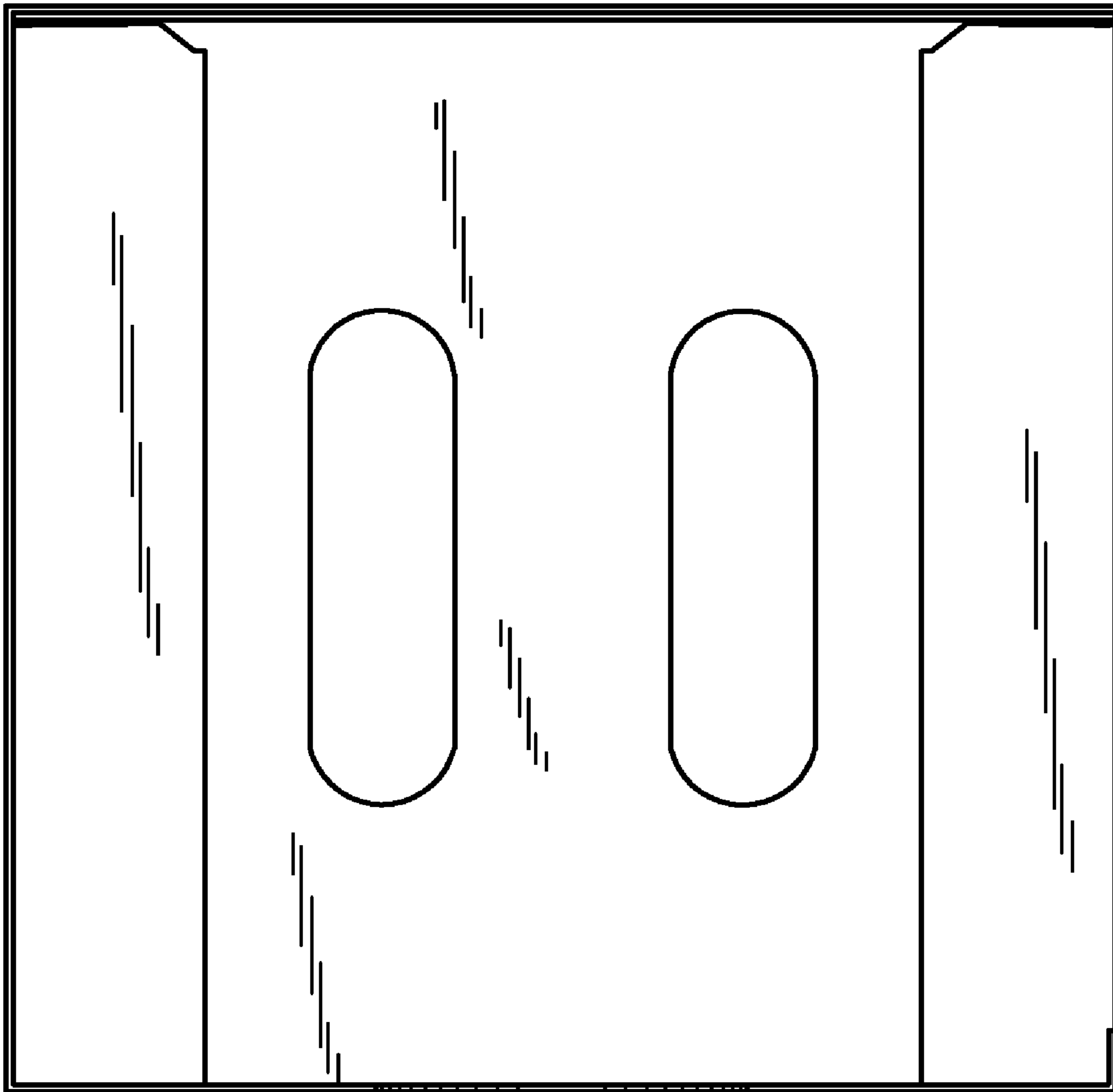
