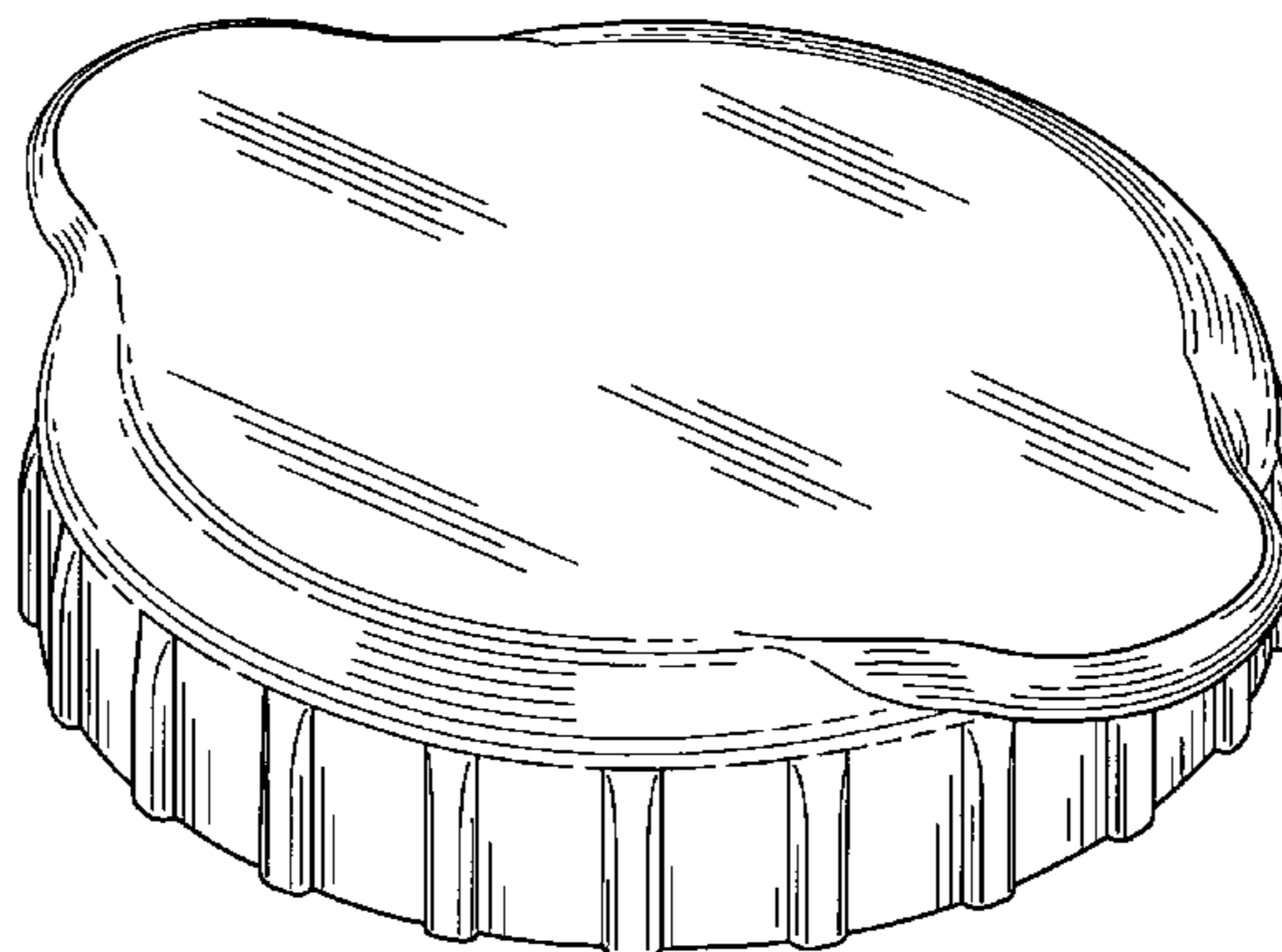
(57) **CLAIM**

The ornamental design for a bottle cap, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view;  
FIG. 2 is a bottom perspective view;  
FIG. 3 is a front elevation view; the rear elevation view being a mirror image thereof;  
FIG. 4 is a left side elevation view, the right side elevation view being a mirror image thereof;  
FIG. 5 is a top plan view; and,  
FIG. 6 is a bottom plan view.  
The broken line showing of internal threads in FIGS. 2 and 6 is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

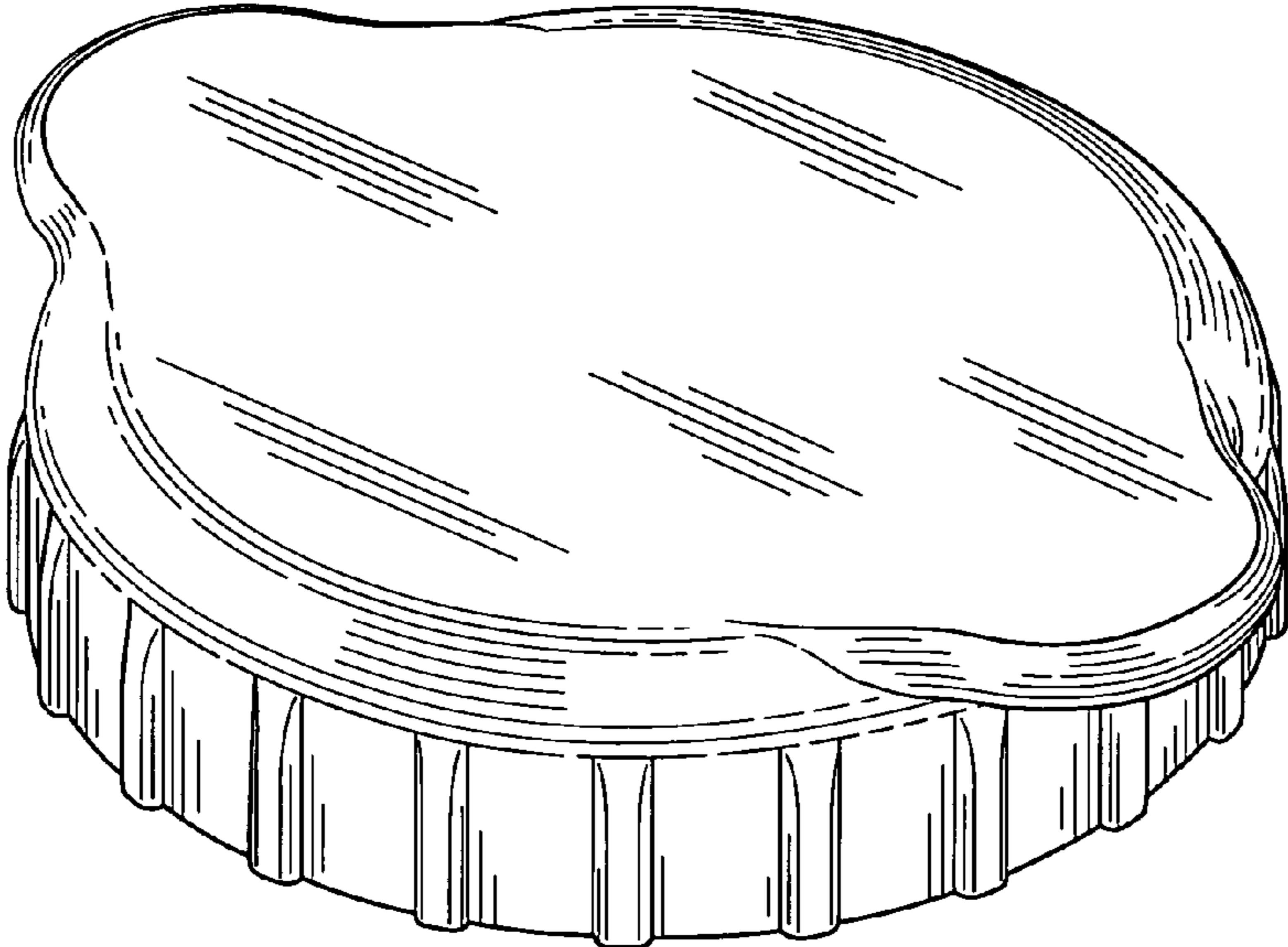

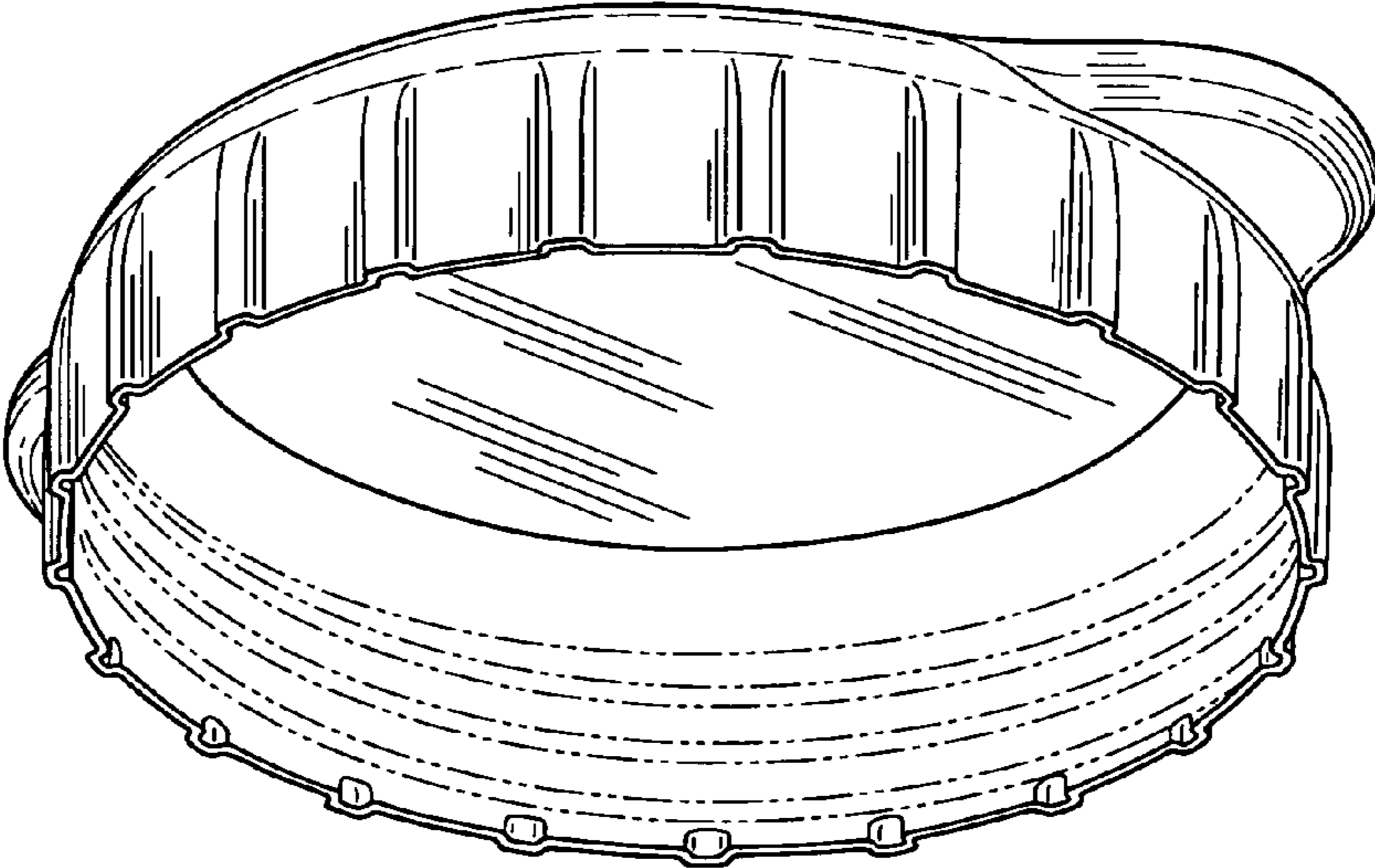
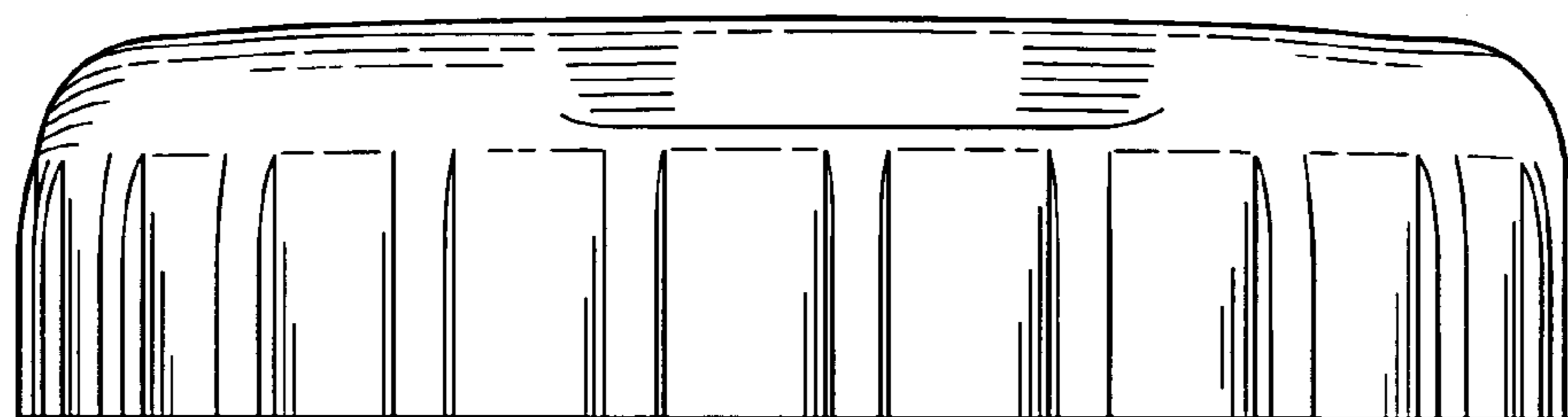

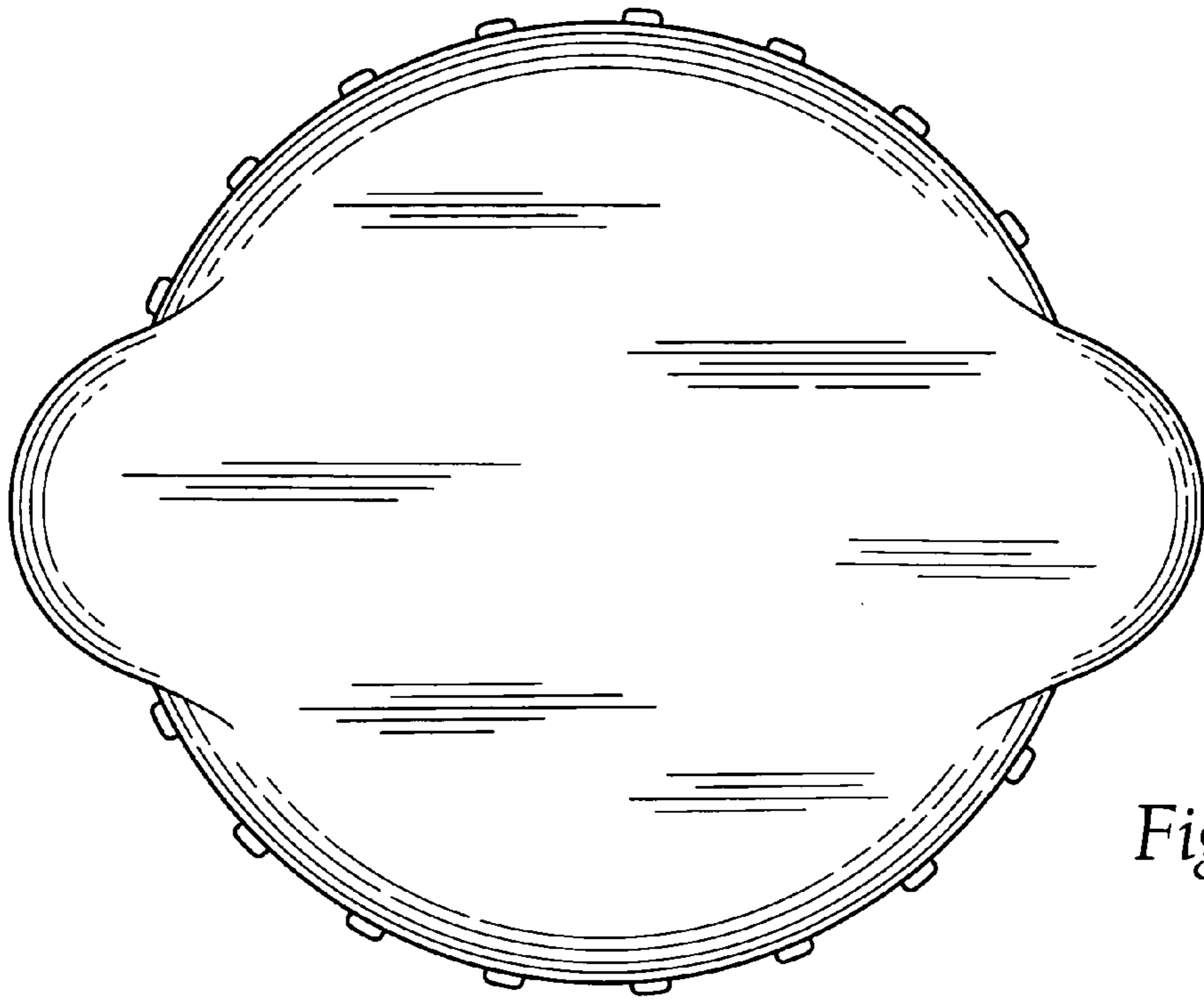

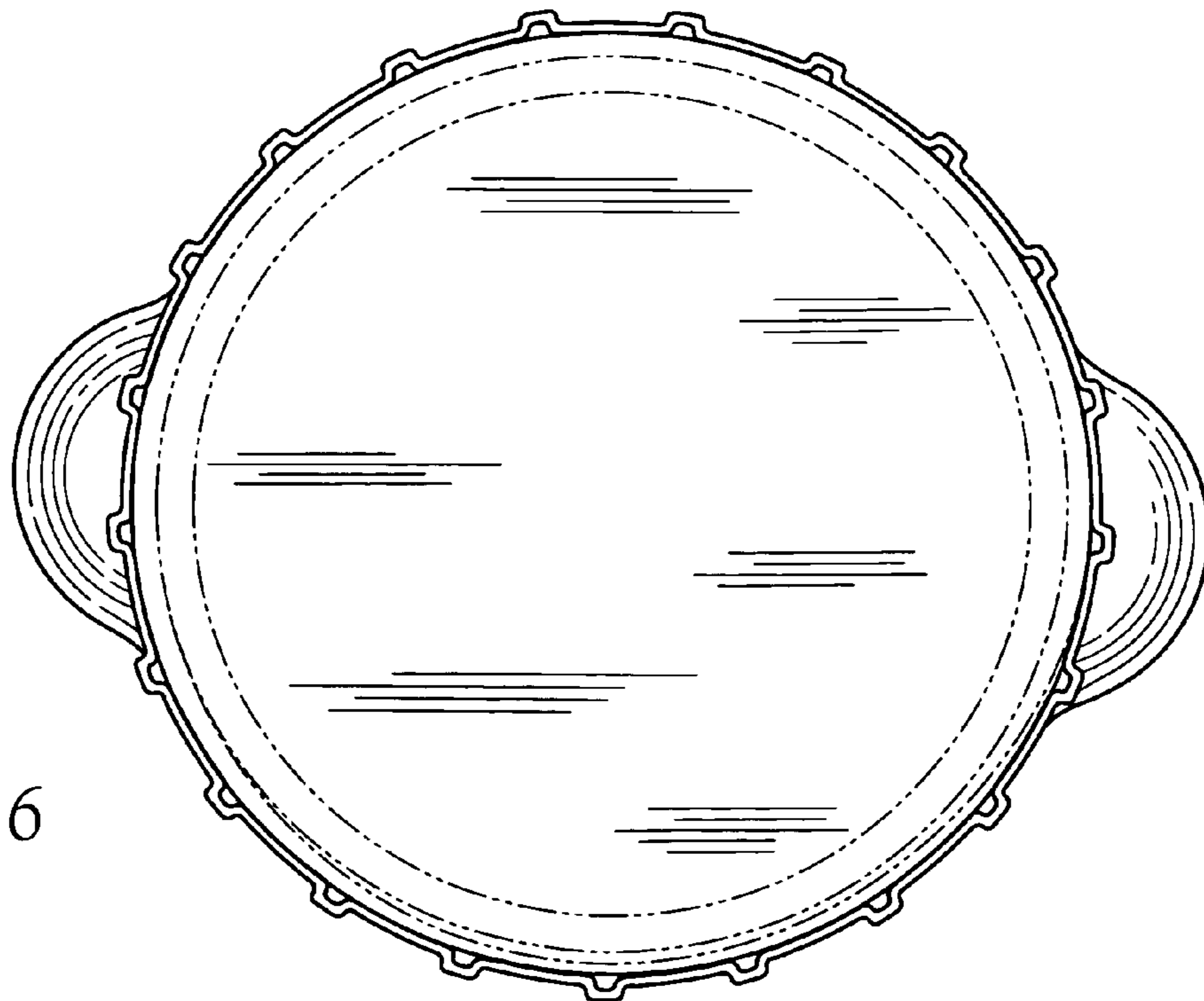
