(57) **CLAIM**

I claim the ornamental design for a handlebar, as shown and
described.

DESCRIPTION

FIG. 1 is a front left perspective view of a handlebar.

FIG. 2 is an elevation view of the left side of the handlebar
illustrated in FIG. 1.

FIG. 3 is an elevation view of the right side of the handlebar
illustrated in FIG. 1.

FIG. 4 is a rear elevation view of the handlebar illustrated in
FIG. 1.

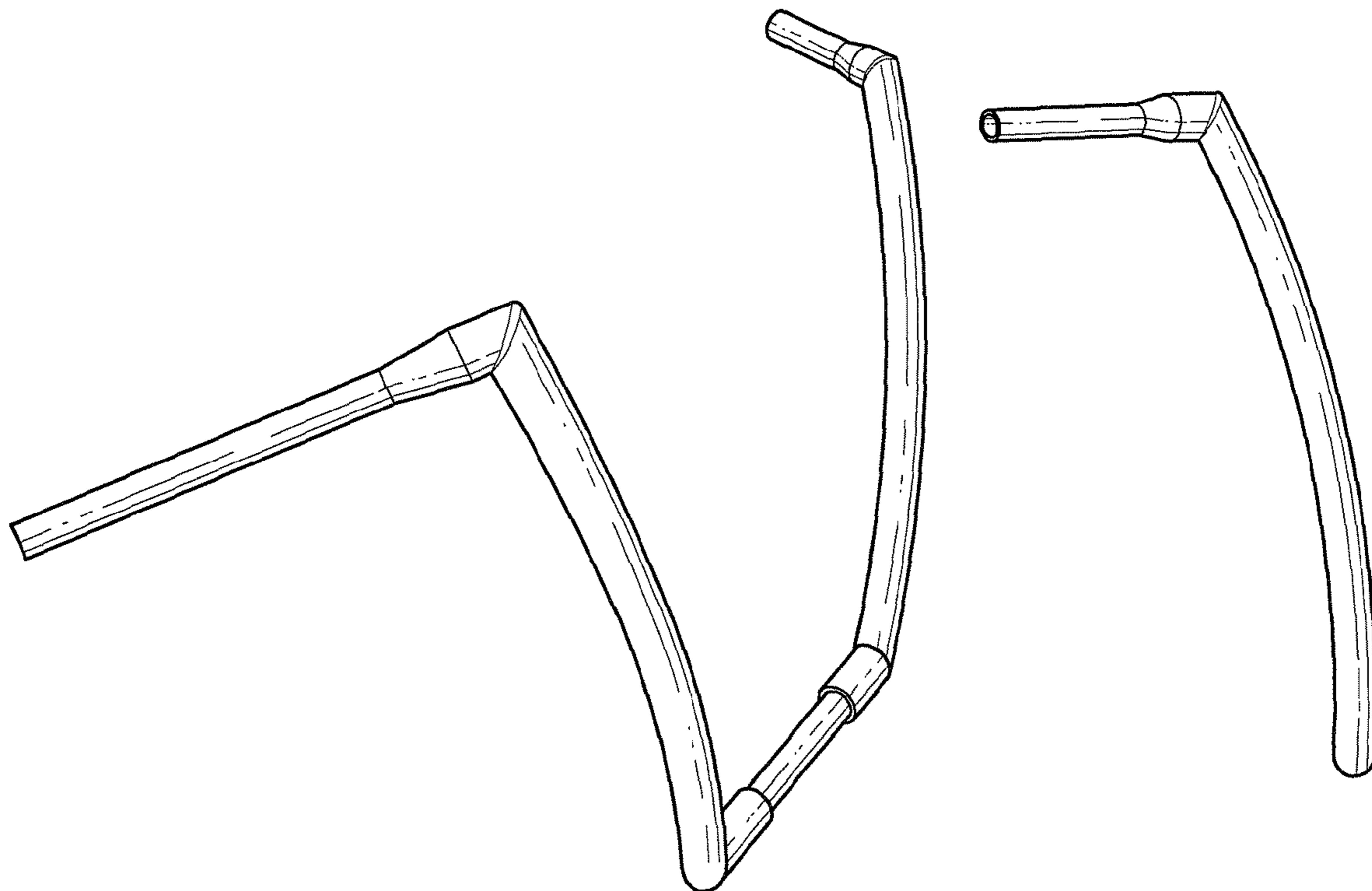
FIG. 5 is a front elevation view of the handlebar illustrated in

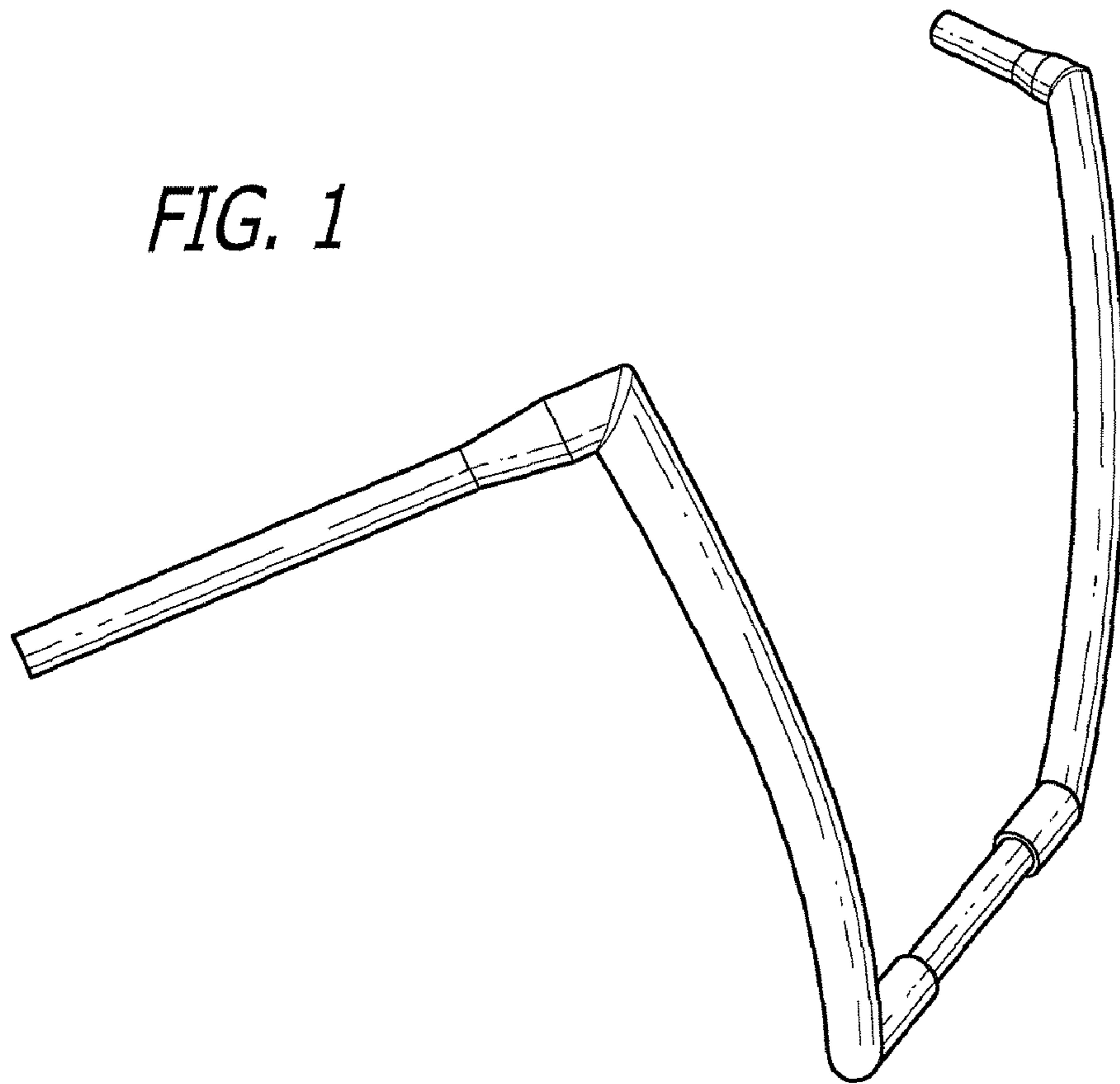

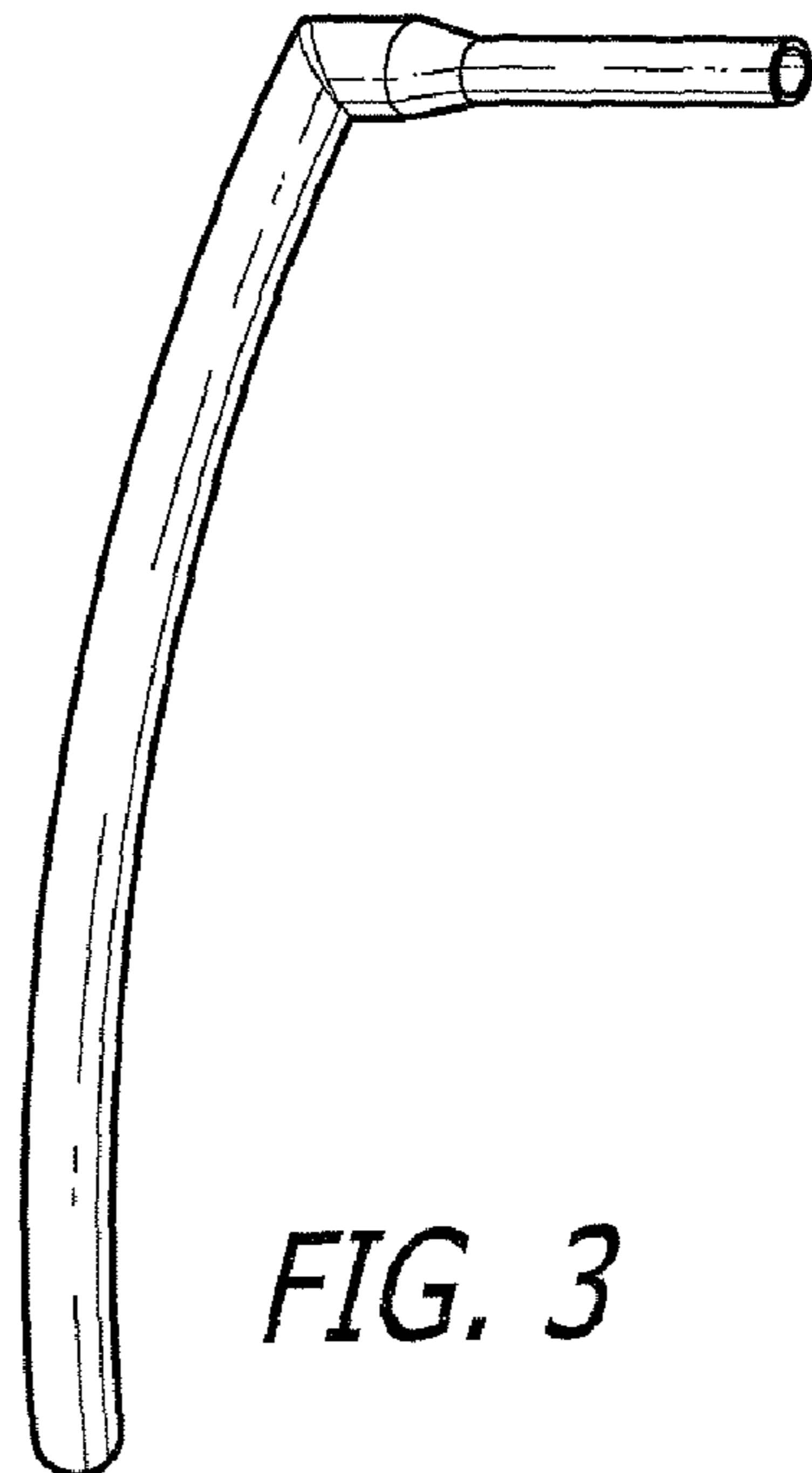

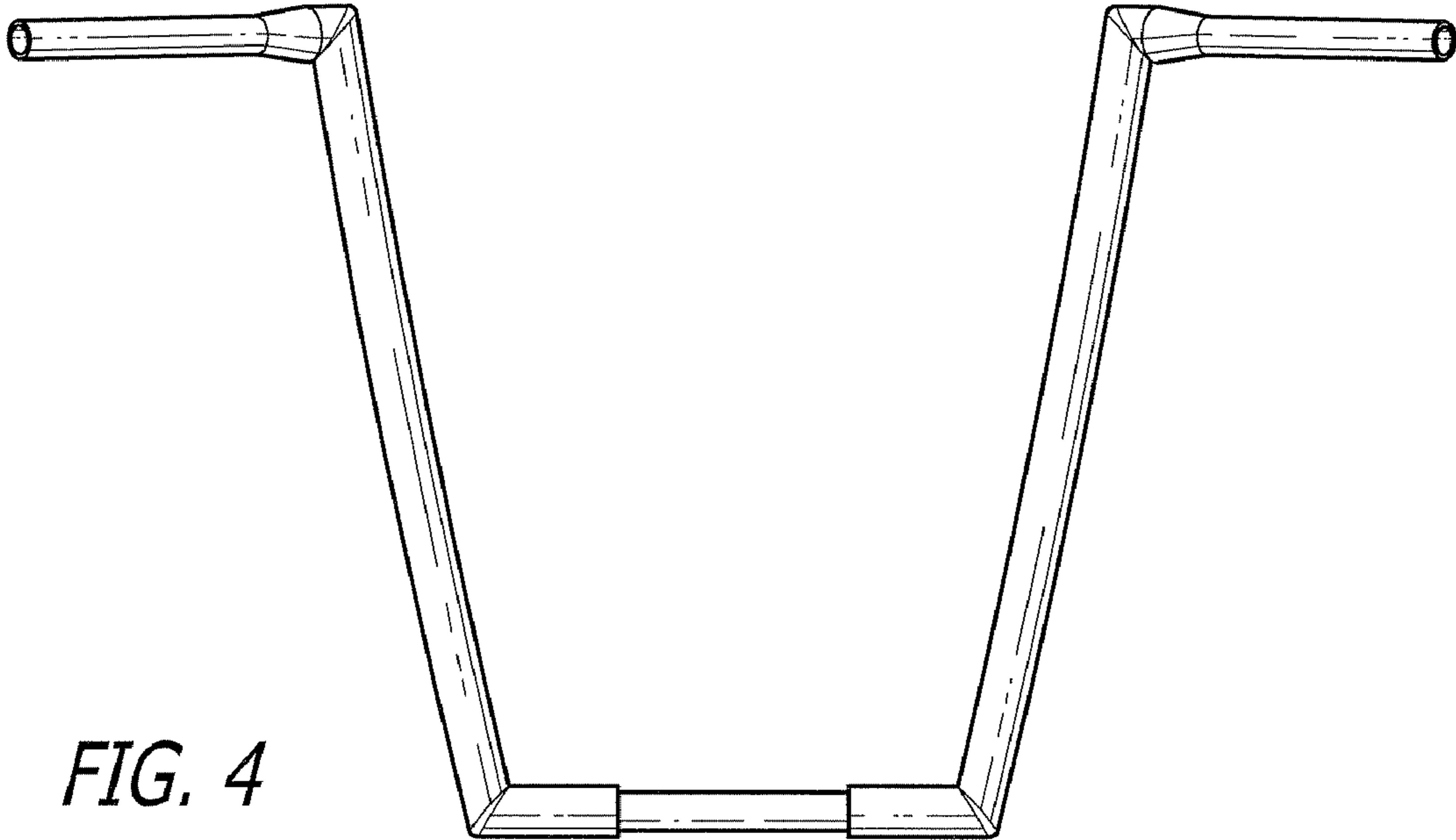

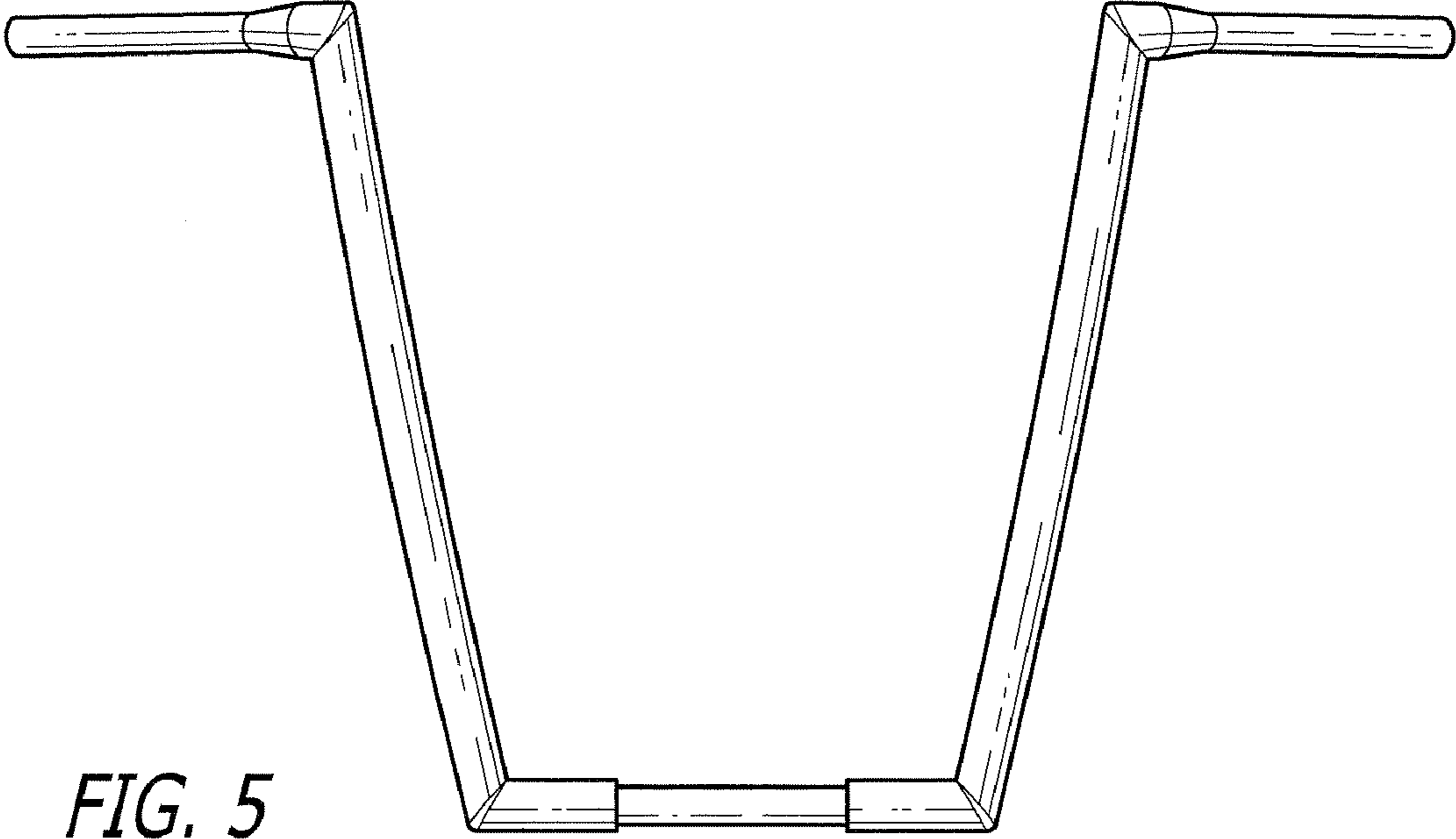

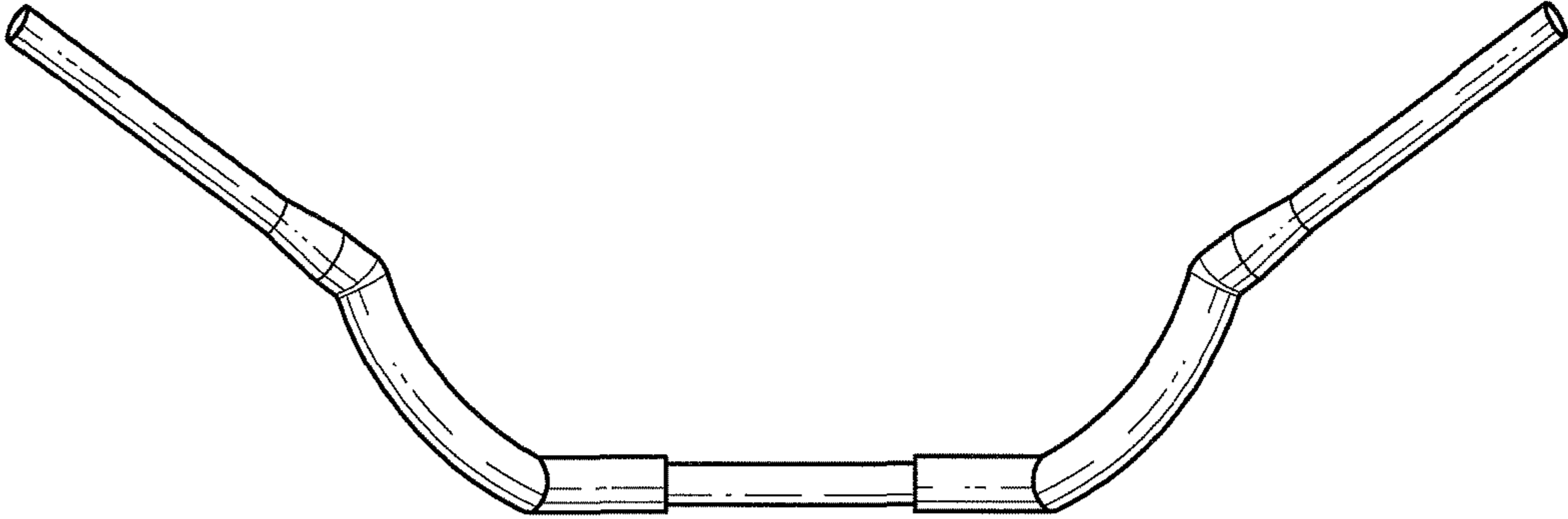

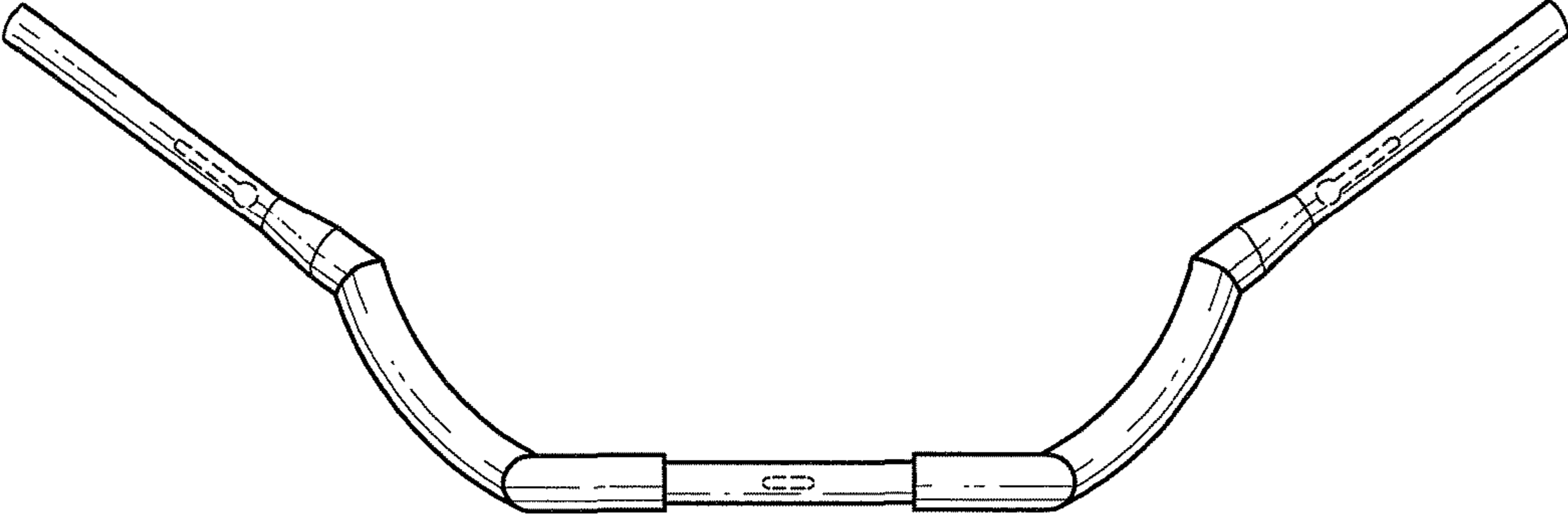
