The ornamental design for a decorative element for sunglasses, as shown and described.

**DESCRIPTION**

FIG. 4 is a top view of the sunglasses shown in FIG. 1;

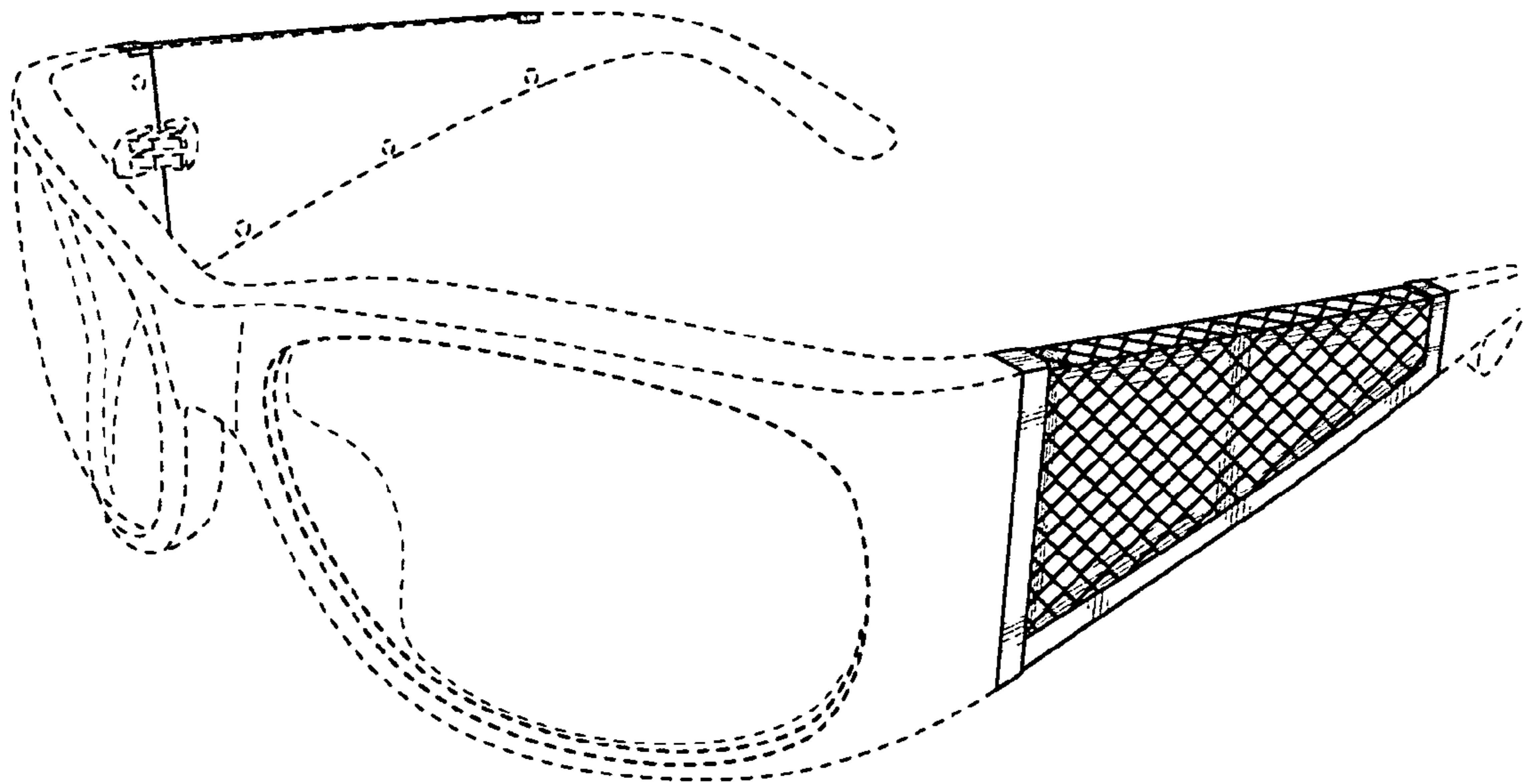
FIG. 5 is a bottom view of the sunglasses shown in FIG. 1;

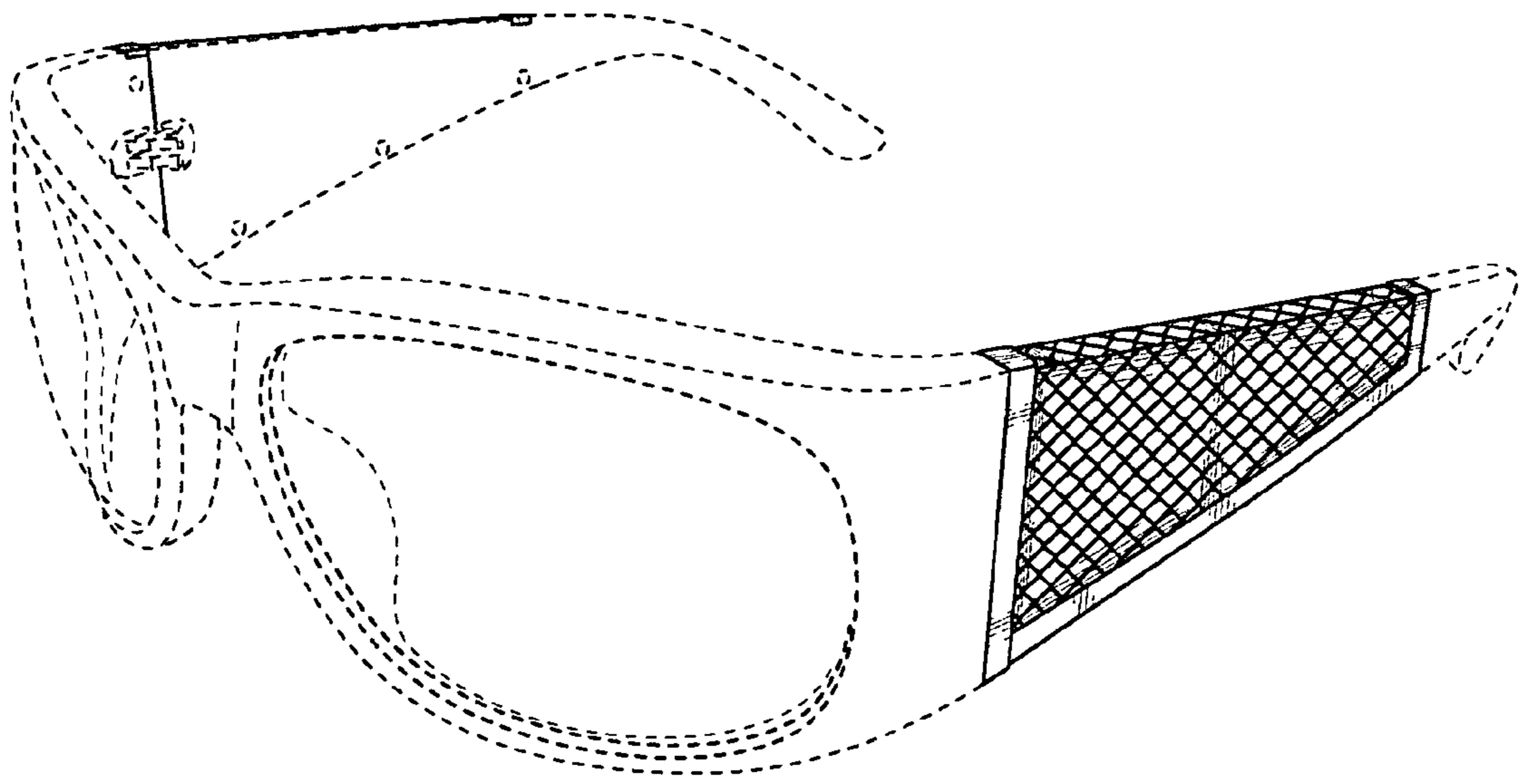

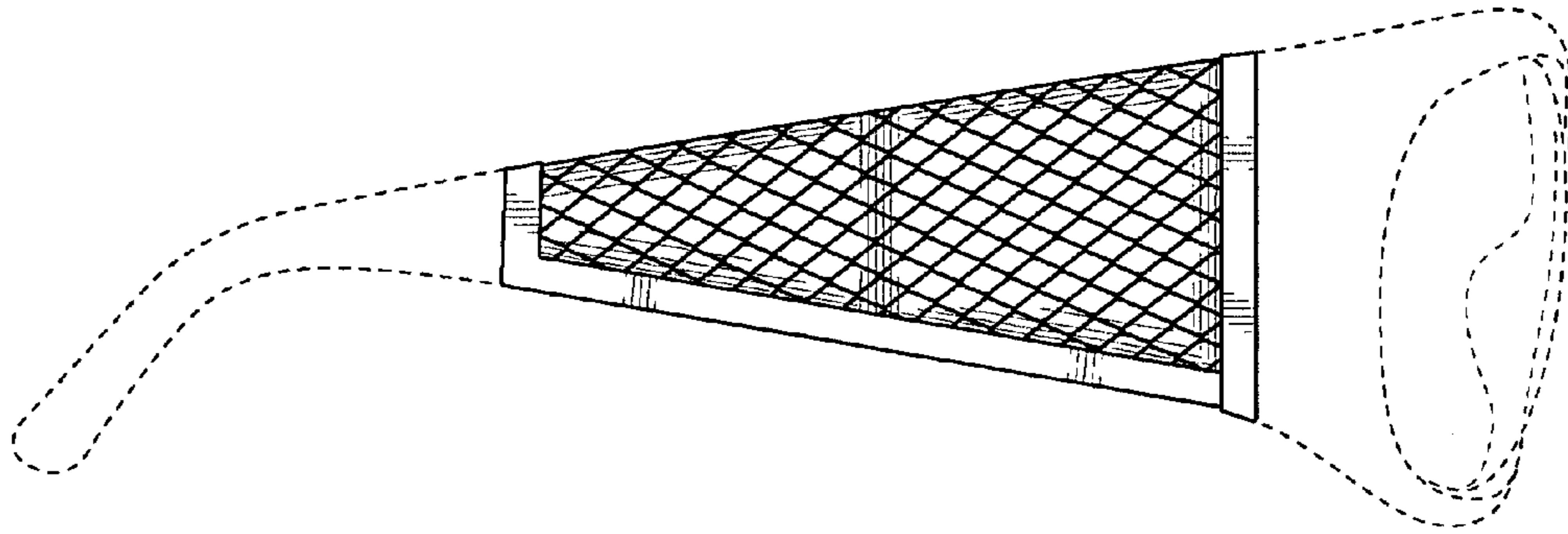

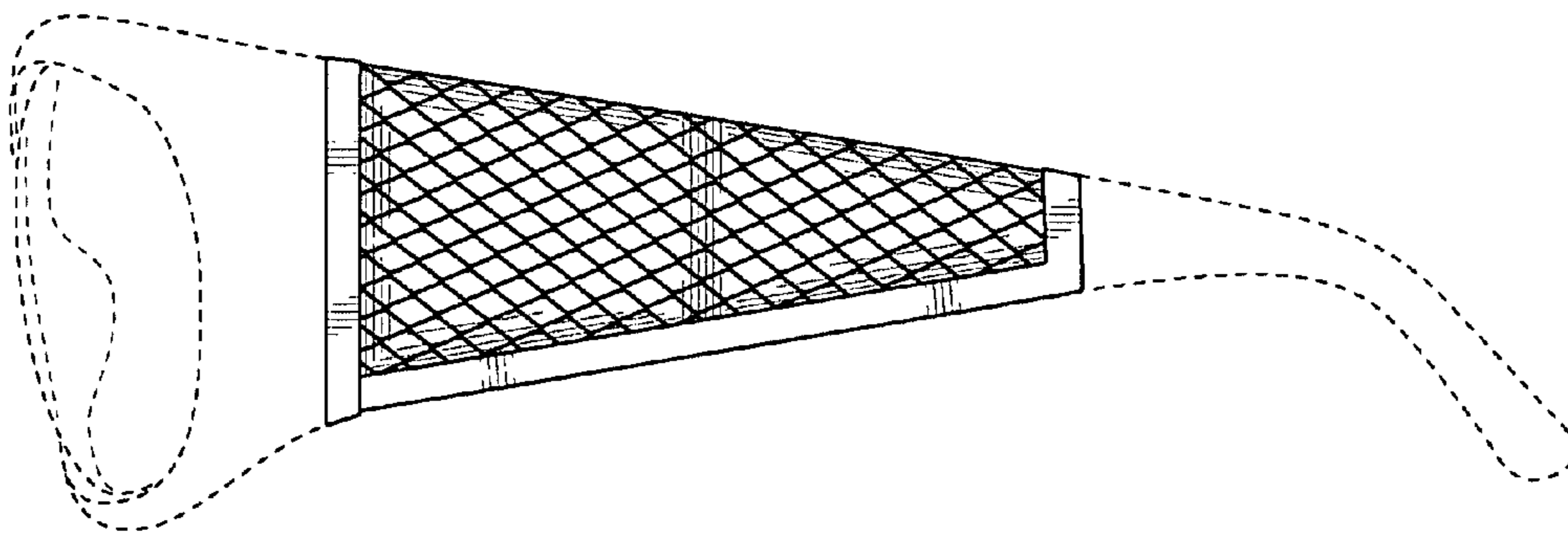

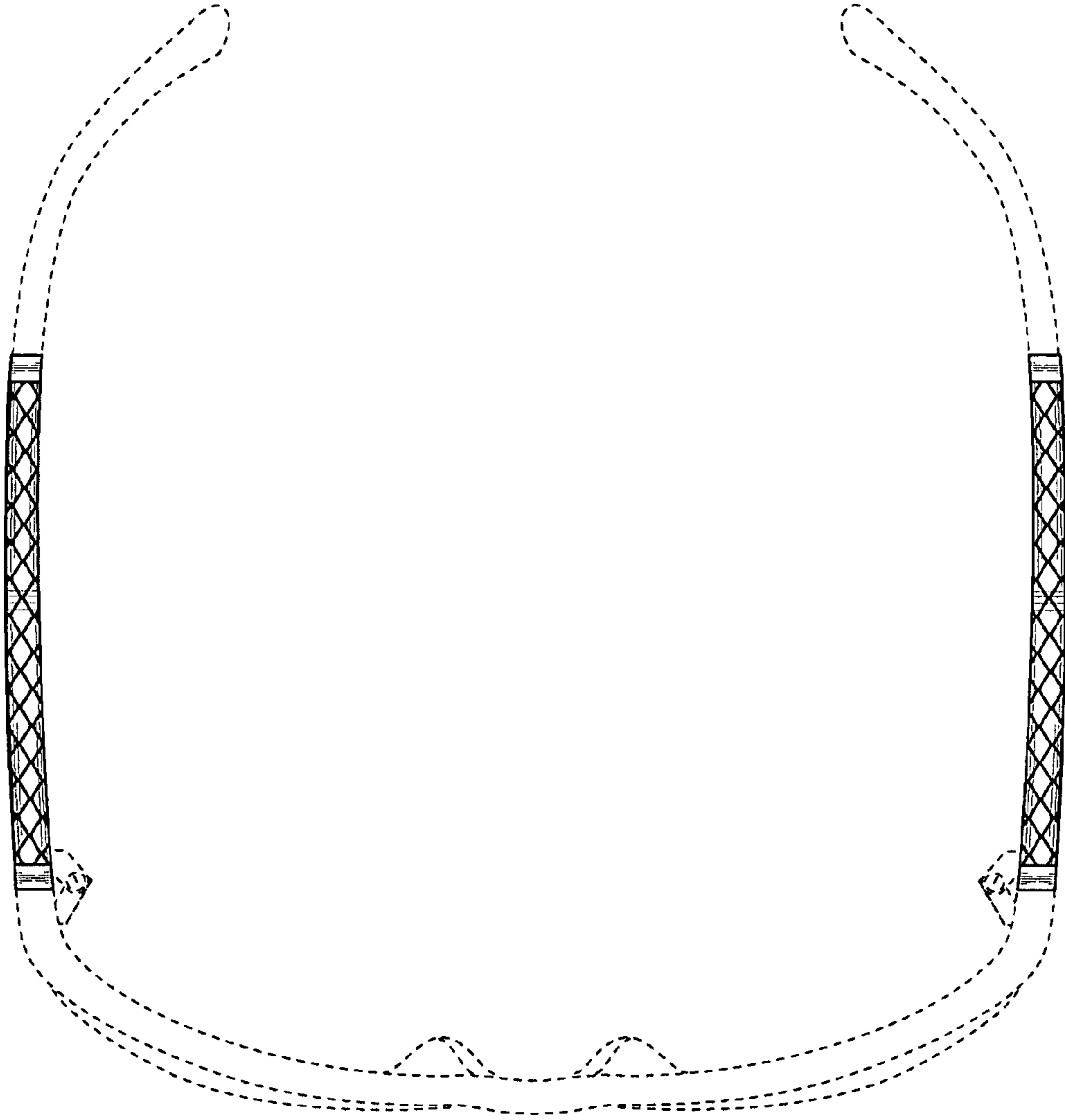

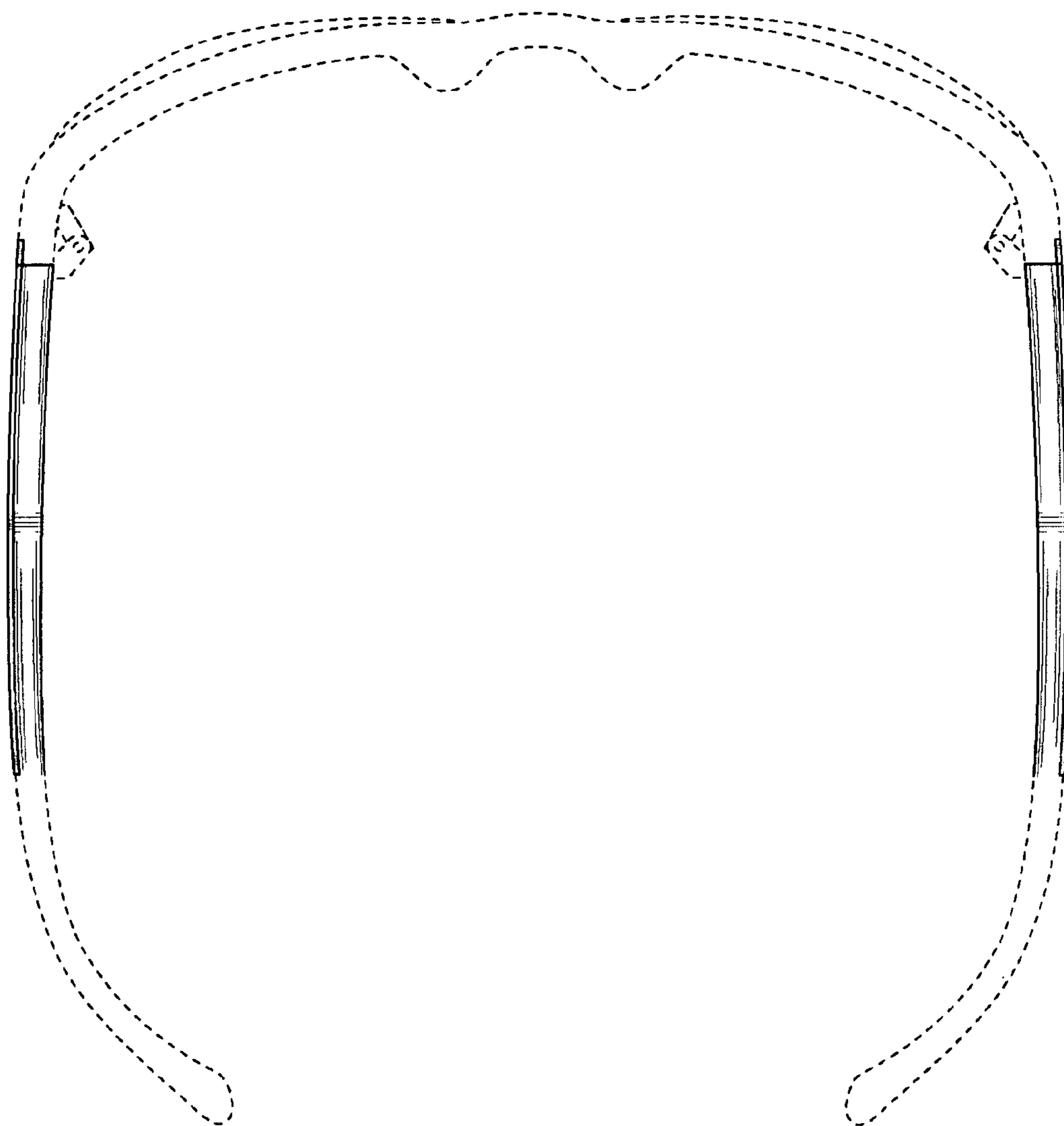

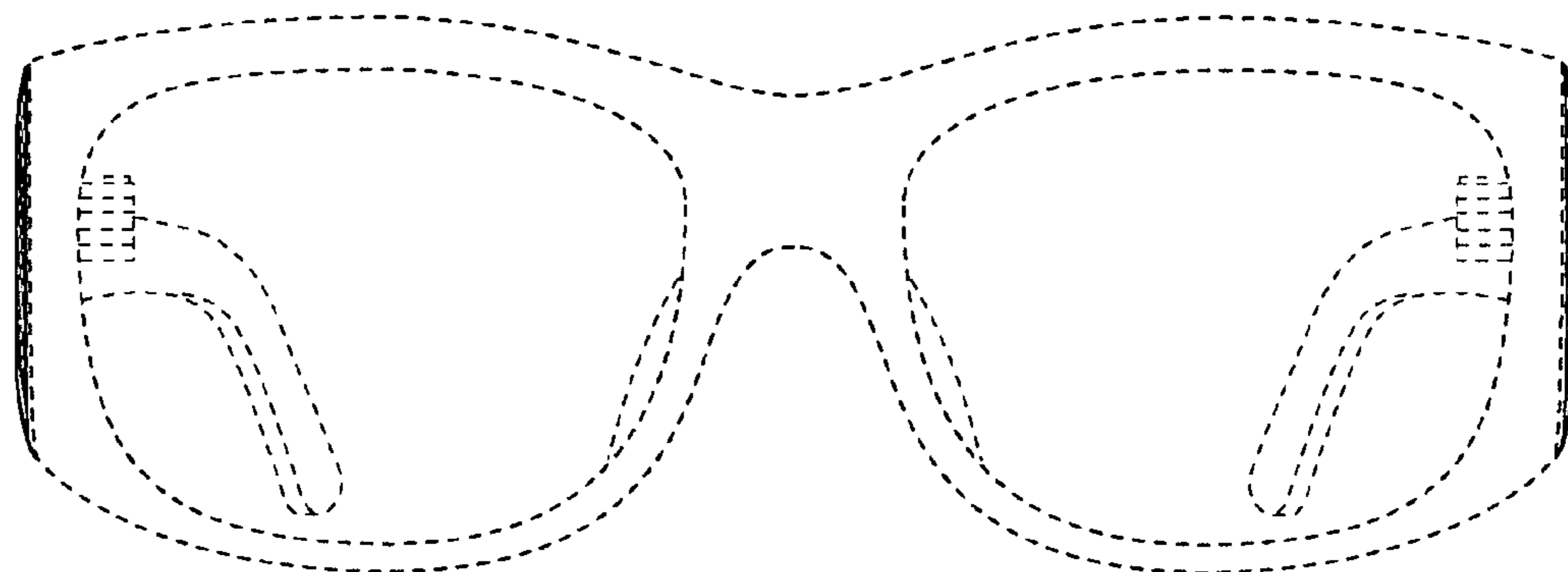

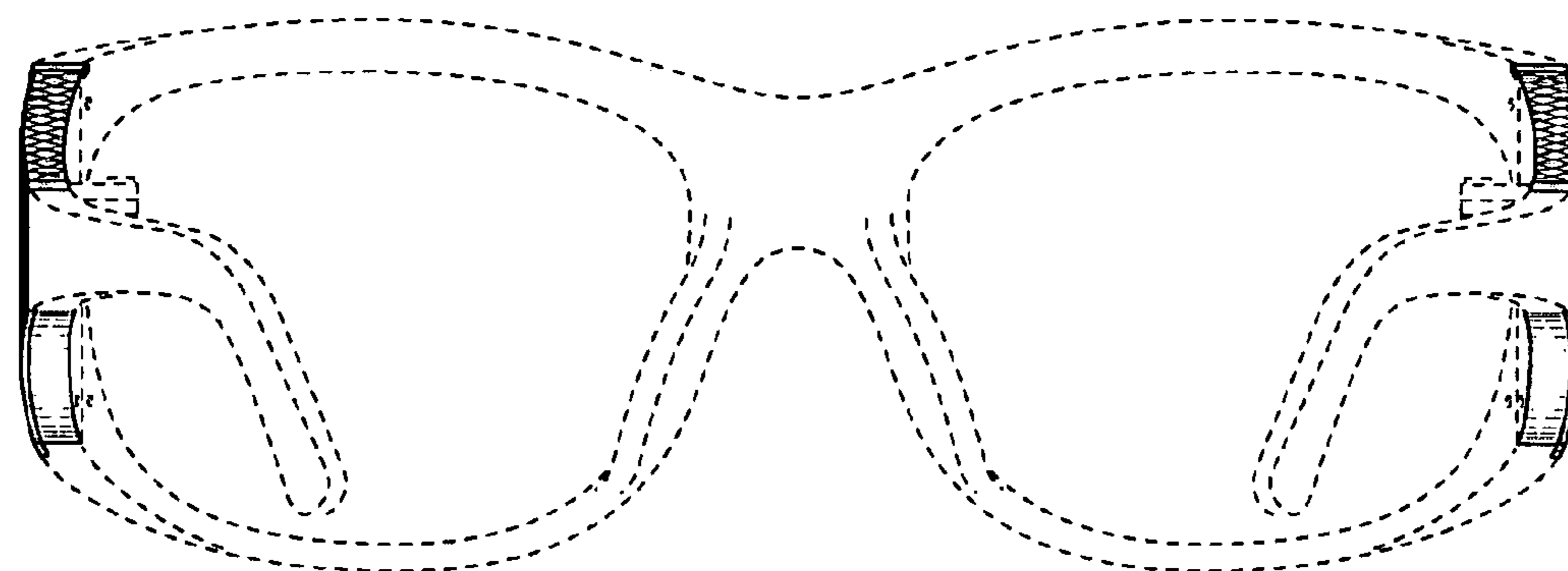
