**DESCRIPTION**

FIG. 5 is an illustration of a front view of the air vent;

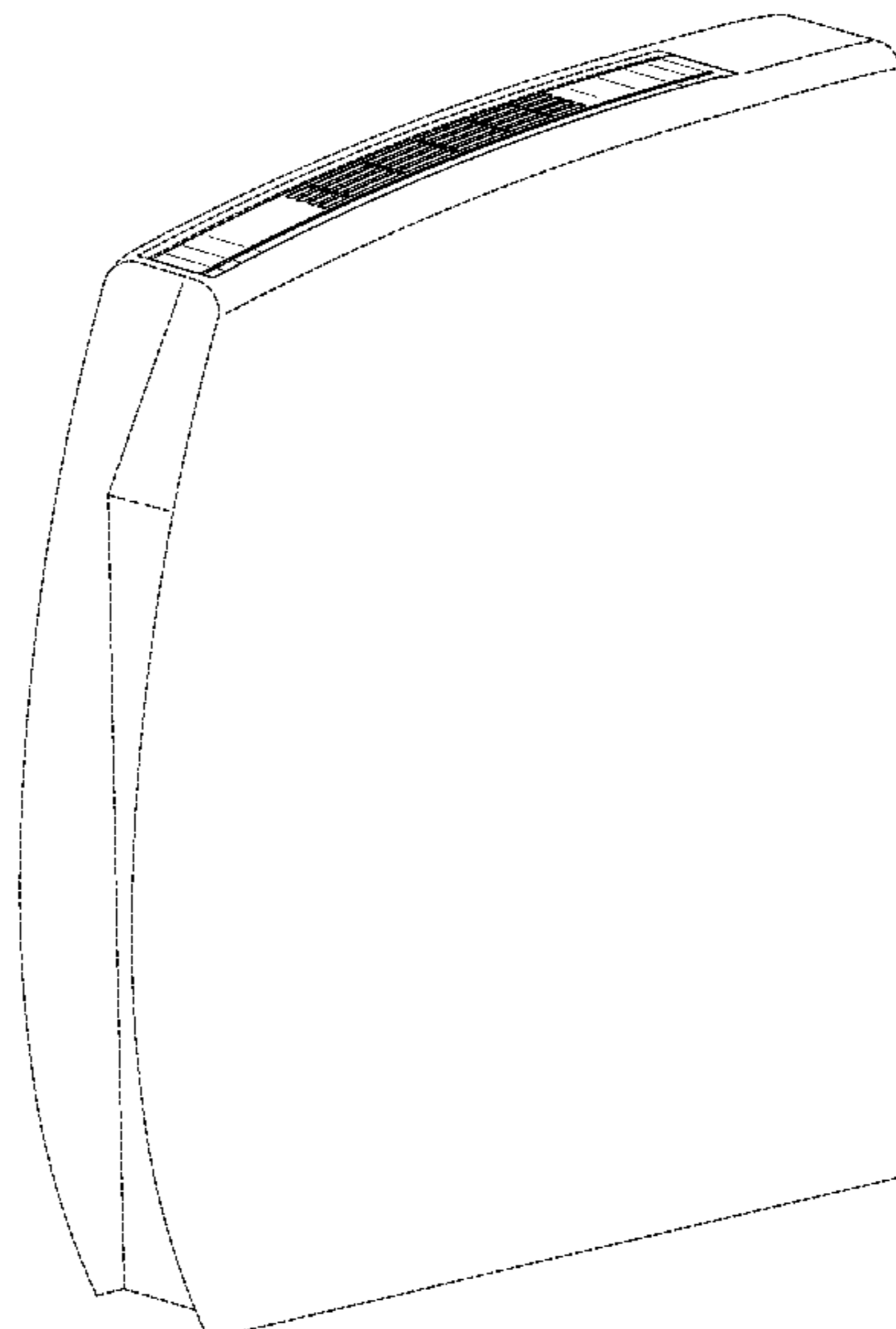
FIG. 6 is an illustration of a rear view of the air vent;

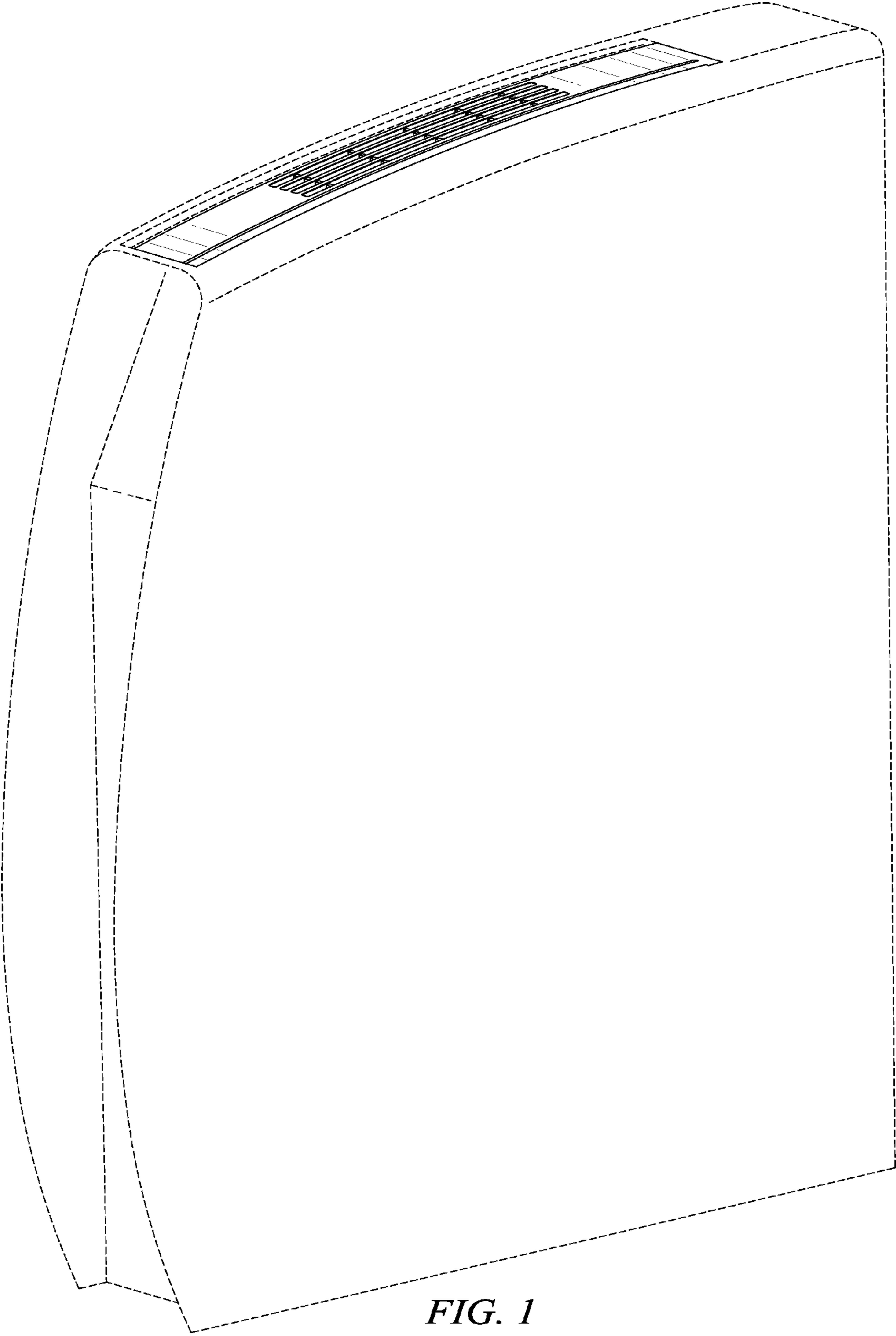

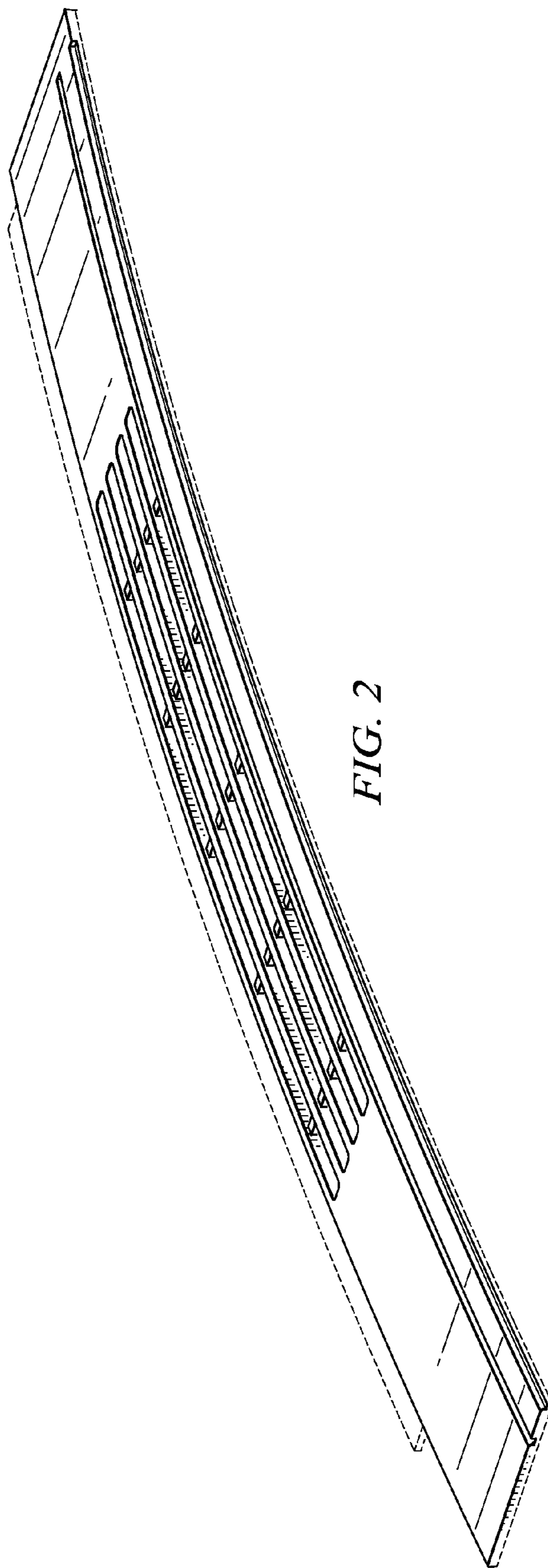

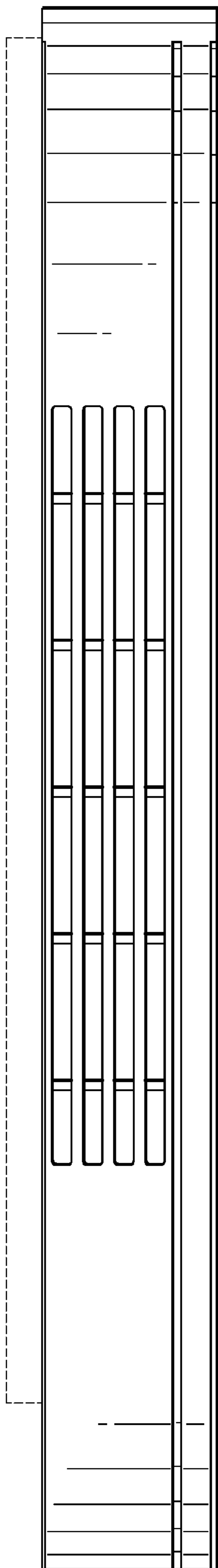

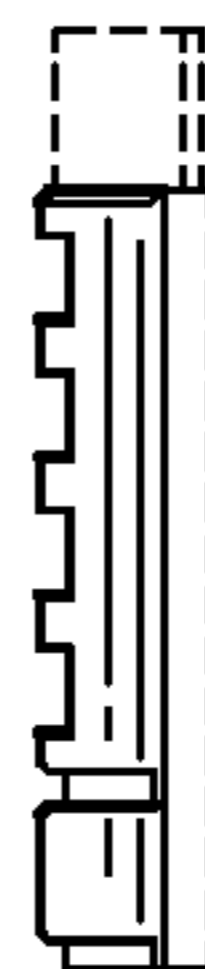

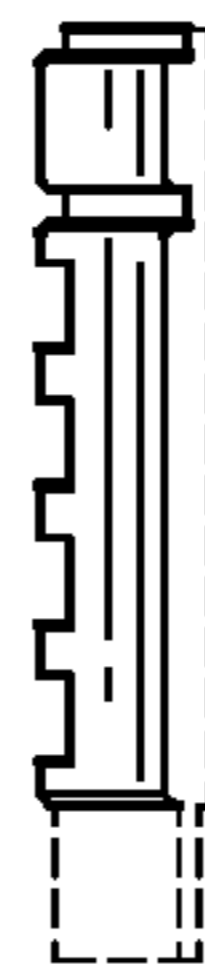

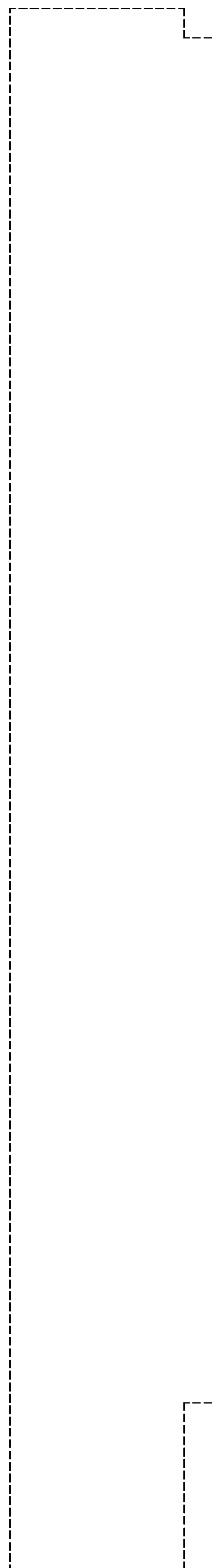

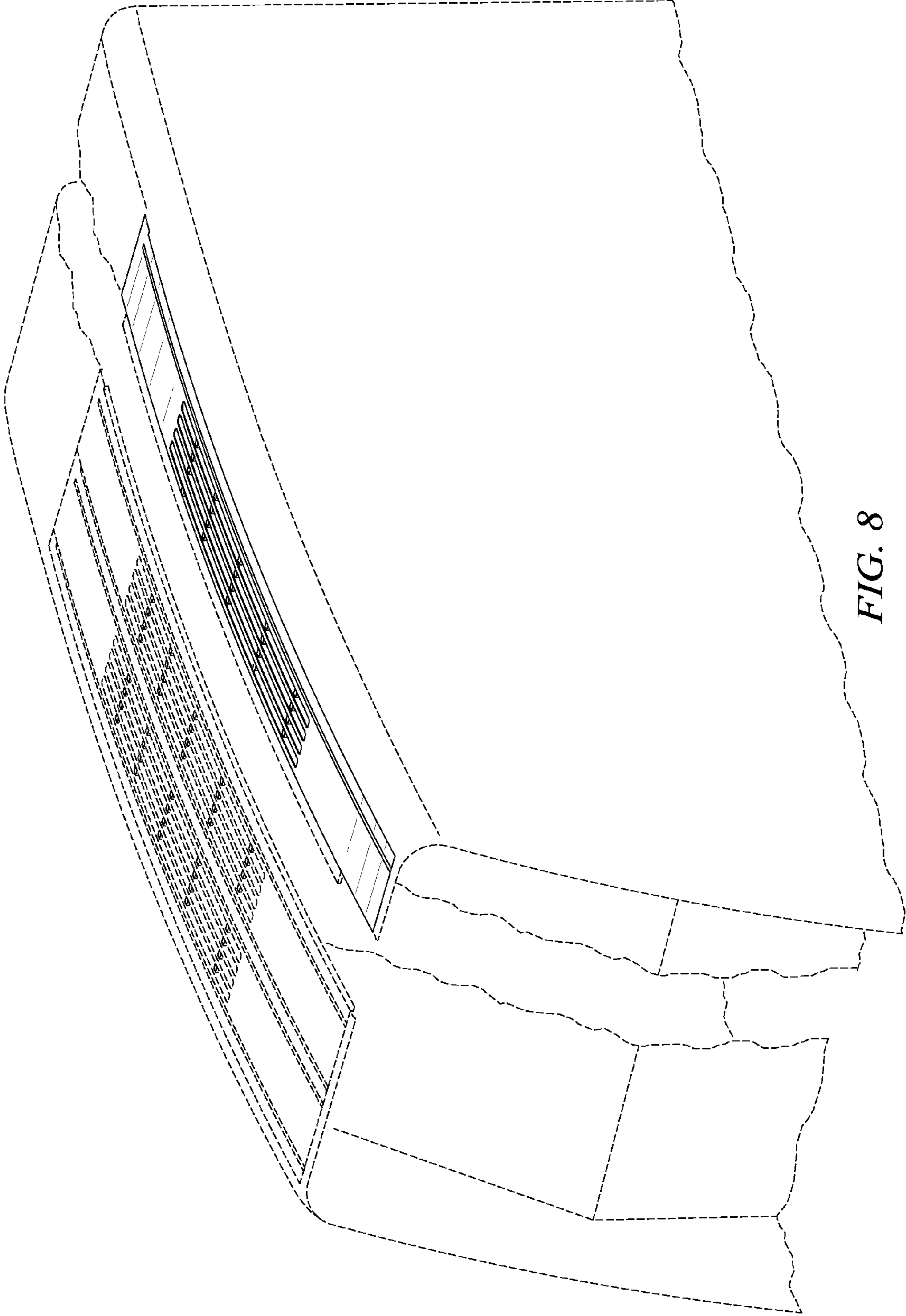
