The ornamental design for a convenience store bump out display, as shown and described.

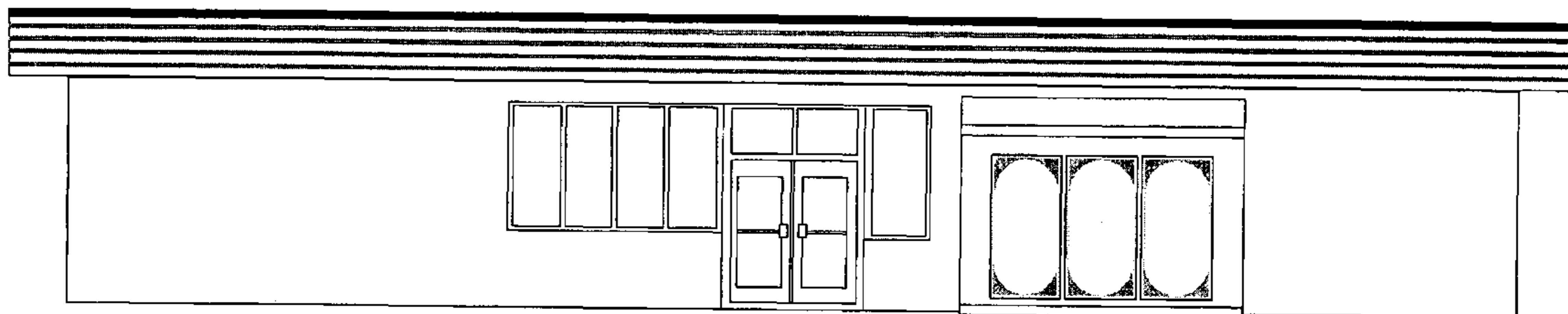
**DESCRIPTION**

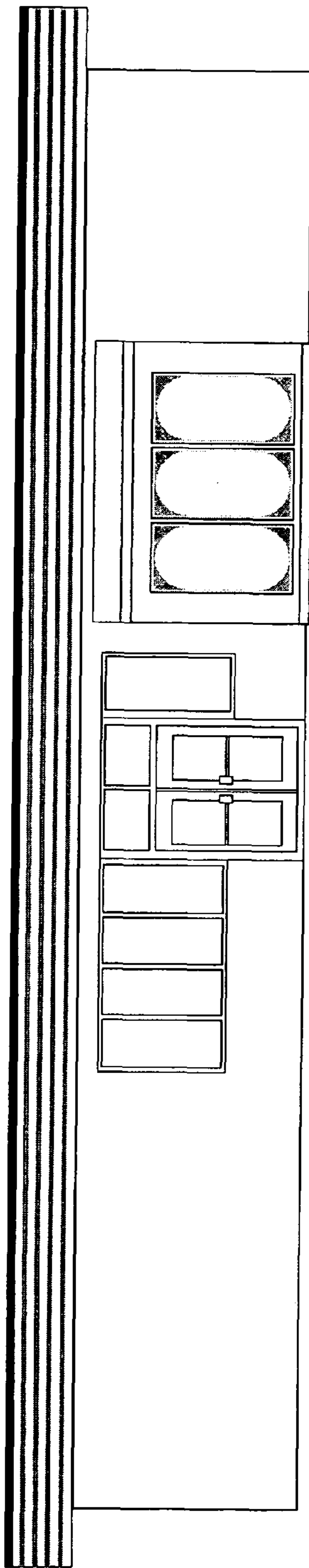

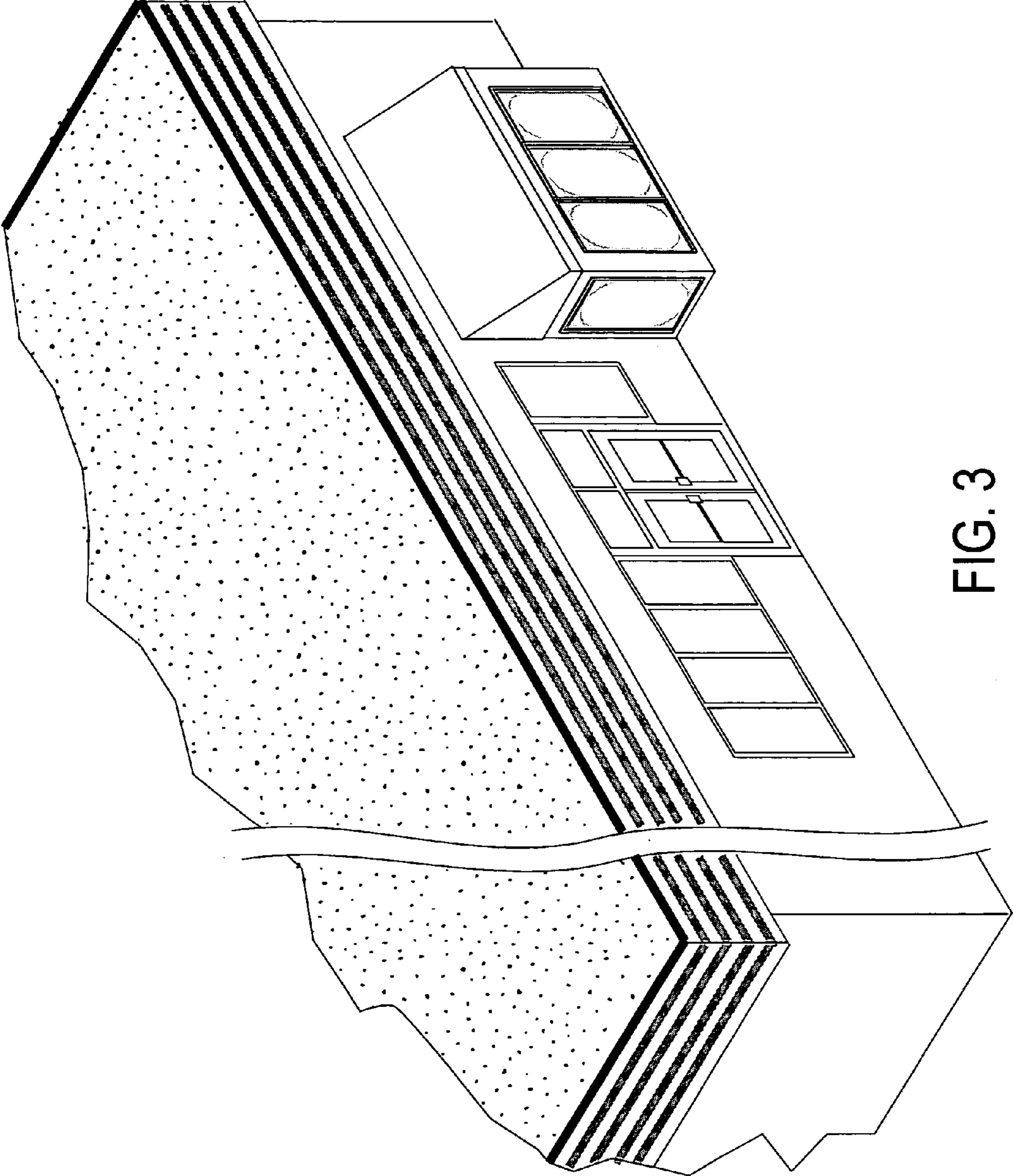
