(57) **CLAIM**

The ornamental design for a one-piece formed anti-slip grab rail, as shown and described.

DESCRIPTION

FIG. 1. is a front perspective view of the one-piece formed anti-slip grab rail according to the present design;

FIG. 2 is a back perspective view of the one-piece formed anti-slip grab rail of FIG. 1;

FIG. 3 is a front view of the one-piece formed anti-slip grab rail of FIG. 1;

FIG. 4 is a back view of the one-piece formed anti-slip grab rail of FIG. 1;

FIG. 5 is a left side view of the one-piece formed anti-slip grab rail of FIG. 1;

FIG. 6 is a right side view of the one-piece formed anti-slip grab rail of FIG. 1;

FIG. 7 is a first end view of the one-piece formed anti-slip grab rail of FIG. 1; and,

FIG. 8 is a second end view of the one-piece formed anti-slip grab rail of FIG. 1.

The claimed design comprises the features visible of the one-piece formed anti-slip grab rail when installed on a surface (not shown). The mounting holes and foot bottoms of the assembly, all shown in dotted lines, form no part of the claimed design.

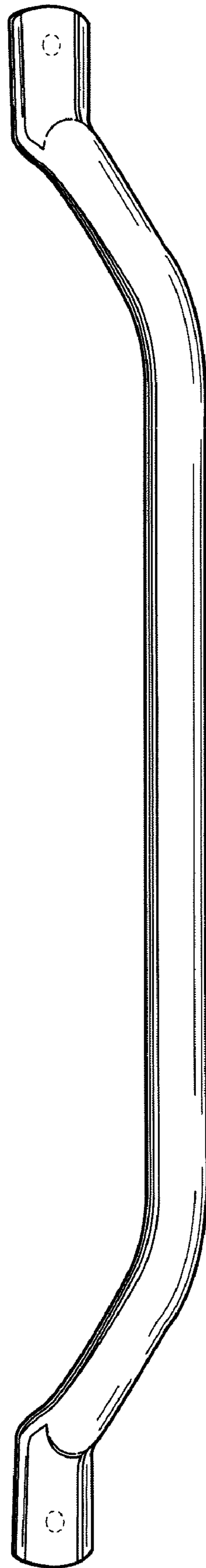

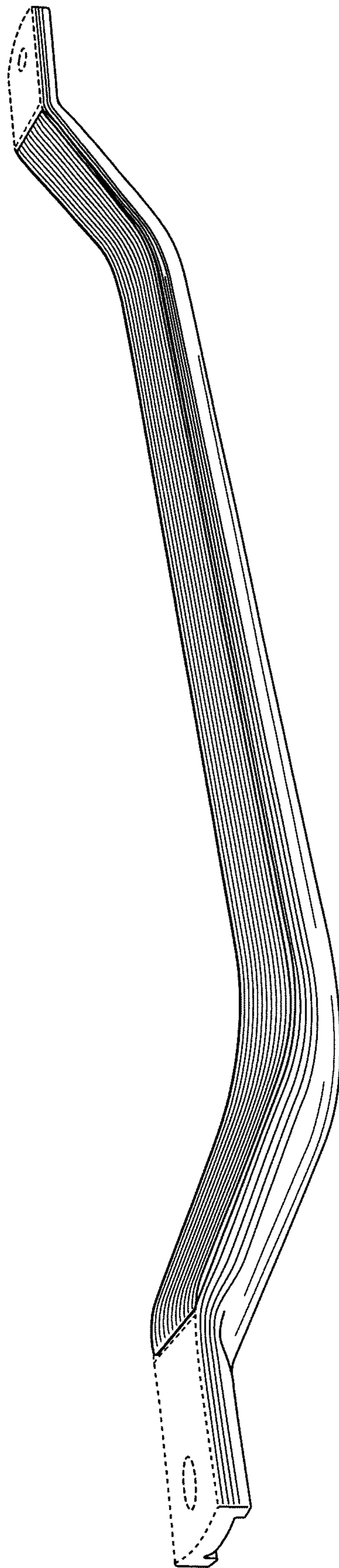

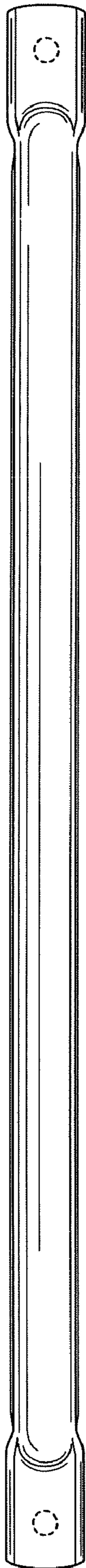

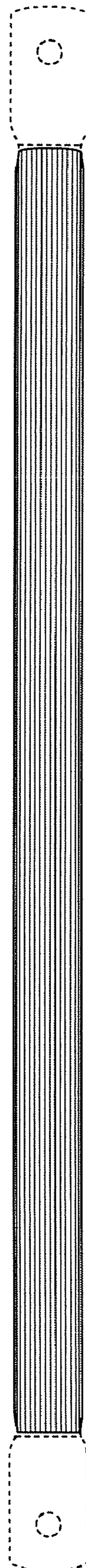

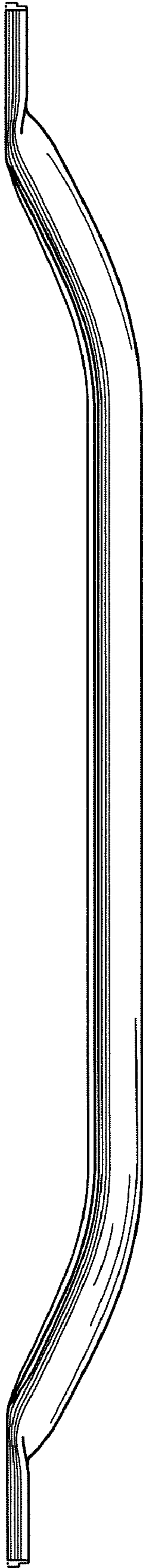

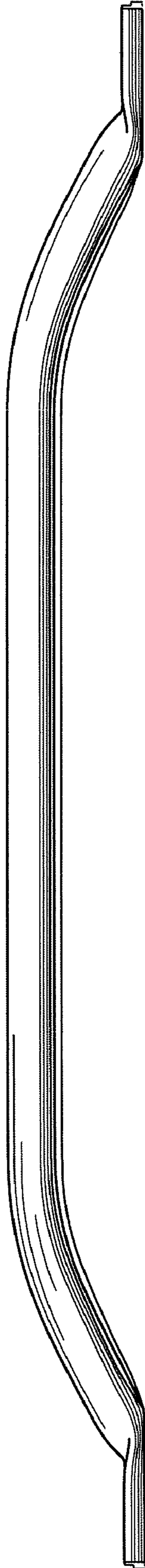

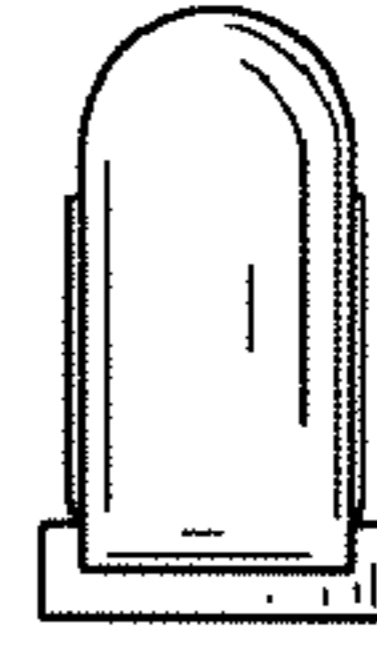

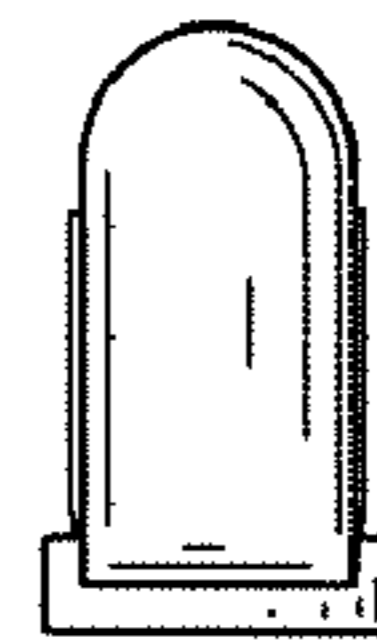
